(57) **CLAIM**

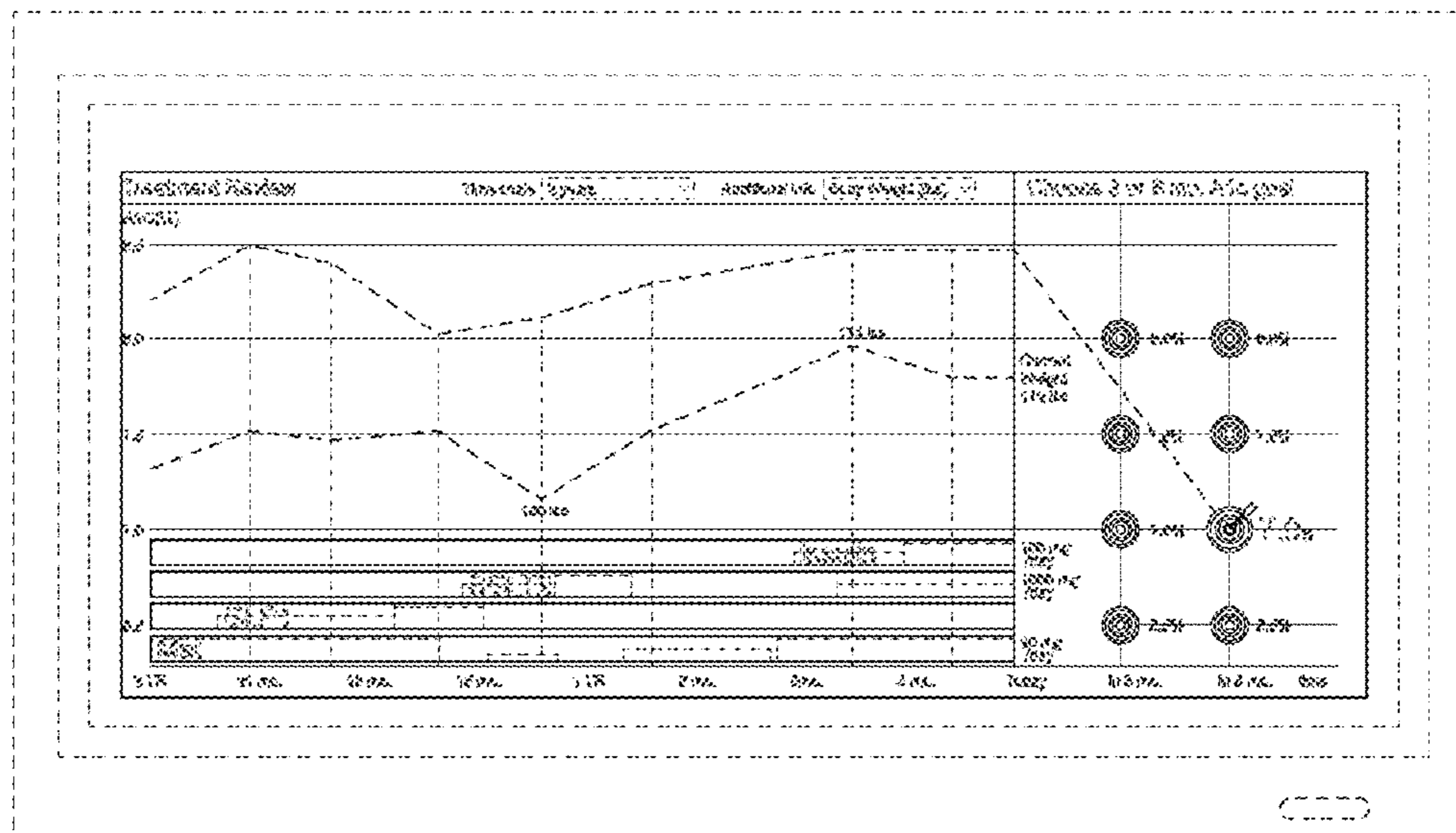
The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a display screen or portion thereof with graphical user interface according to the design; and, FIG. 2 is a partial enlarged view of the claimed design portion in FIG. 1.

The broken lines showing an electronic device illustrate environmental subject matter, whereas the remaining broken lines showing a display screen or portion thereof and elements of the graphical user interface illustrate portions of the article. None of the broken lines form part of the claimed design.

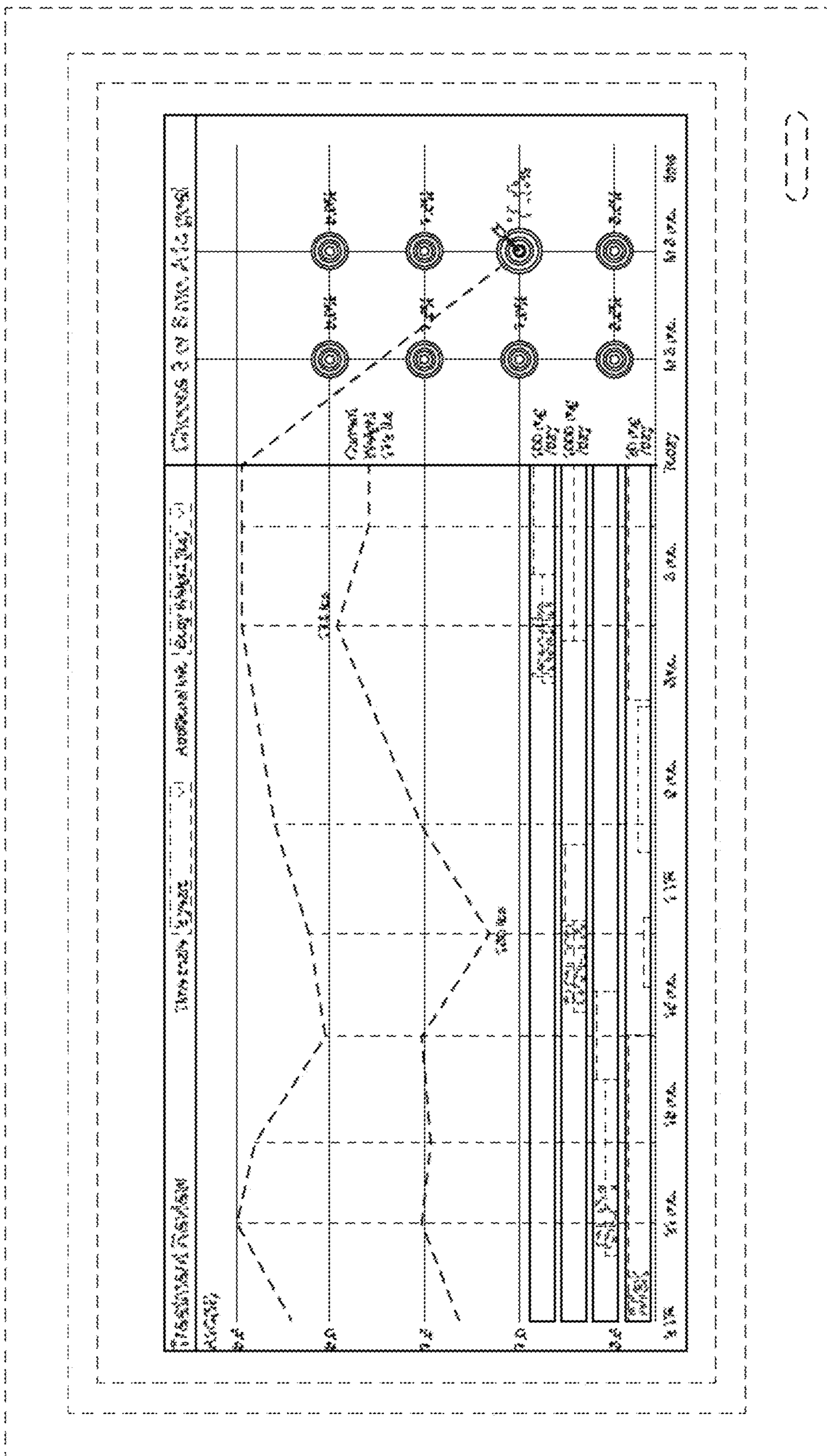

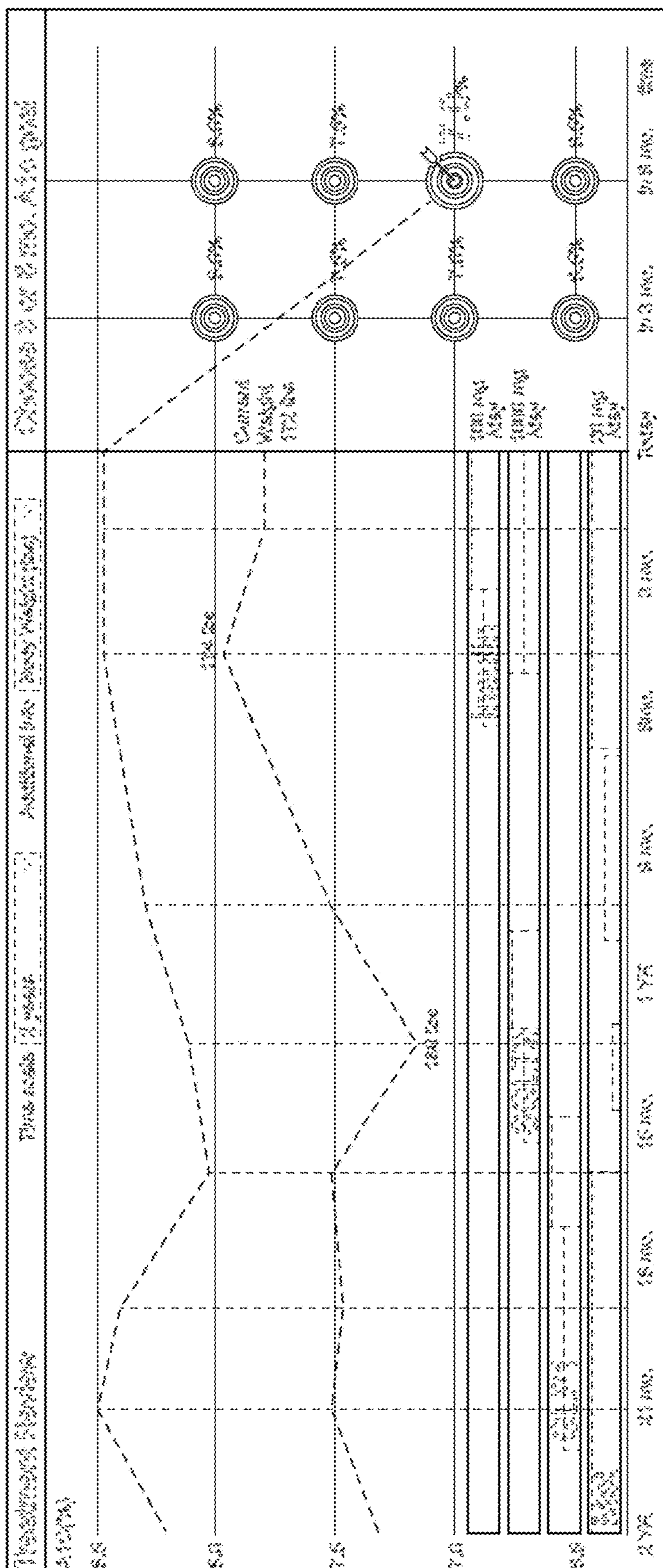
