user interface for workflow.

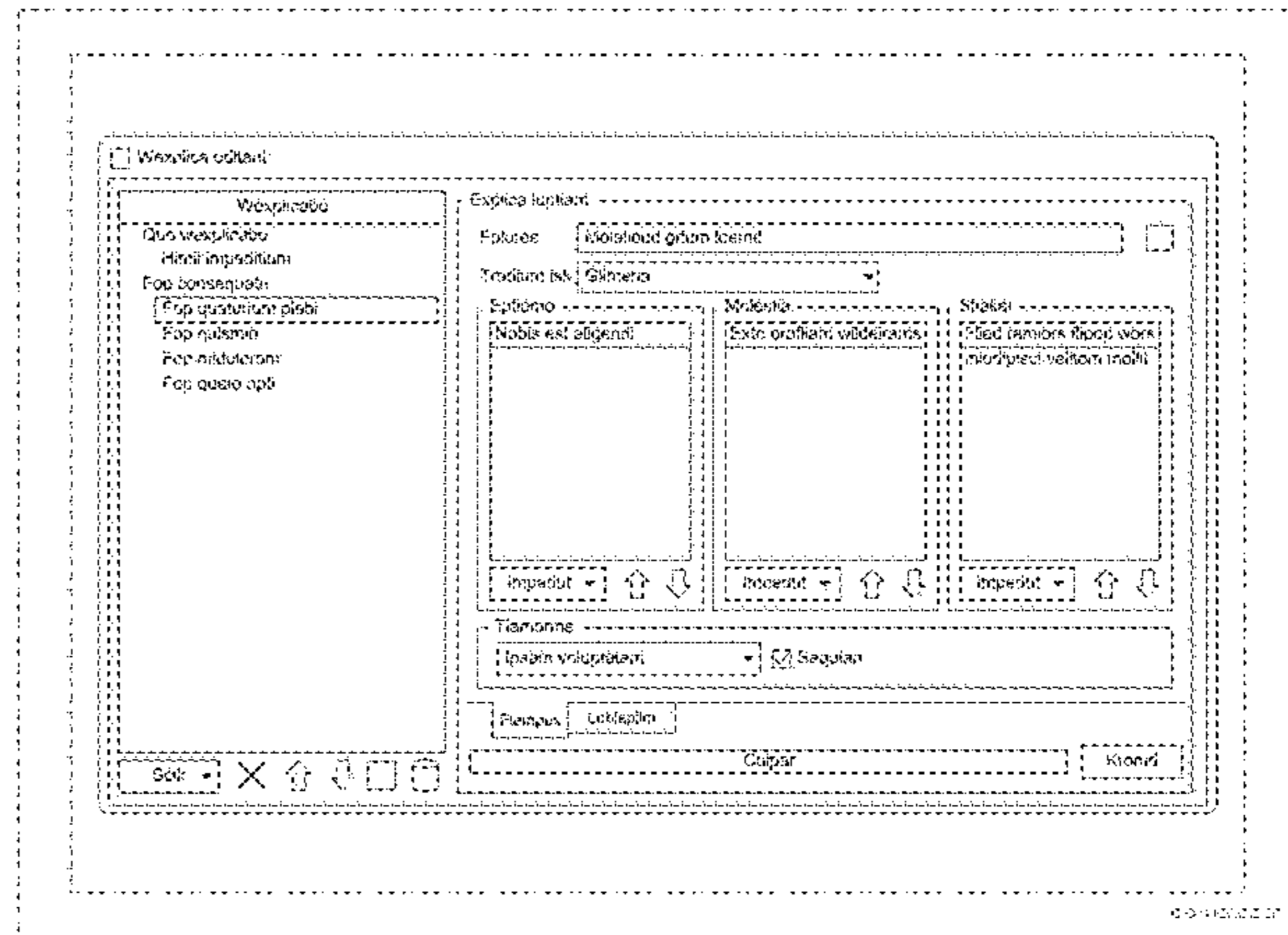
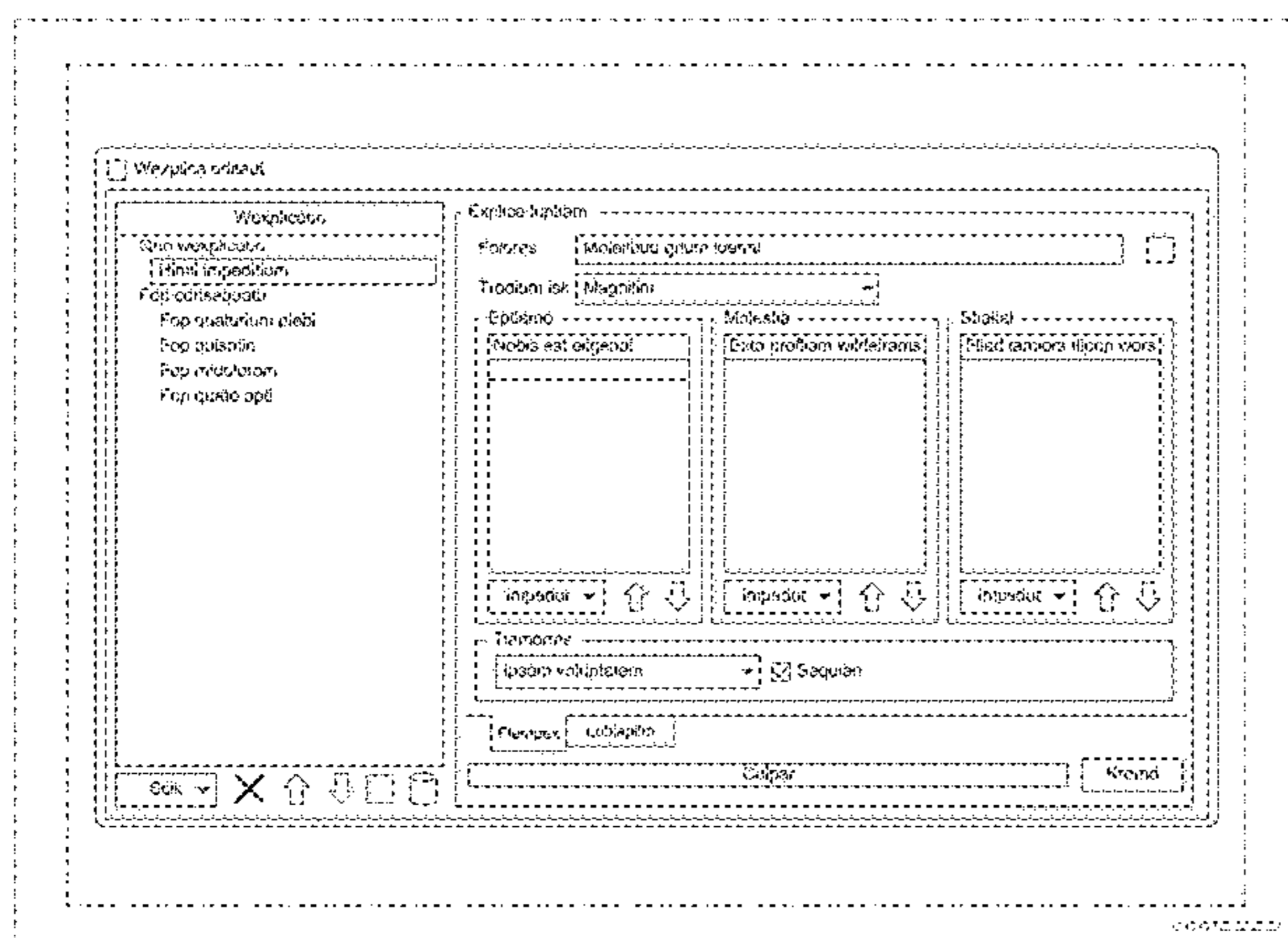
The appearance of the transitional image sequentially transi-

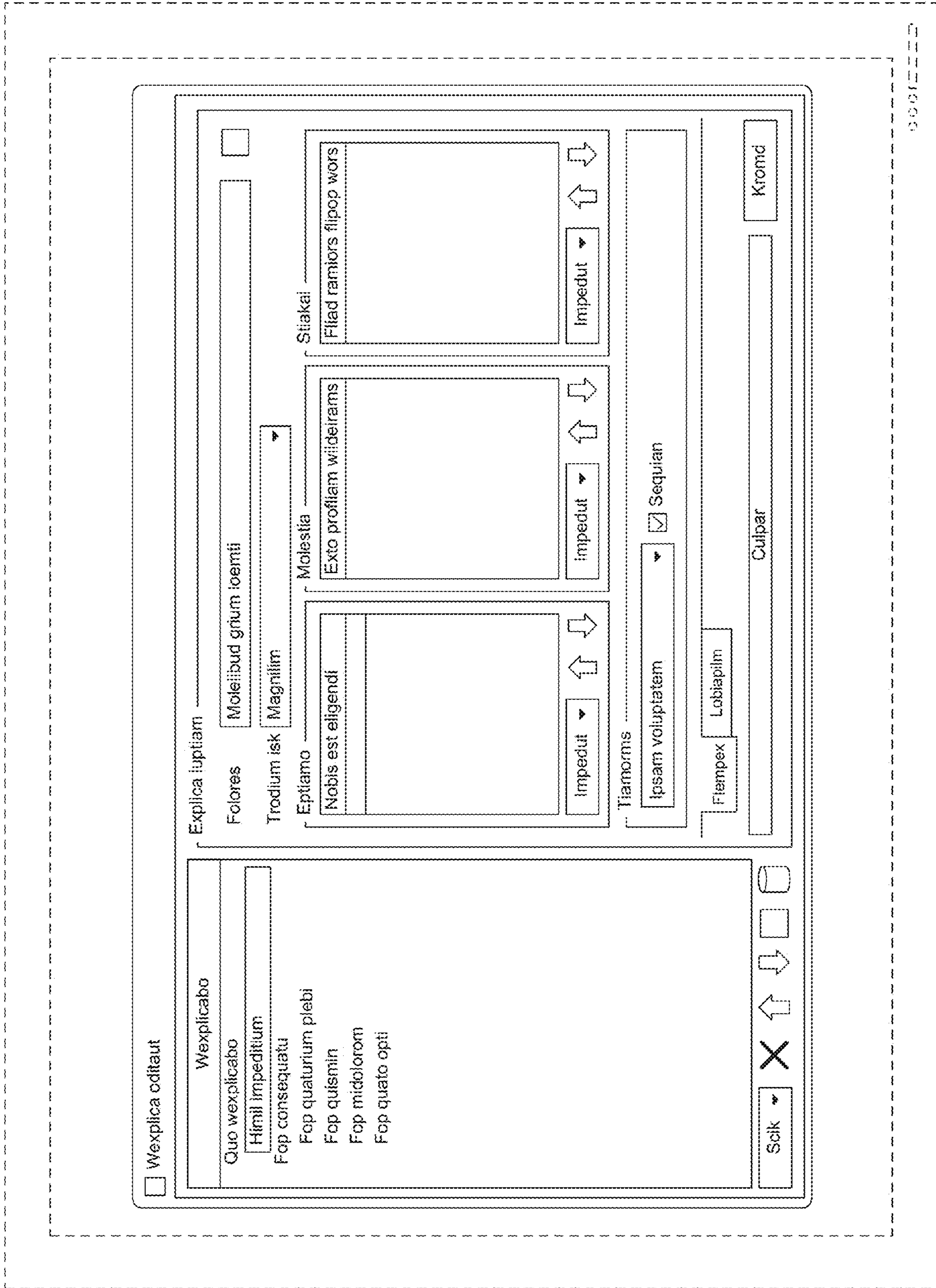

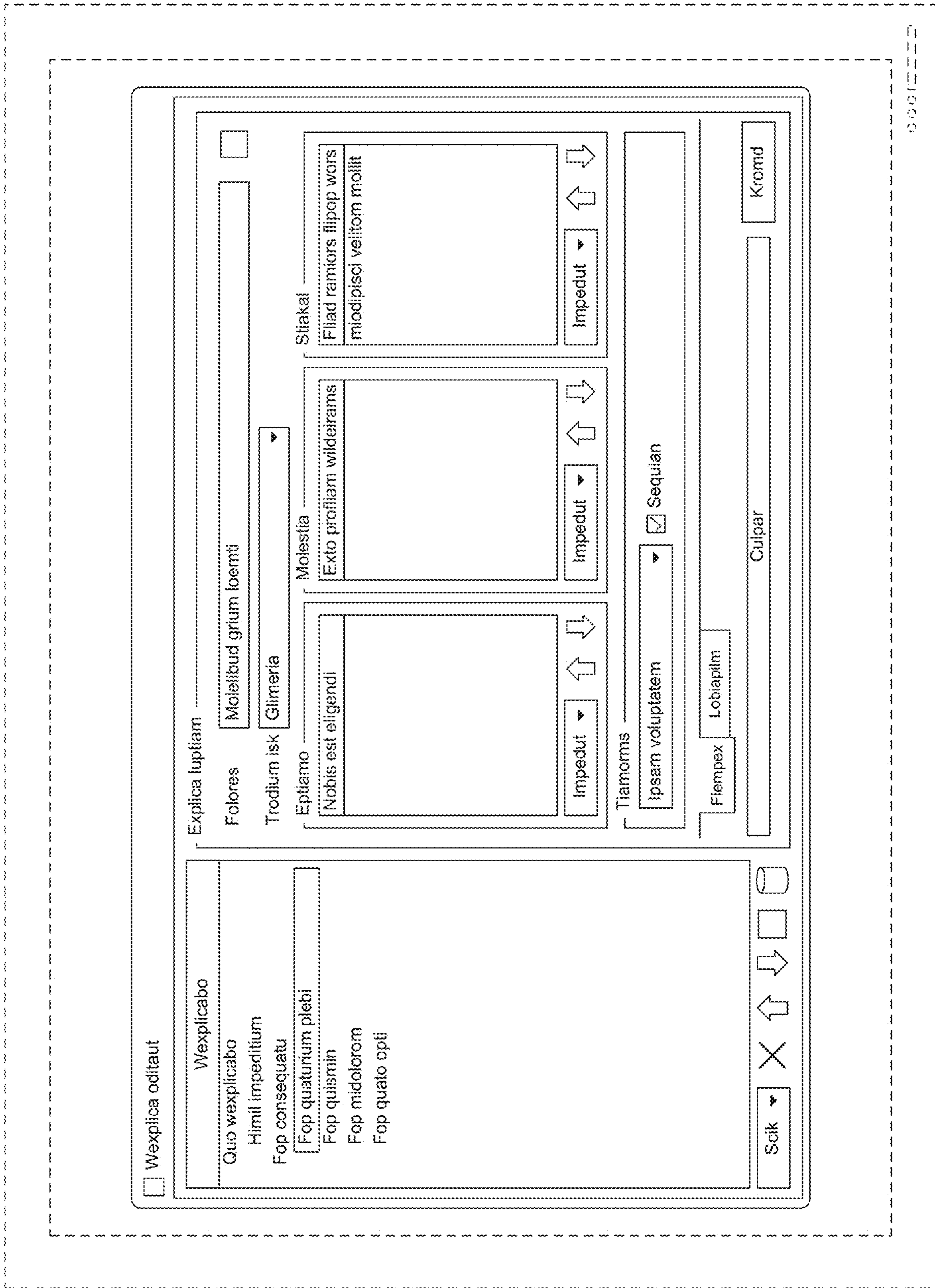
