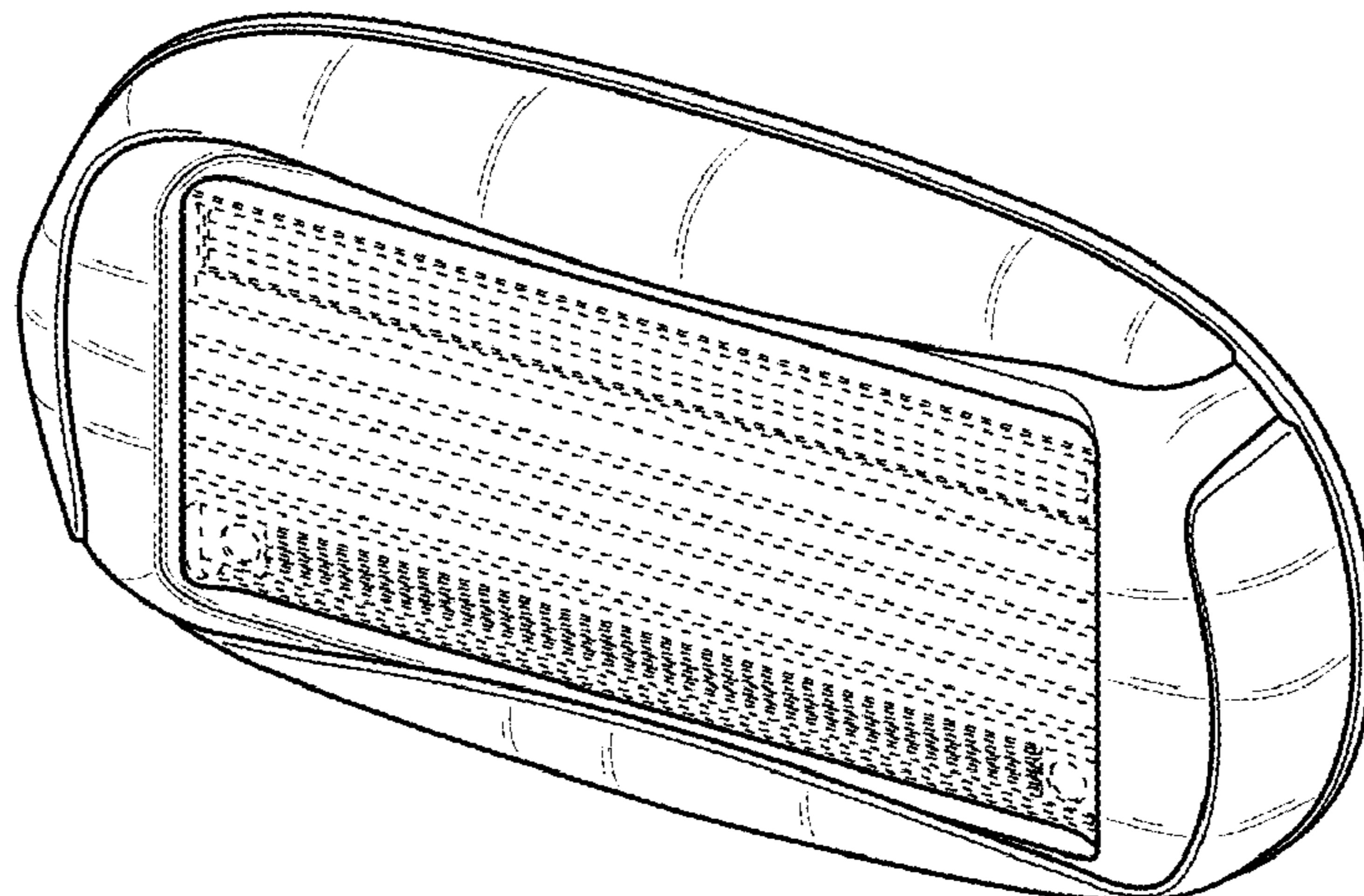


FIG. 35 is a bottom view thereof.

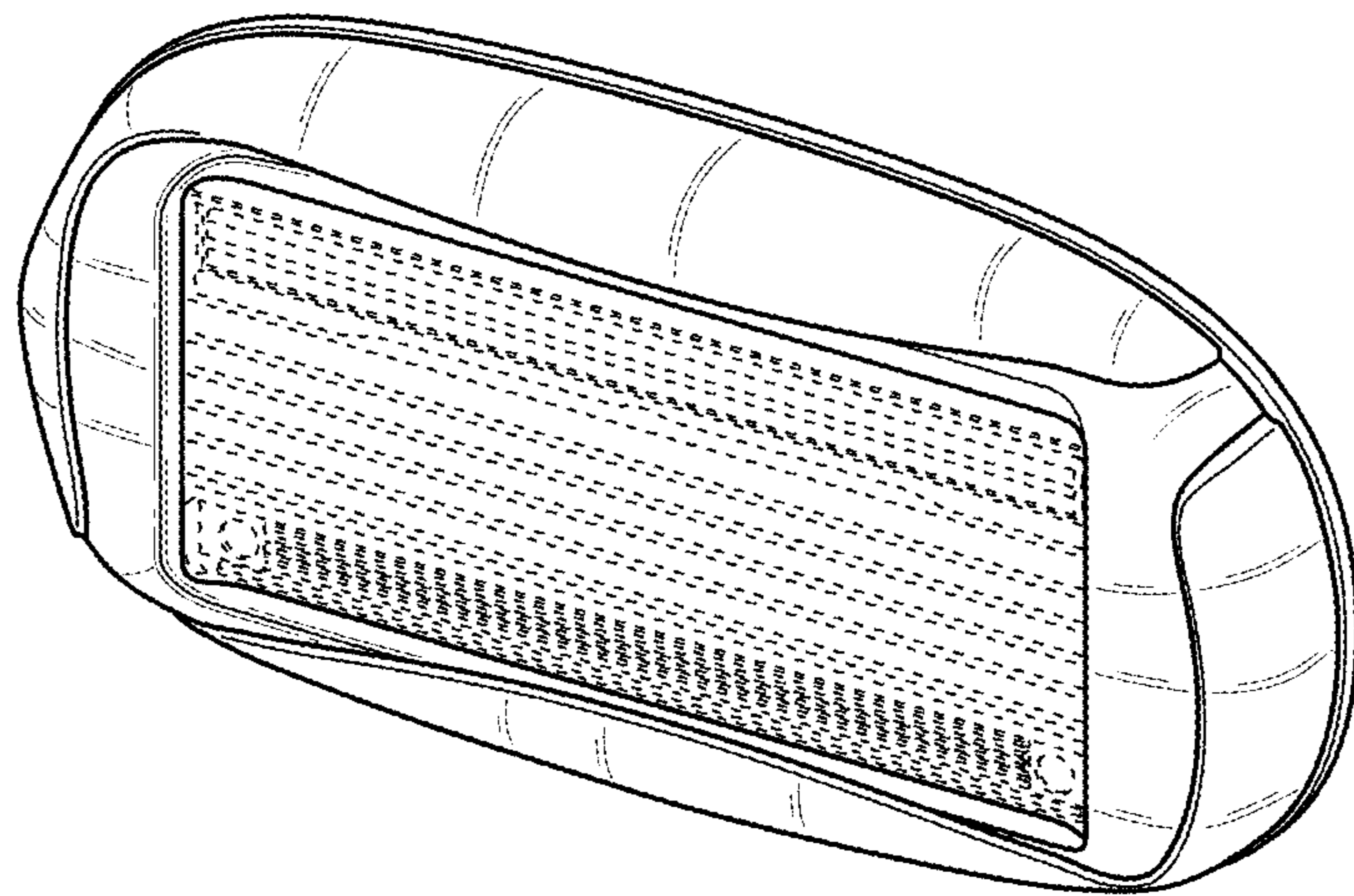

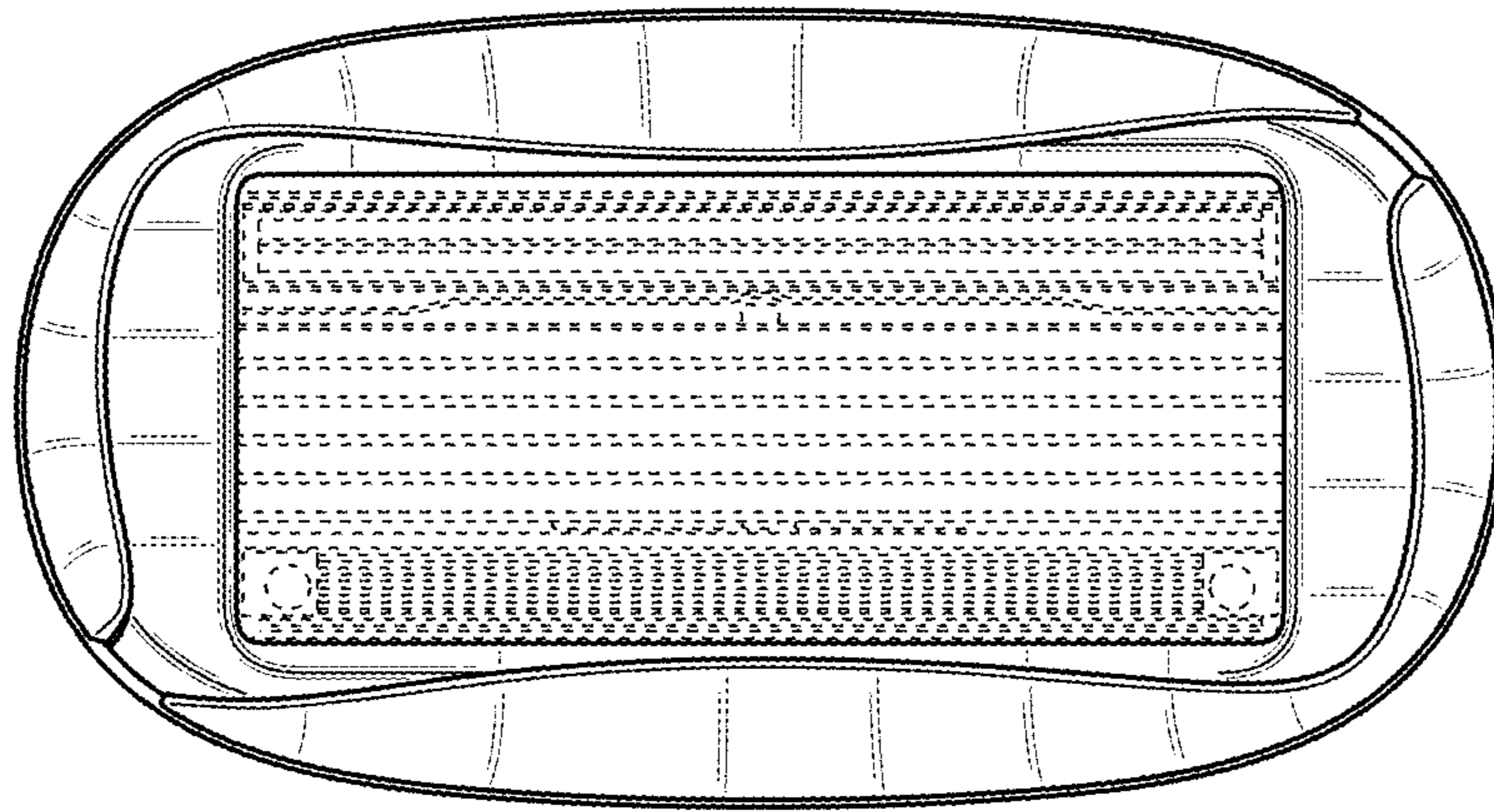

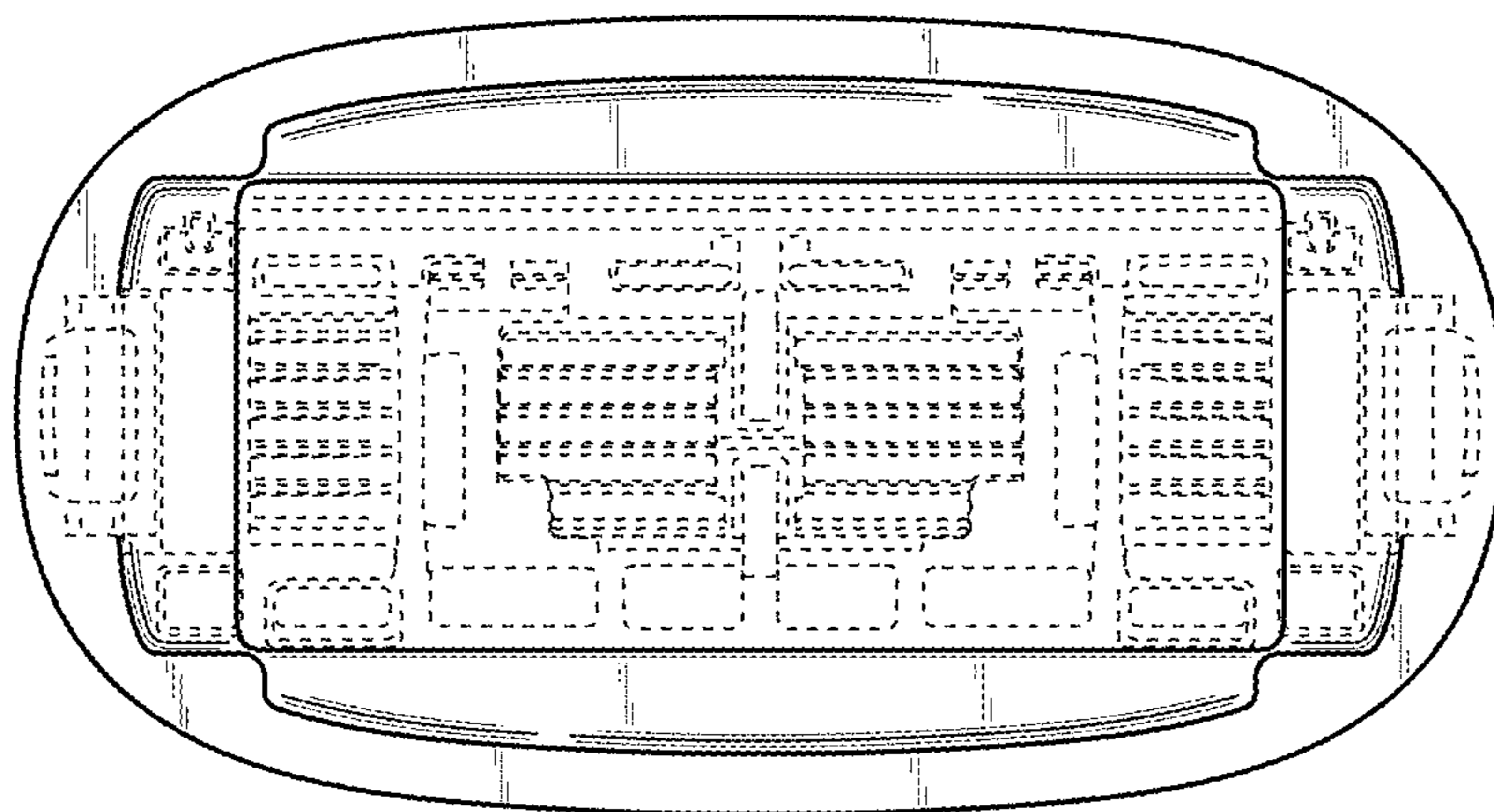

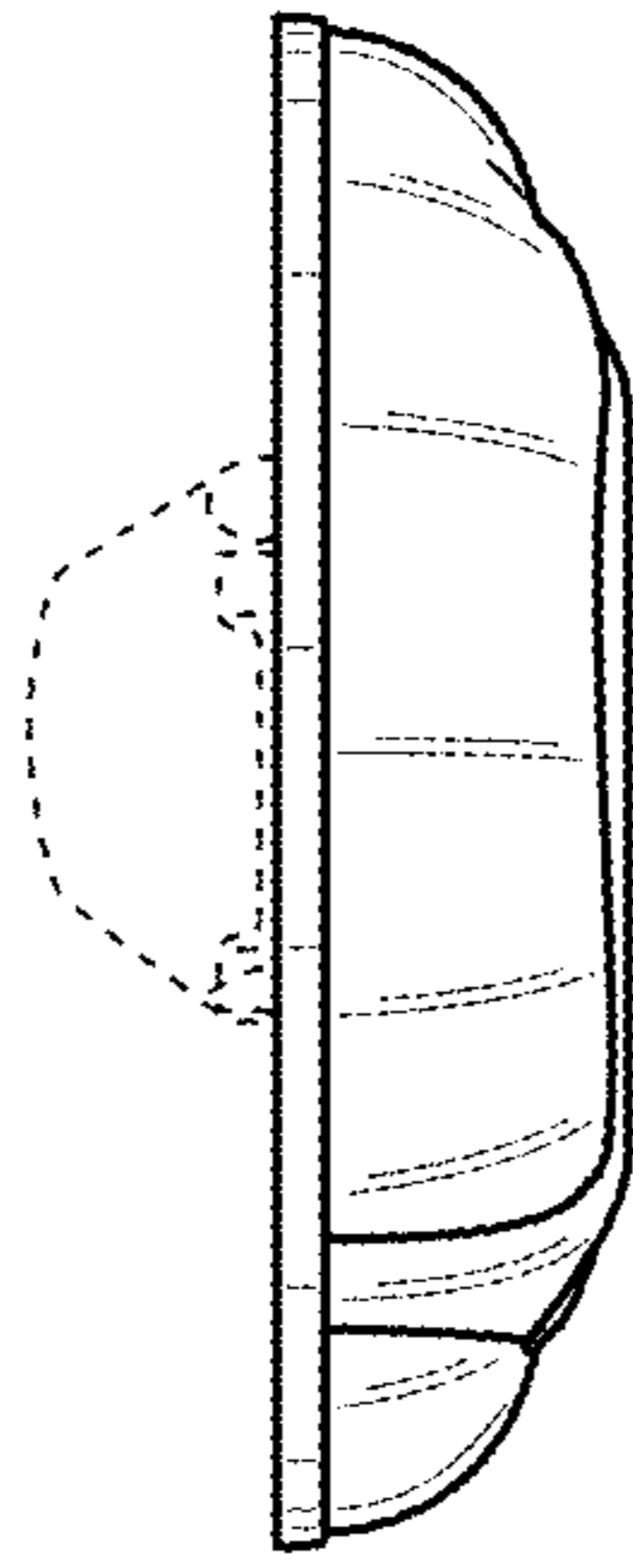

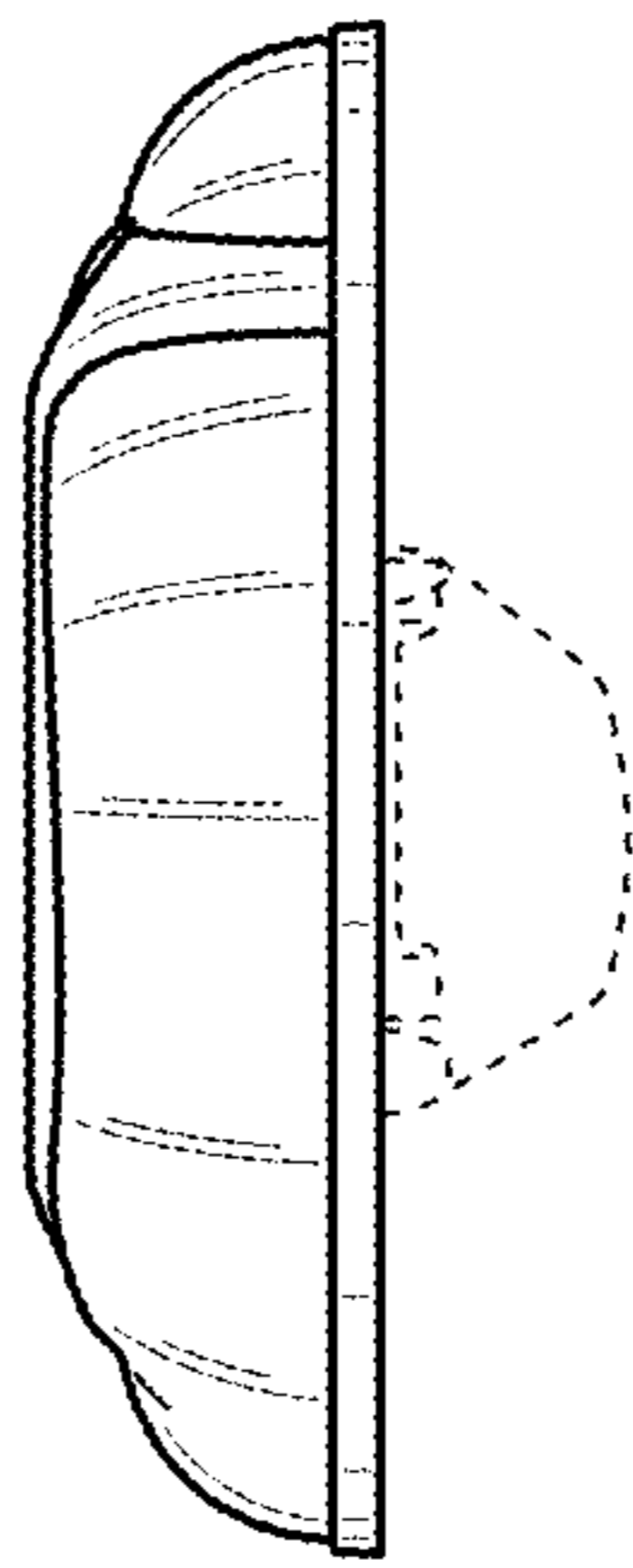

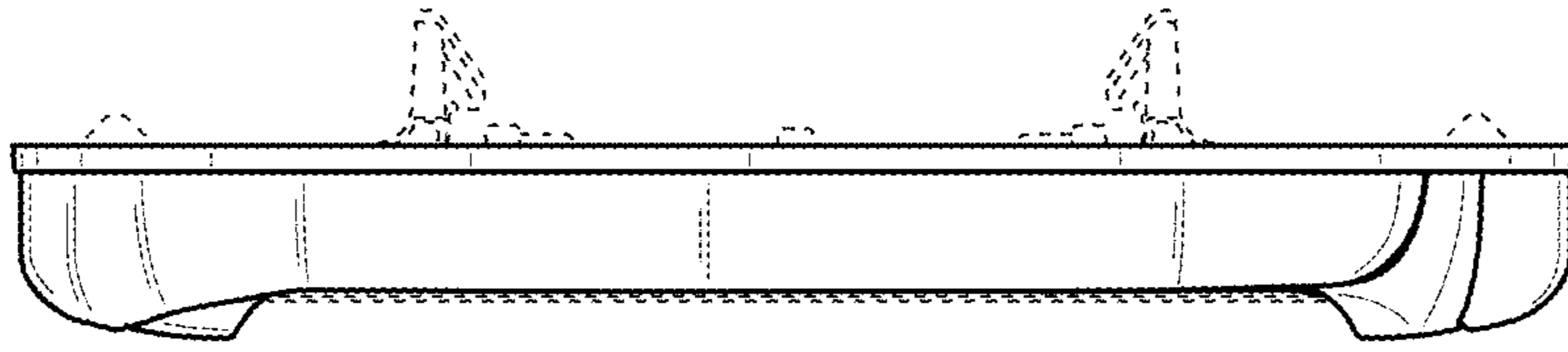

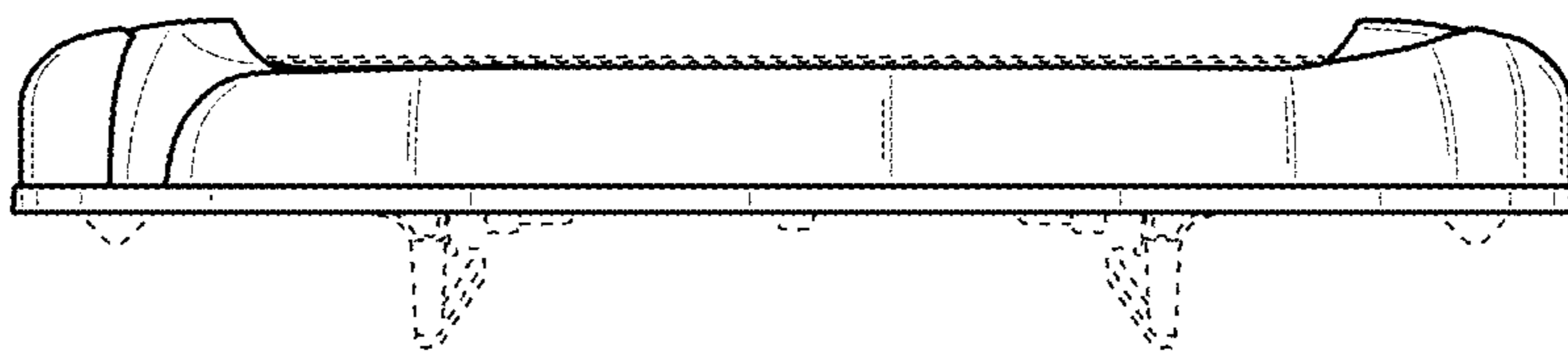

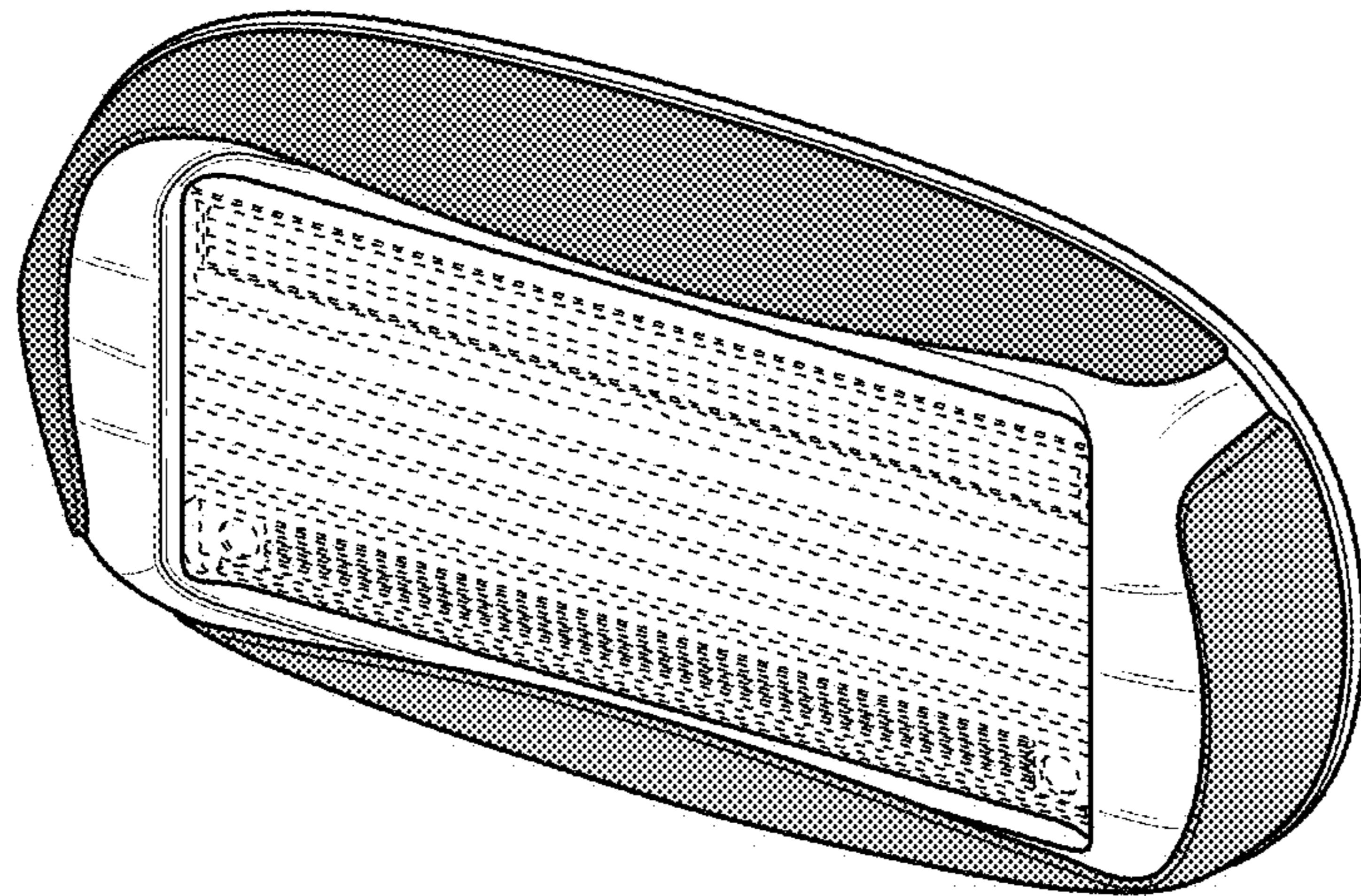

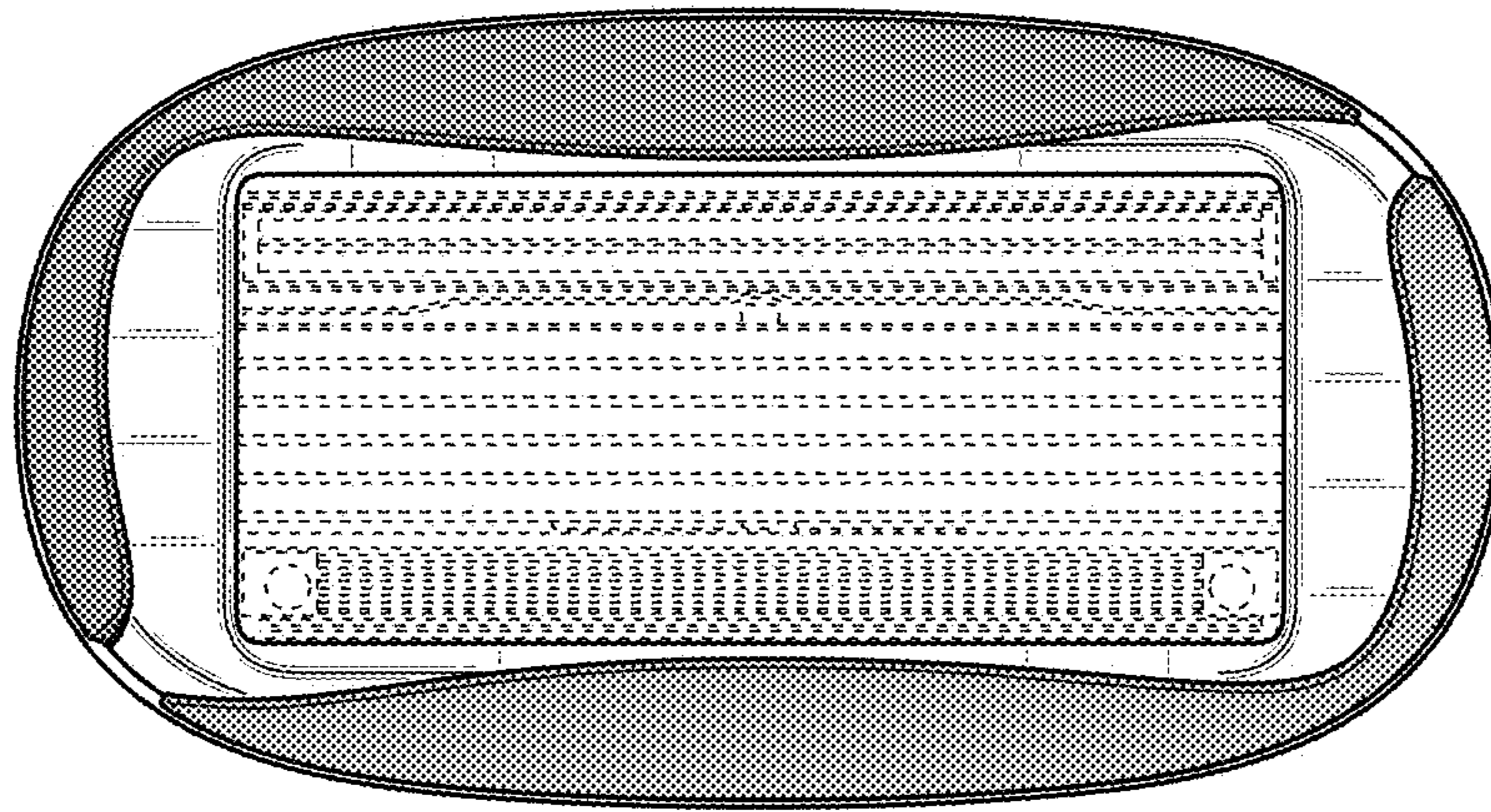

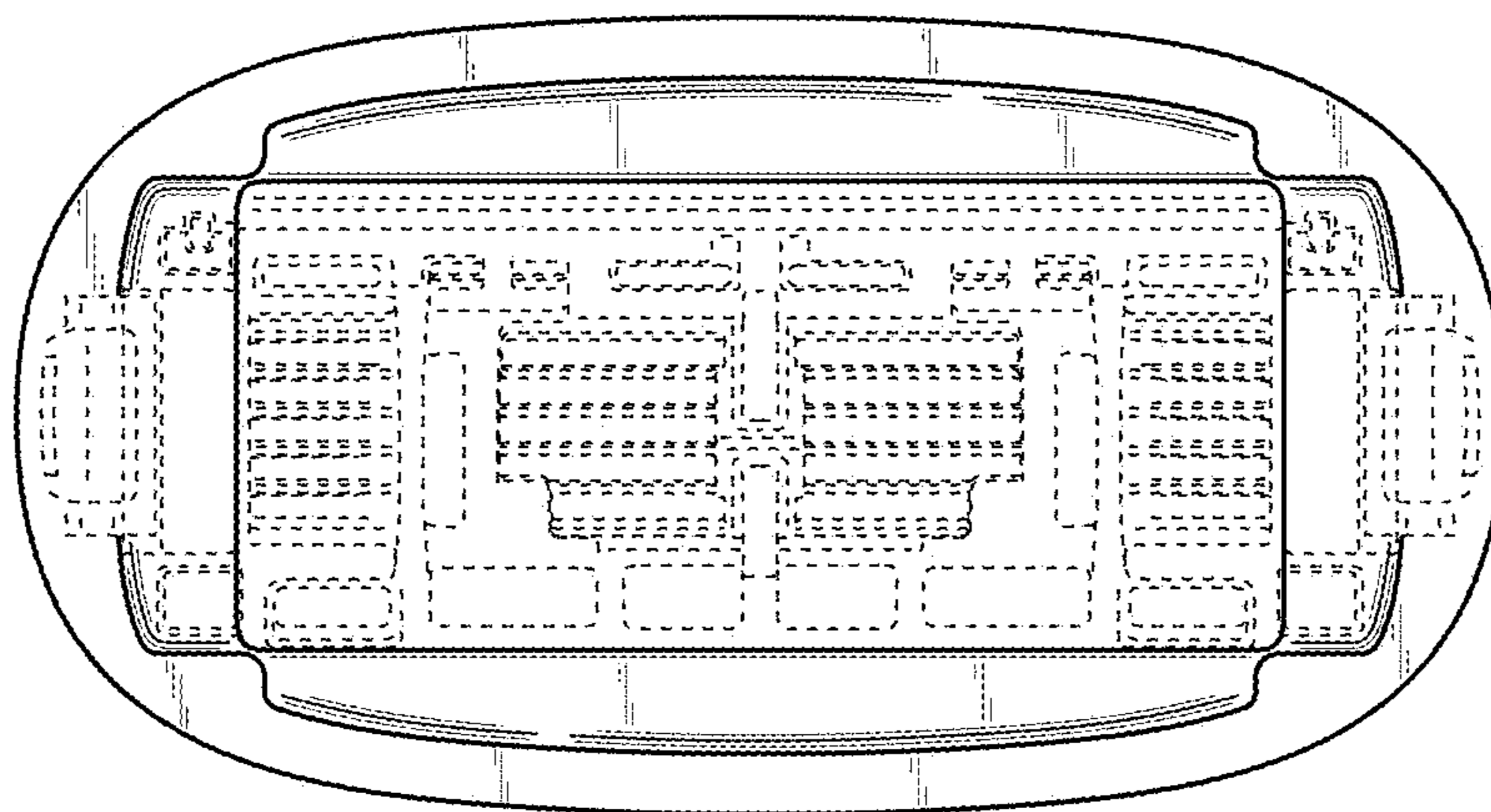

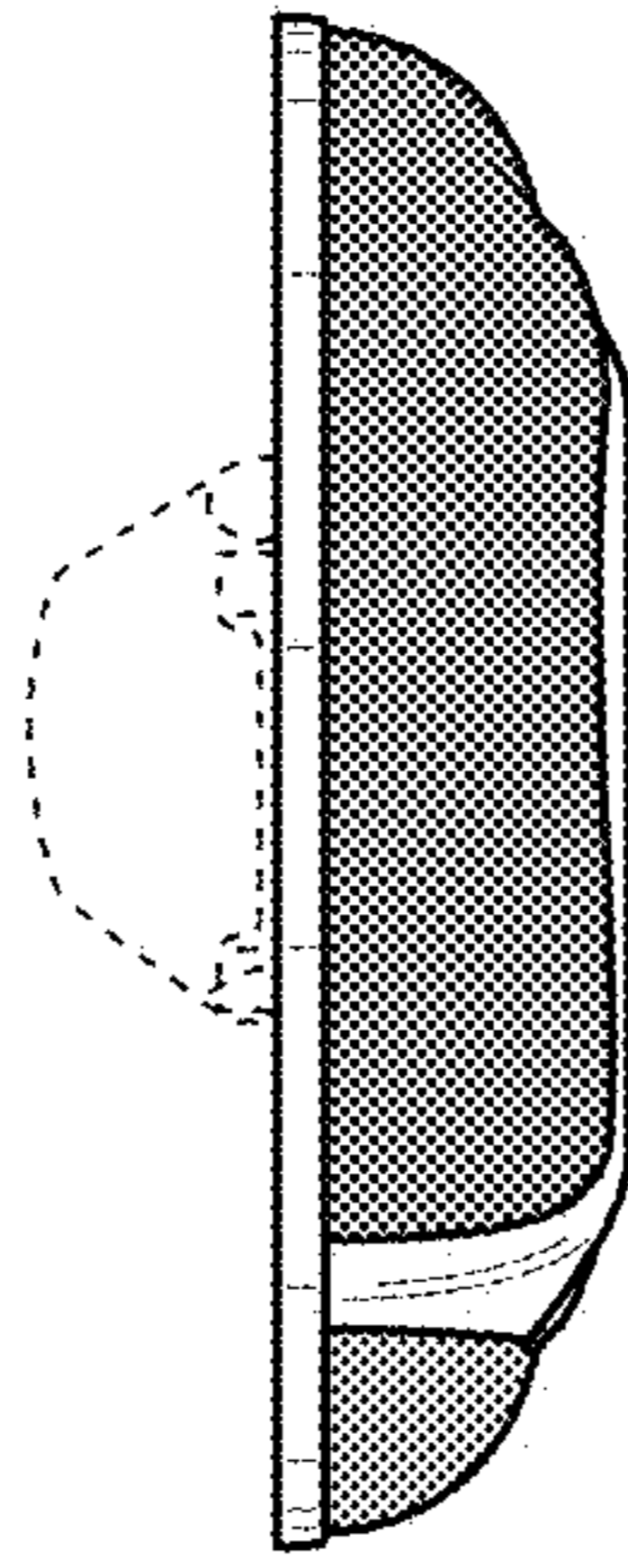

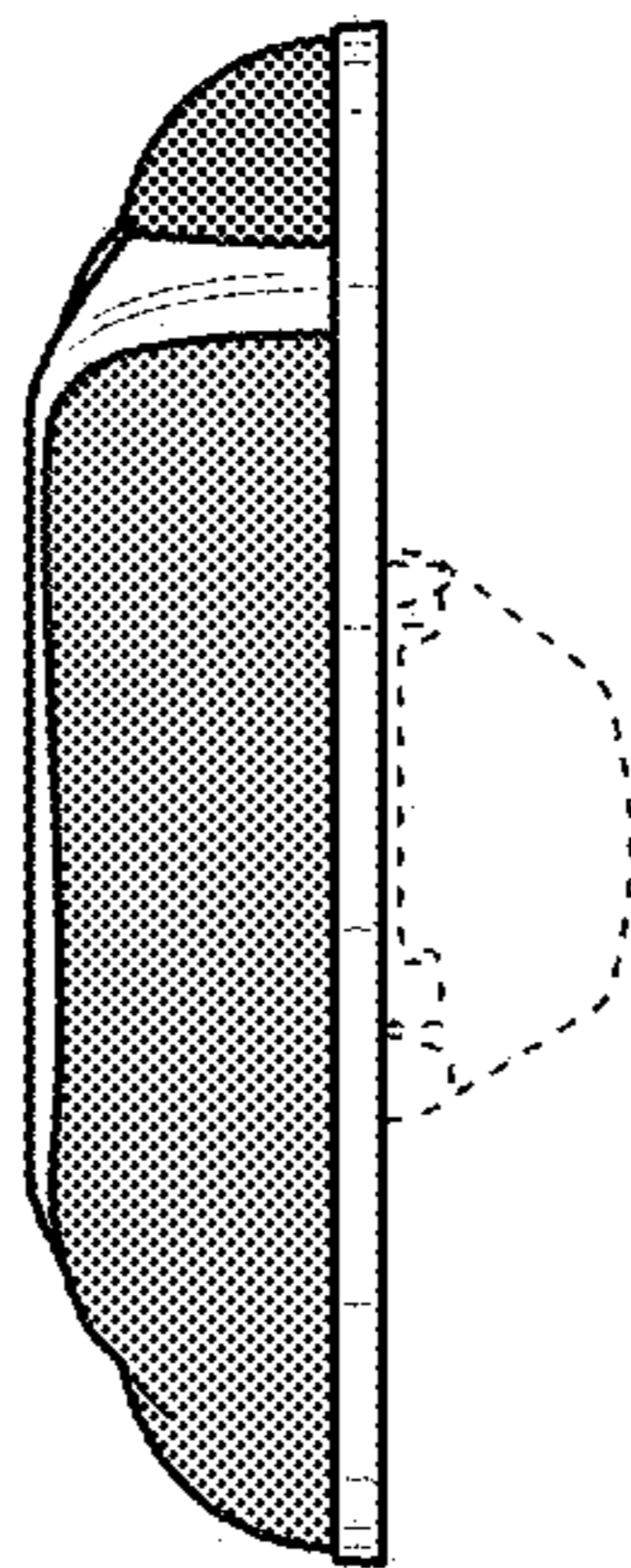

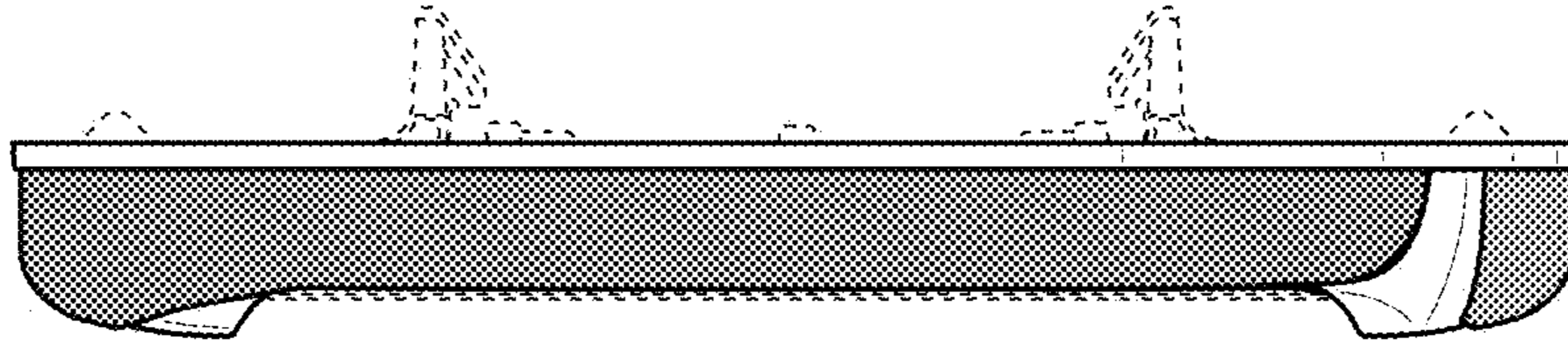

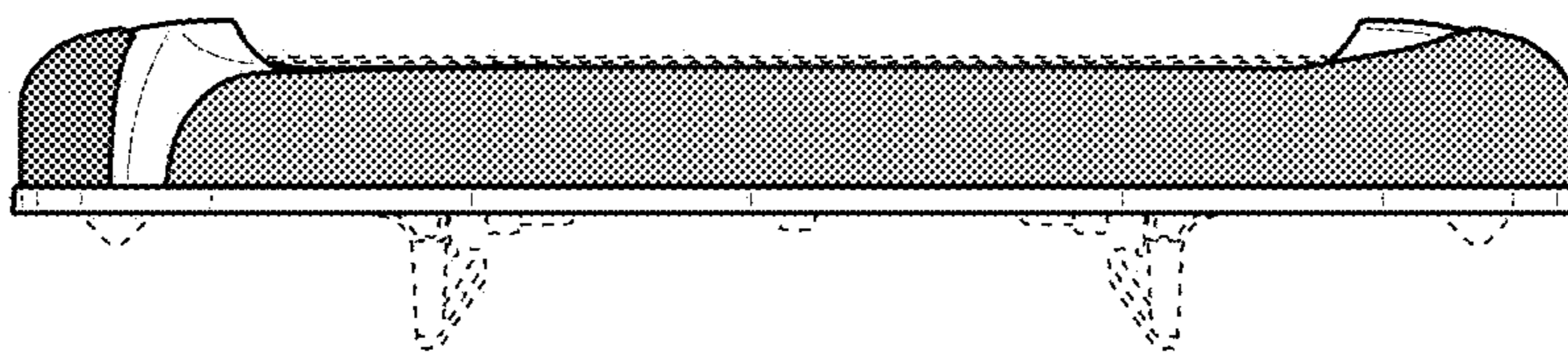

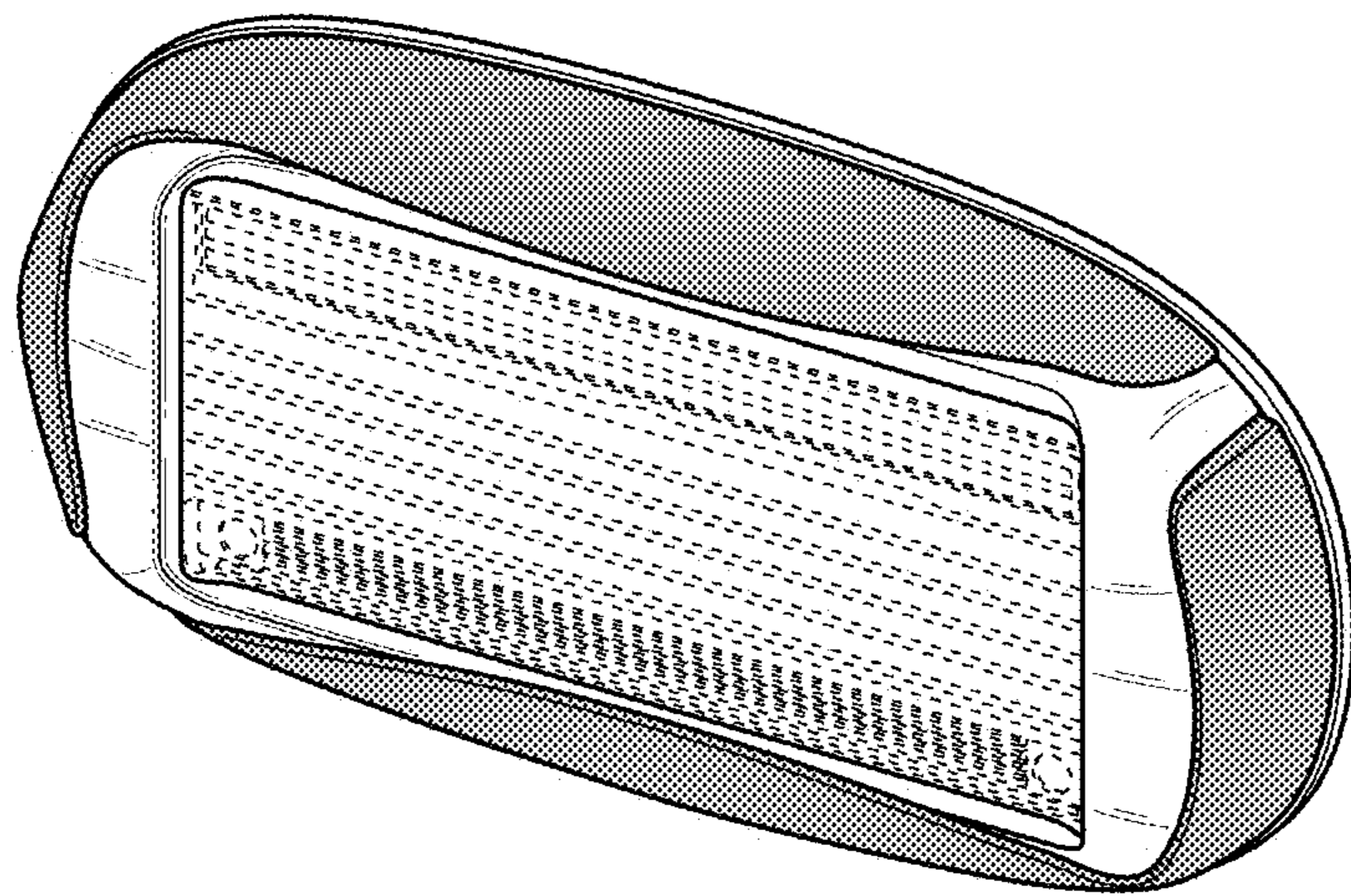

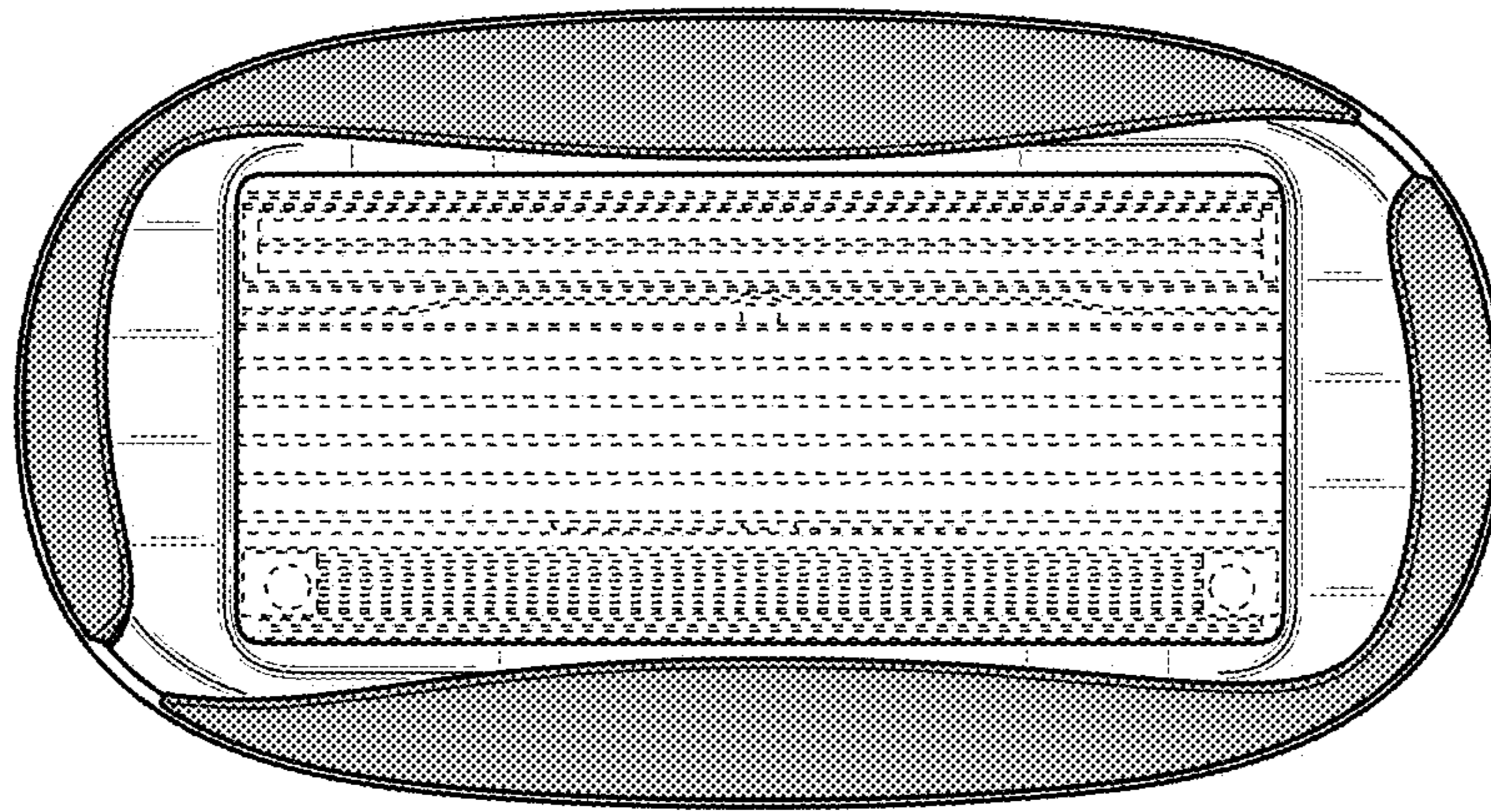

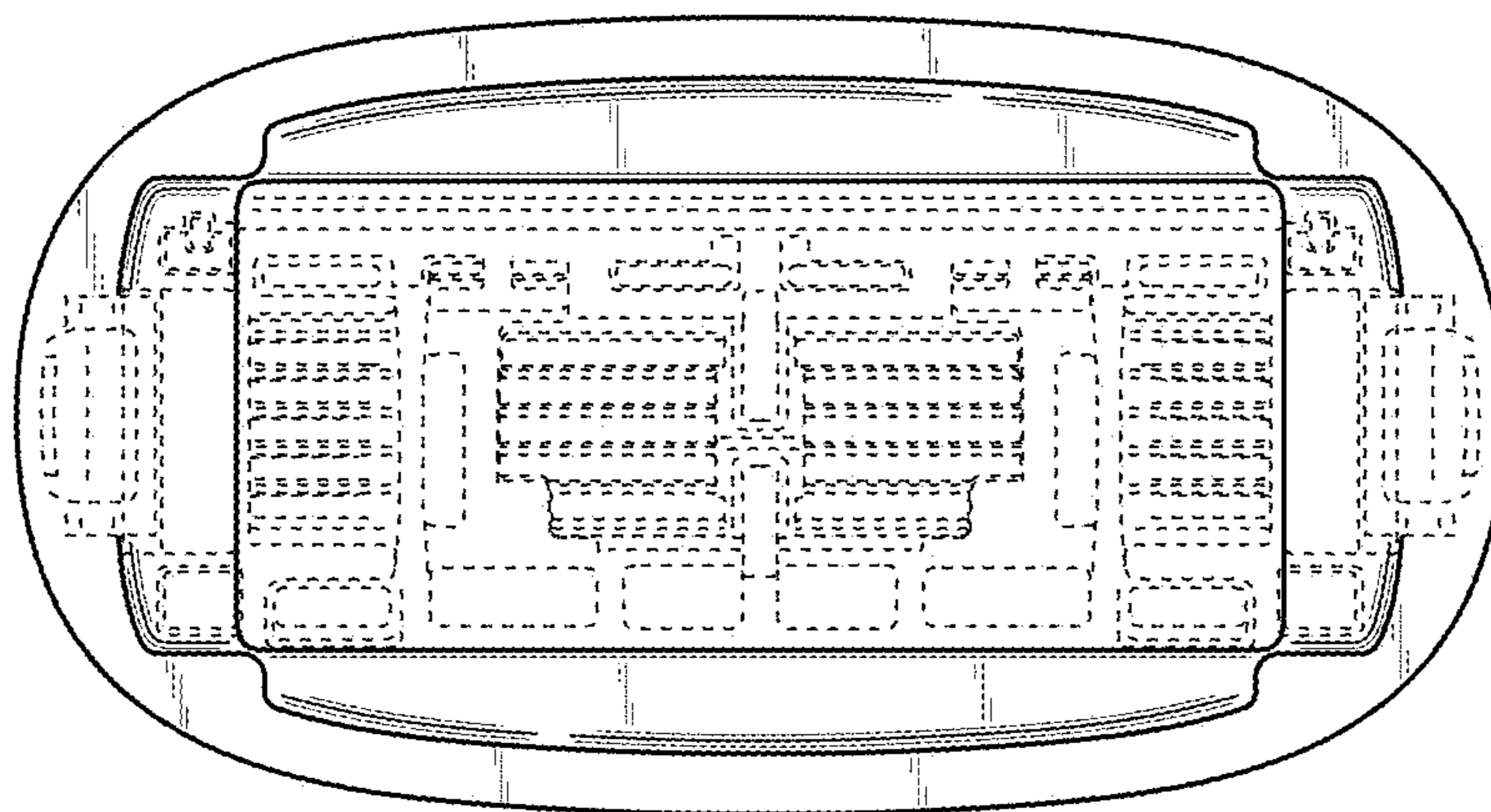

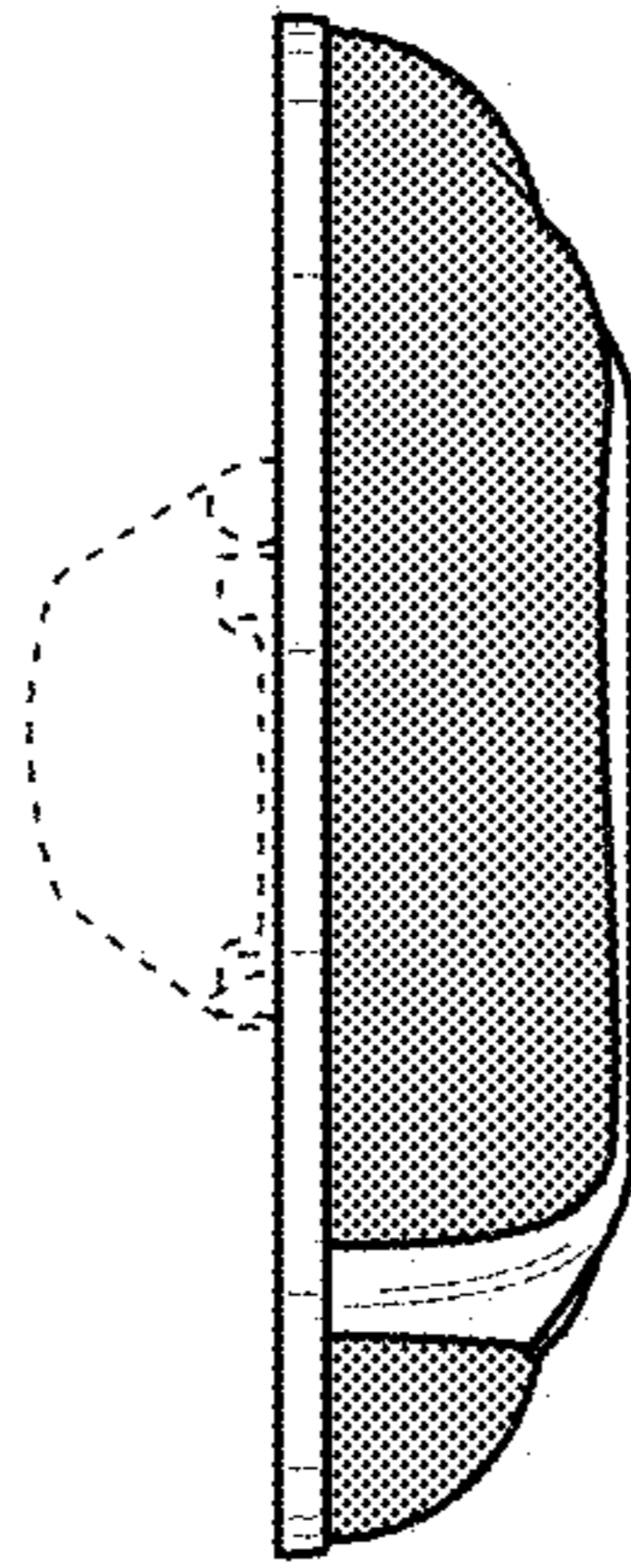

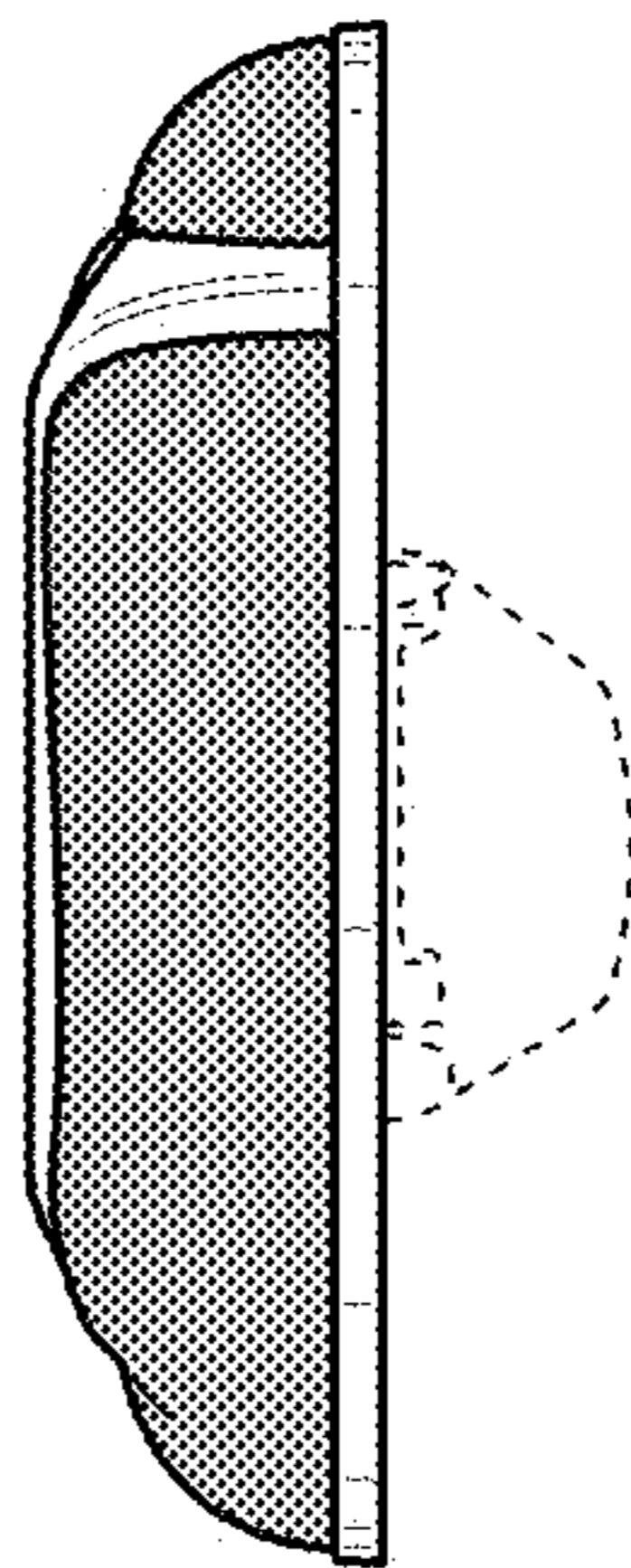

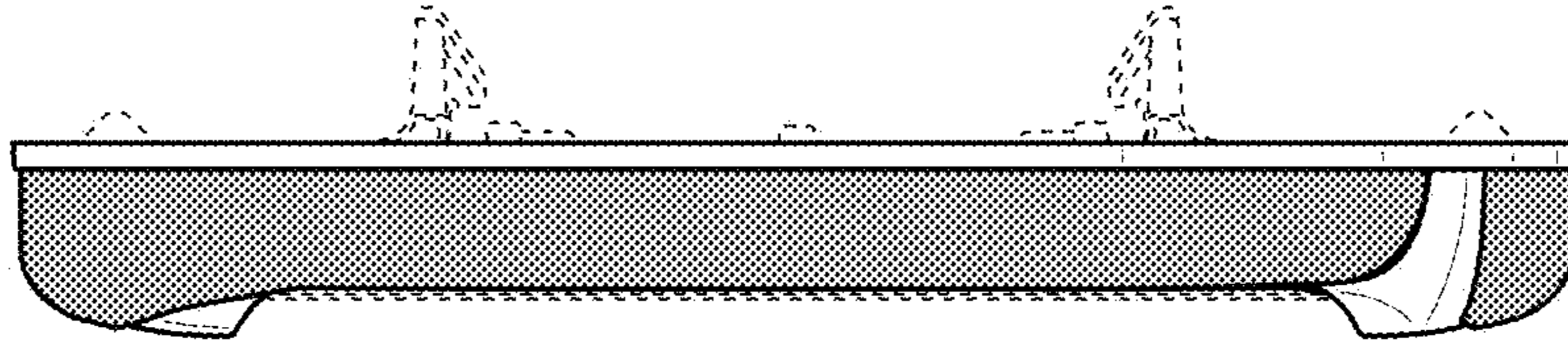

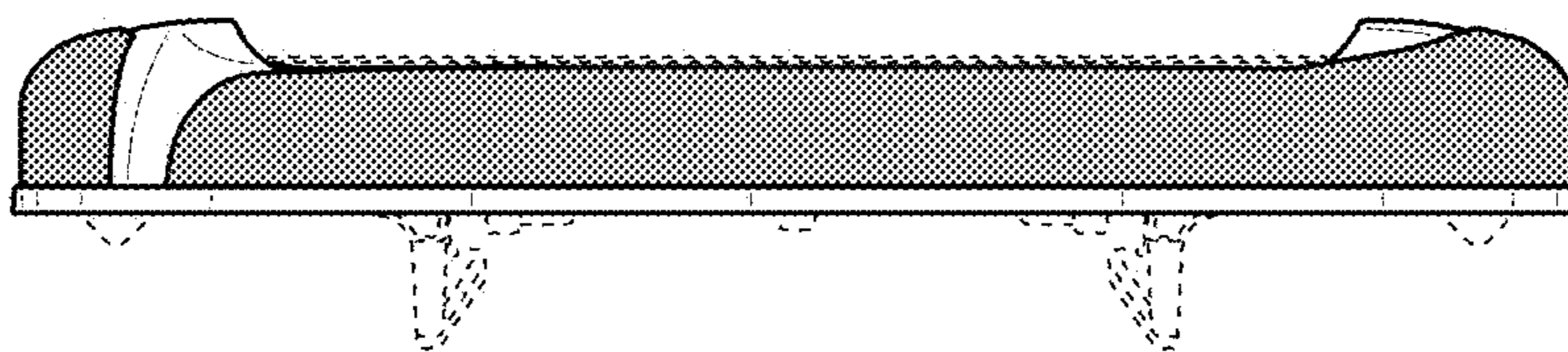

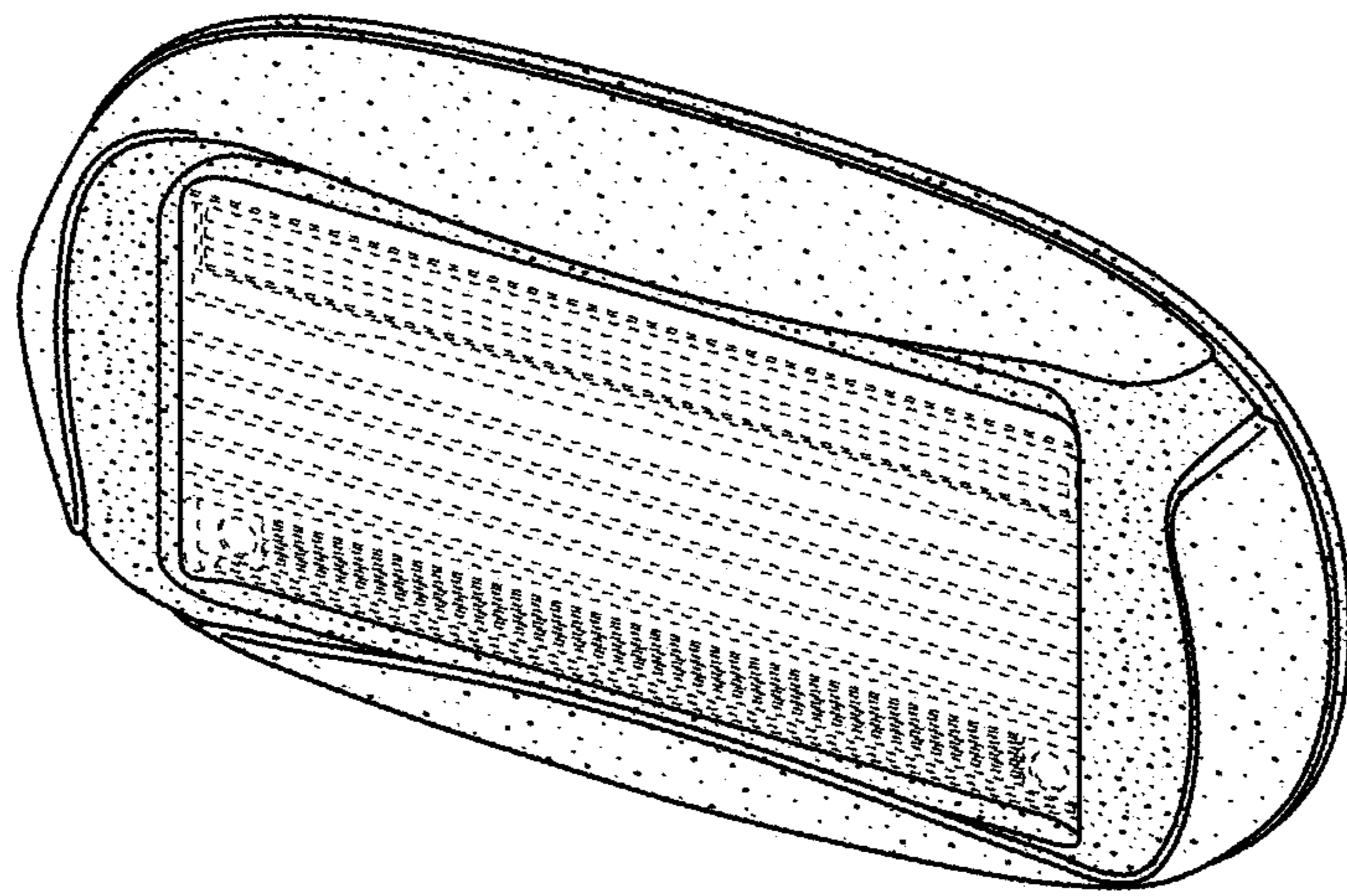

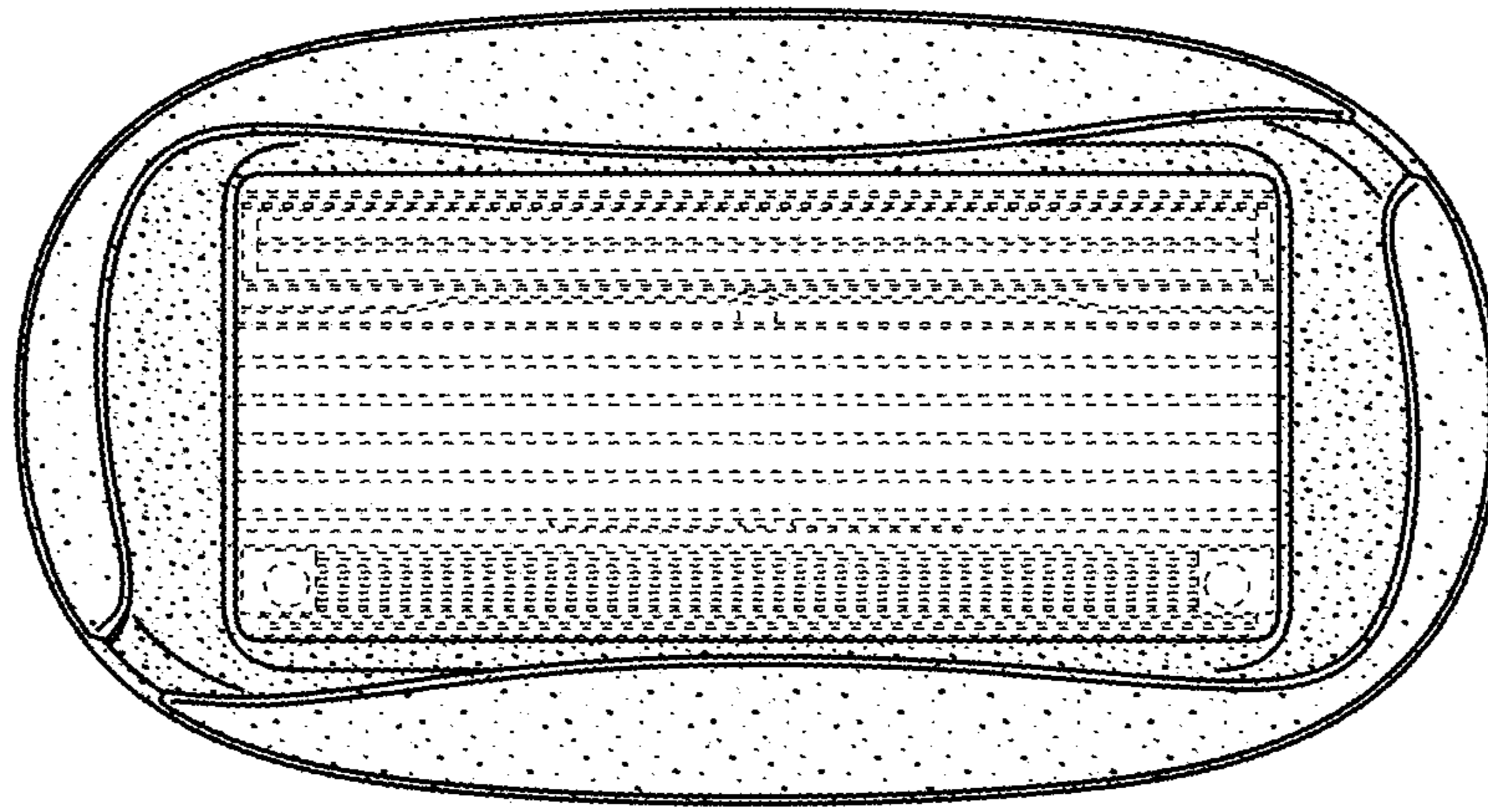

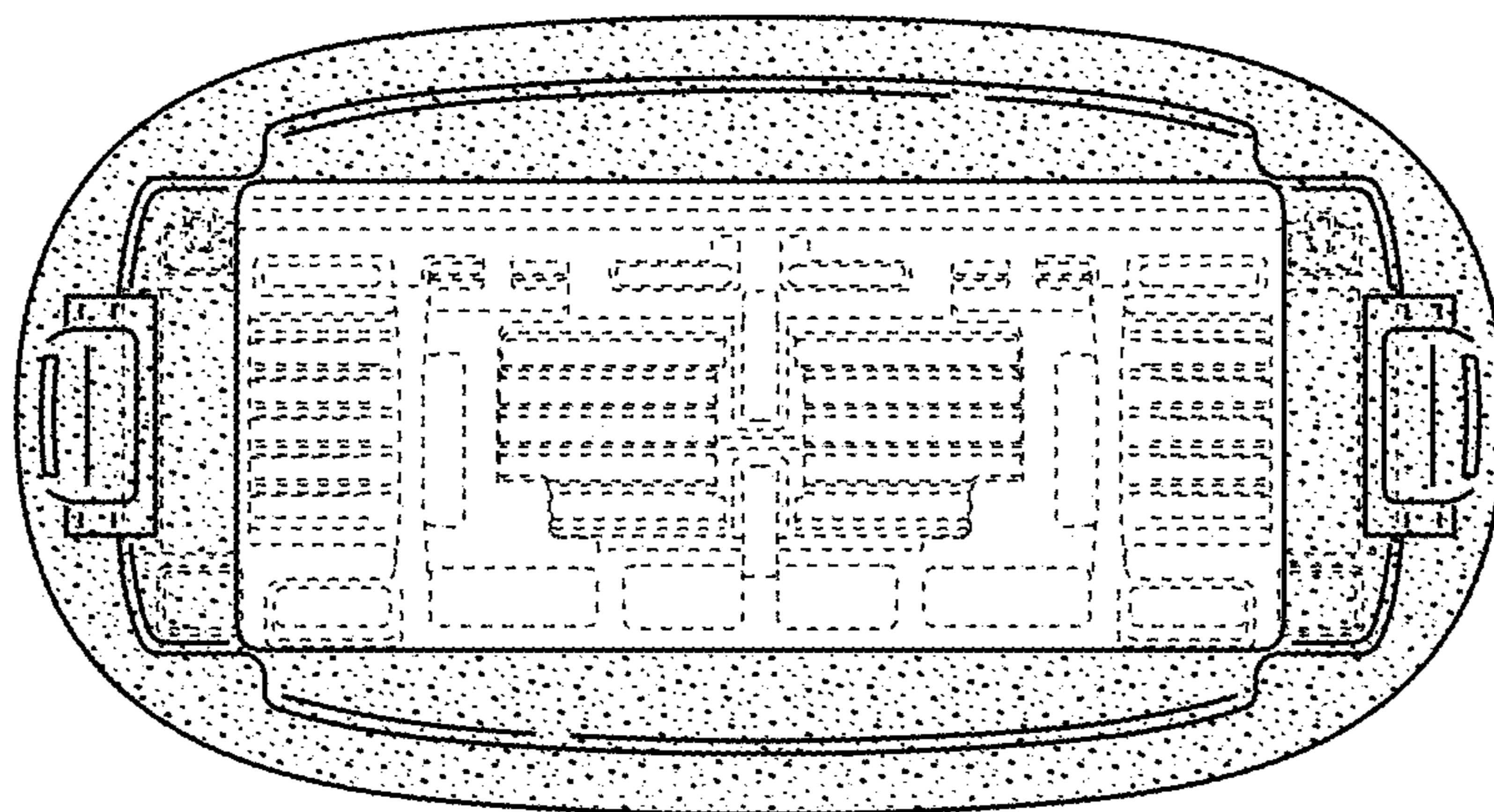

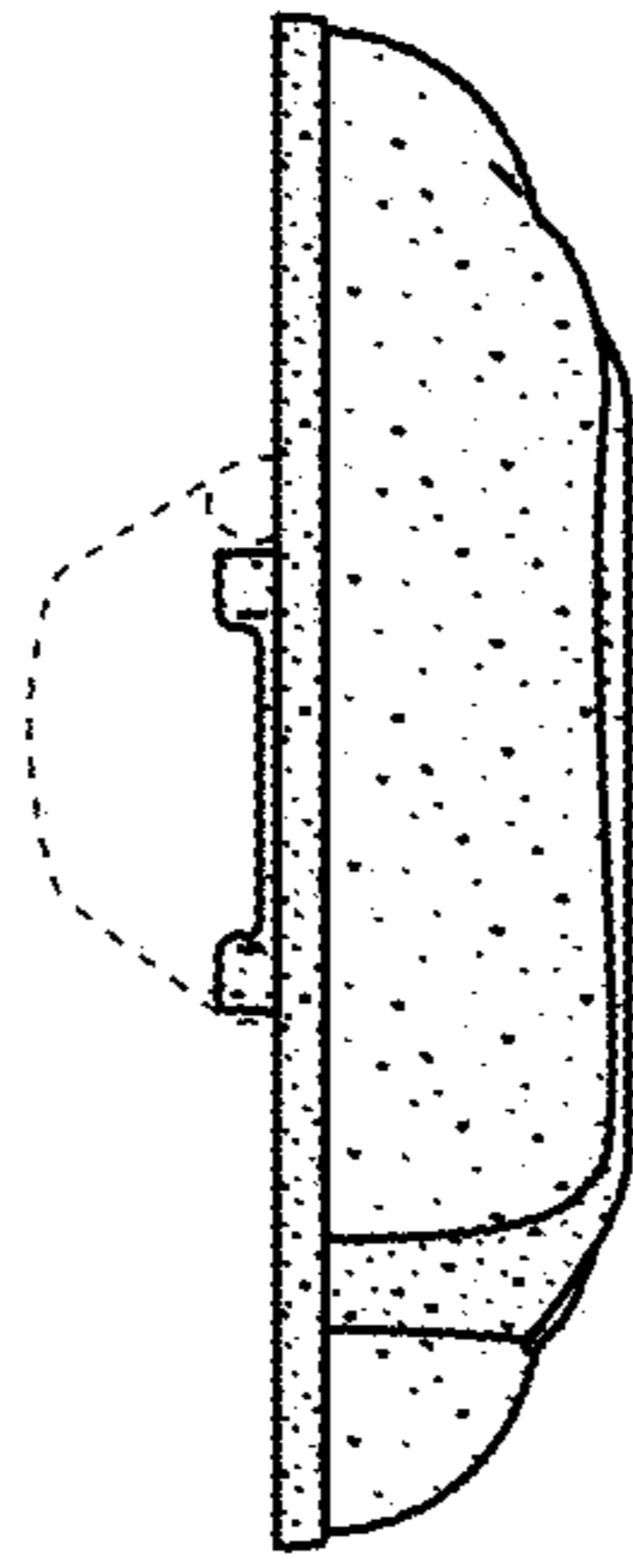

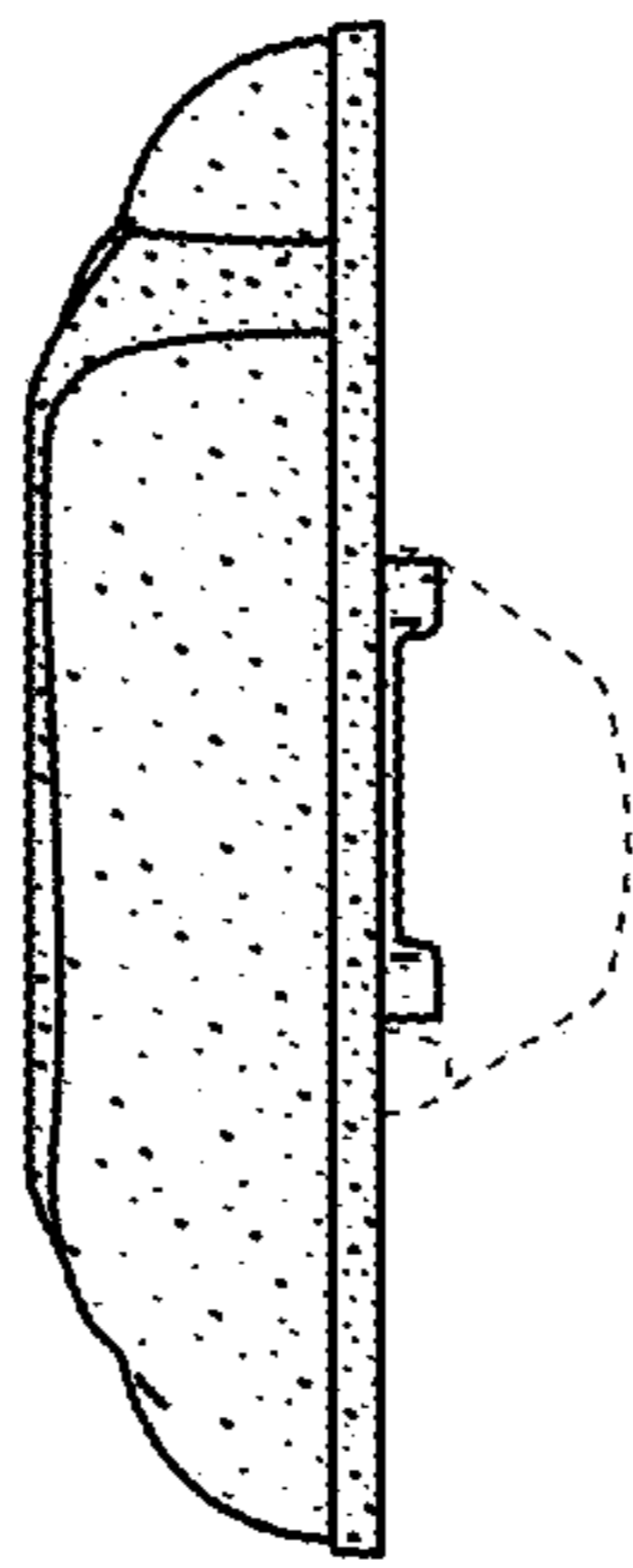

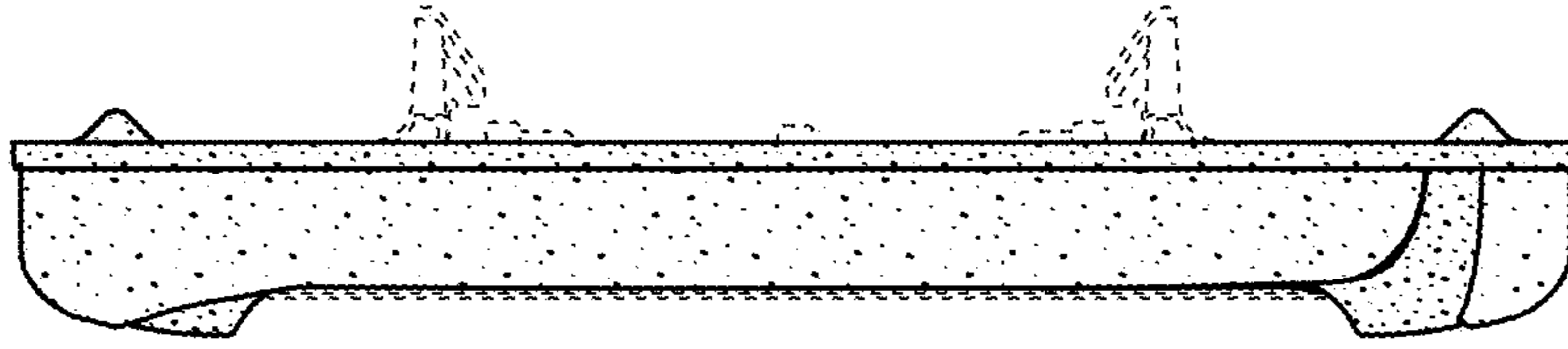

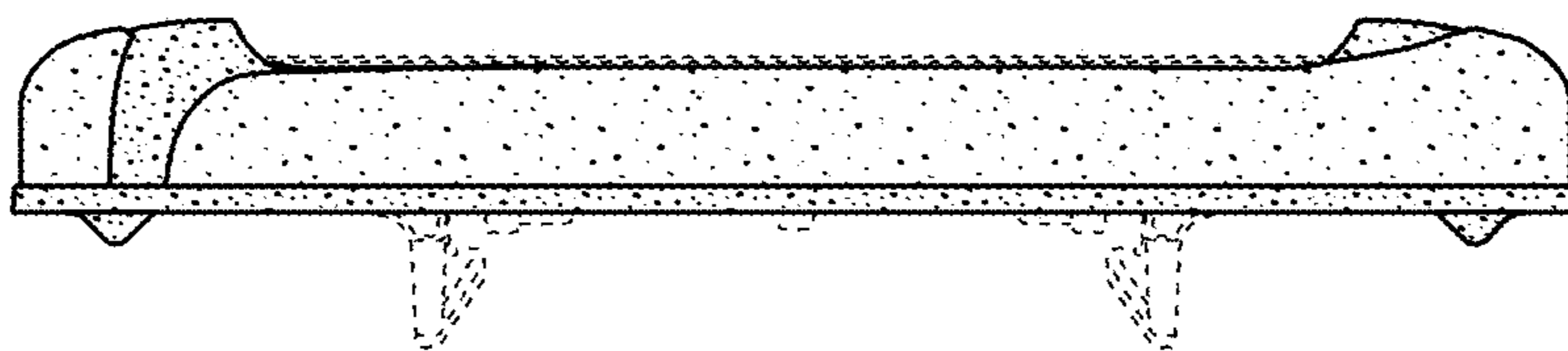

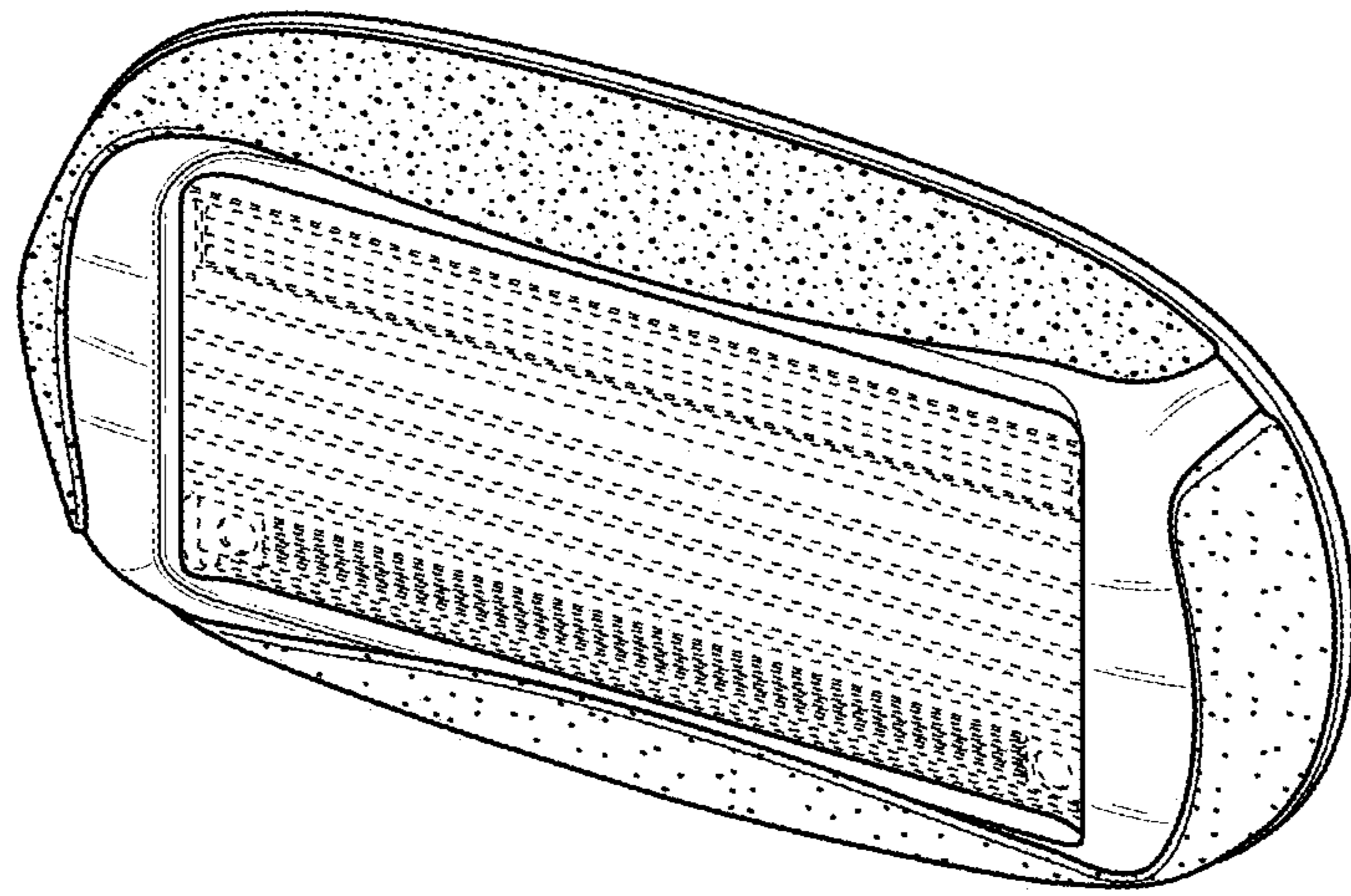

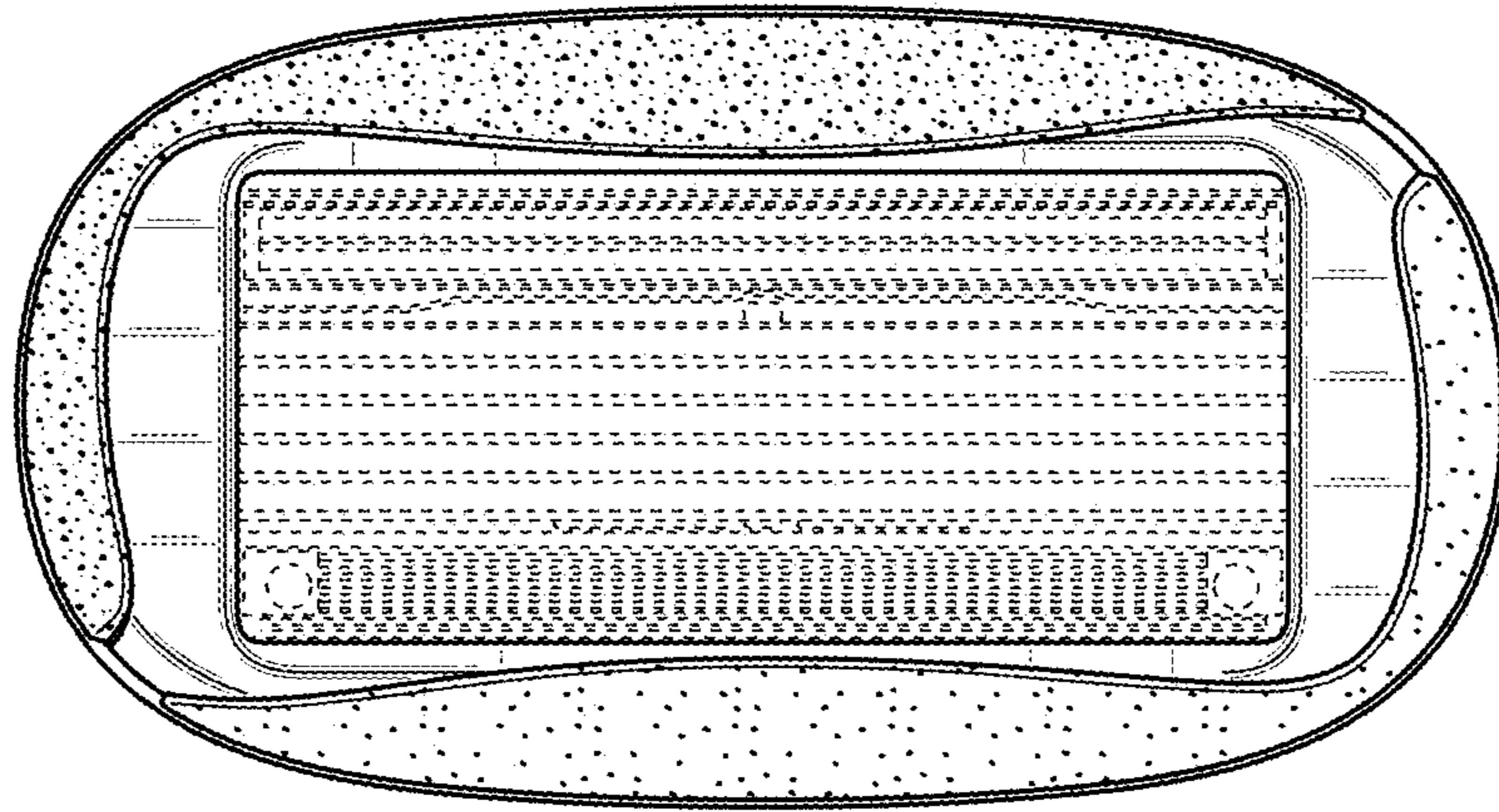

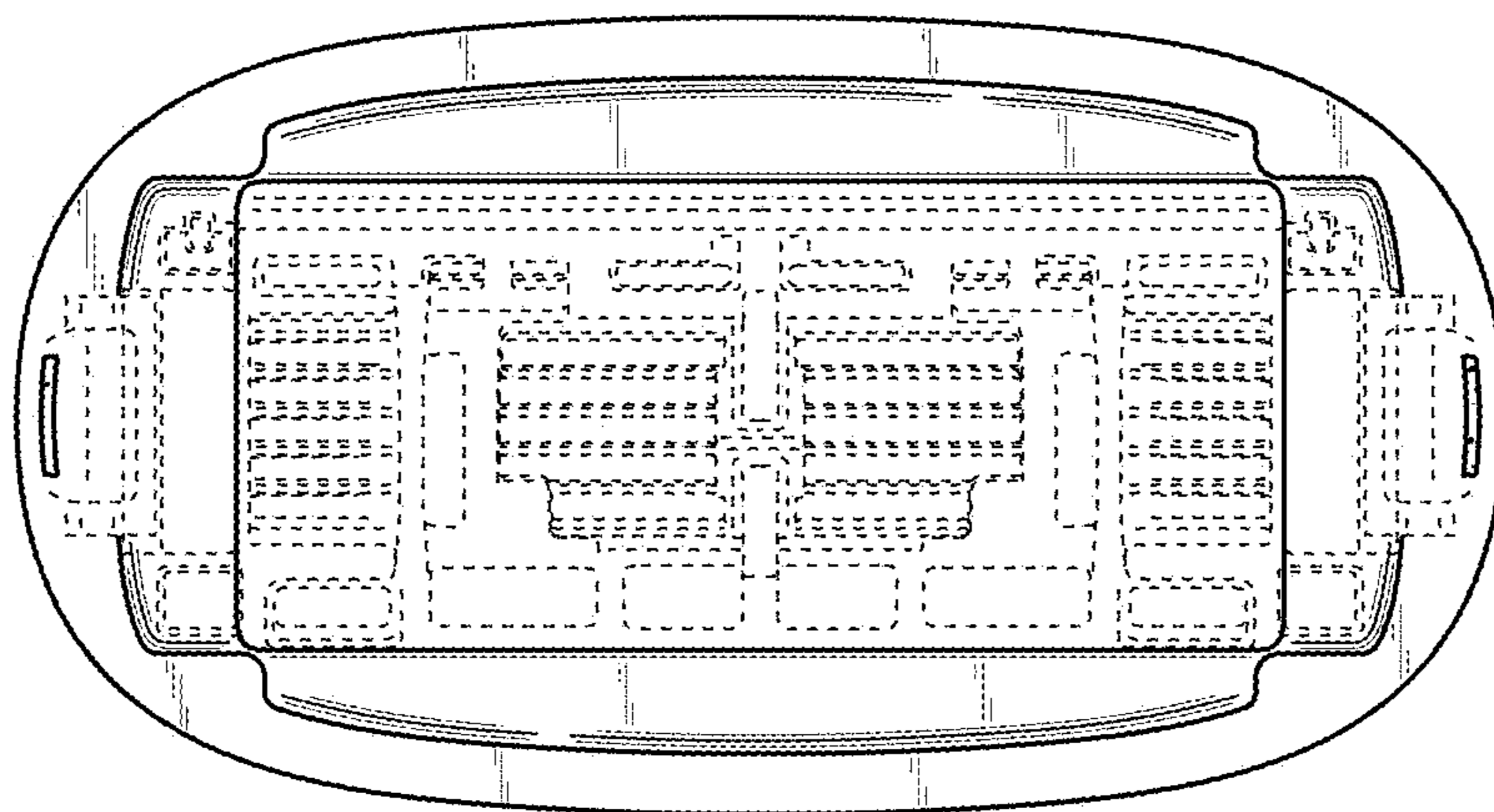

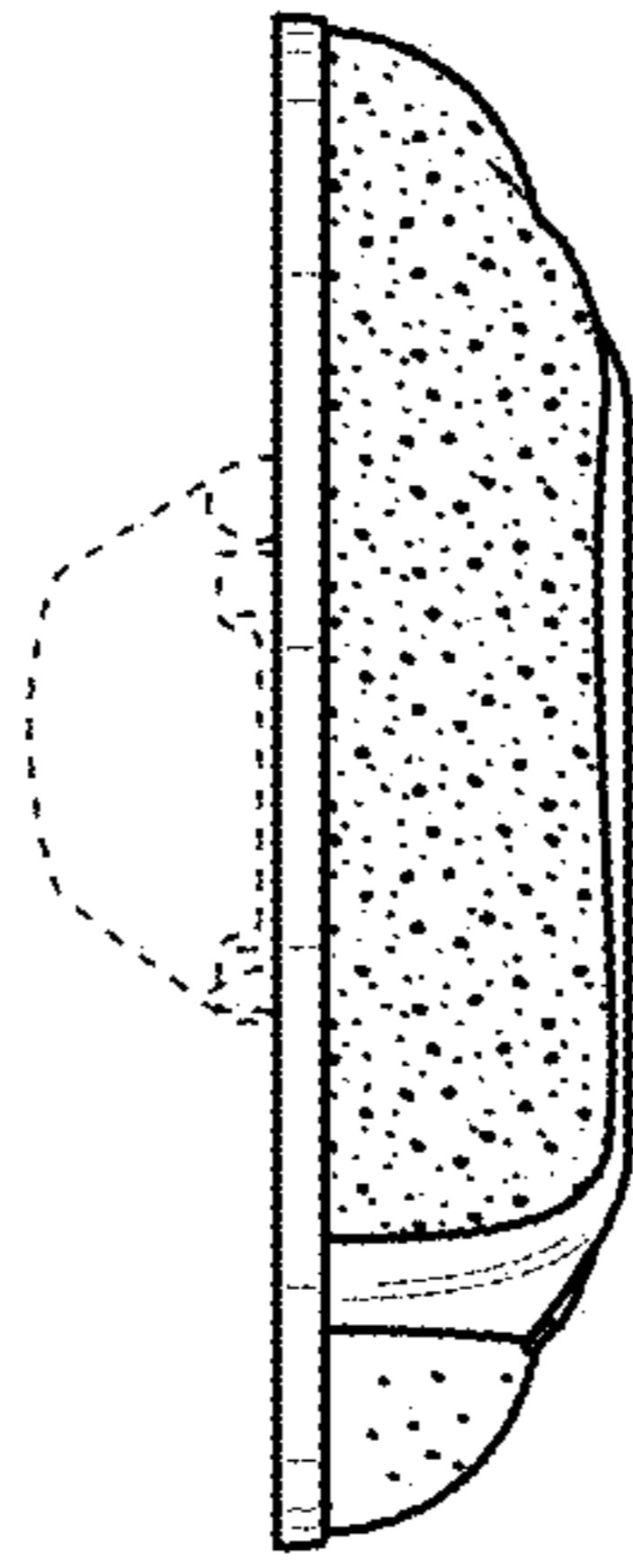

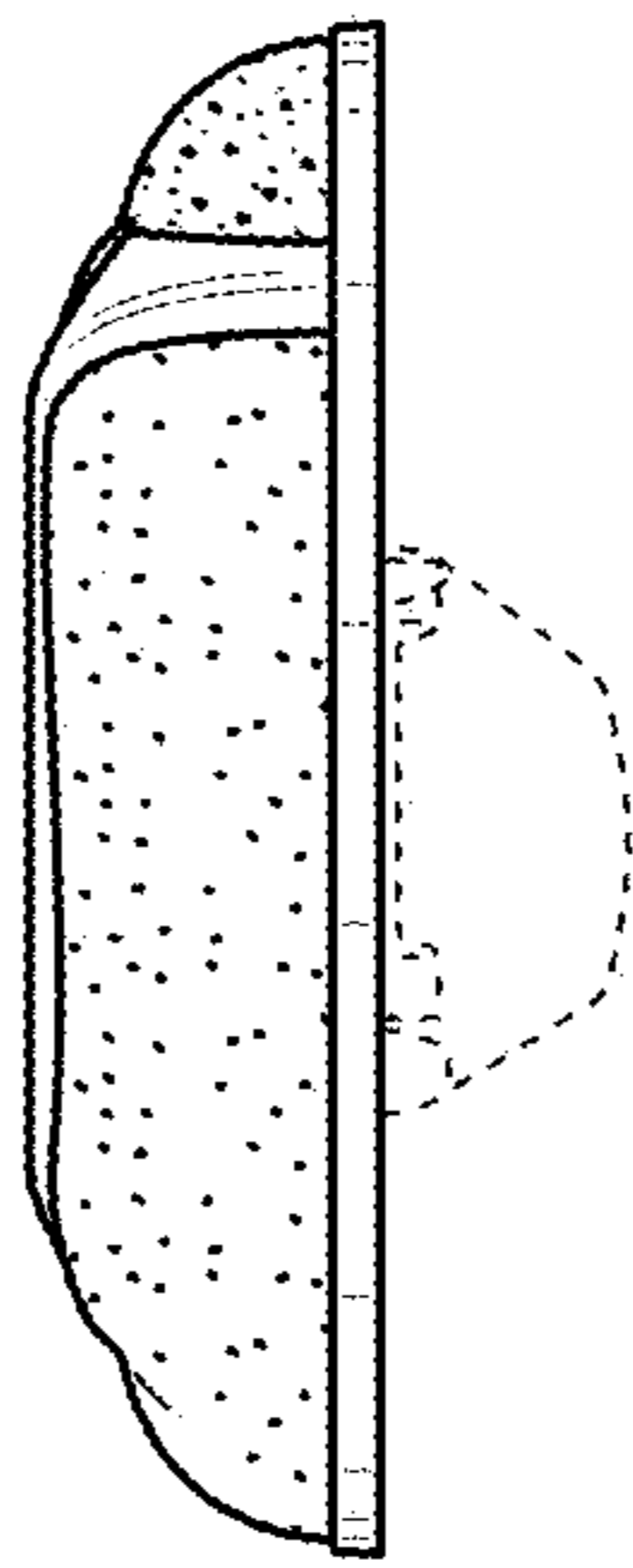

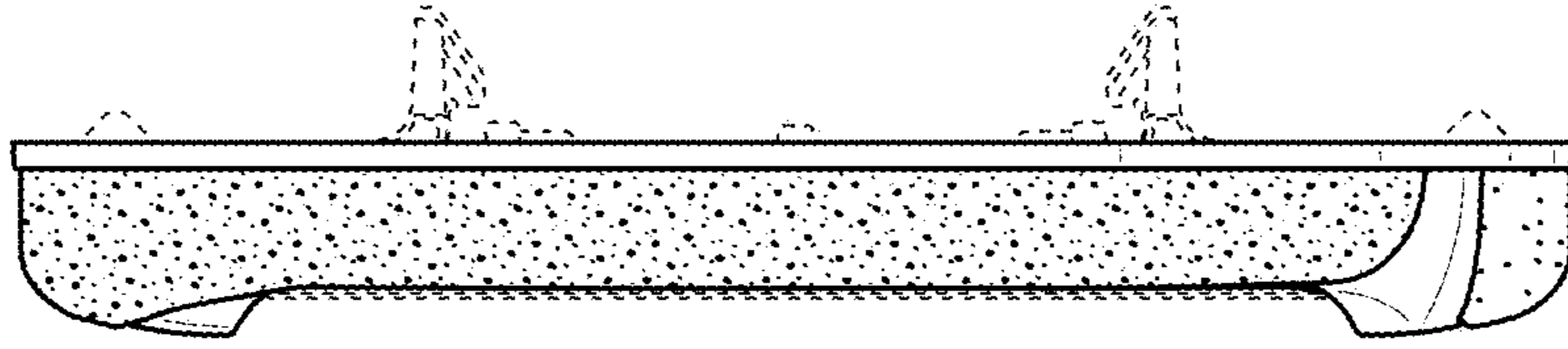

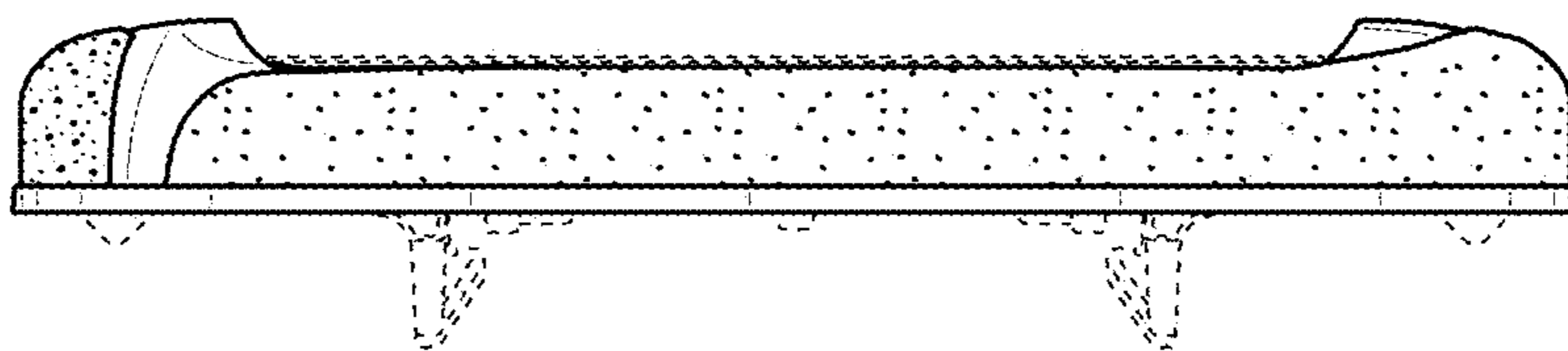
