(57) **CLAIM**

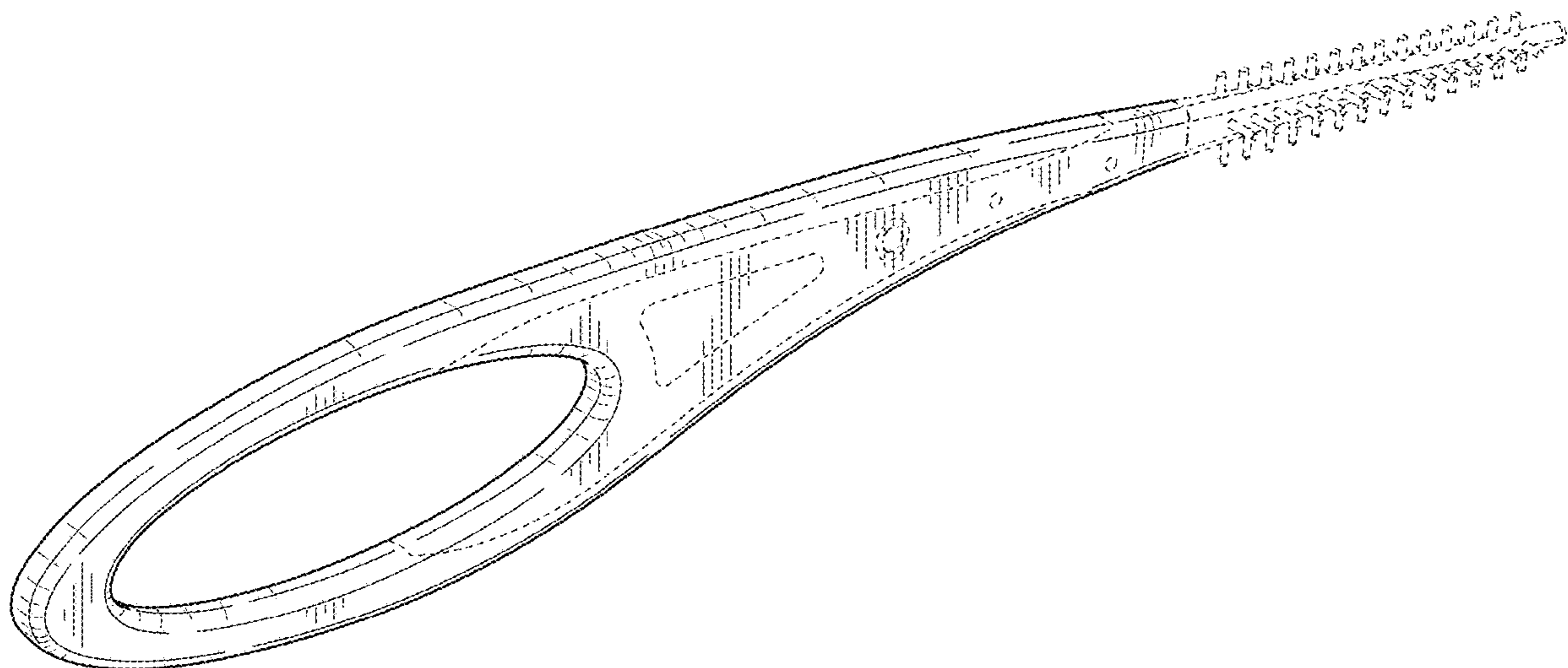
The ornamental design for an oral care device, as shown and described.

DESCRIPTION

FIG. 1 is a rear right perspective view of an oral care device showing my new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The dashed broken lines in FIGS. 1-7 show portions of the oral care device that form no part of the claimed design. The dashed-dotted broken lines in FIGS. 1-3, 6, and 7 show unclaimed boundaries between claimed and unclaimed portions of the oral care device.

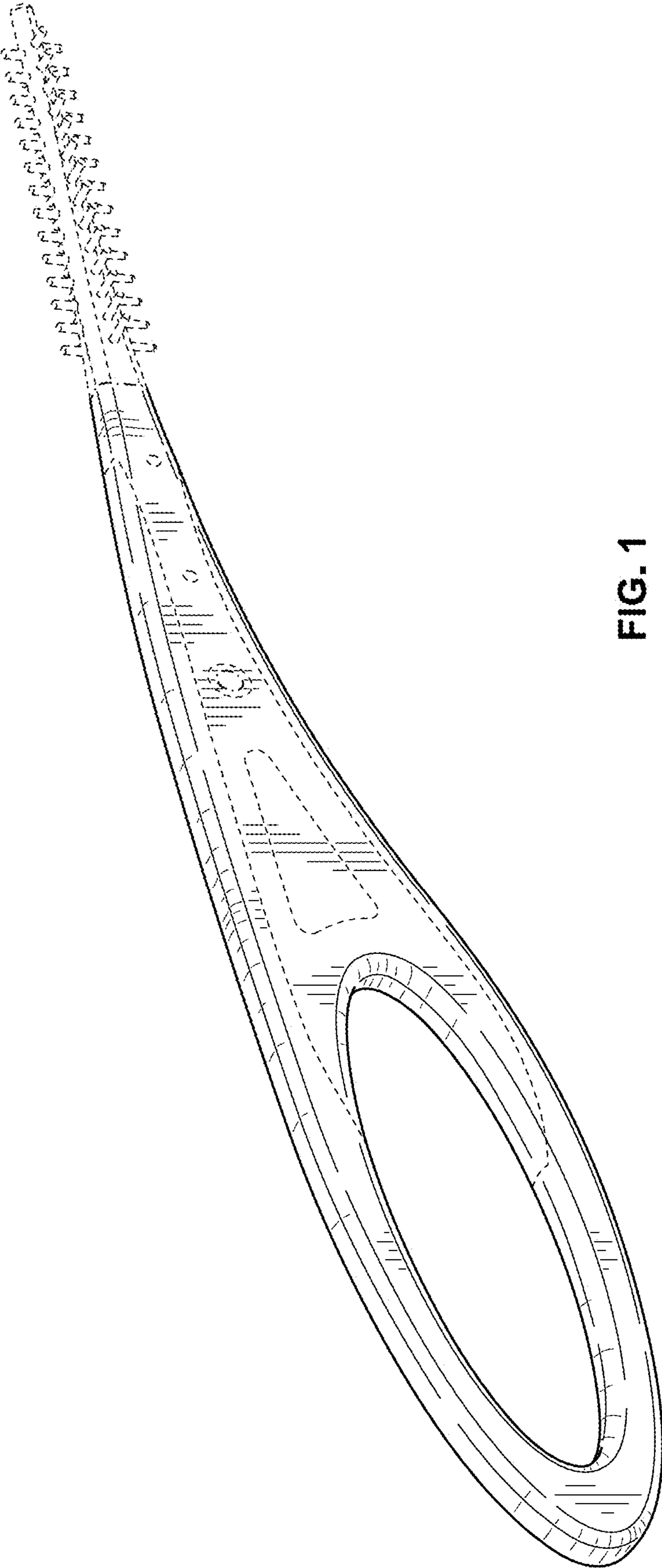

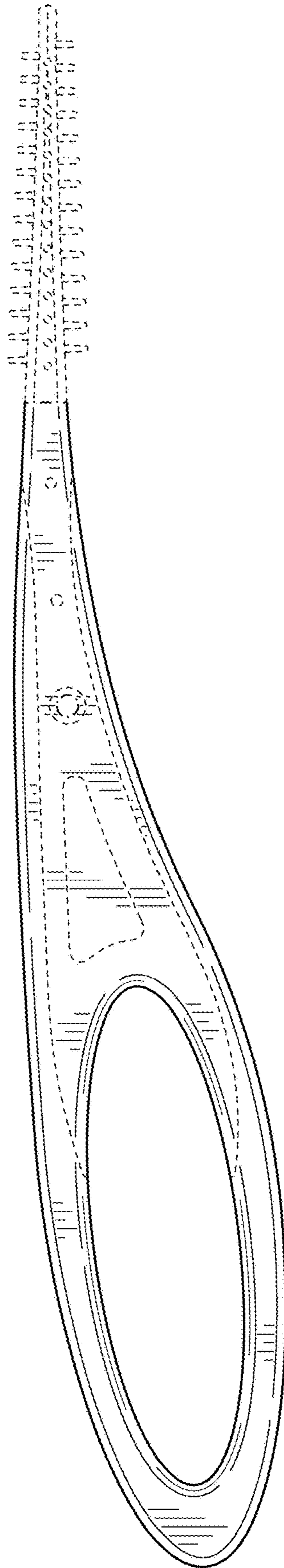

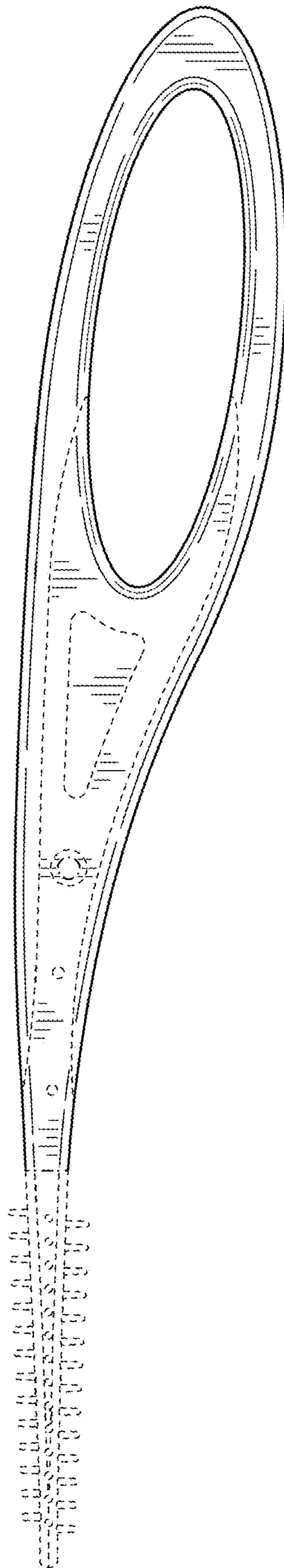

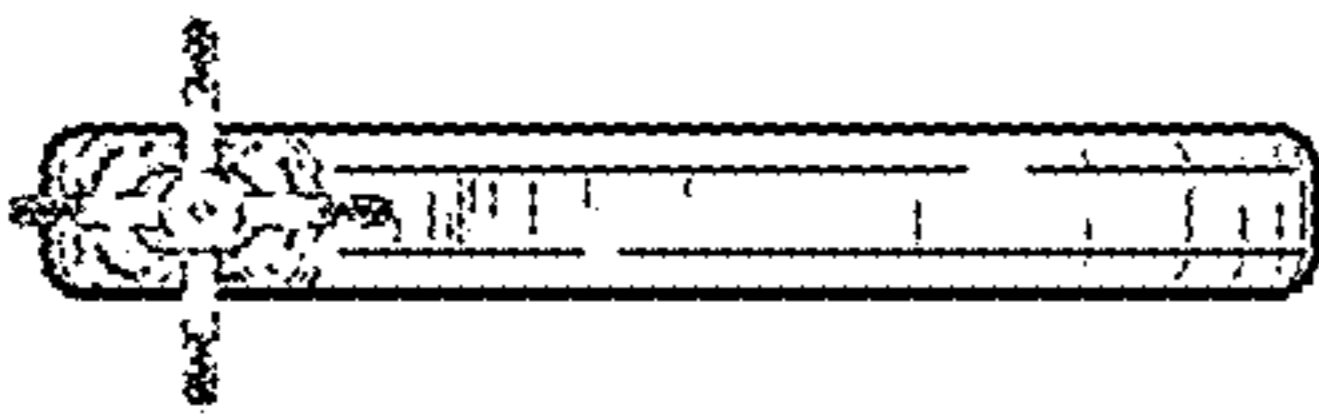

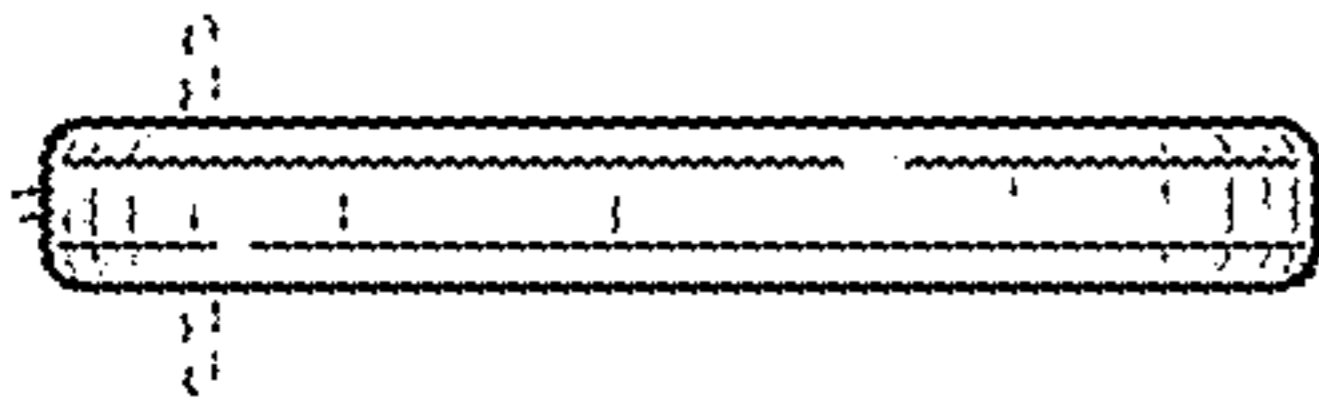

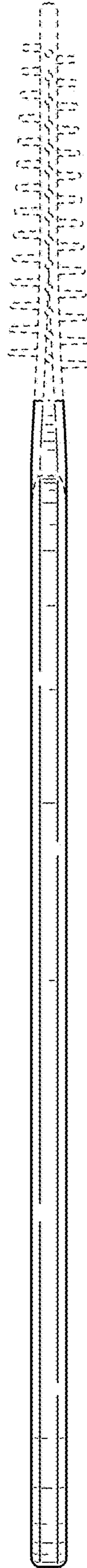

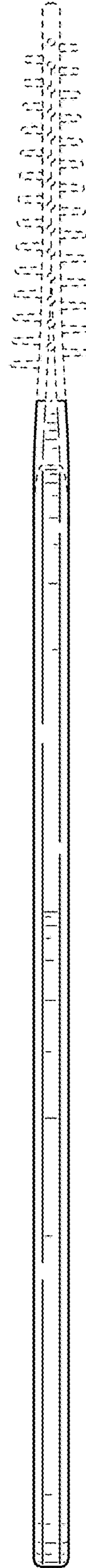
