DESCRIPTION

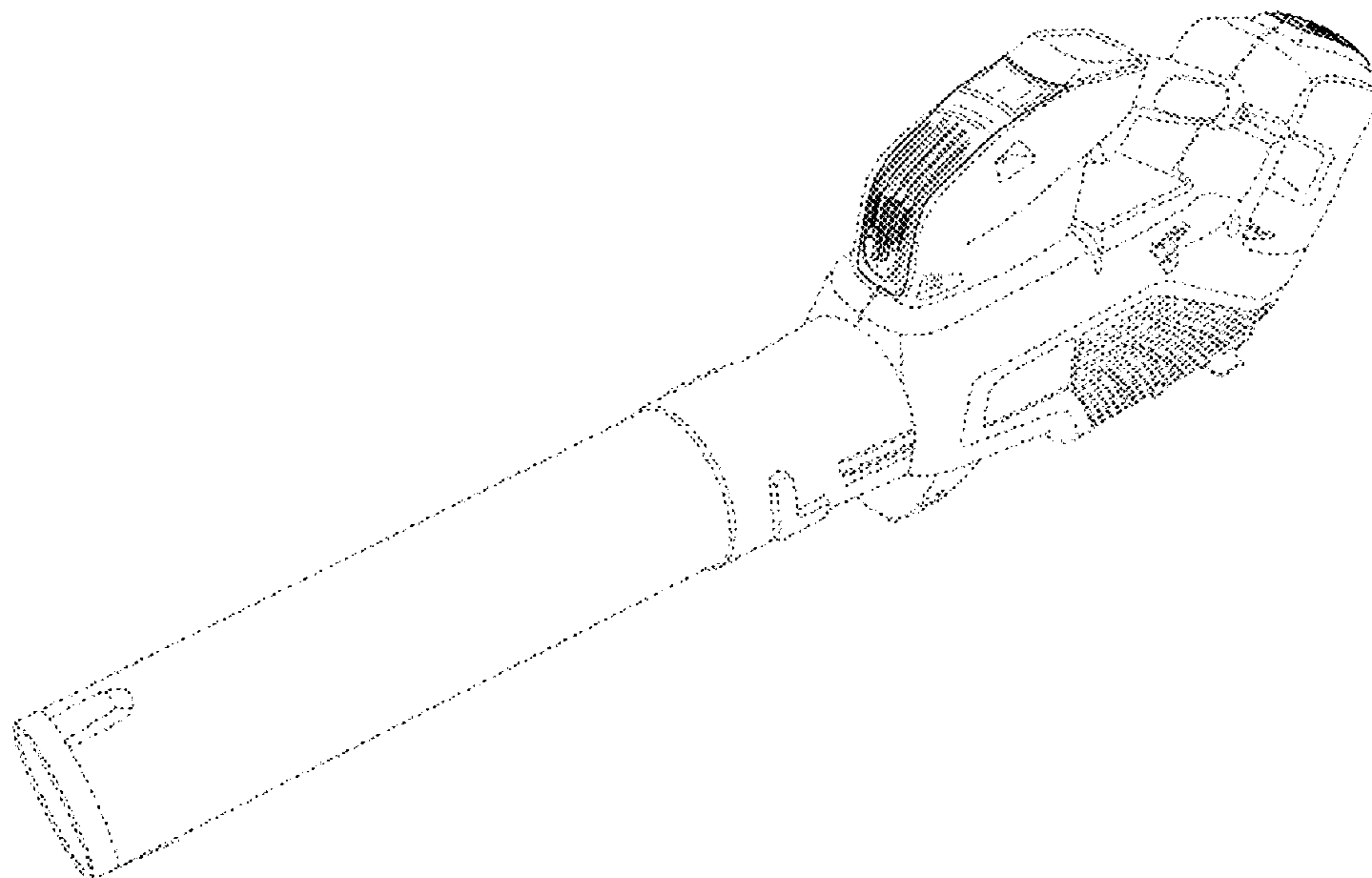
FIG. 1 is a perspective view of a blower having an air outlet in accordance with an embodiment of the present invention; FIG. 2 is a front view of the blower of FIG. 1; FIG. 3 is a rear view of the blower of FIG. 1; FIG. 4 is a left side view of the blower of FIG. 1; FIG. 5 is a right side view of the blower of FIG. 1; FIG. 6 is a top side view of the blower of FIG. 1; and, FIG. 7 is a bottom view of the blower of FIG. 1. The broken lines of the blower in FIGS. 1-7 are illustrative of the visible environmental structure of the blower and form no part of the claimed design.

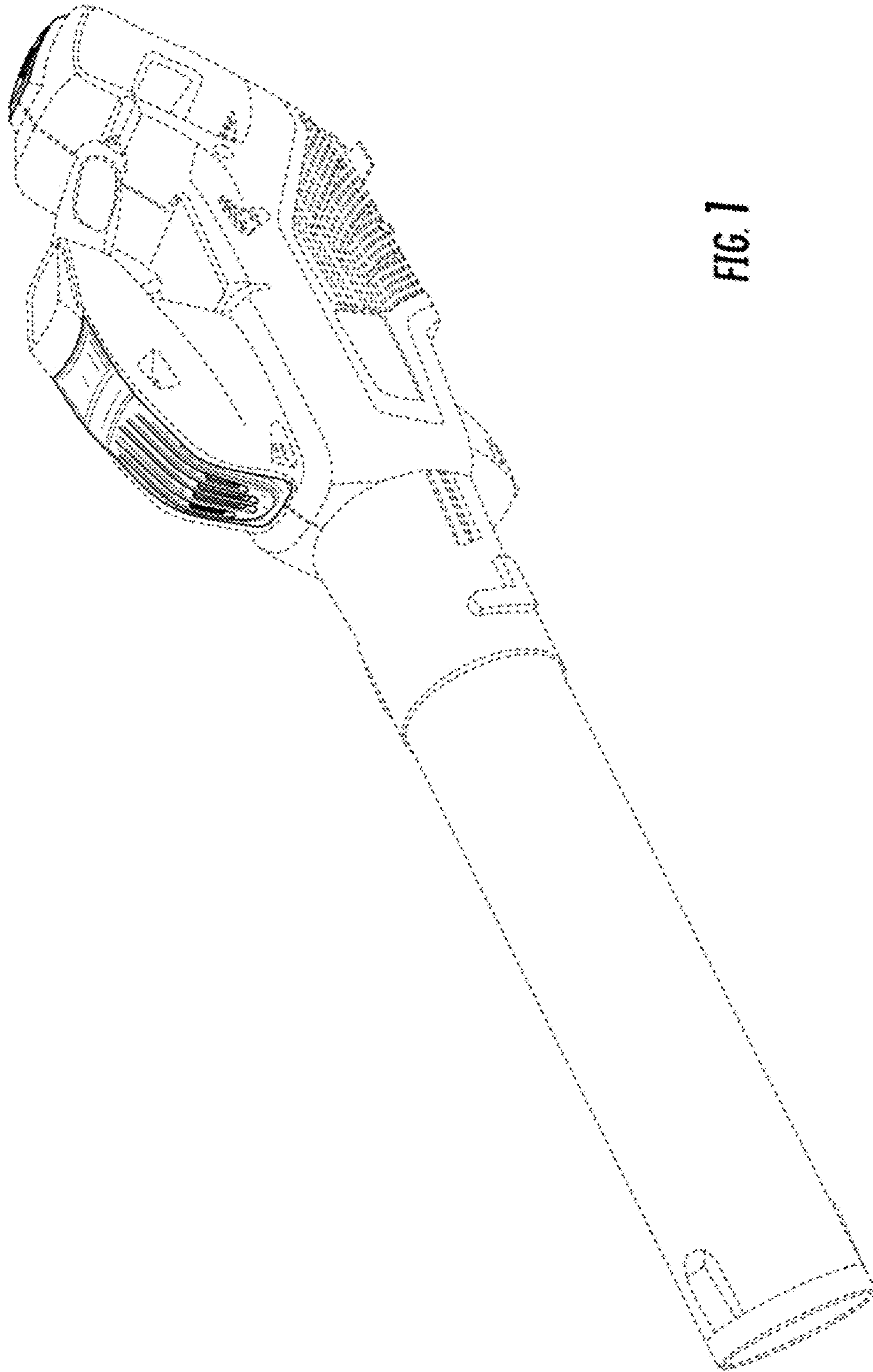

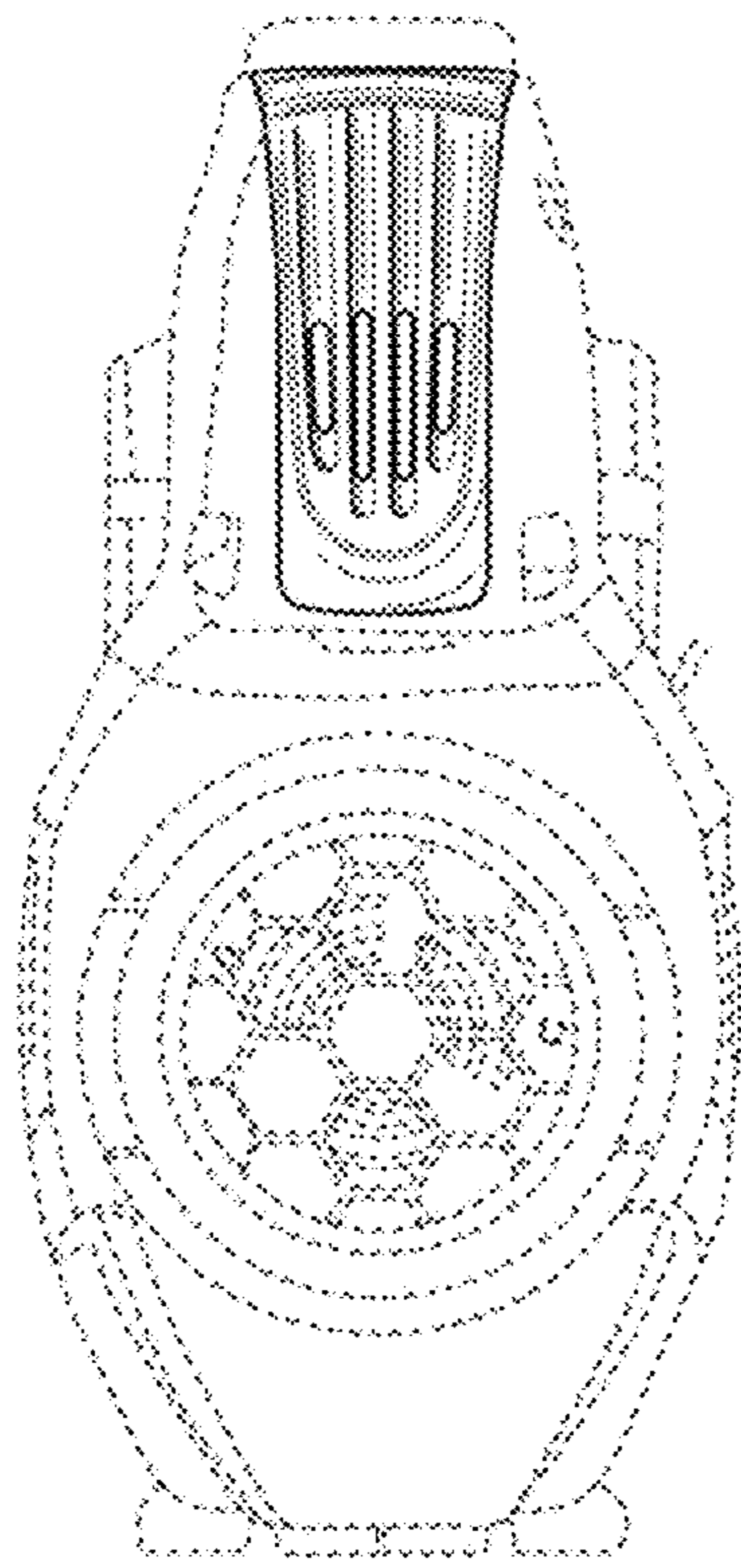

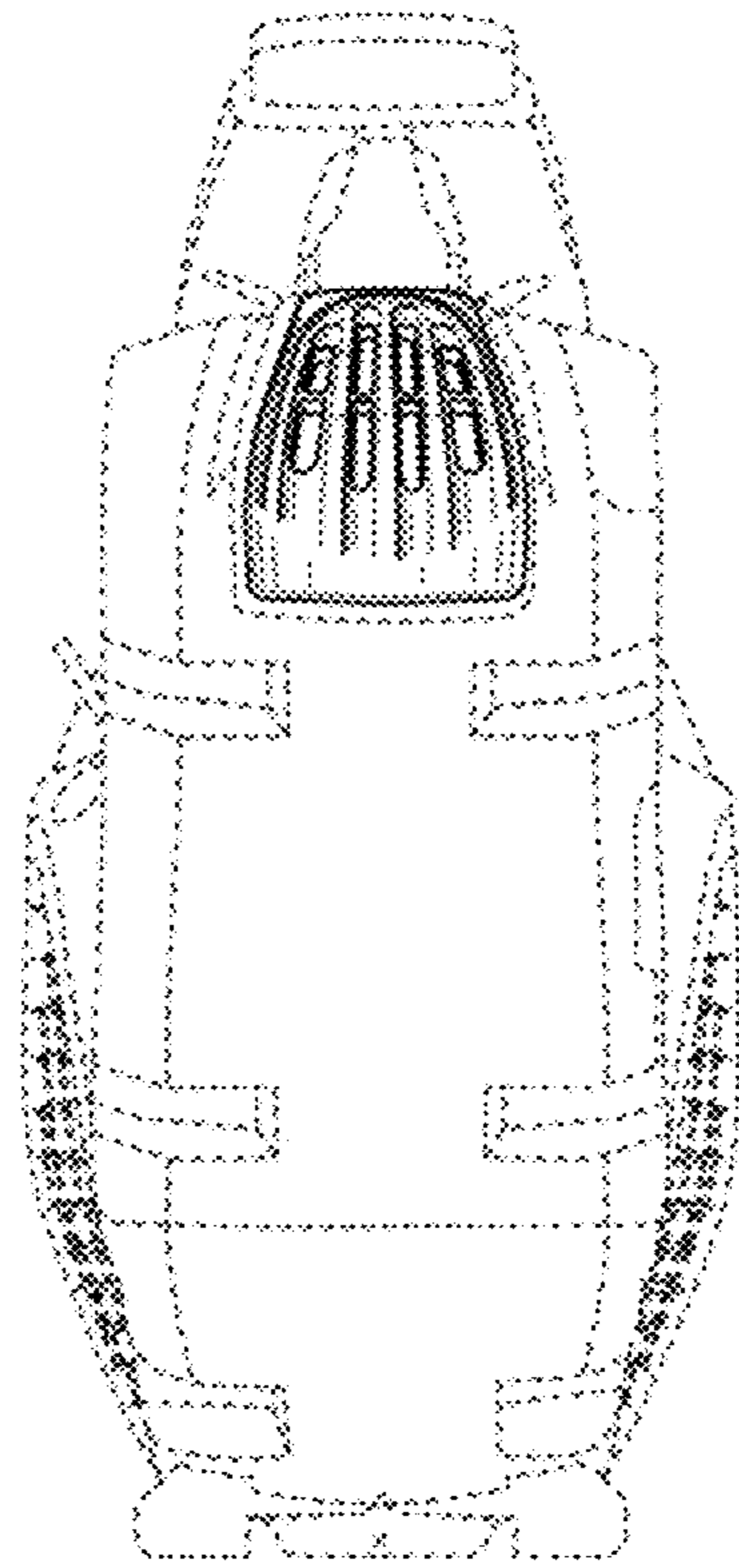

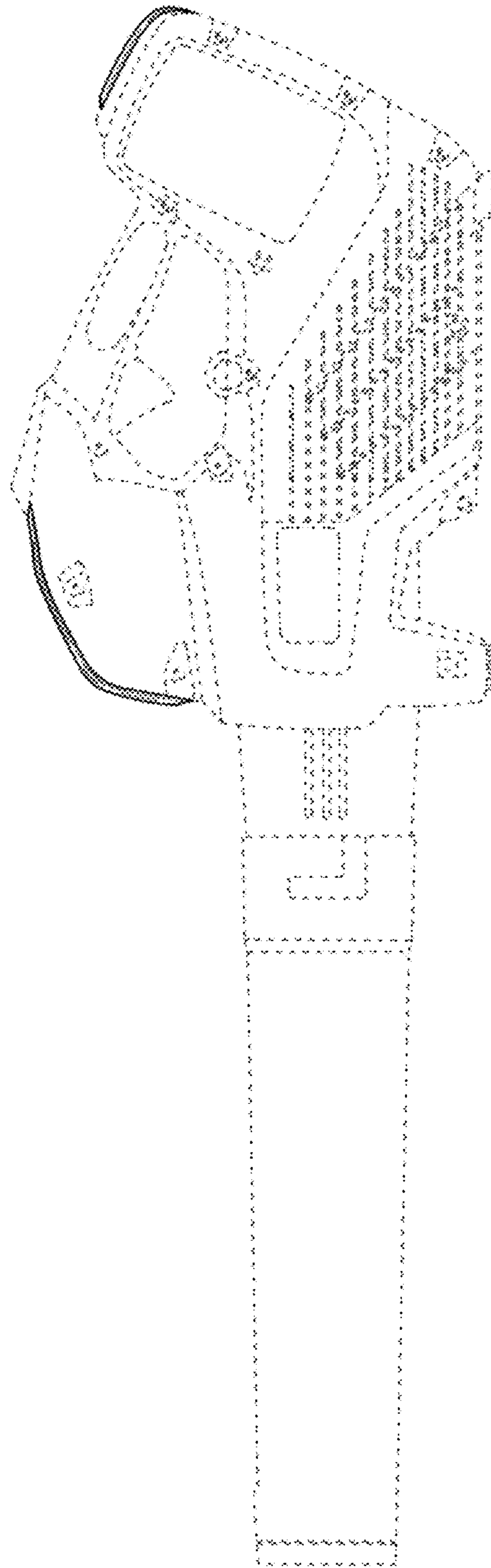

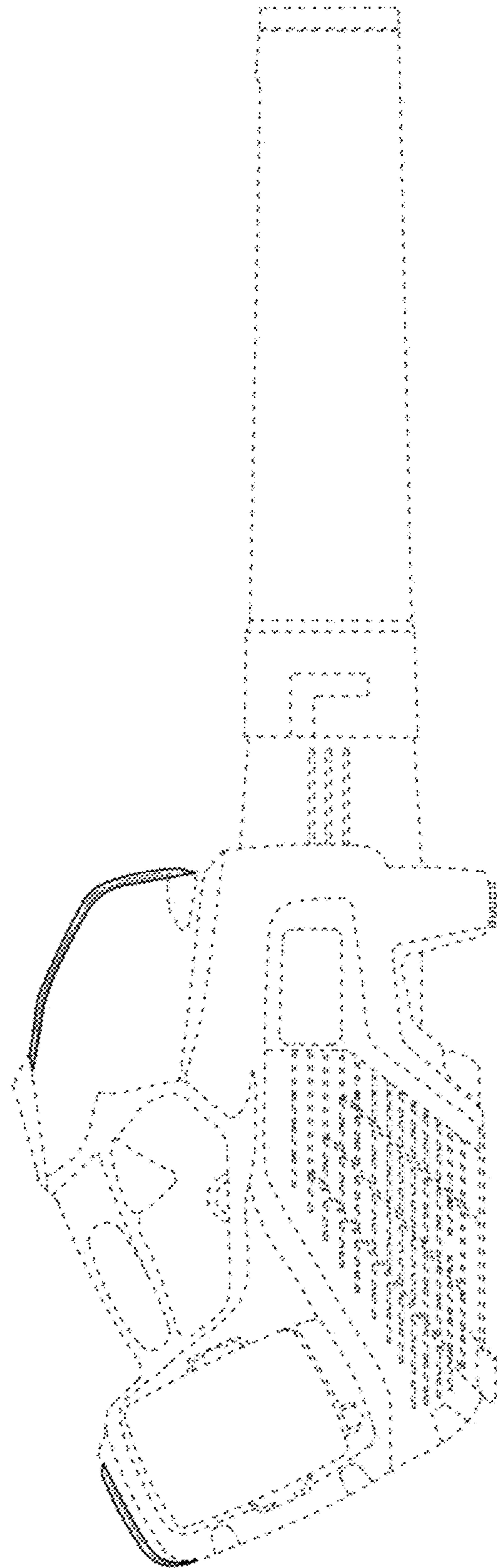

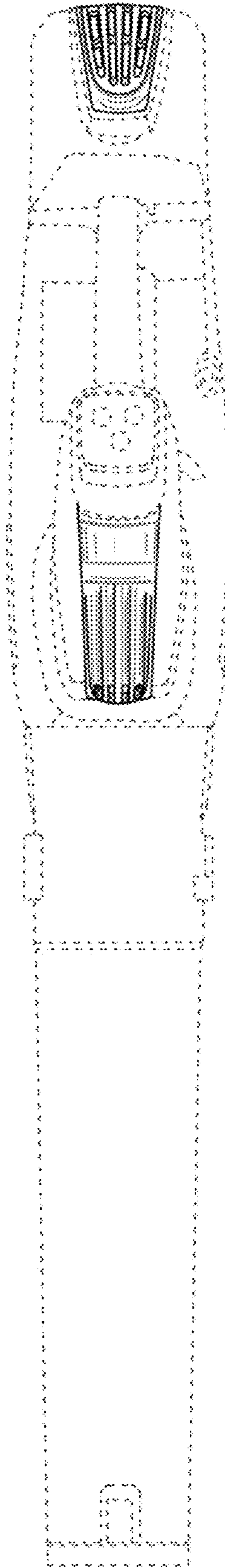

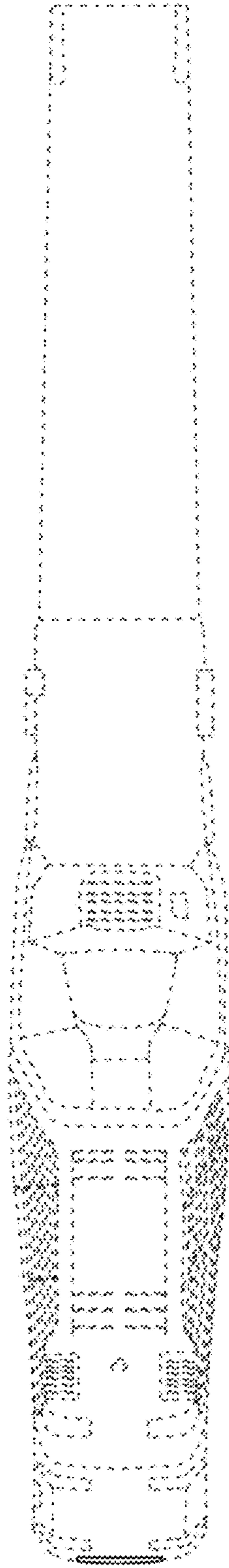
