FIG. 13 is a top plan view thereof.

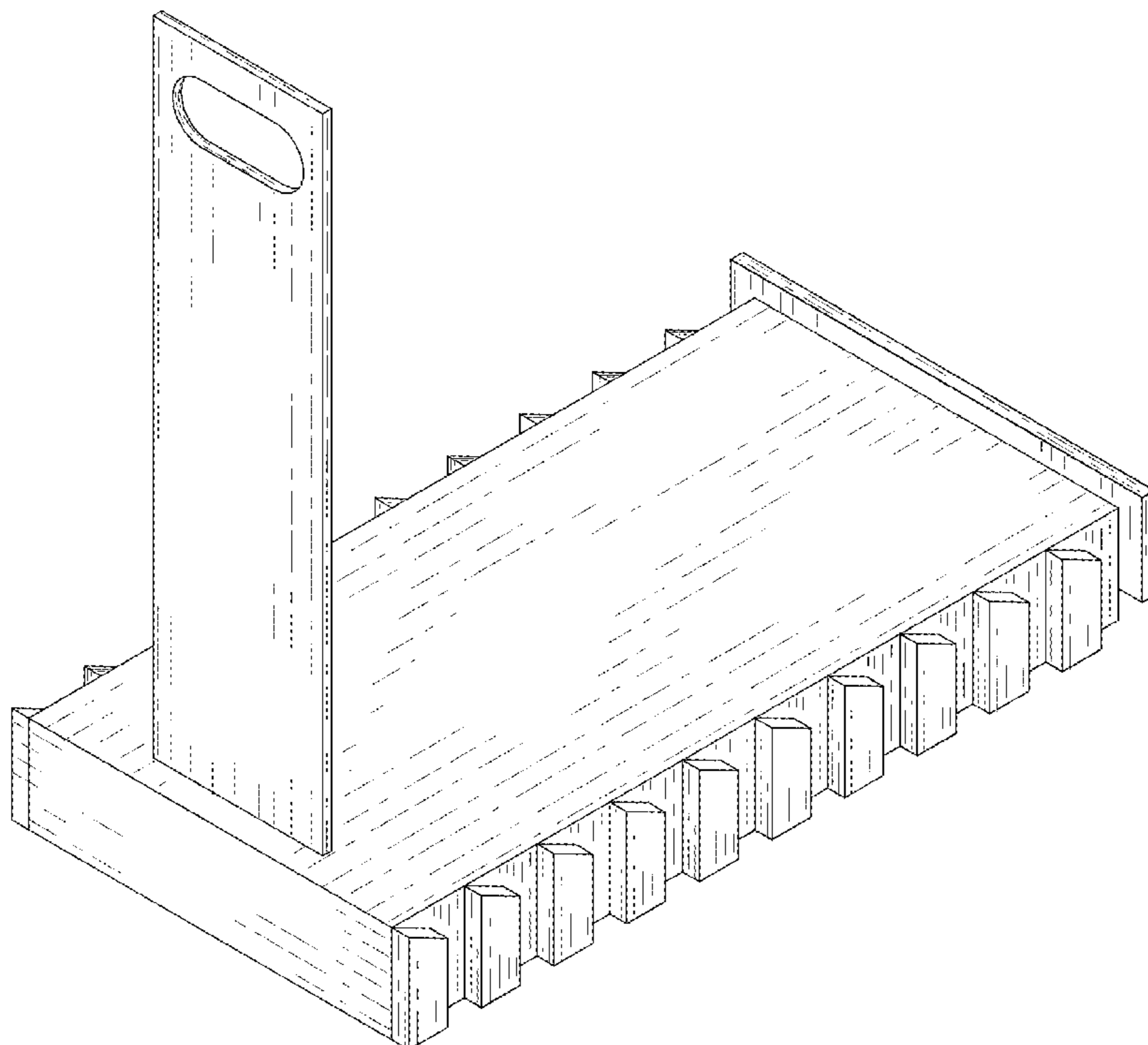

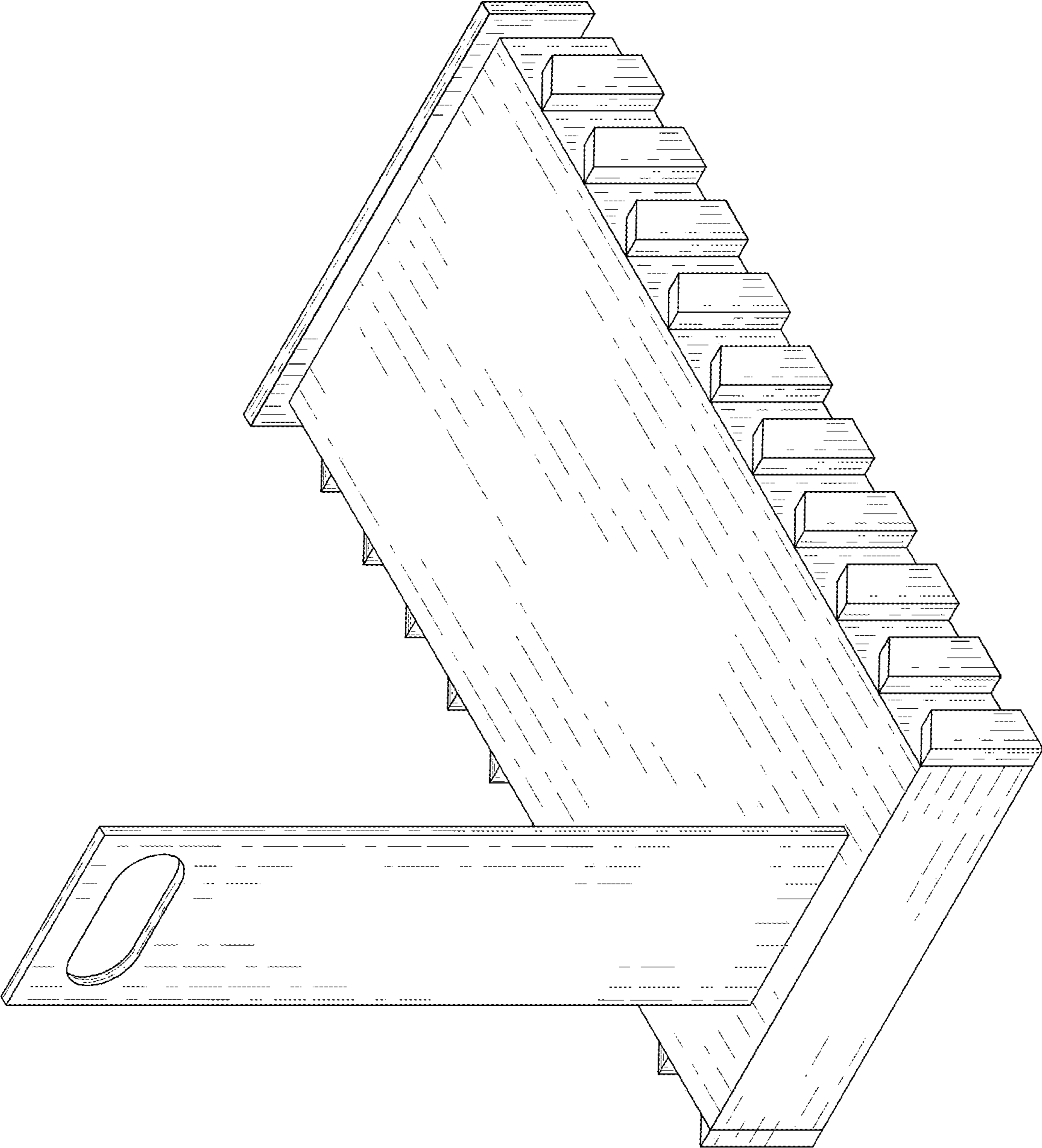

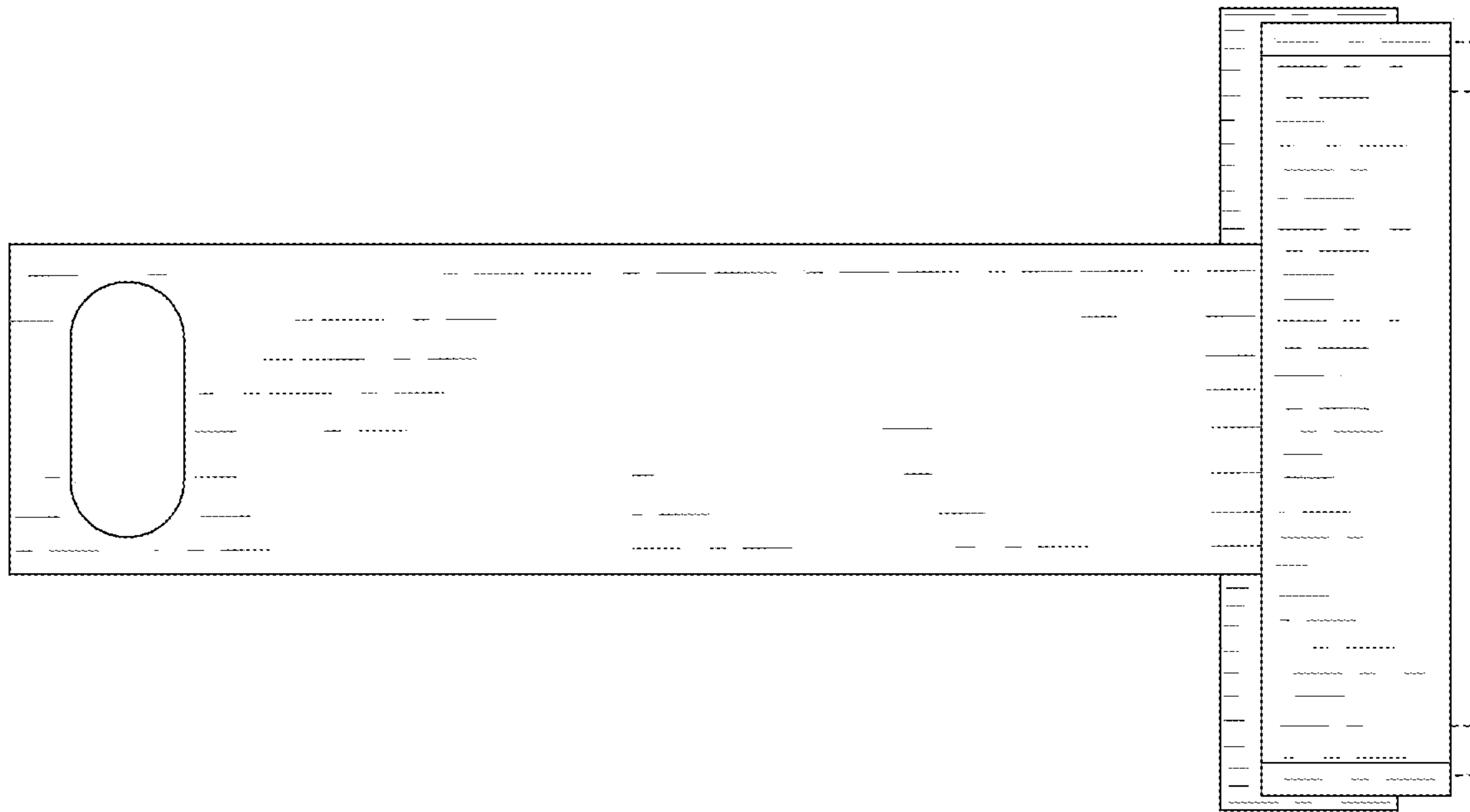

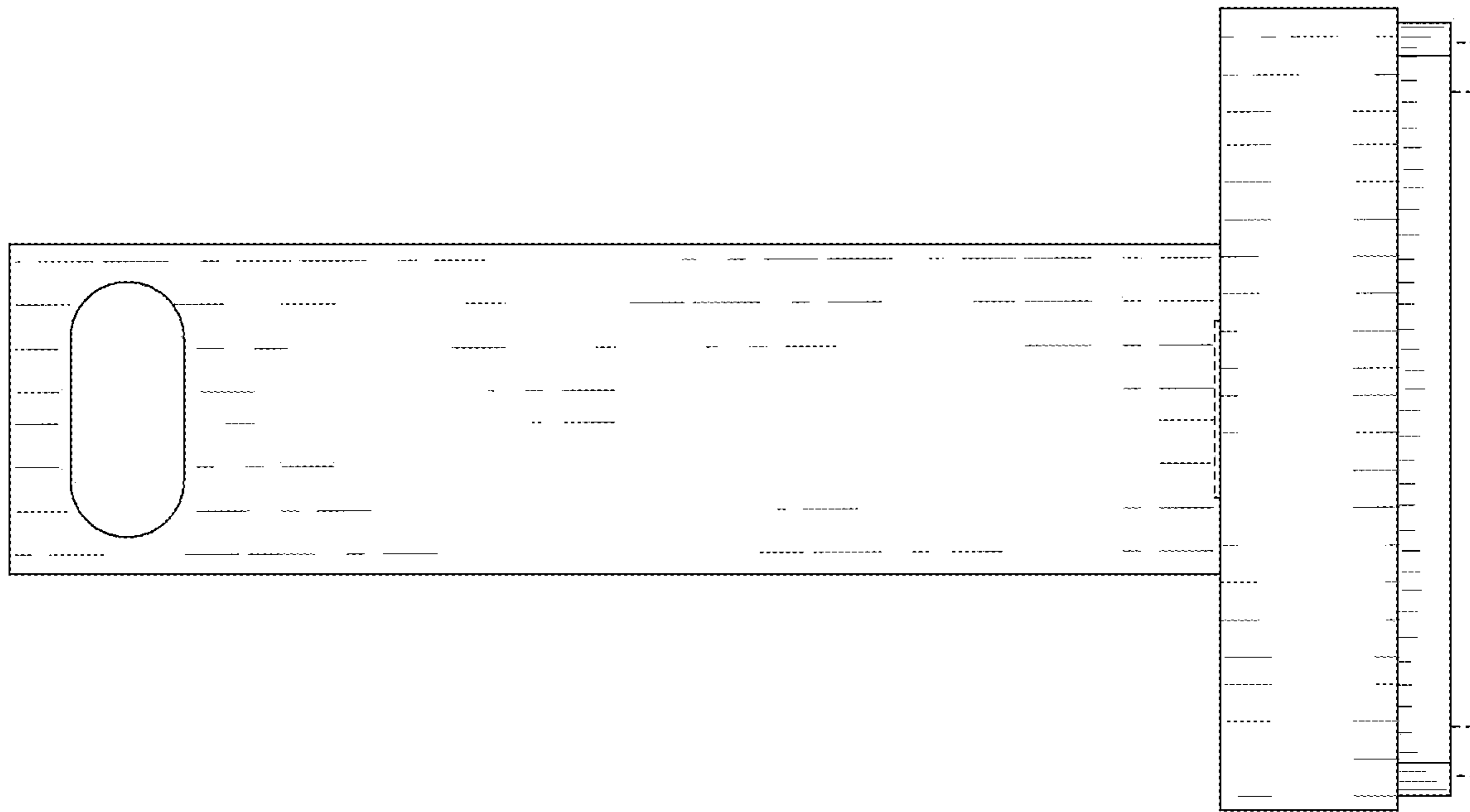

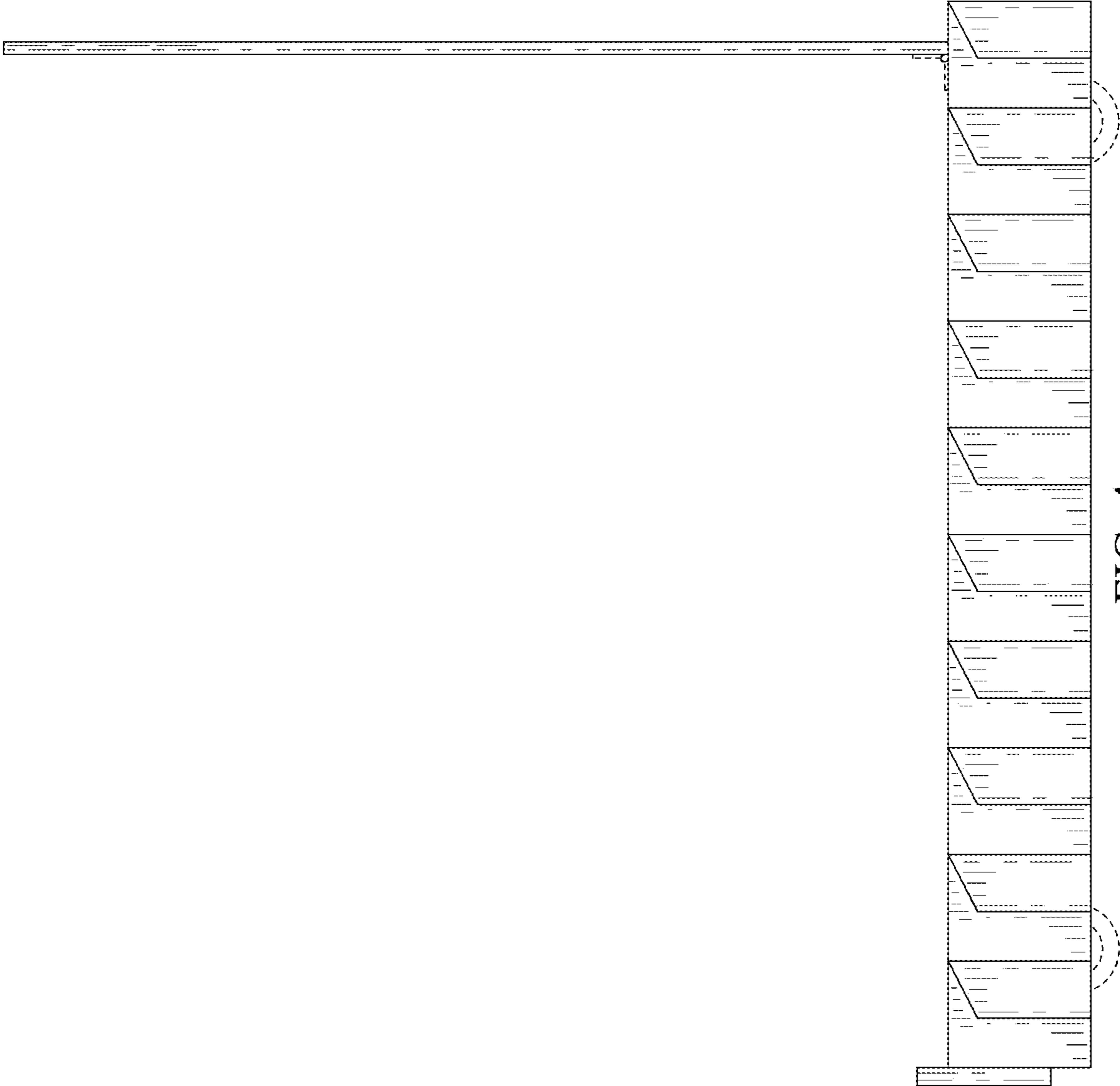

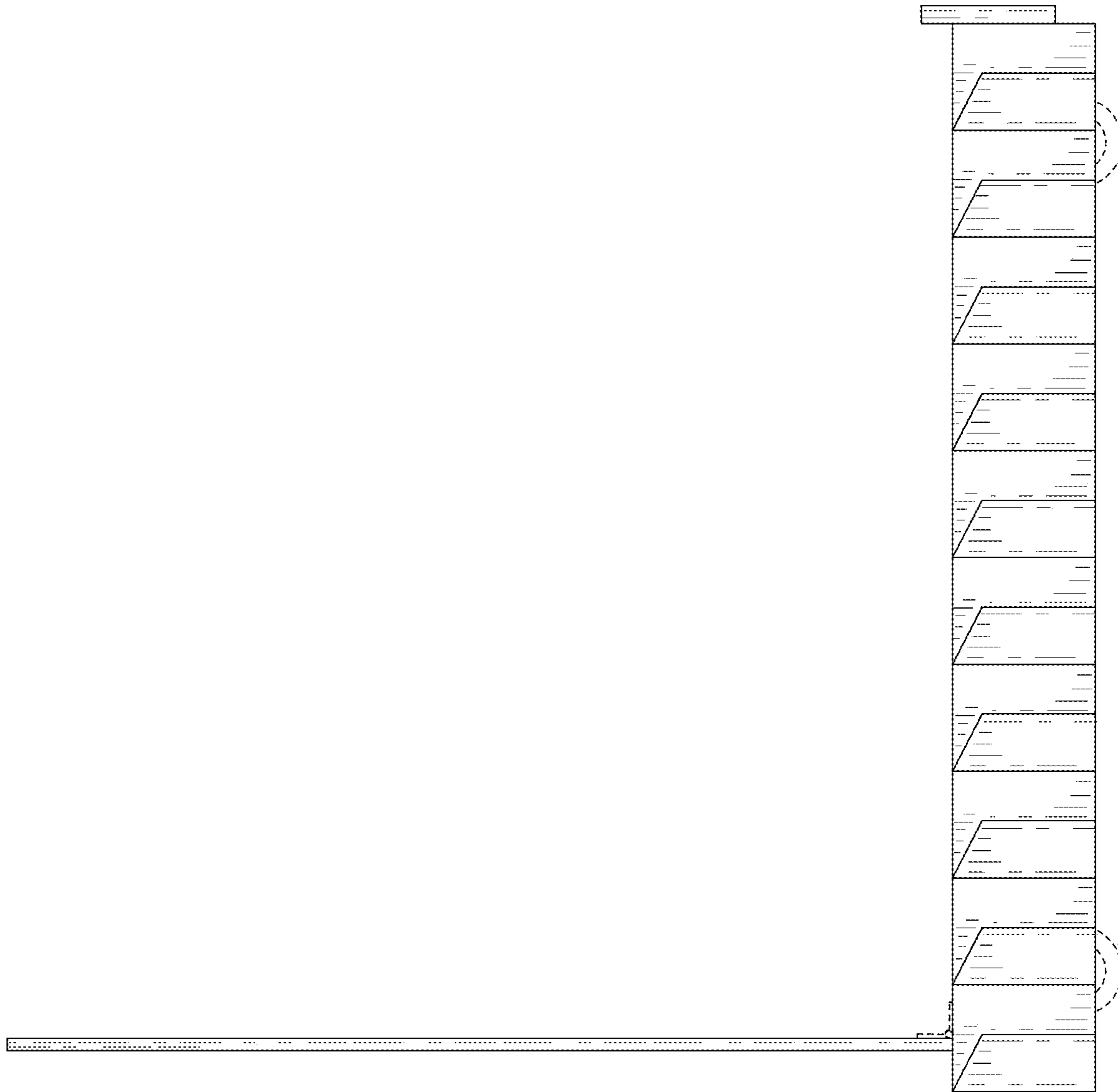

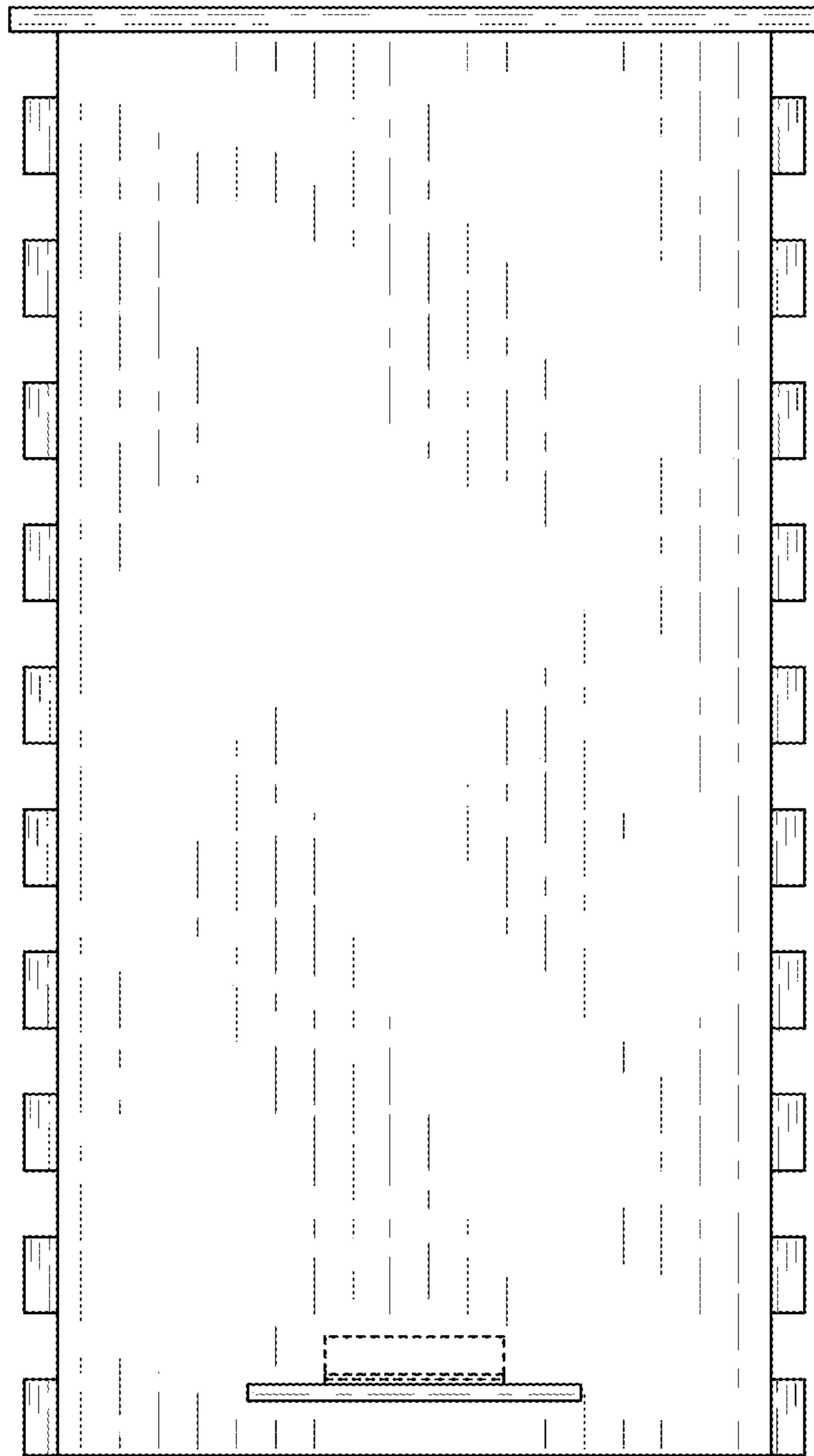

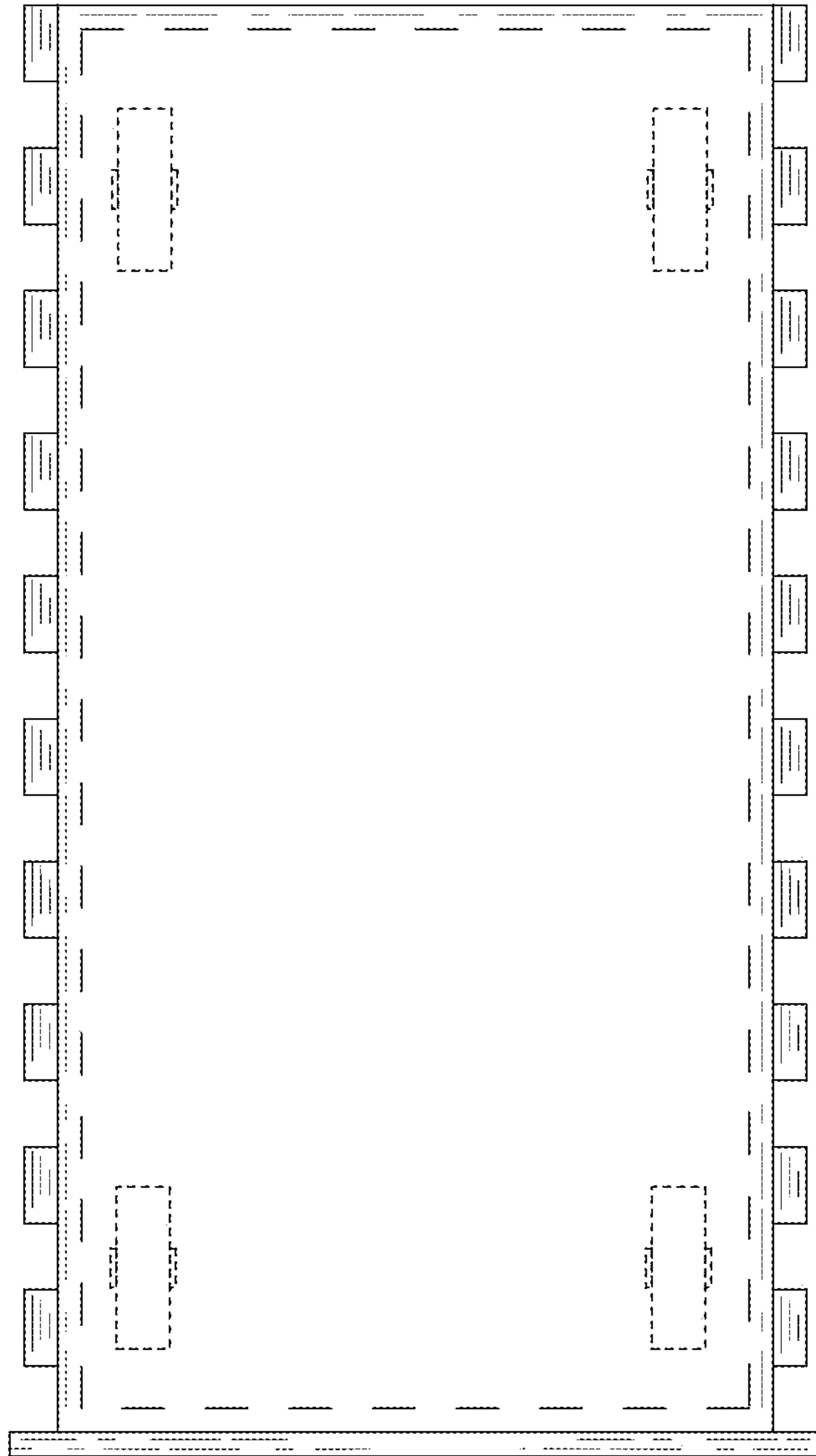

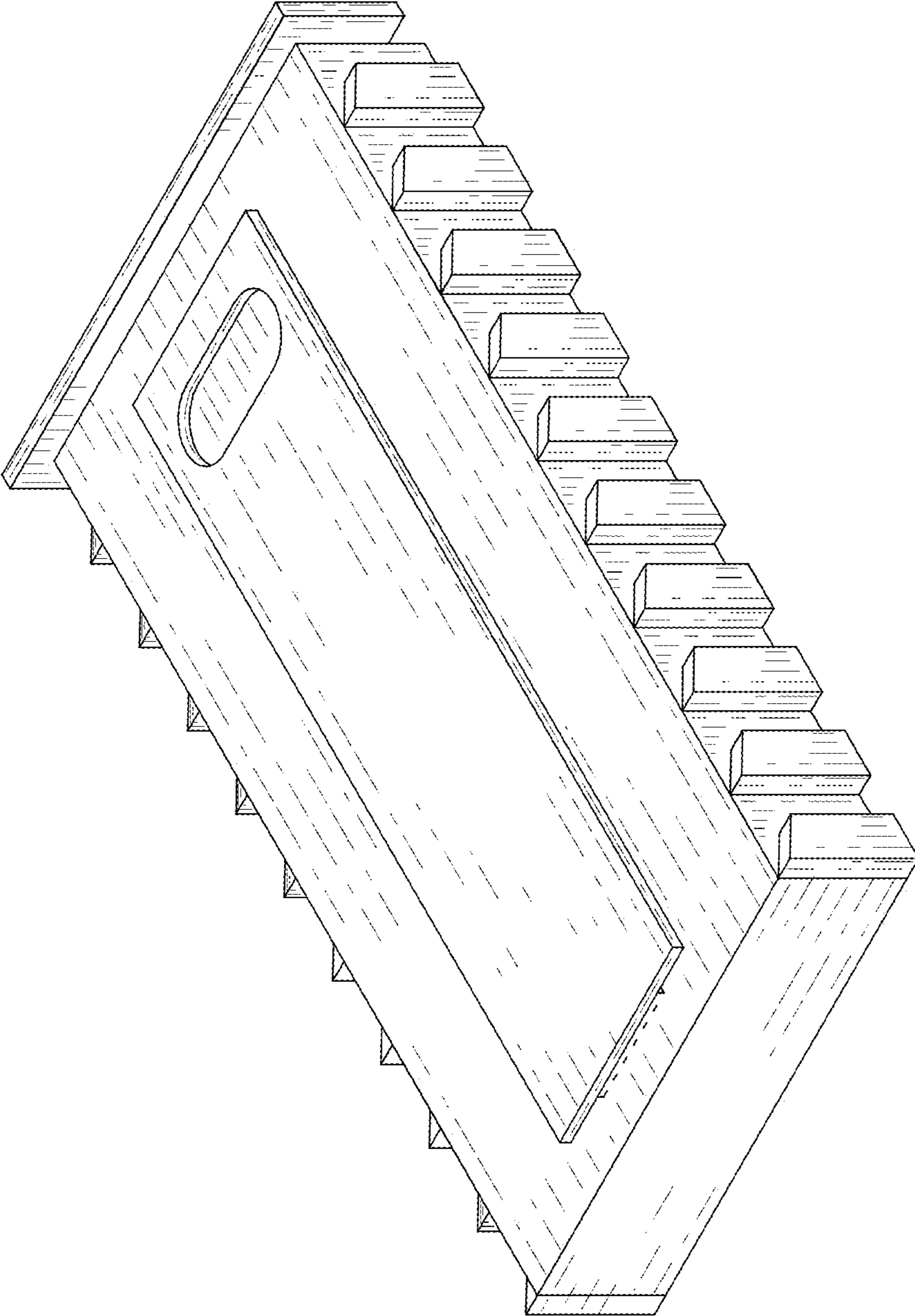

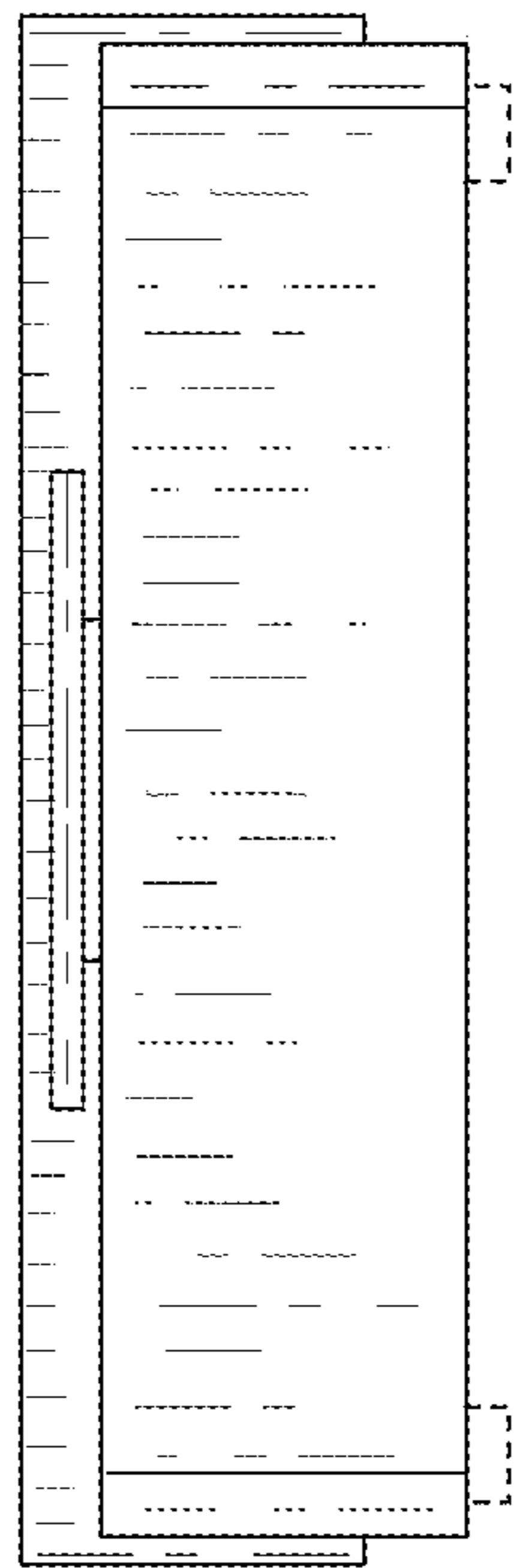

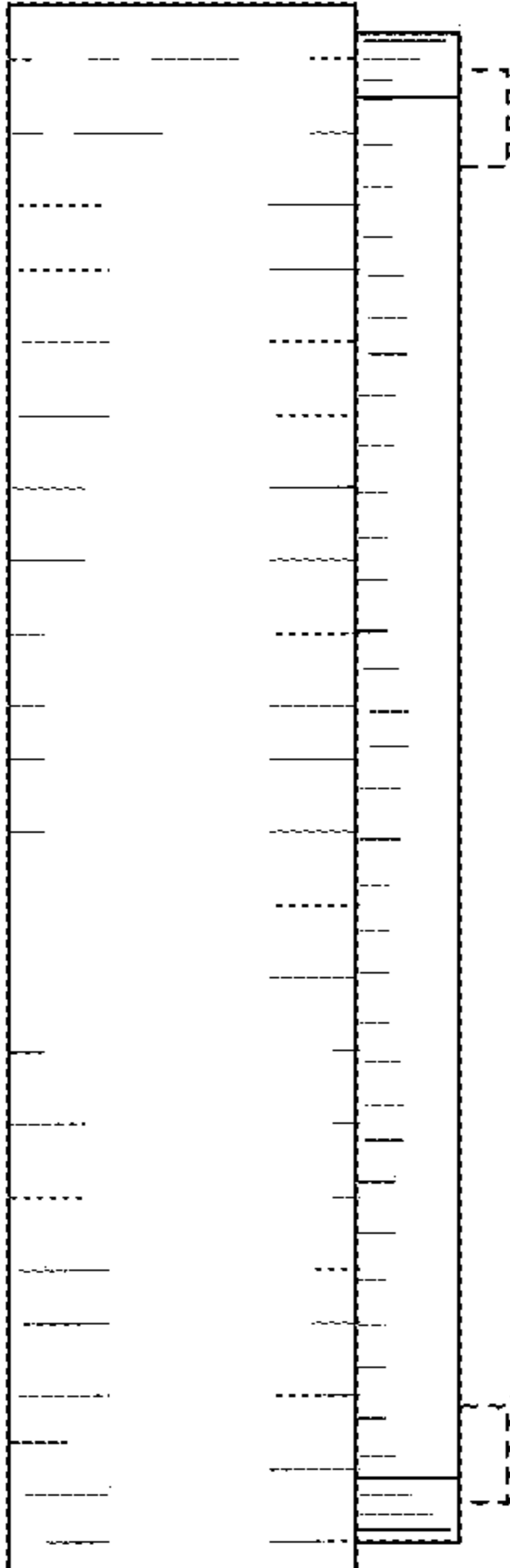

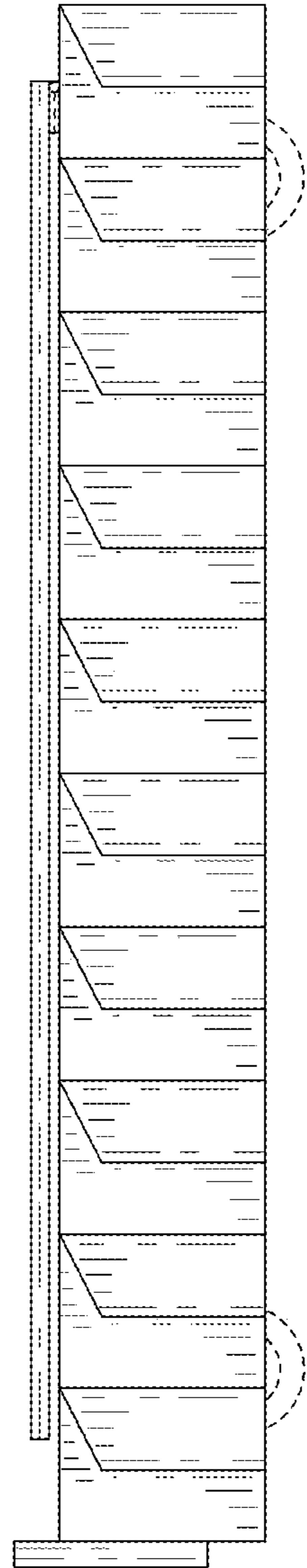

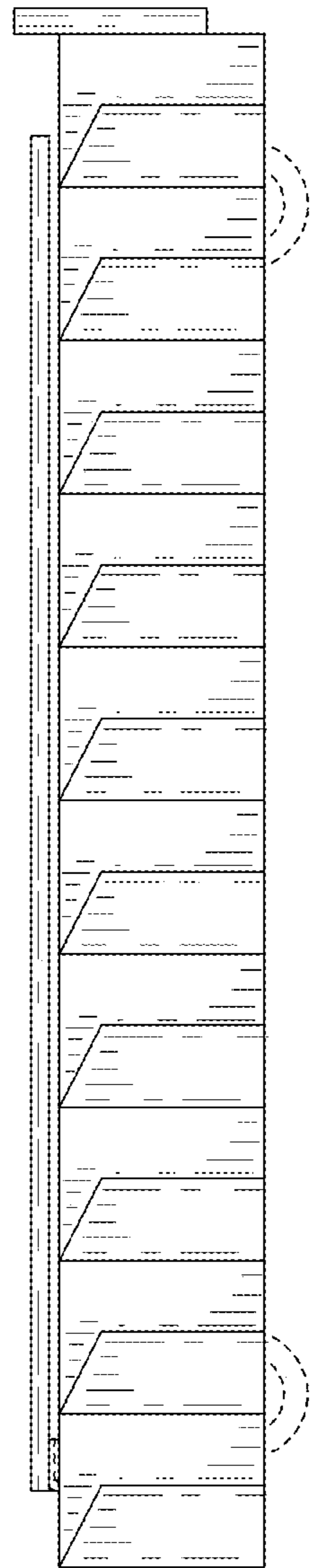

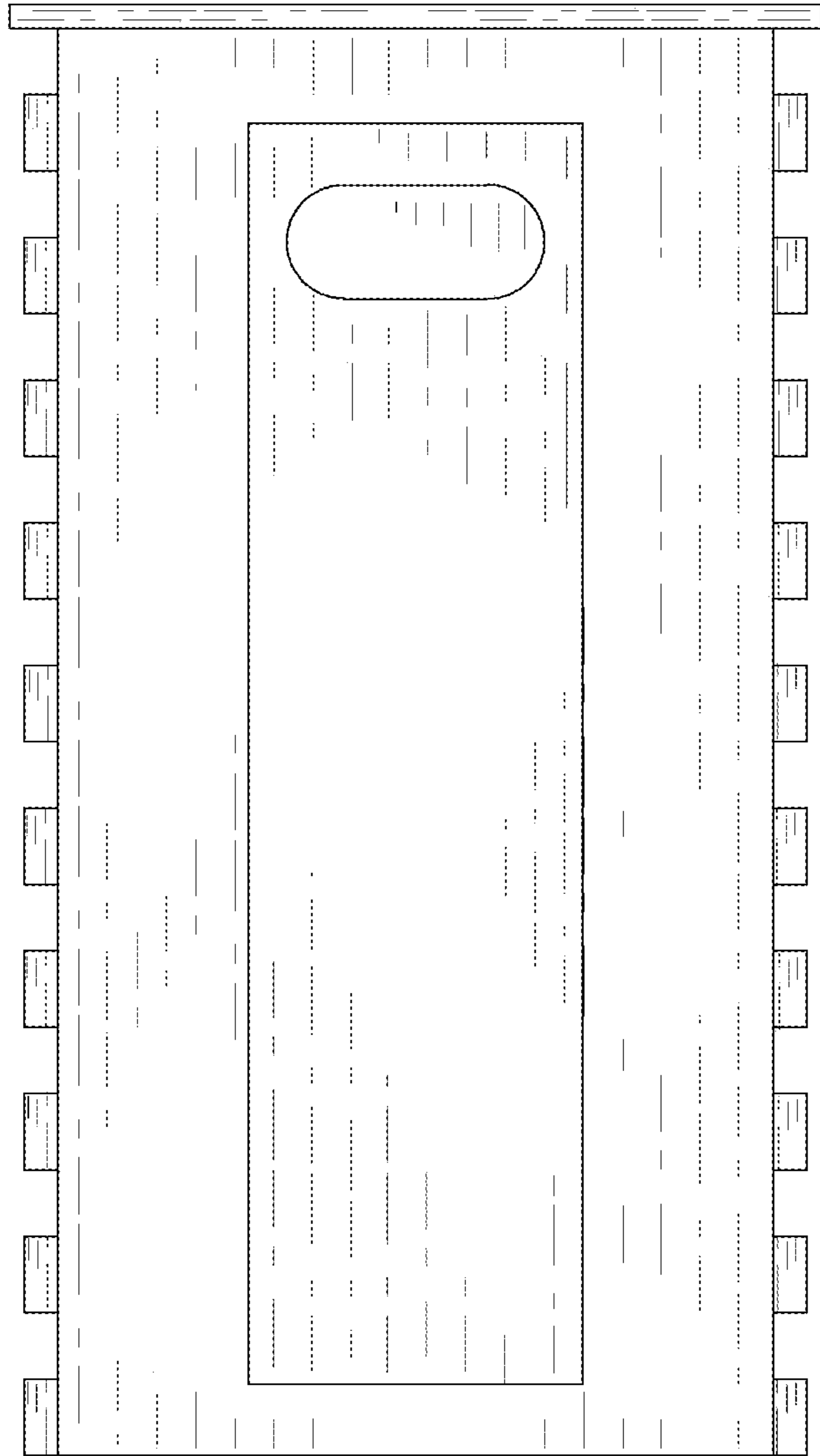
