(57) **CLAIM**

An ornamental design for a padded underwear, as shown and described.

DESCRIPTION

FIG. 1 is a back elevational view of the padded underwear in one of configuration and showing the outside of the padded underwear;
 FIG. 2 is a front elevational view of the padded underwear of FIG. 1;
 FIG. 3 is a left plan view thereof;
 FIG. 4 is a right plan view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof.
 FIG. 7 is a back elevational view of the padded underwear showing the inside out of the padded underwear, dashed dotted lines showing stitches; and,
 FIG. 8 is the left plan view of FIG. 7.
 The dashed dotted lines on the design indicate stitching. None of the broken-line subject matter forms a part of the claimed design.

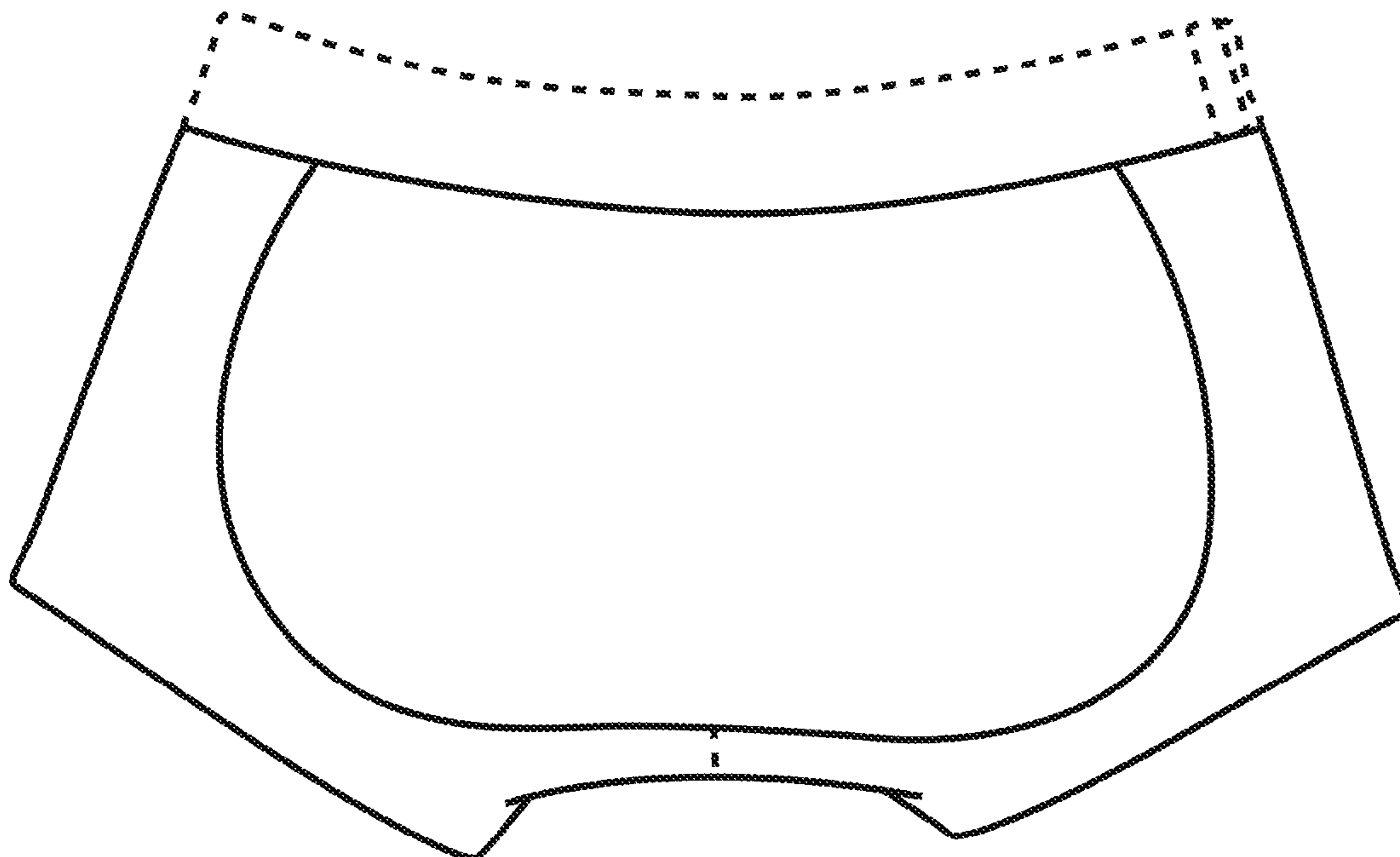
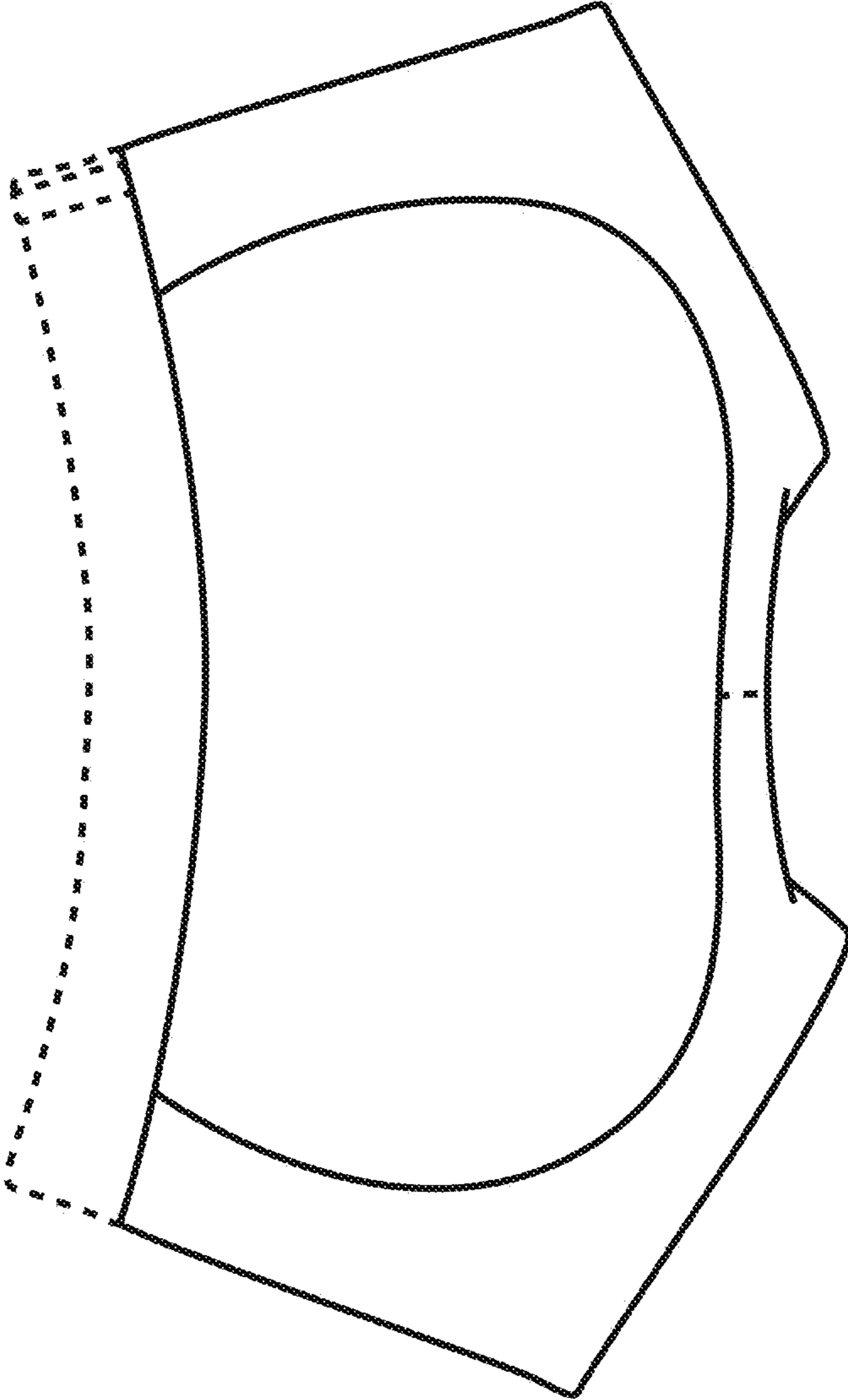

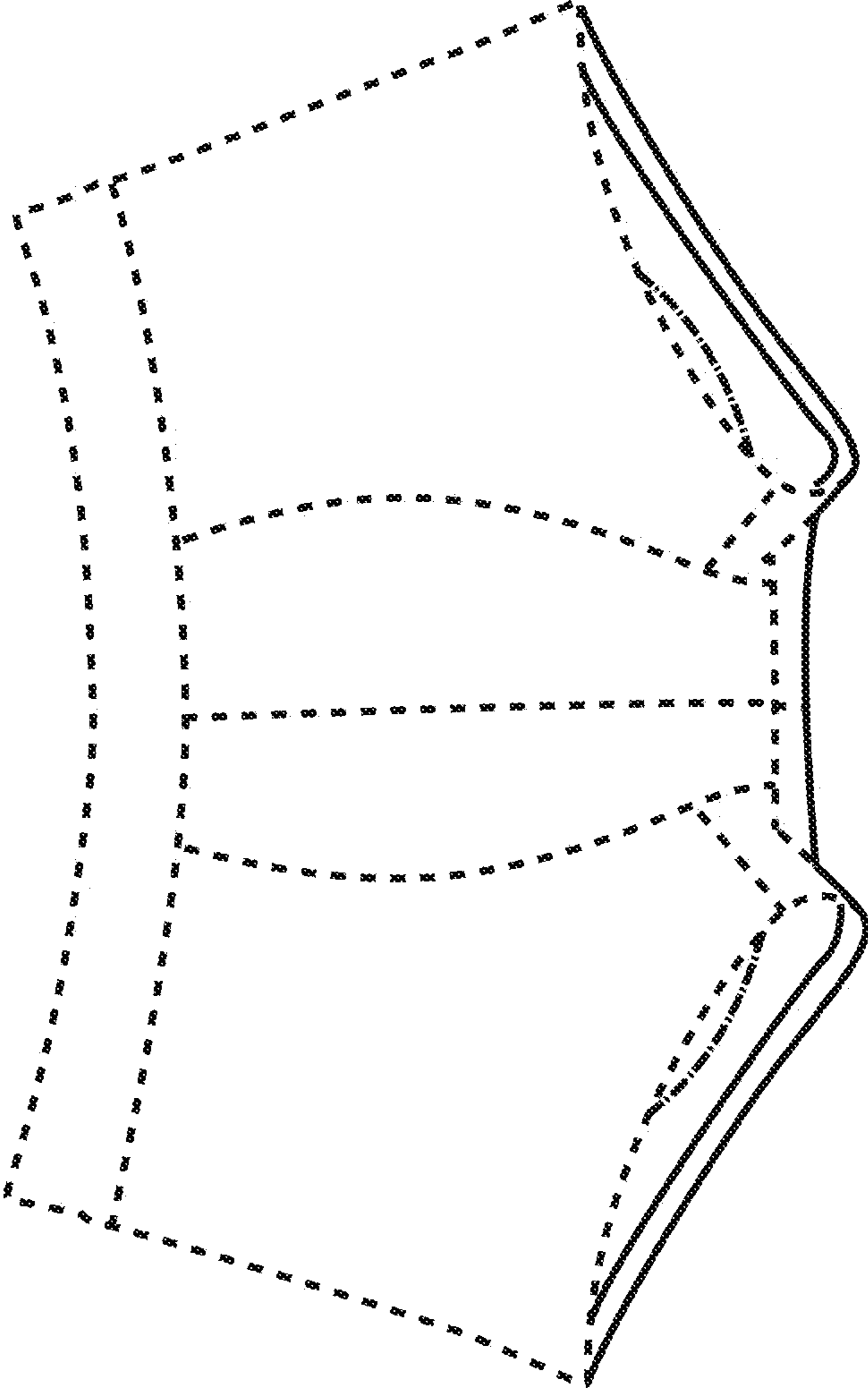

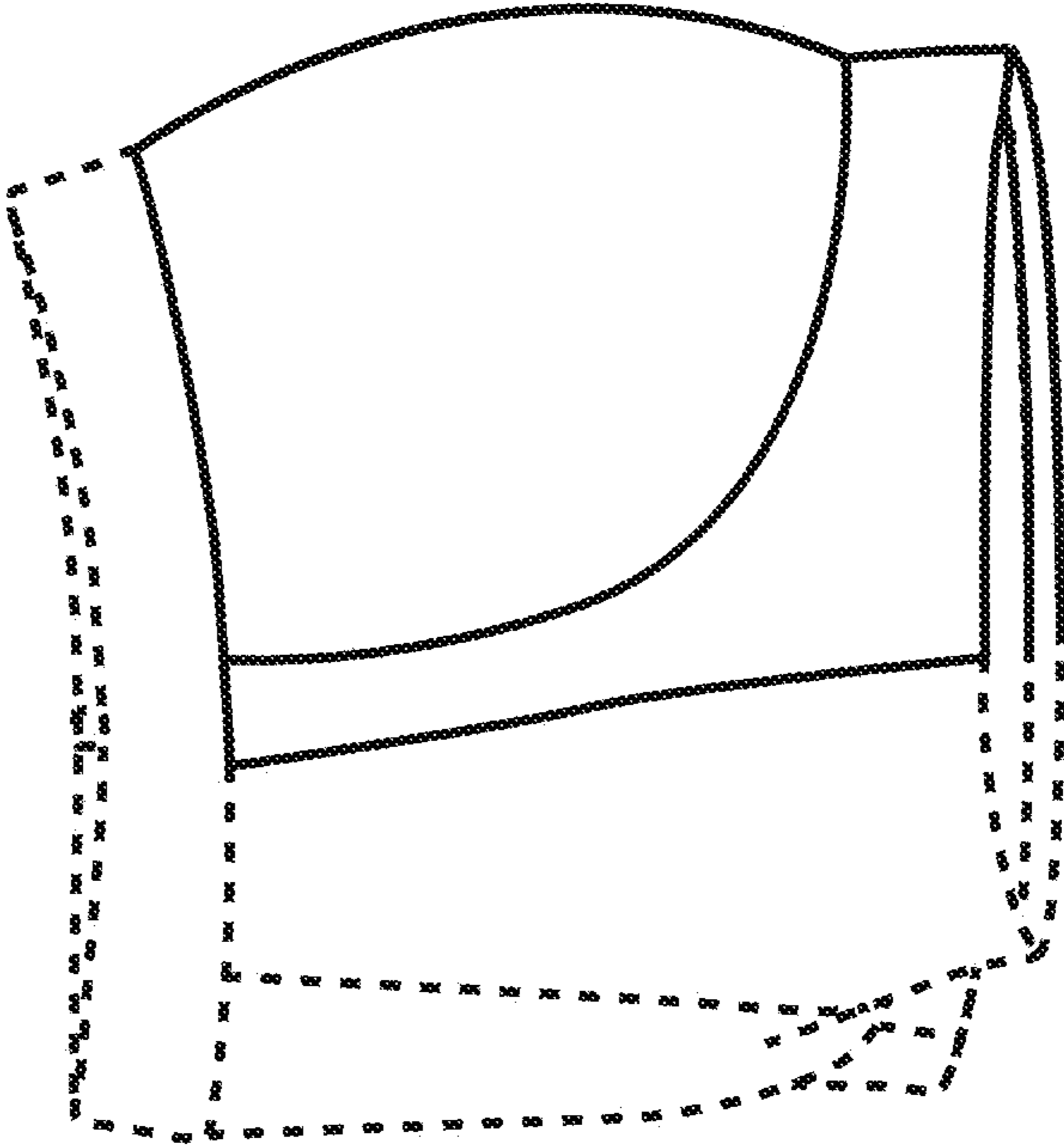

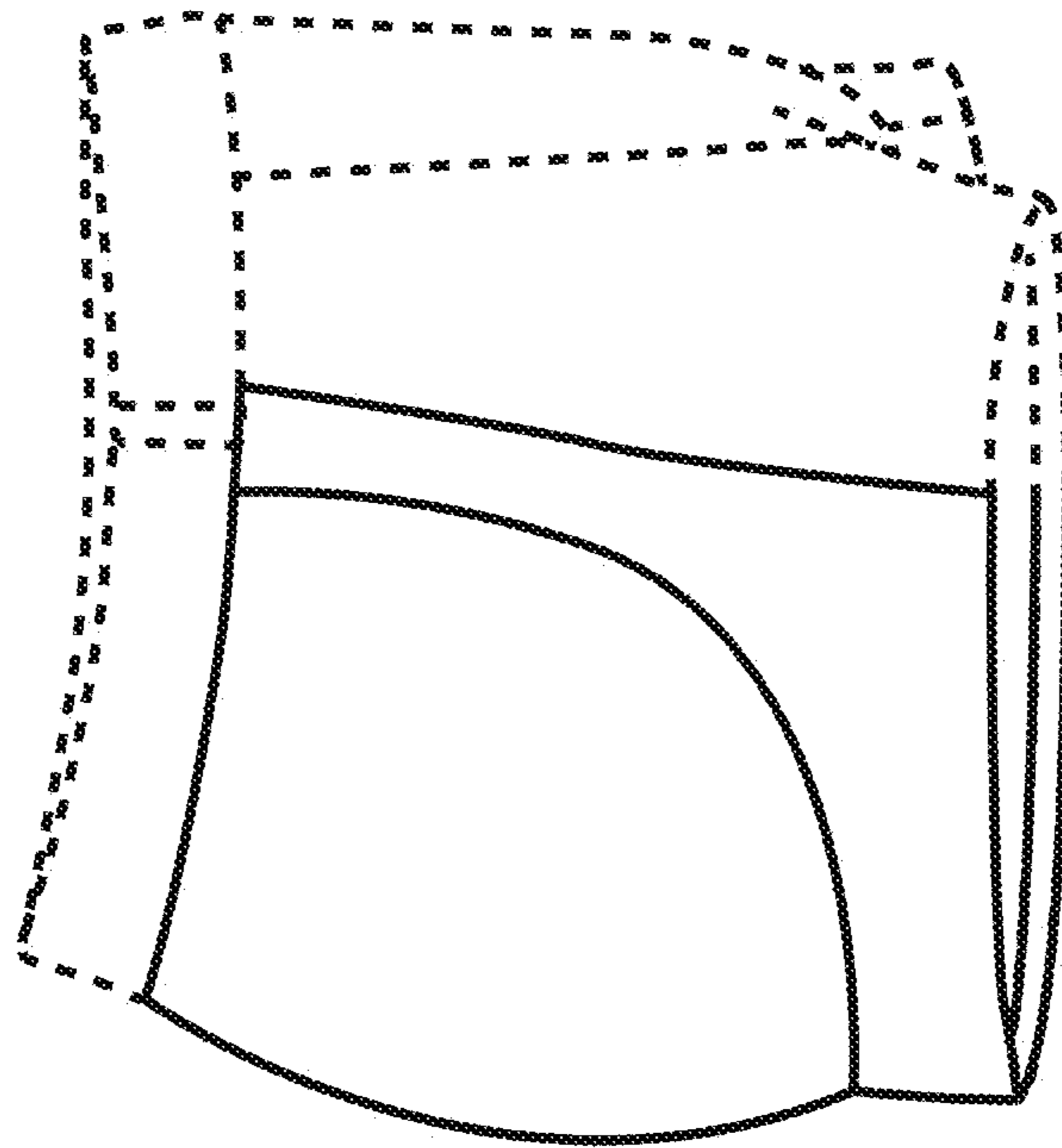
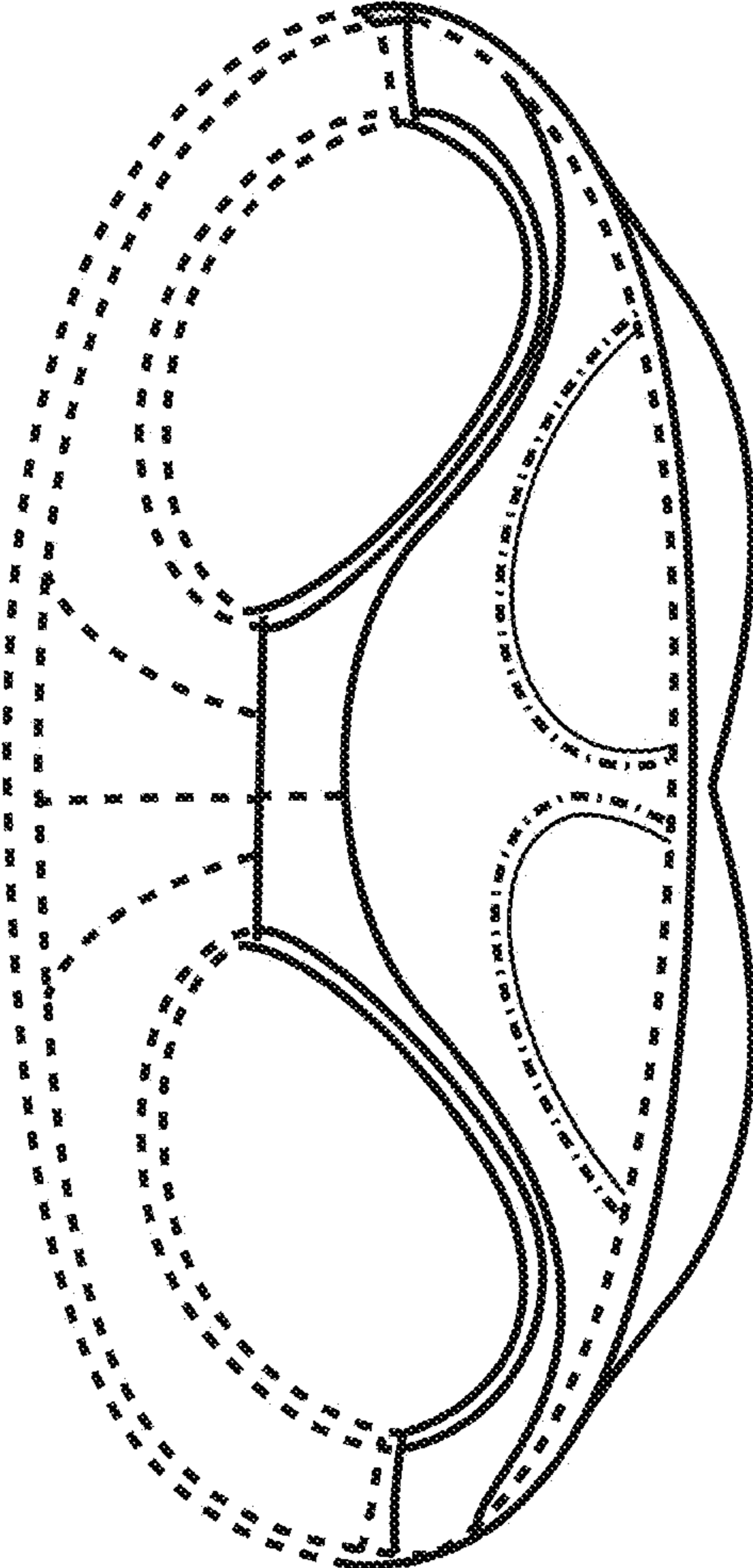

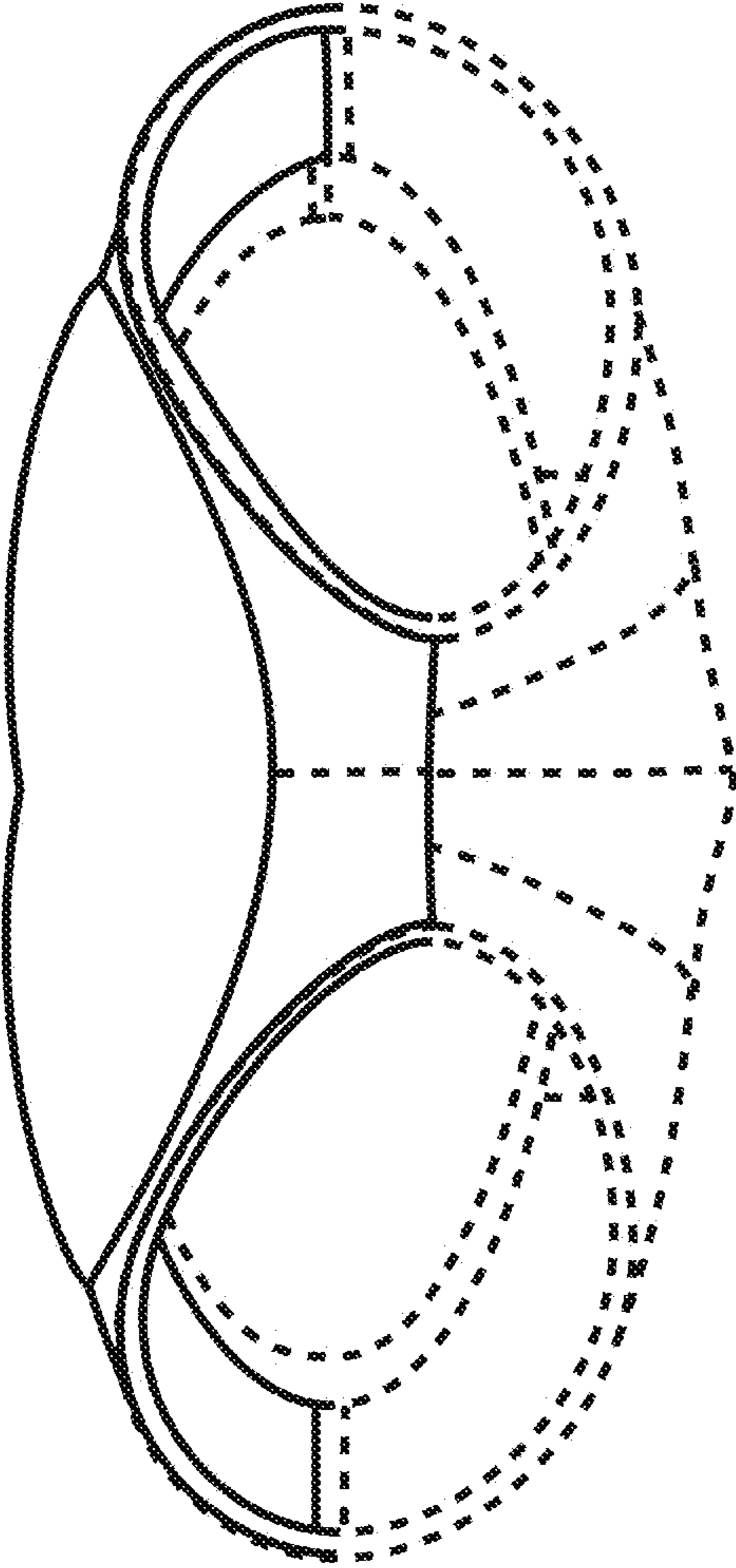

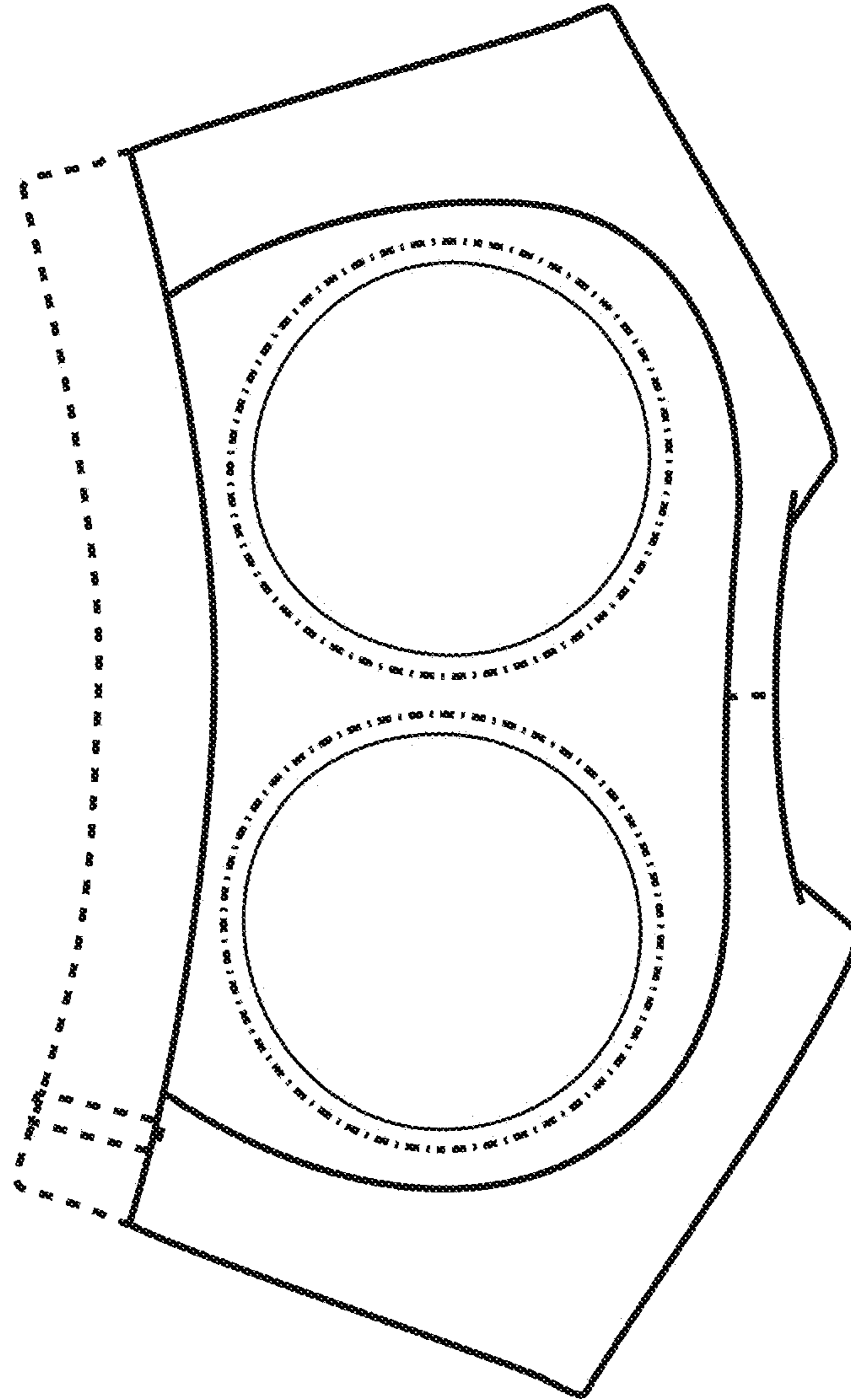

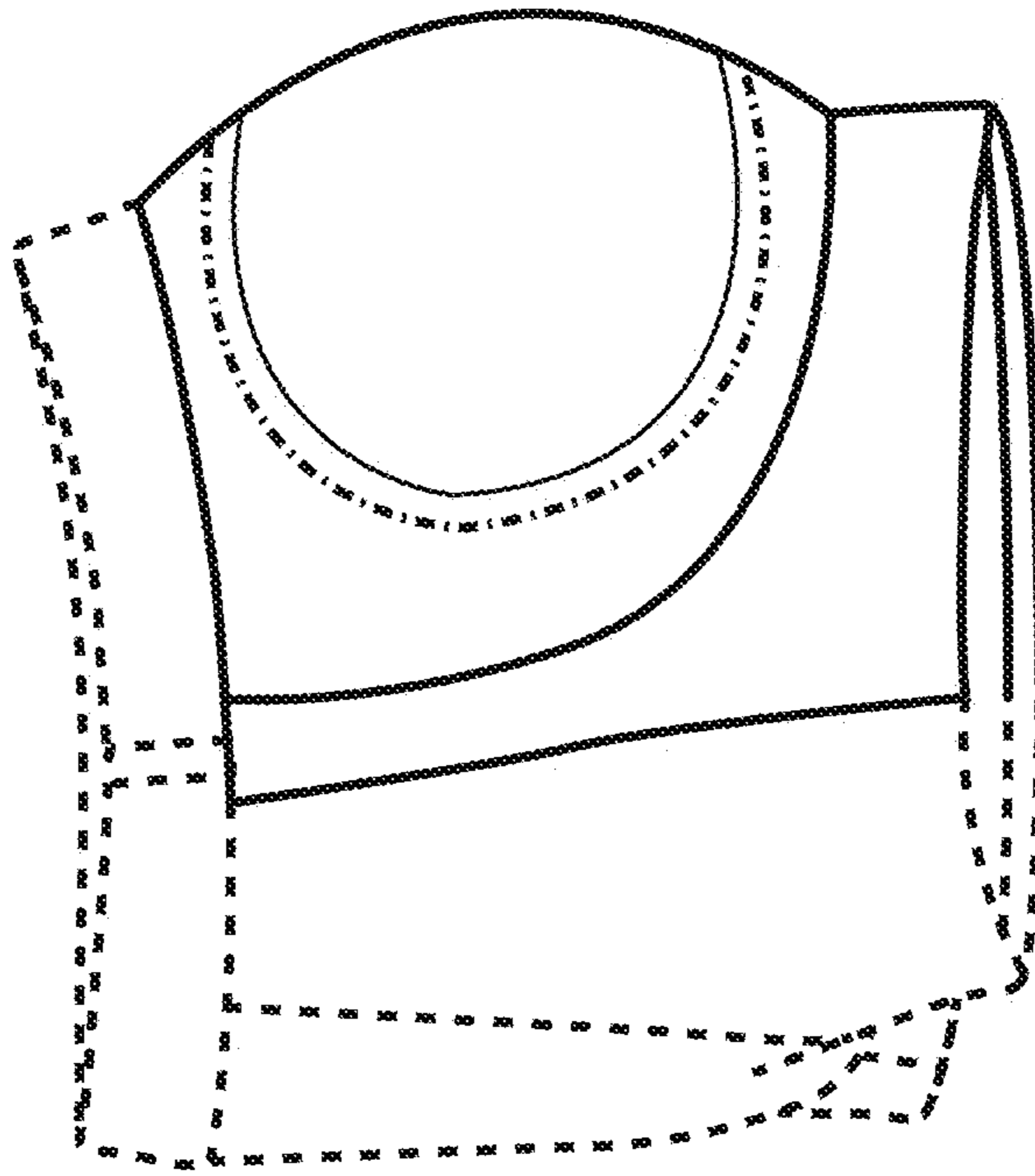
