The ornamental design for leggings, as shown and described.

**DESCRIPTION**

FIG. 4 is a rear elevation view thereof;

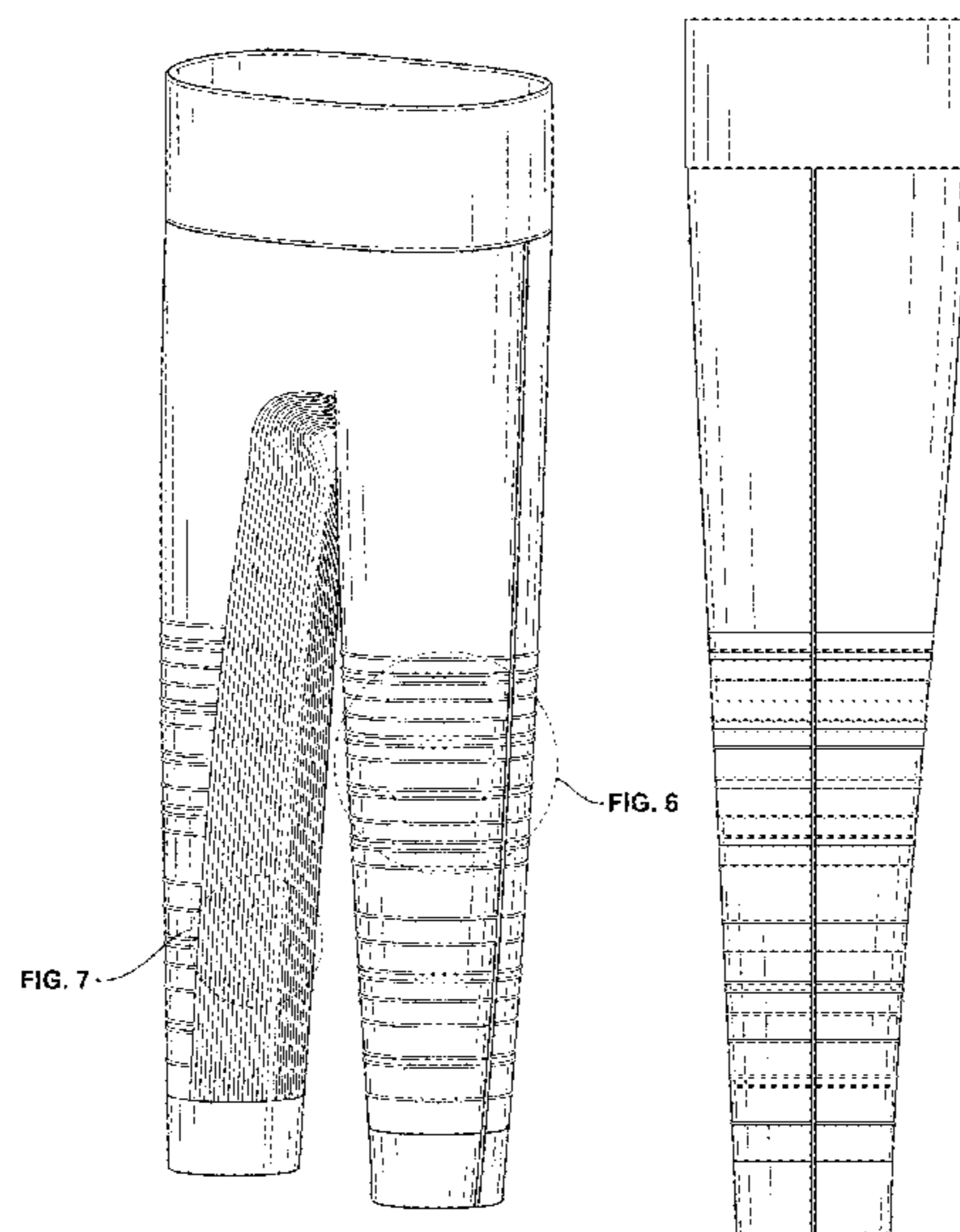
FIG. 5 is a right side elevation view thereof, the left side being a mirror image thereof;

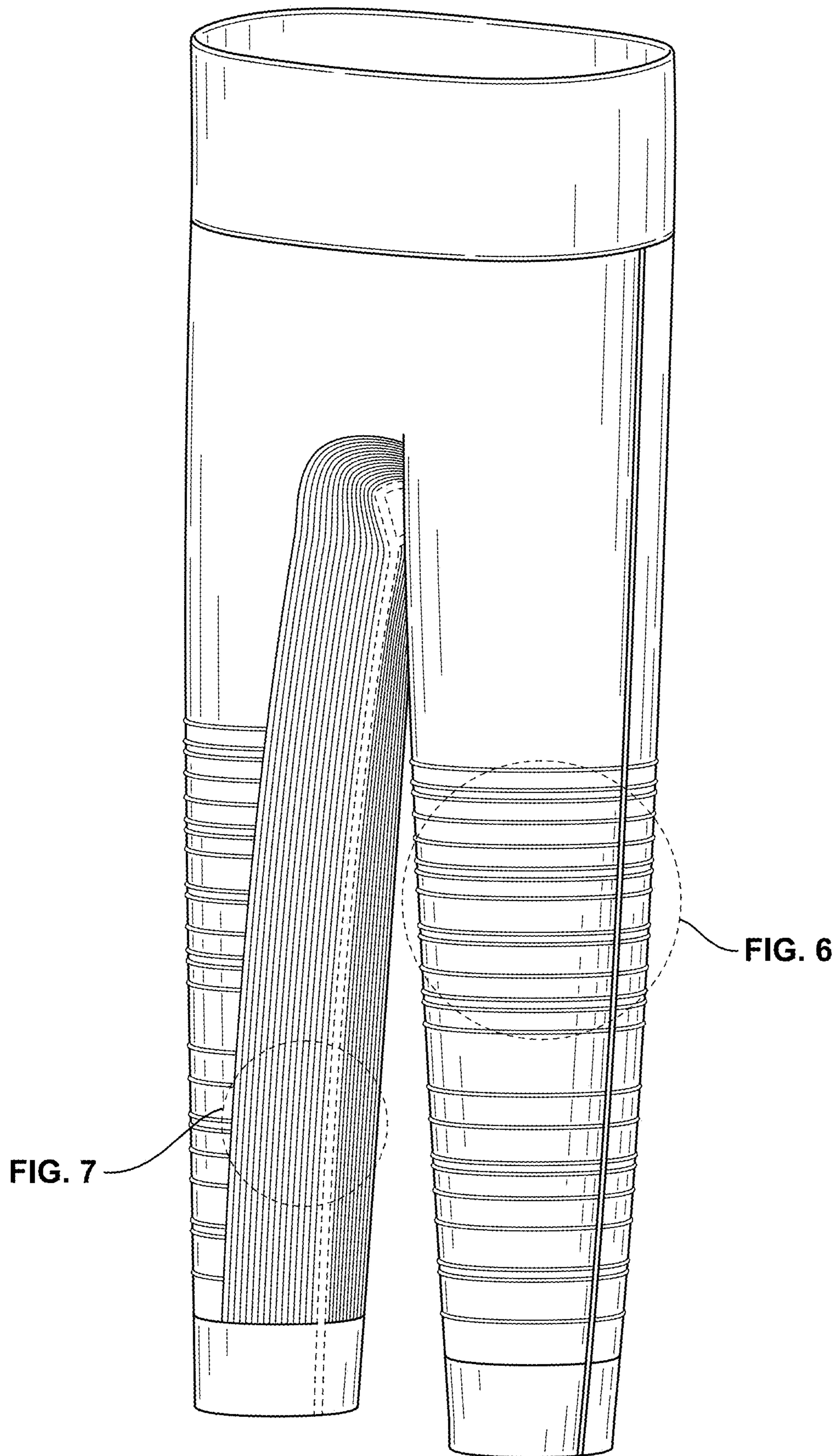

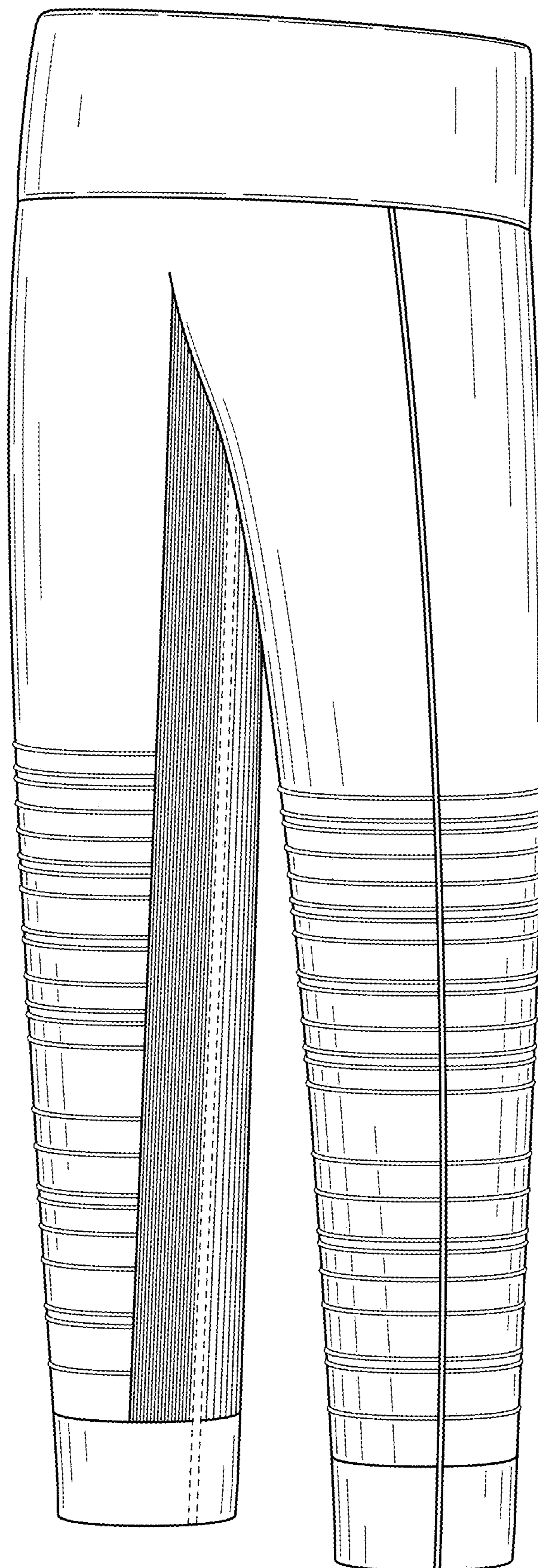

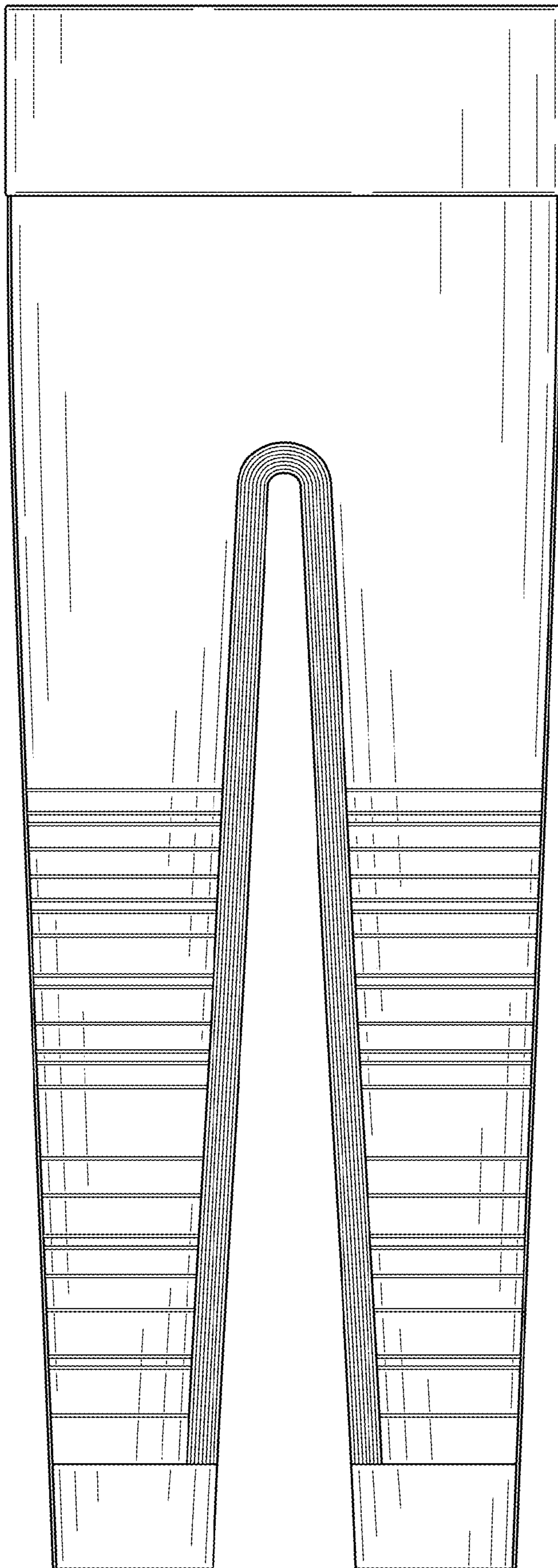

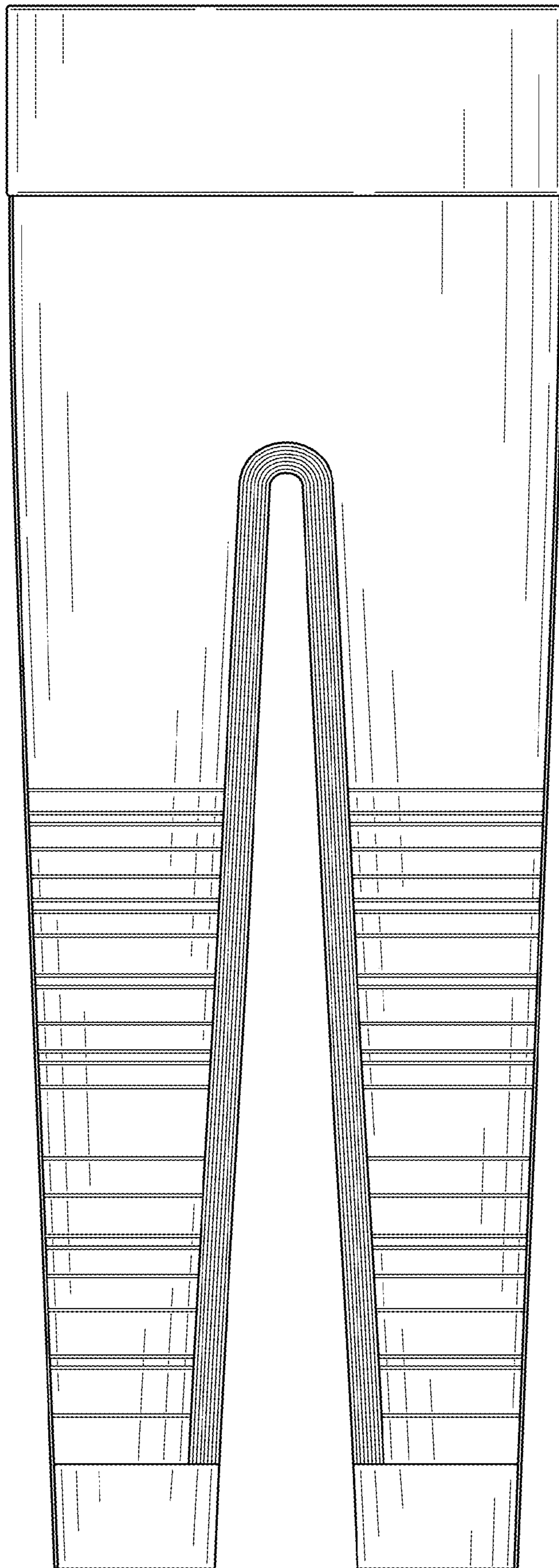

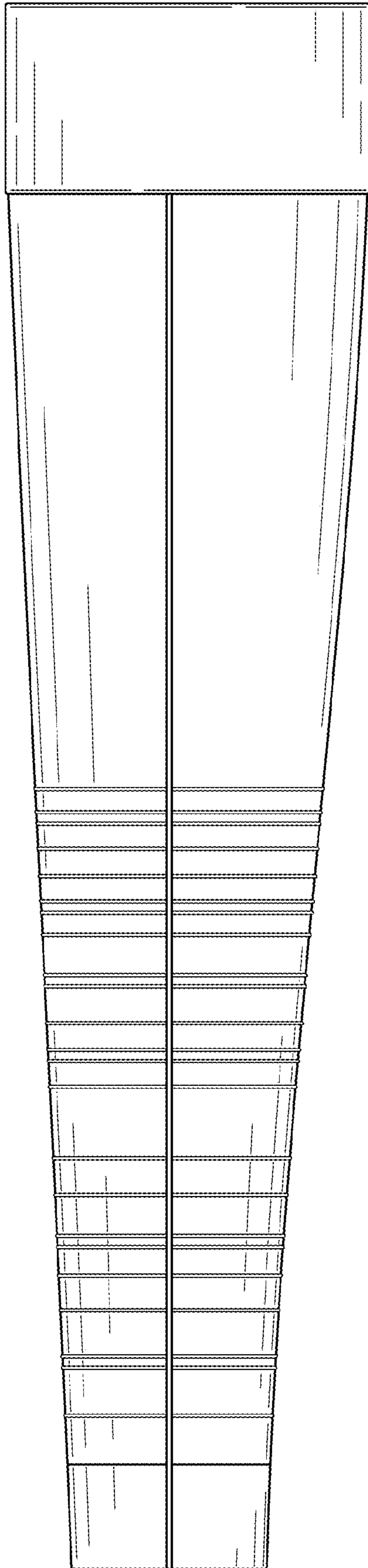

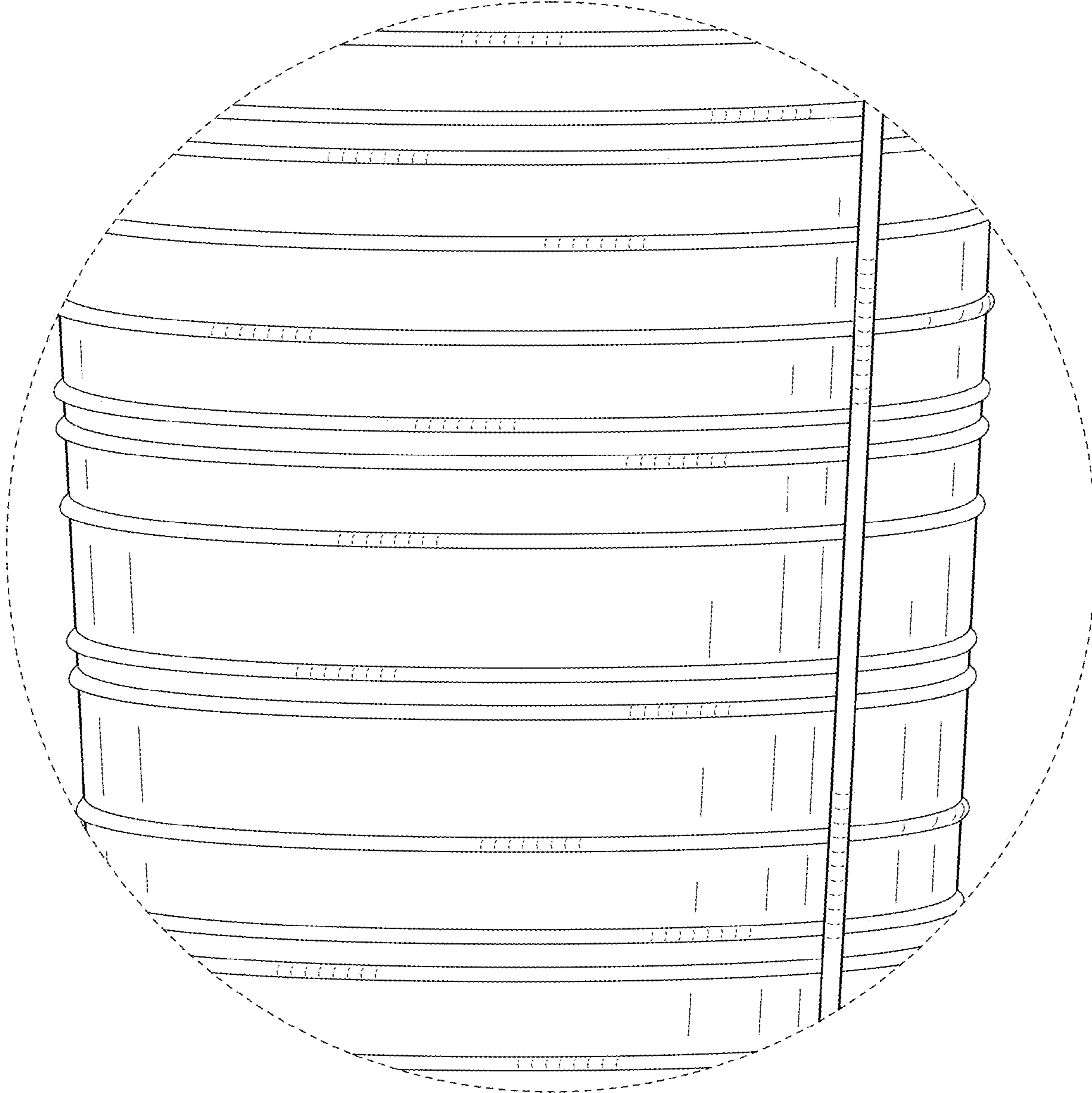

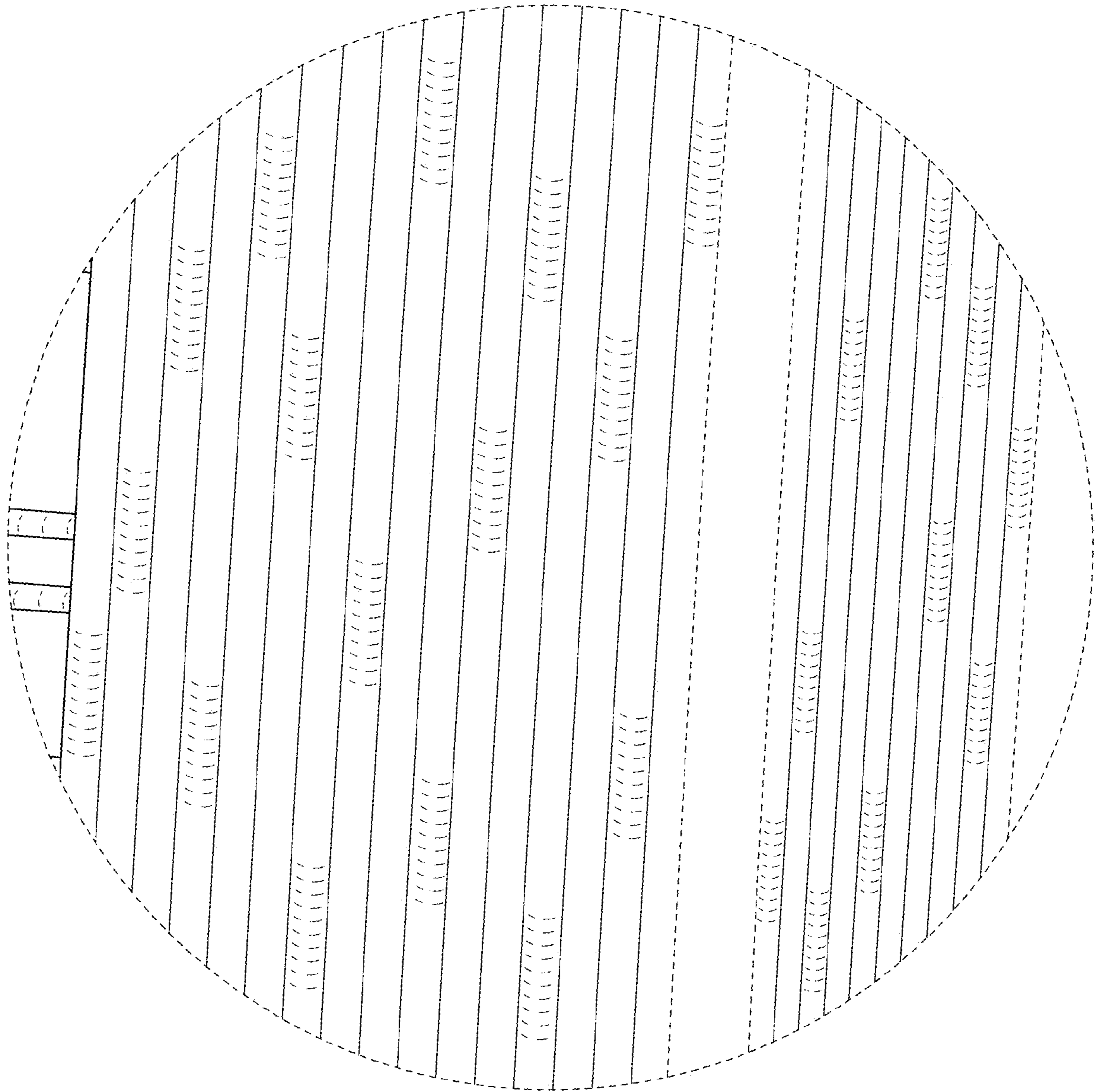
