(57) **CLAIM**

The ornamental design for leggings, as shown and described.

**DESCRIPTION**

This application is related to U.S. application Ser. No. 29/656,297 filed Jul. 11, 2018, entitled “Leggings,” which is concurrently filed herewith, and the disclosure of which is incorporated herein by reference.

FIG. 1 is a front perspective view of leggings according to our new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

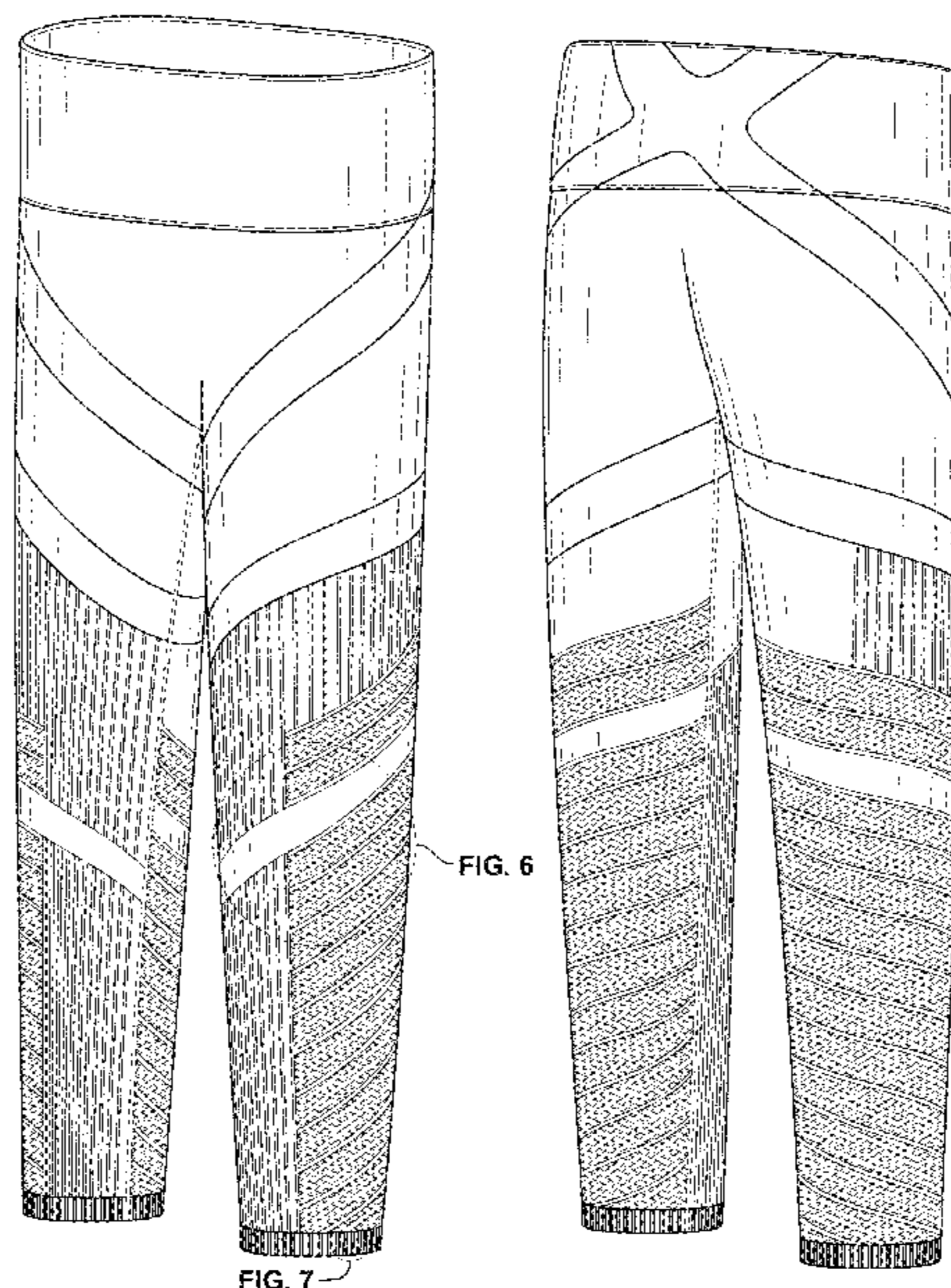
FIG. 5 is a right side elevation view thereof, the left side being a mirror image thereof;

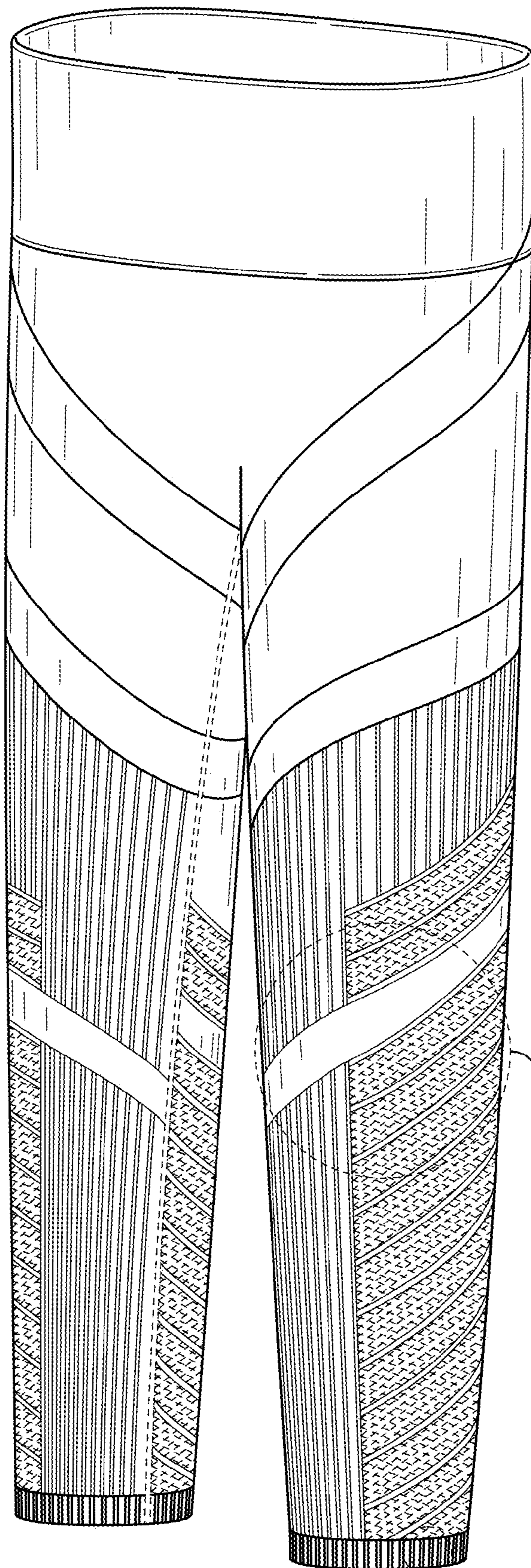

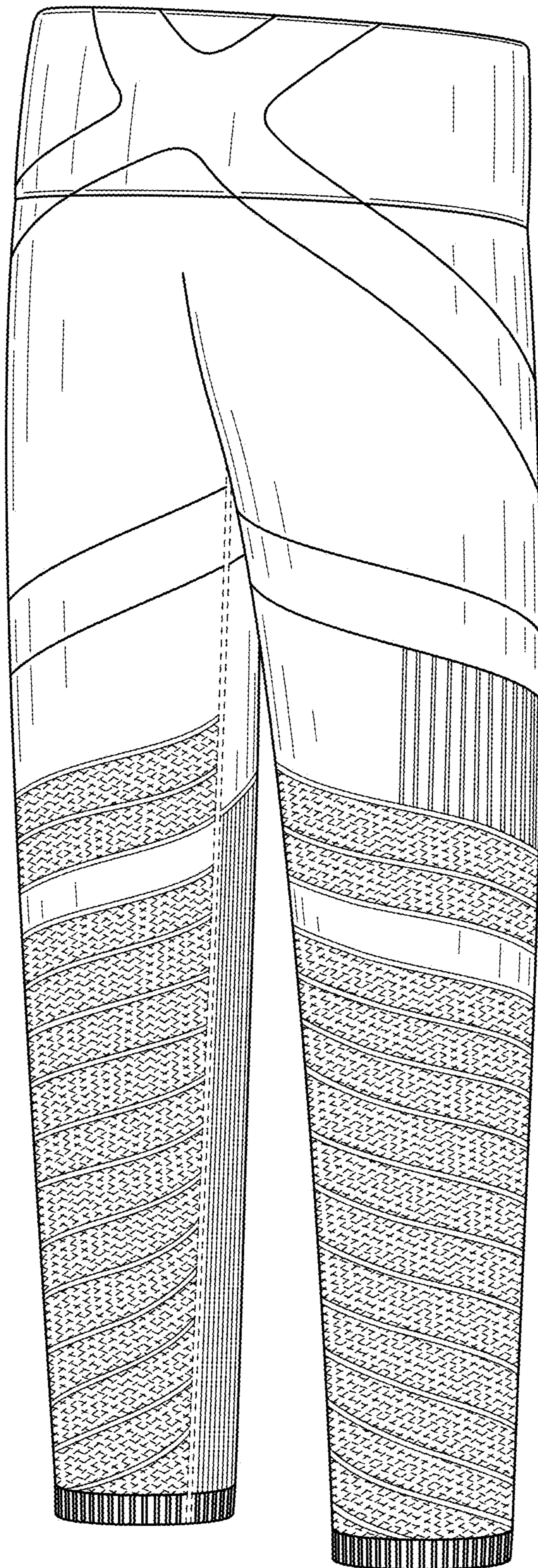

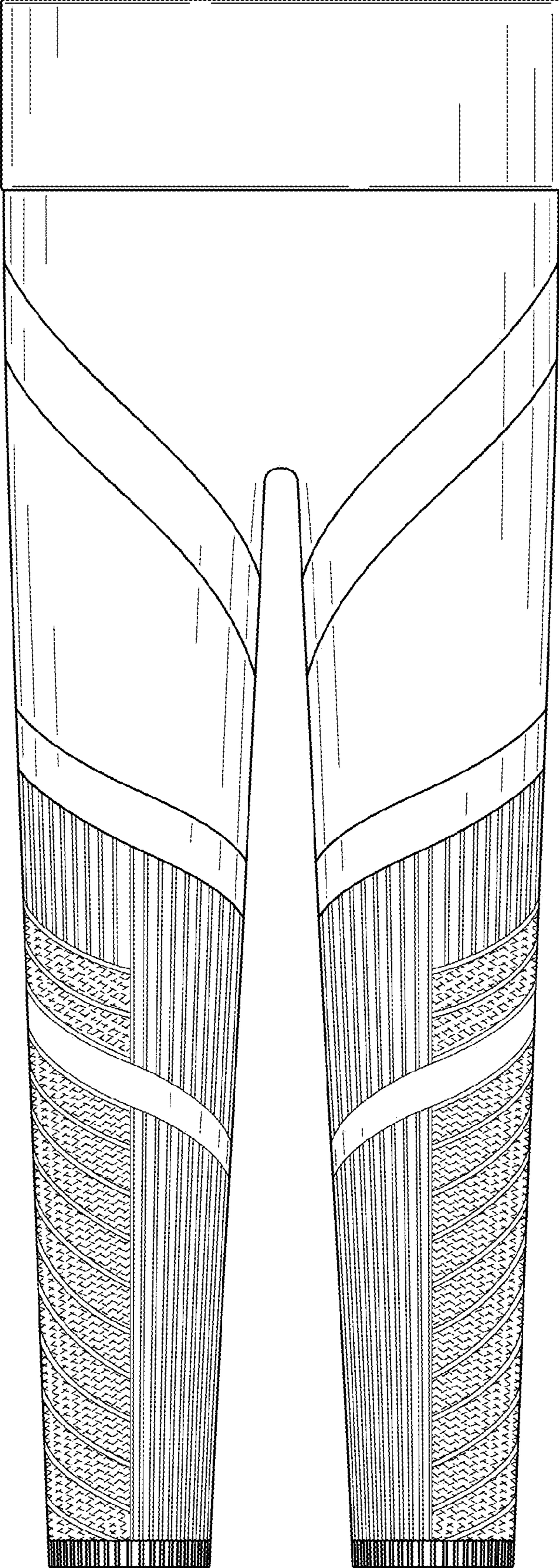

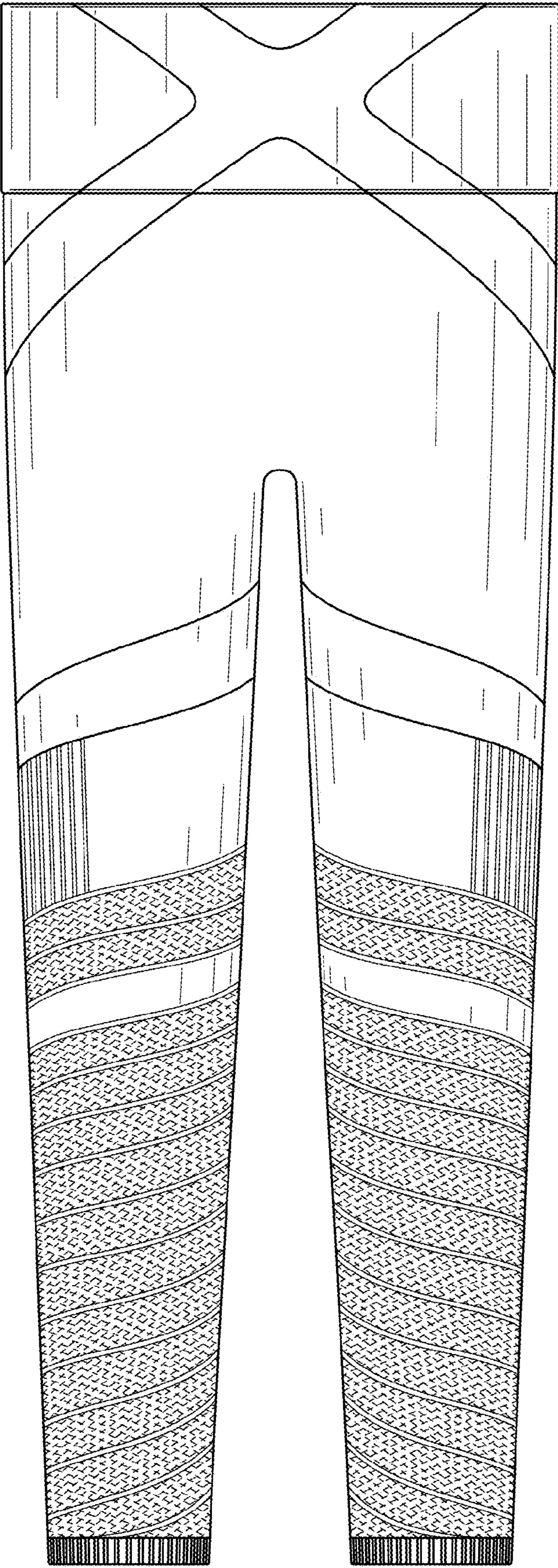

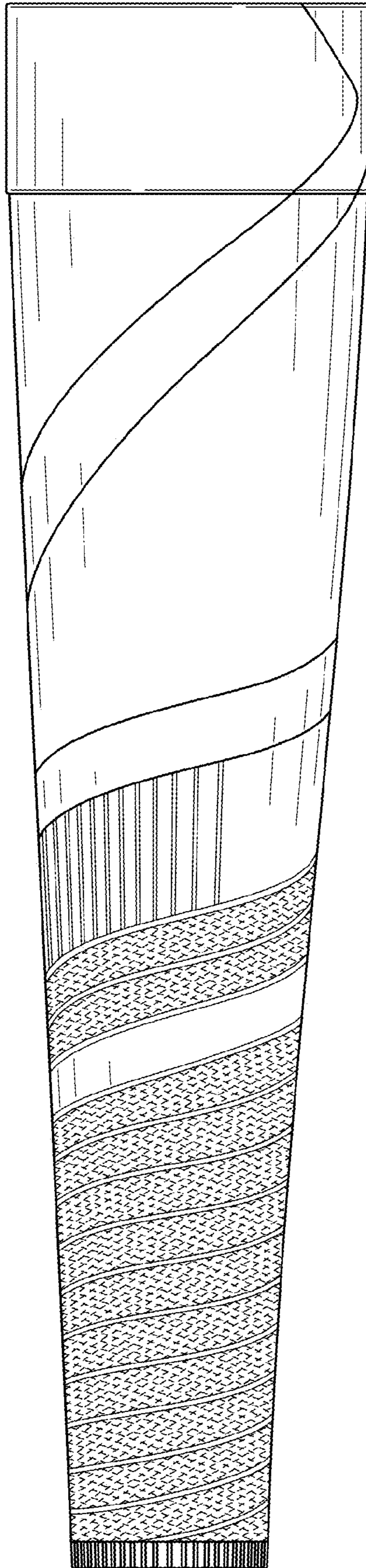

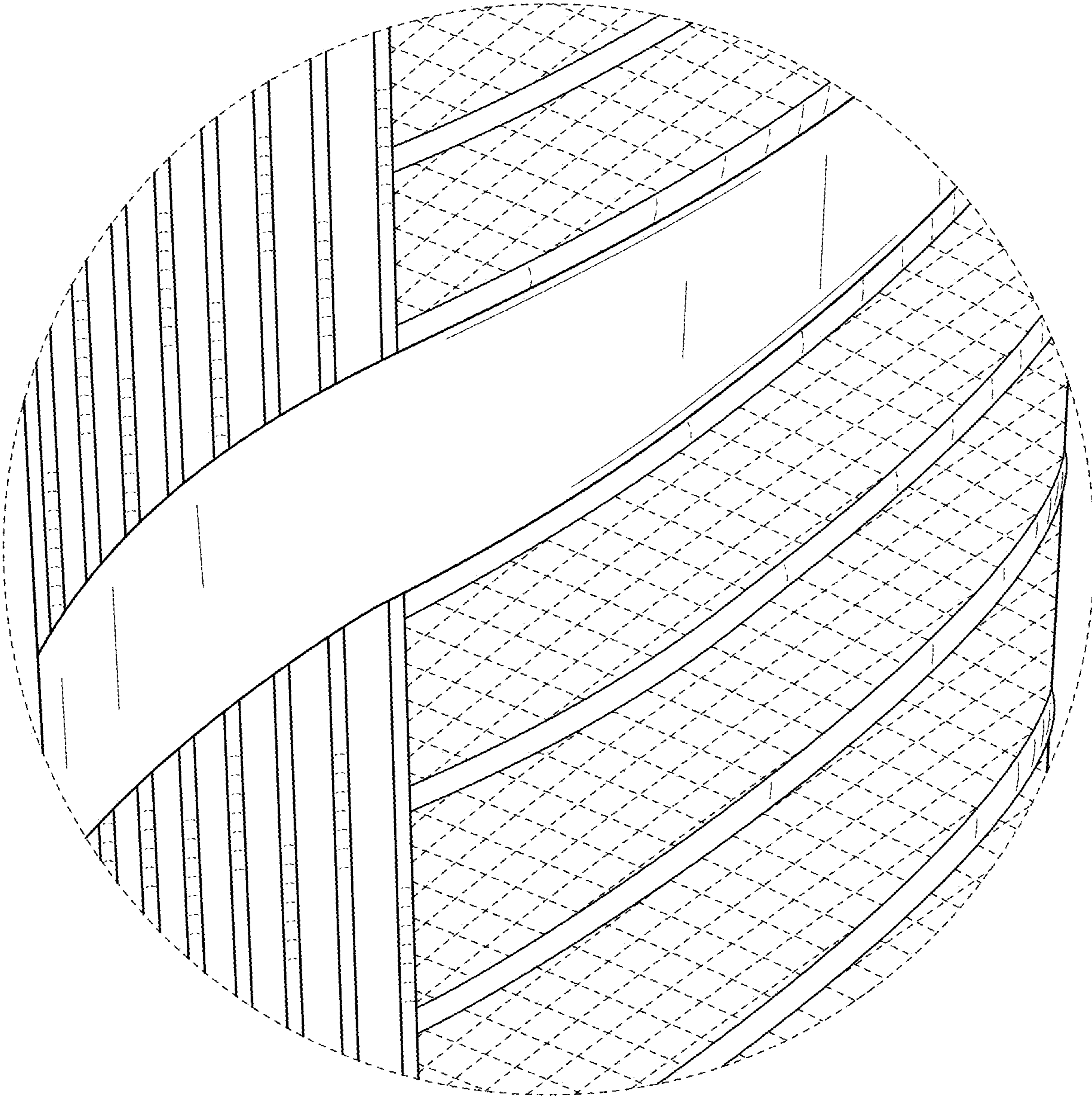

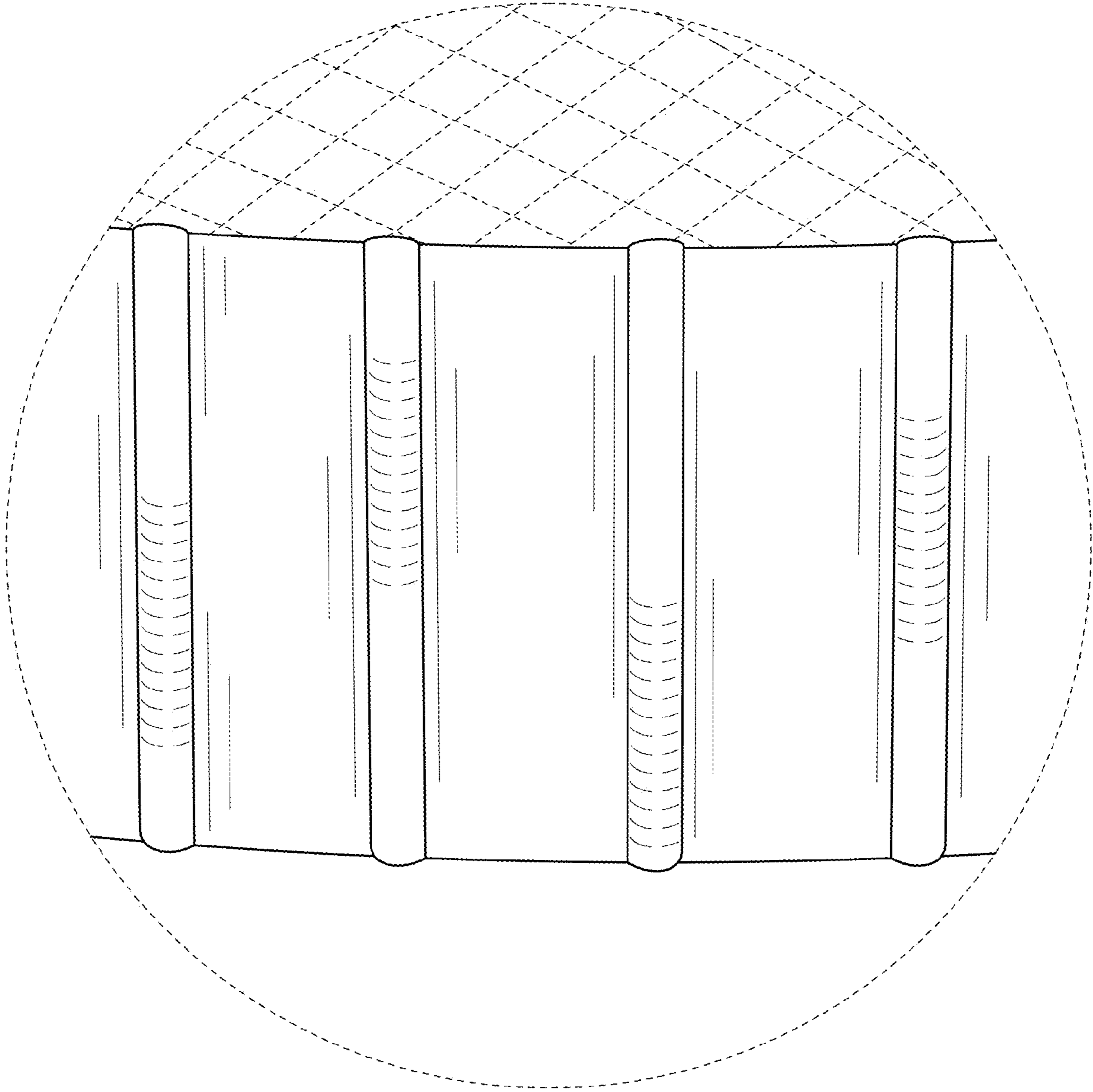
