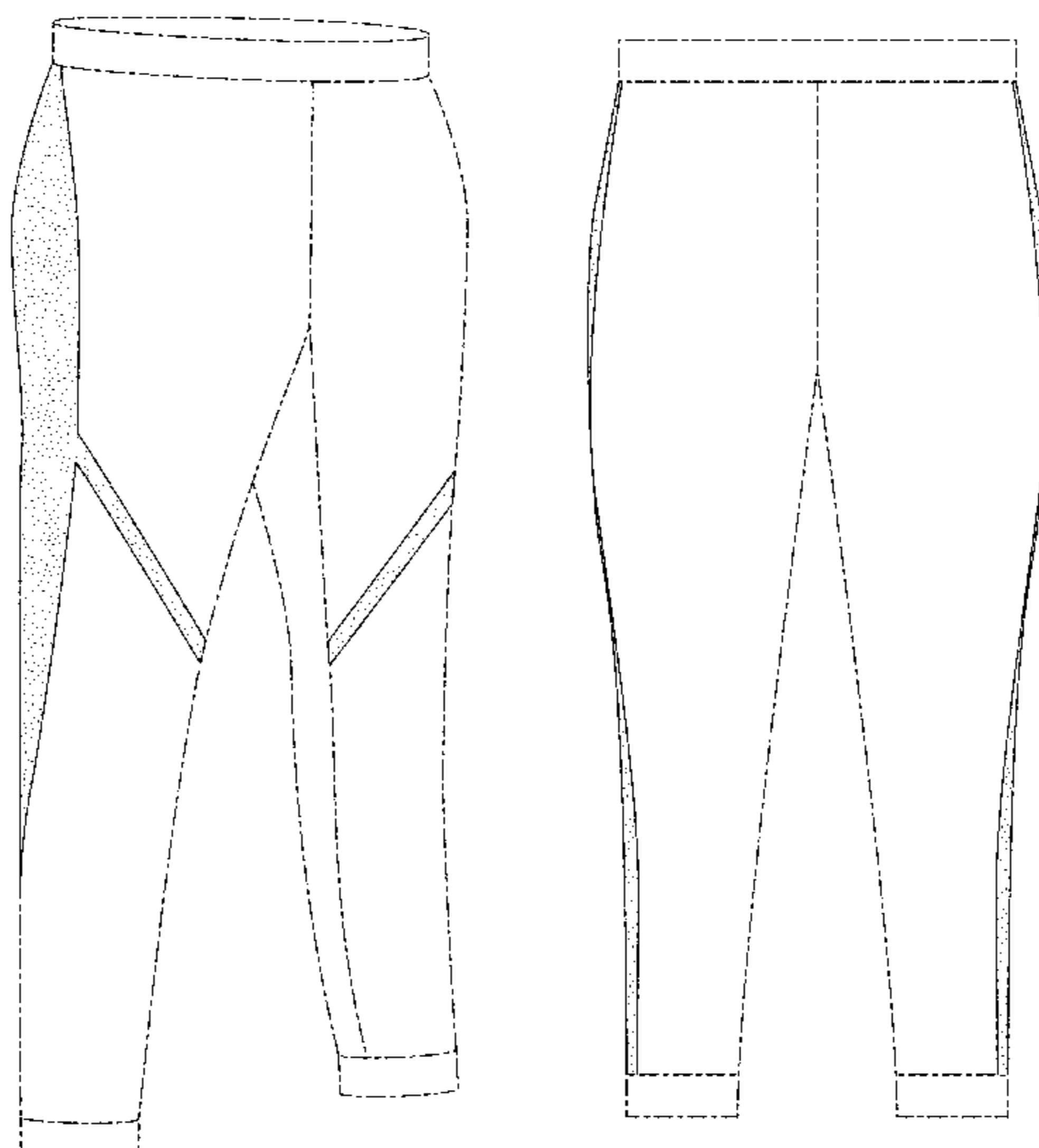
(57) **CLAIM**

The ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of pants showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view thereof; and,
FIG. 5 is an opposite side view thereof.
The broken lines immediately adjacent to the bottom of the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the pants show features that form no part of the claimed design.

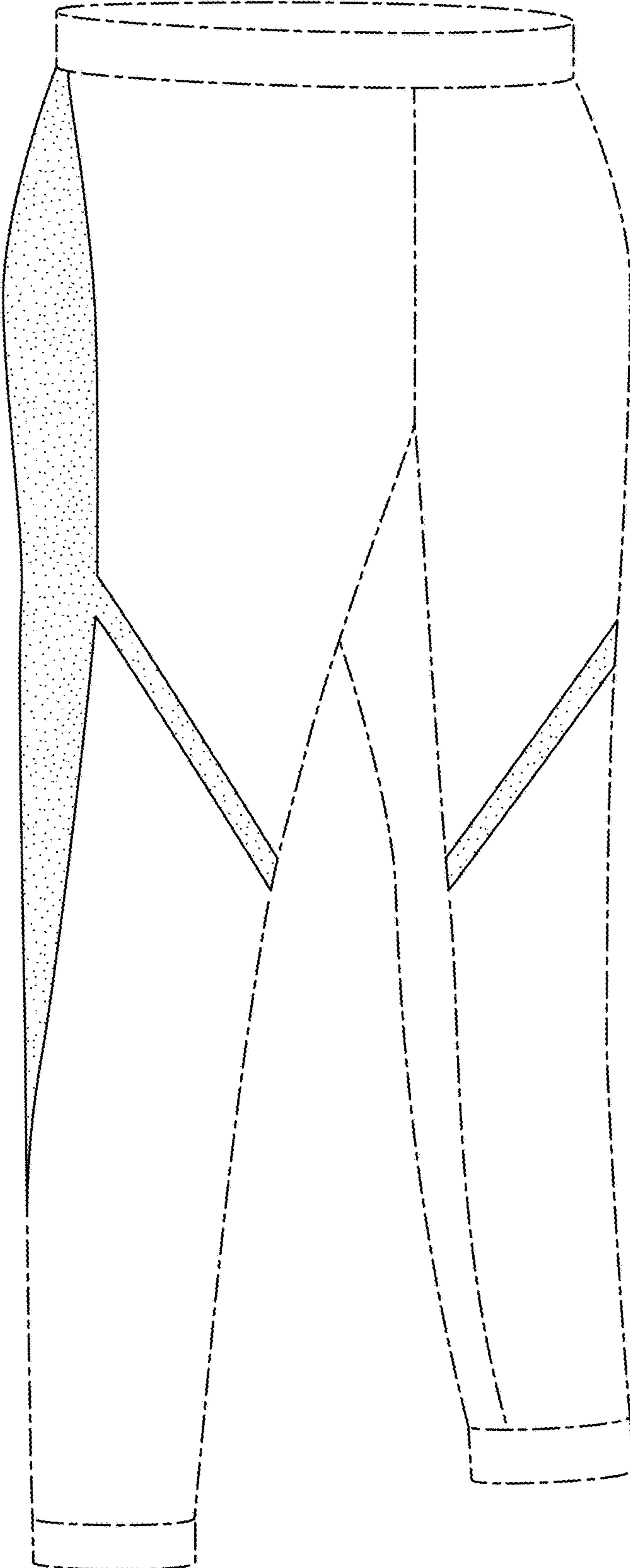

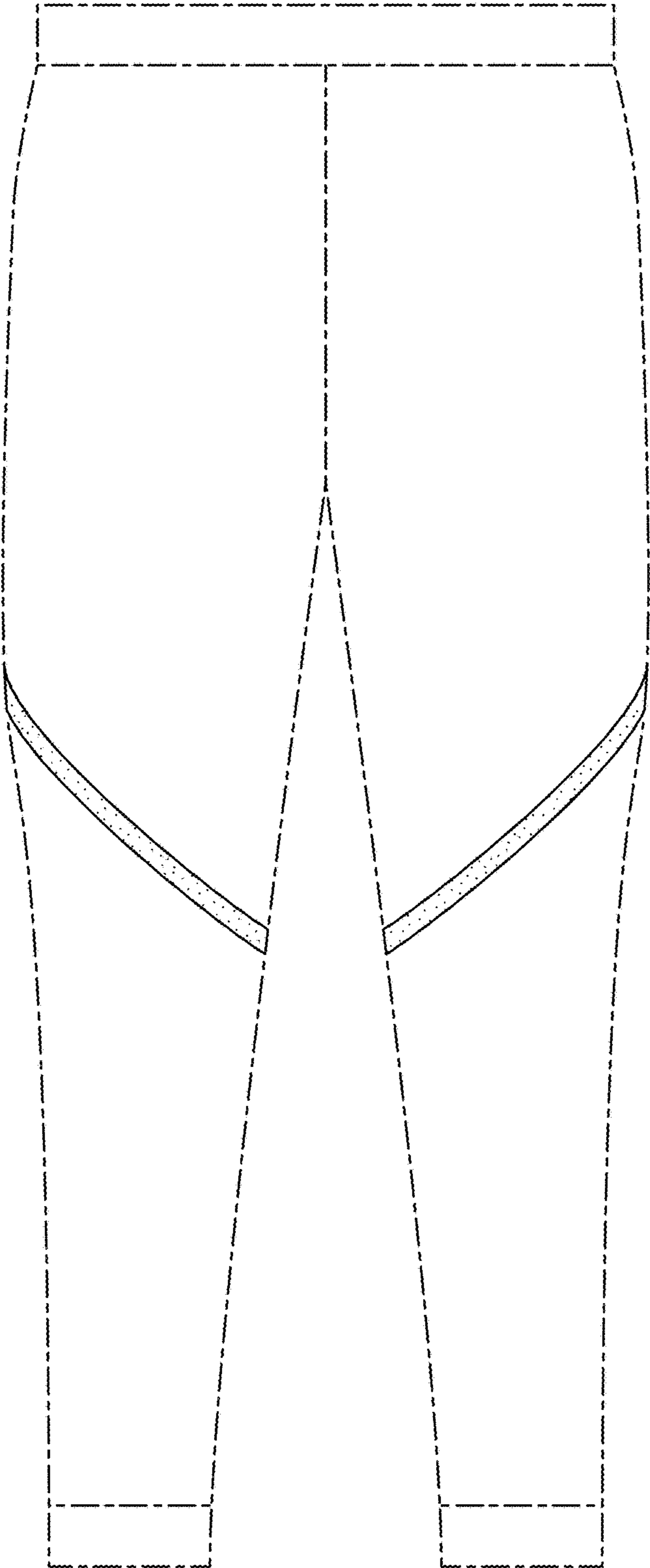

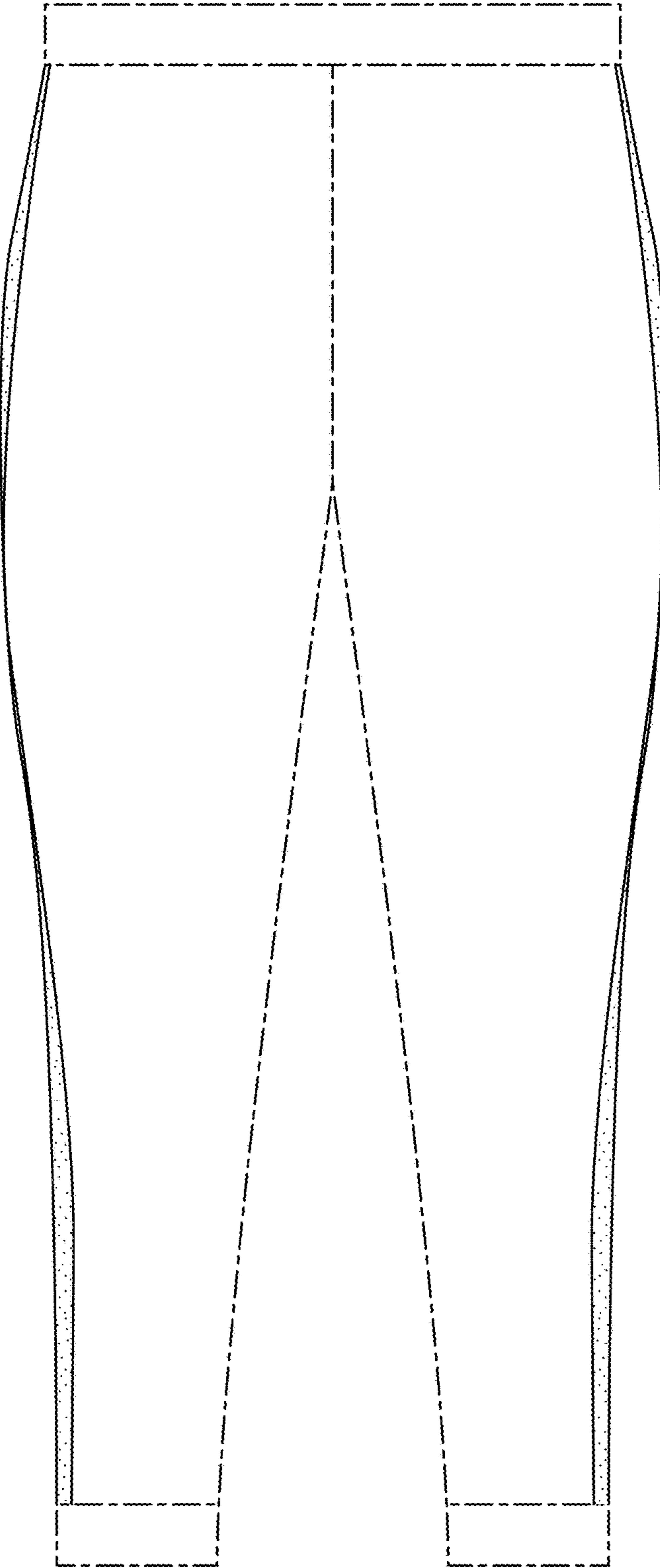

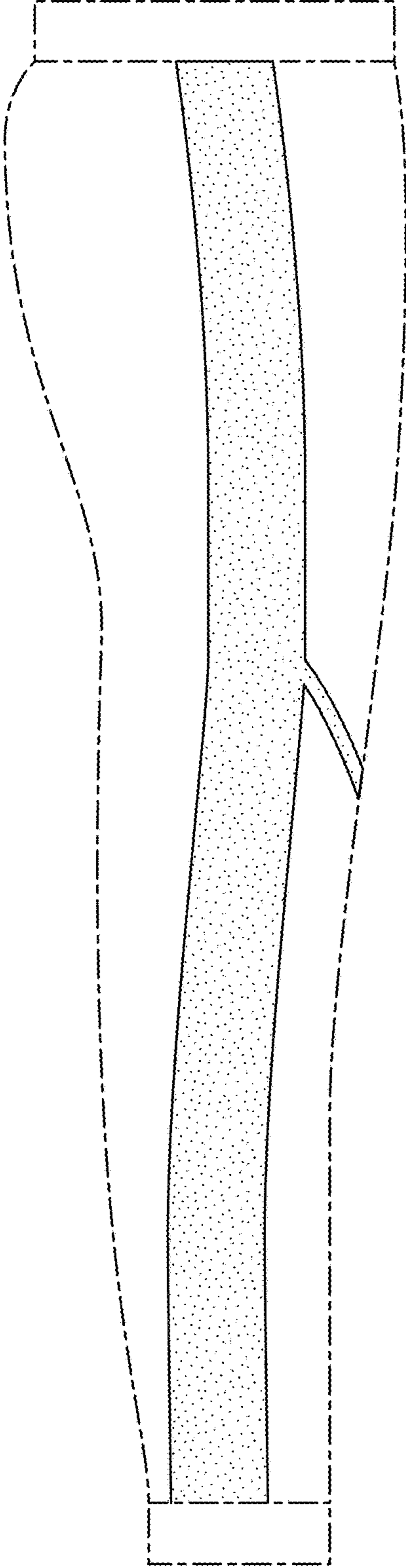

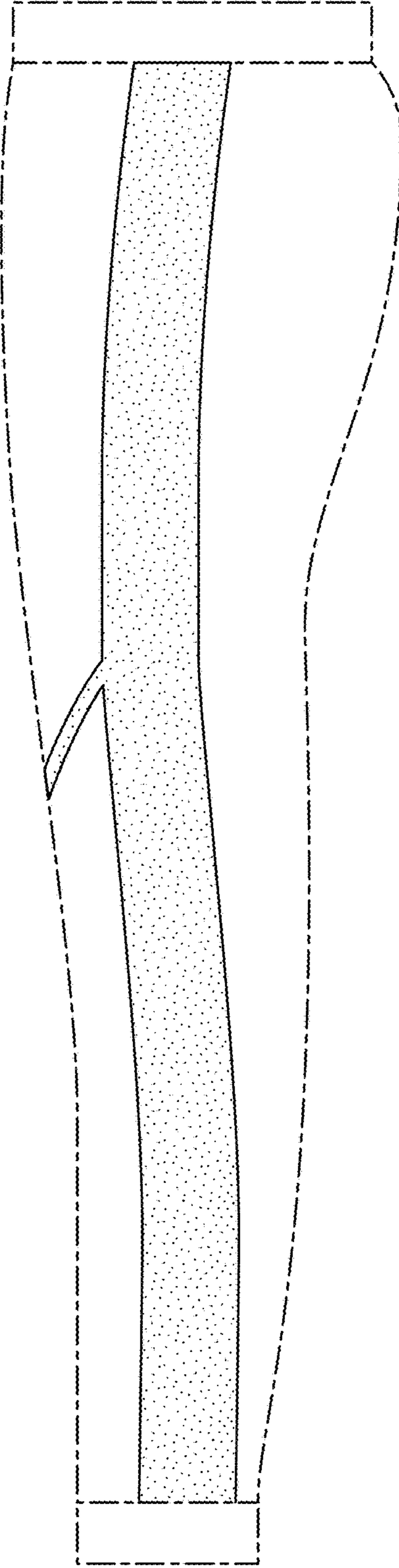
