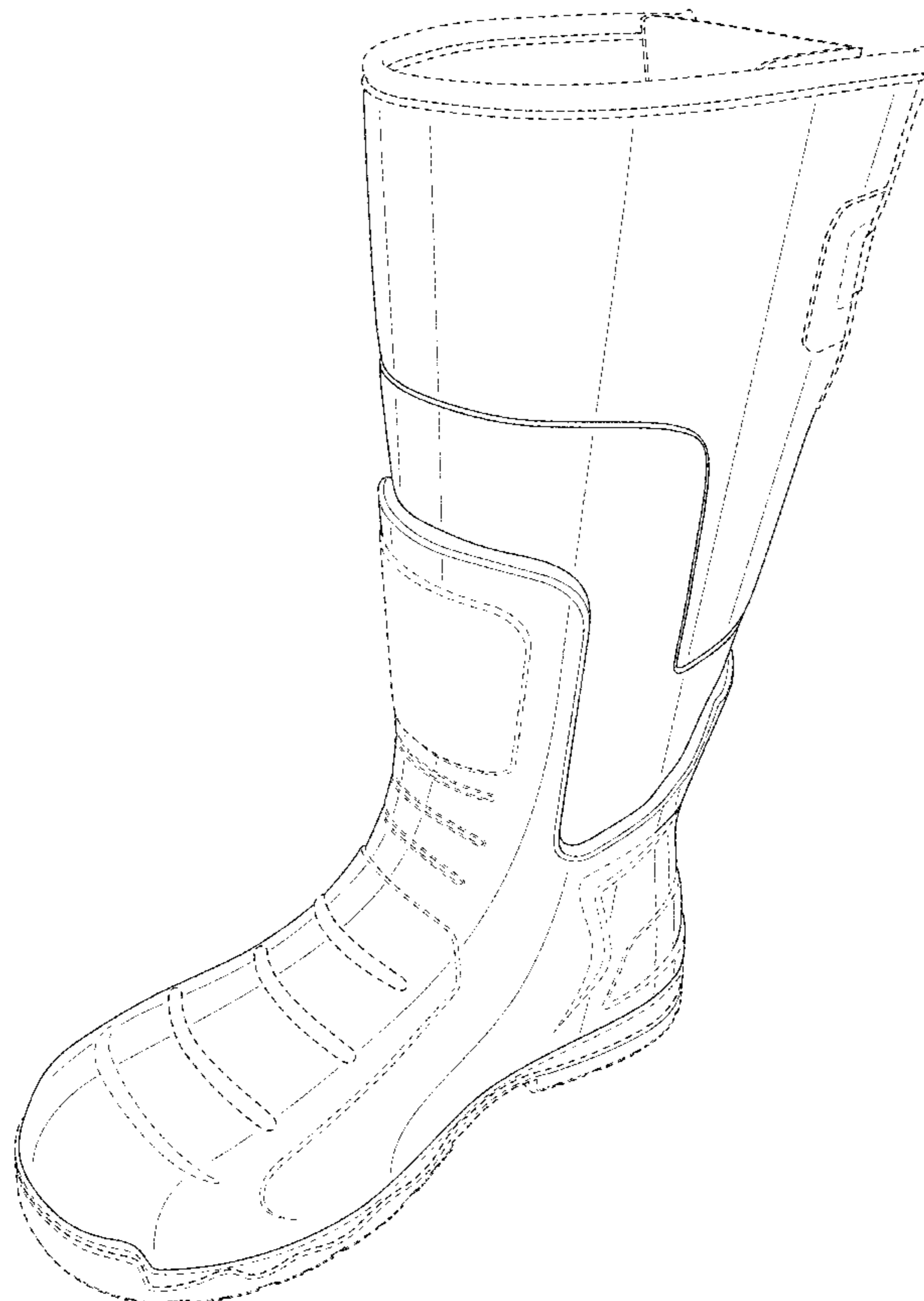

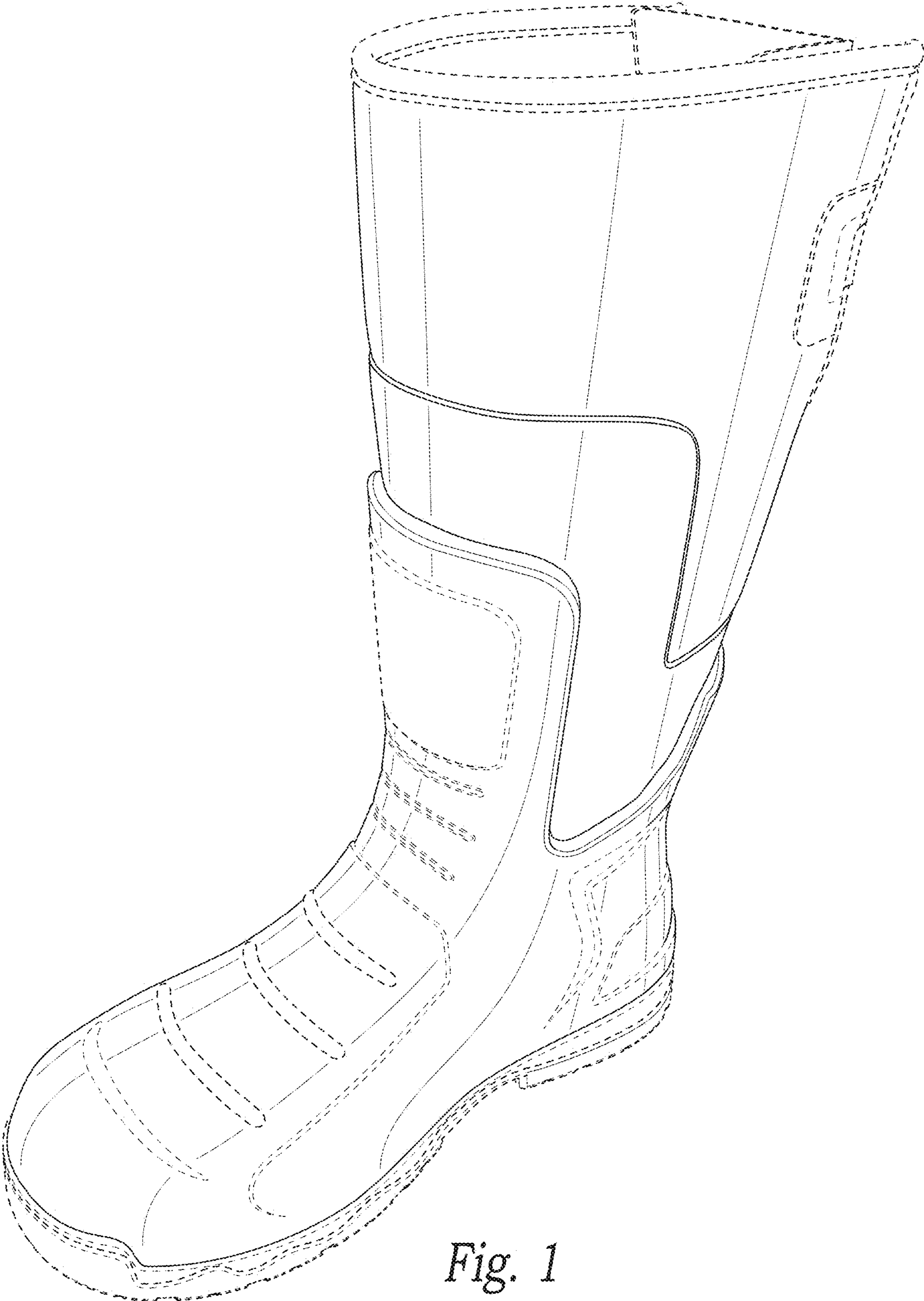
The ornamental design for a boot, as shown and described.

**DESCRIPTION**

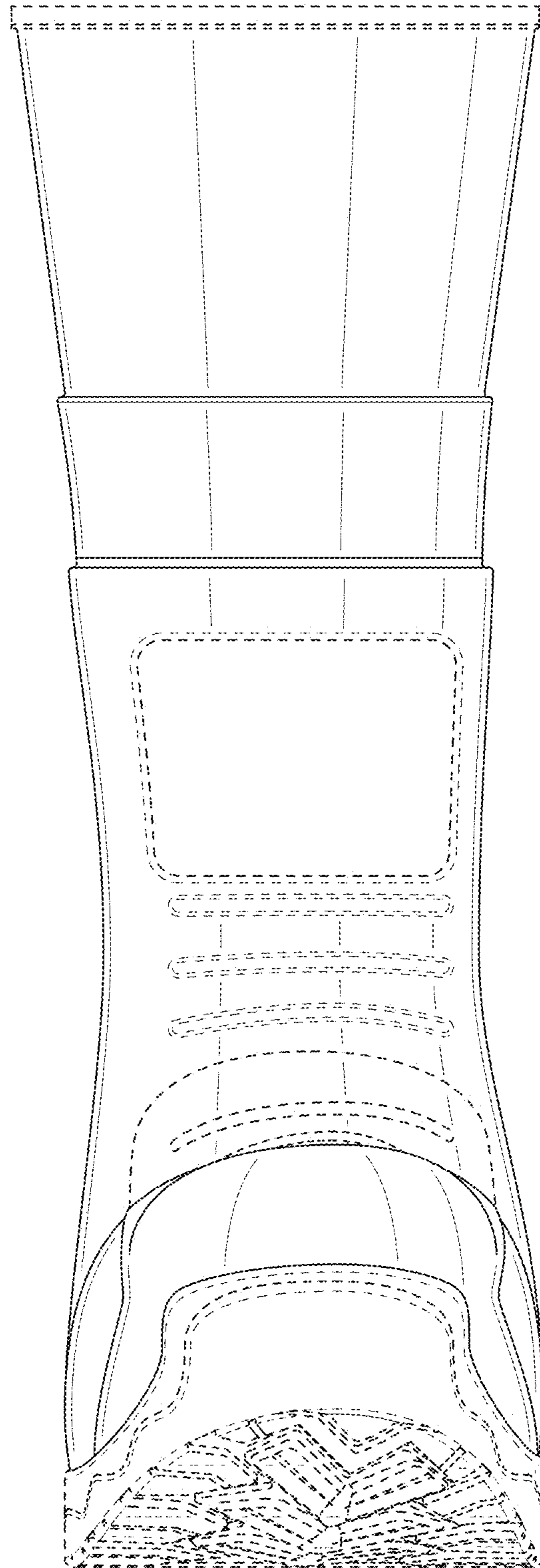
FIG. 1 is a perspective view of the first embodiment of a boot showing our new design.

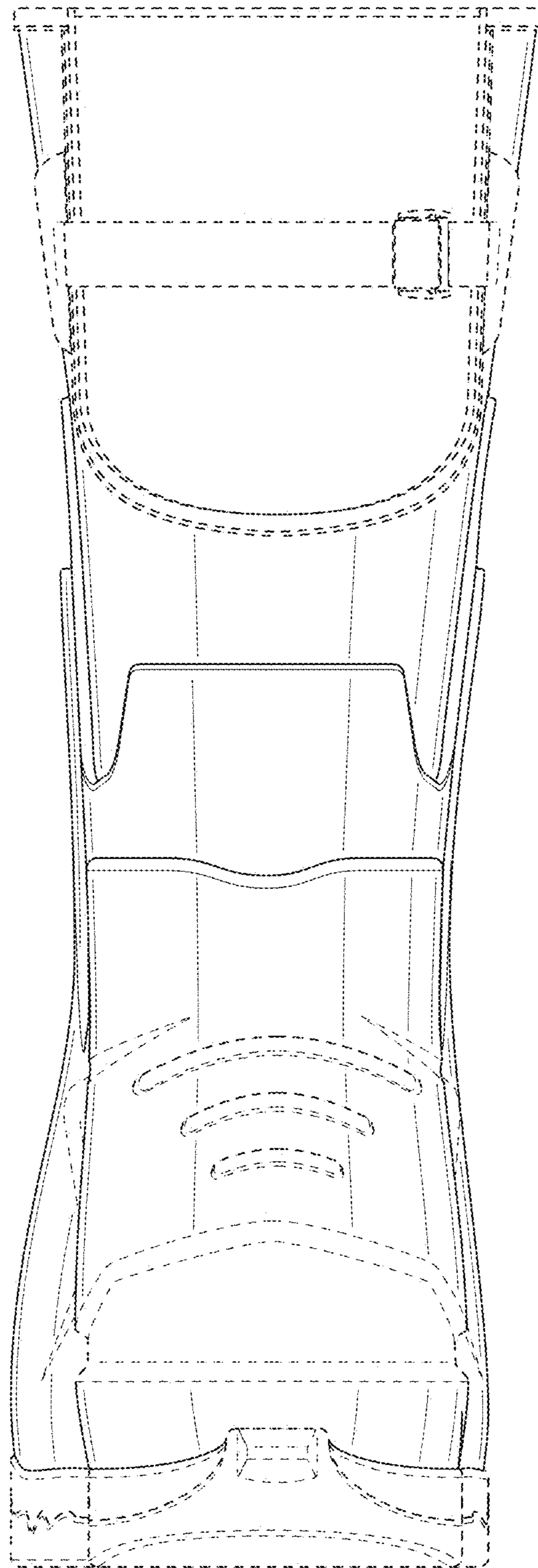

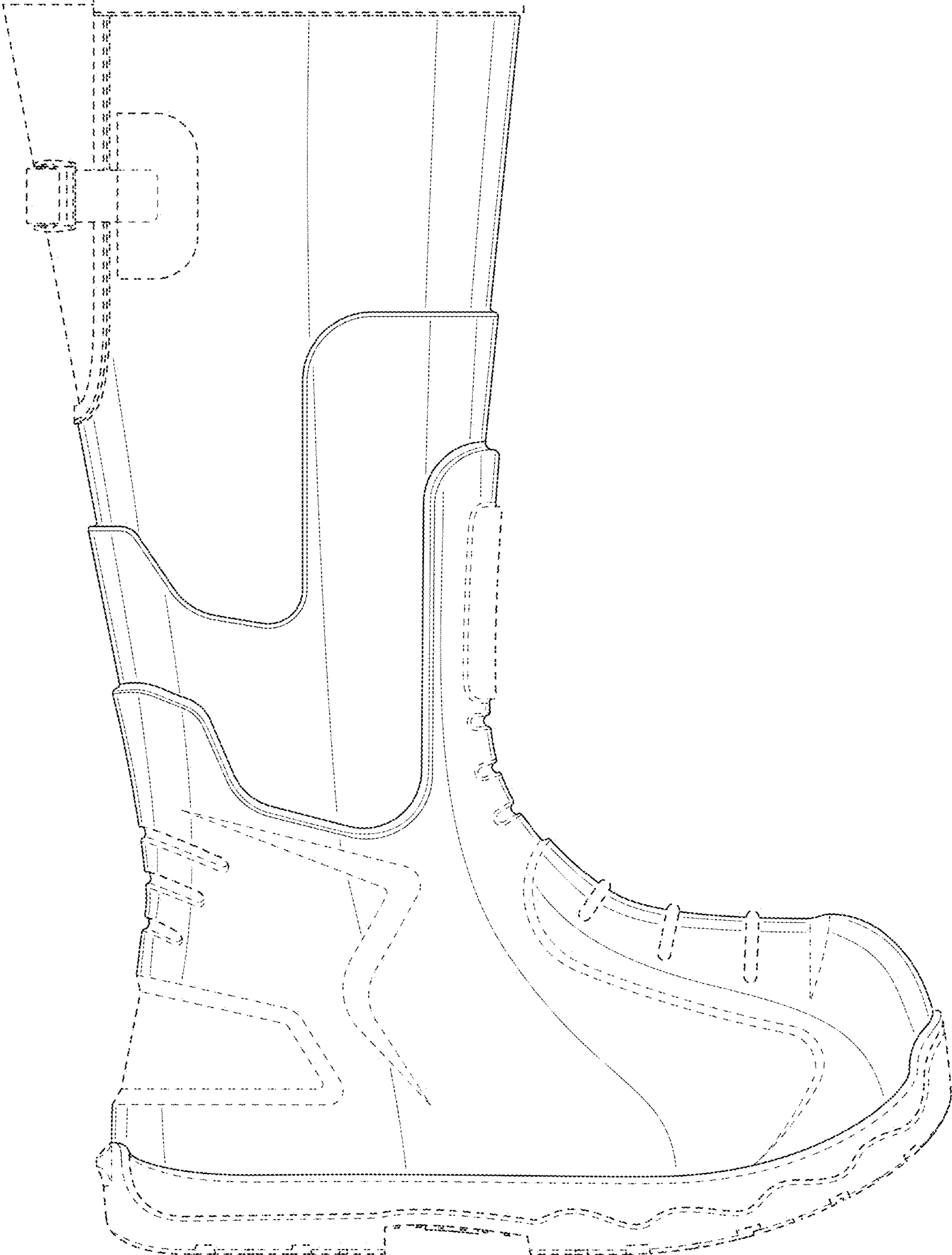

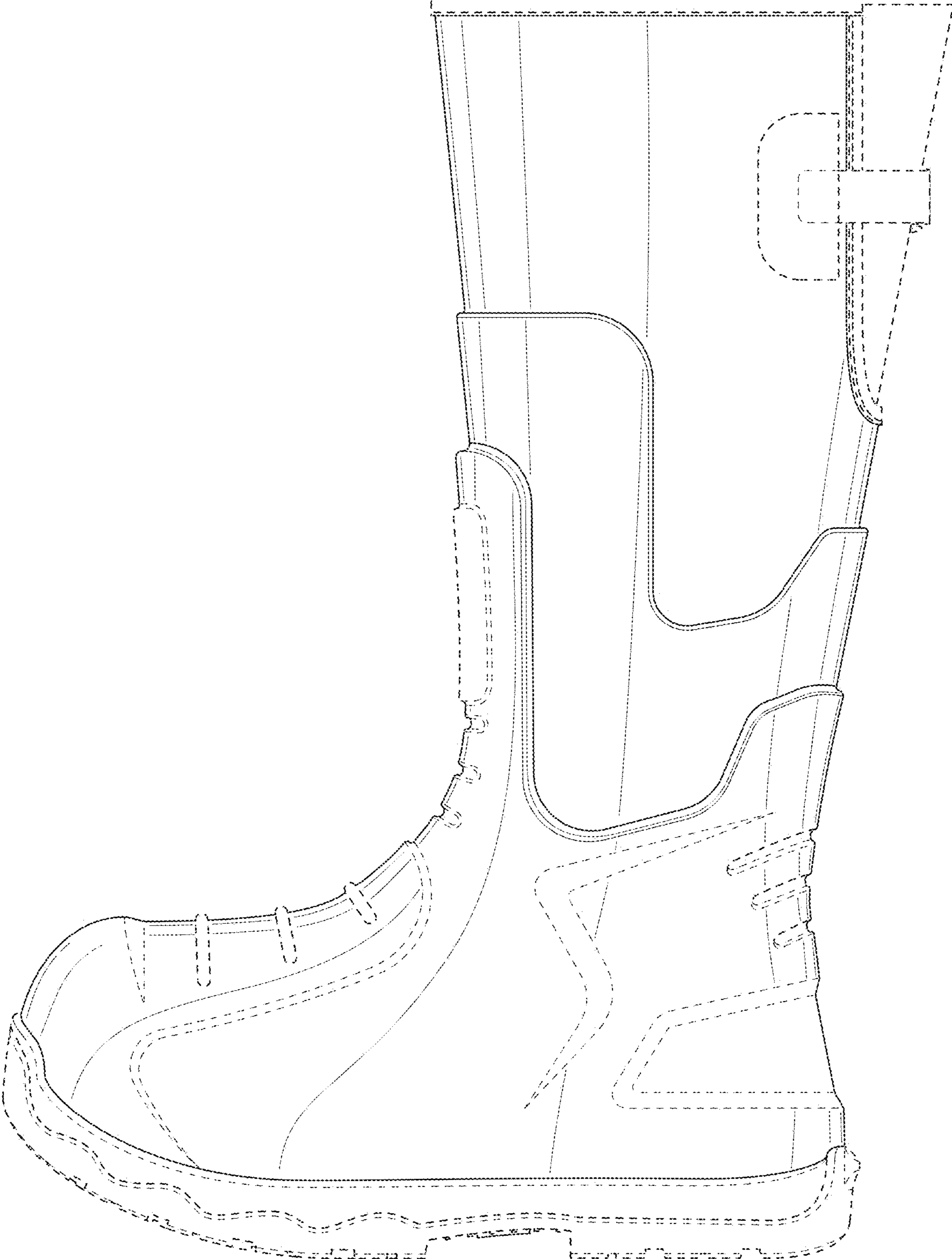

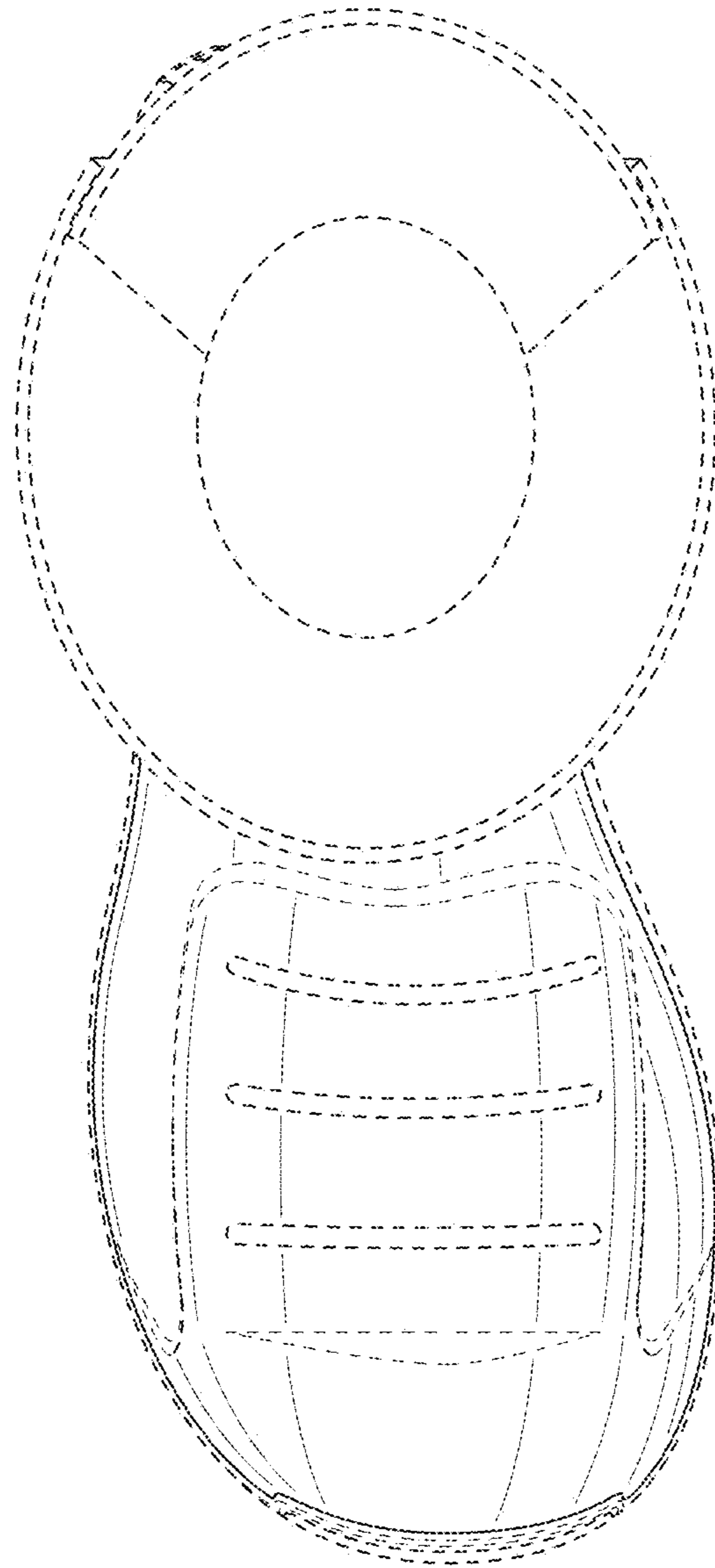




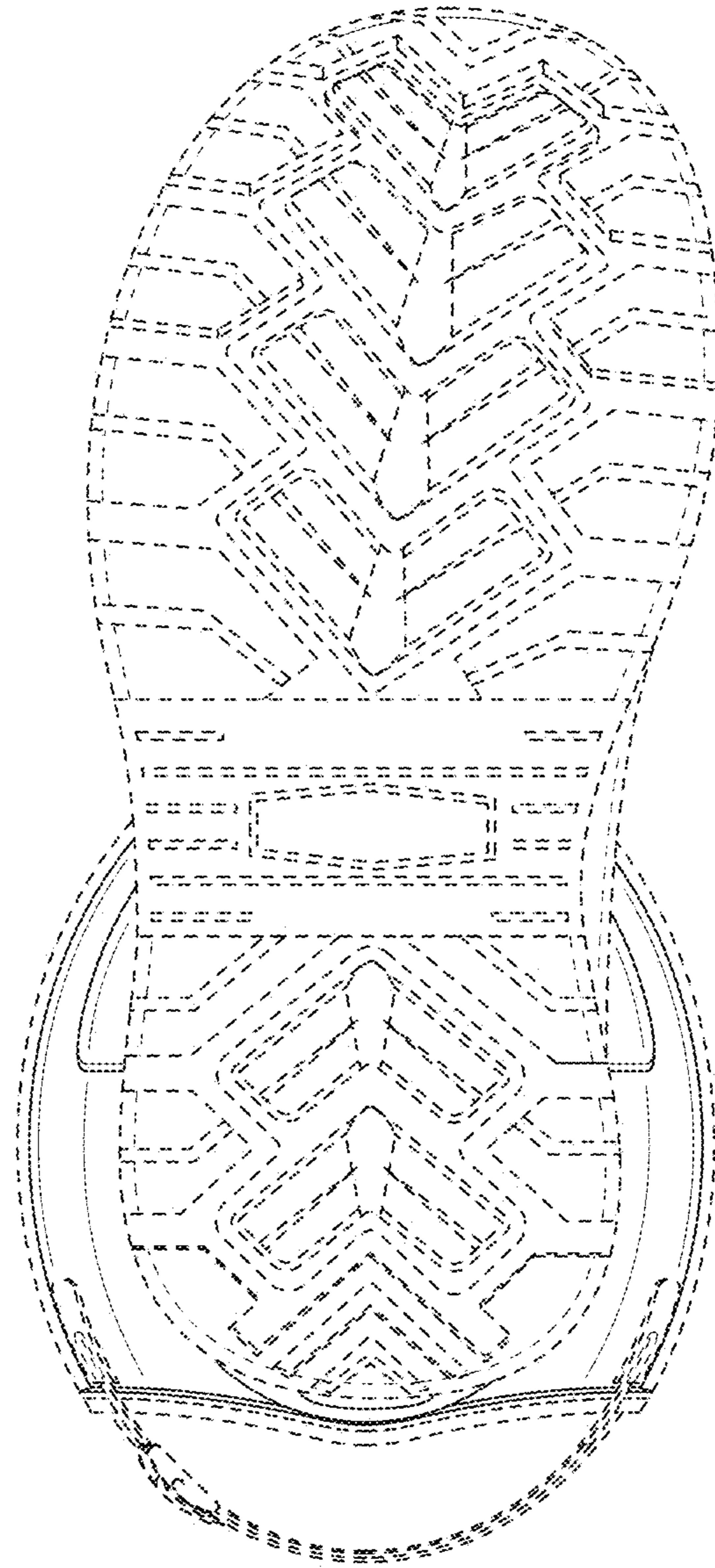
