(57) **CLAIM**

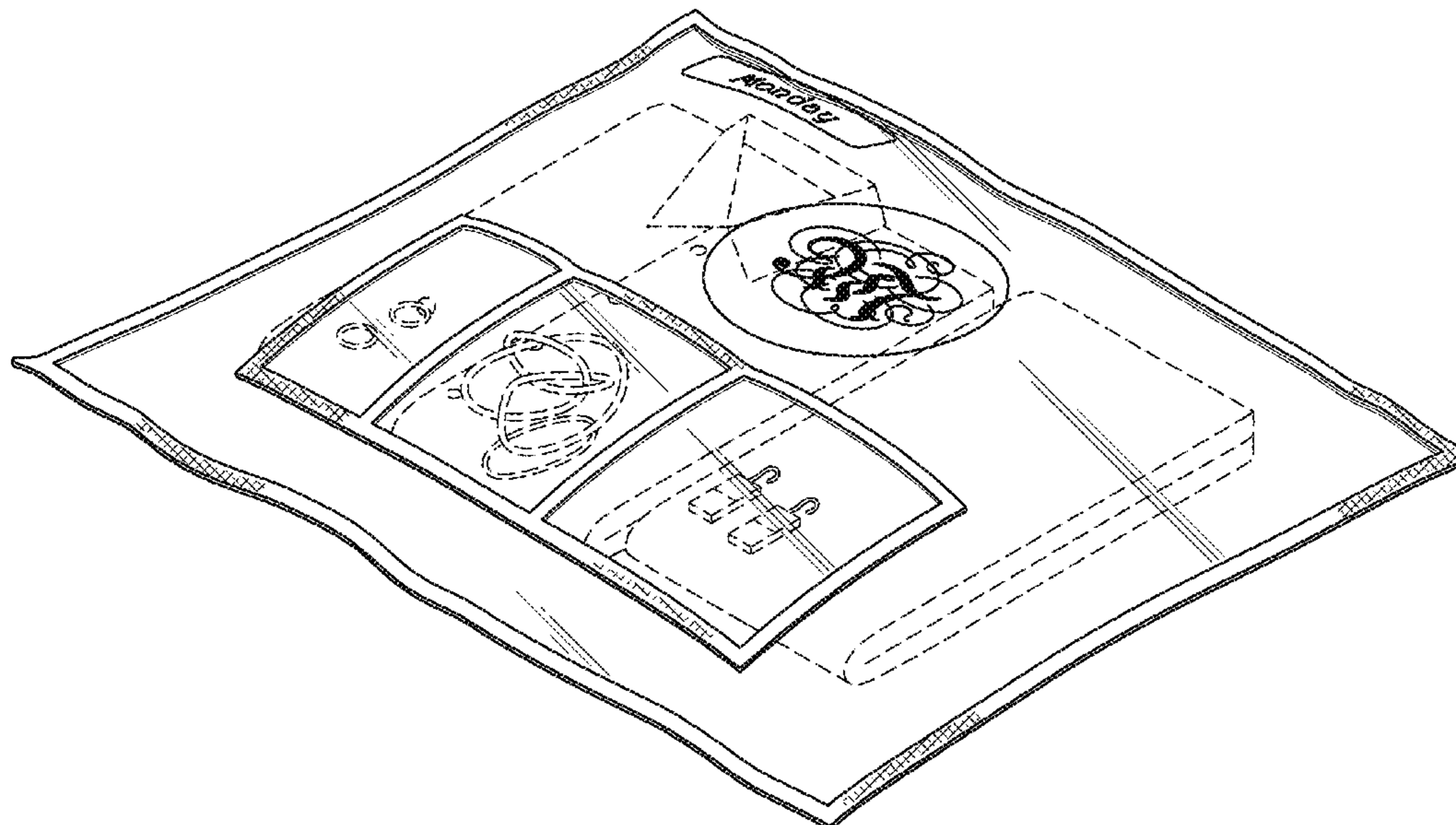
The ornamental design for a travel bag, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a travel bag showing my new design;
FIG. 2 is a rear view of the travel bag;
FIG. 3 is a right side view of the travel bag;
FIG. 4 is a left side view of the travel bag;
FIG. 5 is a top view of the travel bag;
FIG. 6 is a bottom view of the travel bag; and,
FIG. 7 is a bottom front side perspective view of the travel bag in use.
The broken lines in FIG. 7 are illustrative of environmental structure forming no part of the claimed design.

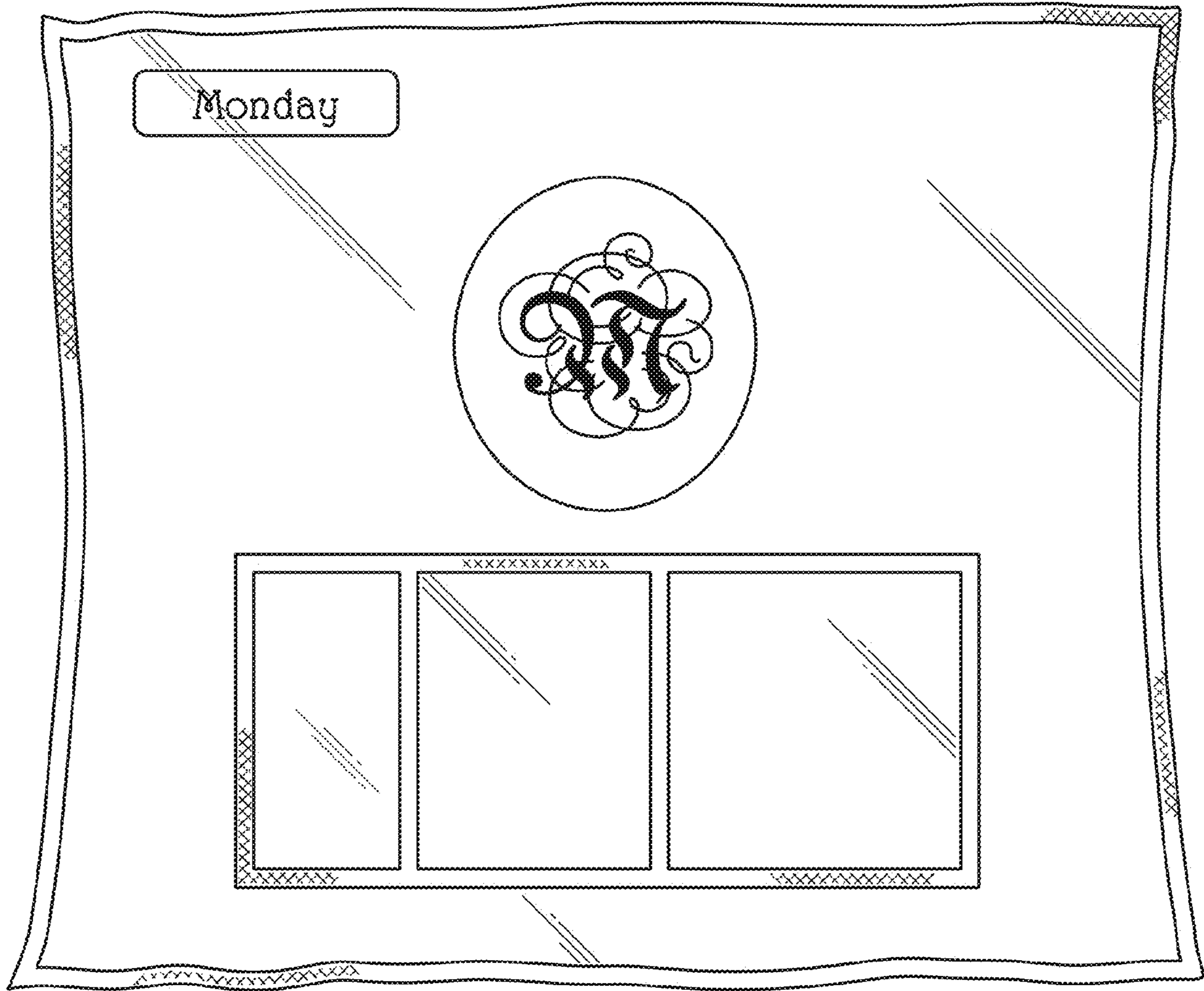

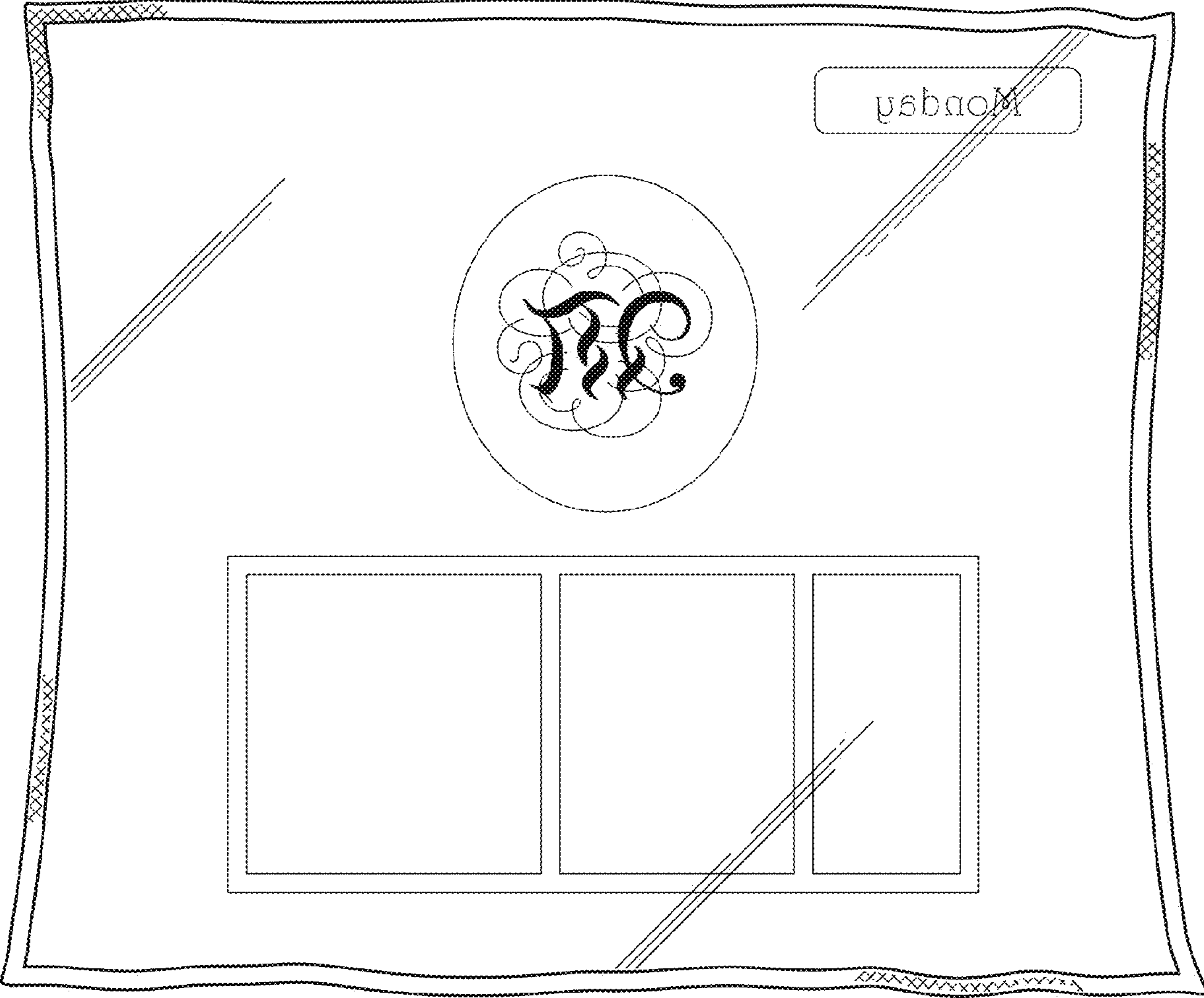

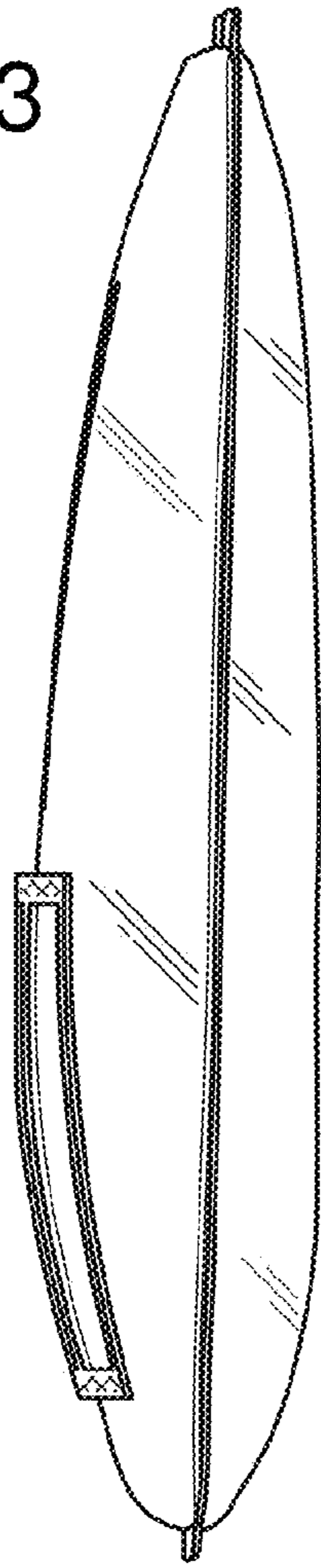

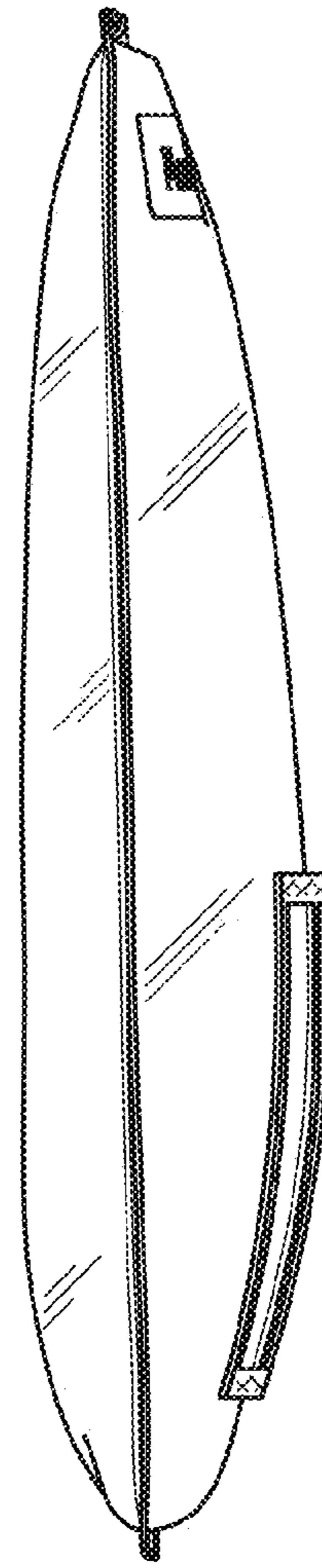

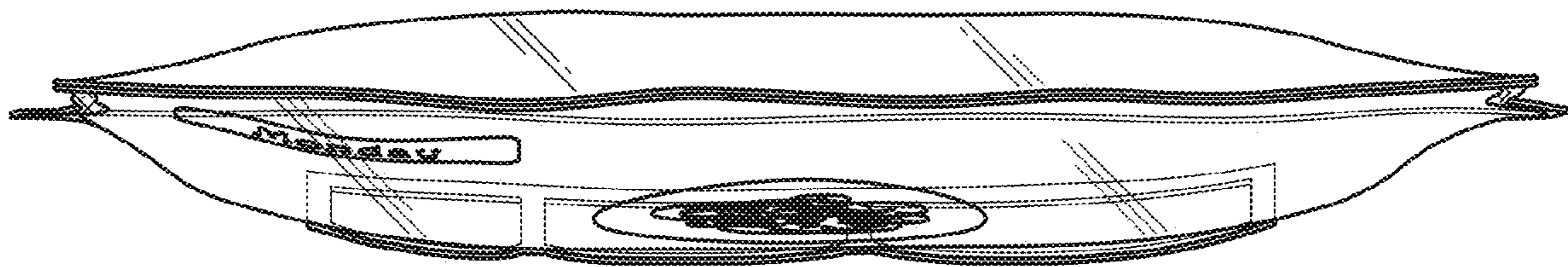
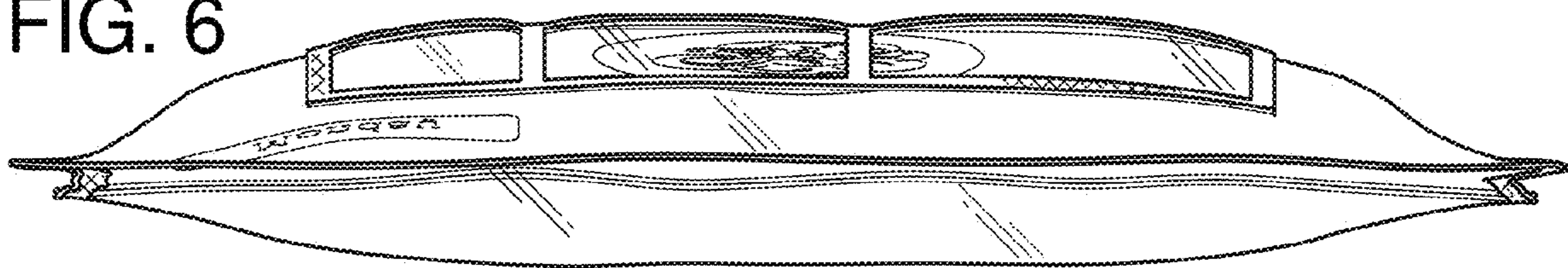

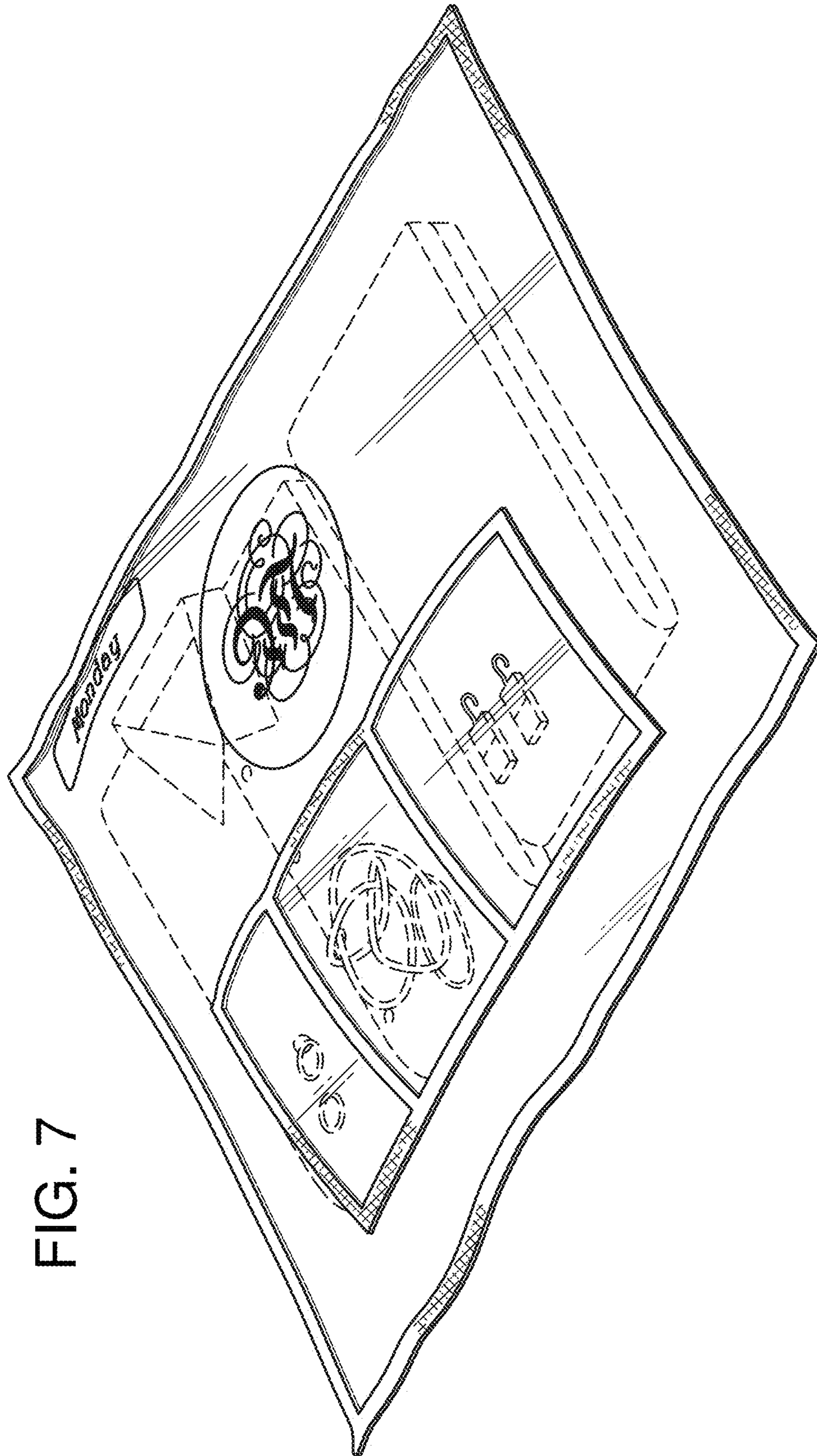
