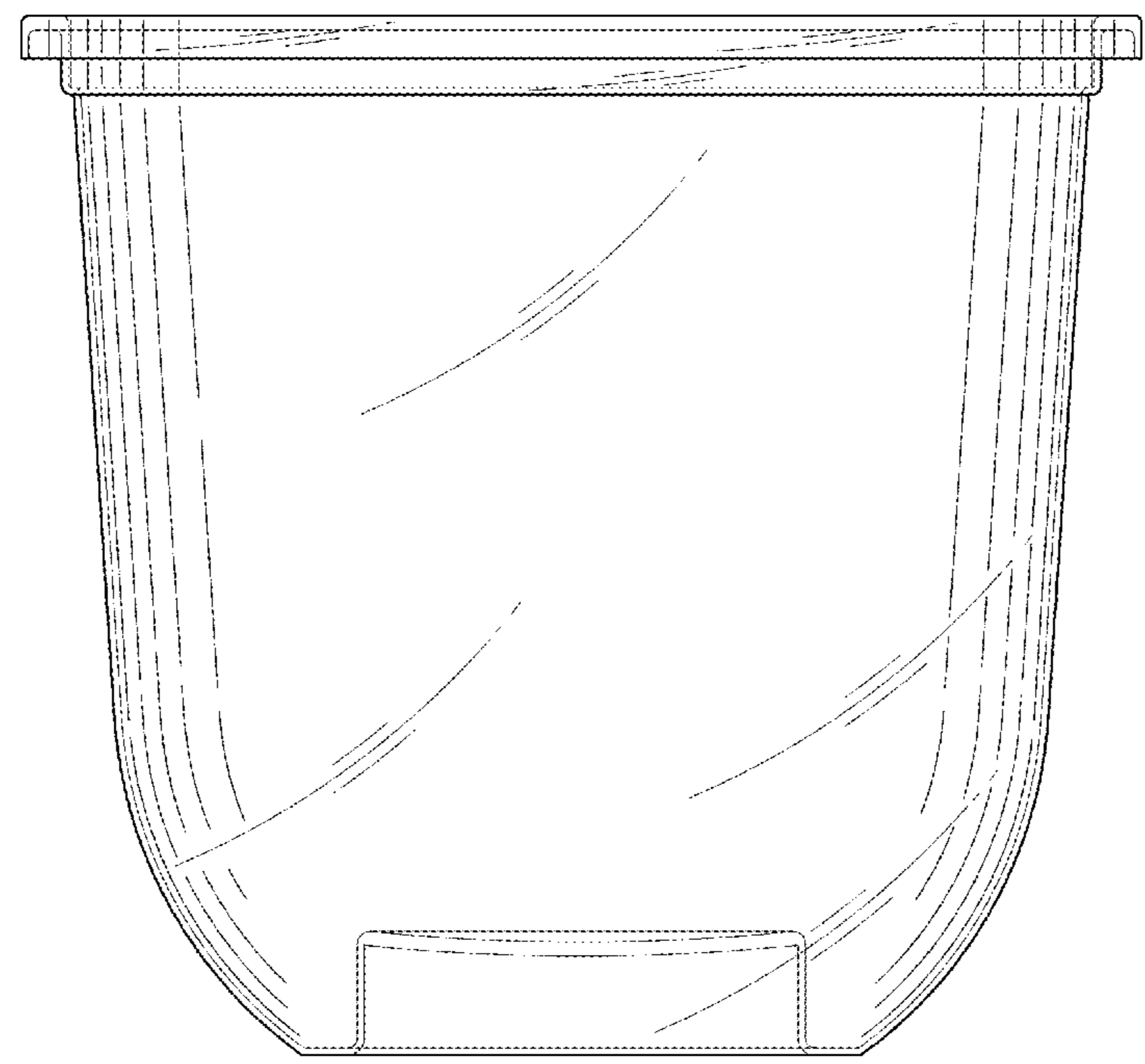

DESCRIPTION
FIG. 1 is a top perspective view of a cup showing my new design;
FIG. 2 is a front elevational view thereof; the rear, left side and right side elevational views being identical to the front elevational view;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a cross section view showing a section taken along line 5-5 of FIG. 3; and,
FIG. 6 is a bottom perspective view thereof.

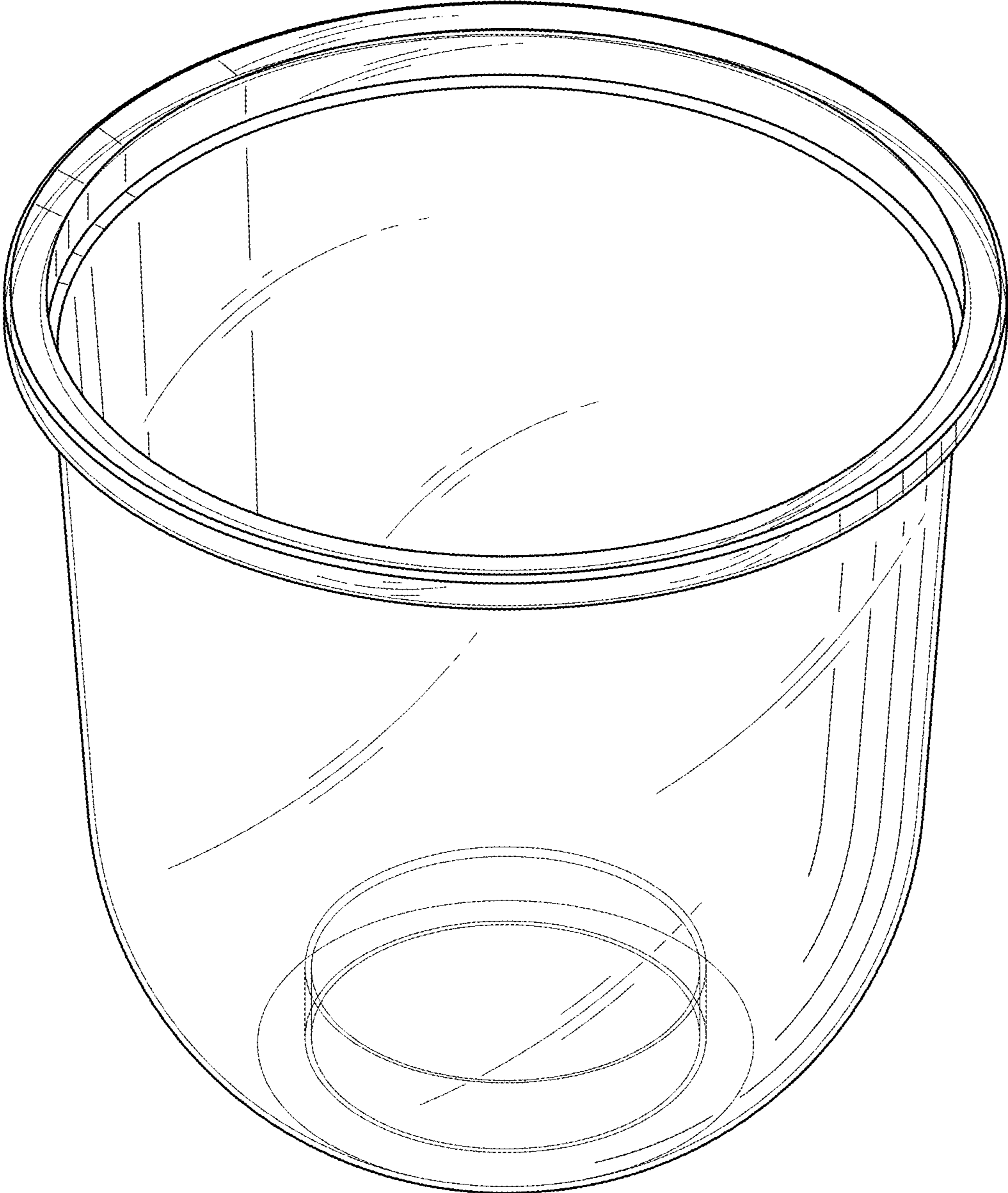

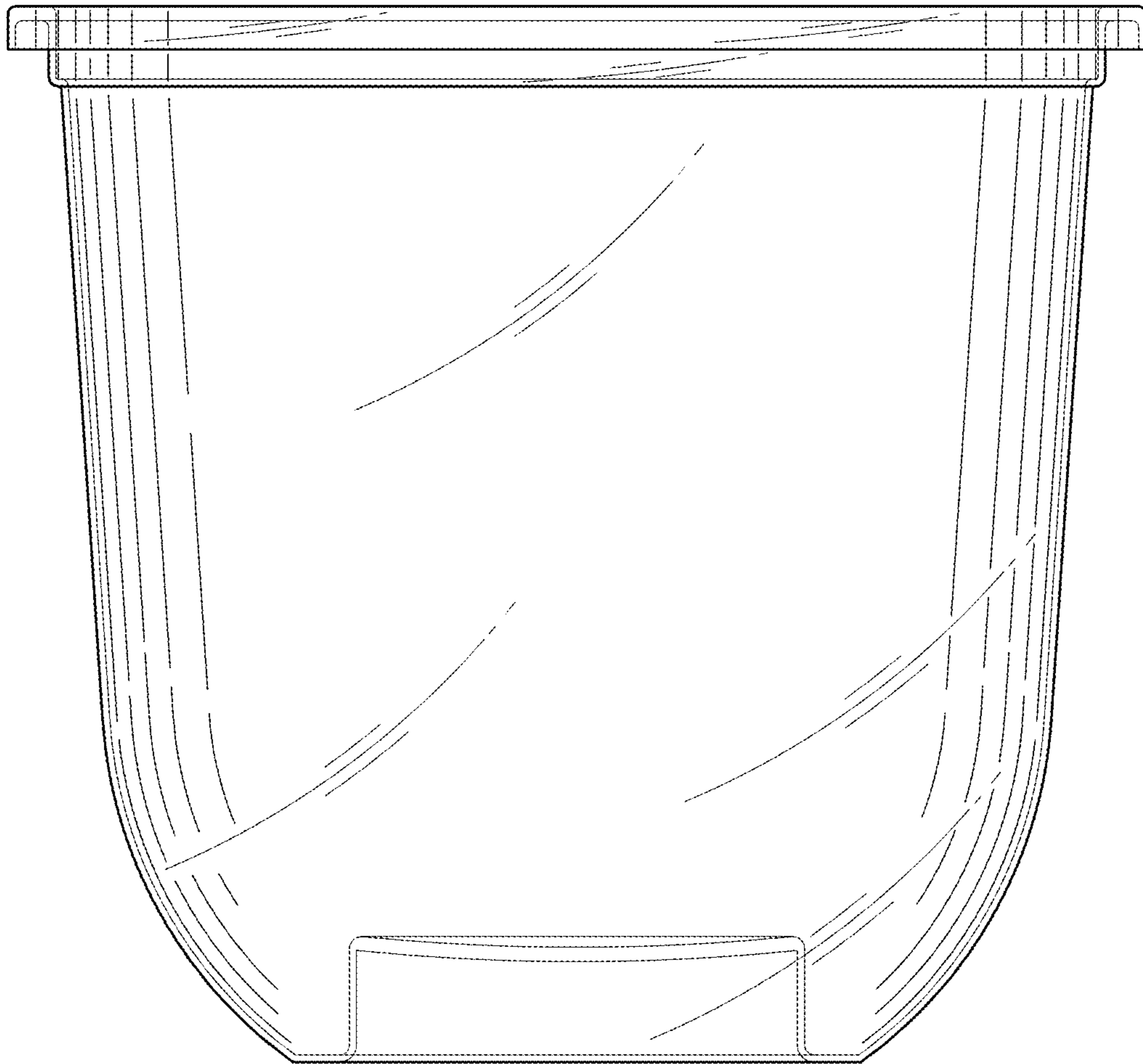

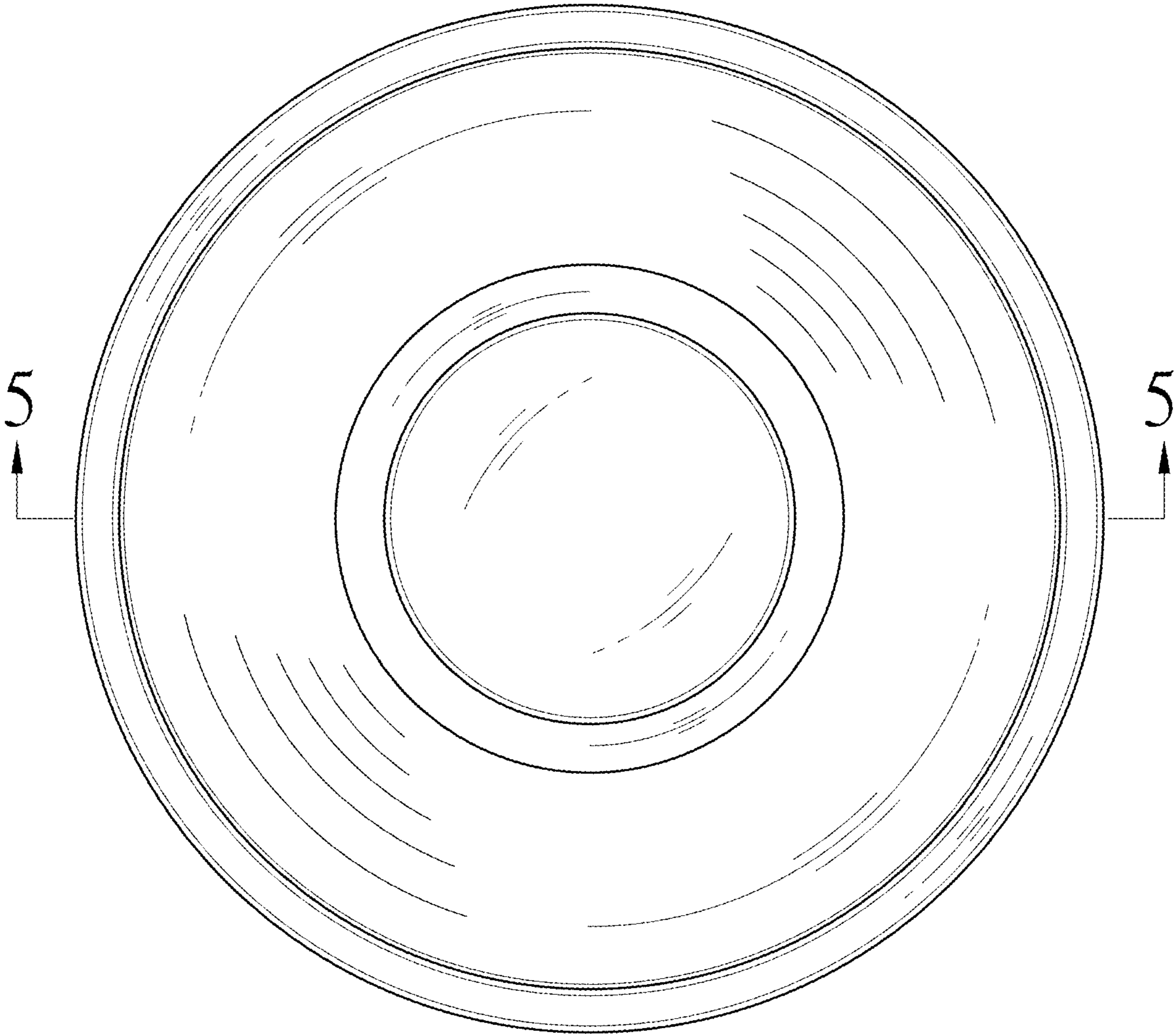

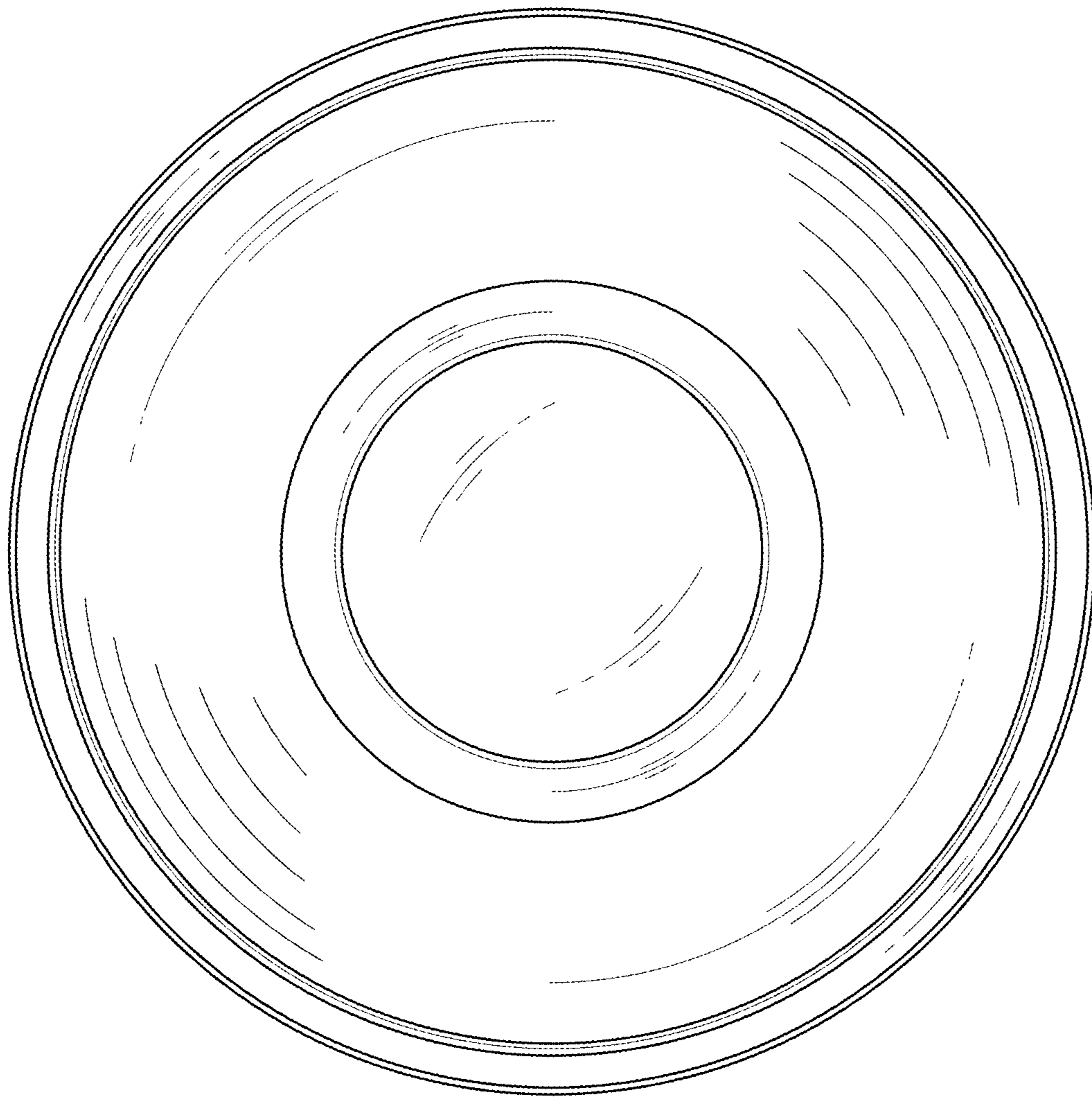

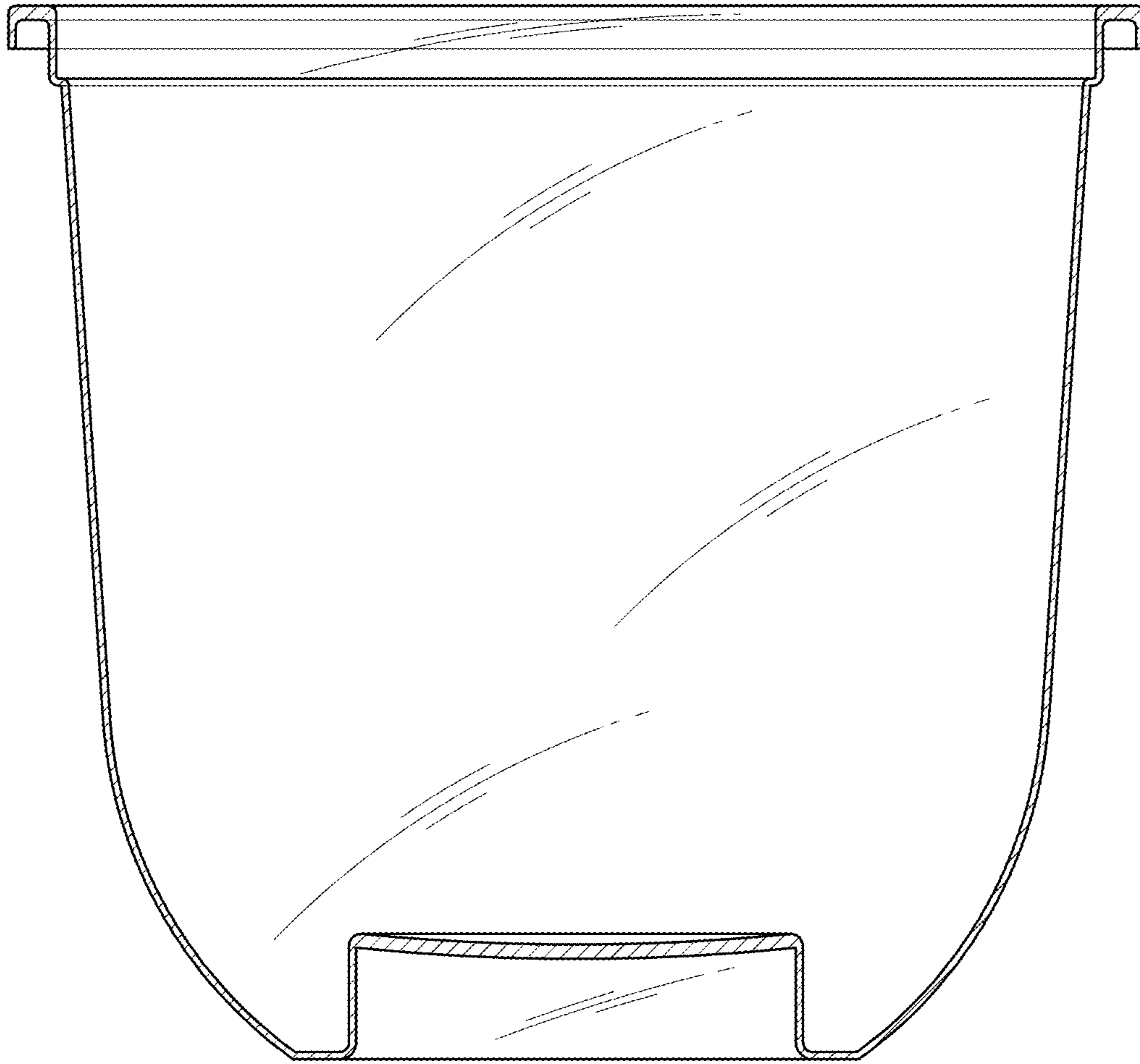

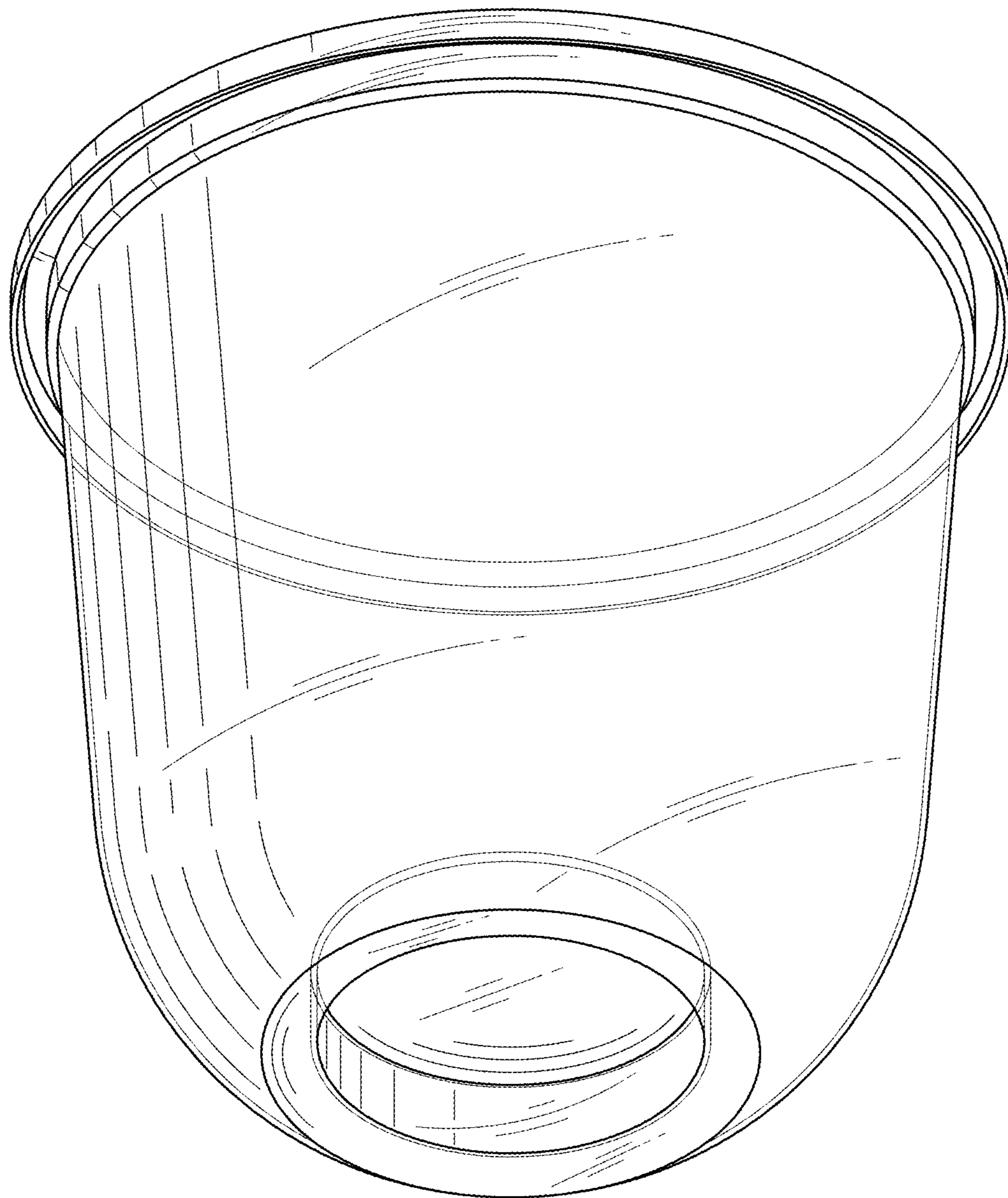
