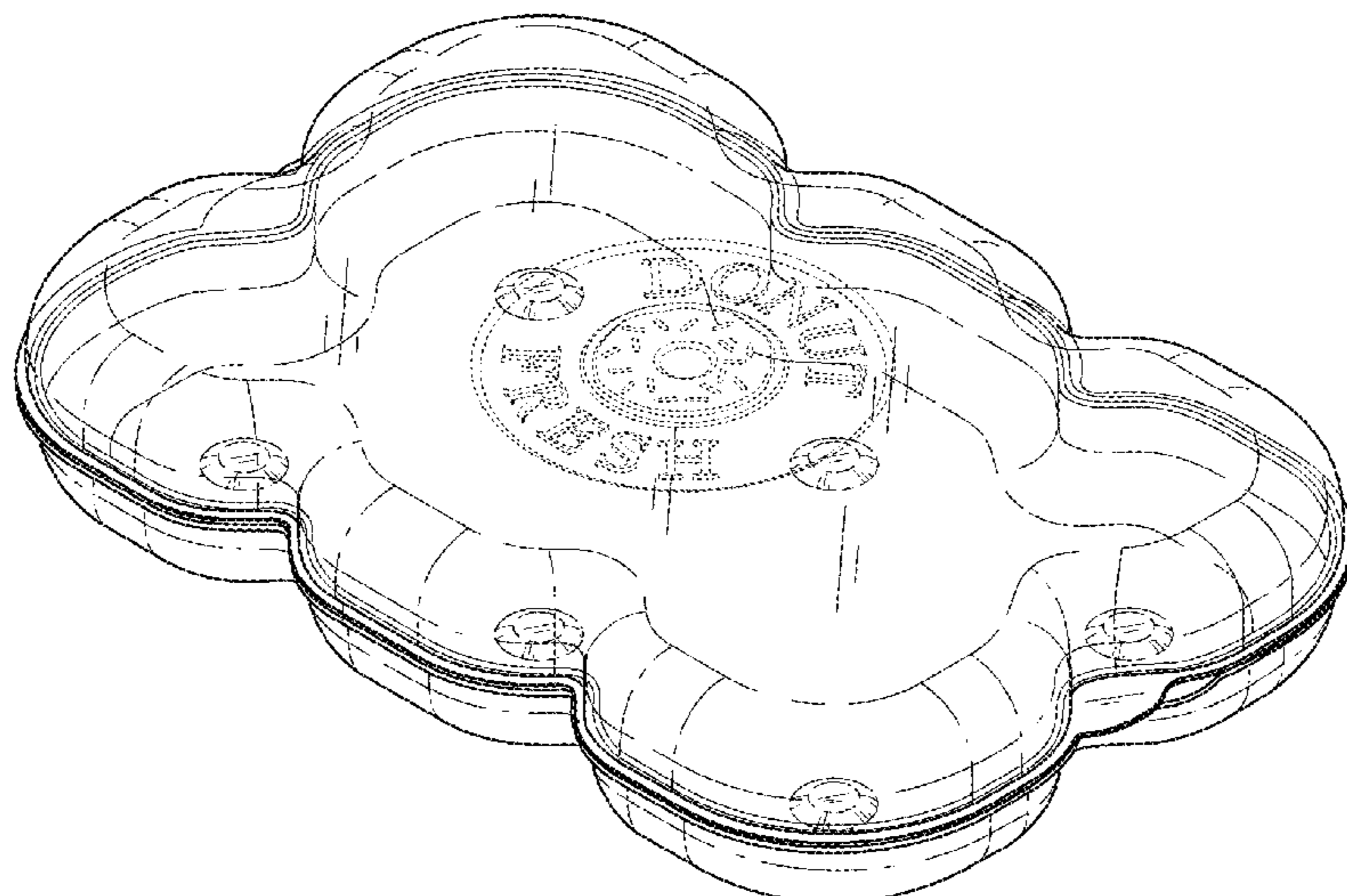

The ornamental design for a doughnut container, as shown and described.

DESCRIPTION
FIG. 1 is a top perspective view of a doughnut container showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a rear elevational view thereof; and,
FIG. 8 is a bottom perspective view thereof.
The broken lines showing a logo on the top of the container illustrate portions of the doughnut container that form no part of the claimed design.

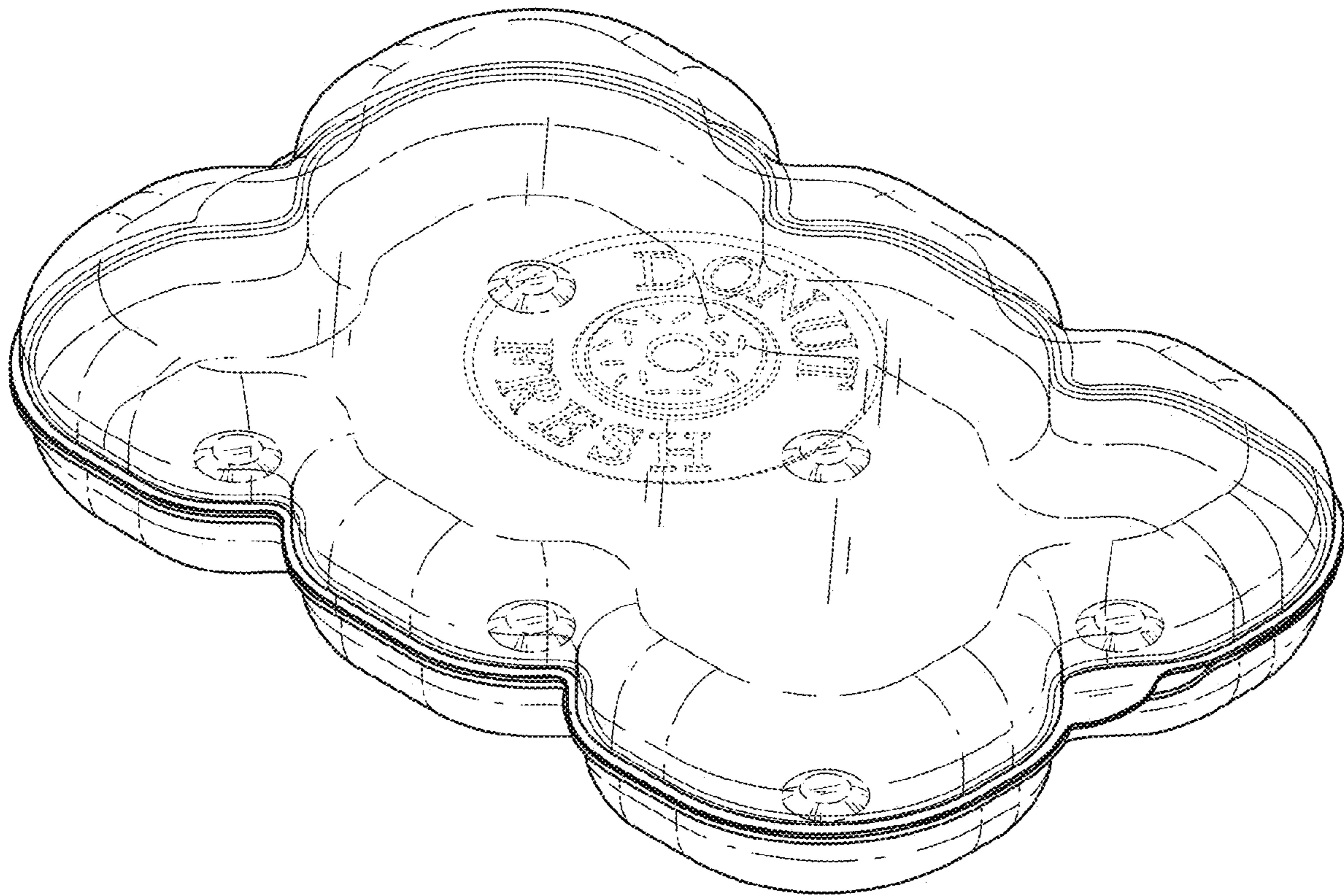

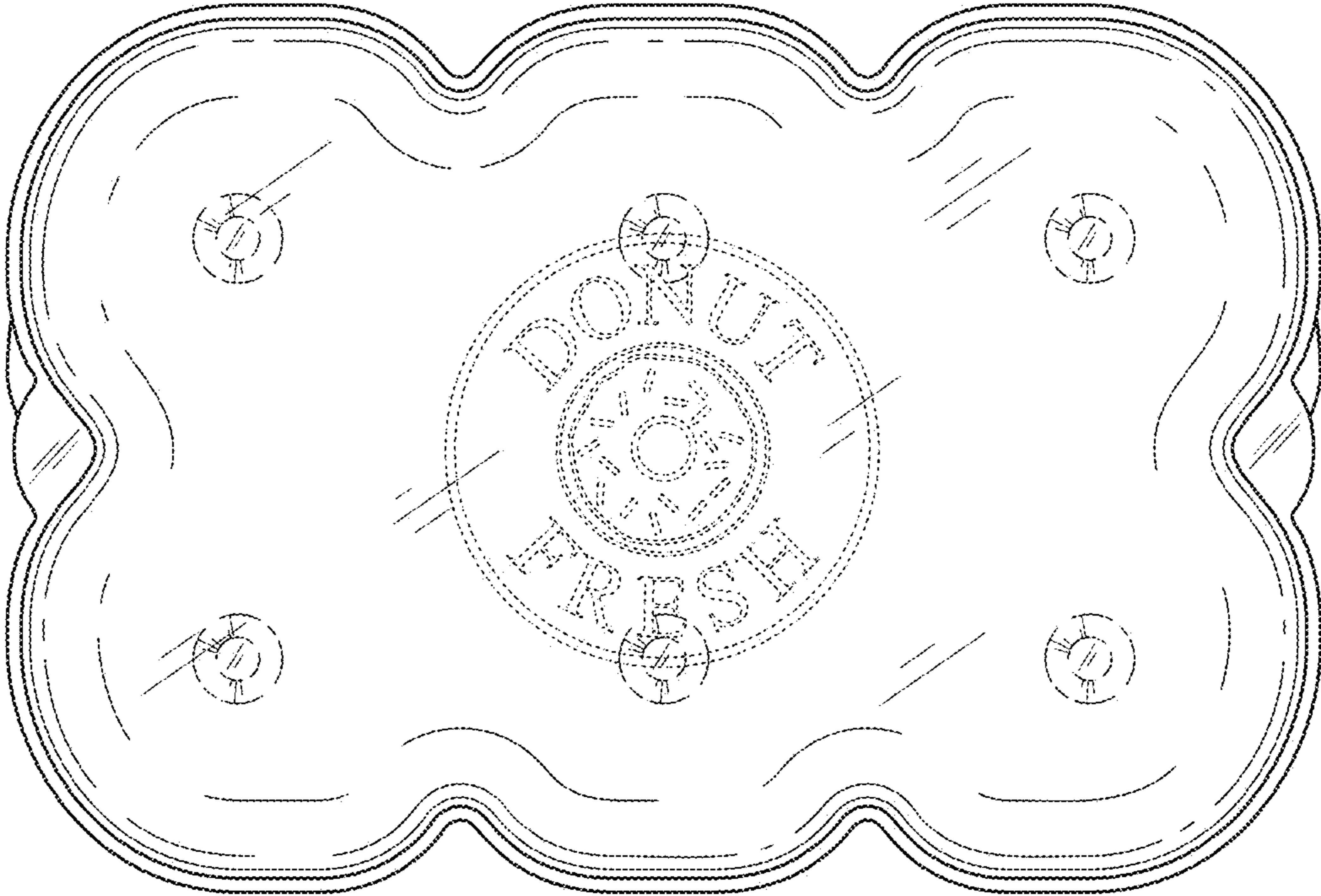

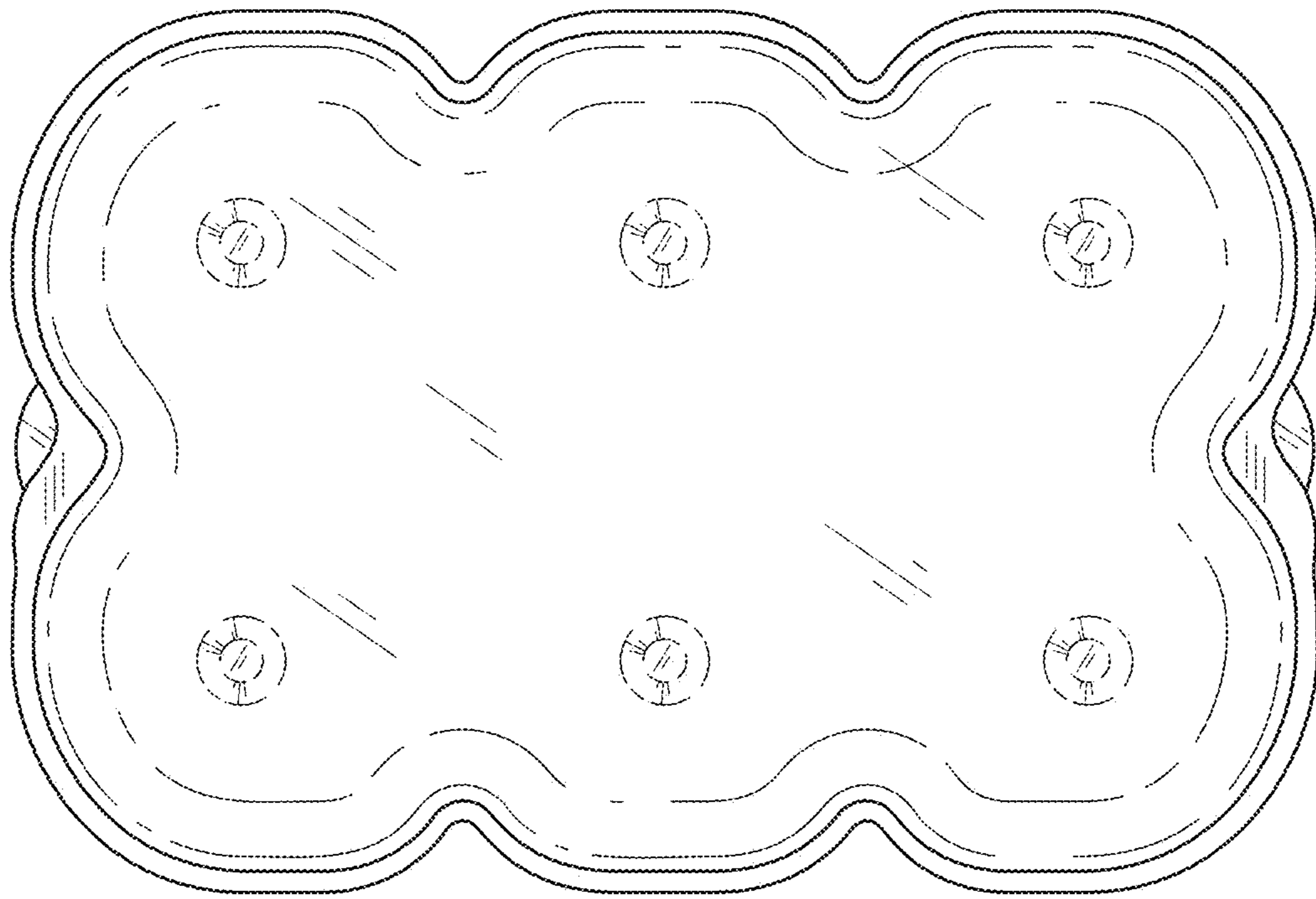

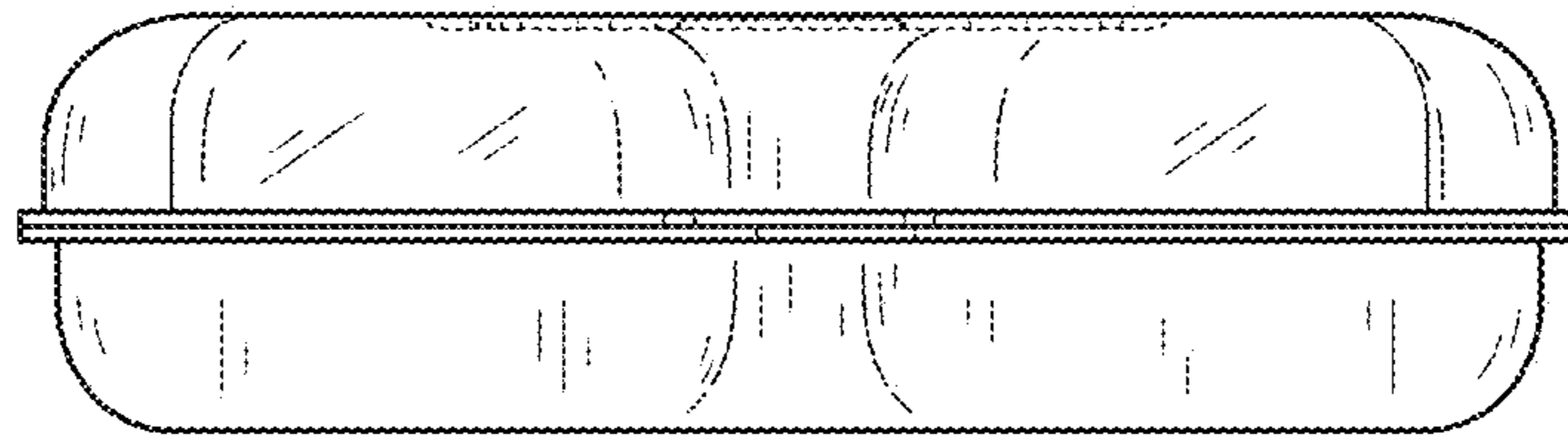

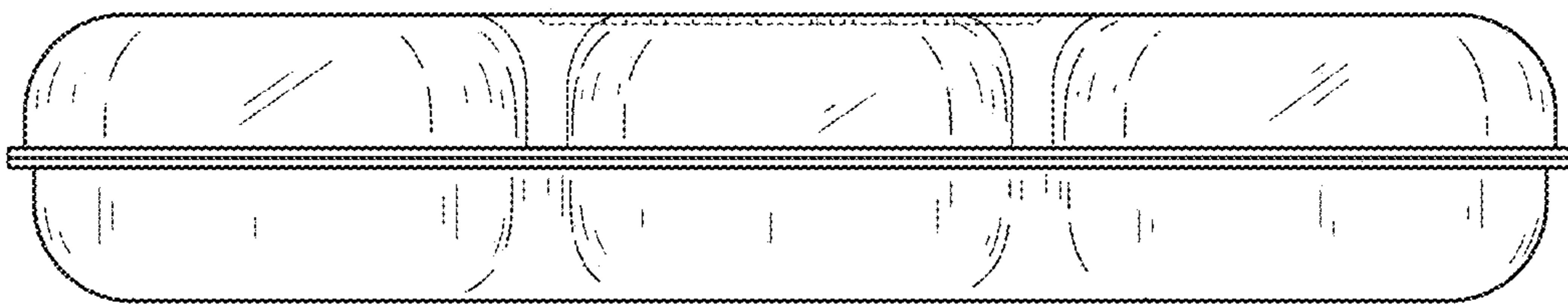

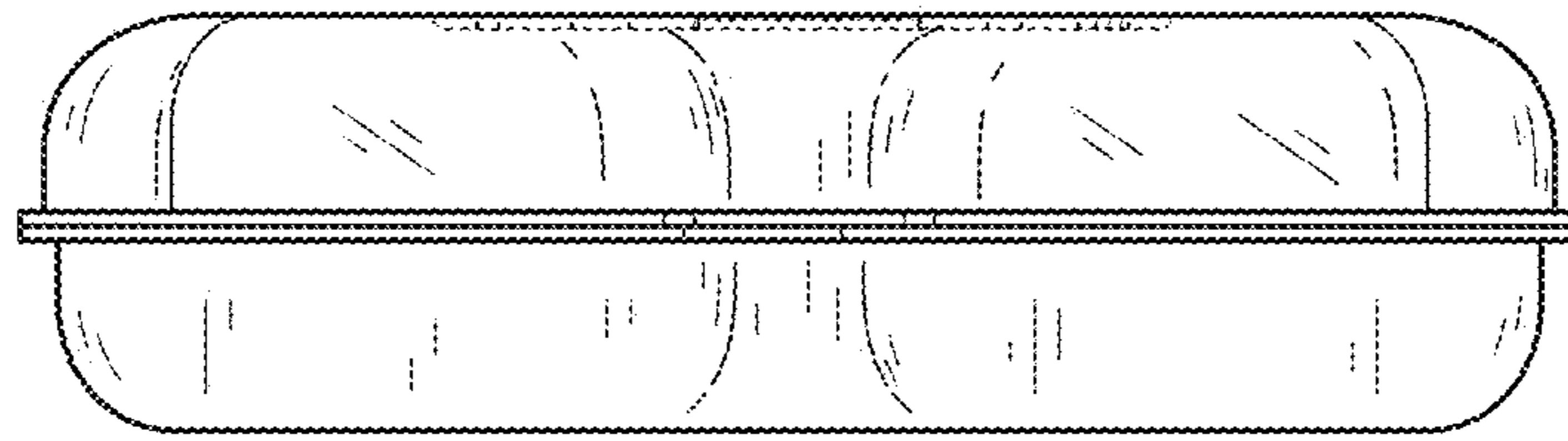

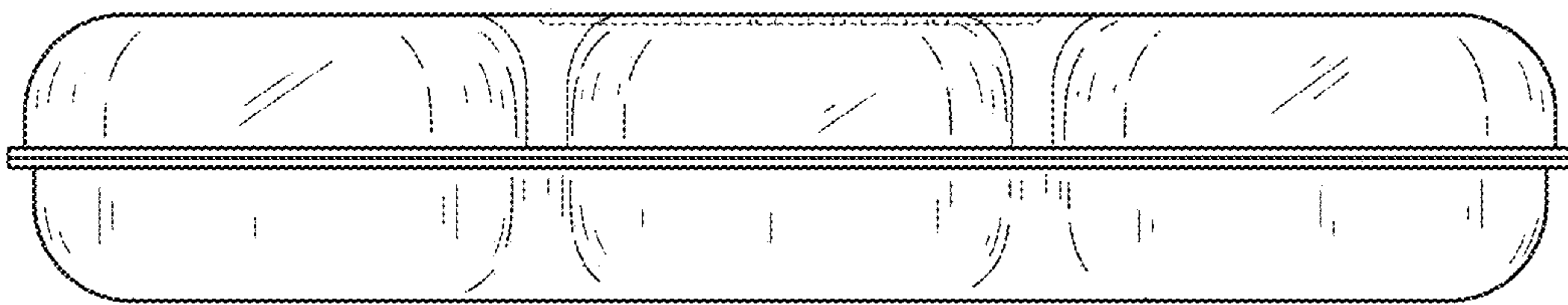

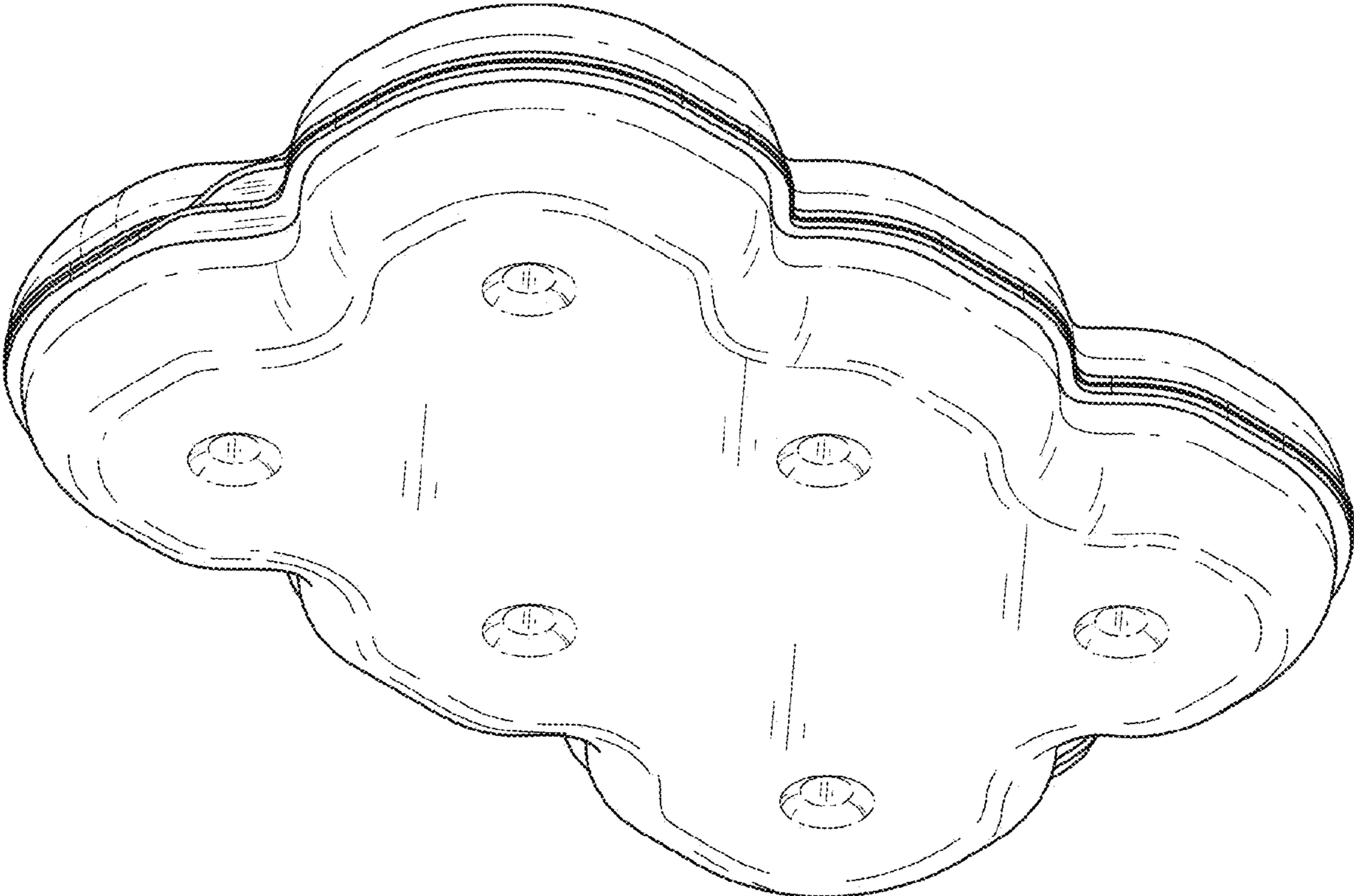
