The ornamental design for a packaging container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a packaging container showing our new design;  
FIG. 2 is a front view thereof, the rear view being mirror image thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side view thereof; and,  
FIG. 6 is a left side view thereof.

The broken lines illustrate portions of the packaging container and form no part of the claimed design.

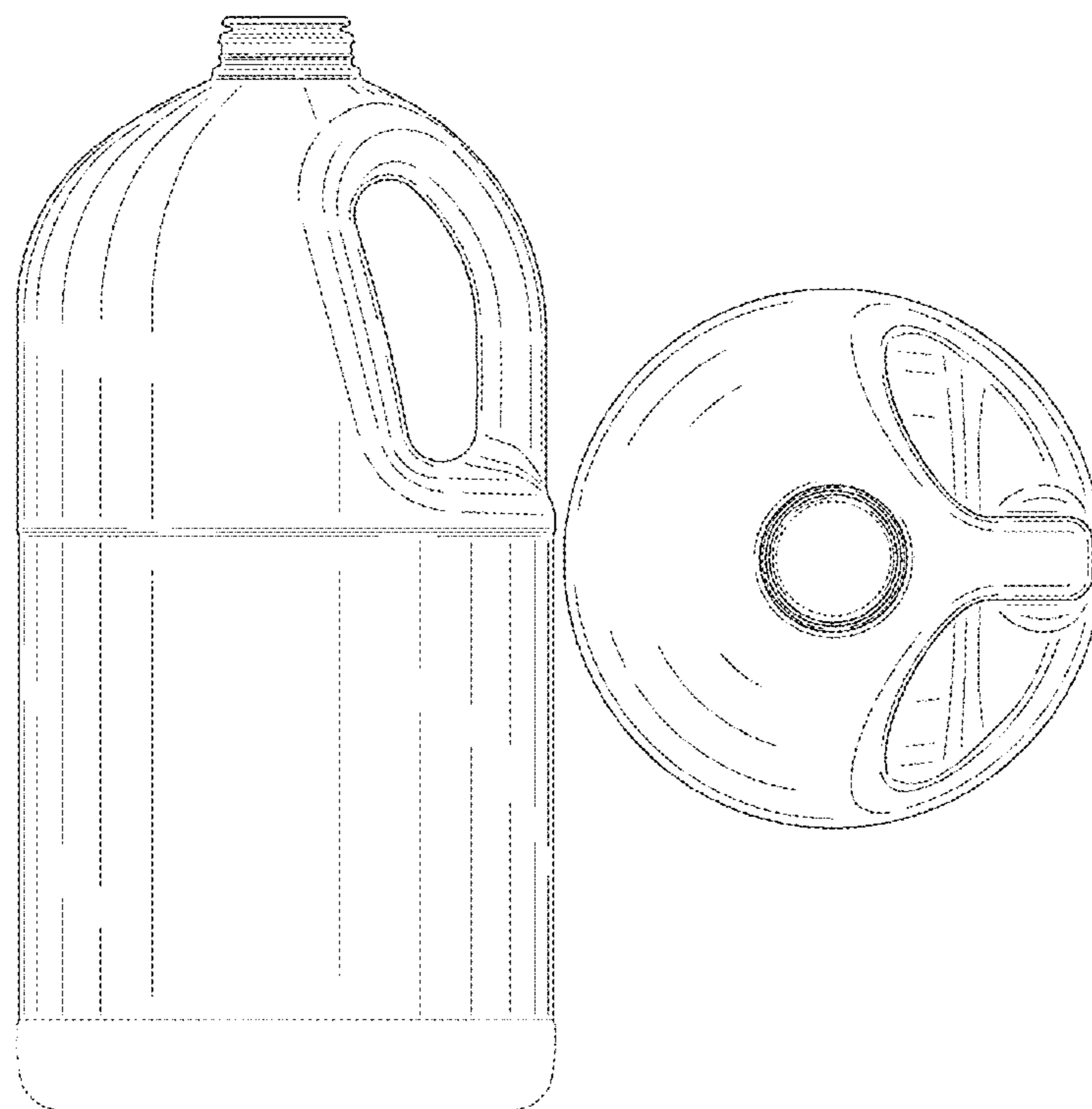

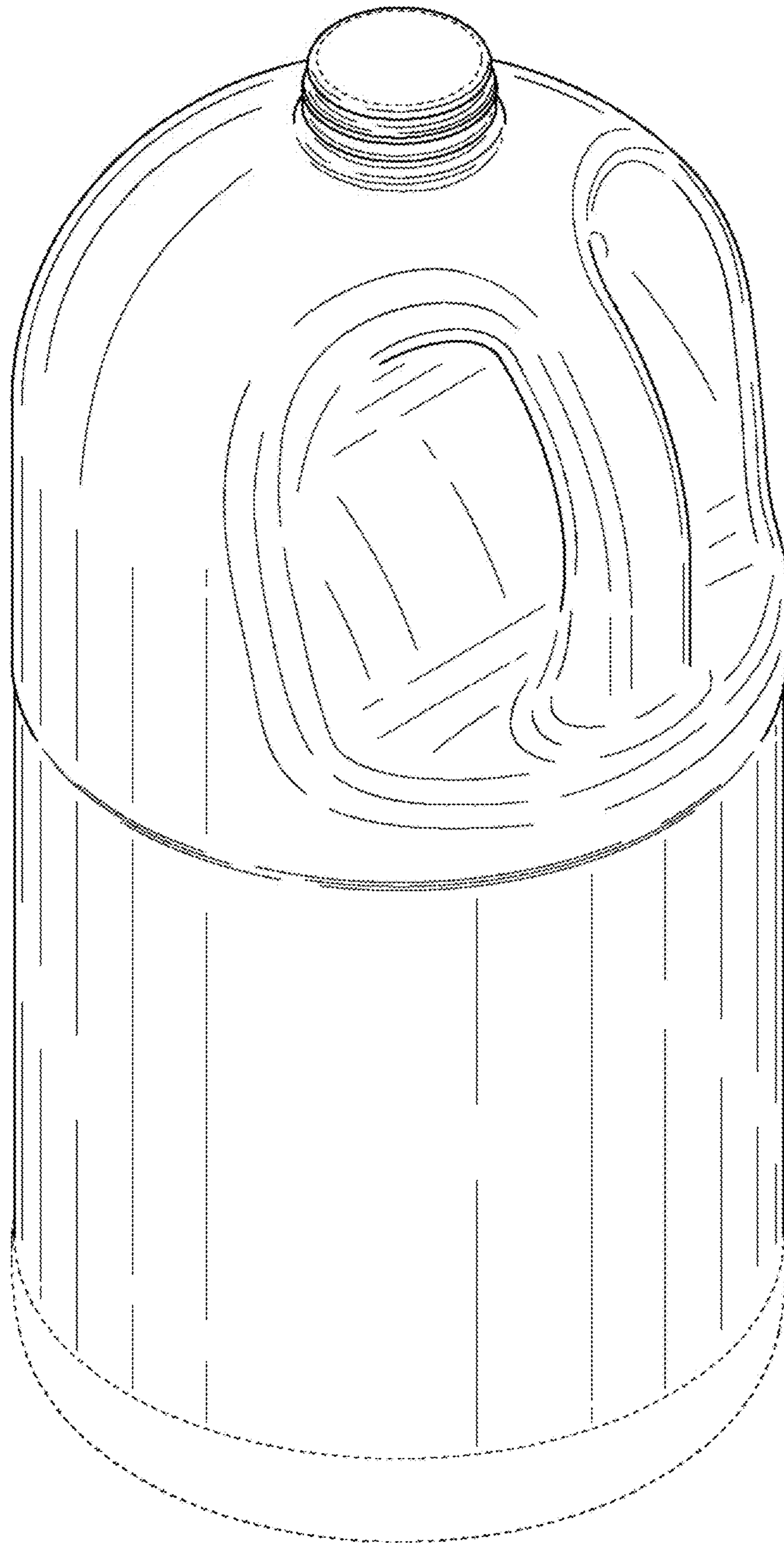

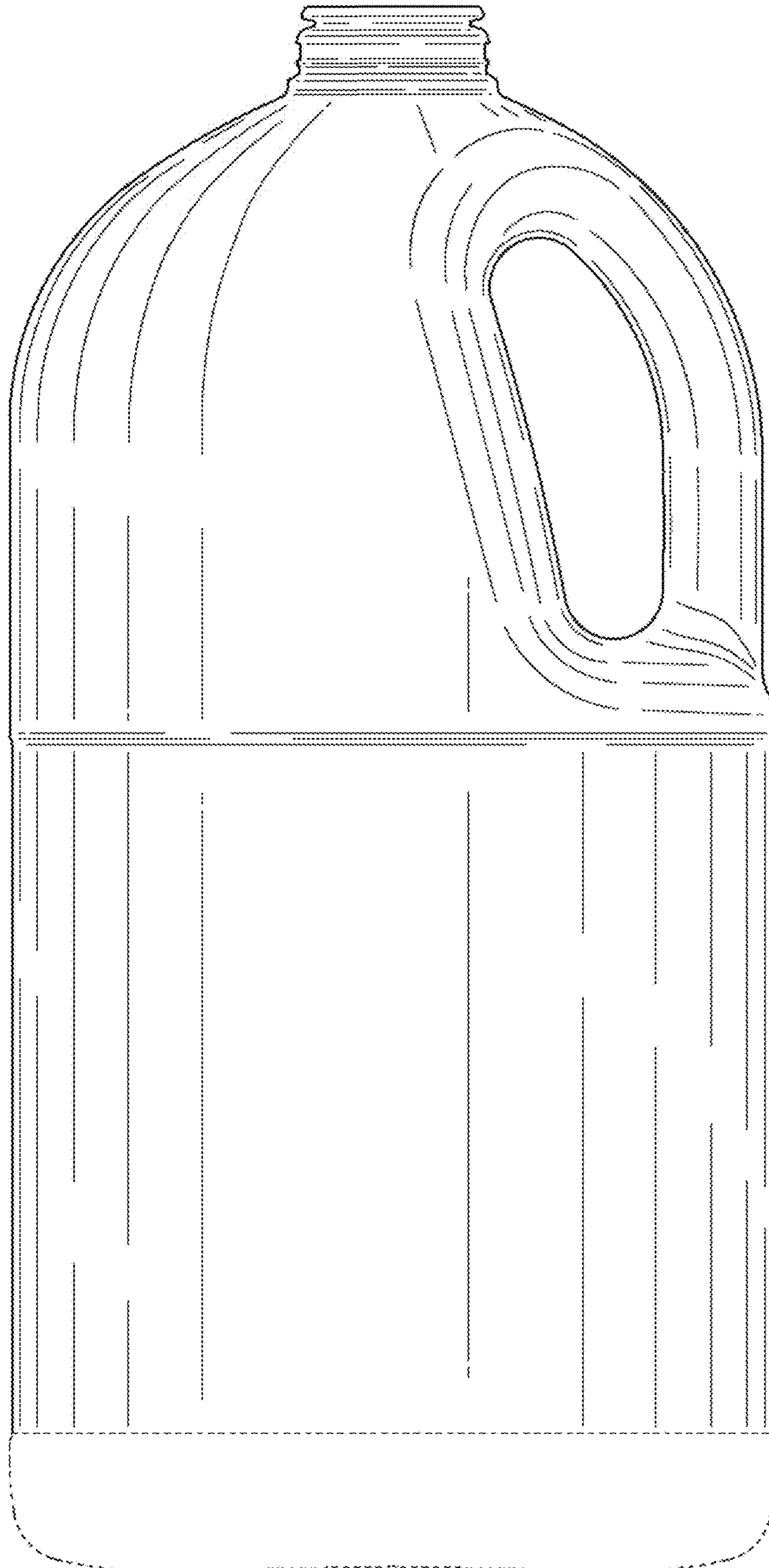

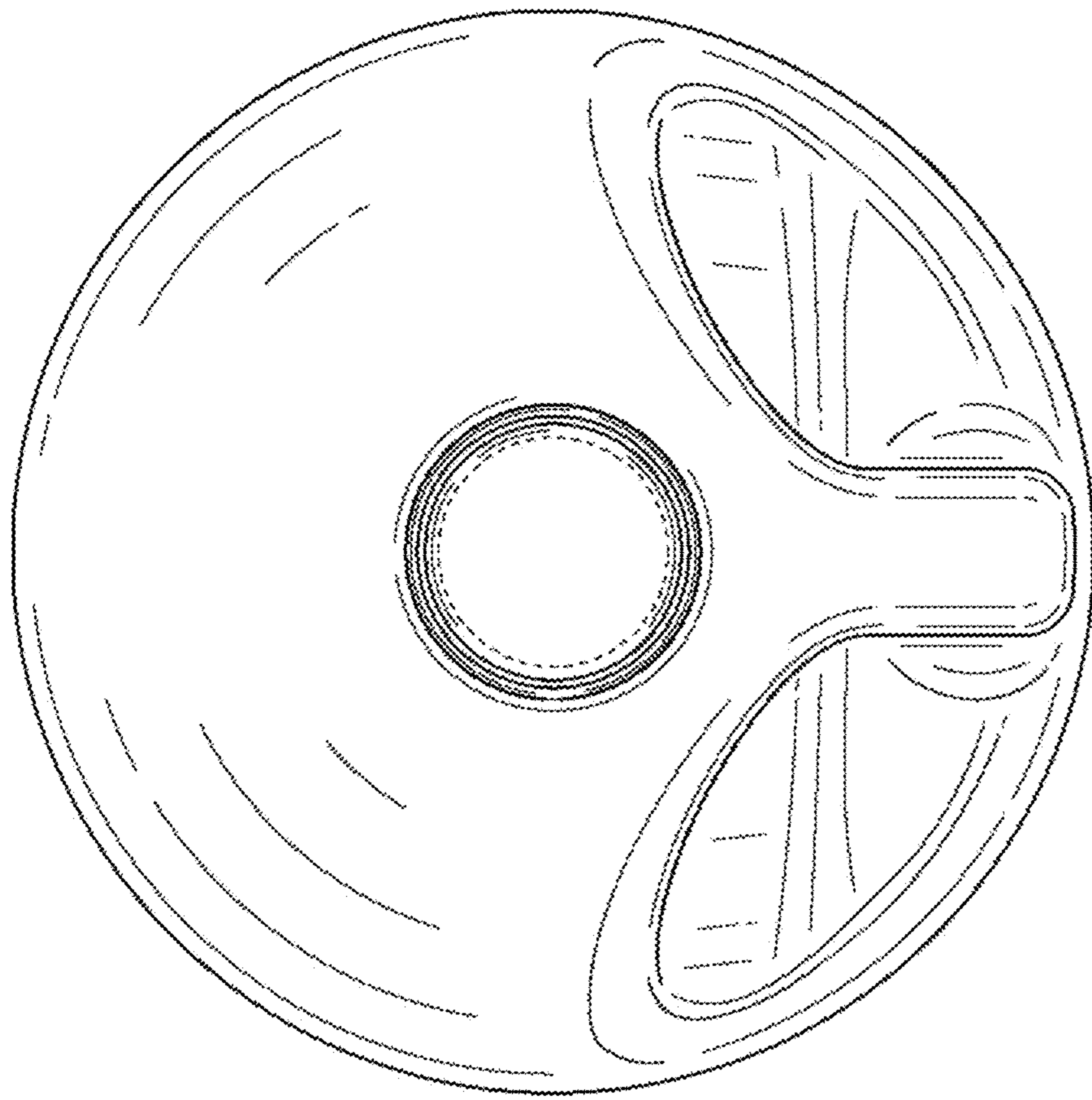

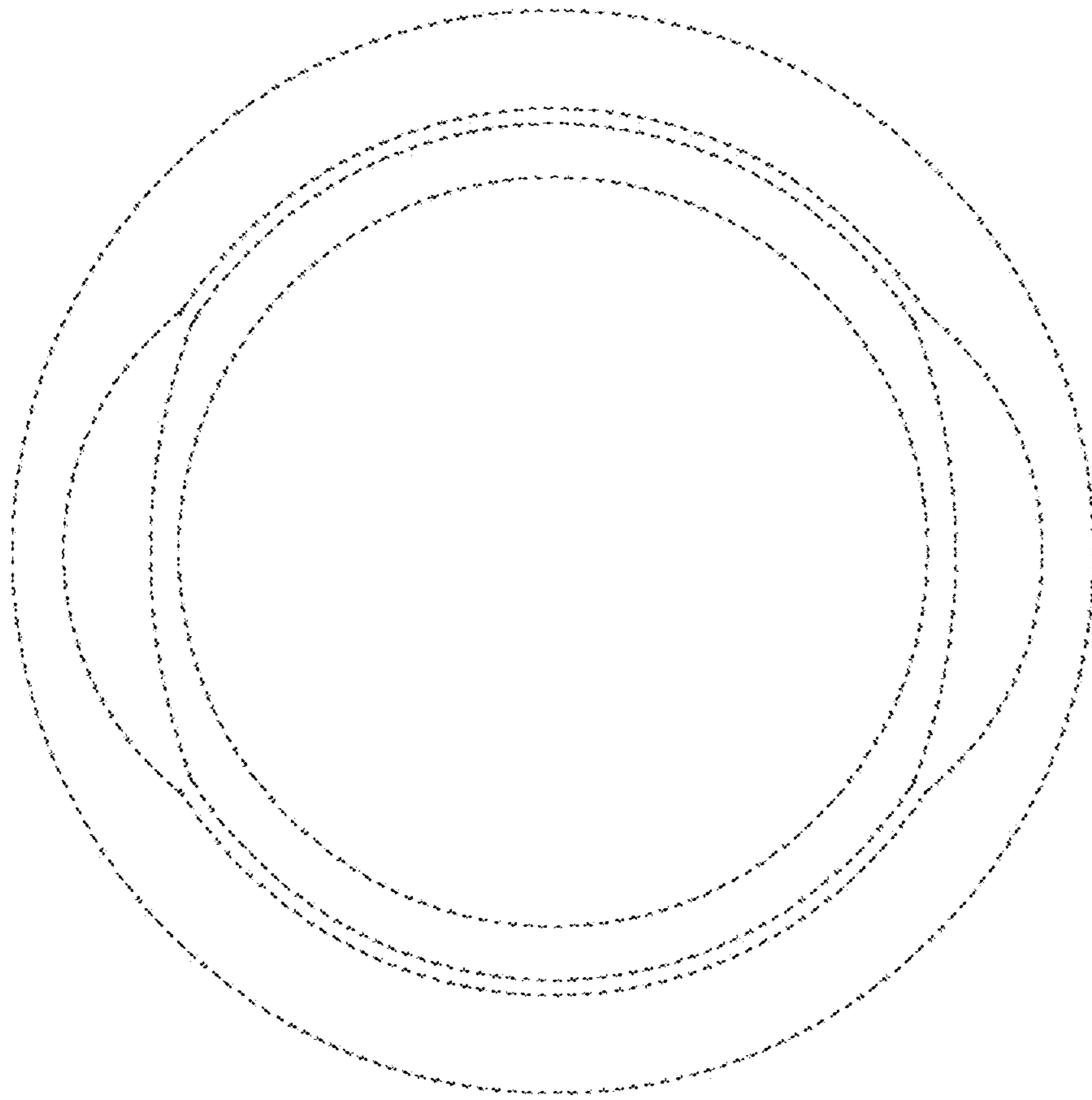

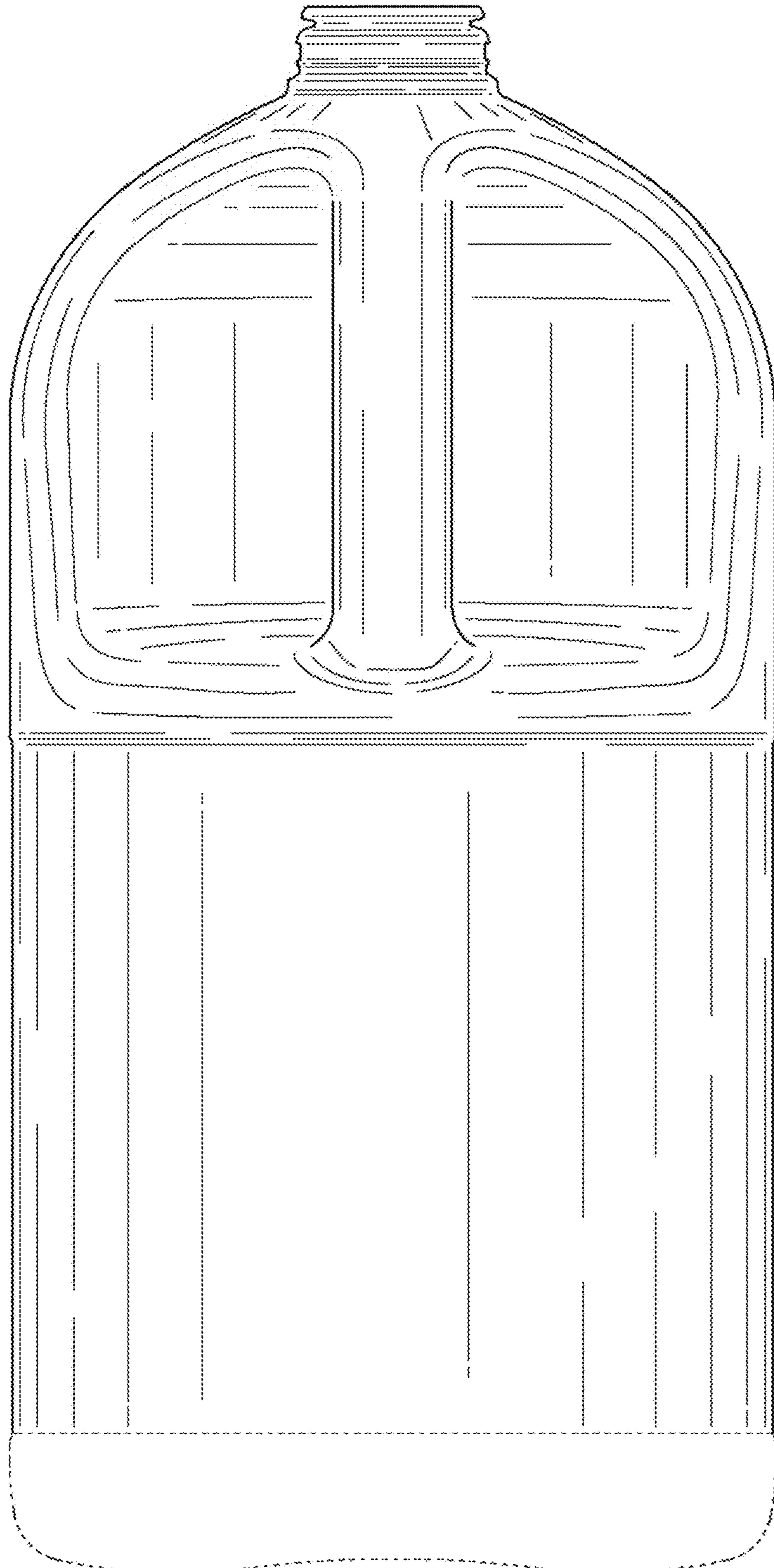
