(57) **CLAIM**

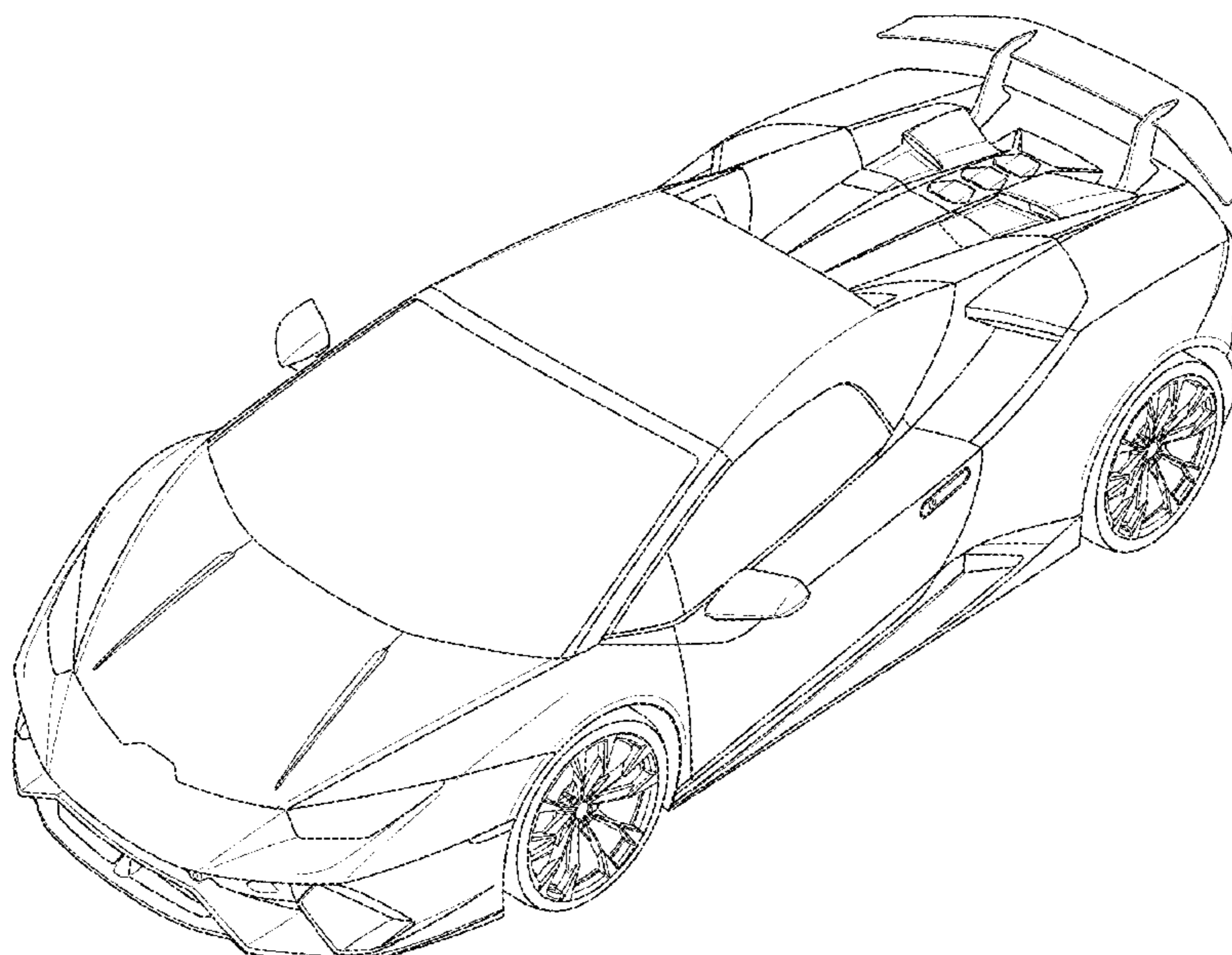
The ornamental design for a car, including toy car, motor car, replica car and scale model car, as shown and described.

DESCRIPTION

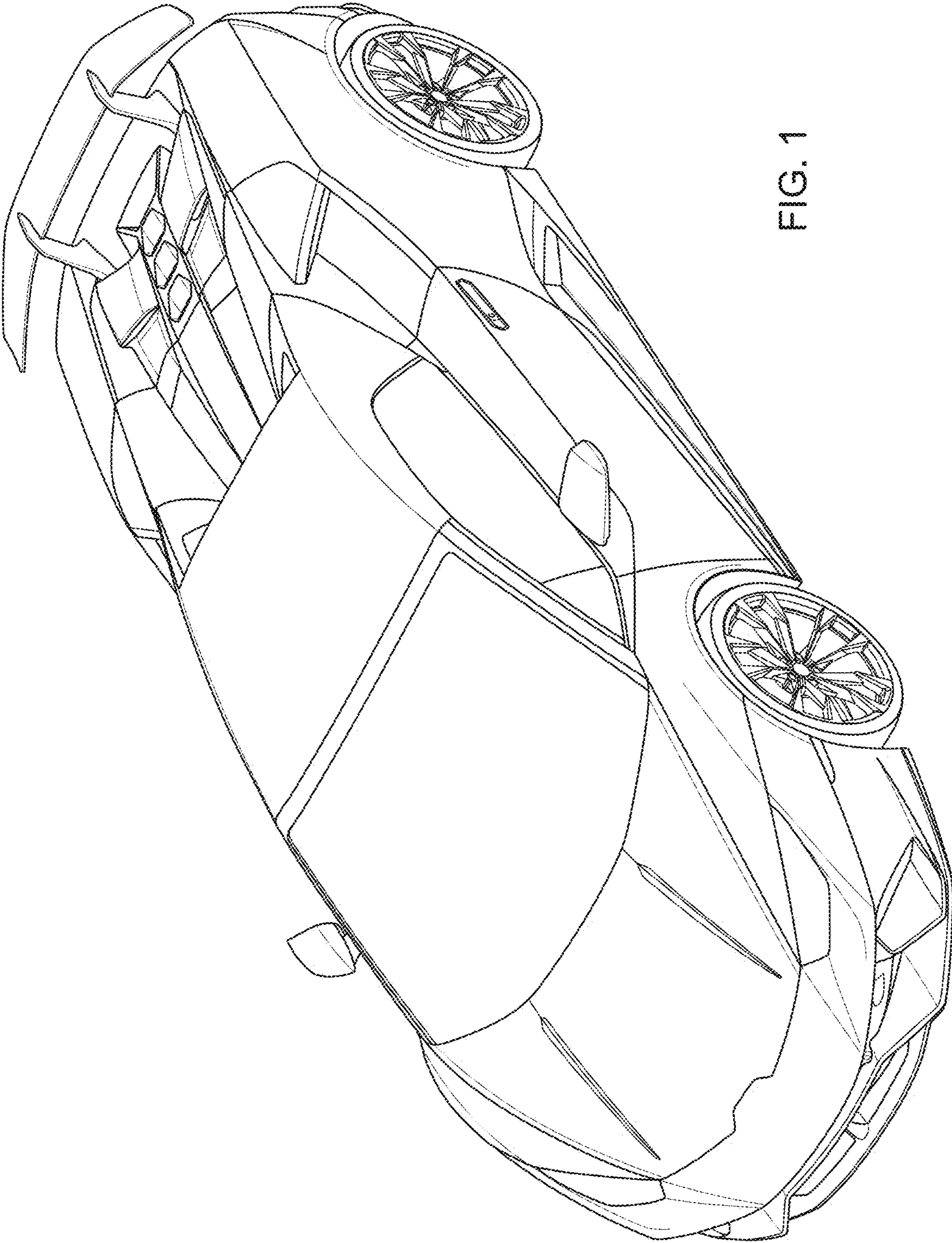

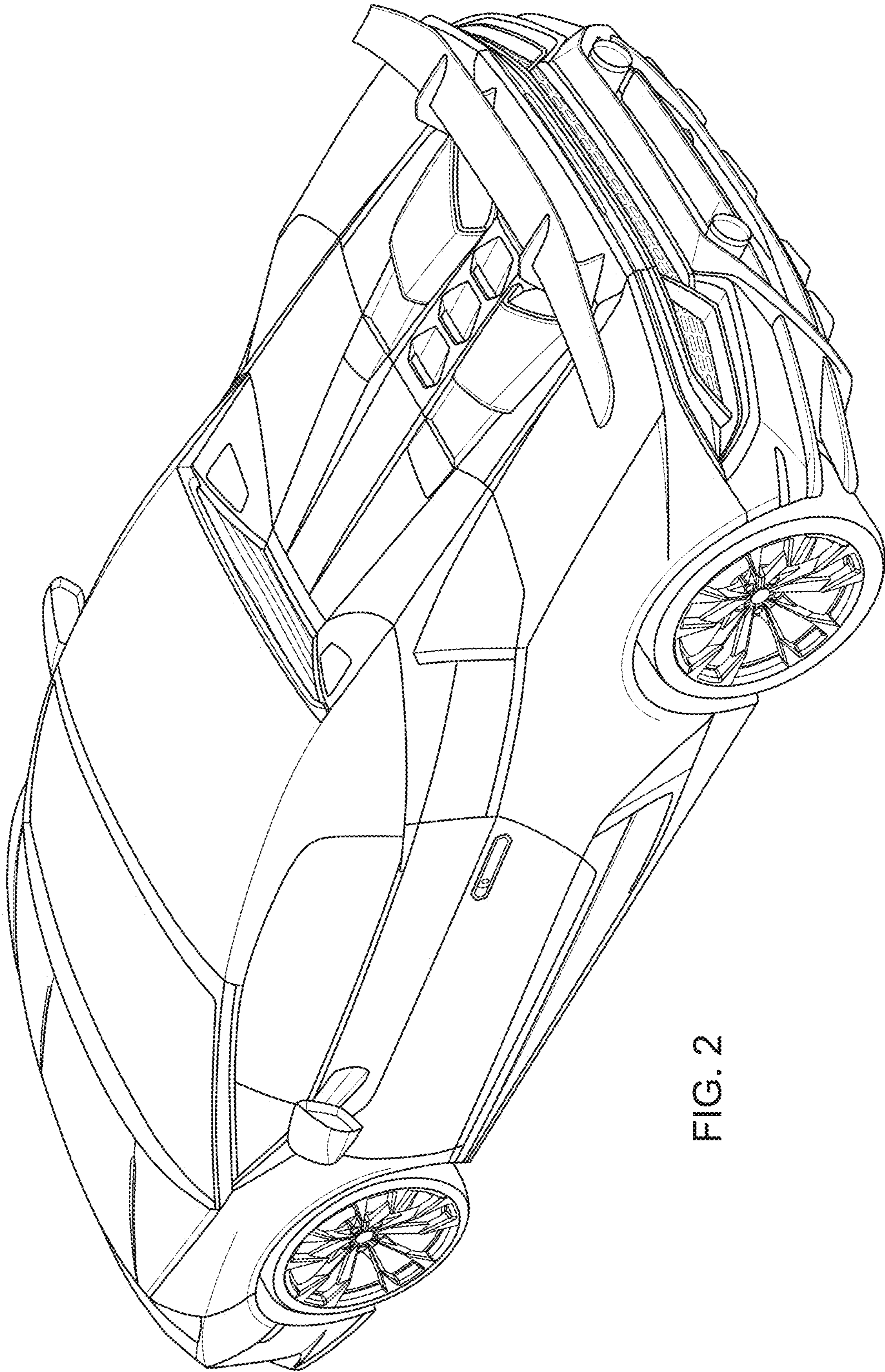

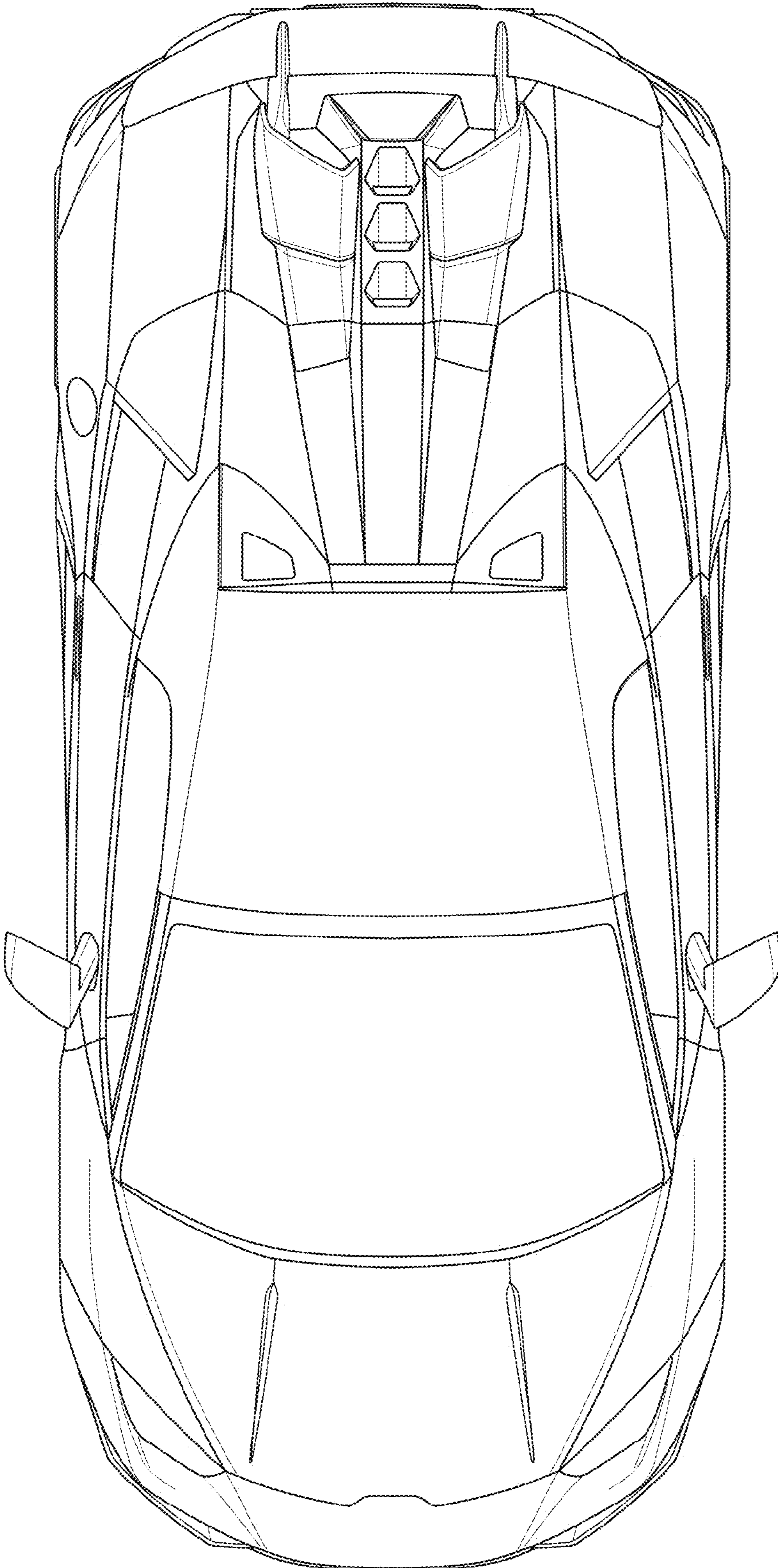

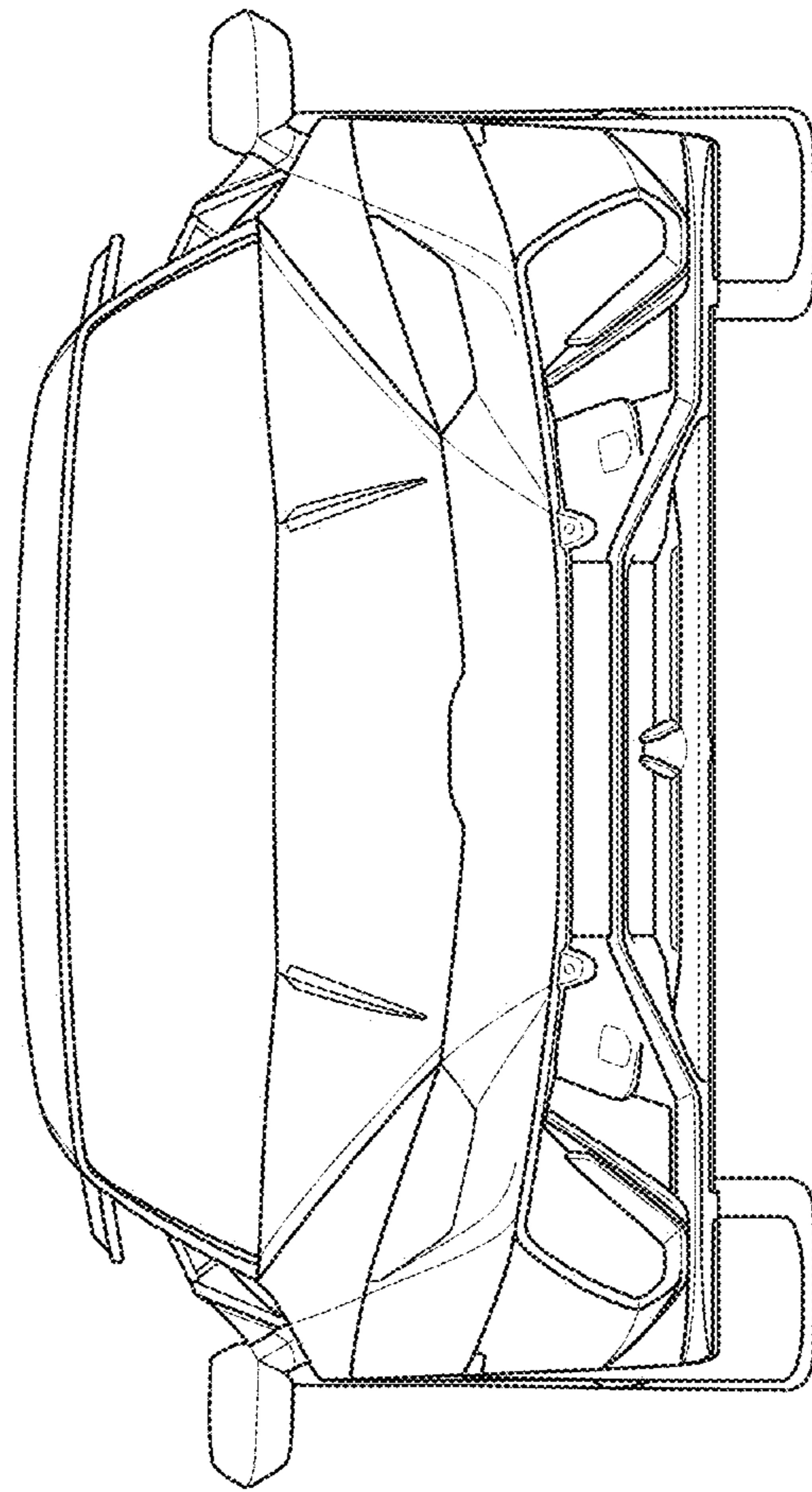

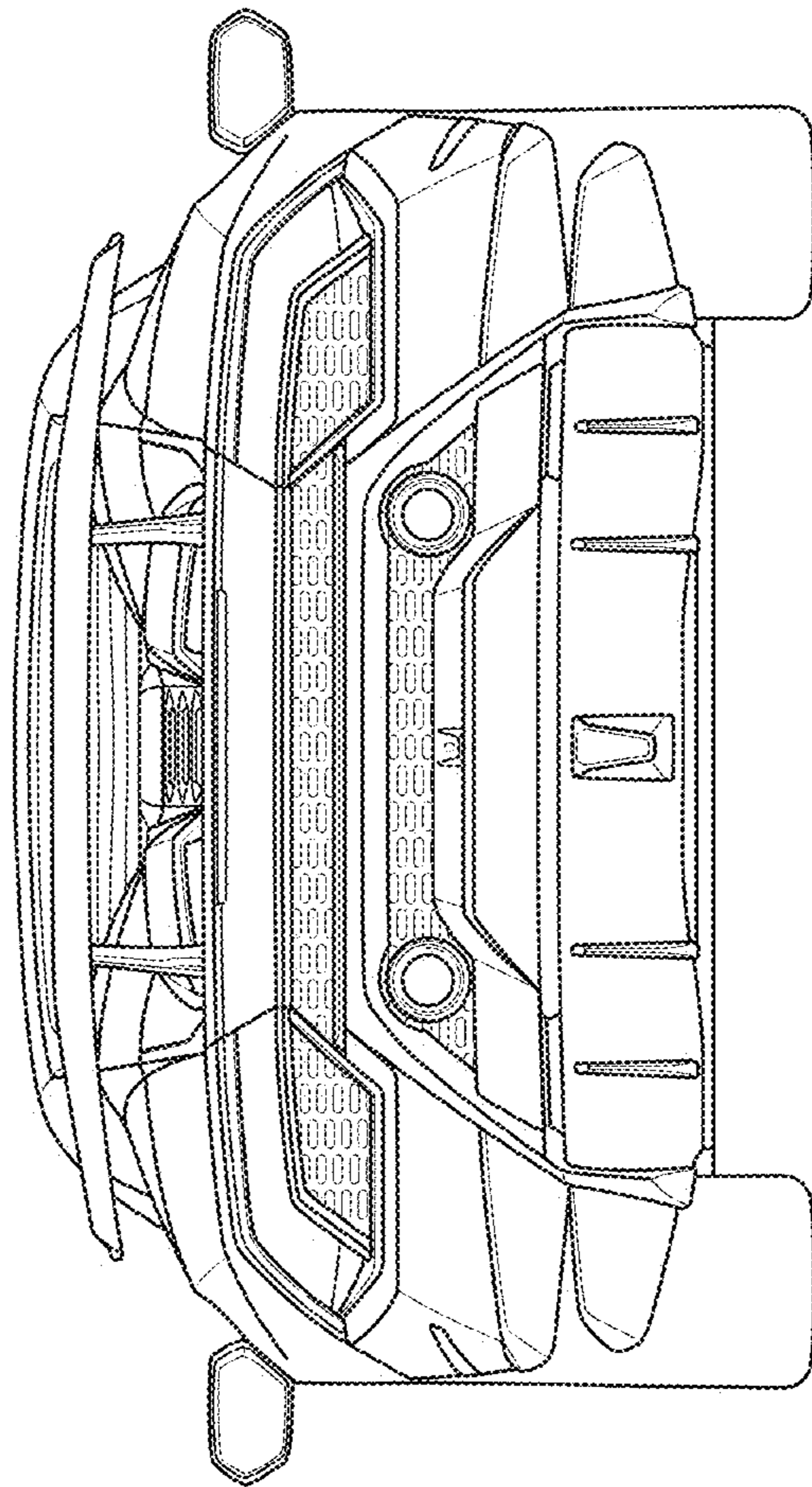

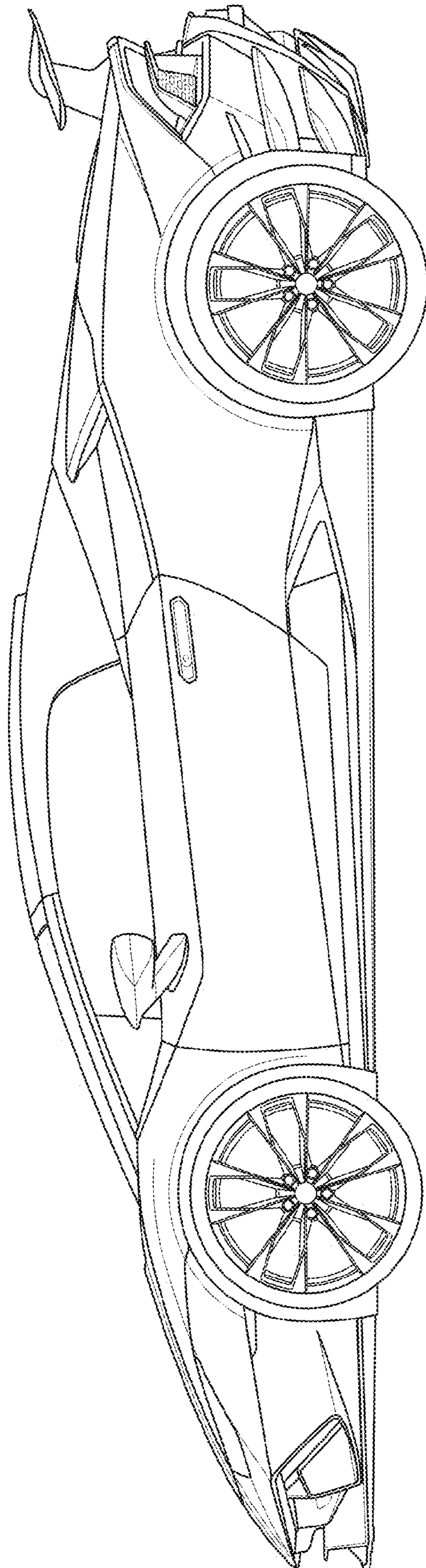

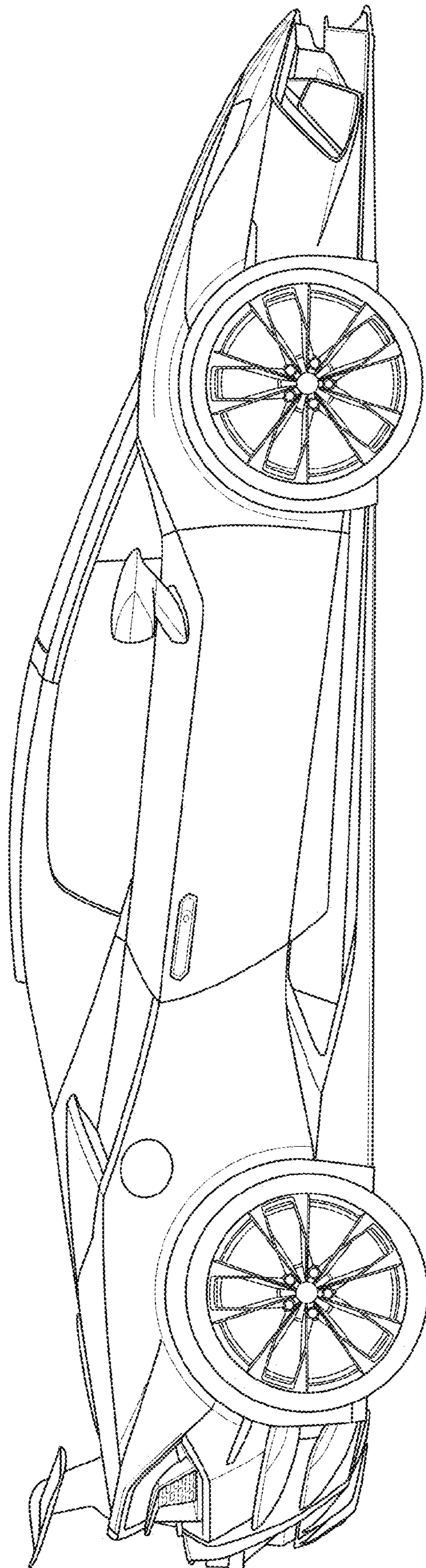

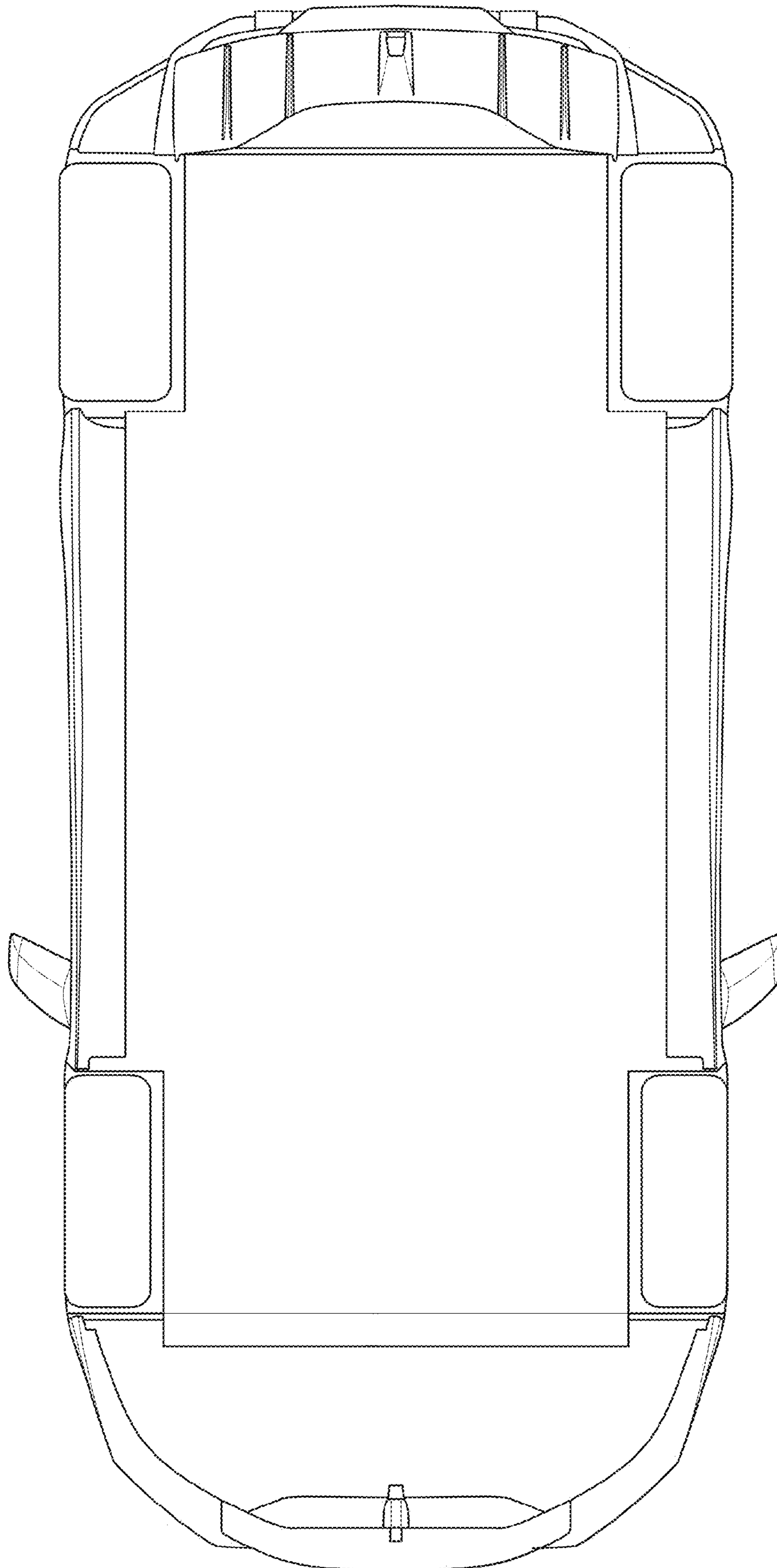

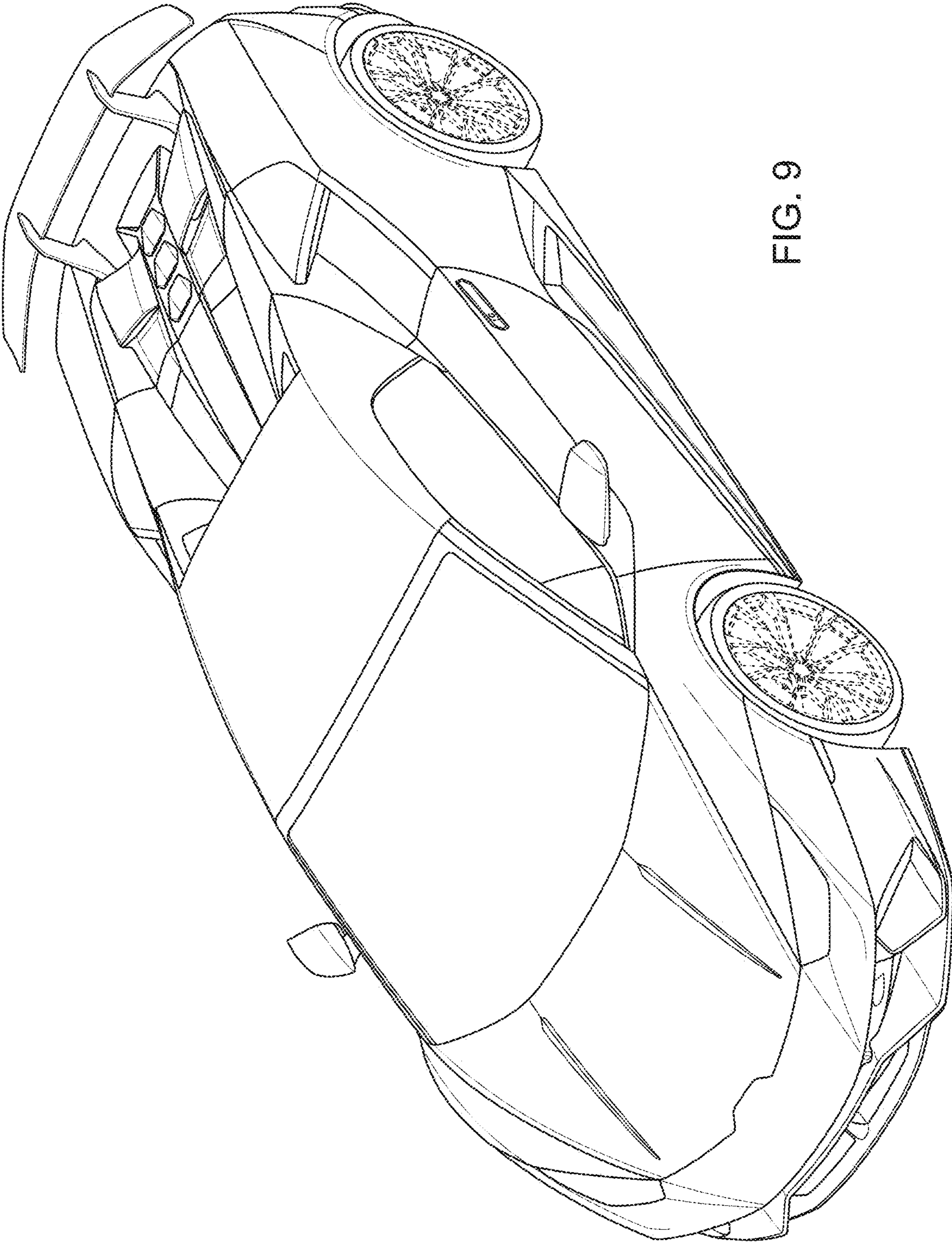

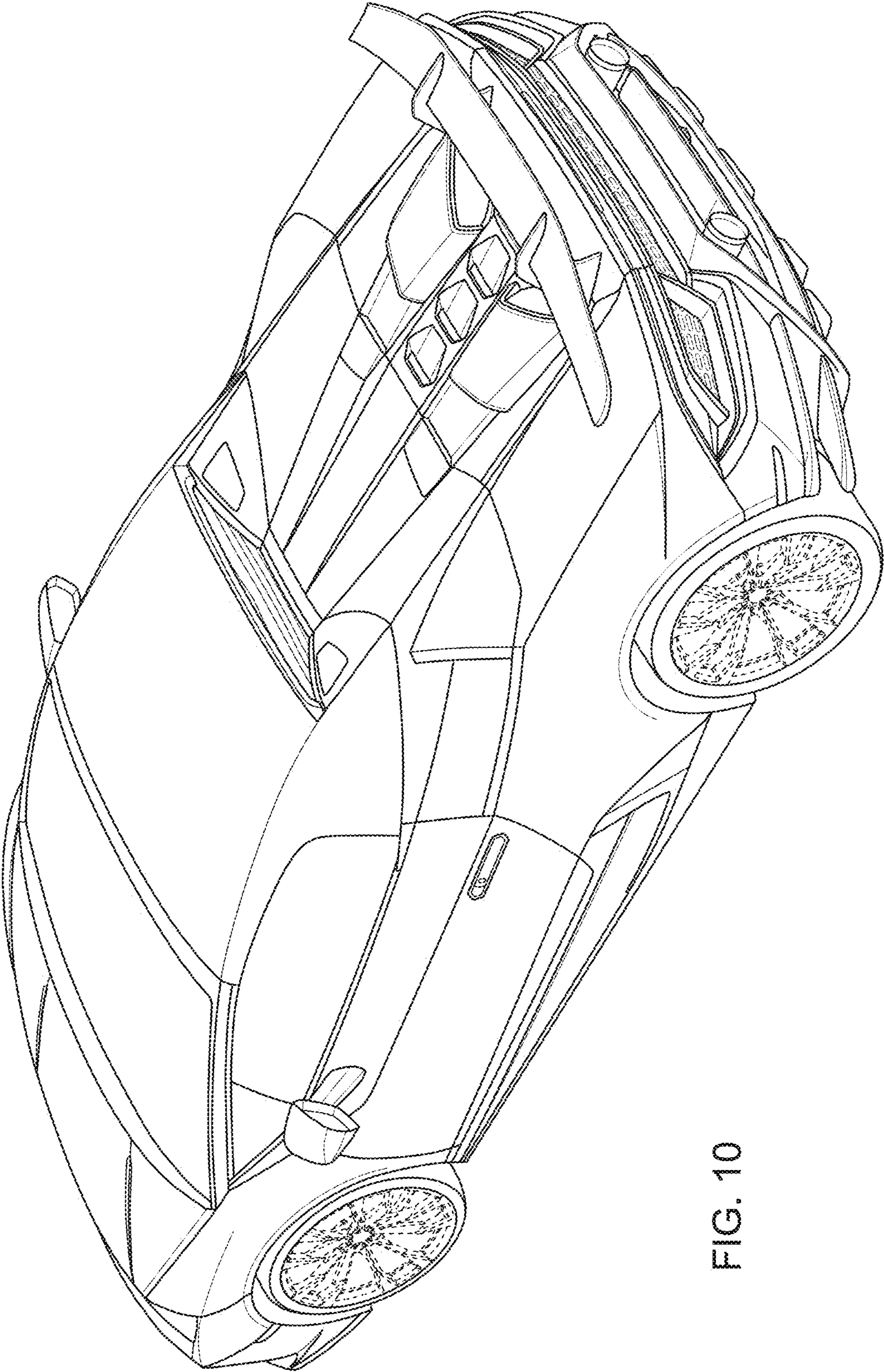

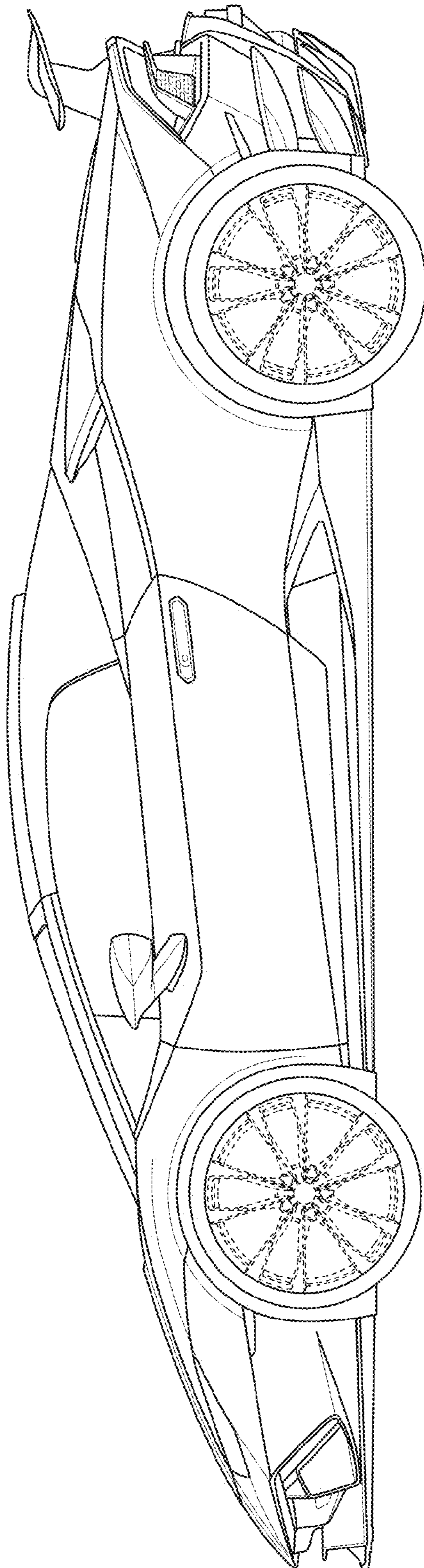

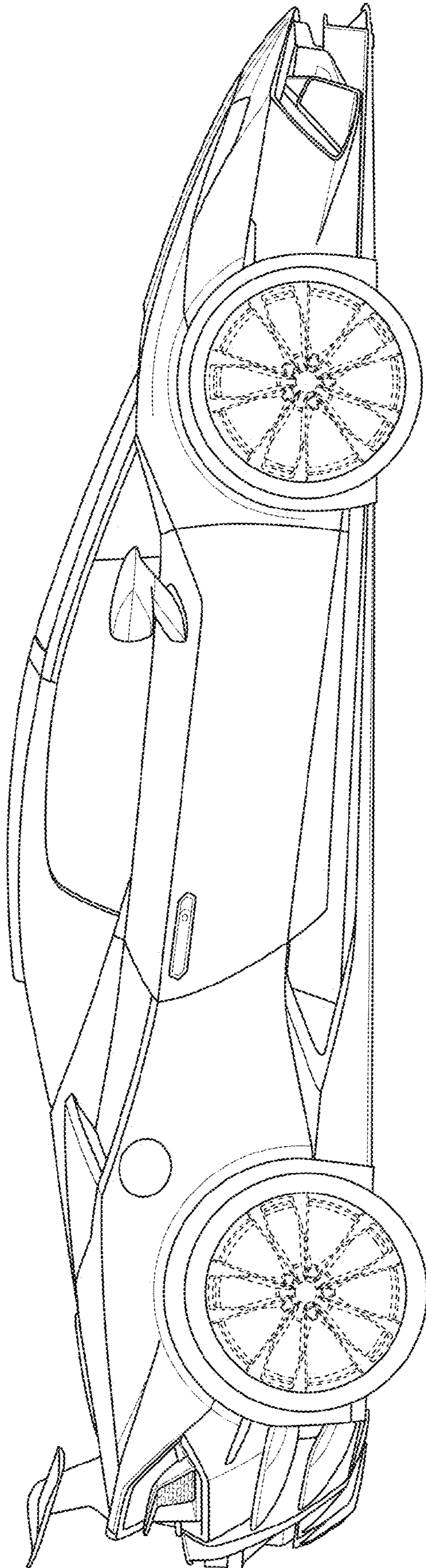
