(57) **CLAIM**

The ornamental design for a fender vent, as shown and
described.

DESCRIPTION

FIG. 1 is a front right perspective view of a fender vent for
a vehicle according to the present invention.

FIG. 2 is a front left perspective view of the fender vent
shown in FIG. 1.

FIG. 3 is a rear left perspective view thereof.

FIG. 4 is a rear right perspective view thereof.

FIG. 5 is a front view thereof.

FIG. 6 is a rear view thereof.

FIG. 7 is a left side view thereof.

FIG. 8 is a right side view thereof.

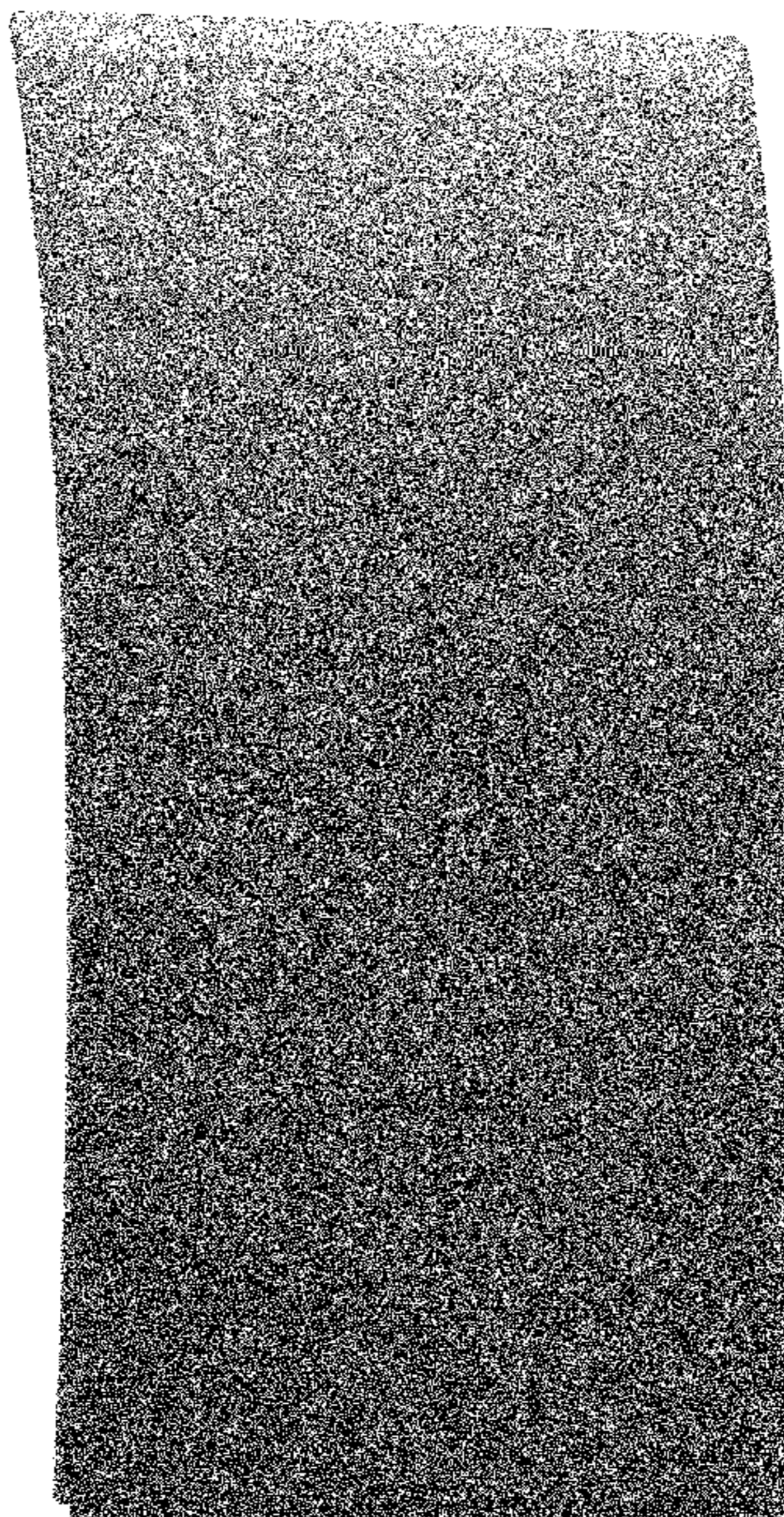
FIG. 9 is a top view thereof.

FIG. 10 is a bottom view thereof; and,

FIG. 11 is a front view of the fender vent shown in FIGS.
1-10, but mounted on a vehicle, with the rest of the vehicle
shown in de-emphasized and half-tone portions so as to
illustrate environmental structure.

More particularly, in FIG. 11, the inventive fender vent is
shown within the broken line, and the elements shown
outside the broken line form no part of the claimed inven-
tion, but are instead included to show environmental aspects
thereof.

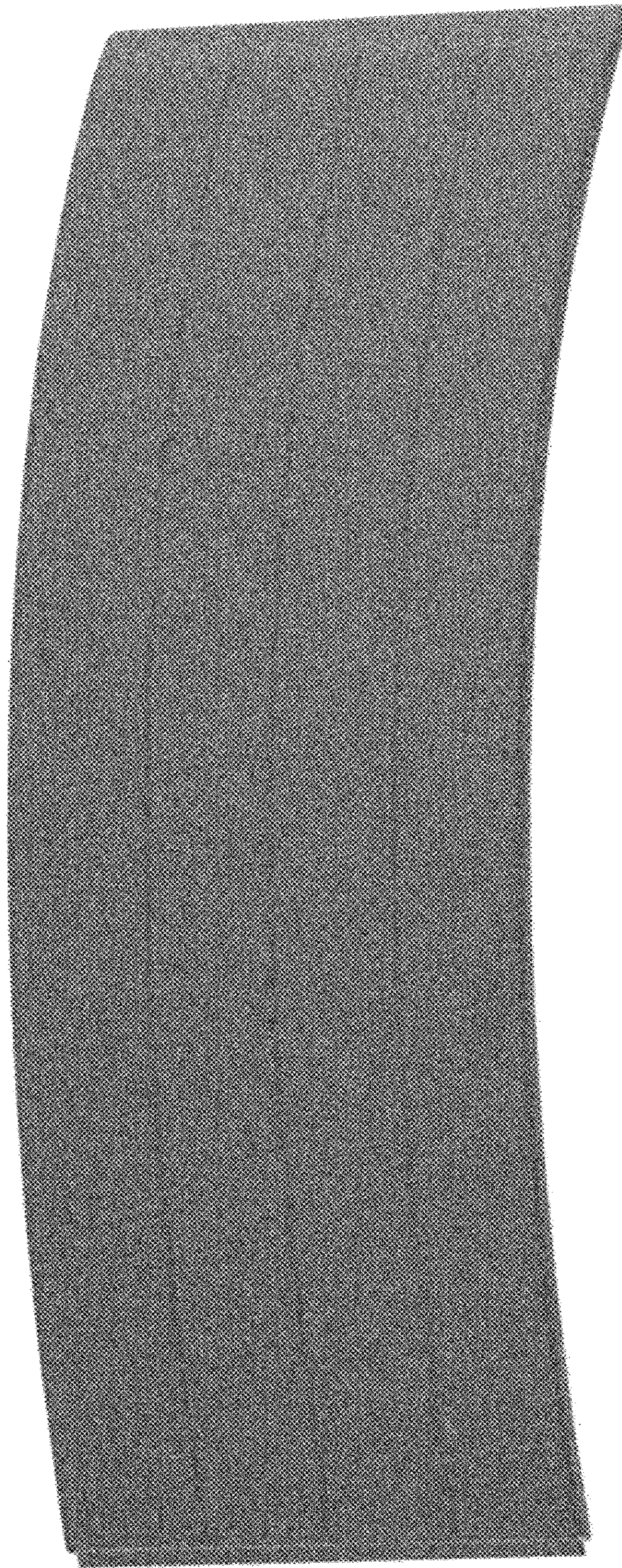

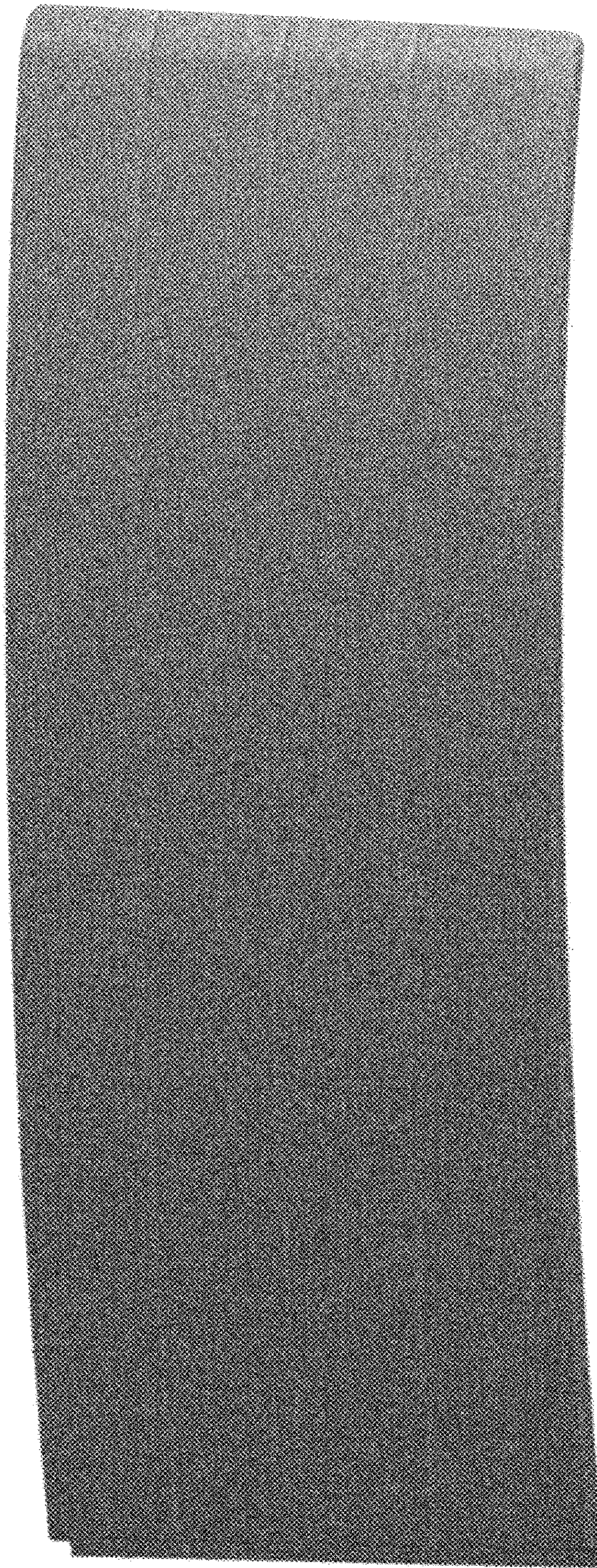

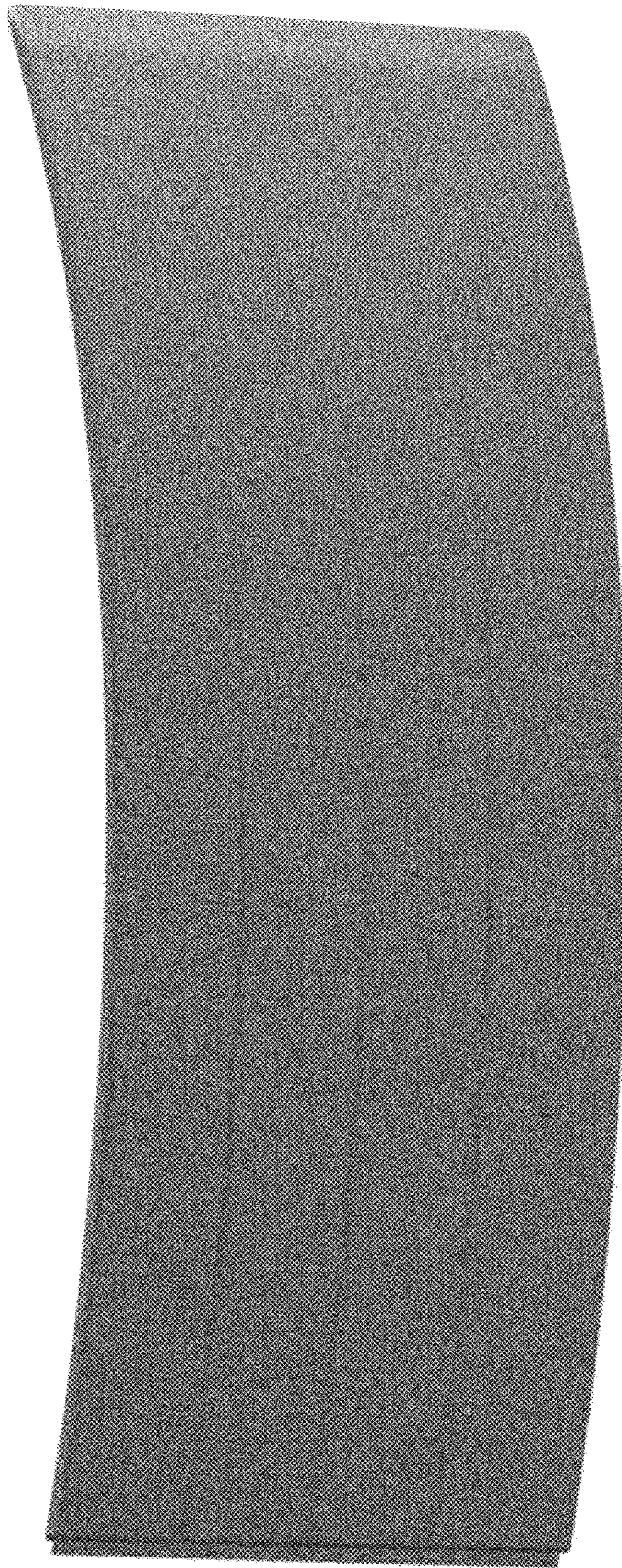

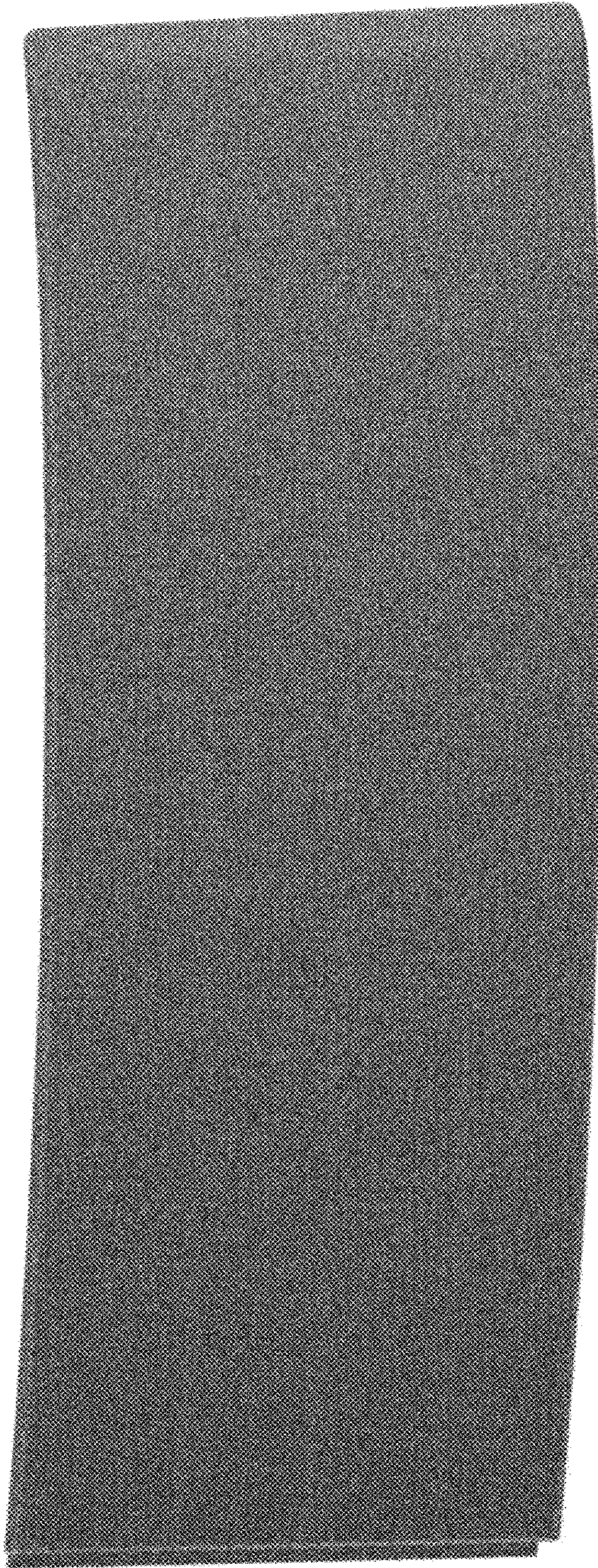

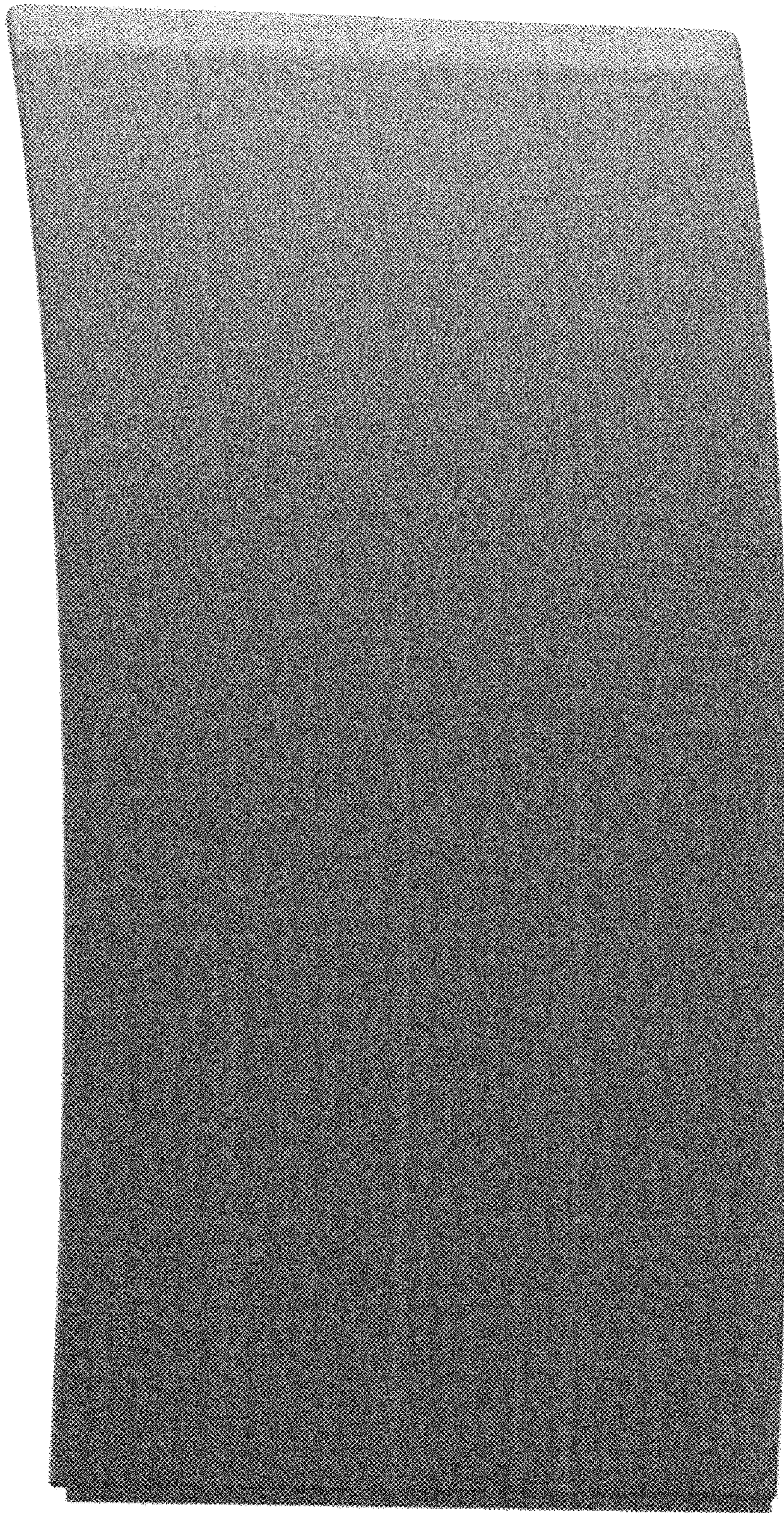

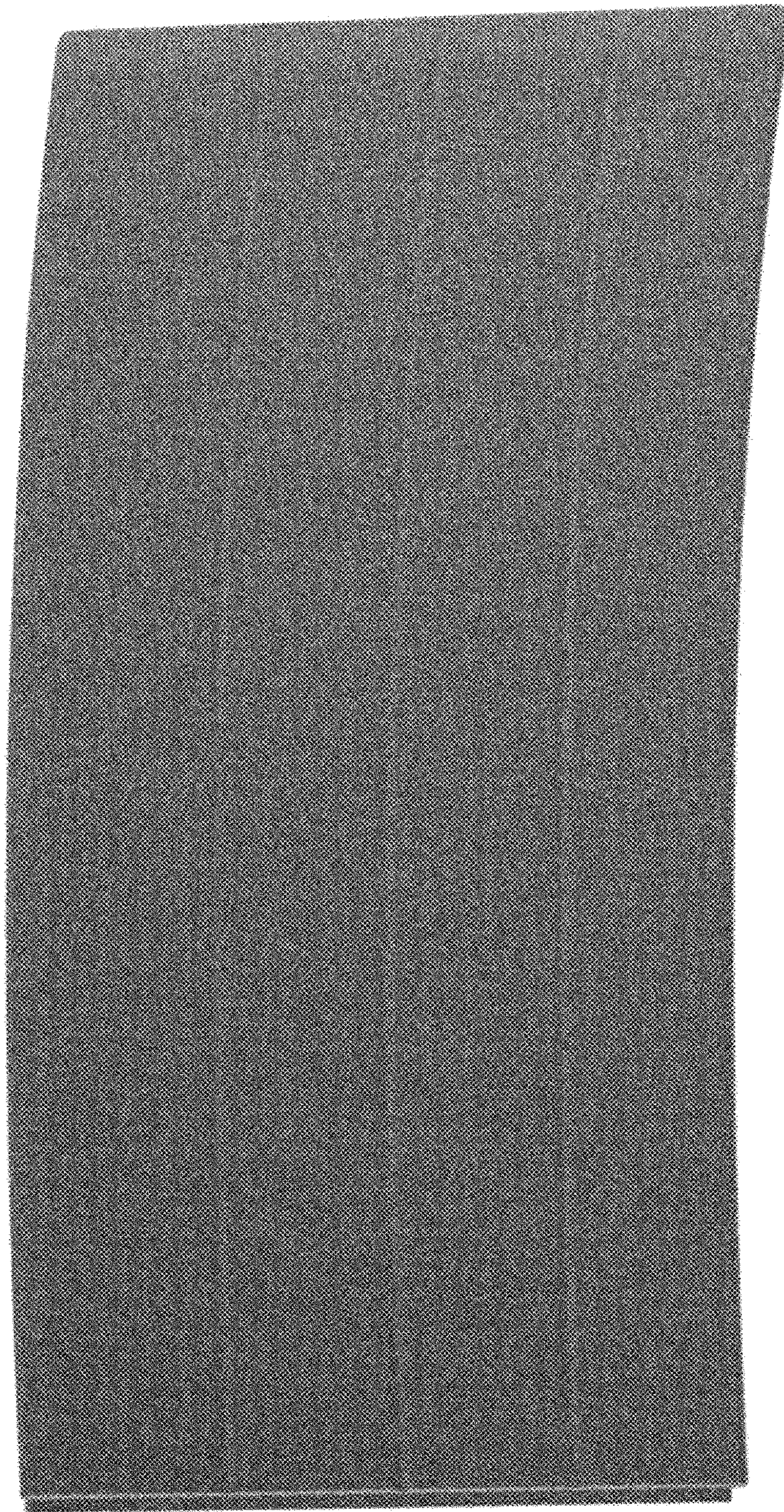

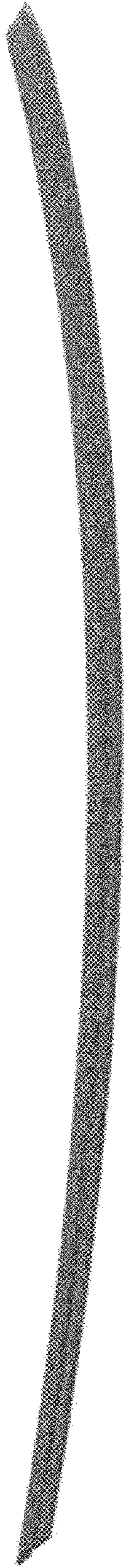

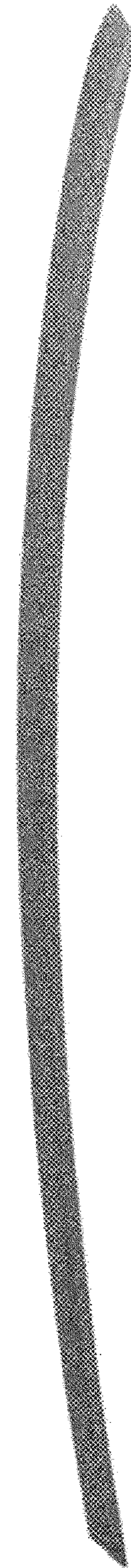

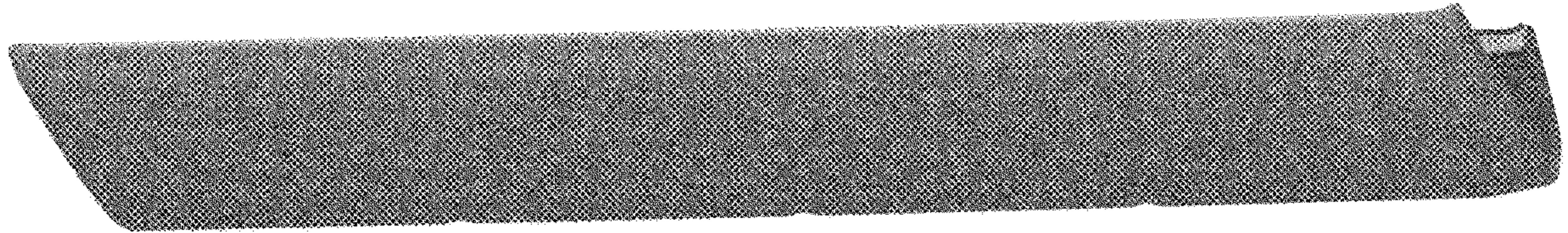

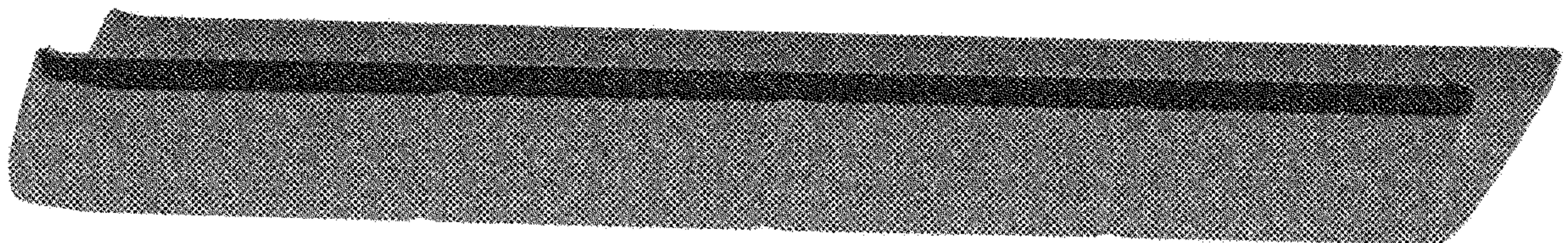

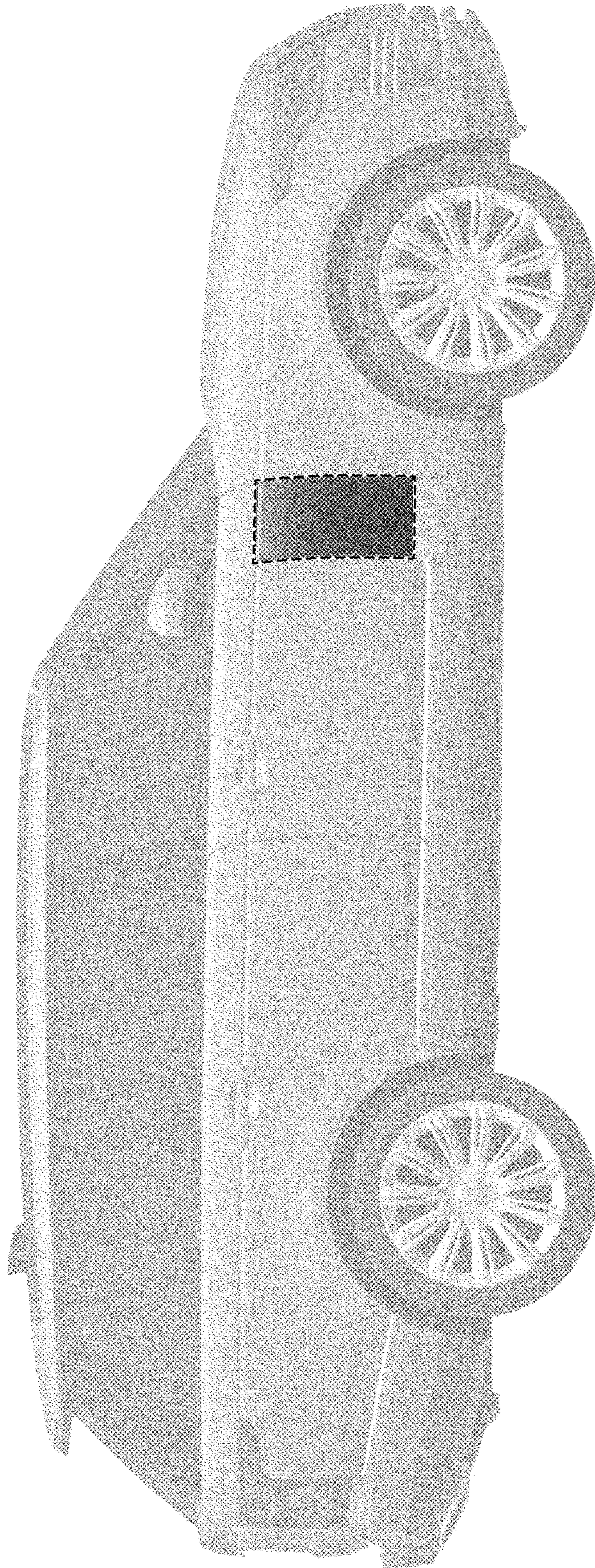
