(57) **CLAIM**

The ornamental design for a fender vent for a vehicle, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a fender vent for a  
vehicle according to the present invention.

FIG. 2 is a front right perspective view of the fender vent  
shown in FIG. 1.

FIG. 3 is a rear right perspective view thereof.

FIG. 4 is a rear left perspective view thereof.

FIG. 5 is a front view thereof.

FIG. 6 is a rear view thereof.

FIG. 7 is a left side view thereof.

FIG. 8 is a right side view thereof.

FIG. 9 is a top view thereof.

FIG. 10 is a bottom view thereof; and,

FIG. 11 is a front view of the fender vent shown in FIGS.  
1-10, but with the fender vent mounted on a vehicle shown  
in de-emphasized and half-tone portions so as to illustrate  
environmental structure. These portions form no part of the  
claimed invention. More particularly, in FIG. 11, the inven-  
tive fender vent is shown within the broken line, and the  
elements shown outside the broken line form no part of the  
claimed invention, but are included to show environmental  
aspects thereof.

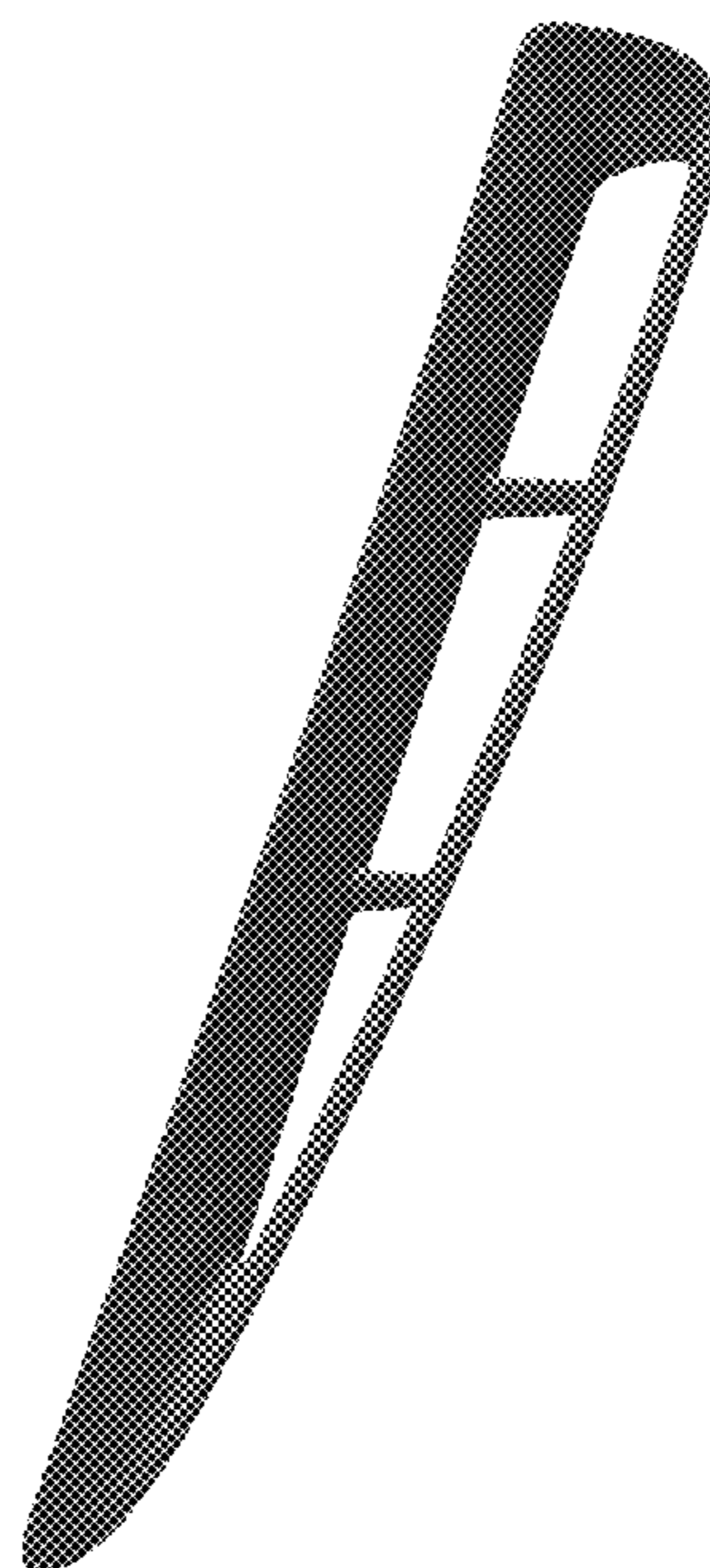

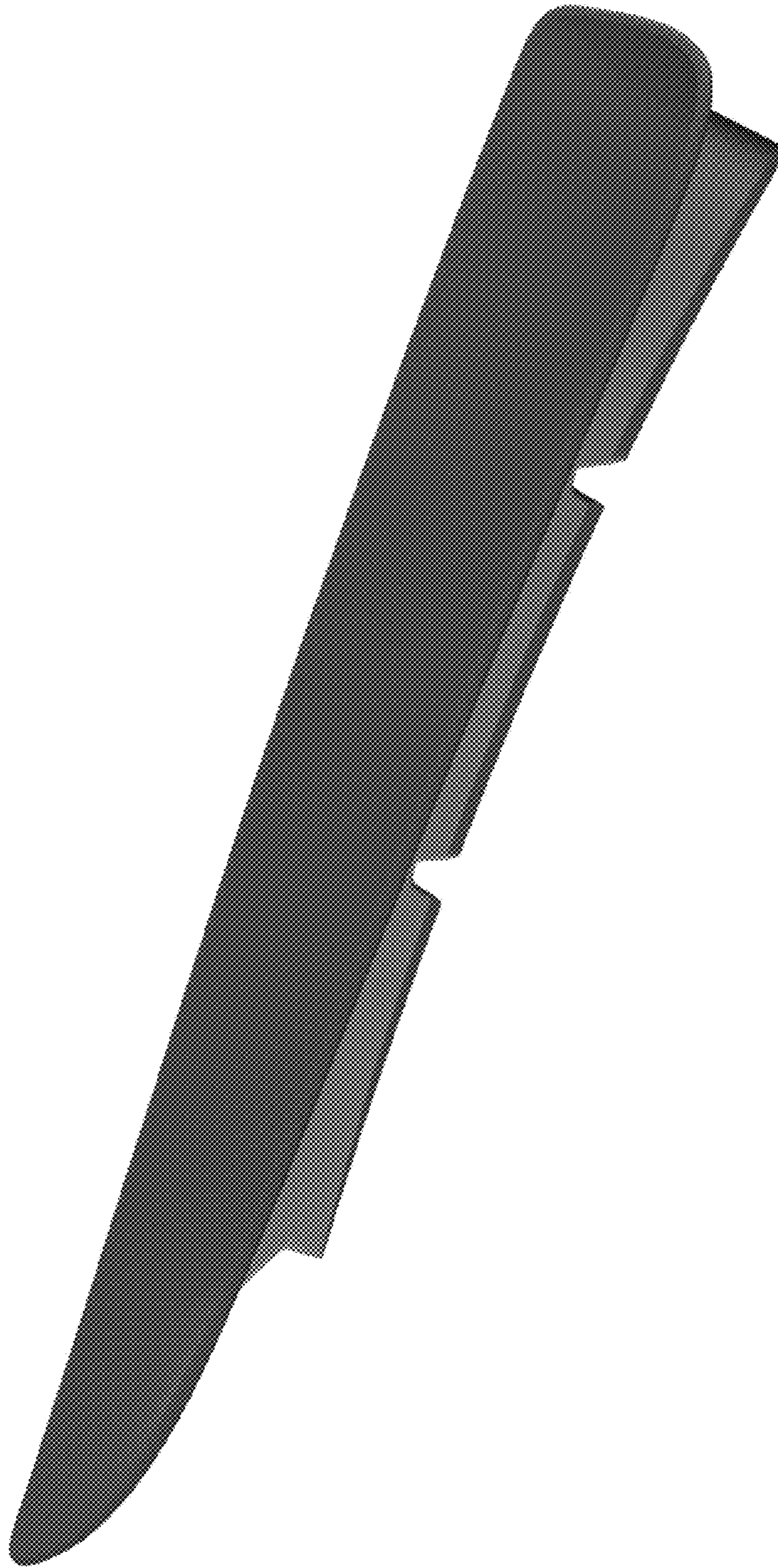

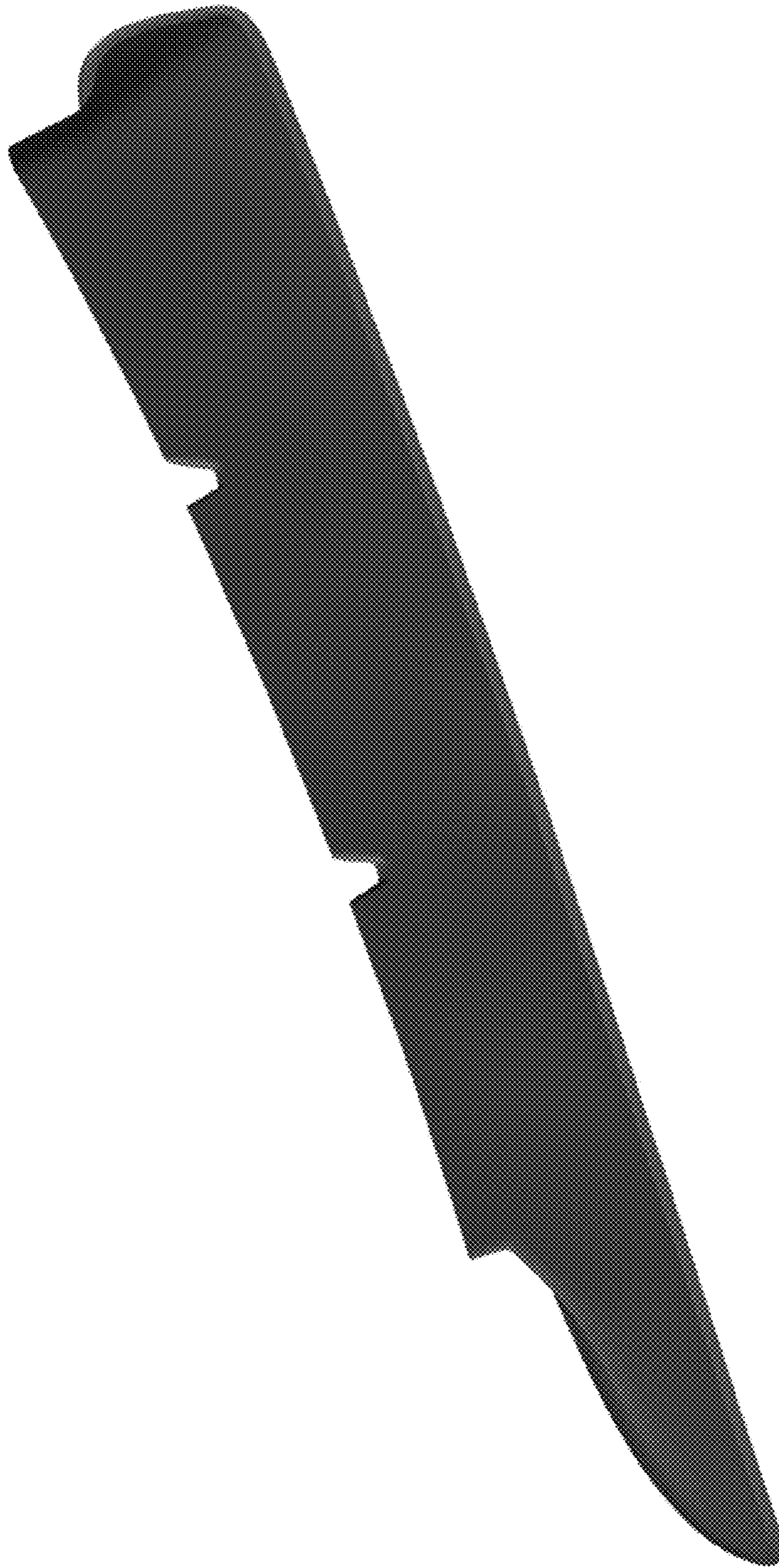

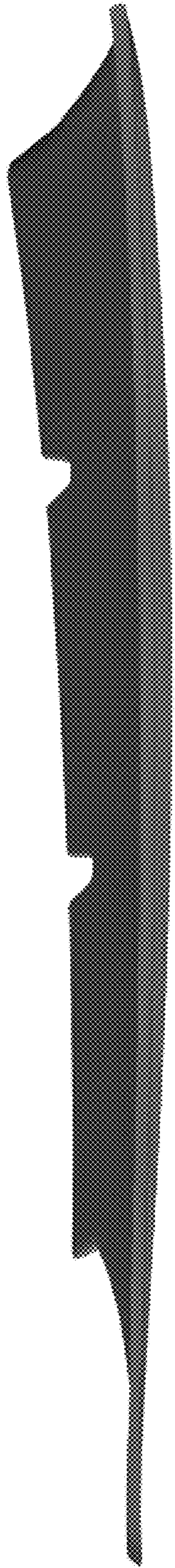

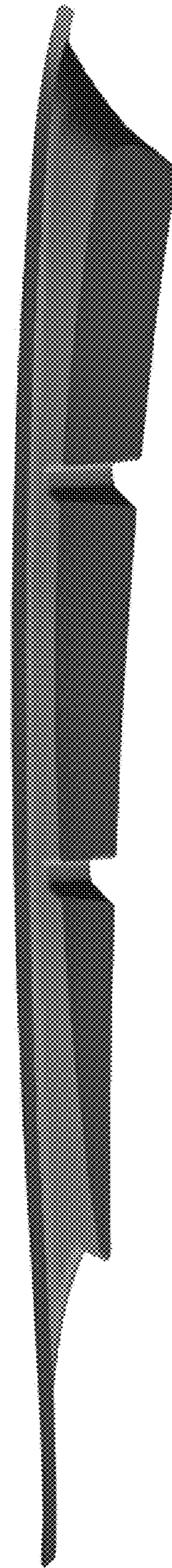

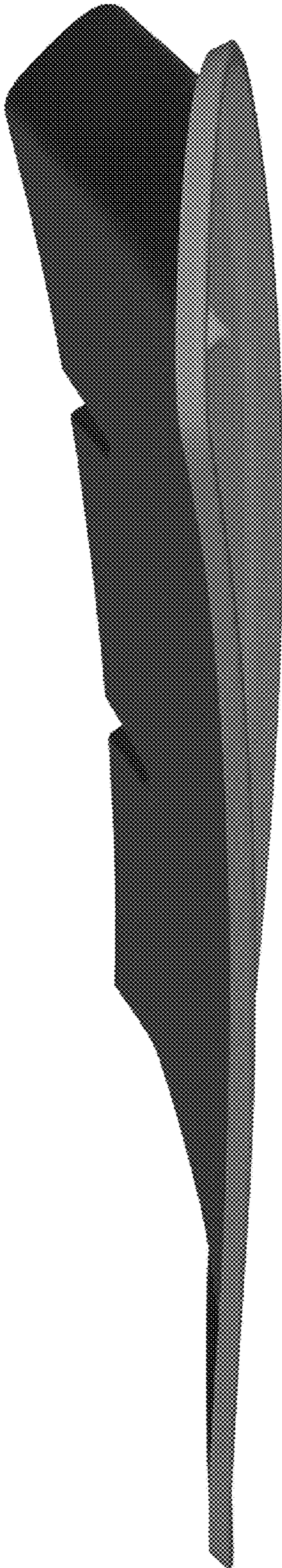

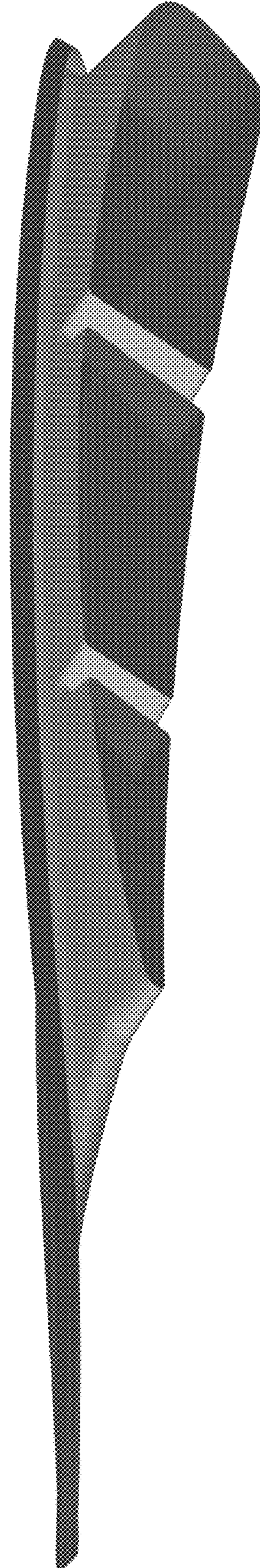

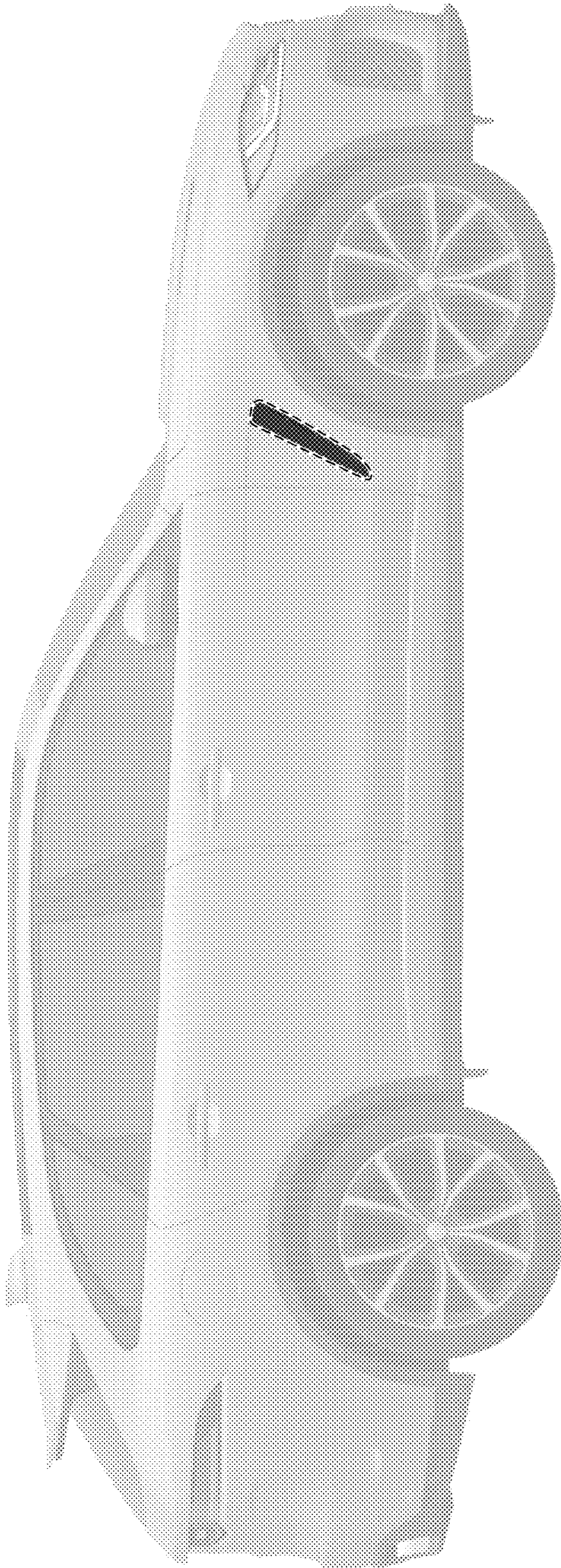
