**DESCRIPTION**

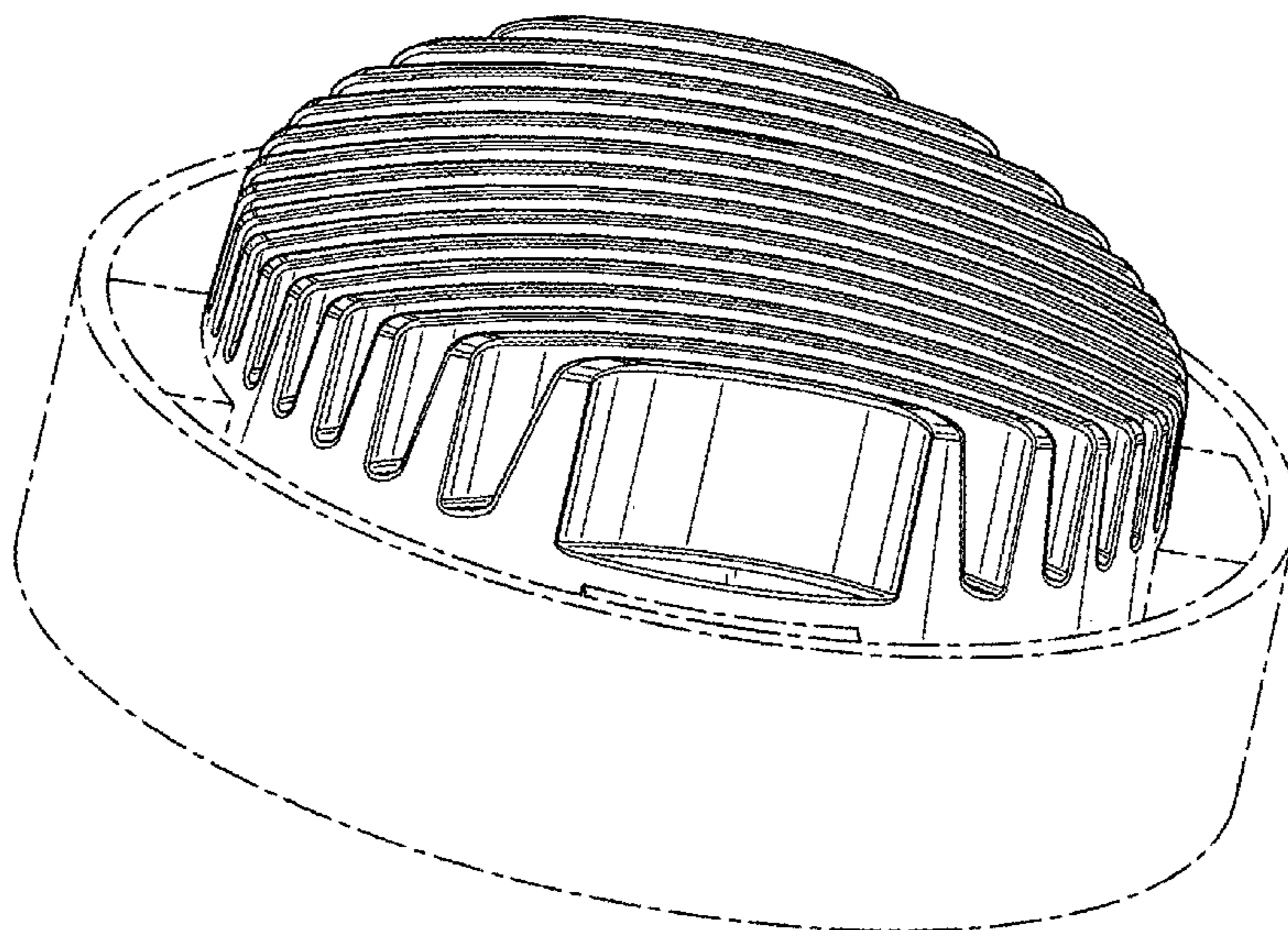

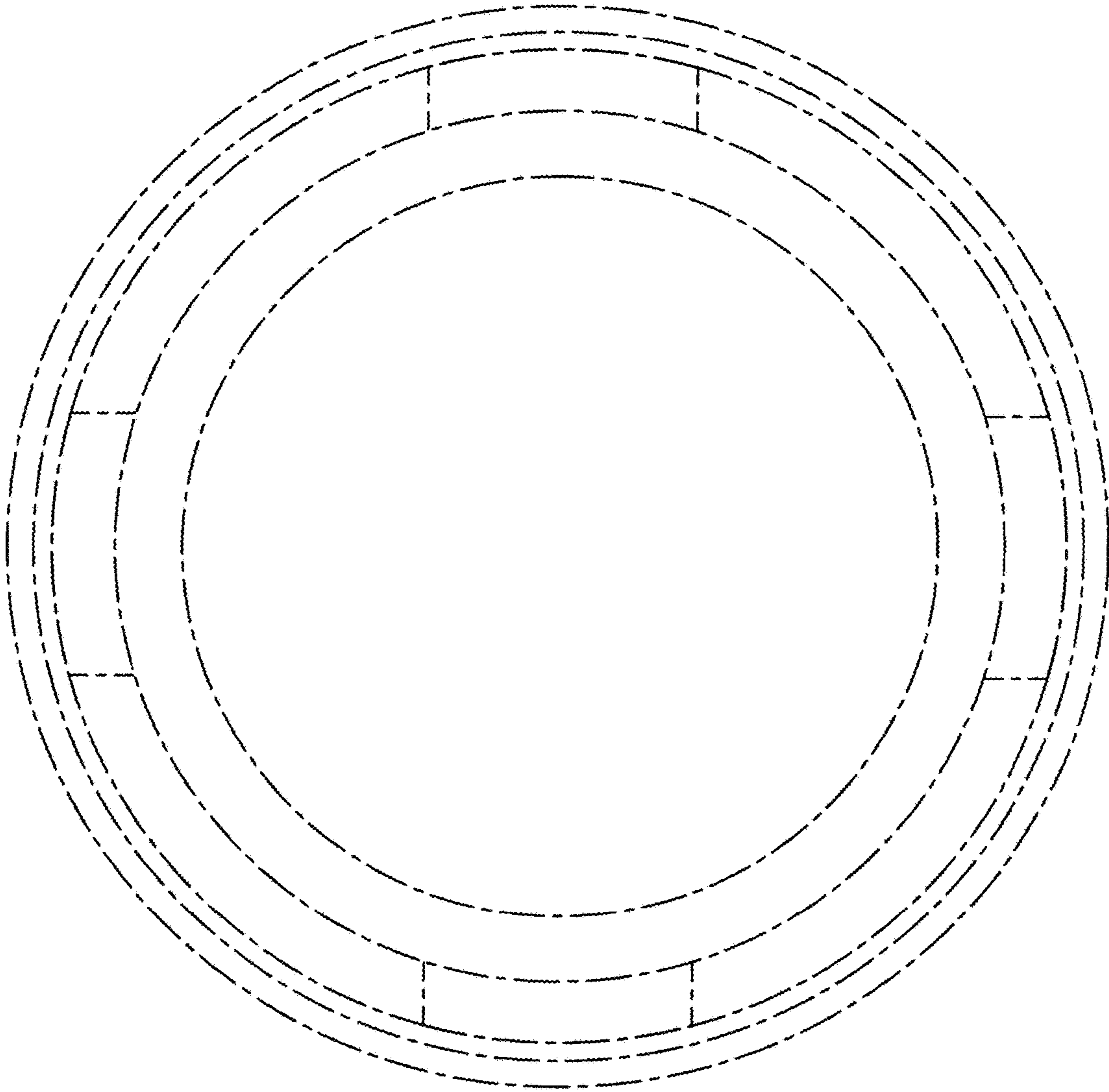

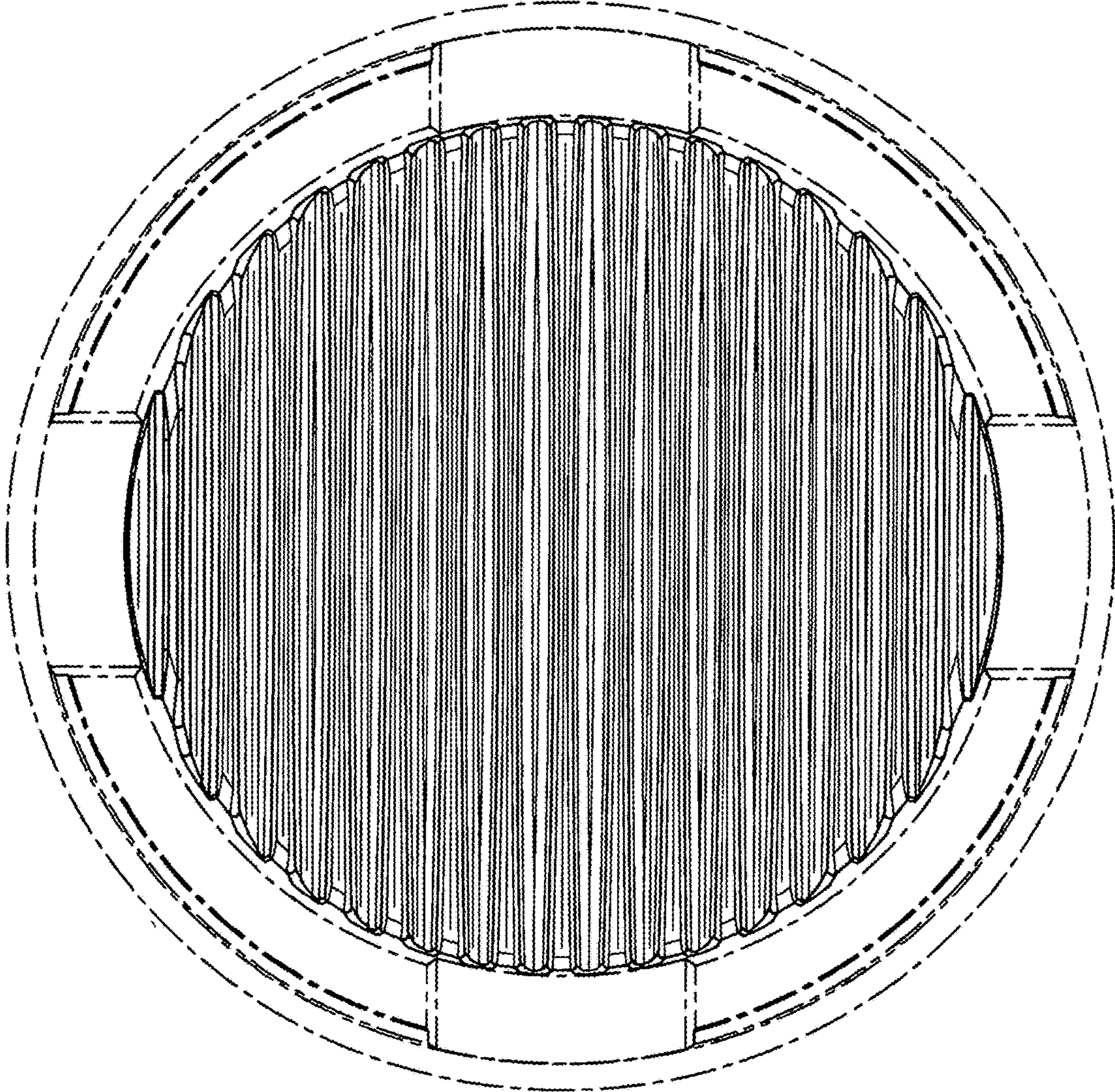

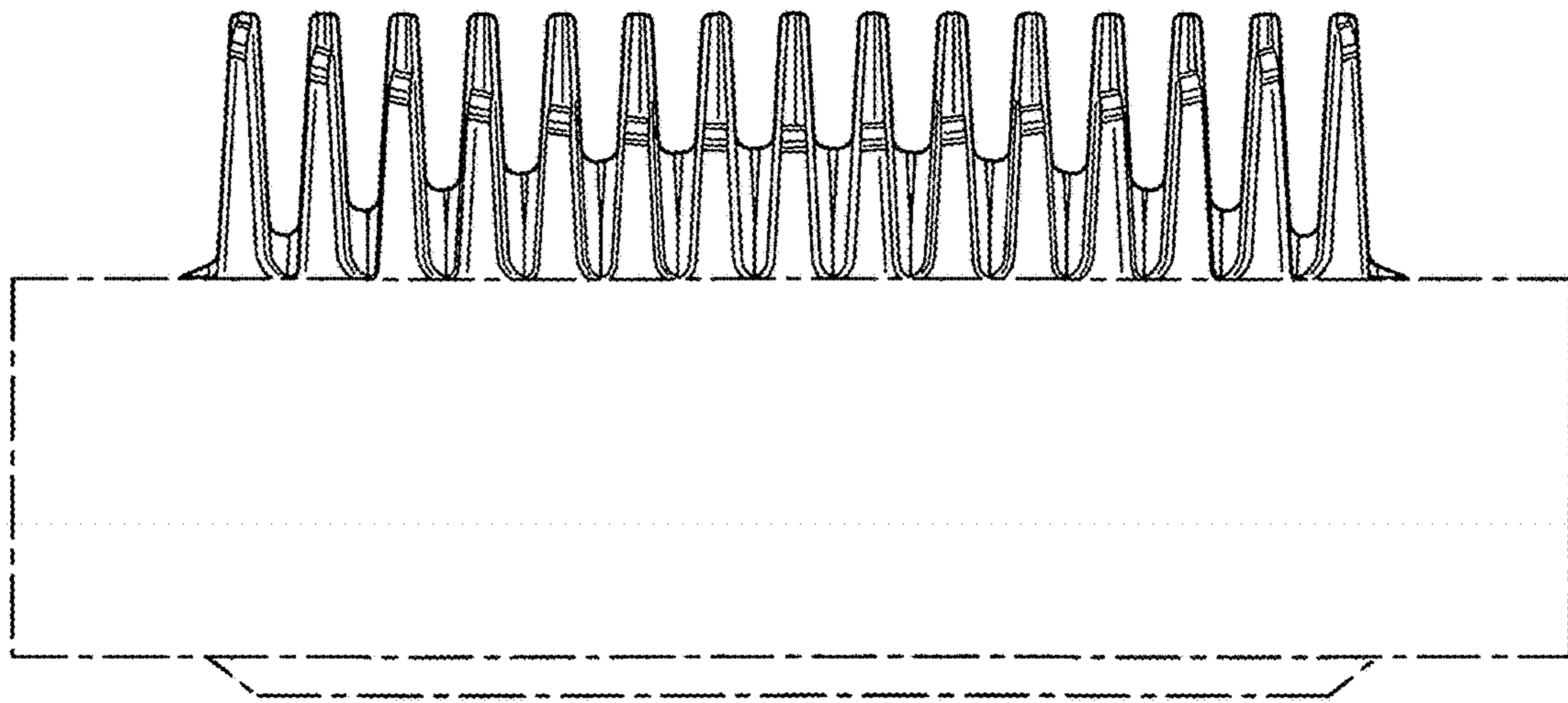

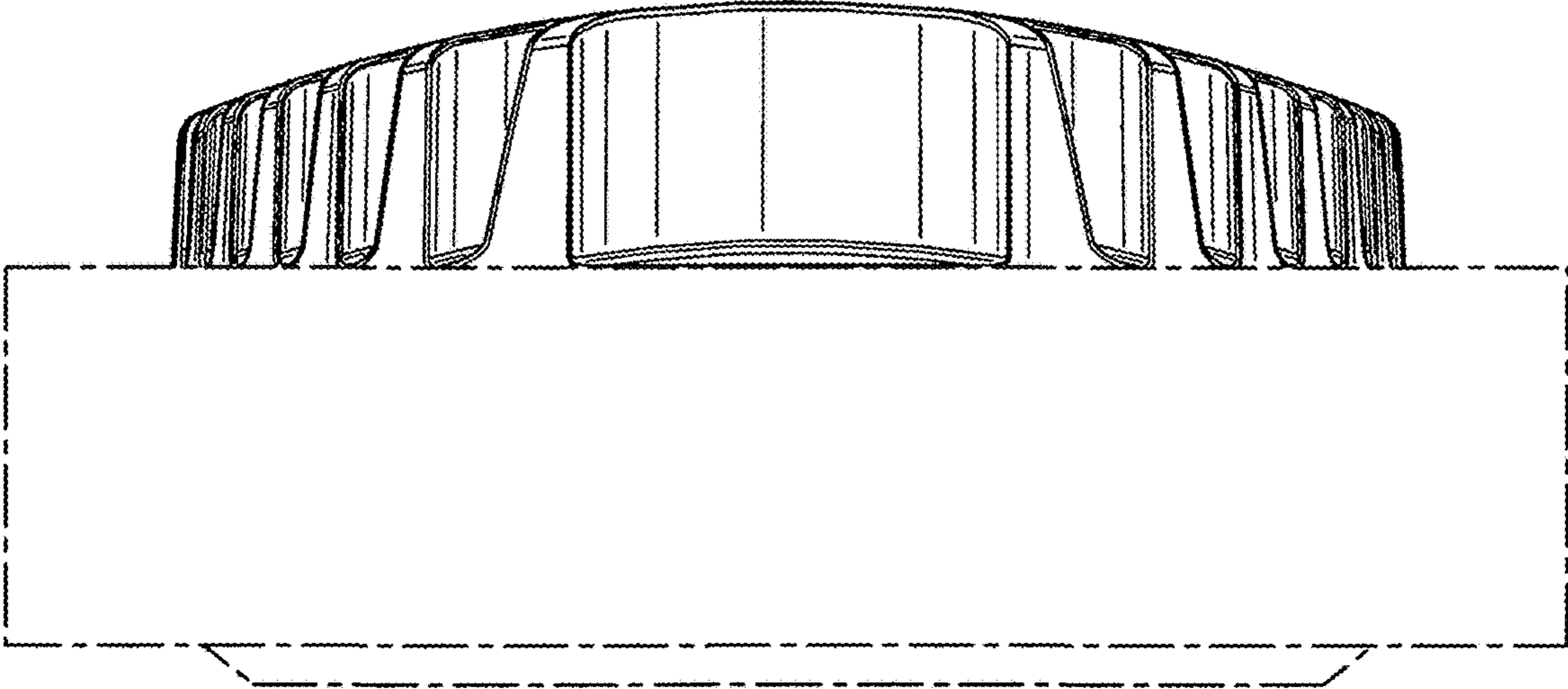

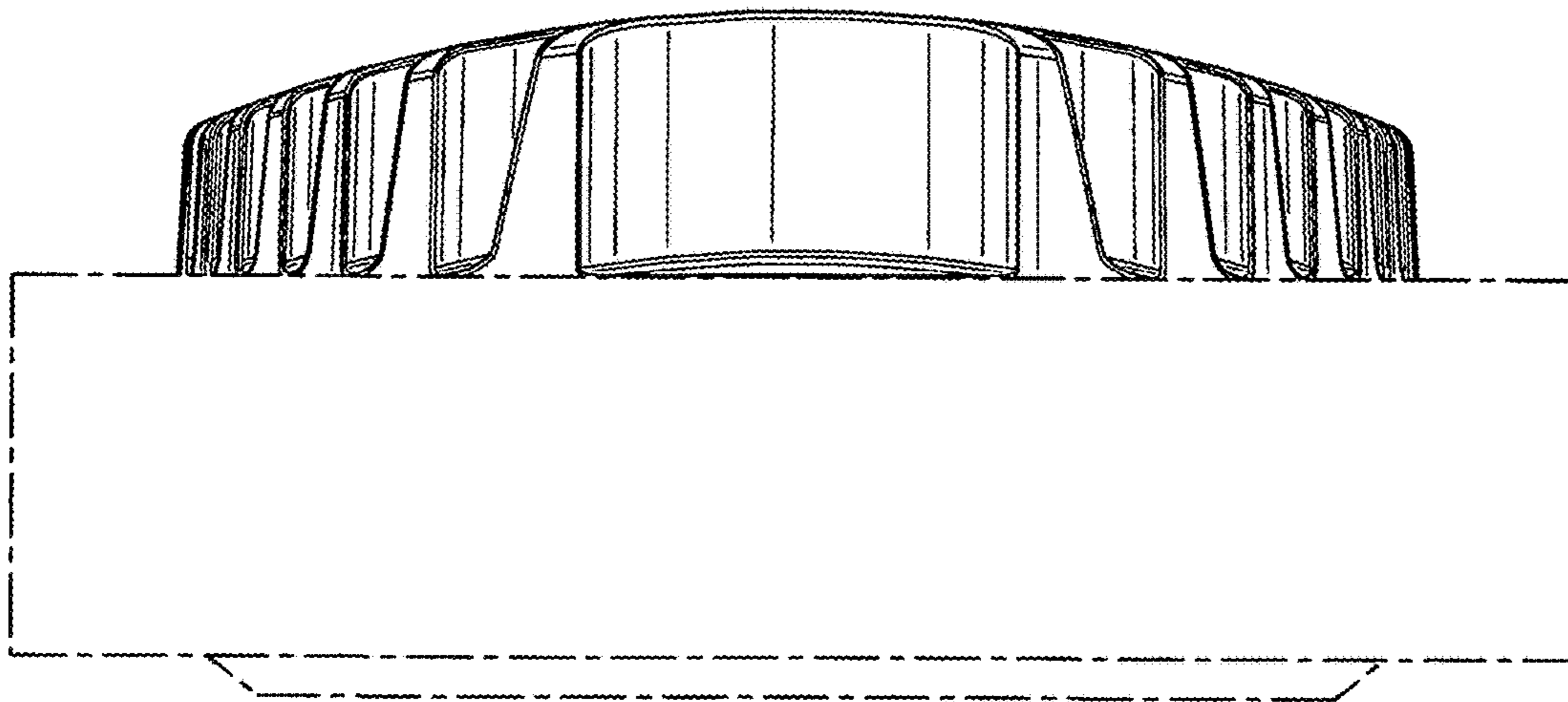

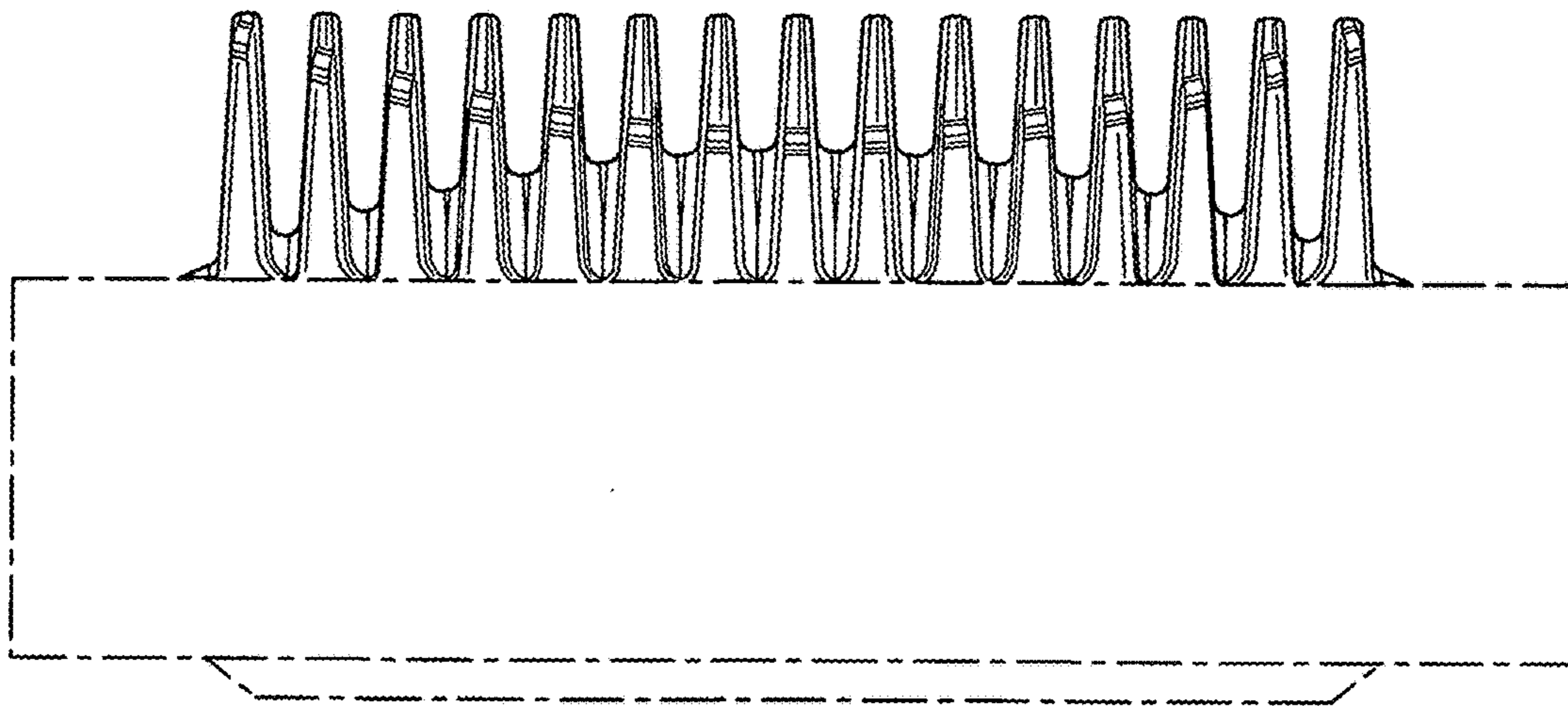

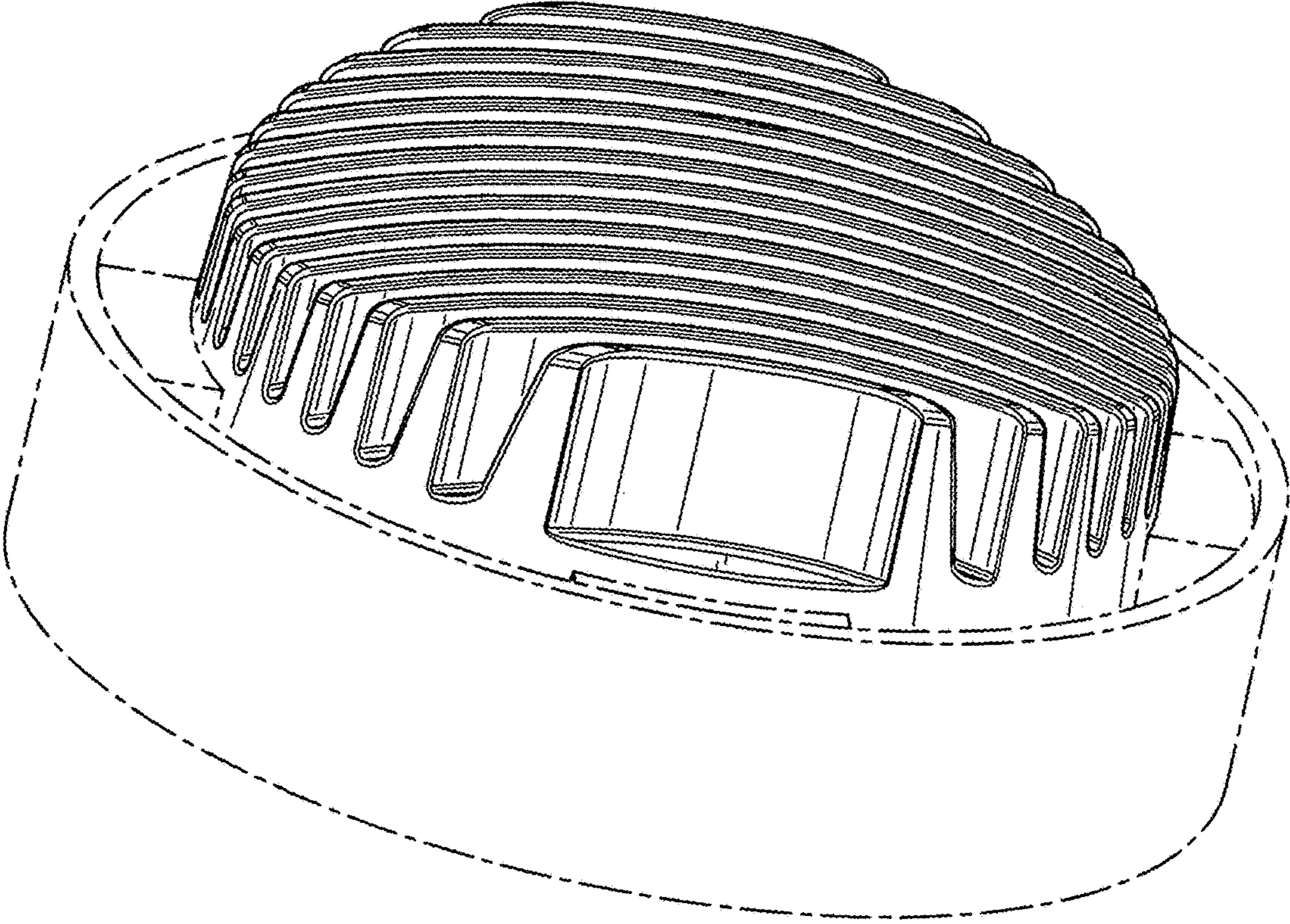

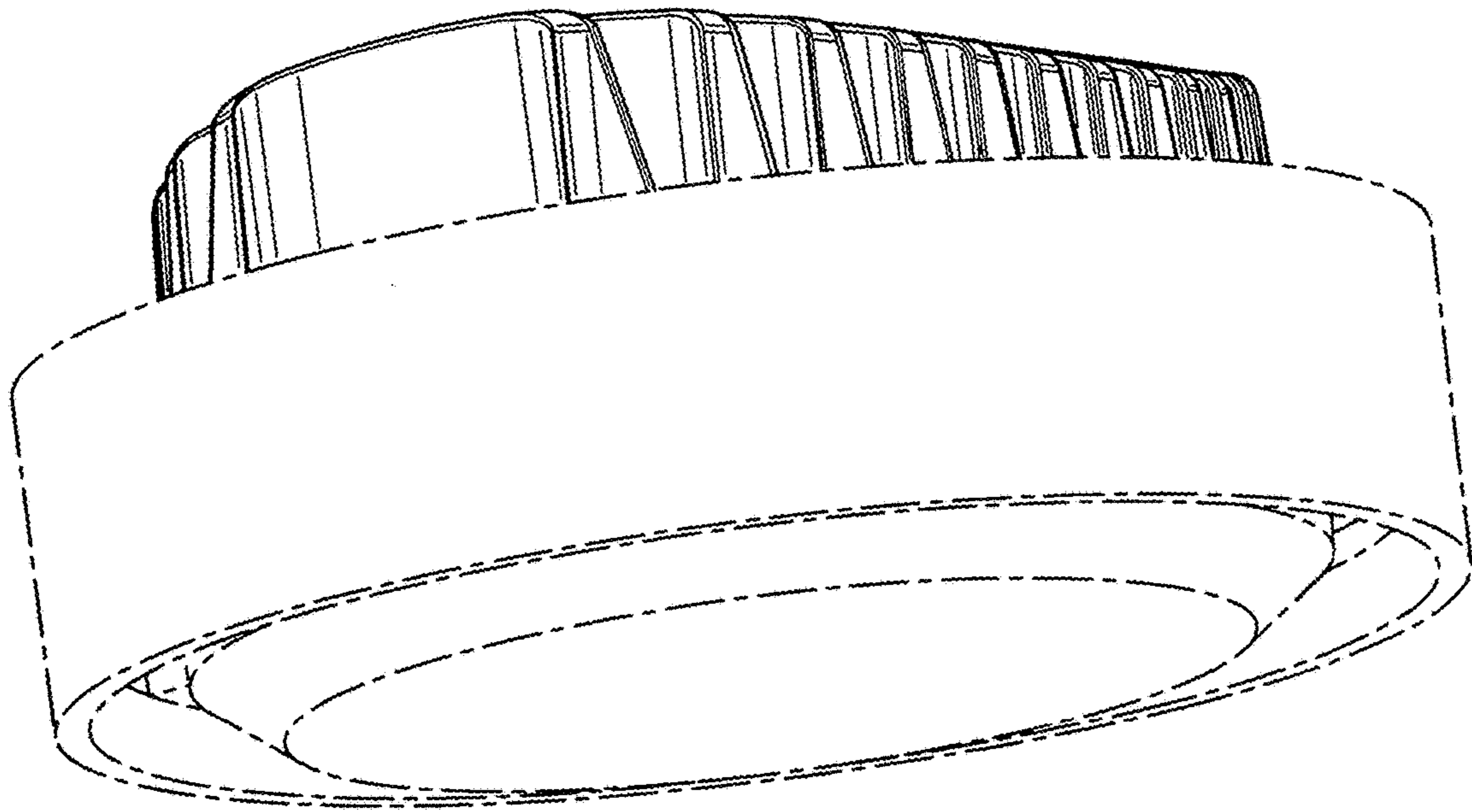
