DESCRIPTION

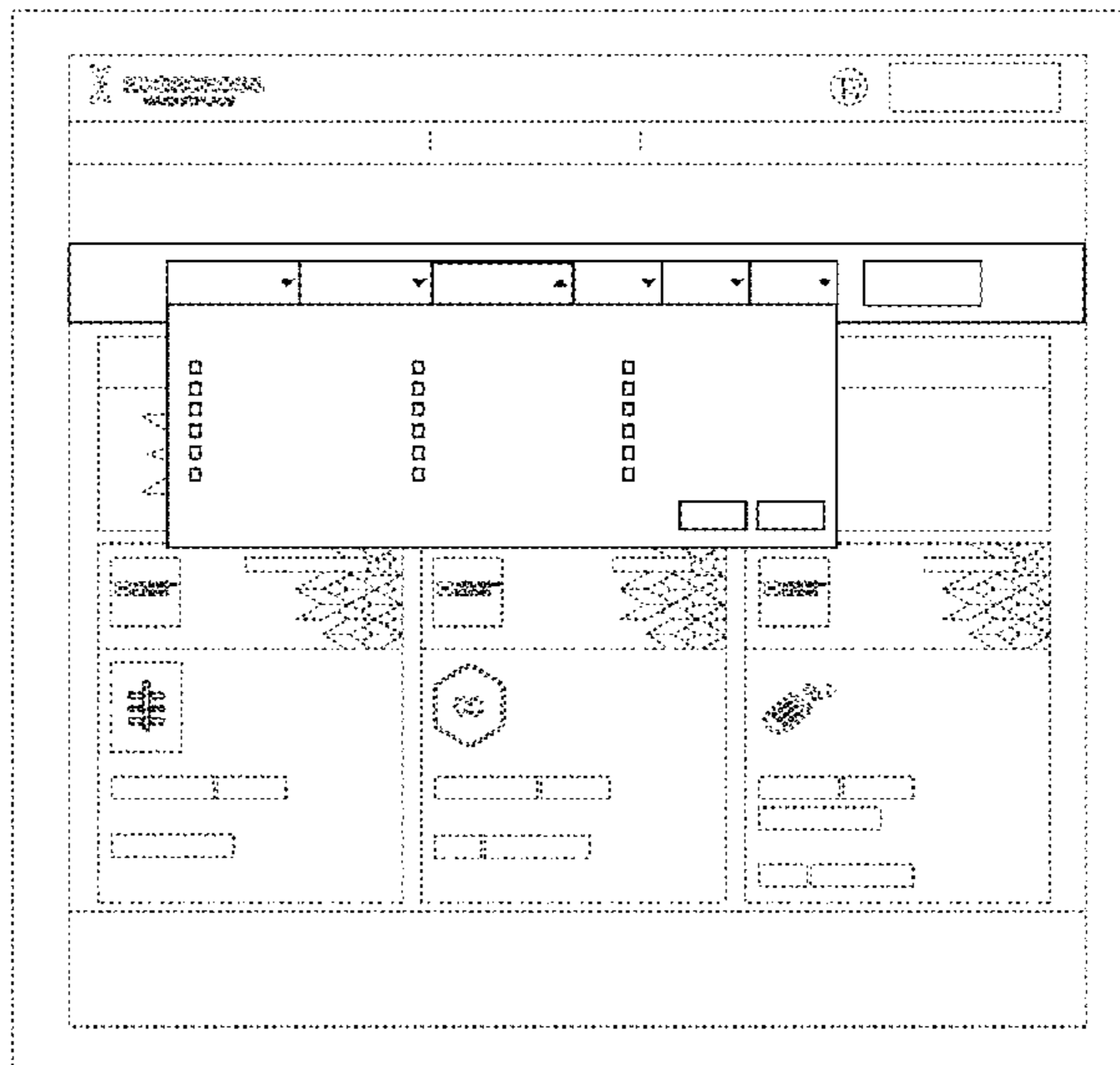
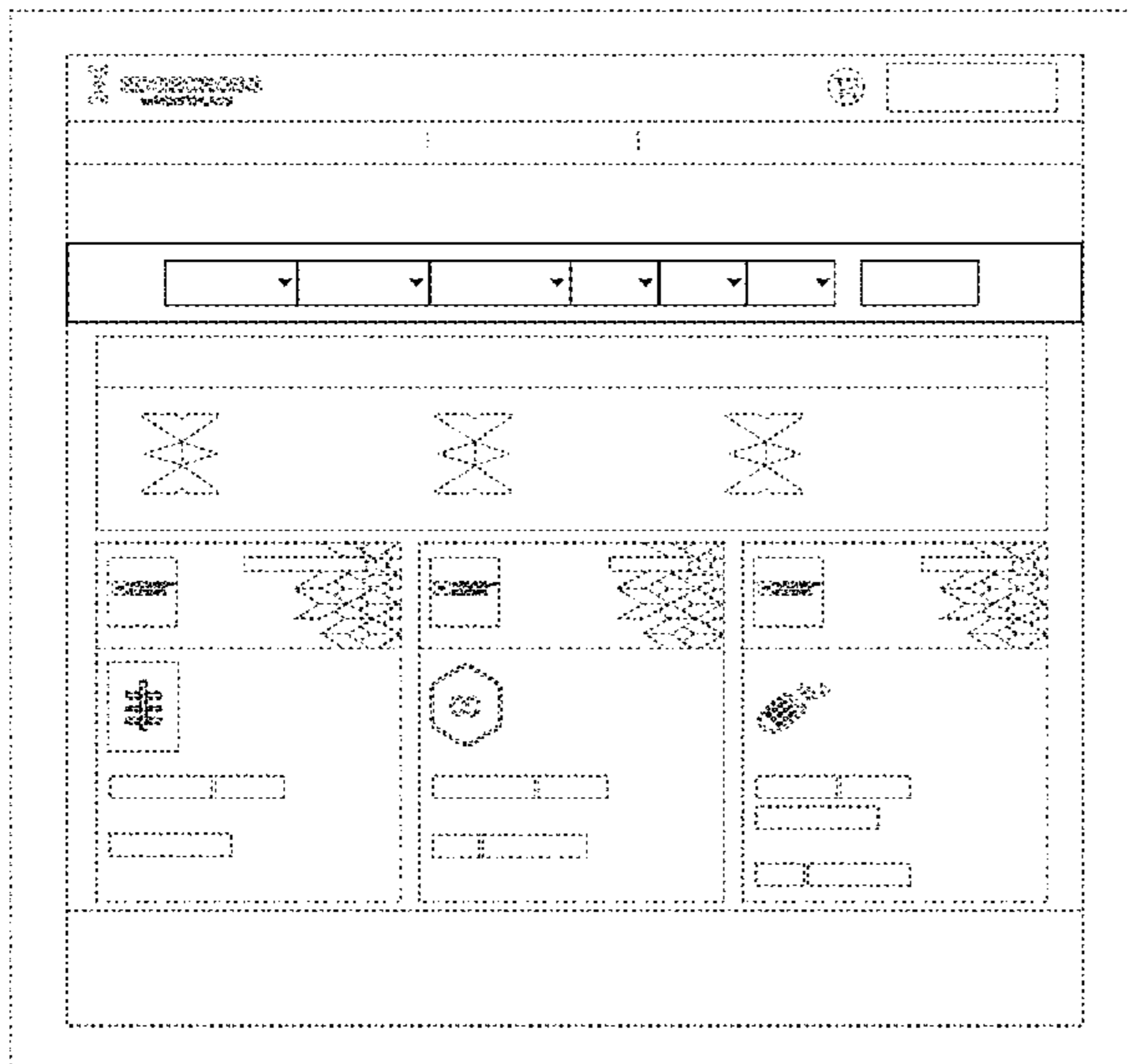
FIG. 1. is a front view of a first image of display screen with animated graphical user interface, showing our new design; and,

FIG. 2. is a front view of a second image thereof.

The outermost broken lines show a display screen and form no part of the claimed design. The remaining broken lines show portions of the animated graphical user interface and form no part of the claimed design.

The appearance of the image transitions sequentially between the images shown in FIGS. 1 and 2. The process or period in which the image changes into the other image forms no part of the claimed design.

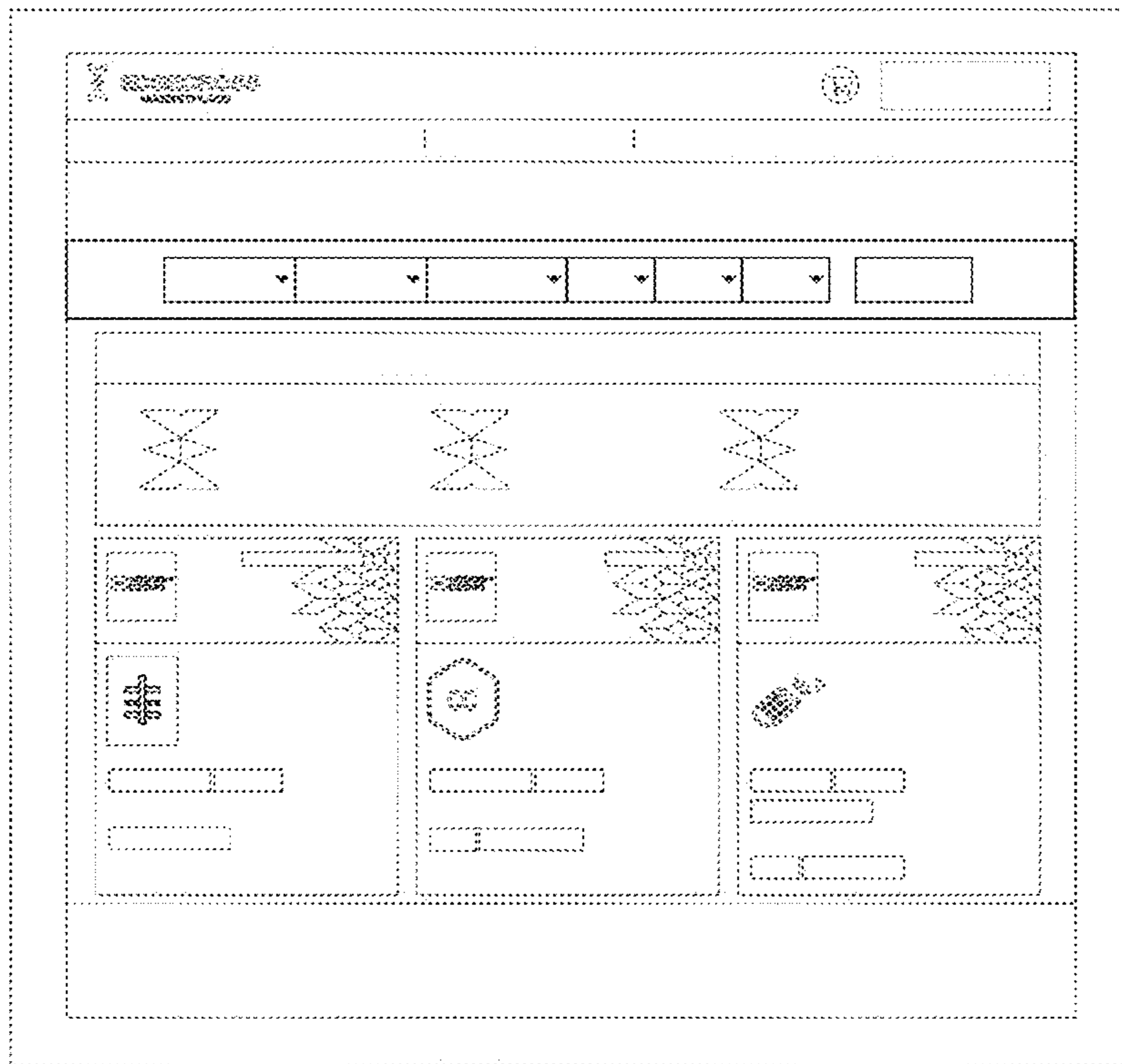
