(57) **CLAIM**

We claim the ornamental design for a vertical grip attachable to a rail of a firearm, as shown and described.

DESCRIPTION

FIG. 13 is a side view thereof;

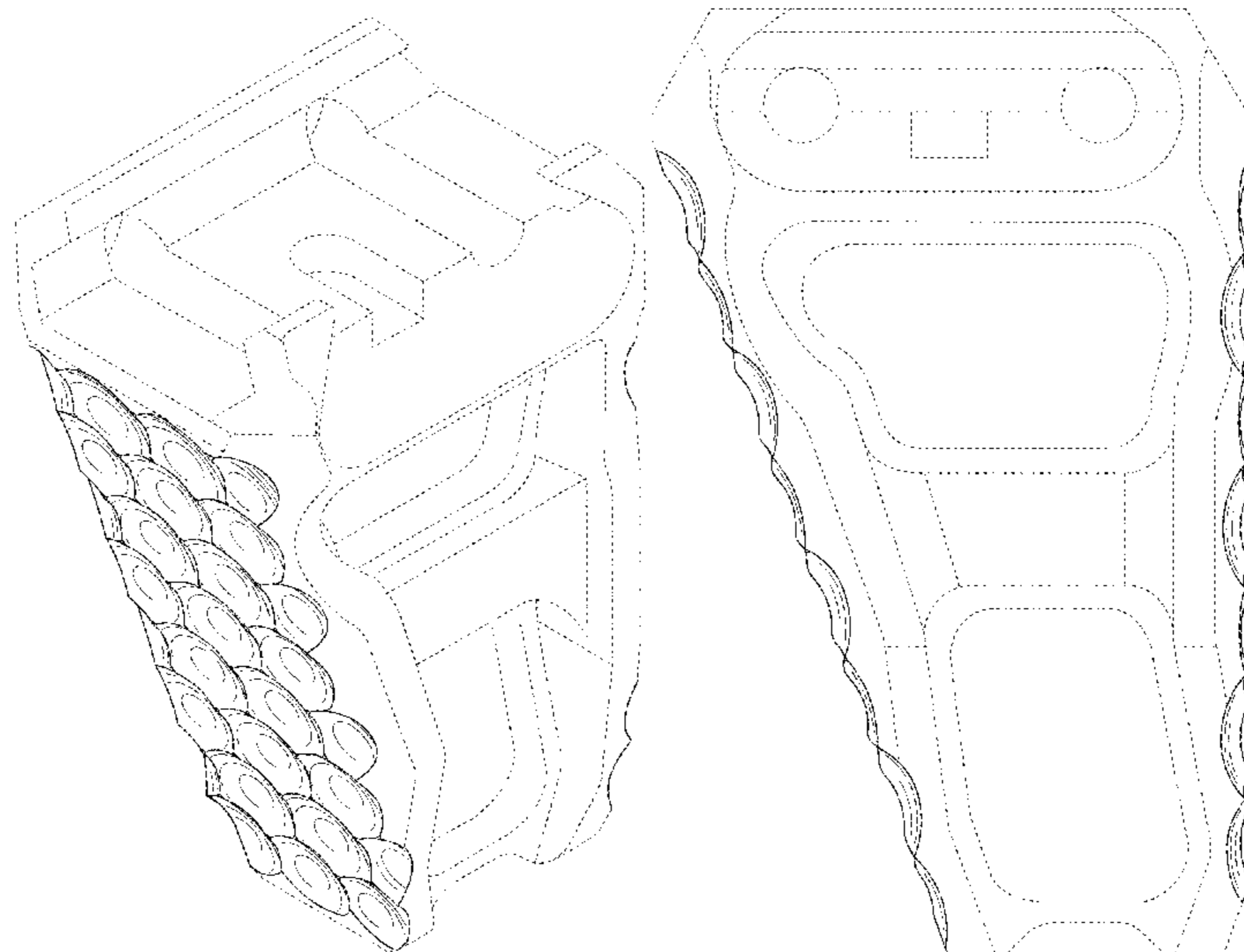
FIG. 14 is a side view thereof;

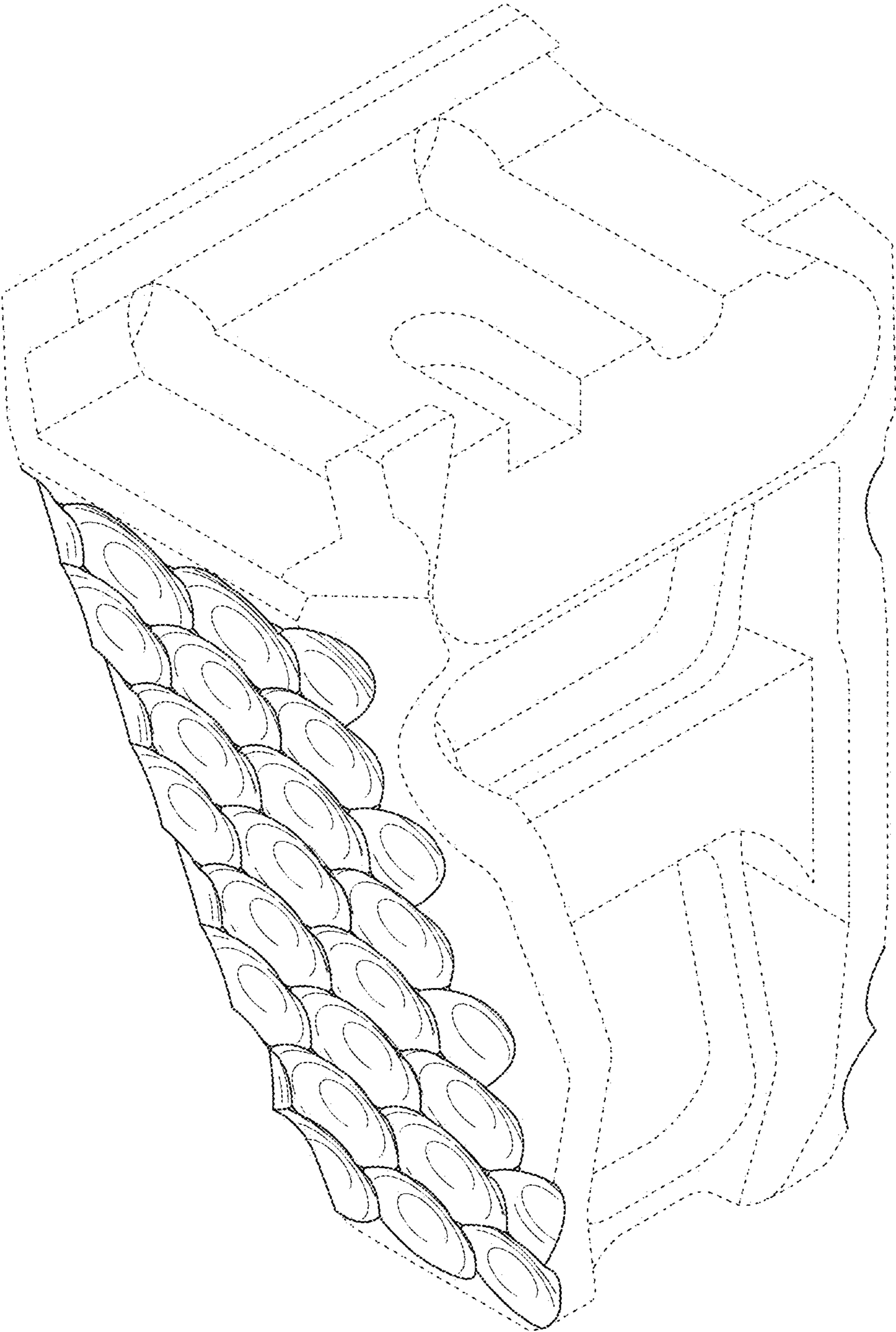

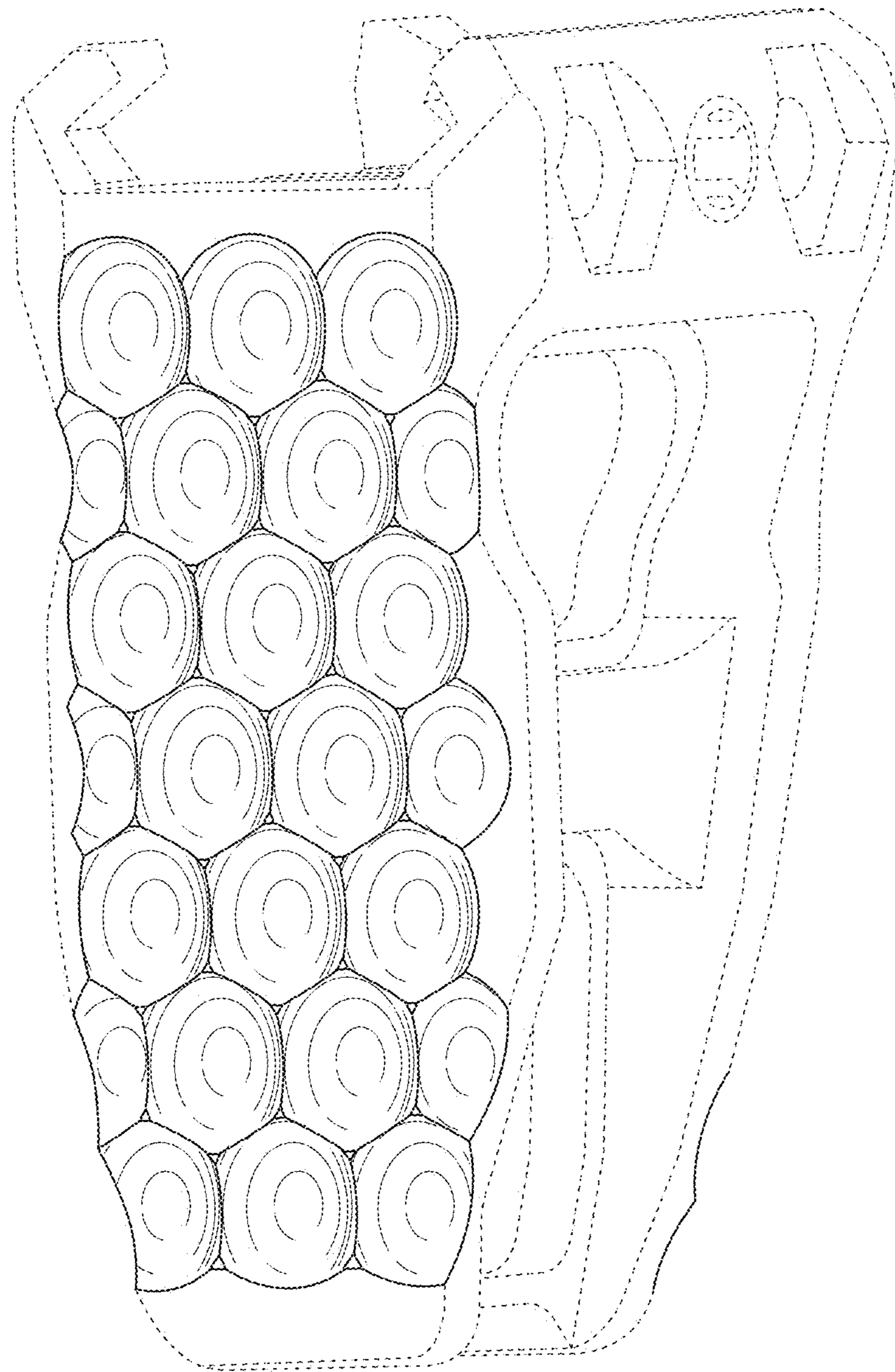

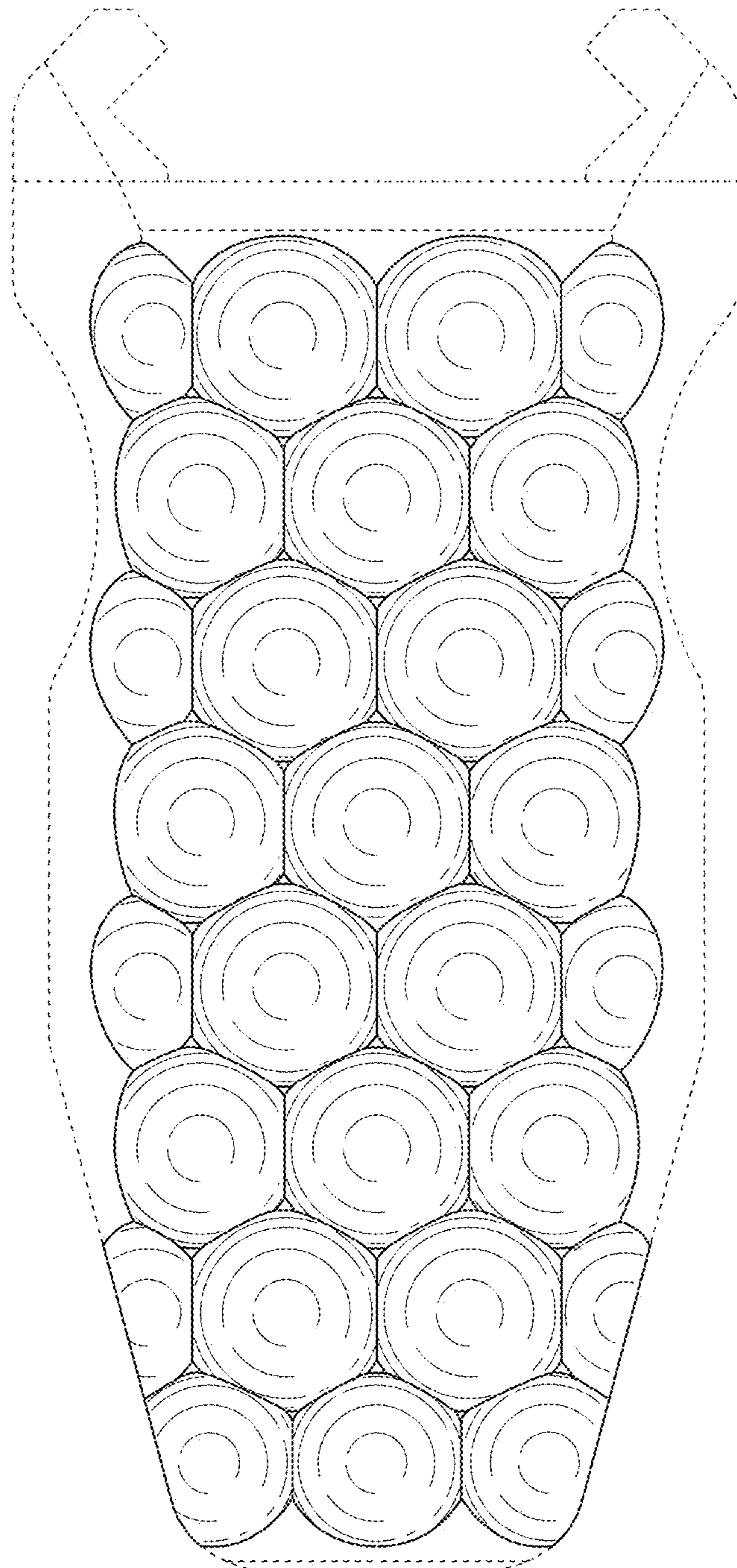

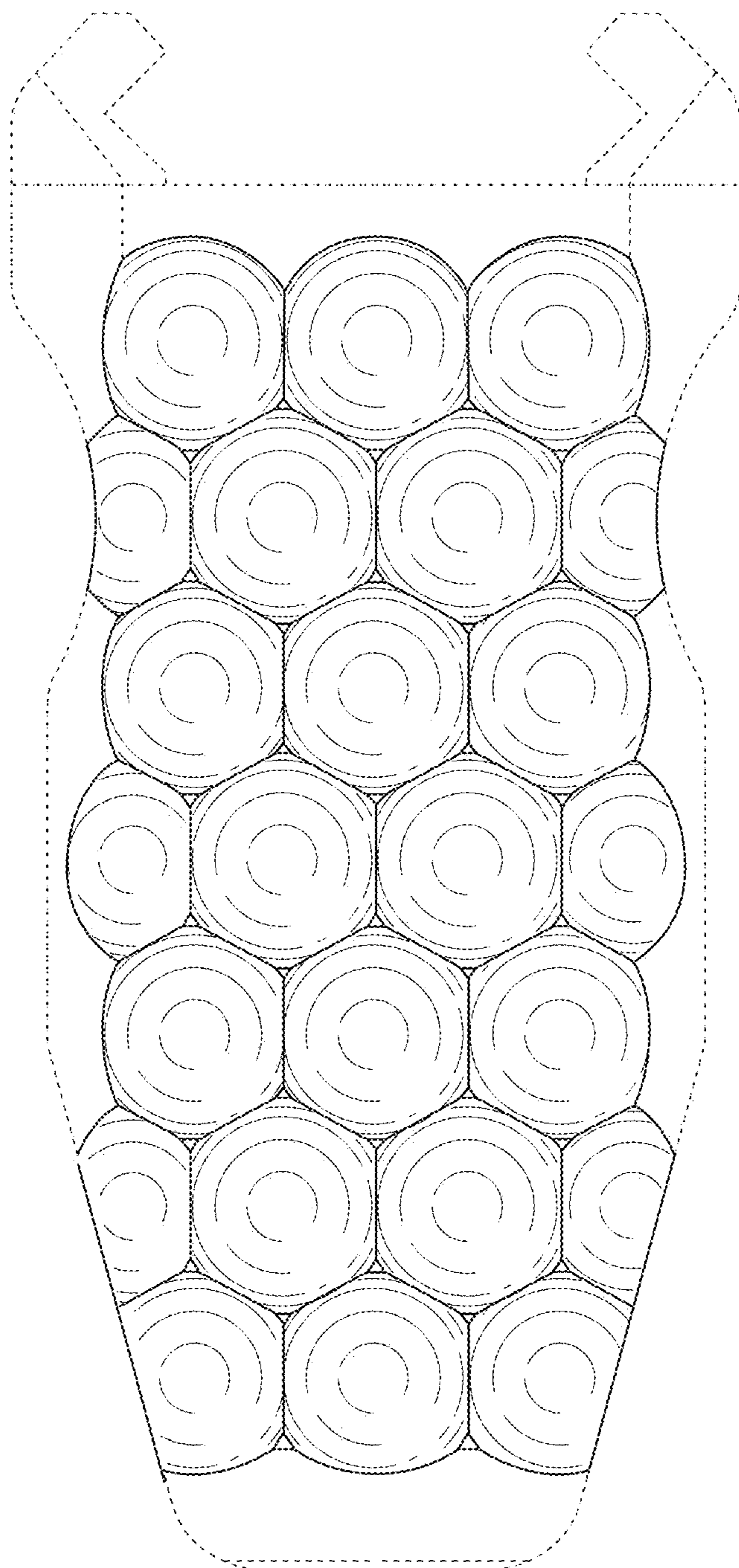

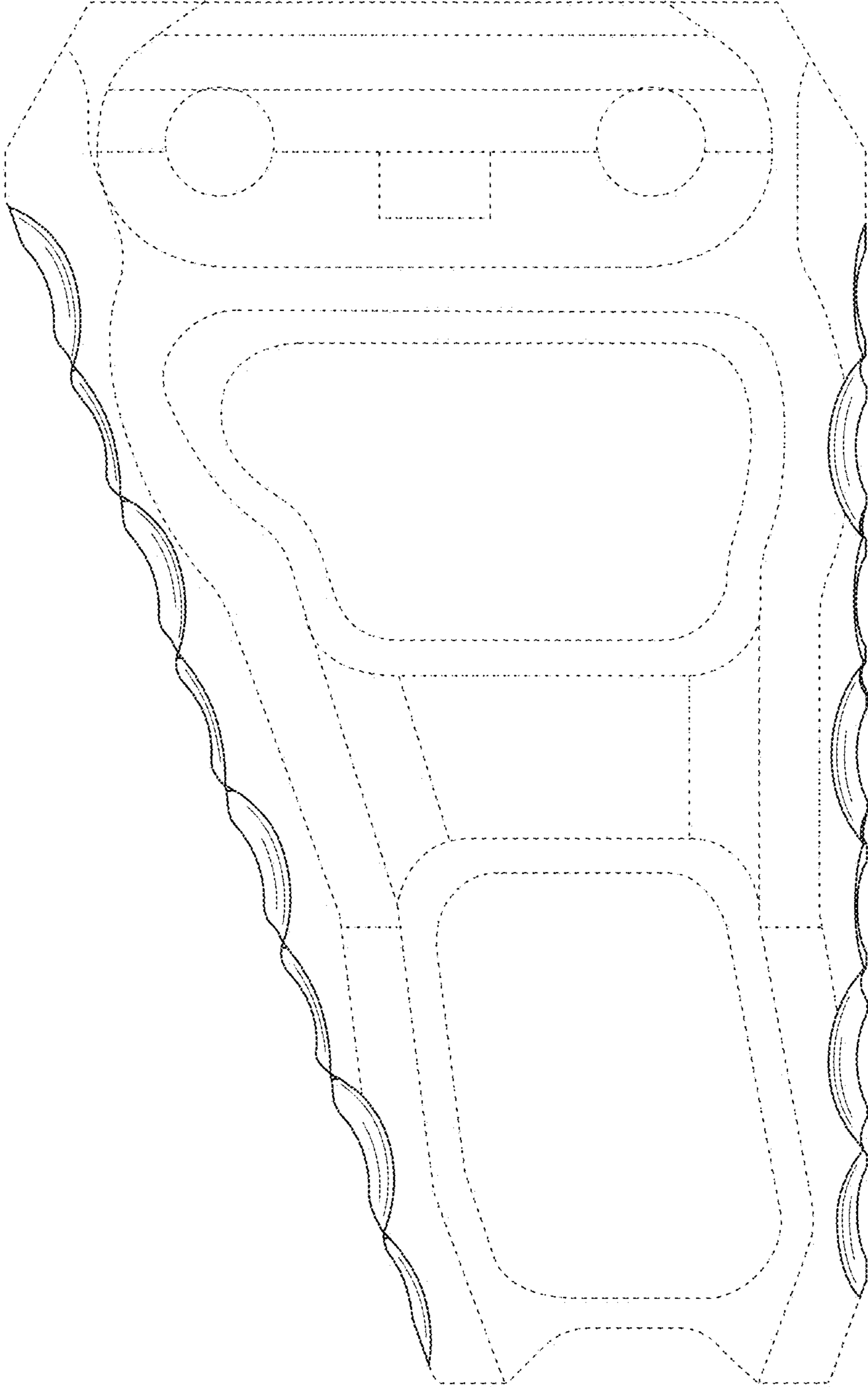

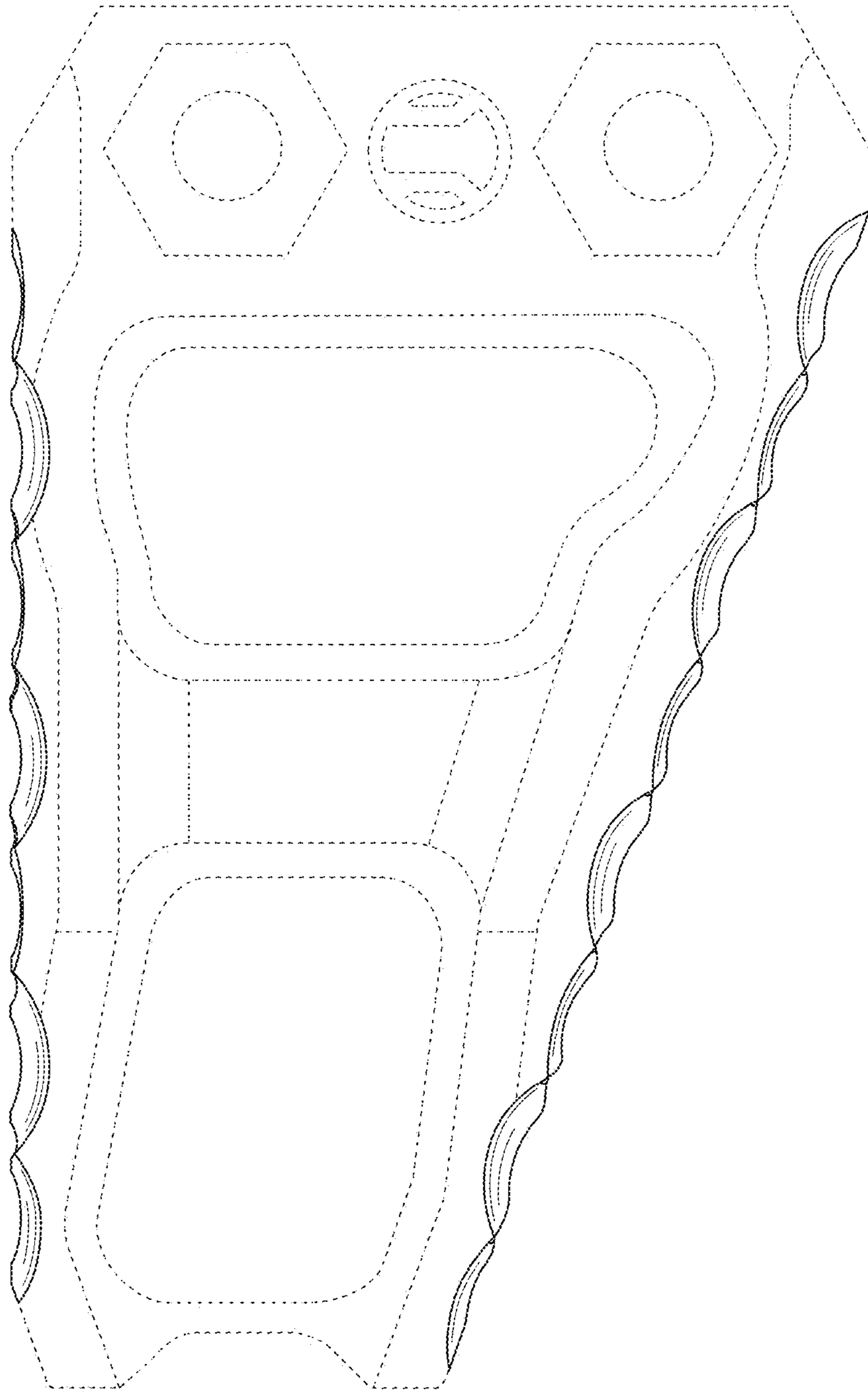

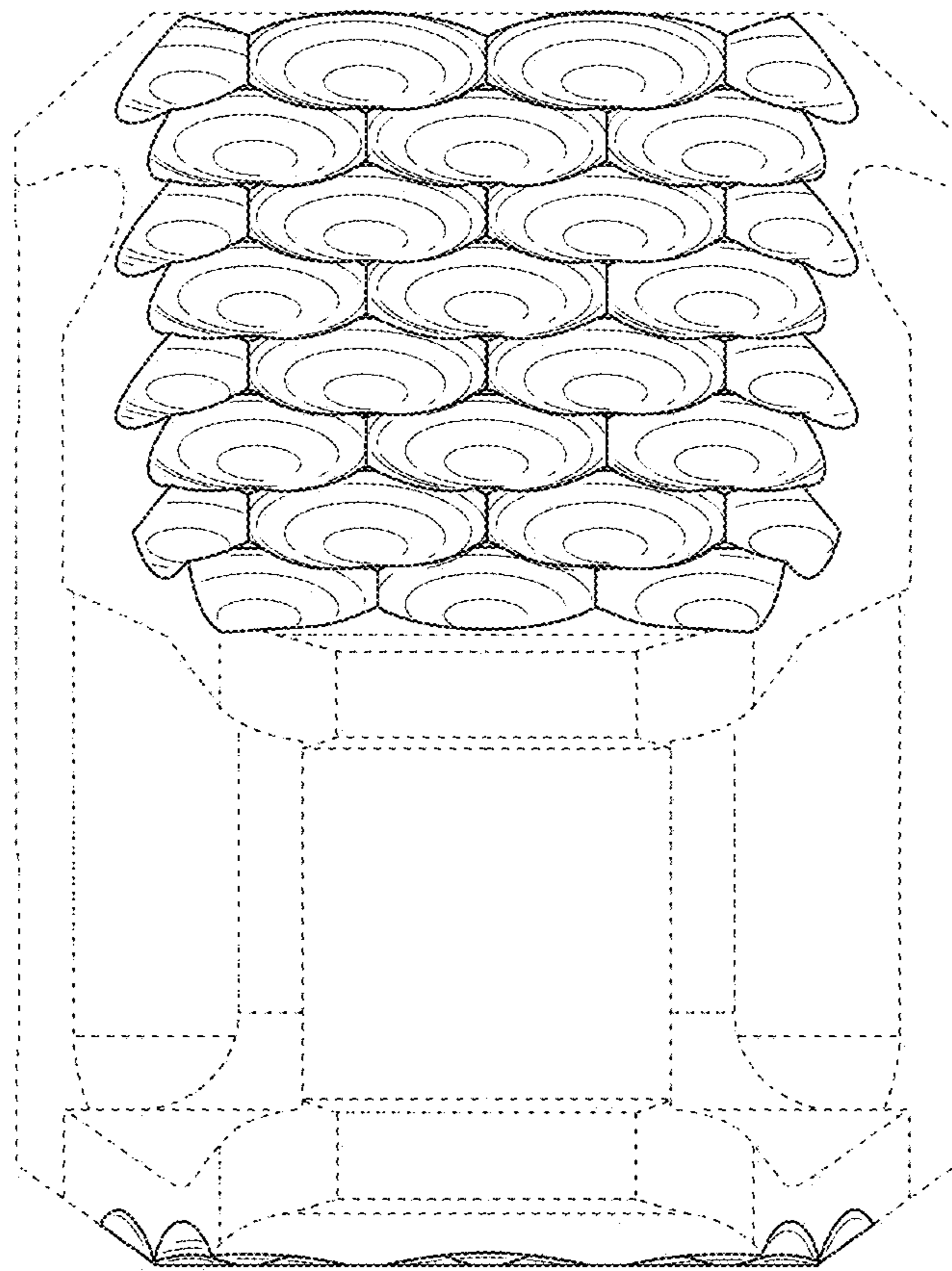

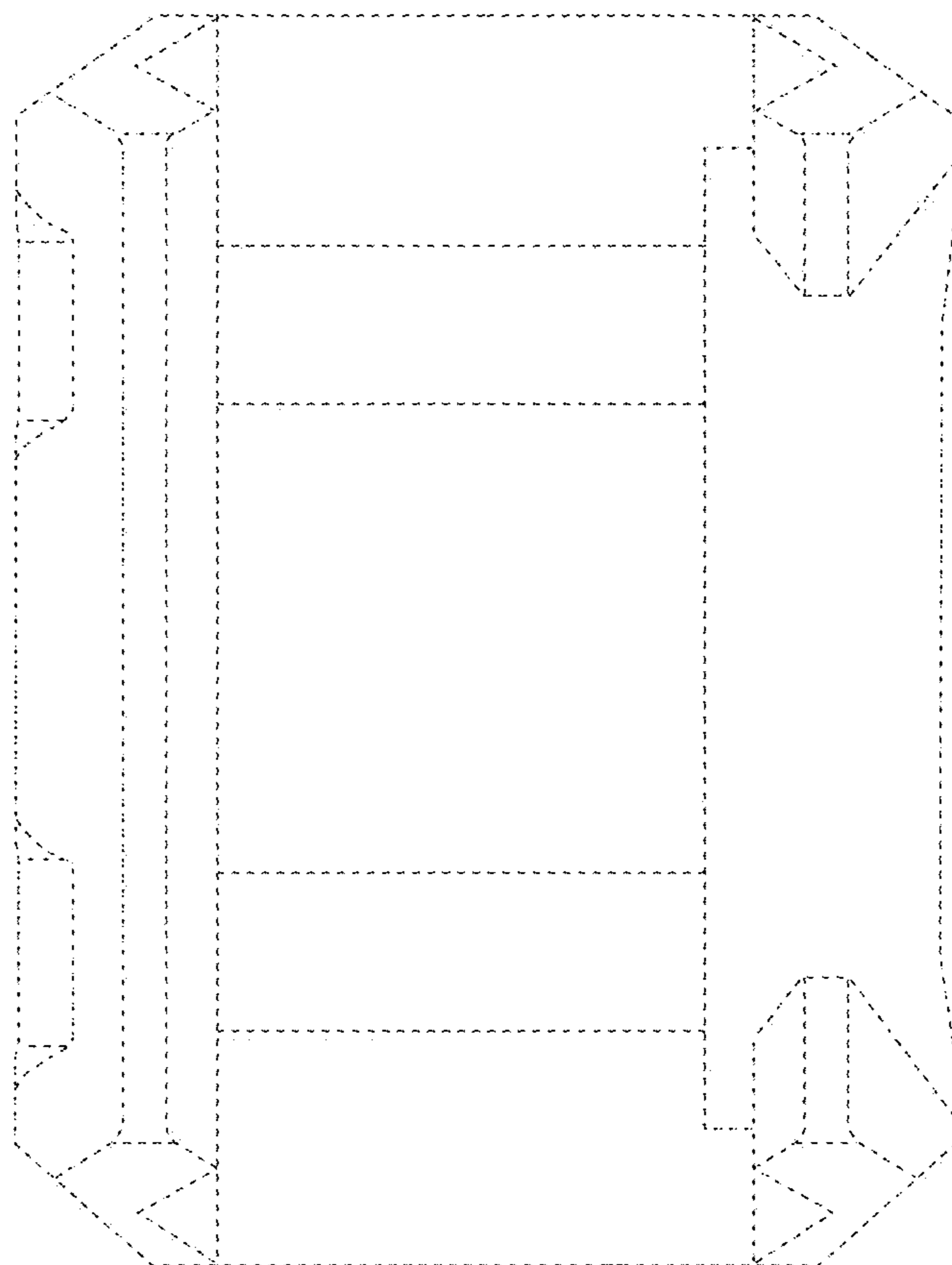

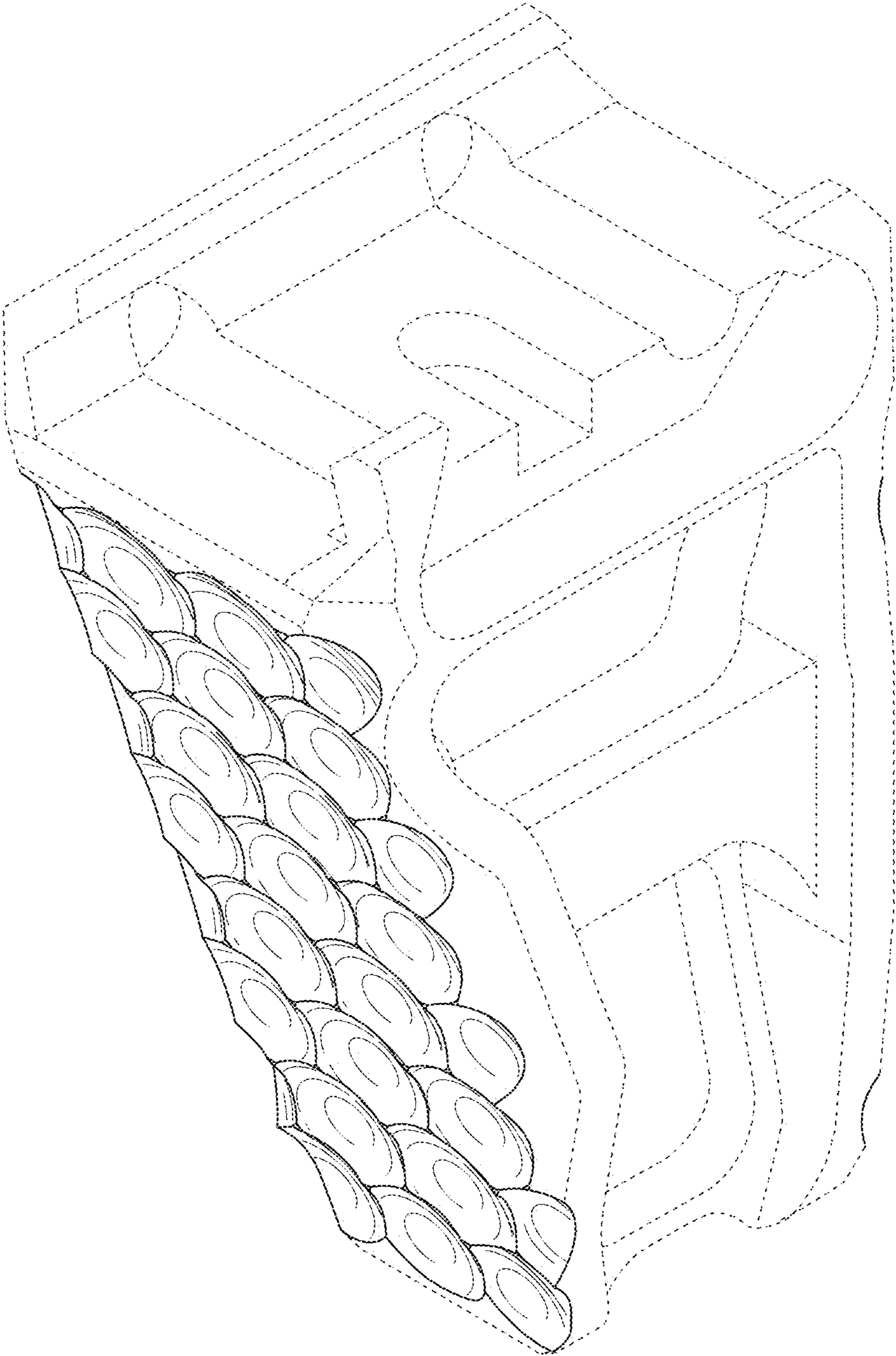

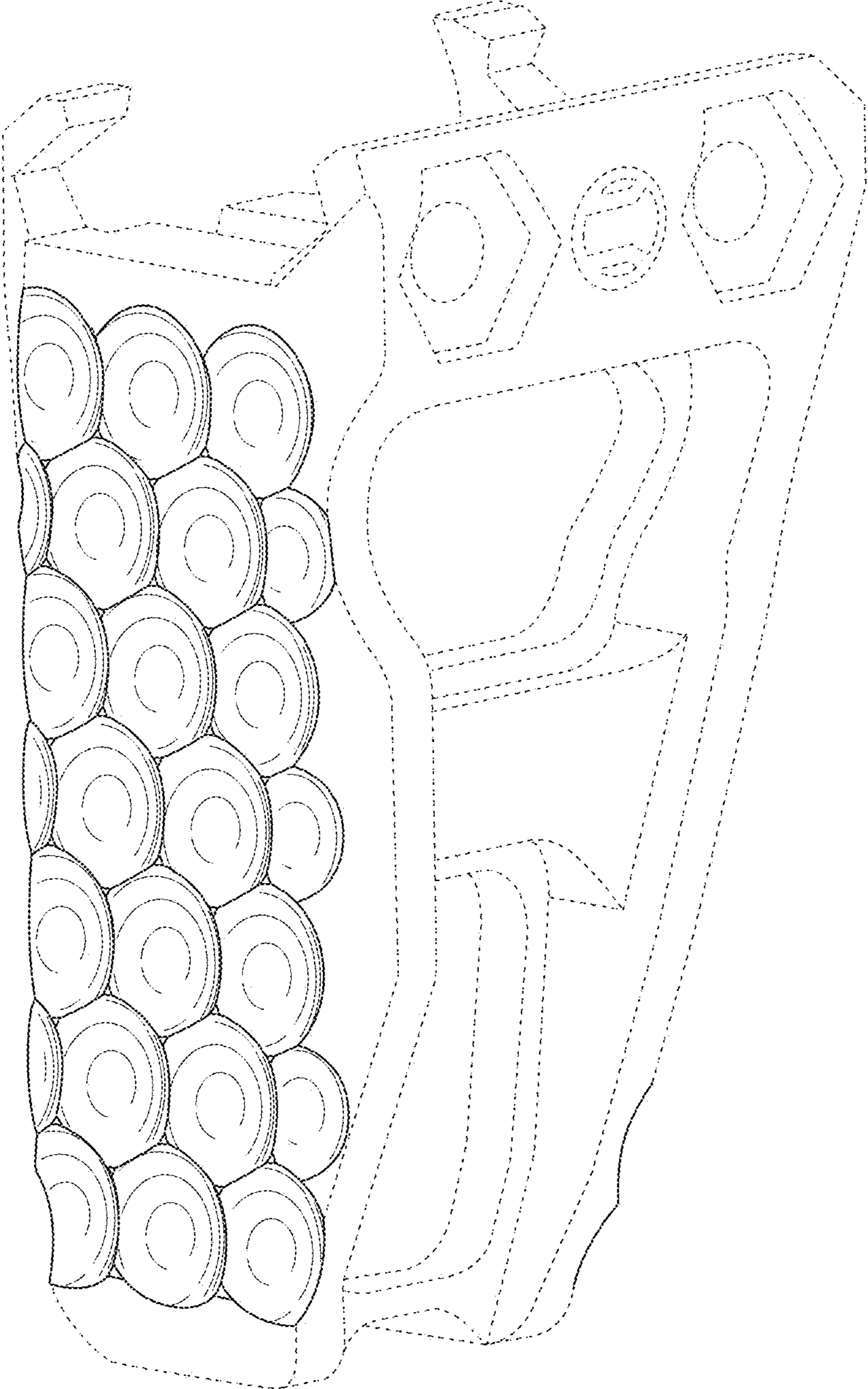

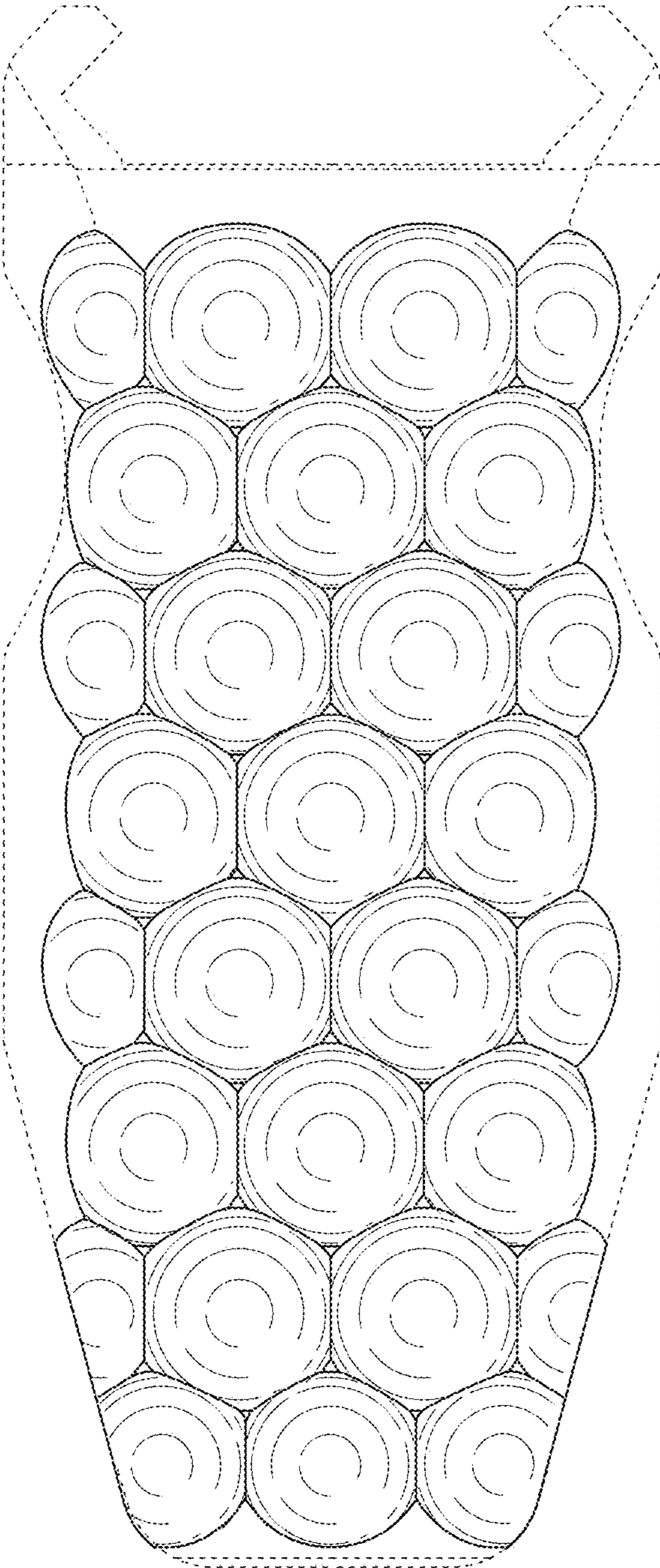

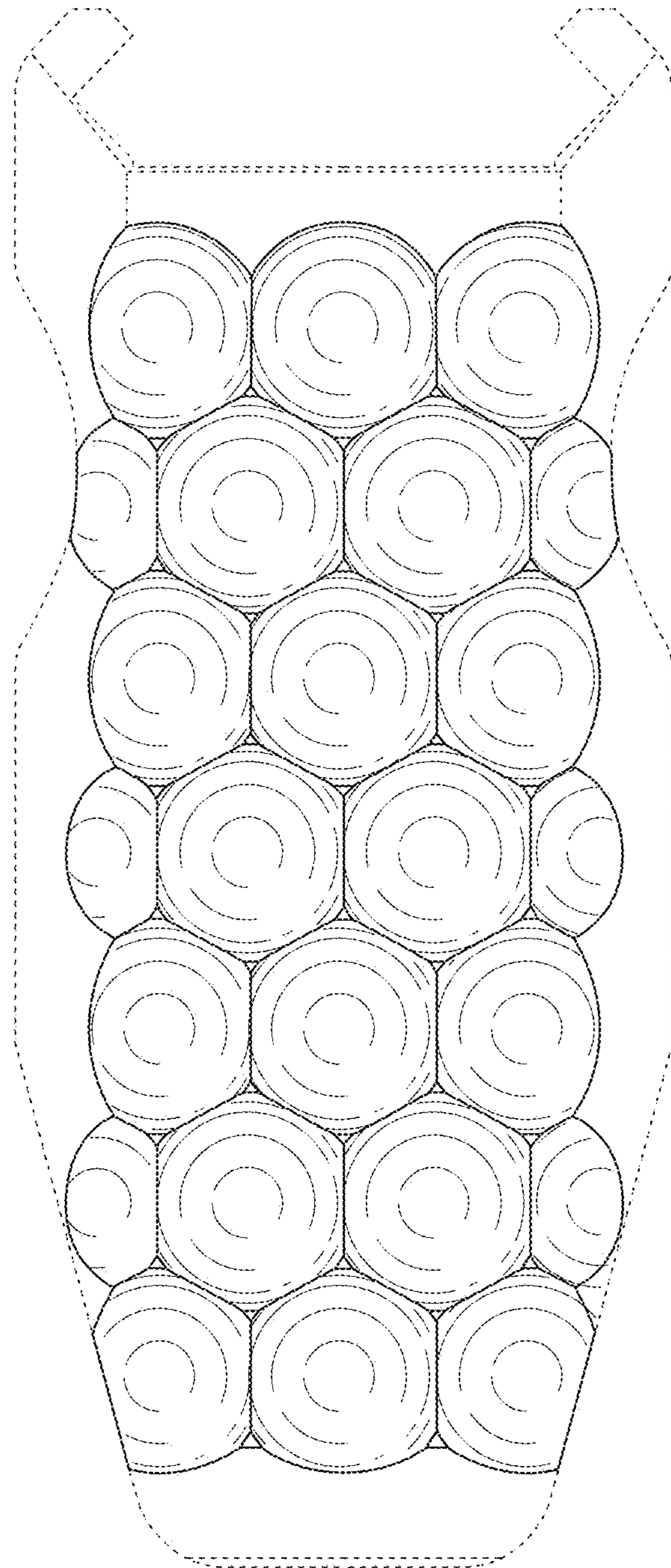

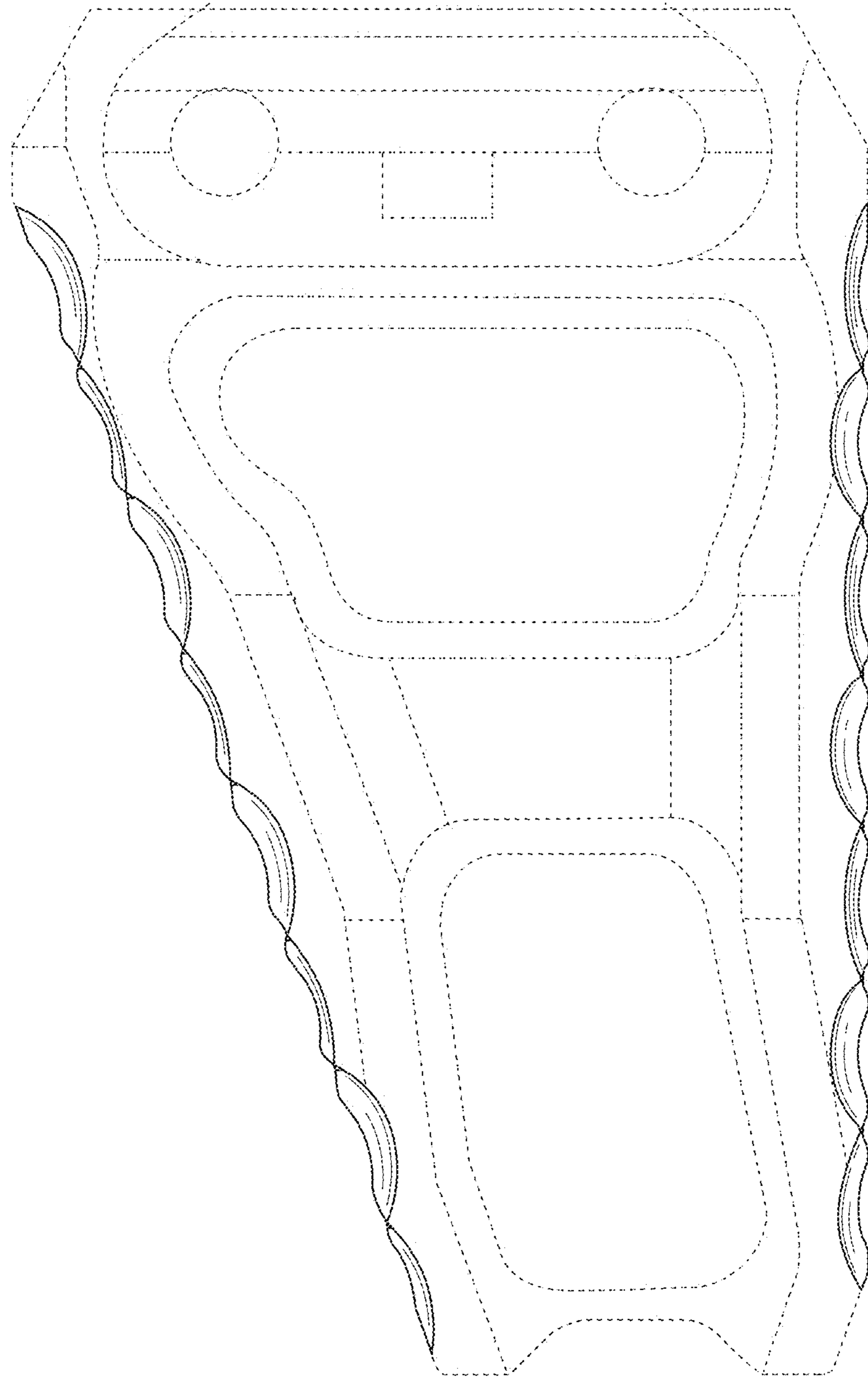

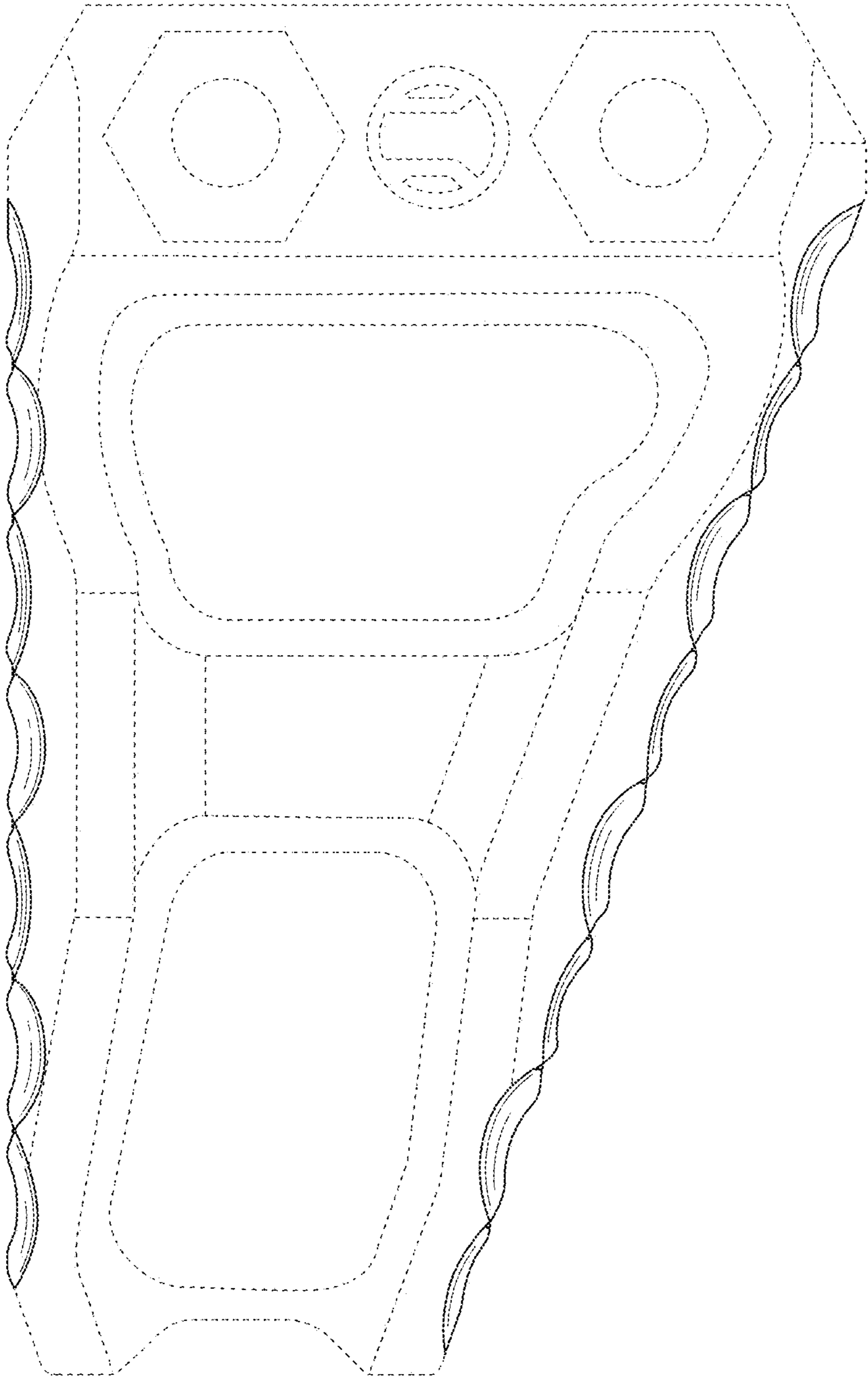

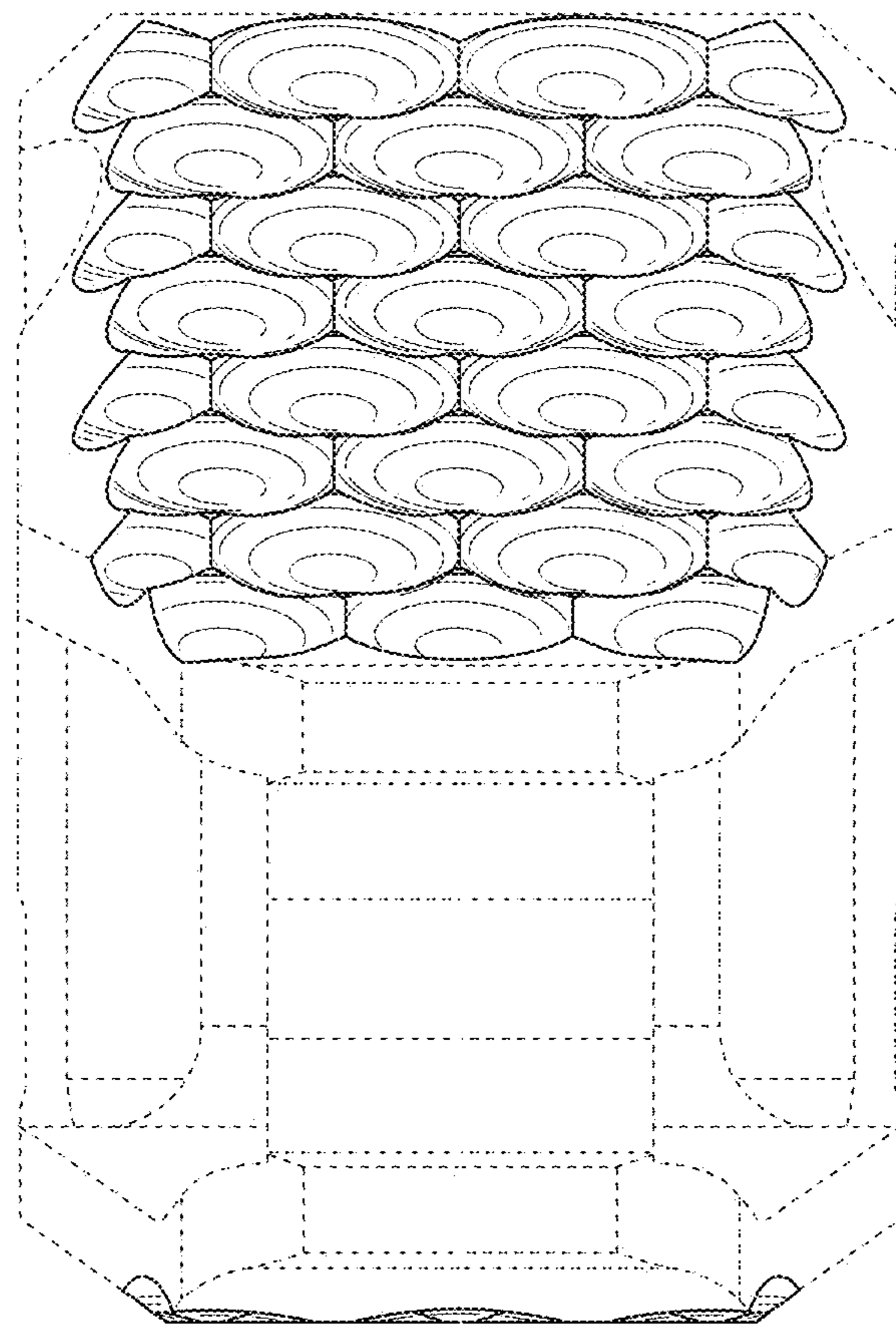

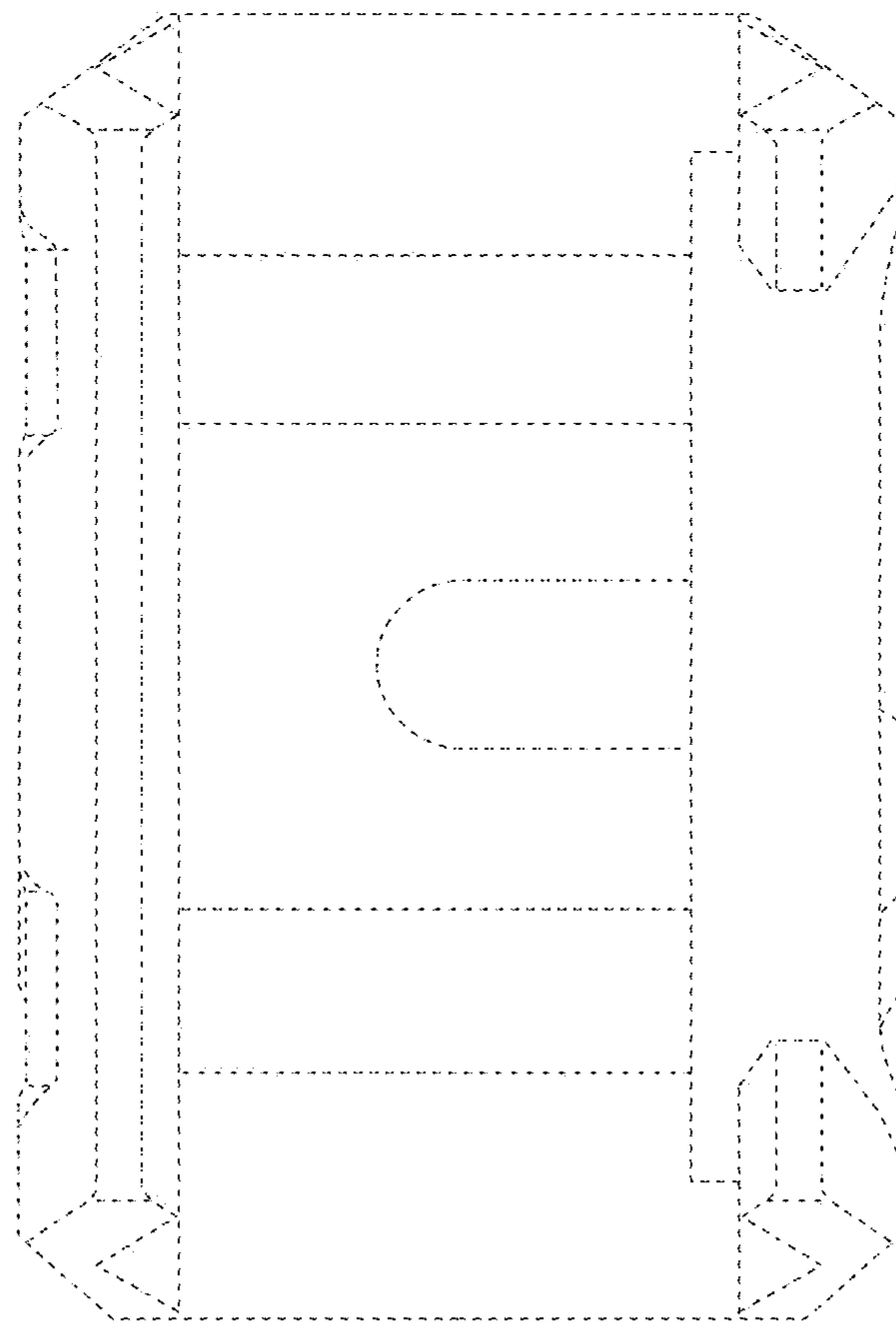
