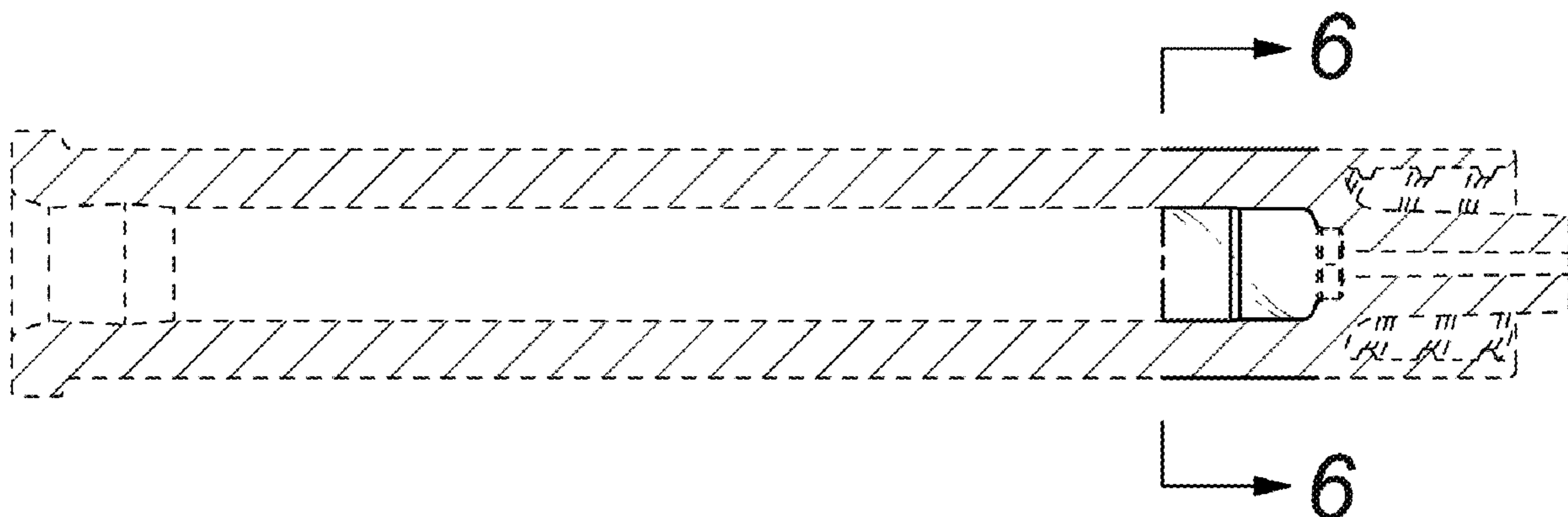
(57) **CLAIM**

The ornamental design for a medical syringe, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a medical syringe showing our new design, the rear view being a mirror image thereof;
FIG. 2 is a top view thereof, the bottom view being a mirror image thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a cross sectional view of a portion defined by lines 5-5 shown in FIG. 1;
FIG. 6 is an enlarged cross sectional view of a portion defined by lines 6-6 shown in FIG. 5; and,
FIG. 7 is a front reference view of the medical syringe showing thickness of transparent body.
In the drawings, the broken lines depict environmental subject matter only and form no part of the claimed design. The dot and dashed lines represents a boundary between the claimed portion and the non-claimed portion.

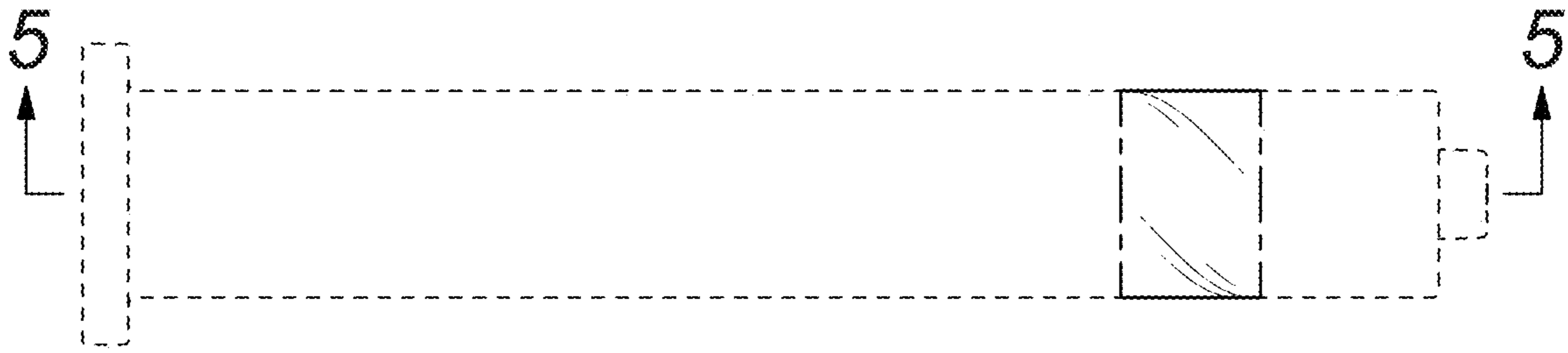

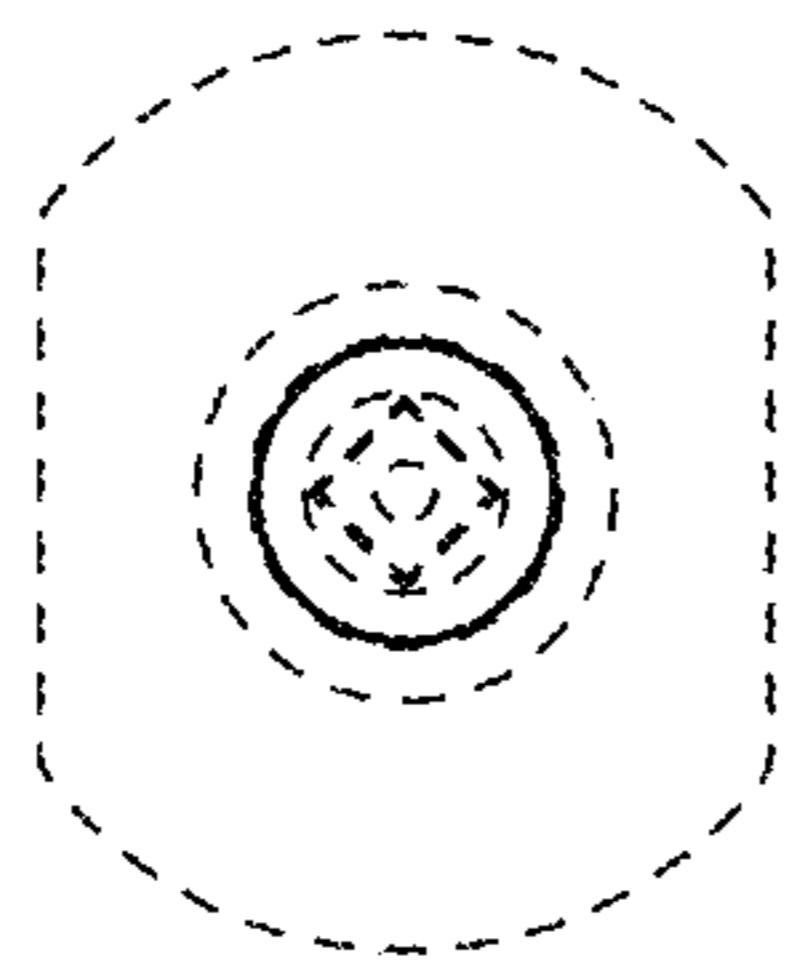

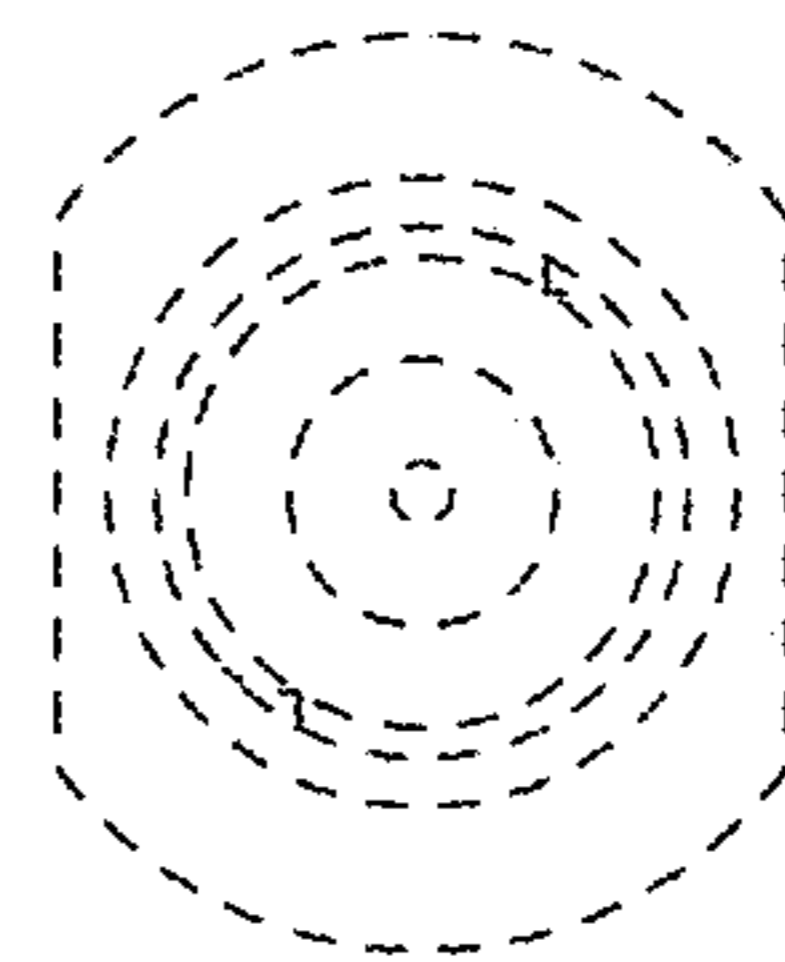

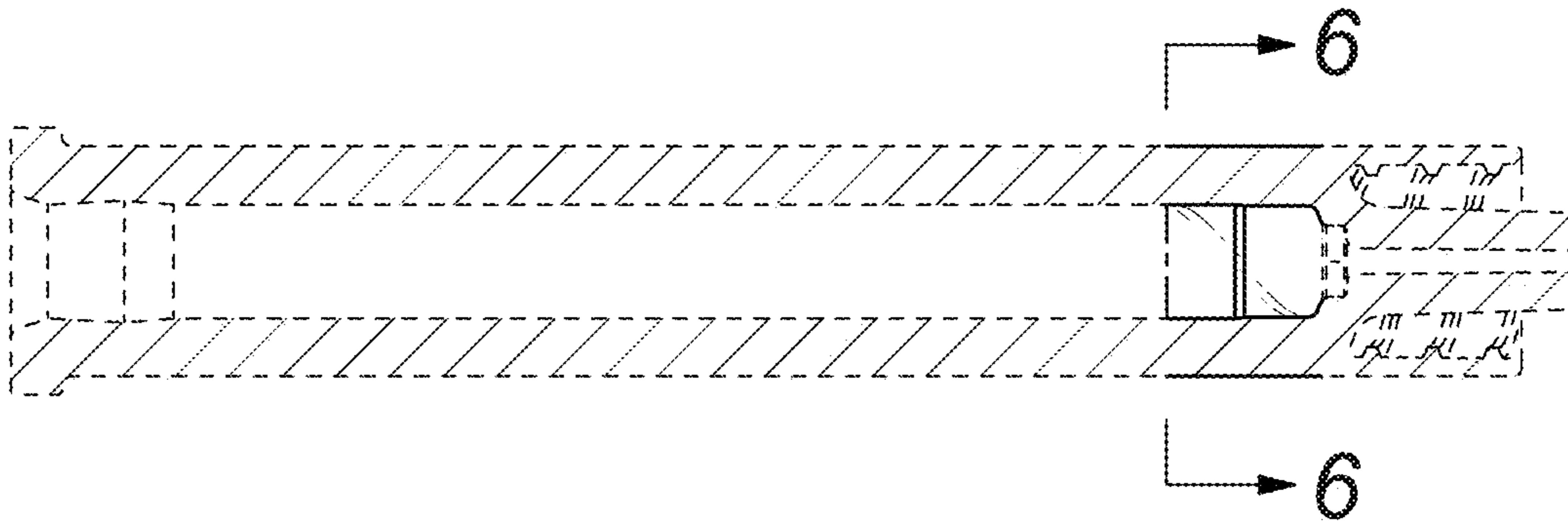

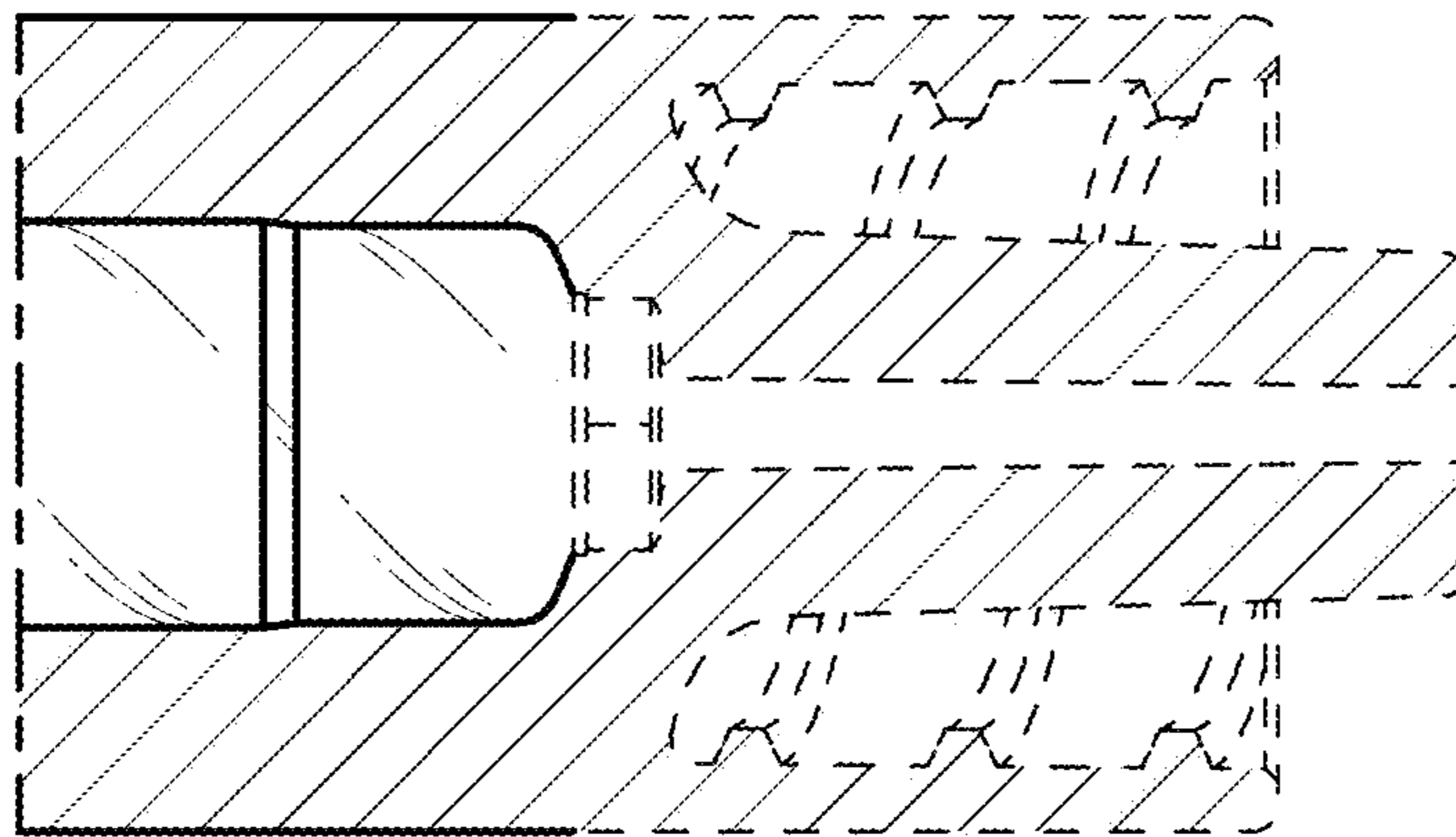

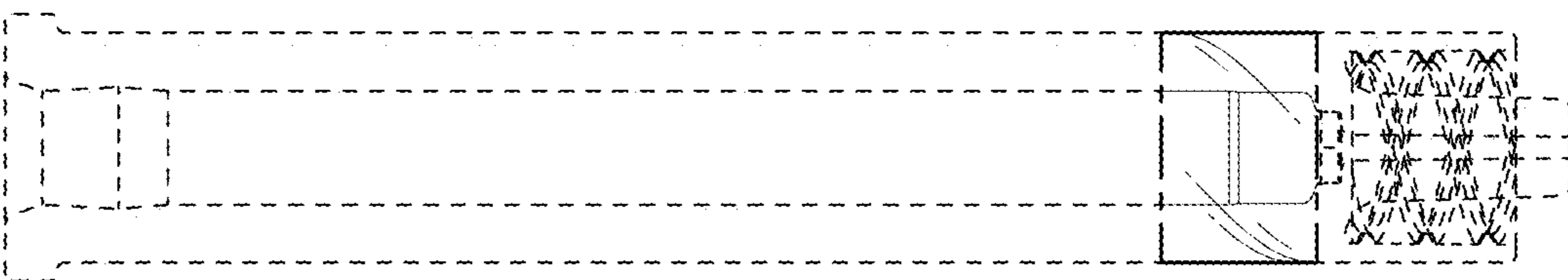
