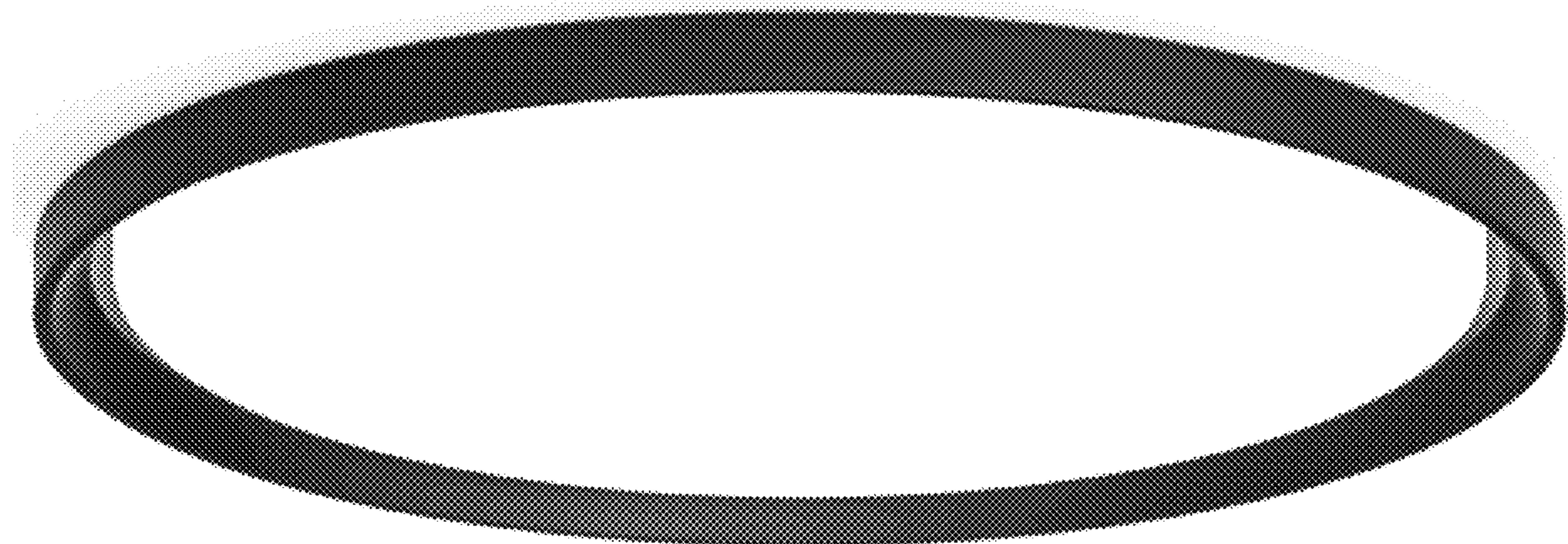
(57) **CLAIM**

The ornamental design for a ceiling lamp, as shown and described.

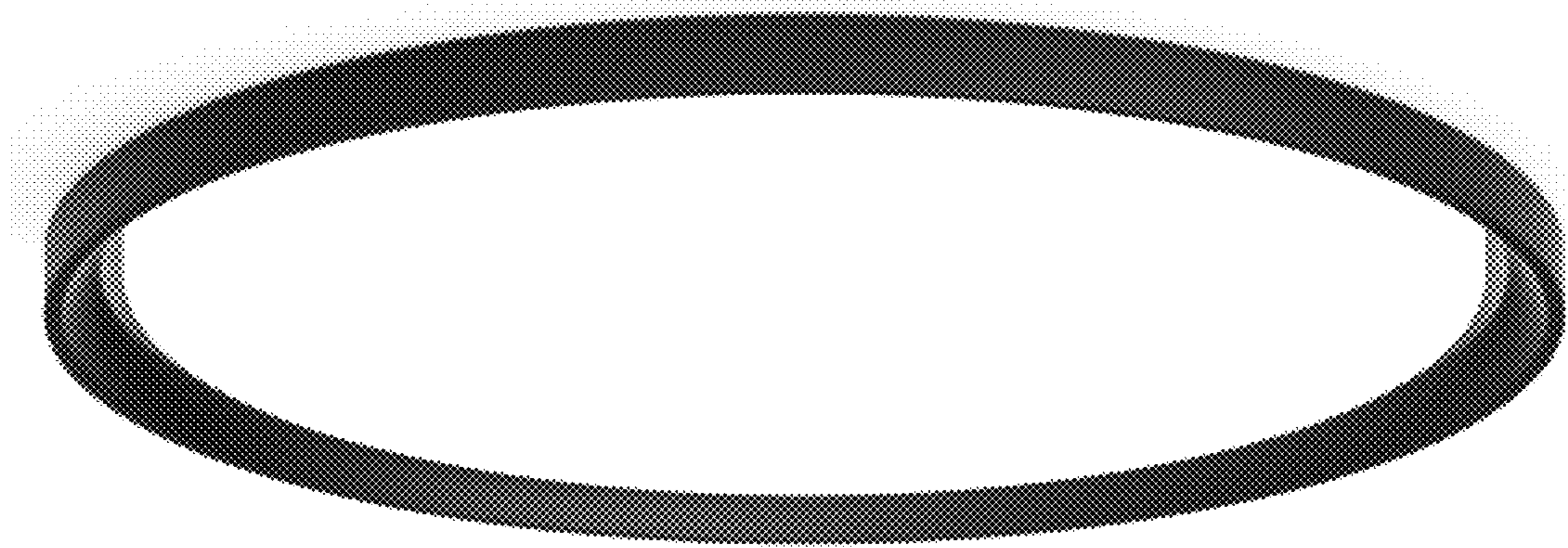
**DESCRIPTION**

Figure **3.0** is a front perspective view of a third embodiment of a ceiling lamp.

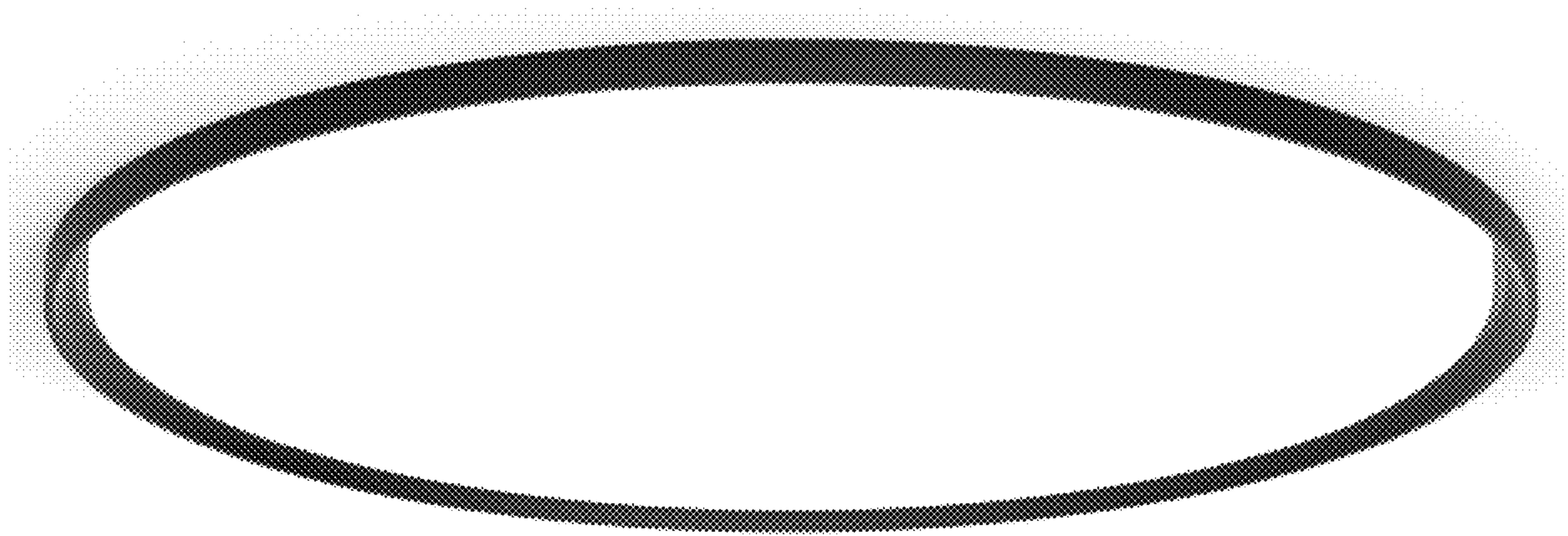
