FIG. 8 is a bottom plan view thereof.

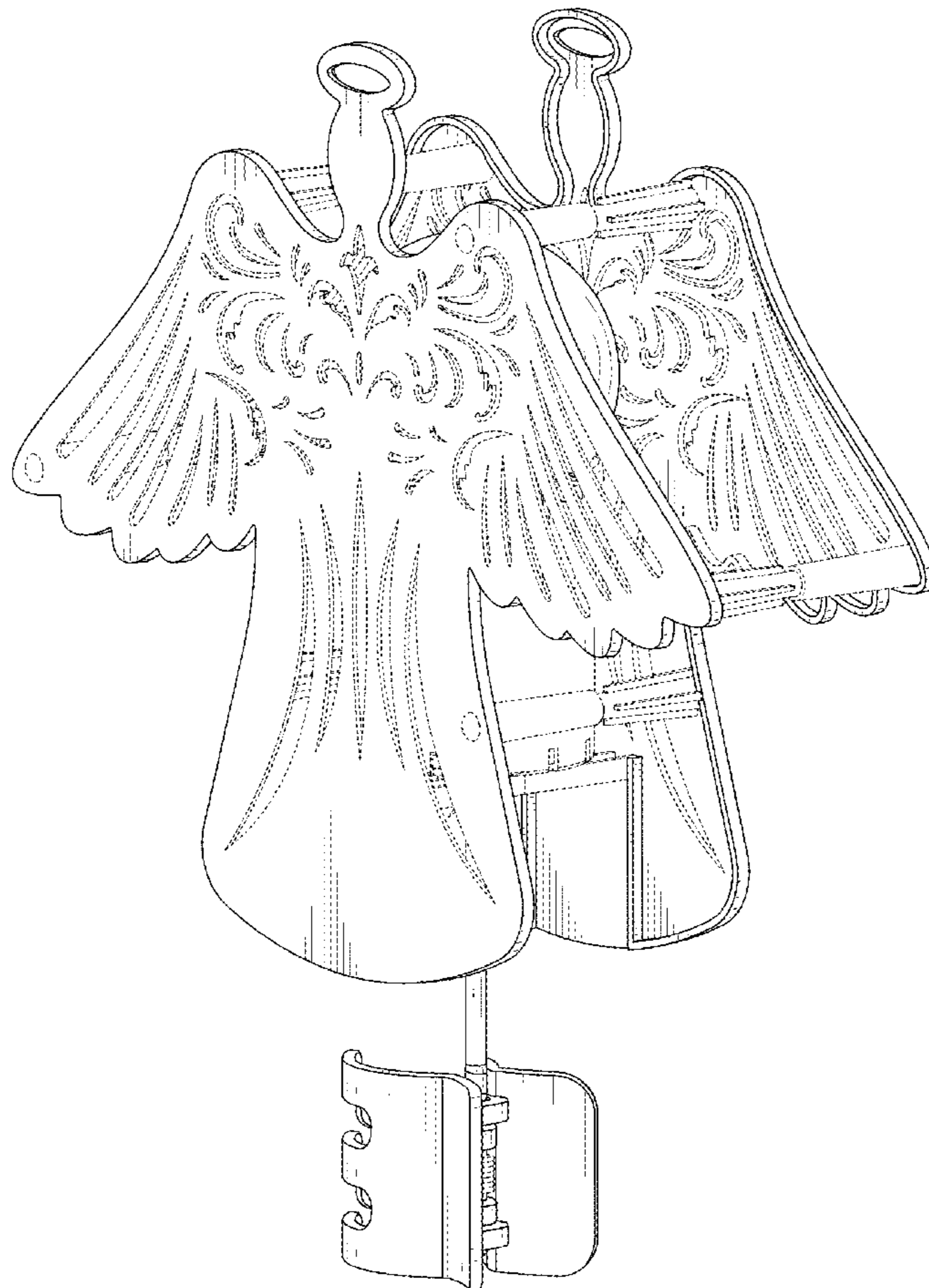
The broken lines in the figures illustrate portions of the angel-shaped lamp that form no part of the claimed design.

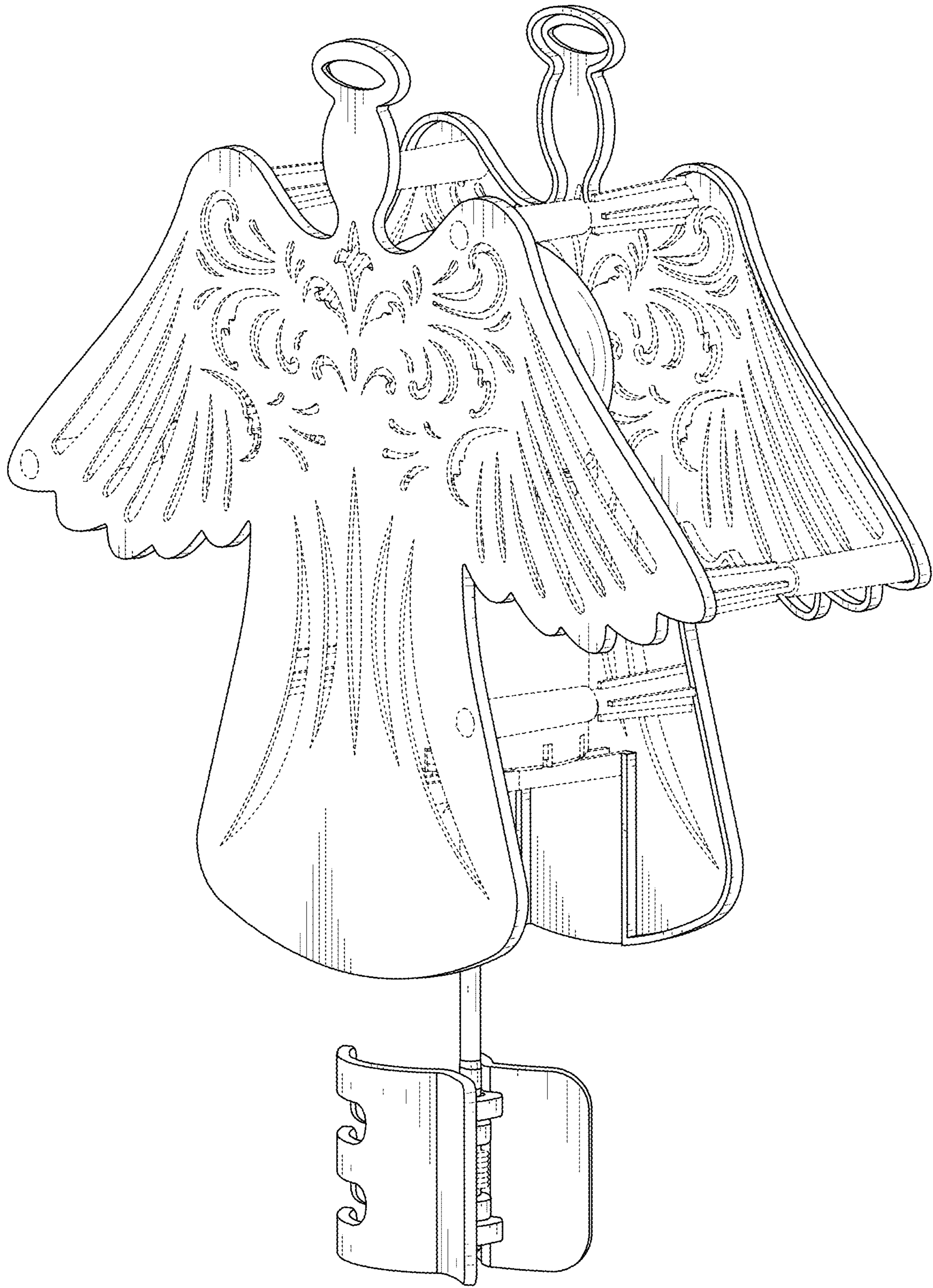

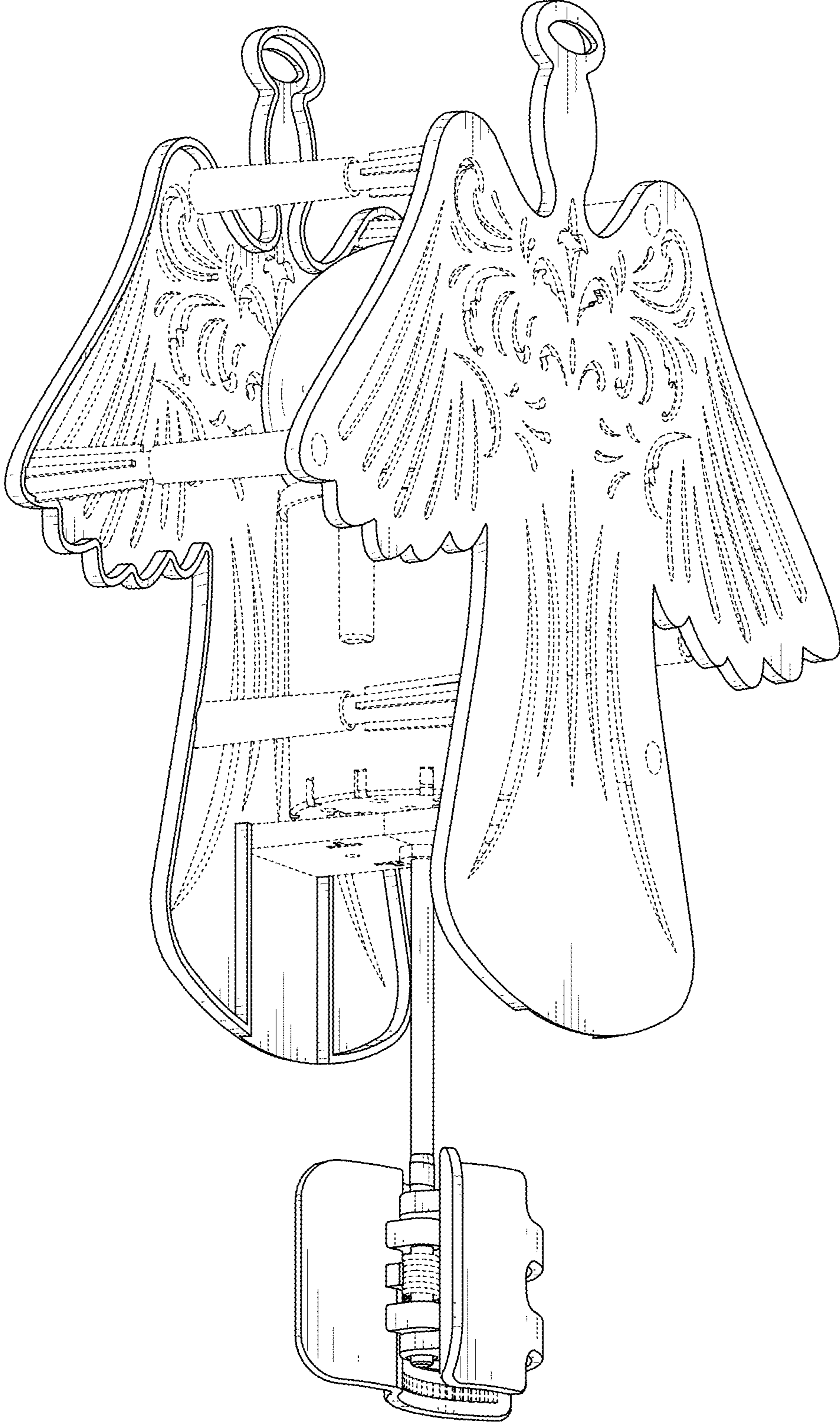

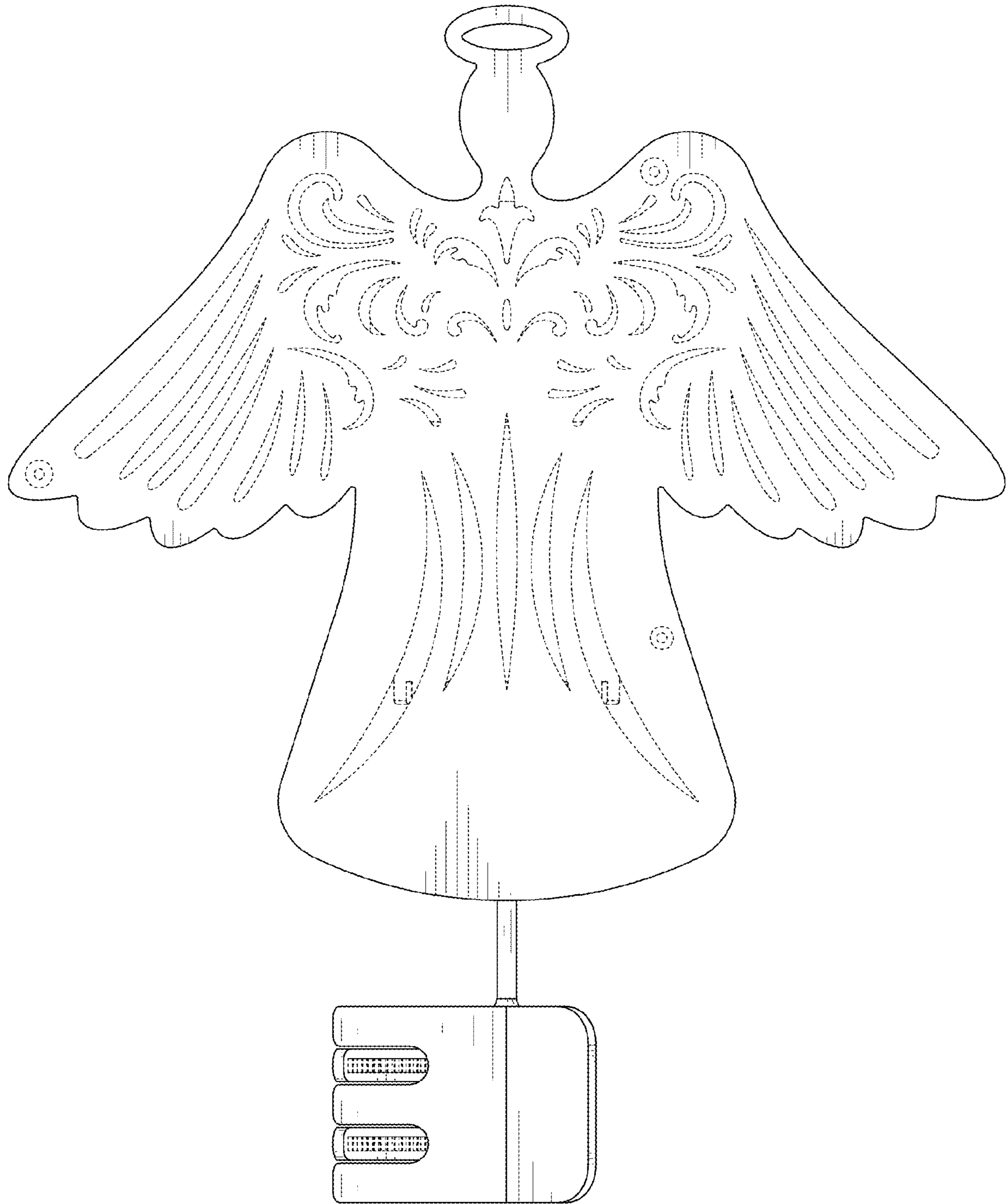

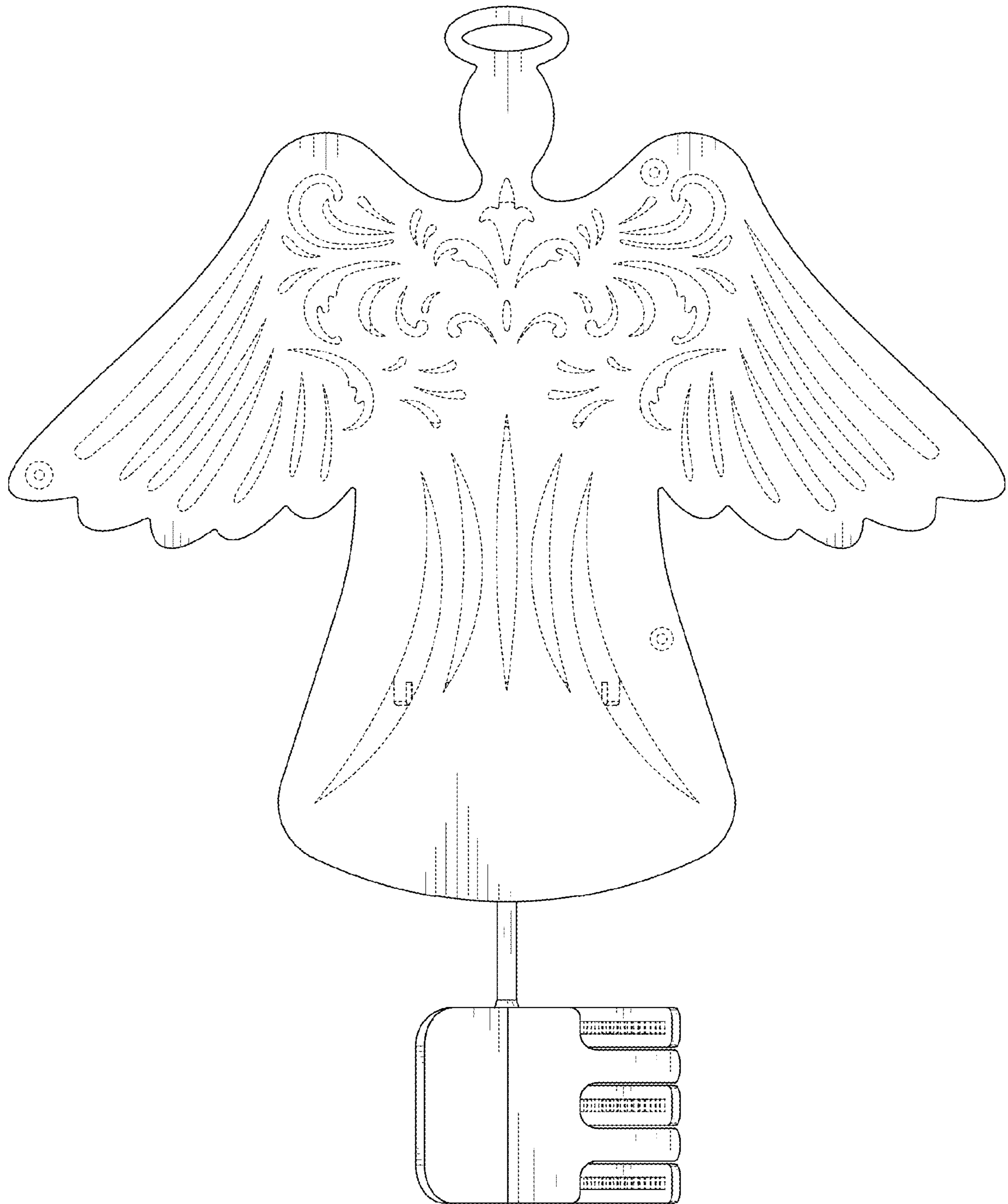

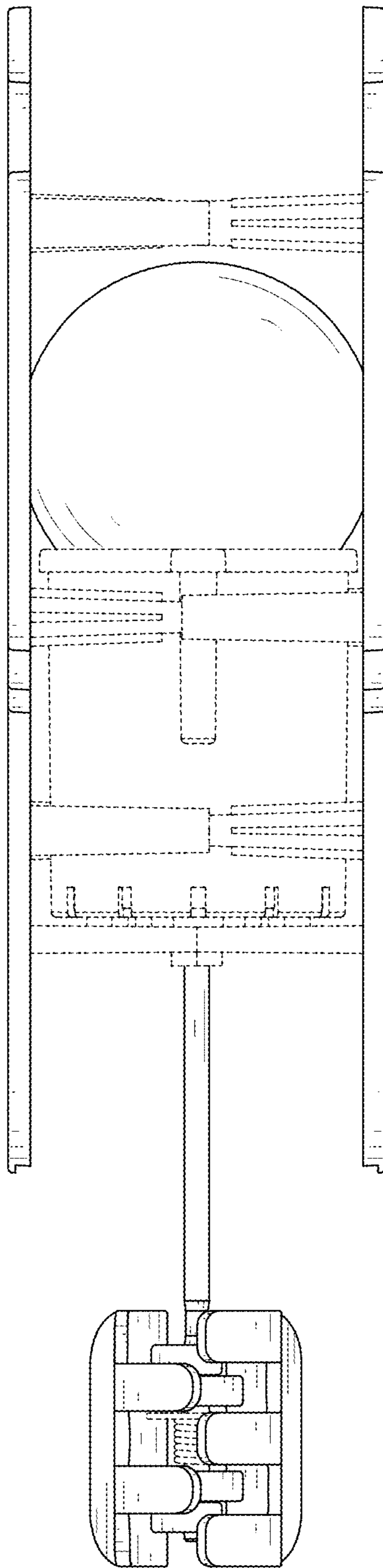

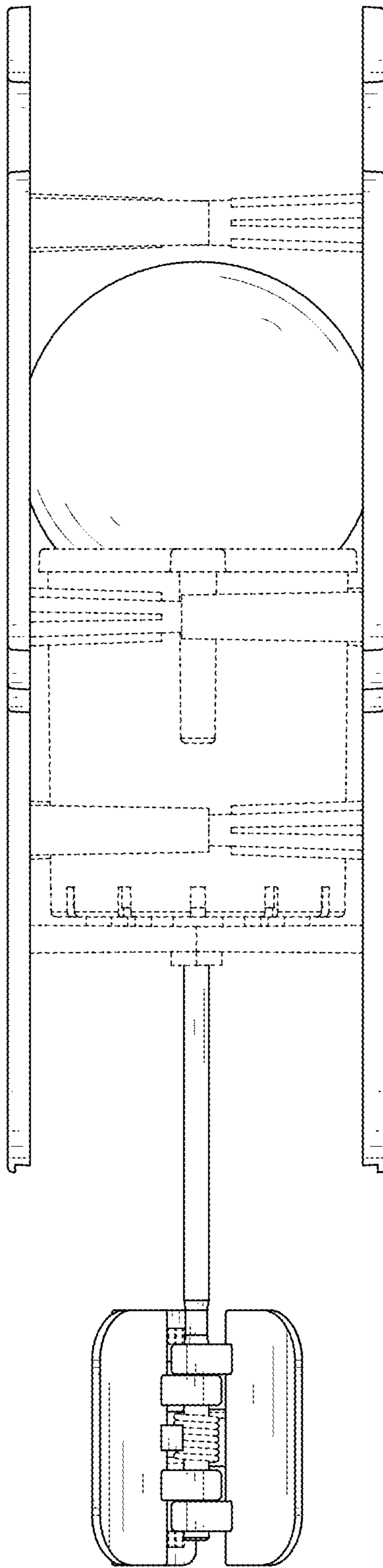

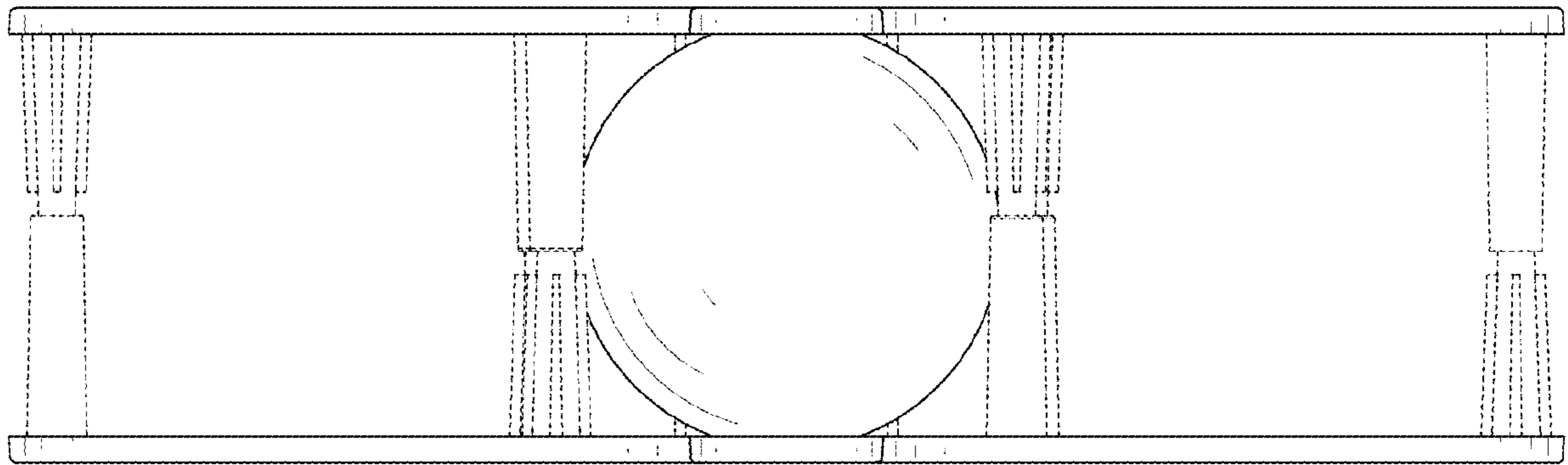

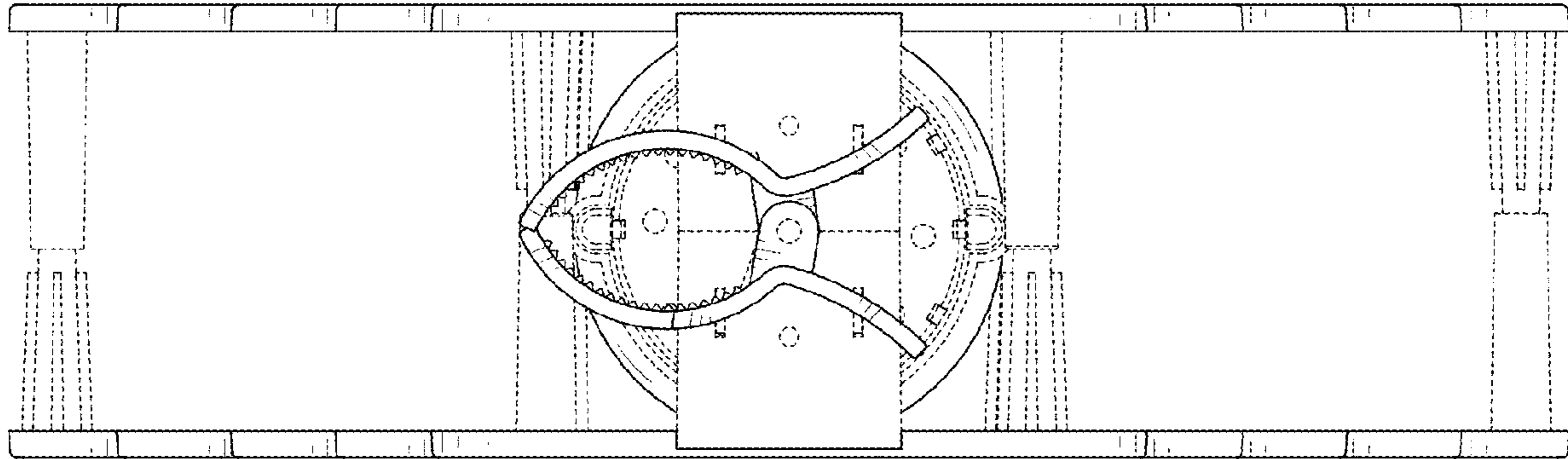
