DESCRIPTION

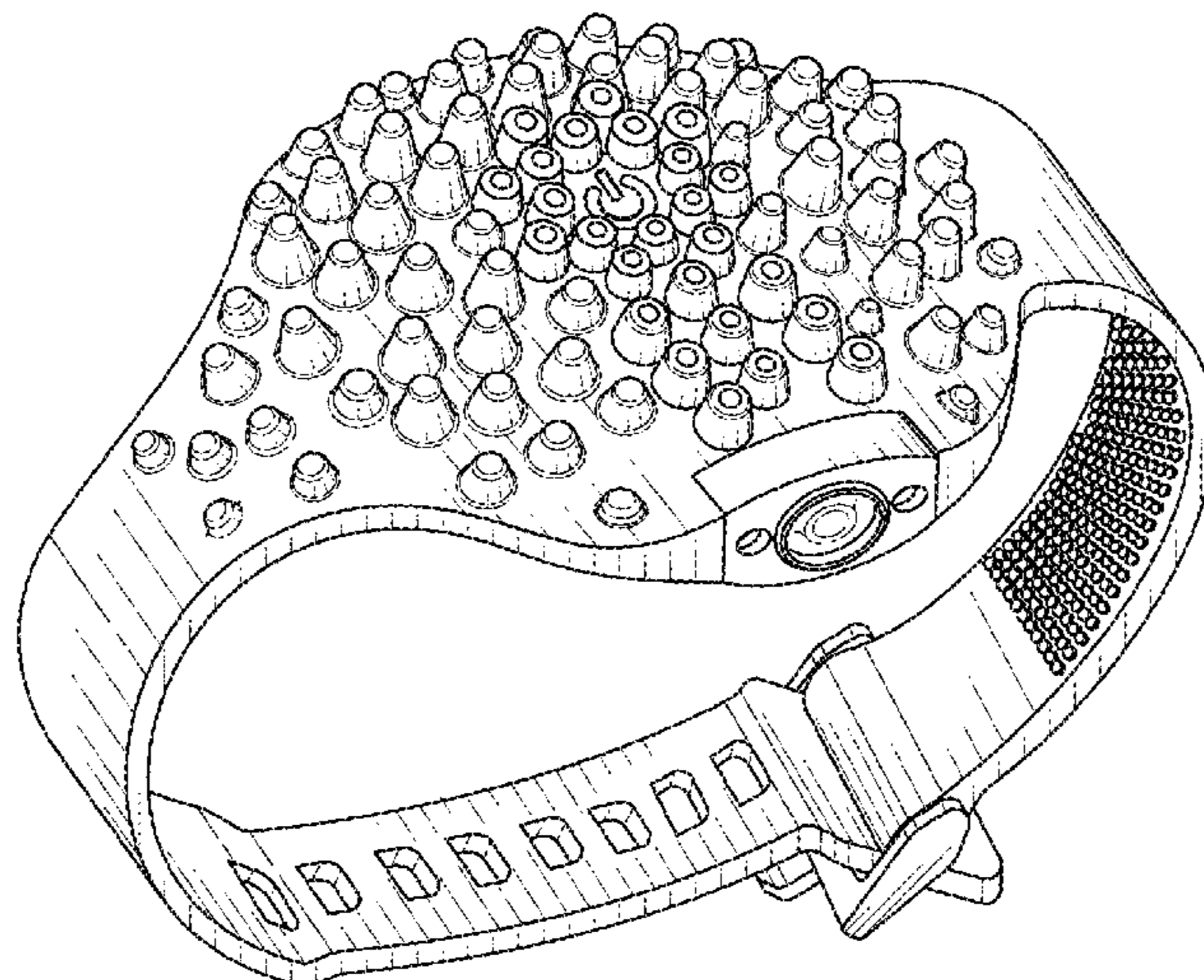
FIG. 1 is an isometric view of a handheld pet washing device in accordance with the present design;

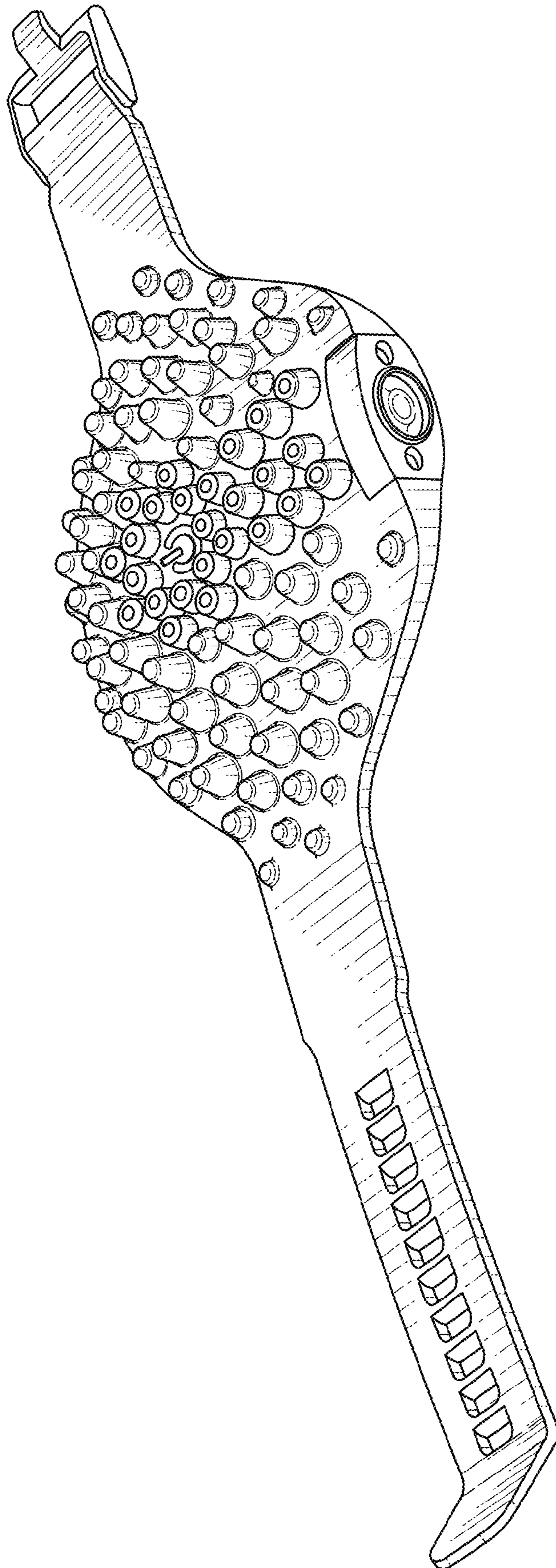

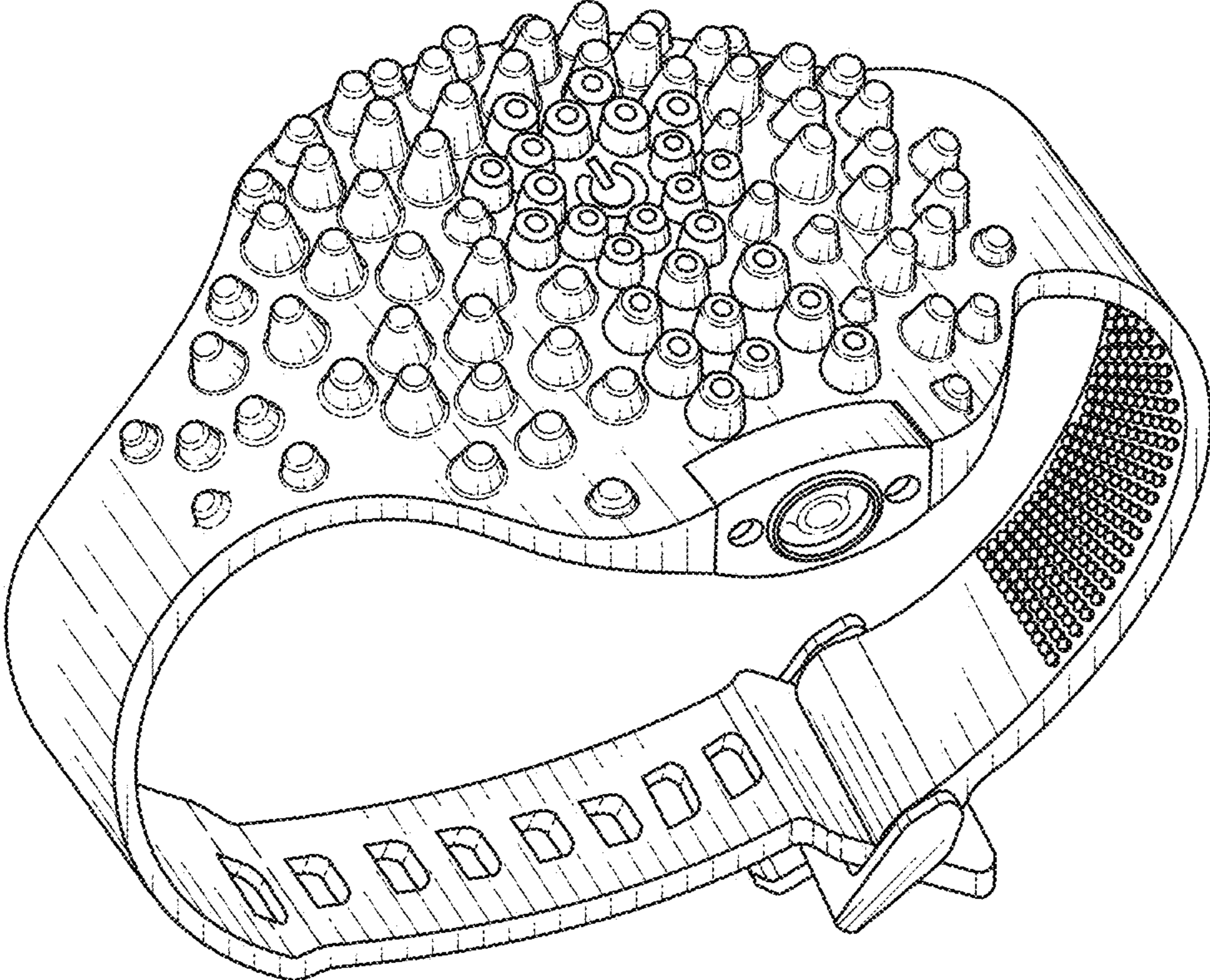

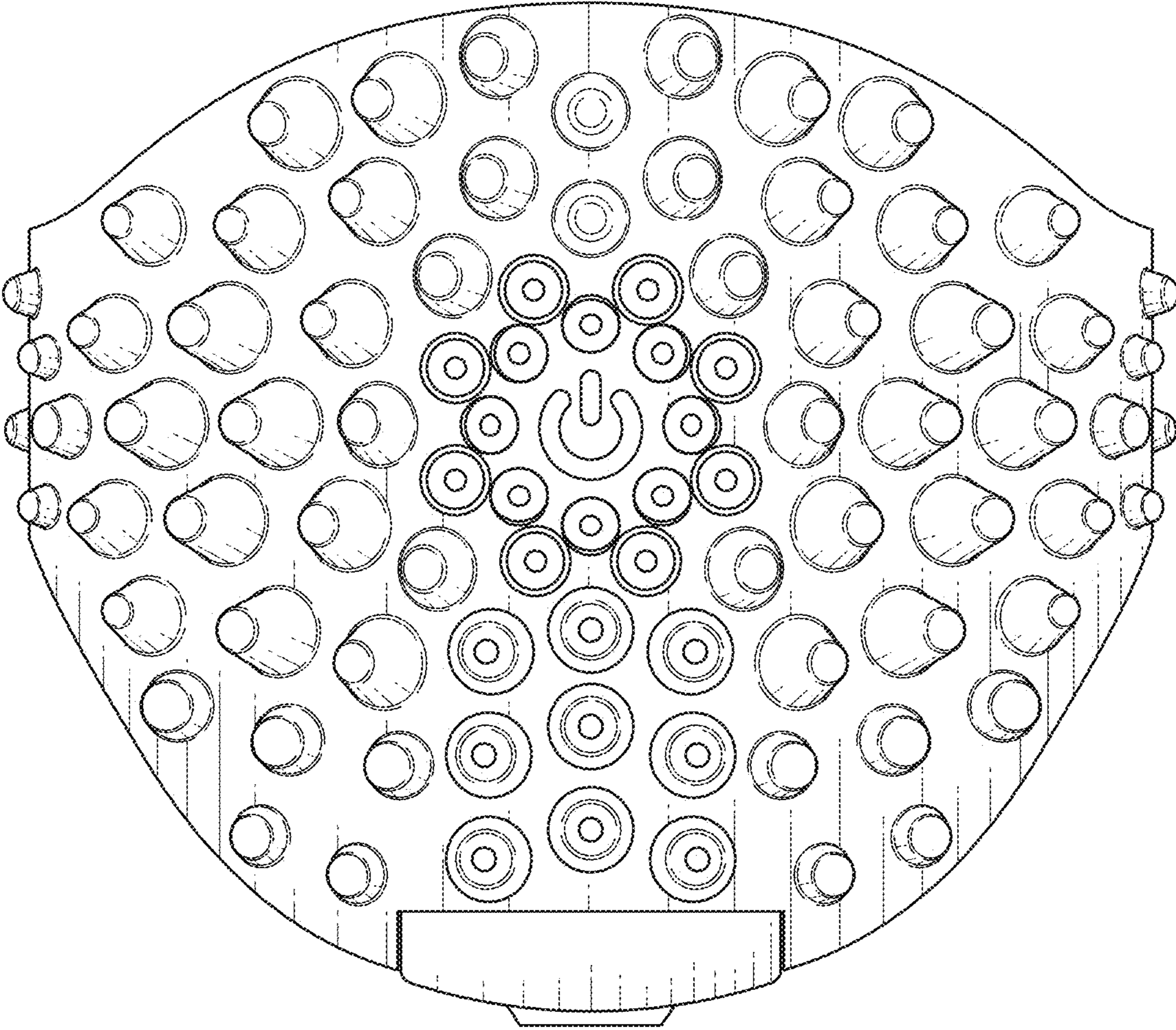

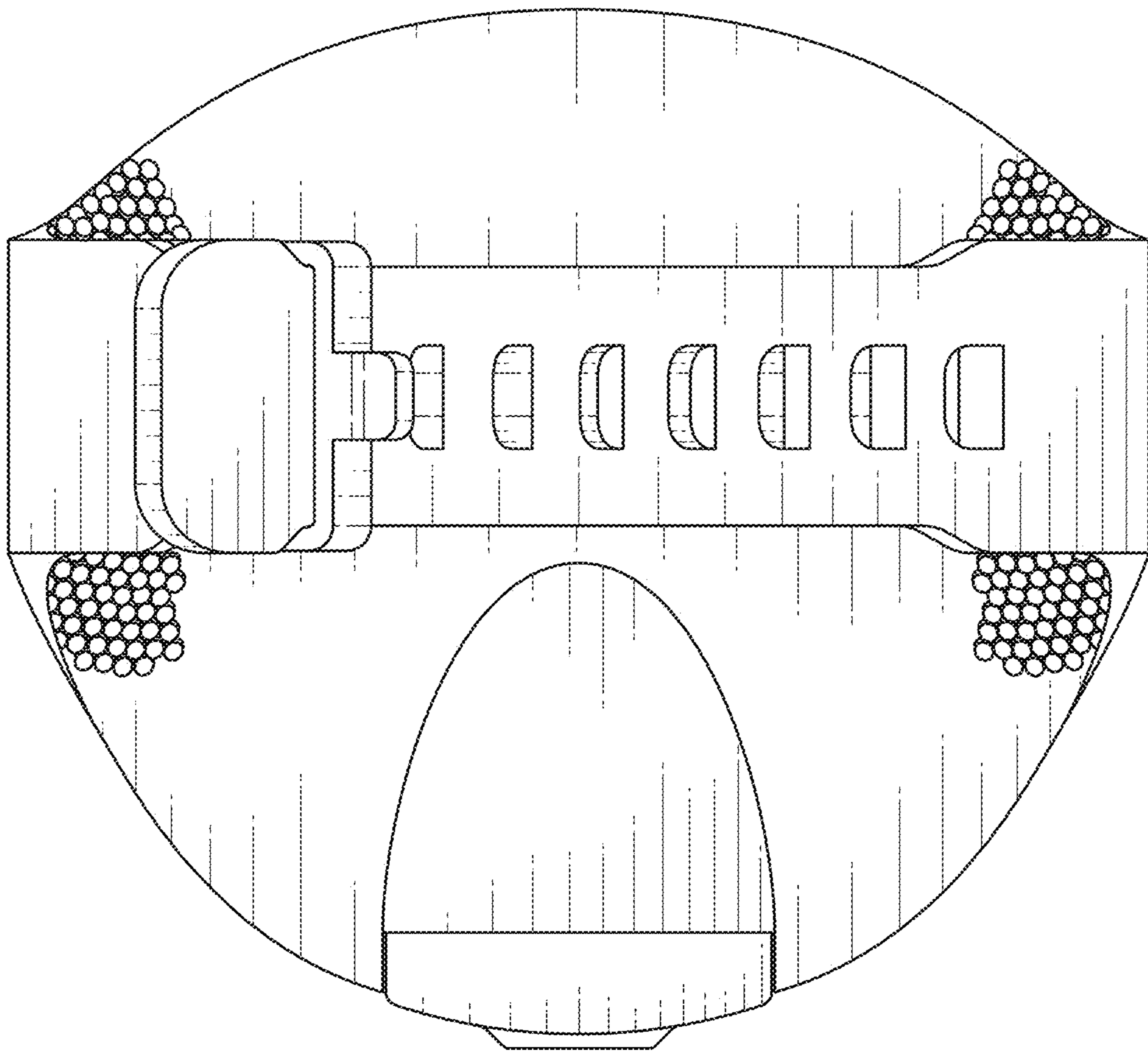

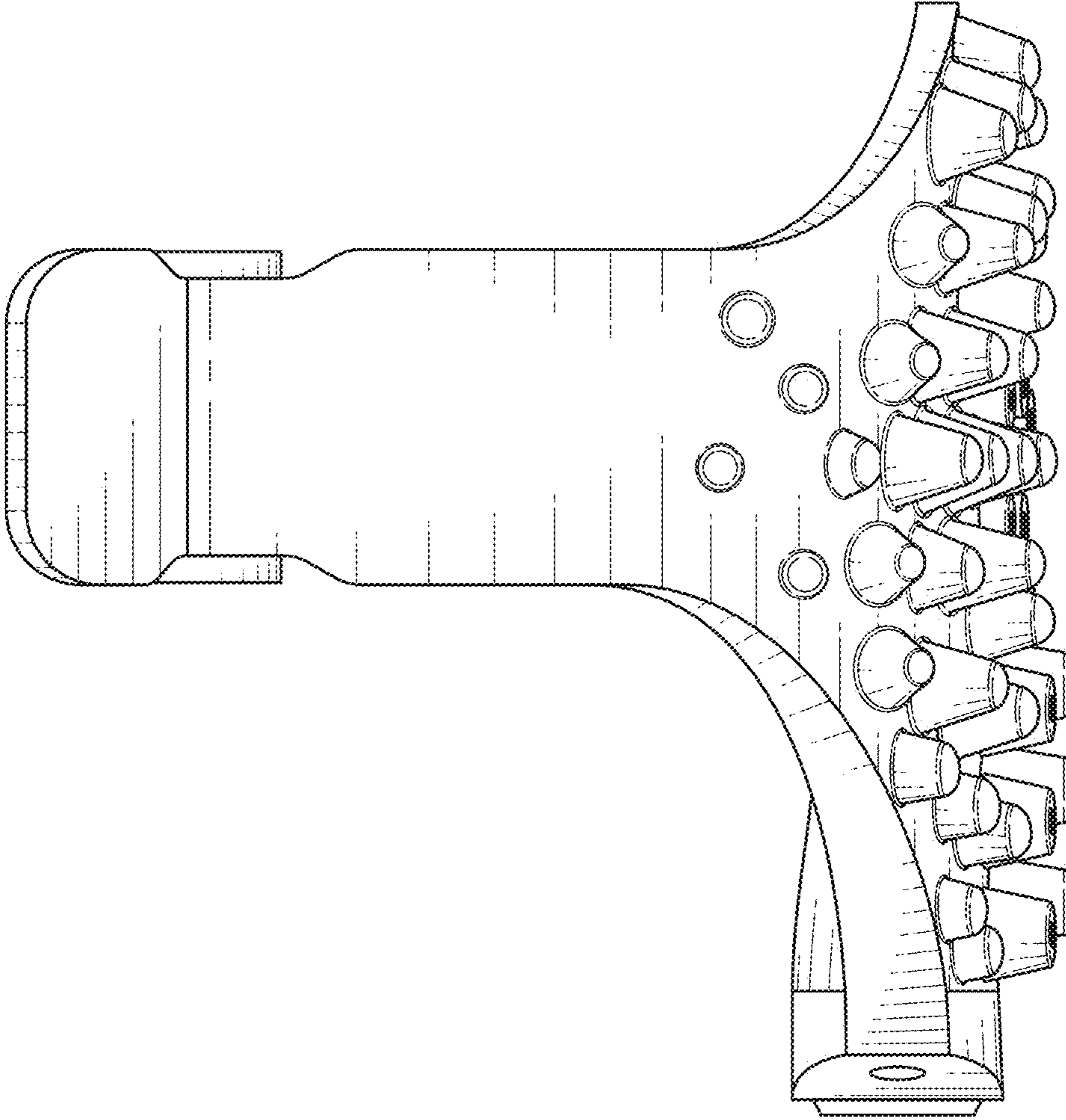

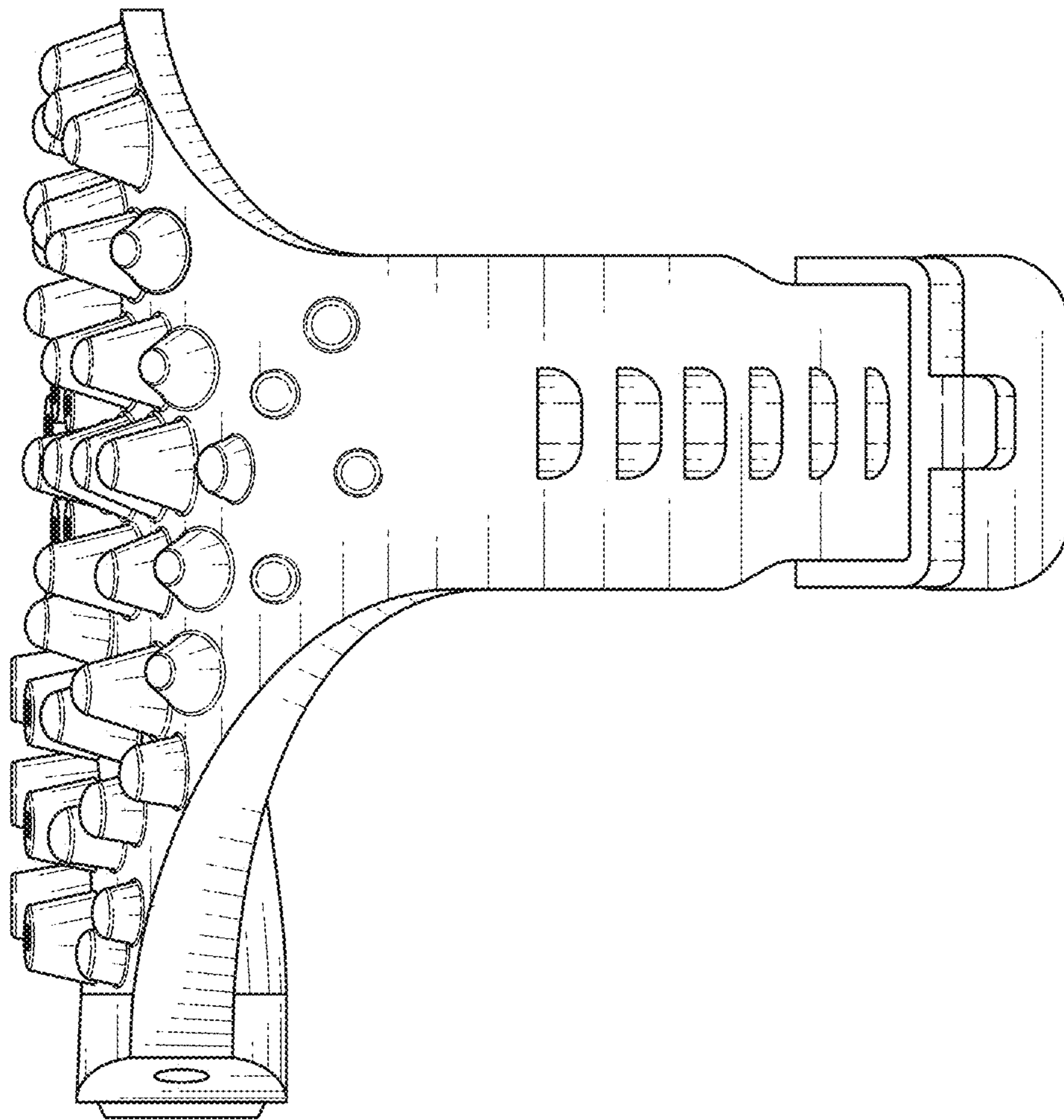

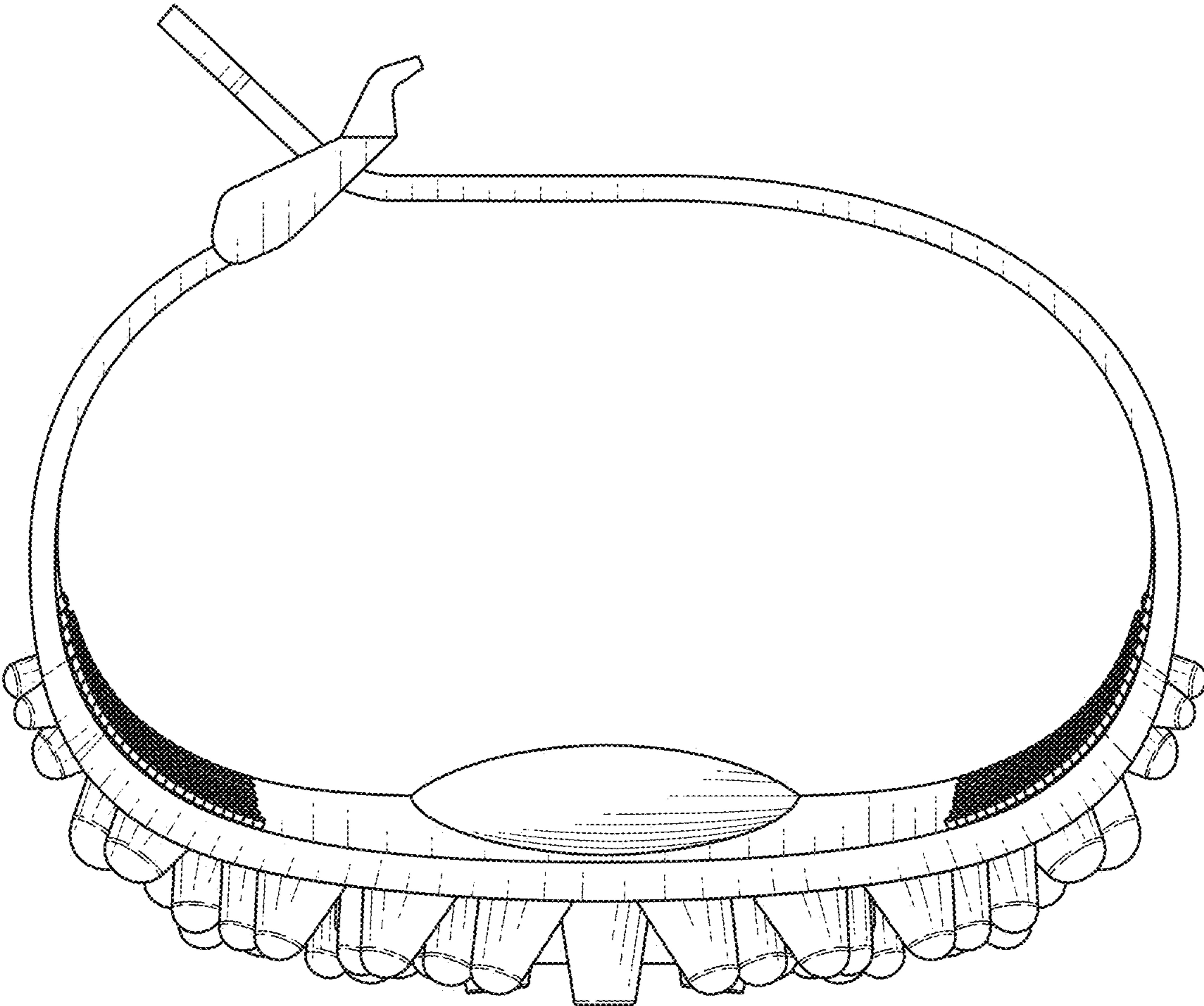

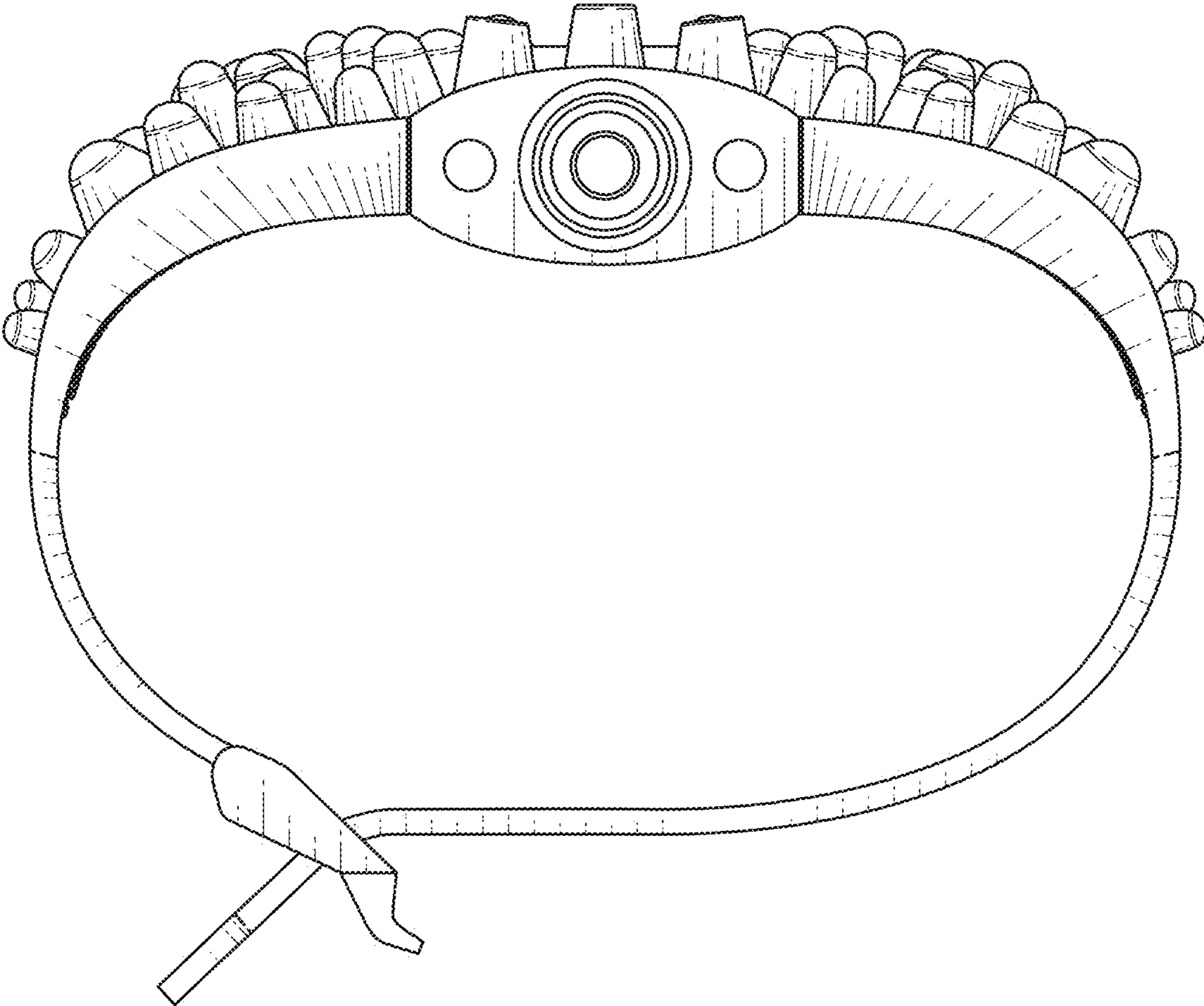
