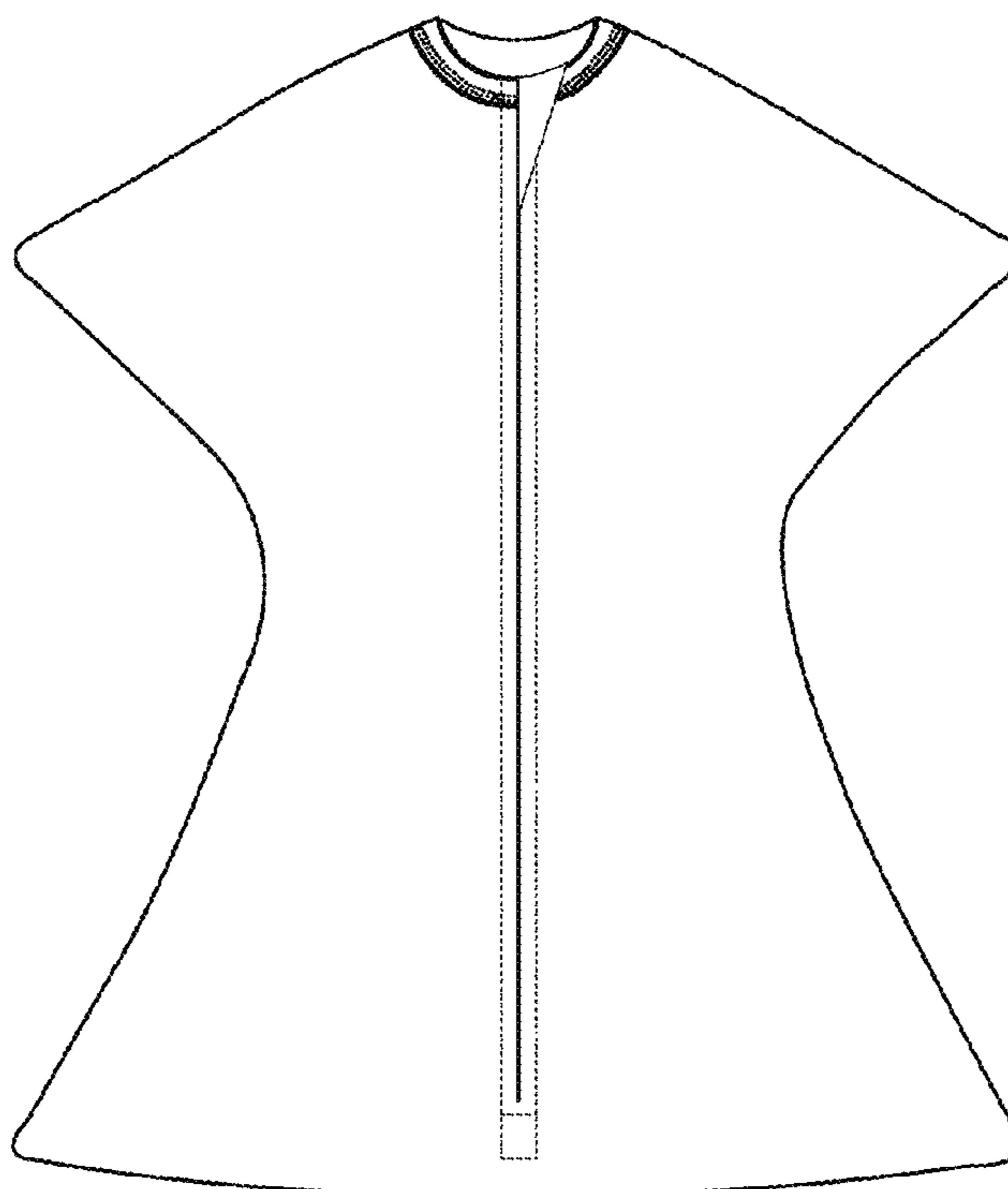
(57) **CLAIM**

The ornamental design for a star shaped one piece baby garment with zipper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front plan view of the star shaped one piece baby garment with zipper in accordance with my new design; FIG. 2 is a front plan view with zipper detail exposed; FIG. 3 is a front plan view with garment fully unzipped; FIG. 4 is a back plan view thereof; FIG. 5 is a bottom perspective view thereof; and, FIG. 6 is a top perspective view thereof.

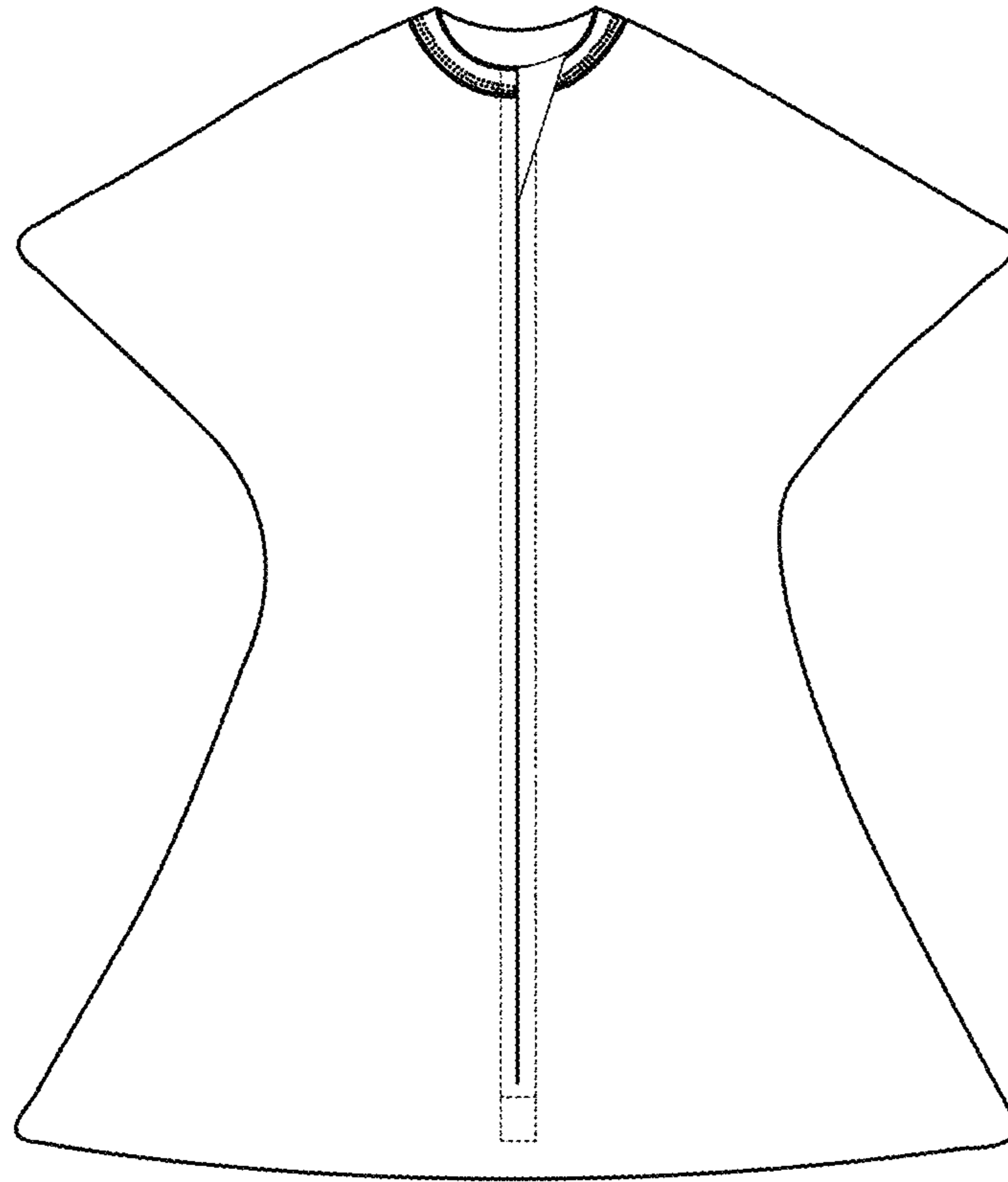

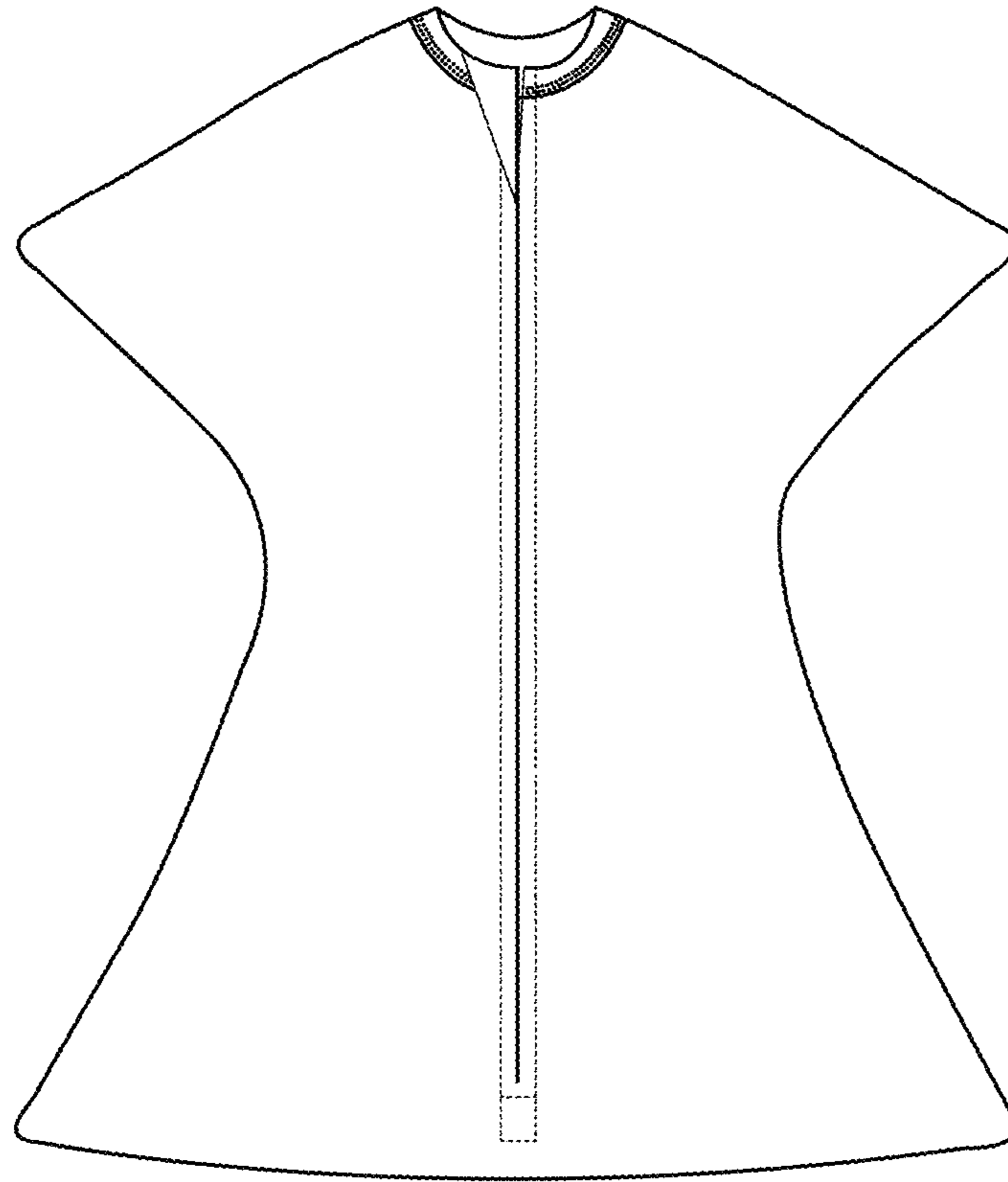

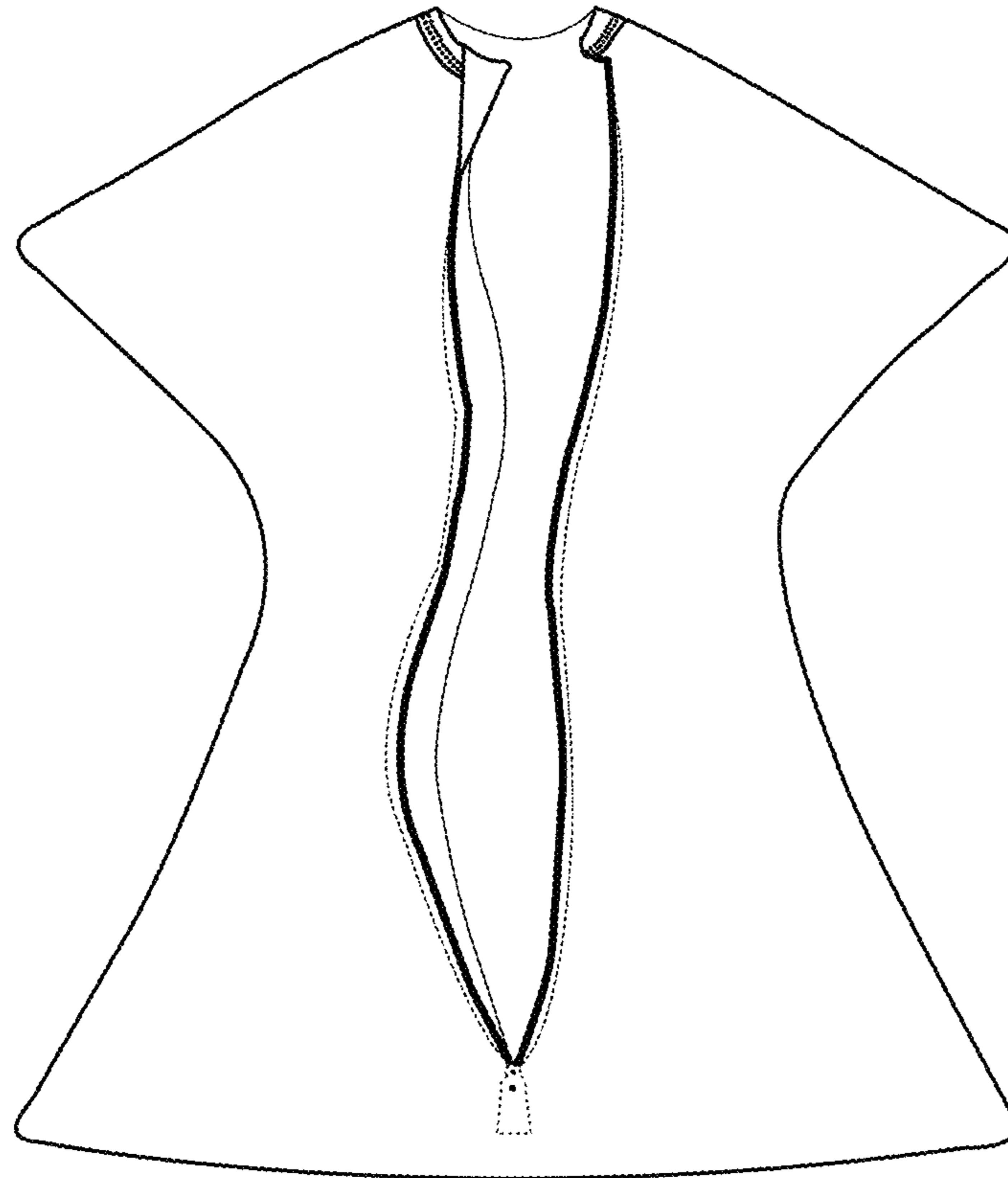

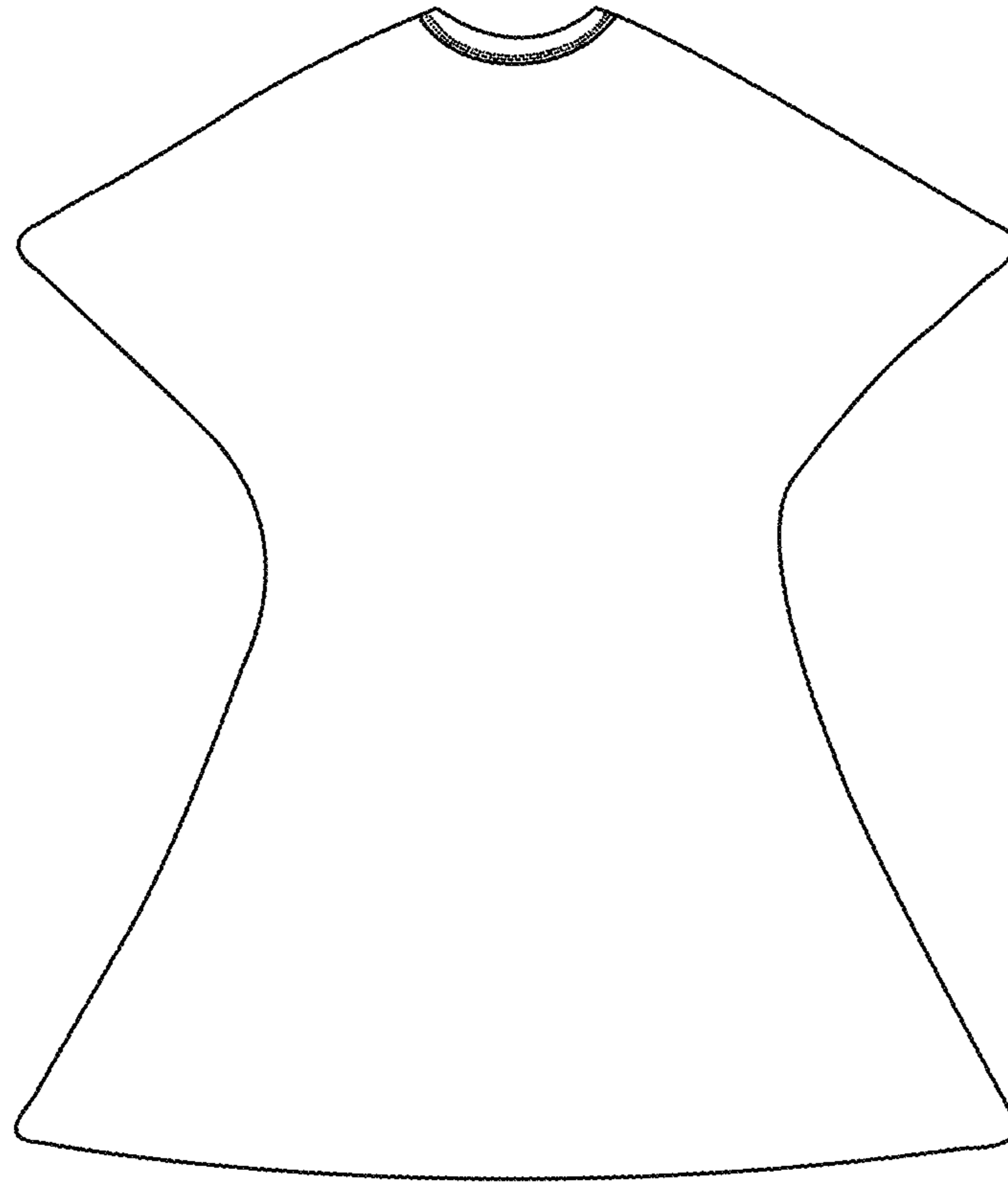

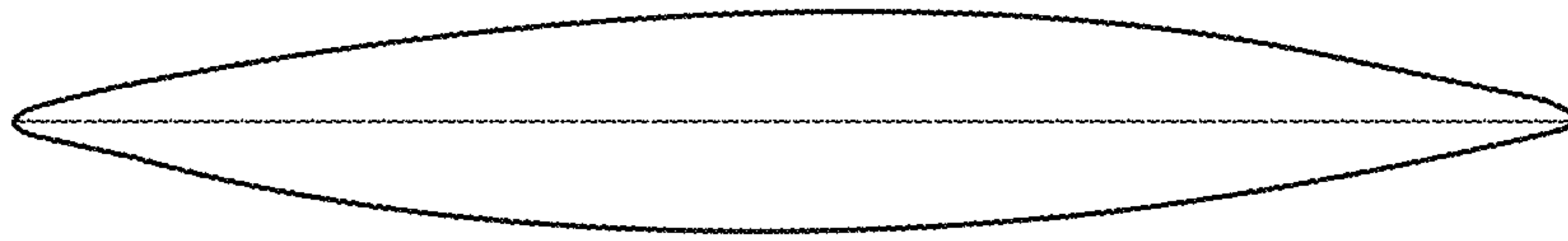

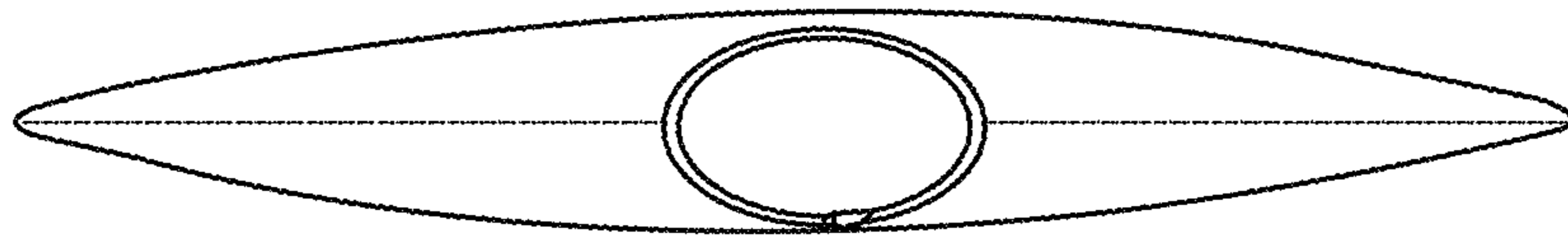
