The ornamental design for leggings, as shown and described.

DESCRIPTION

This application is related to U.S. application Ser. No. 29/656,262 filed Jul. 11, 2018, entitled “Leggings,” and, U.S. application Ser. FIG. 2 is a rear perspective view thereof;

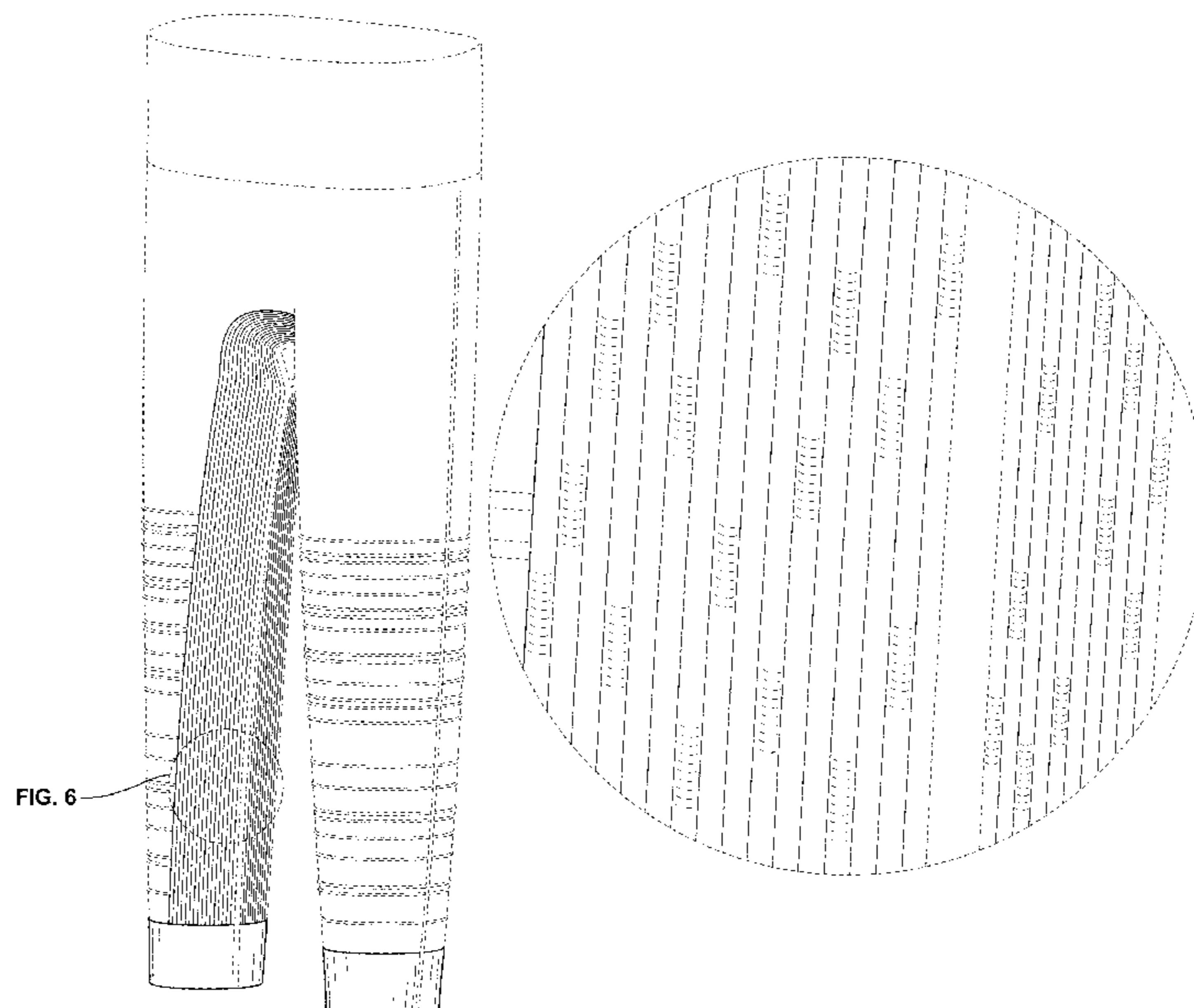
FIG. 3 is a front elevation view thereof;

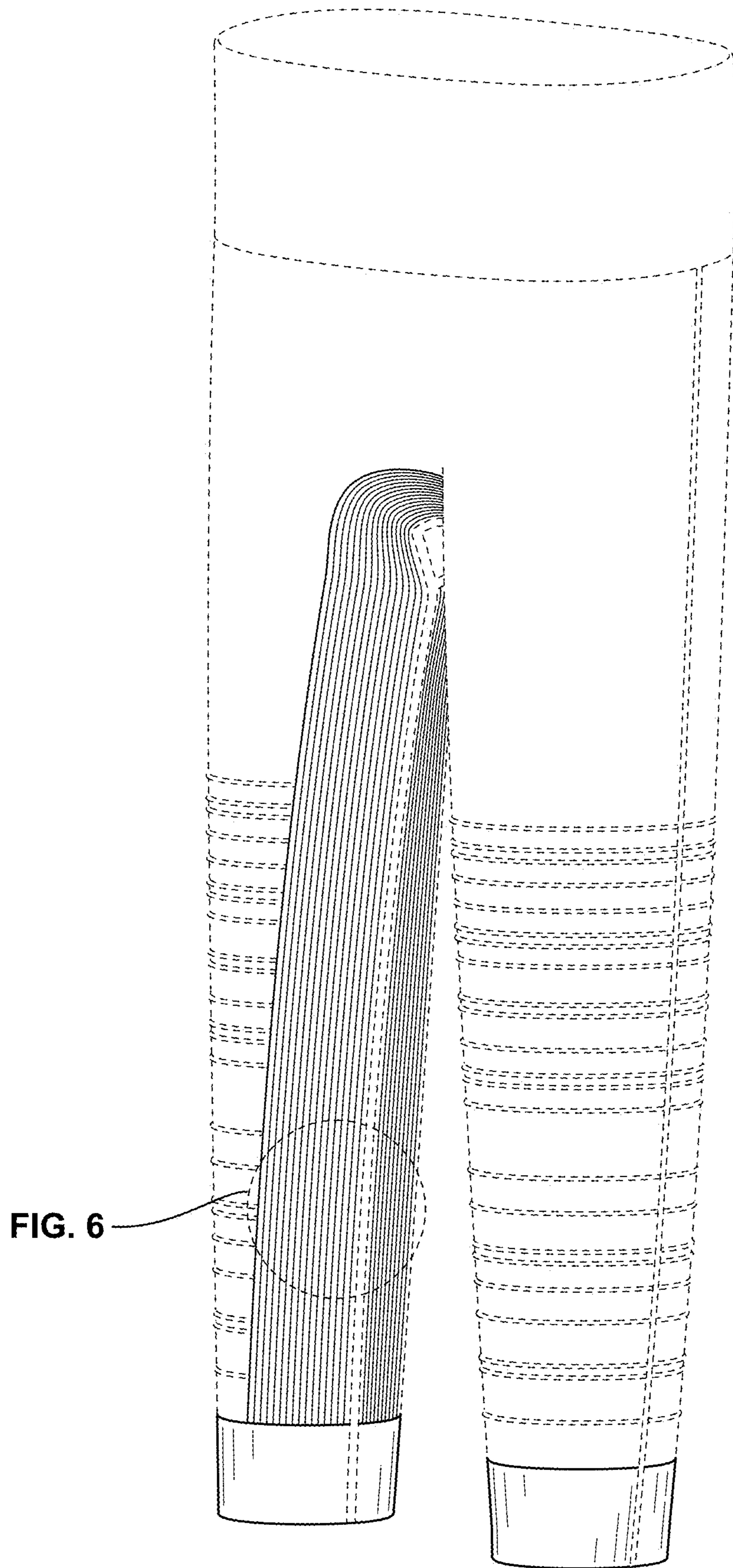

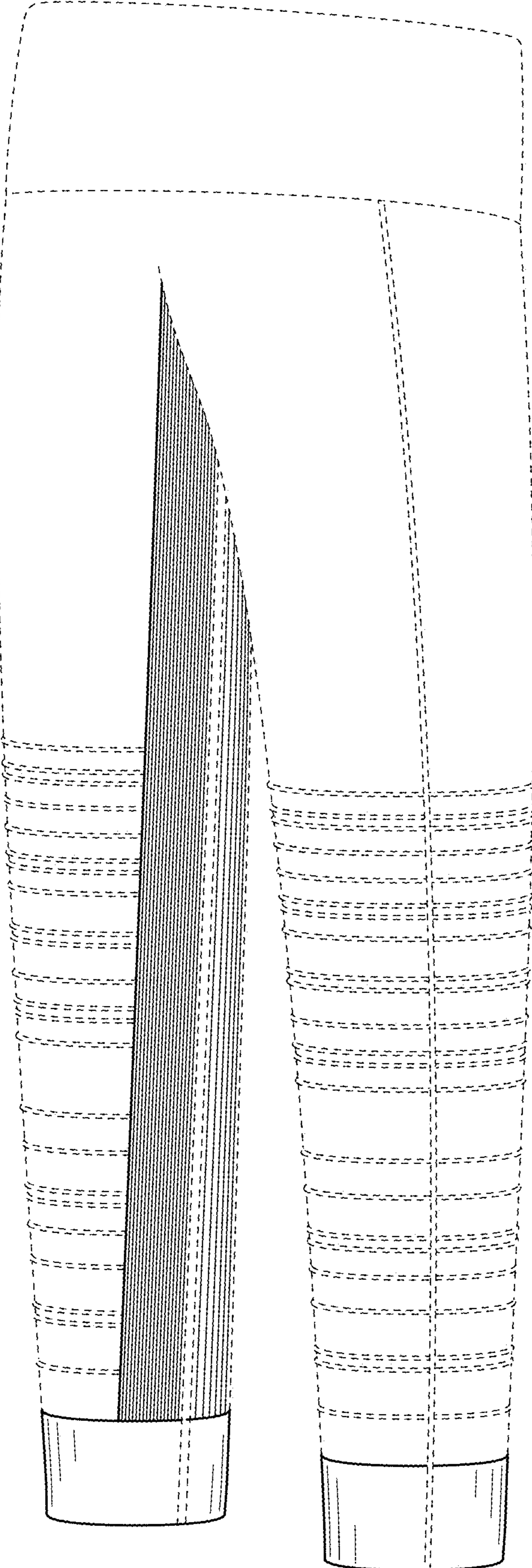

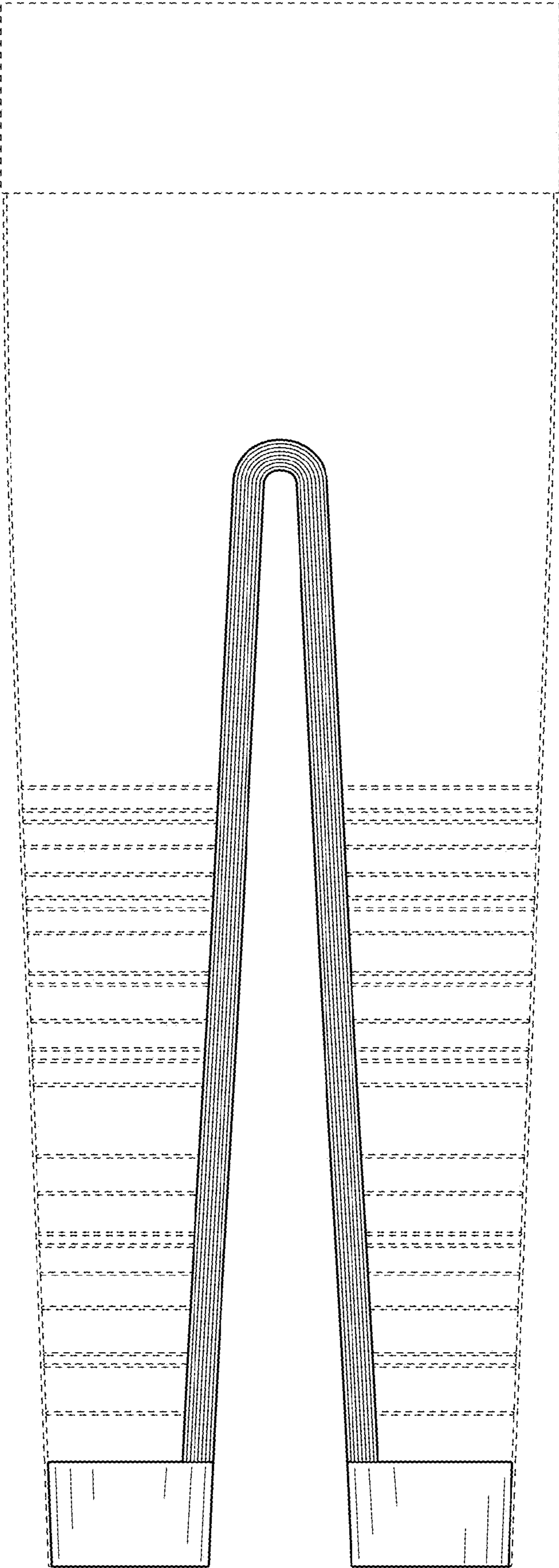

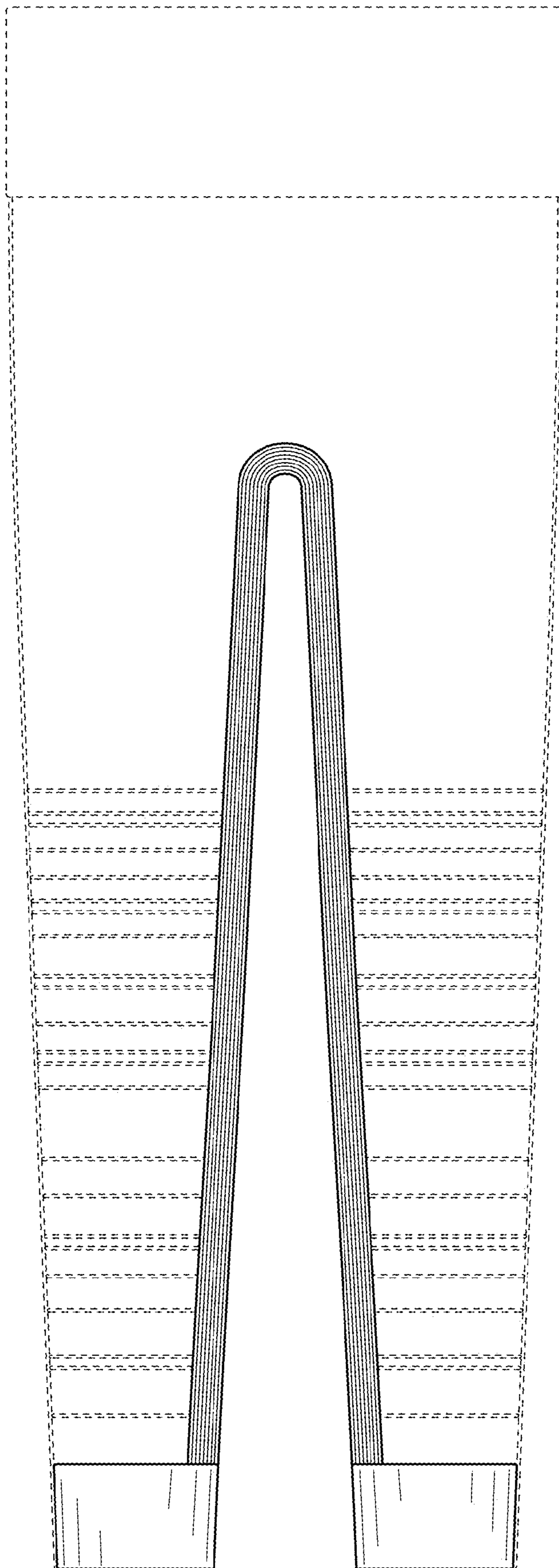

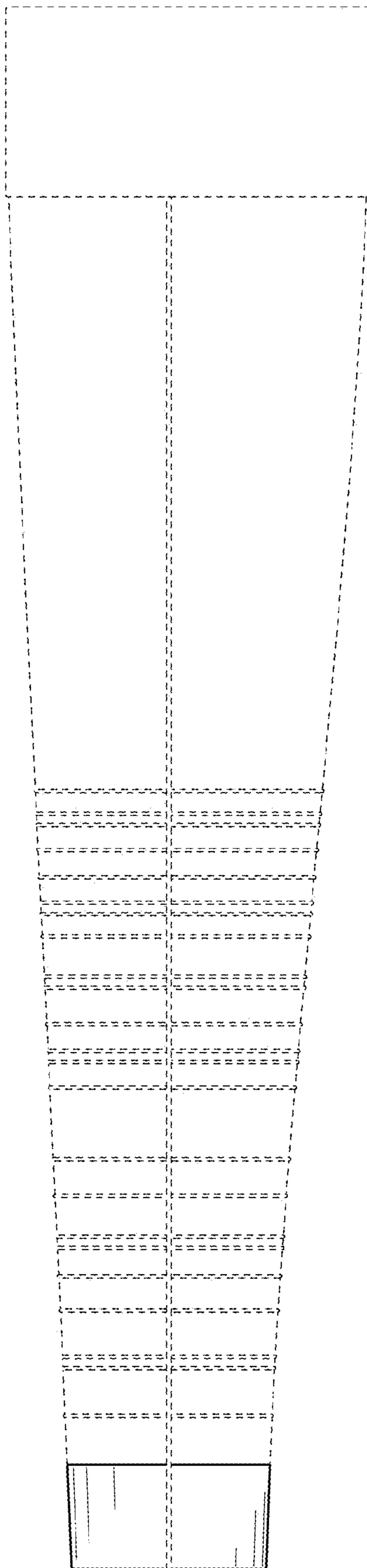

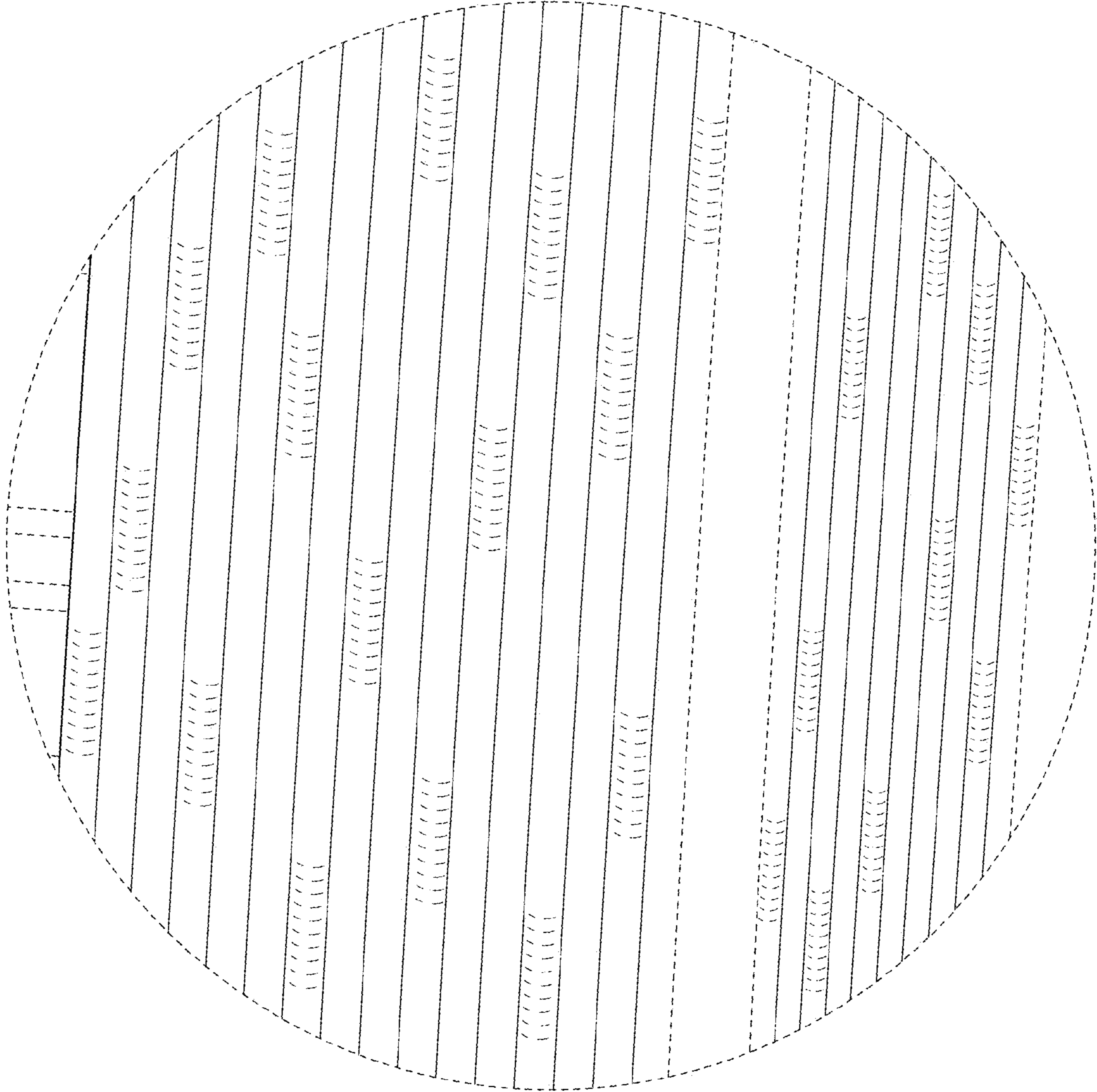
