DESCRIPTION

FIG. 1 is a top perspective view of the boot showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof;

FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof; and,

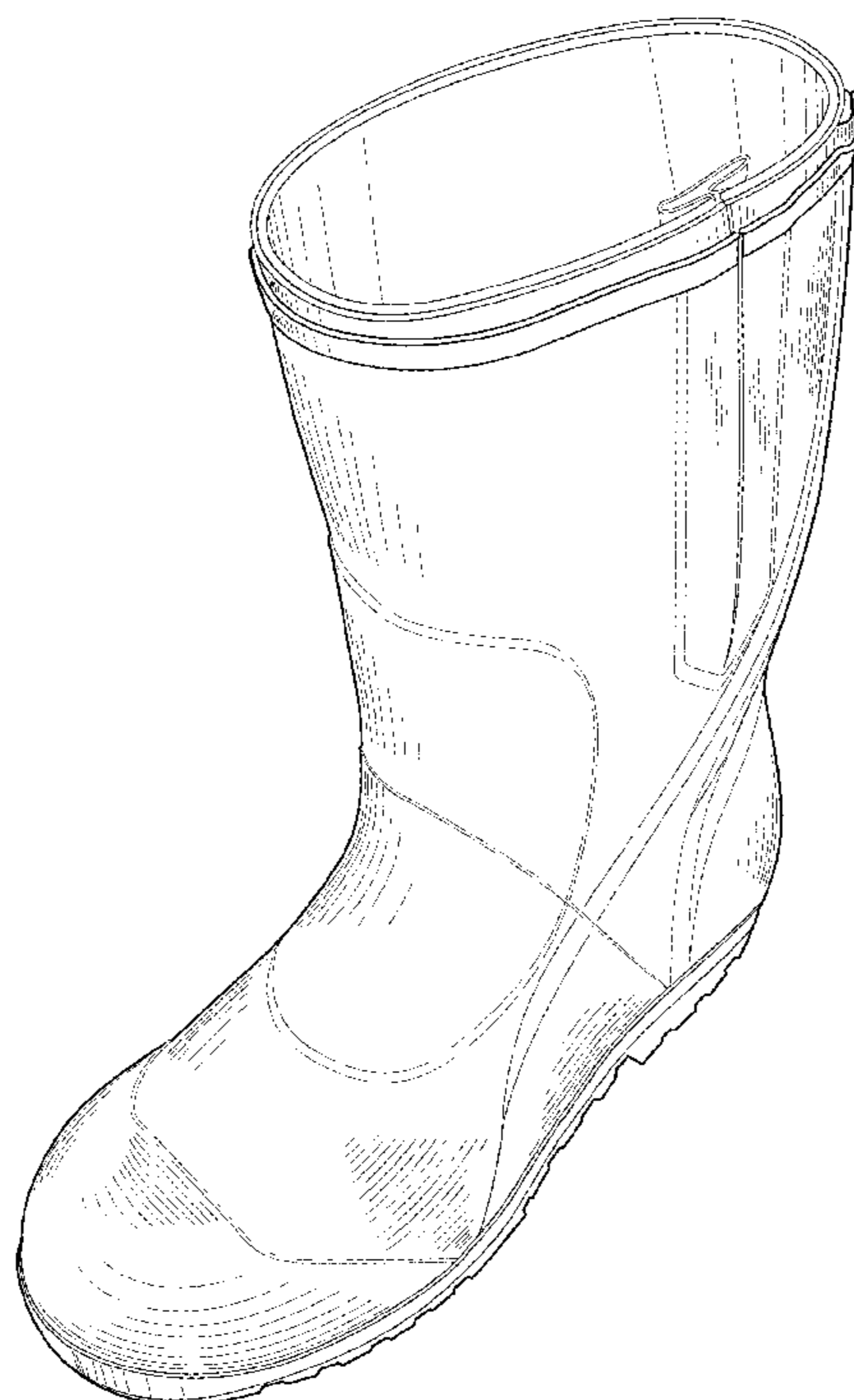

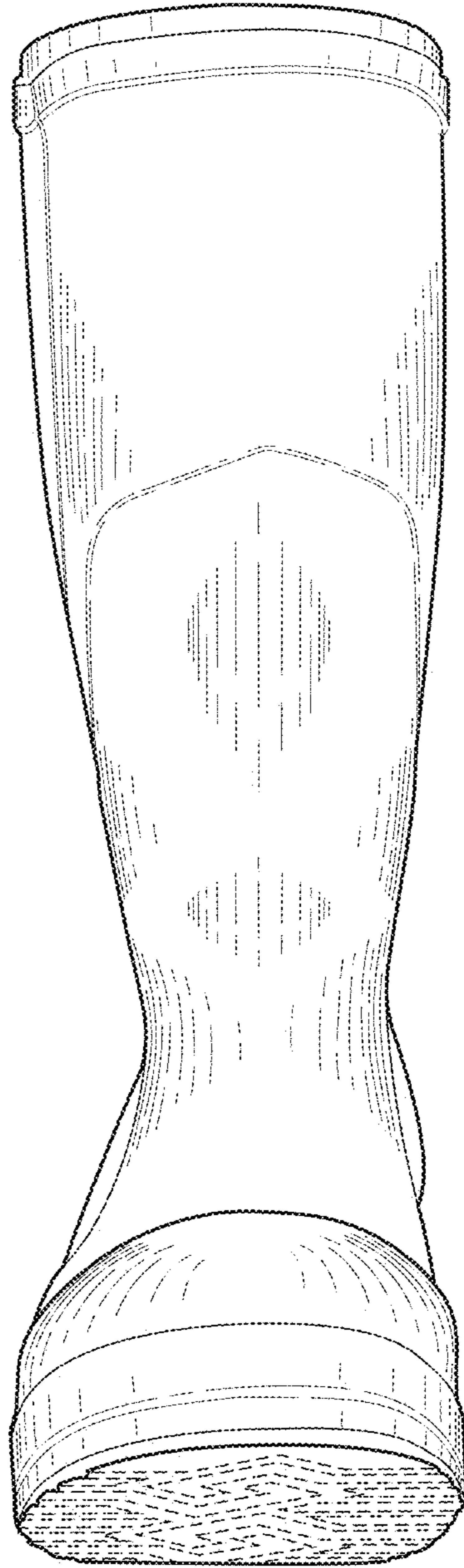

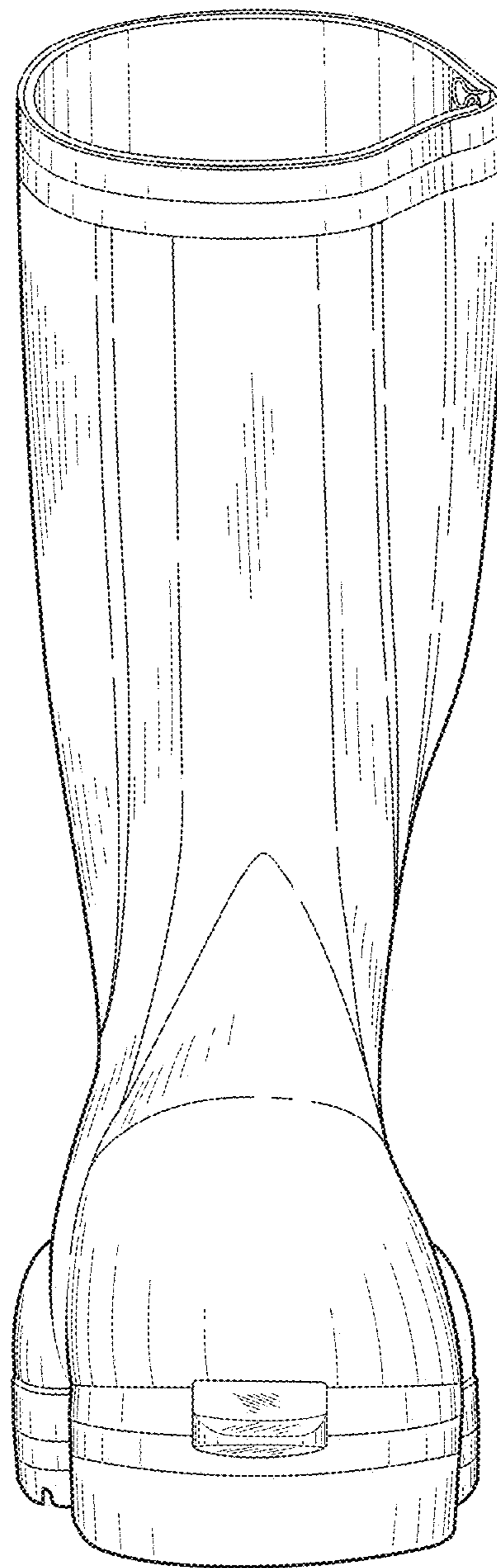

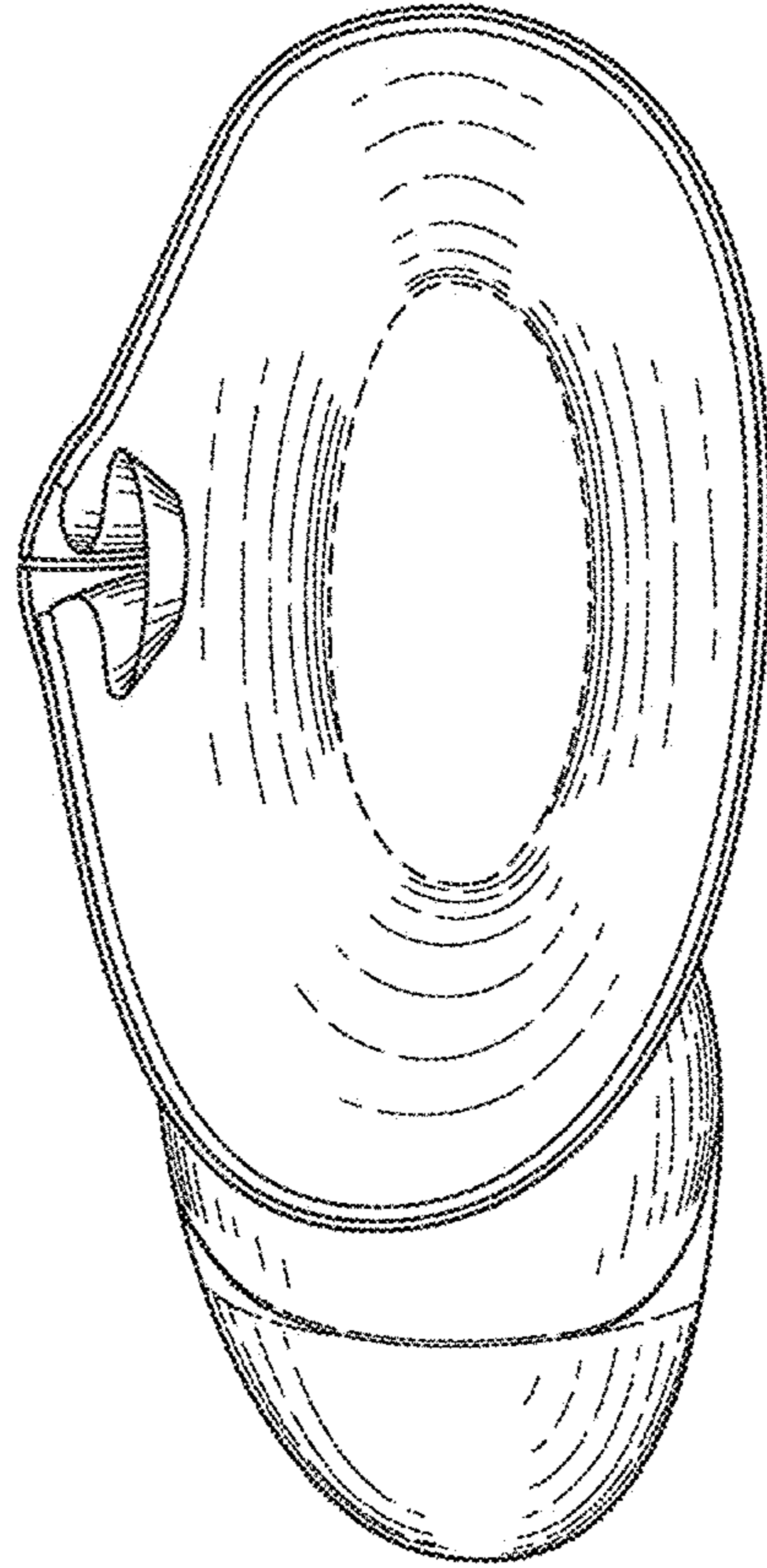

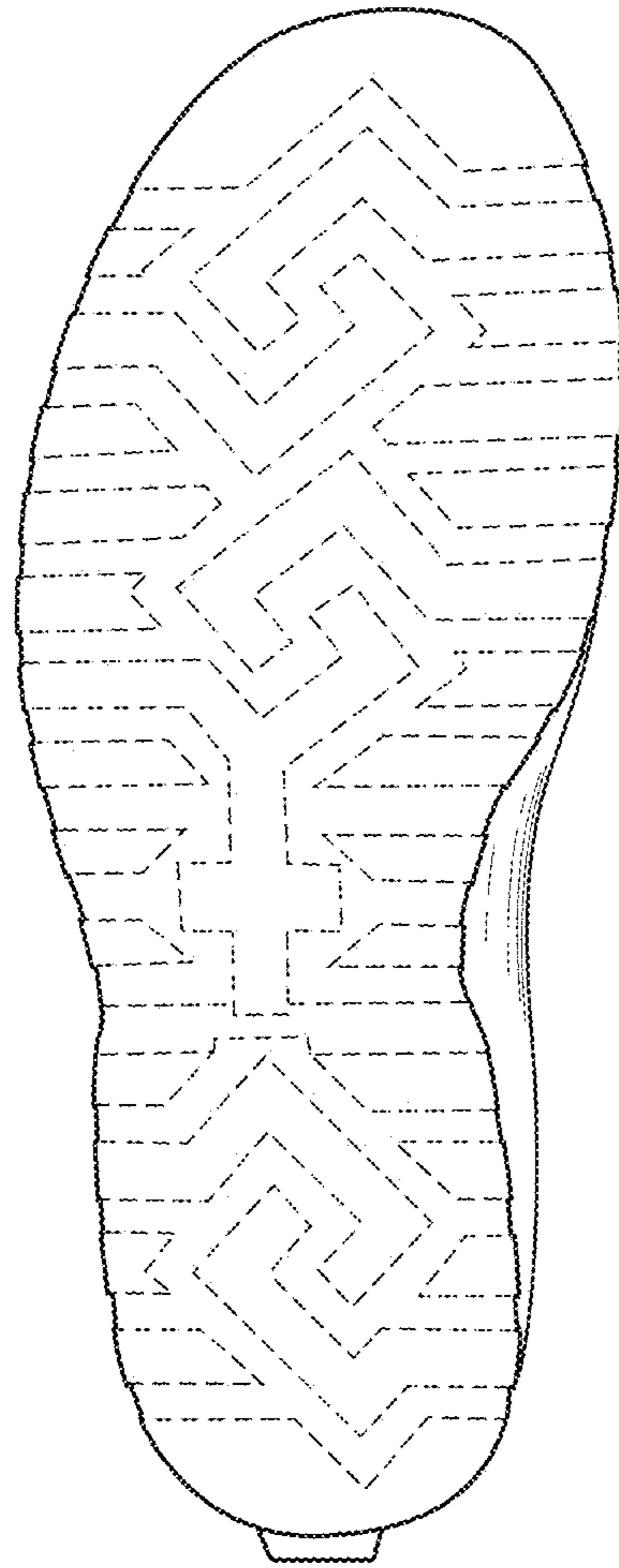
