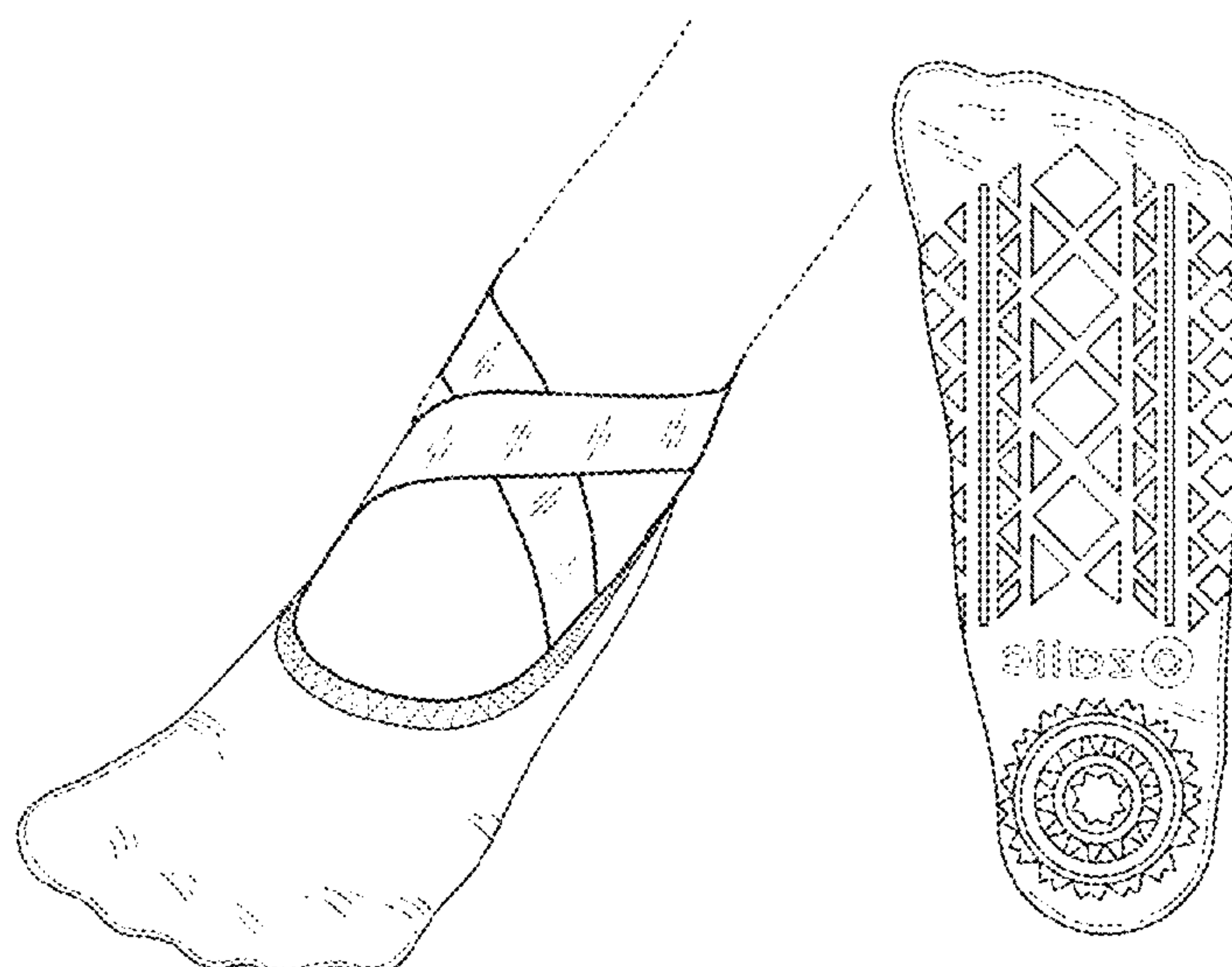
(57) **CLAIM**

The ornamental design for a sock, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a sock showing the claimed design in a position of use;
 FIG. 2 is a top plan view of the first embodiment of the sock;
 FIG. 3 is a bottom plan view of the first embodiment of the sock;
 FIG. 4 is a left side elevational view of the first embodiment of the sock;
 FIG. 5 is a right side elevational of the first embodiment of the sock;
 FIG. 6 is a top perspective view of a second embodiment of the sock with separated toes in a position of use;
 FIG. 7 is a top plan view of the second embodiment of the sock;
 FIG. 8 is a bottom plan view of the second embodiment of the sock;
 FIG. 9 is a left side elevational view of the second embodiment of the sock; and,
 FIG. 10 is a right side elevational view of the second embodiment of the sock.

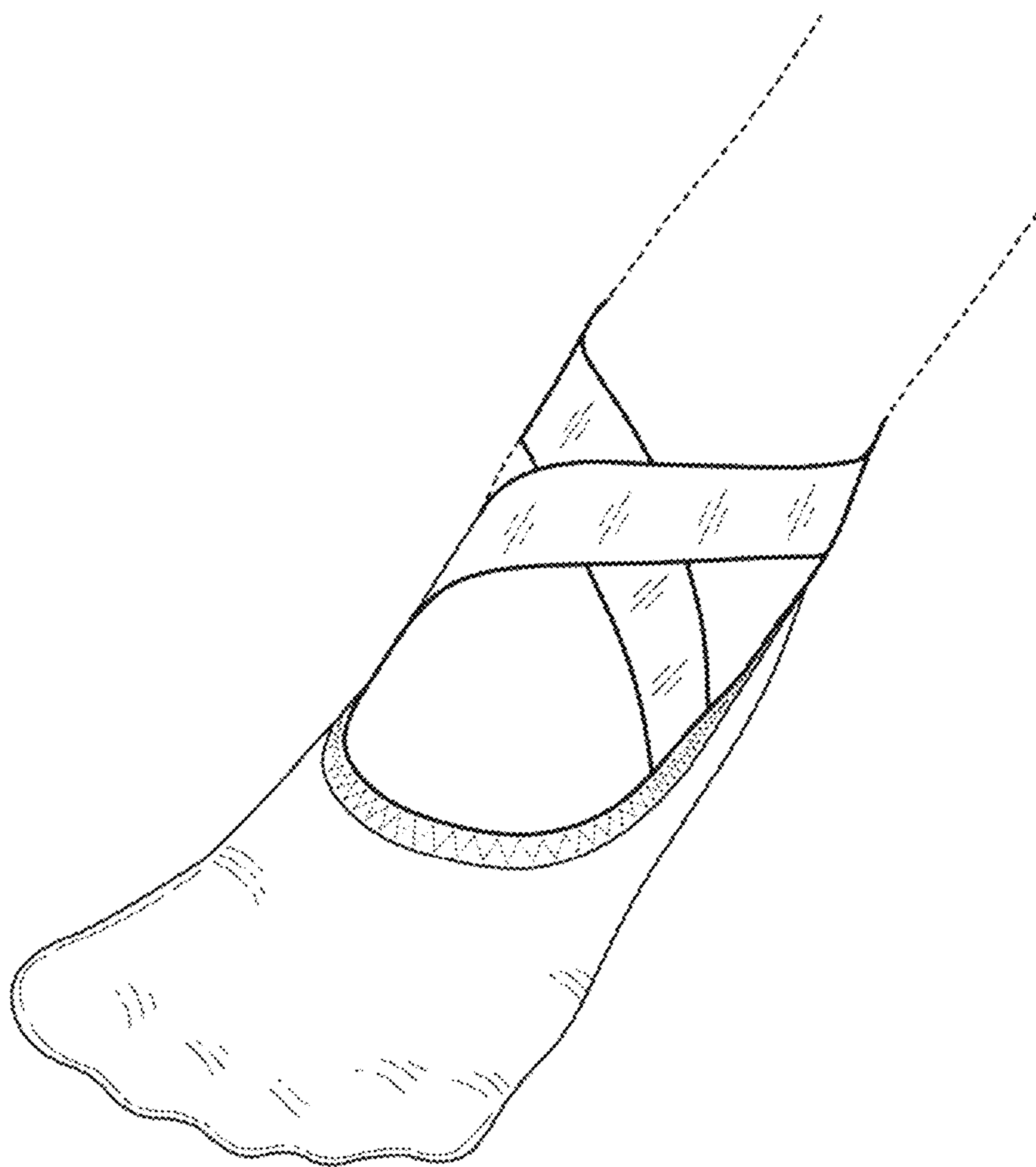

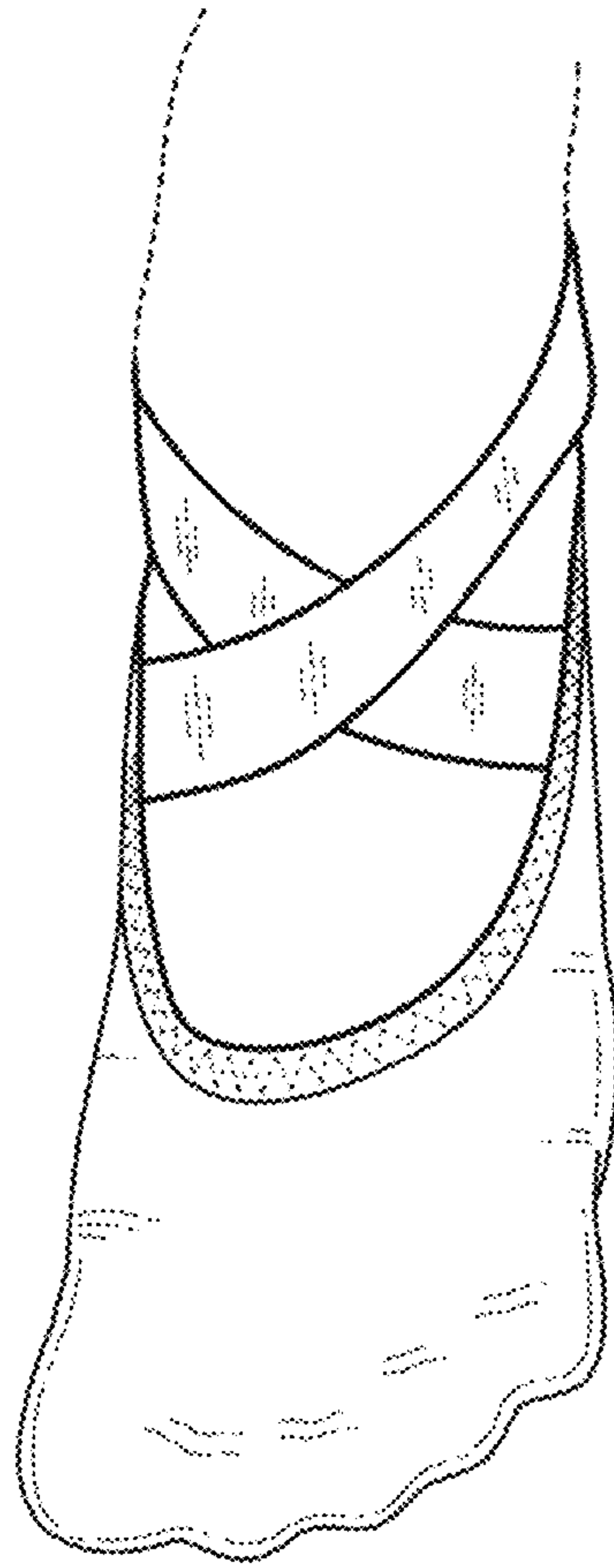

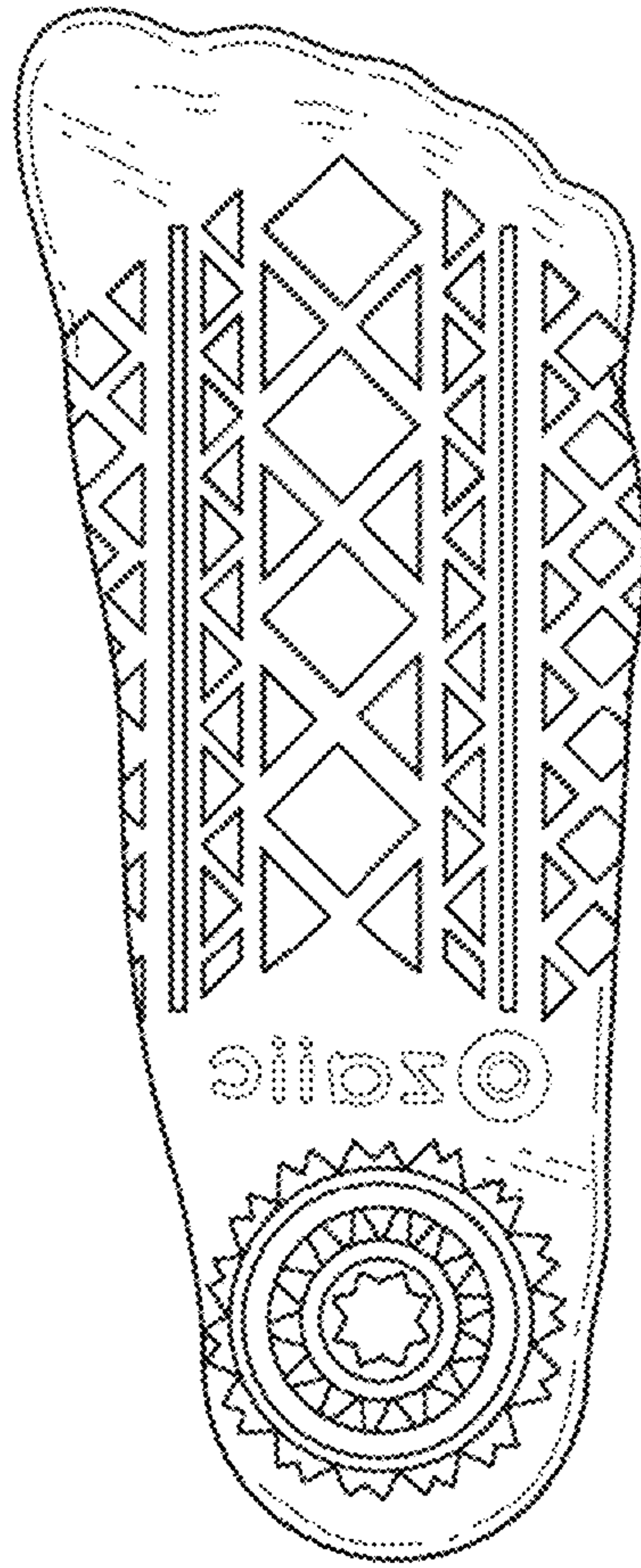

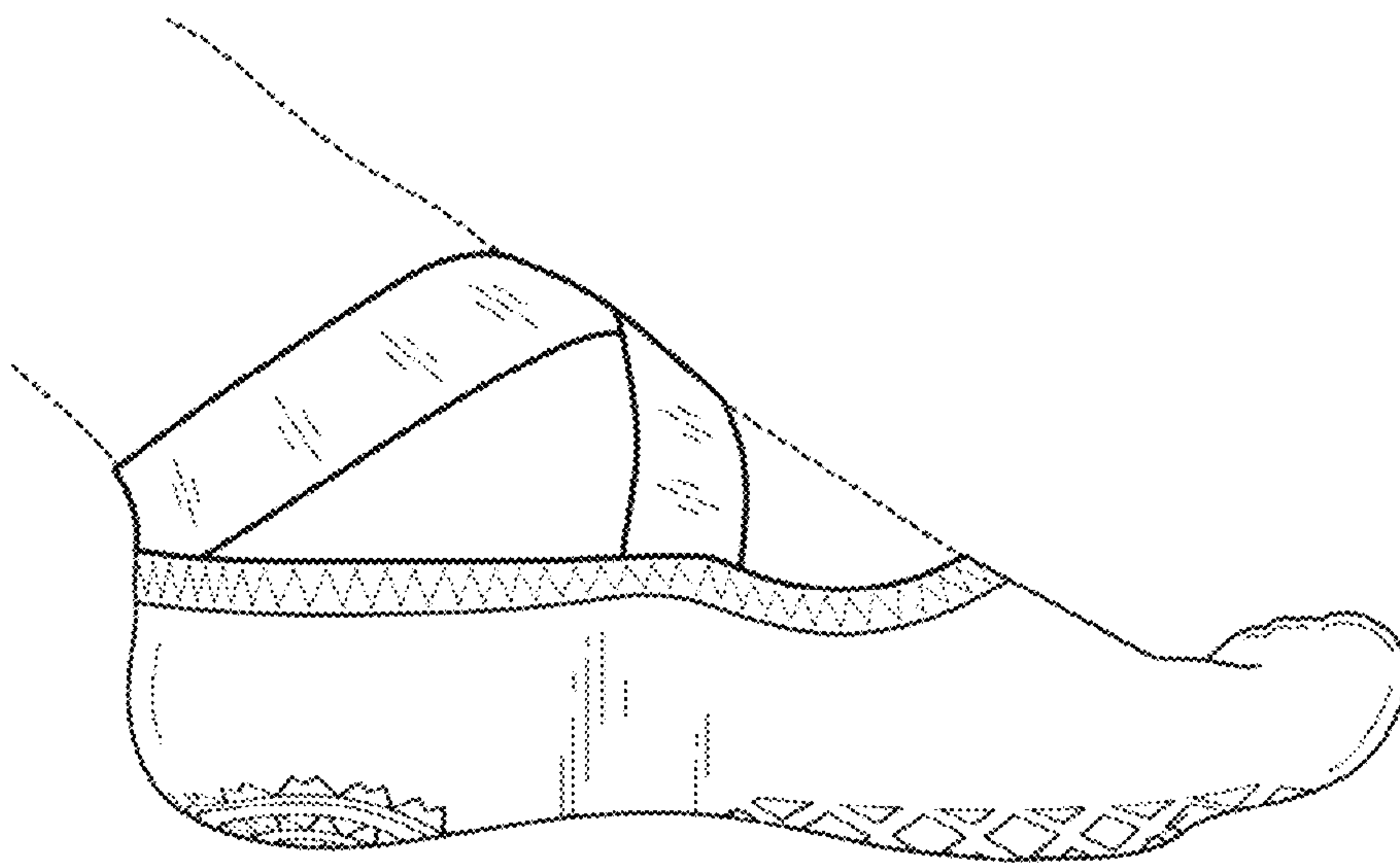

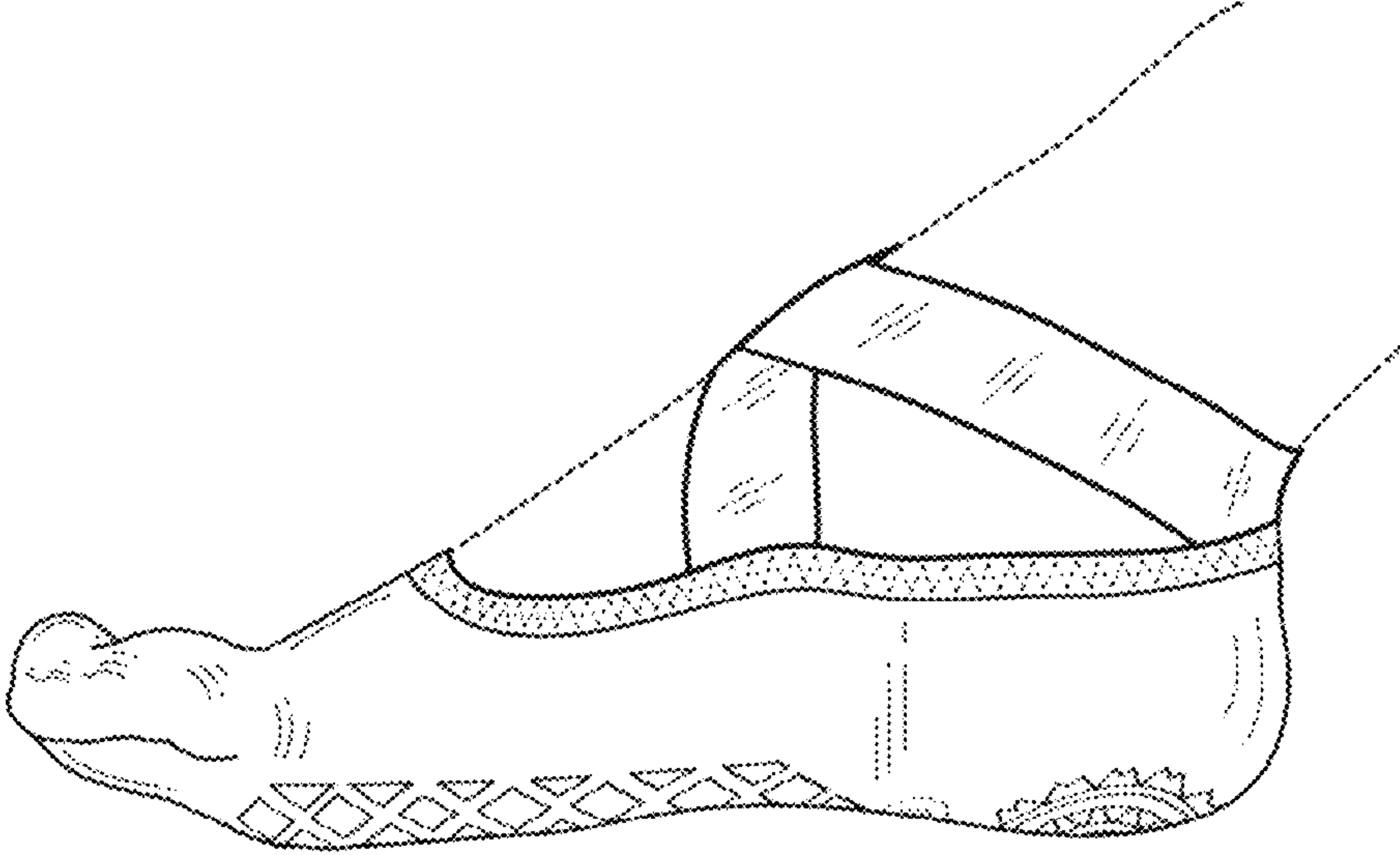

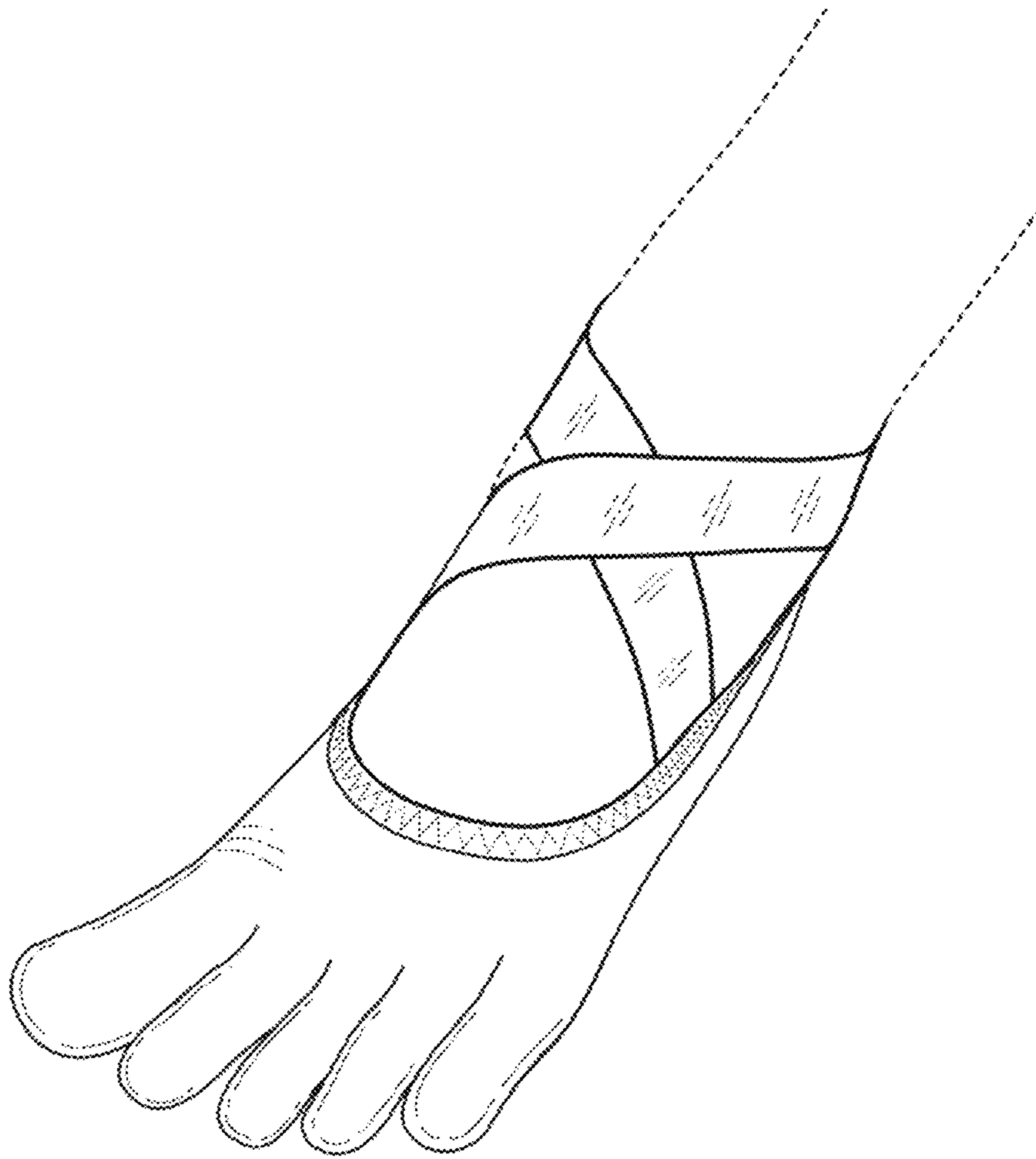

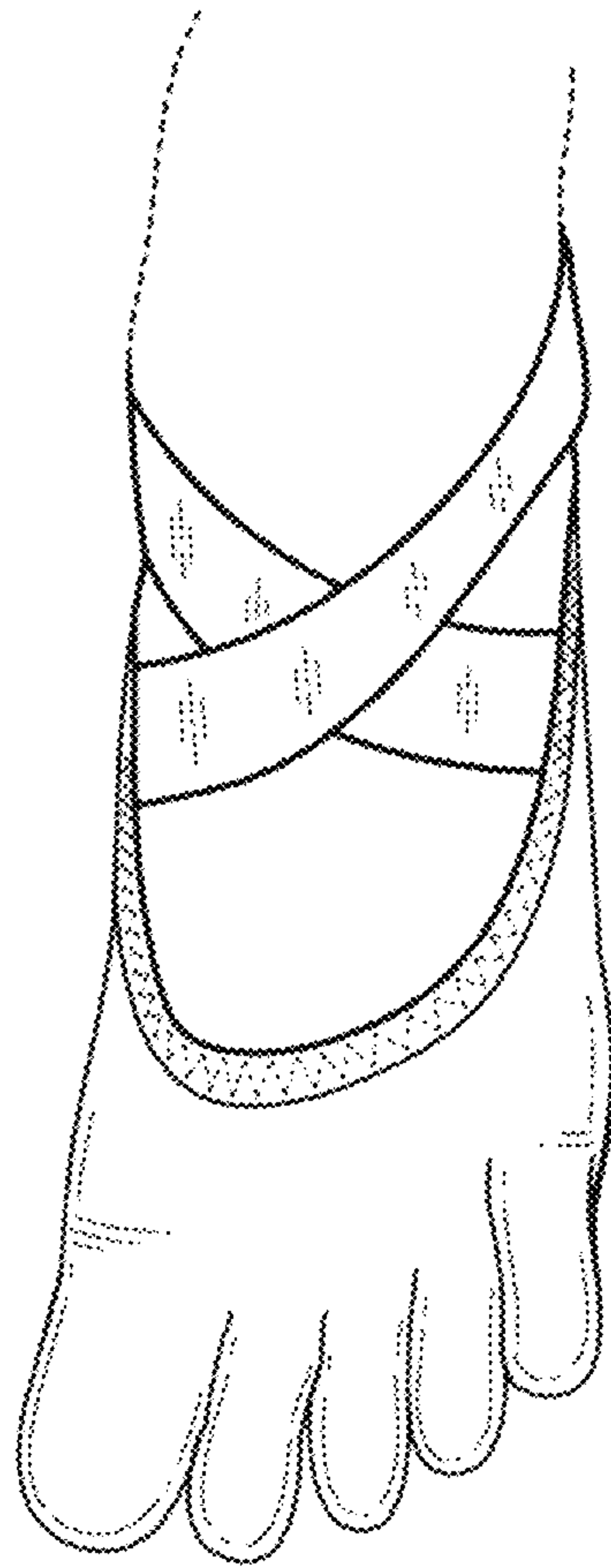

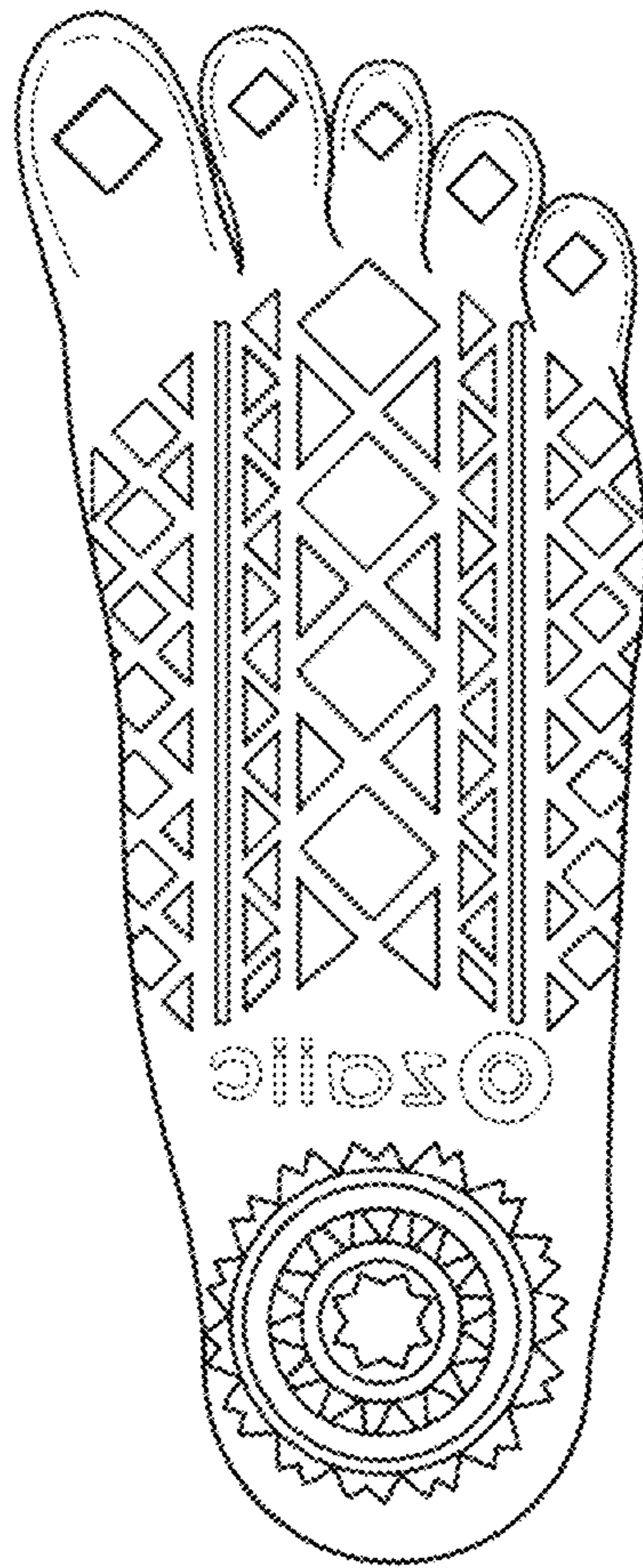

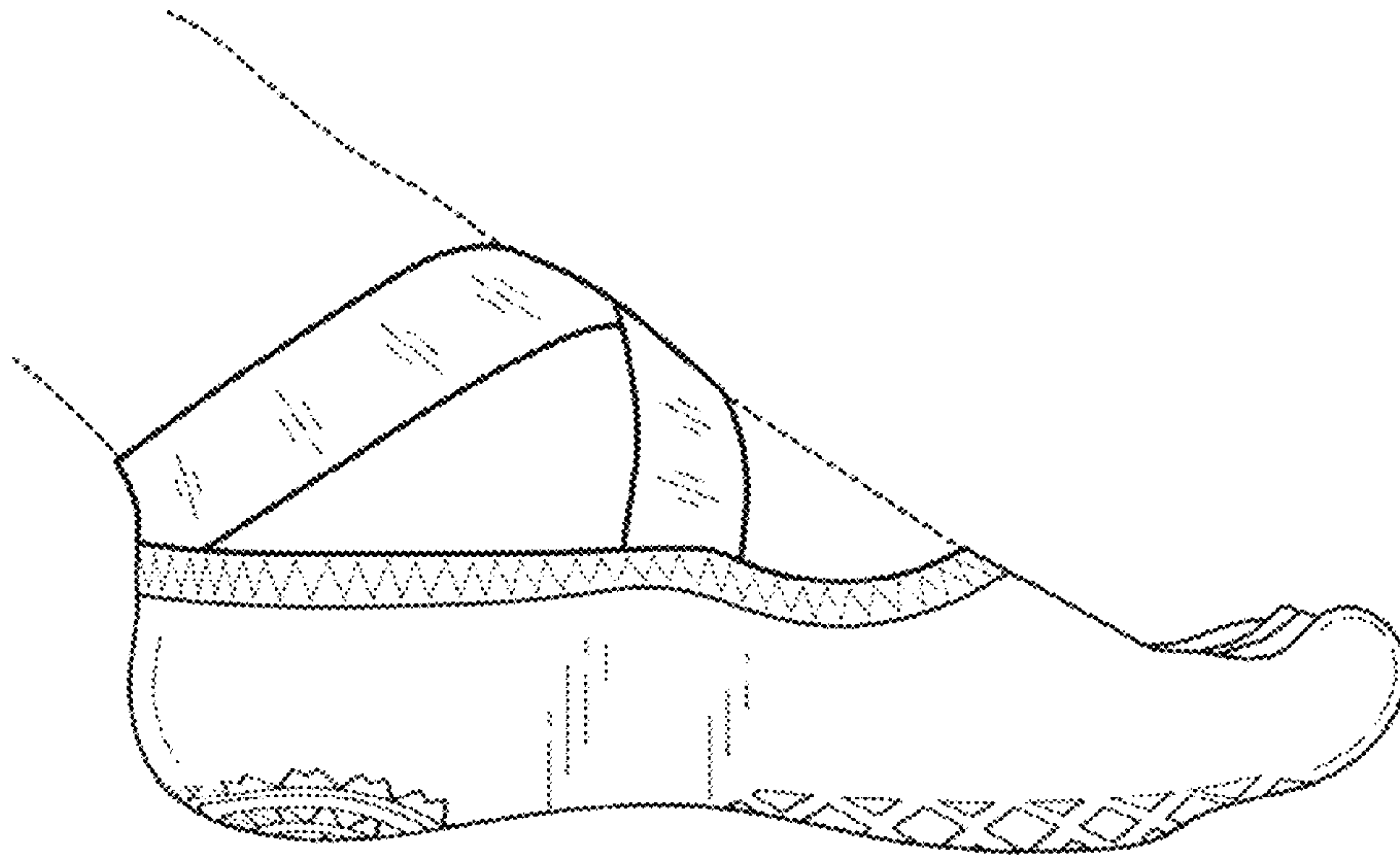

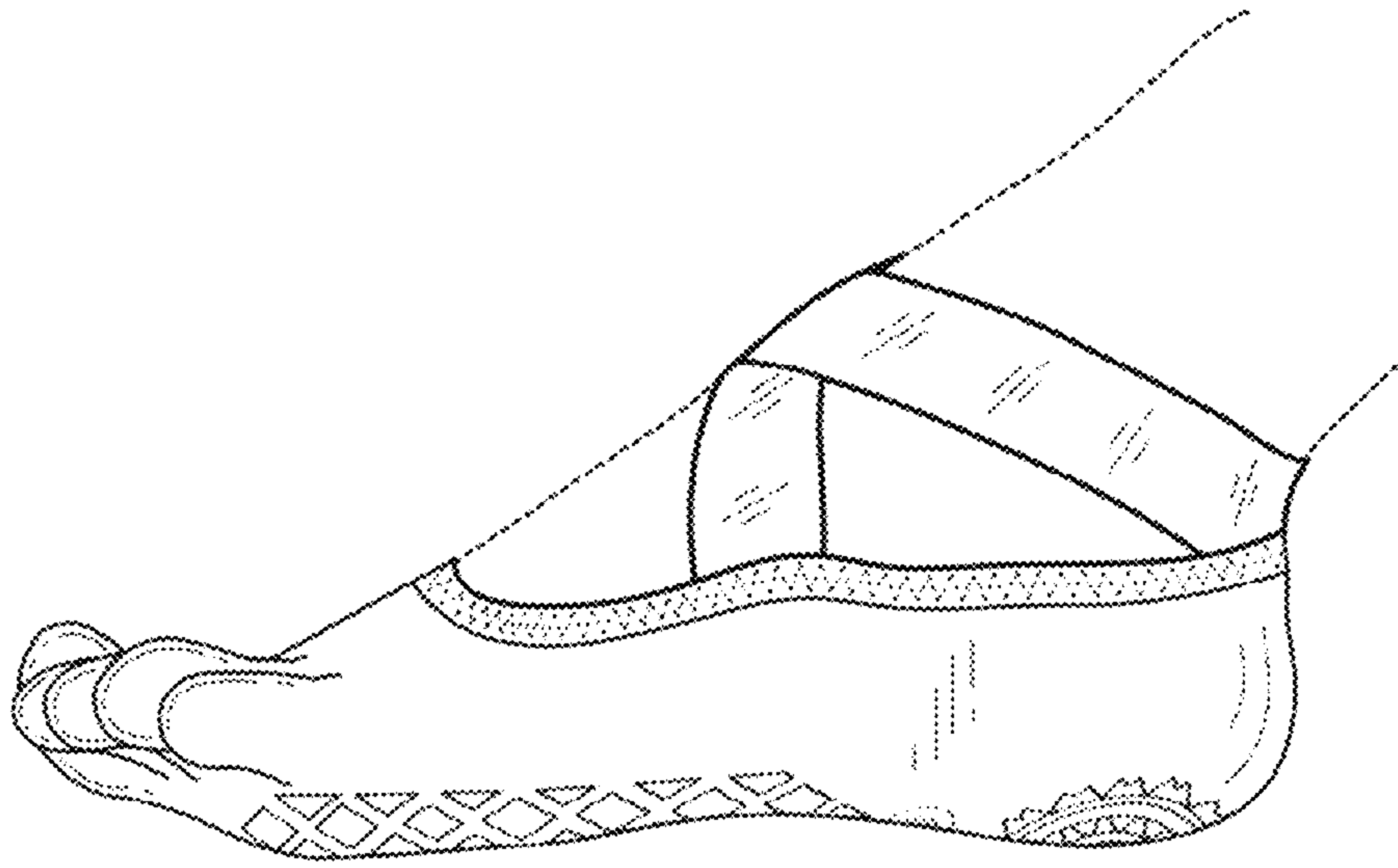
