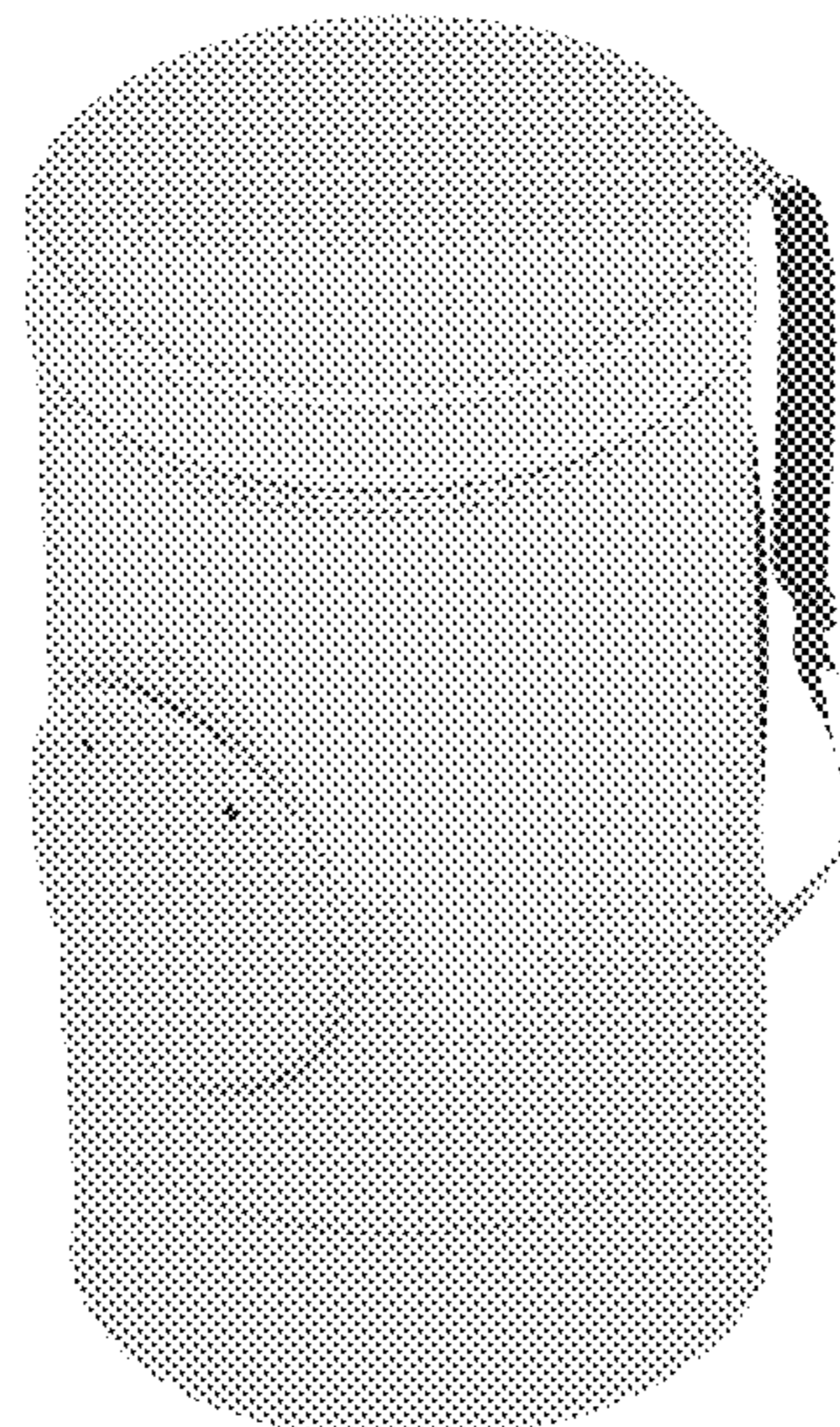
FIG. 1 is a front elevational view of a combination game

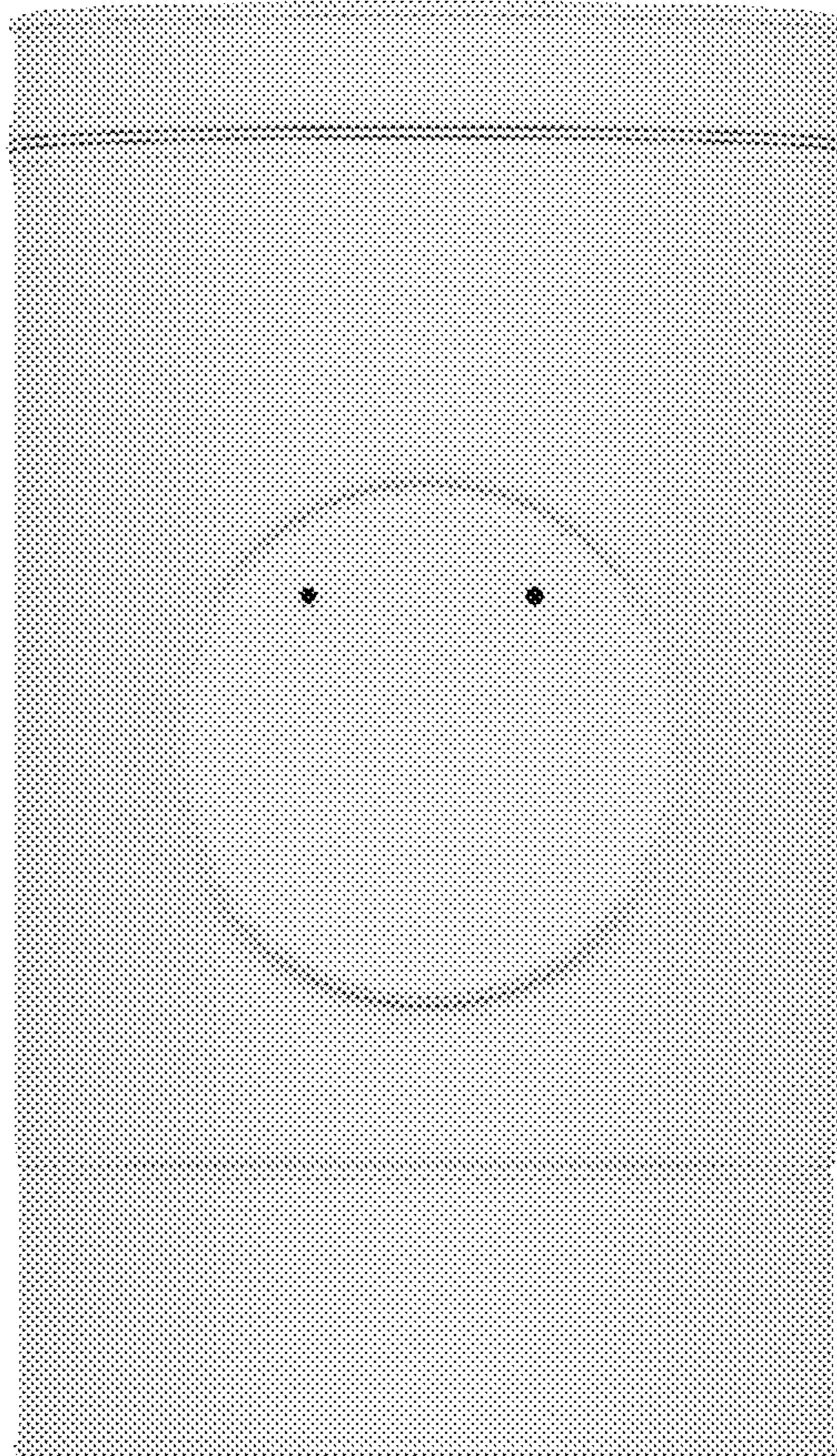

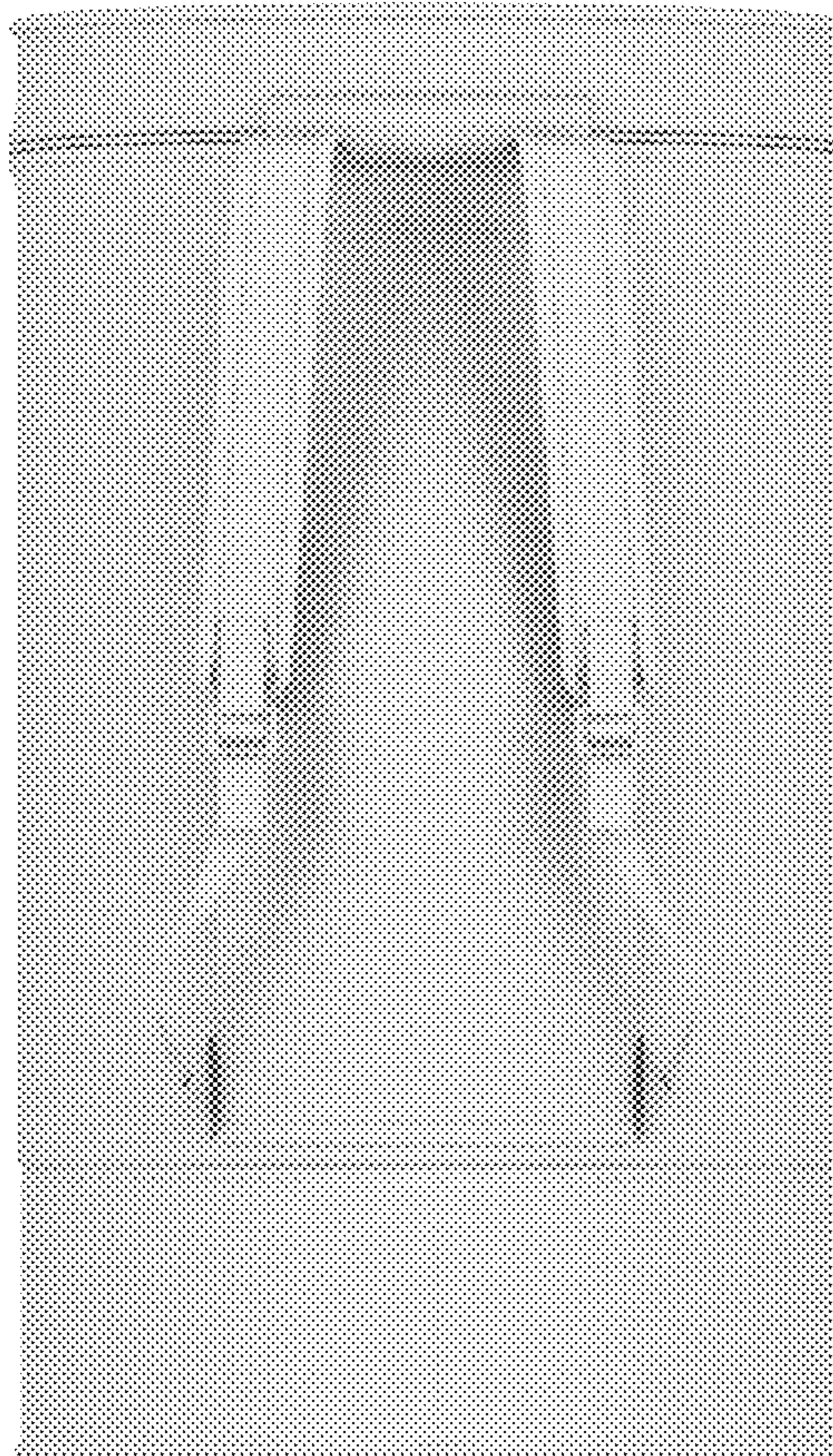

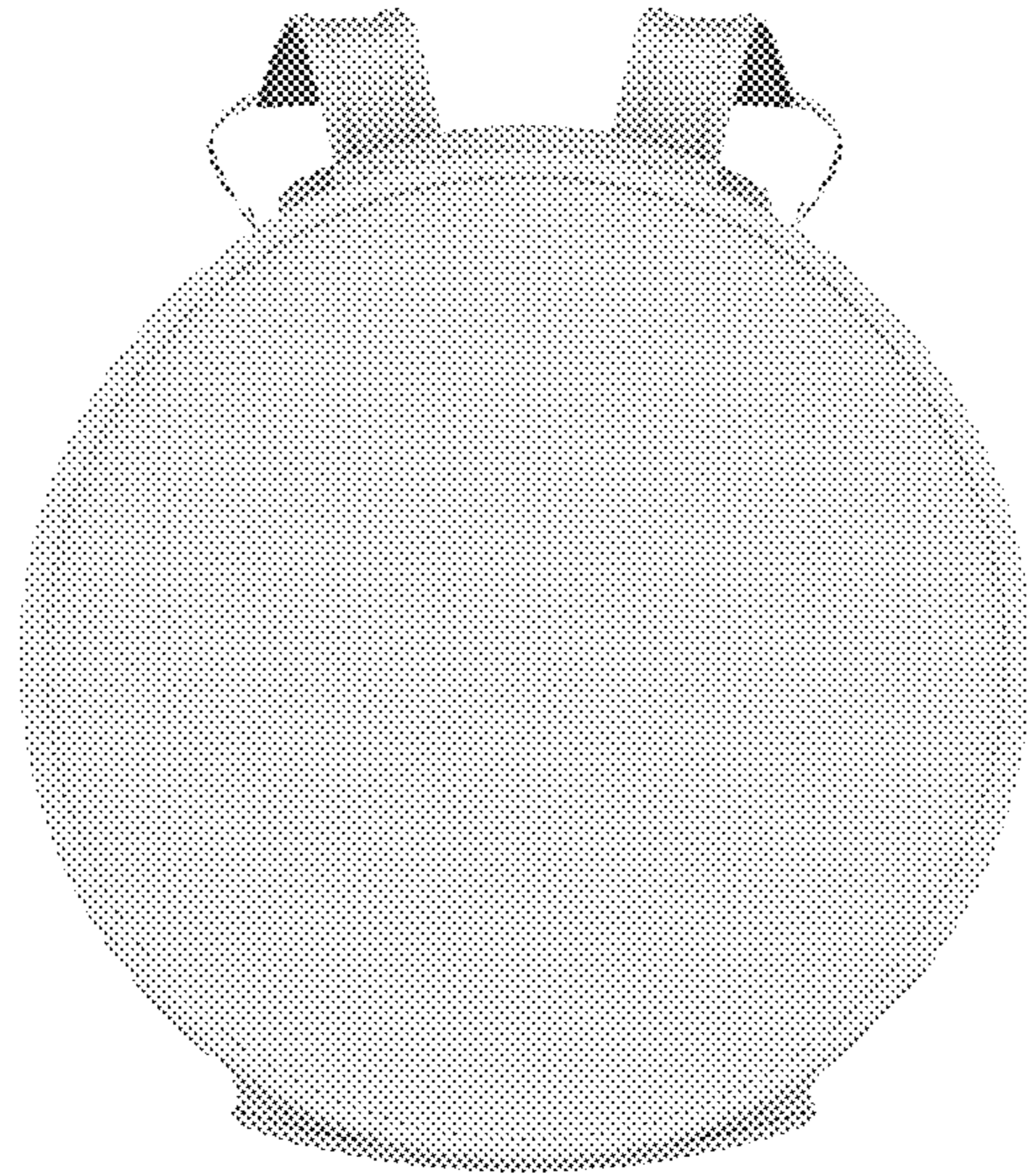

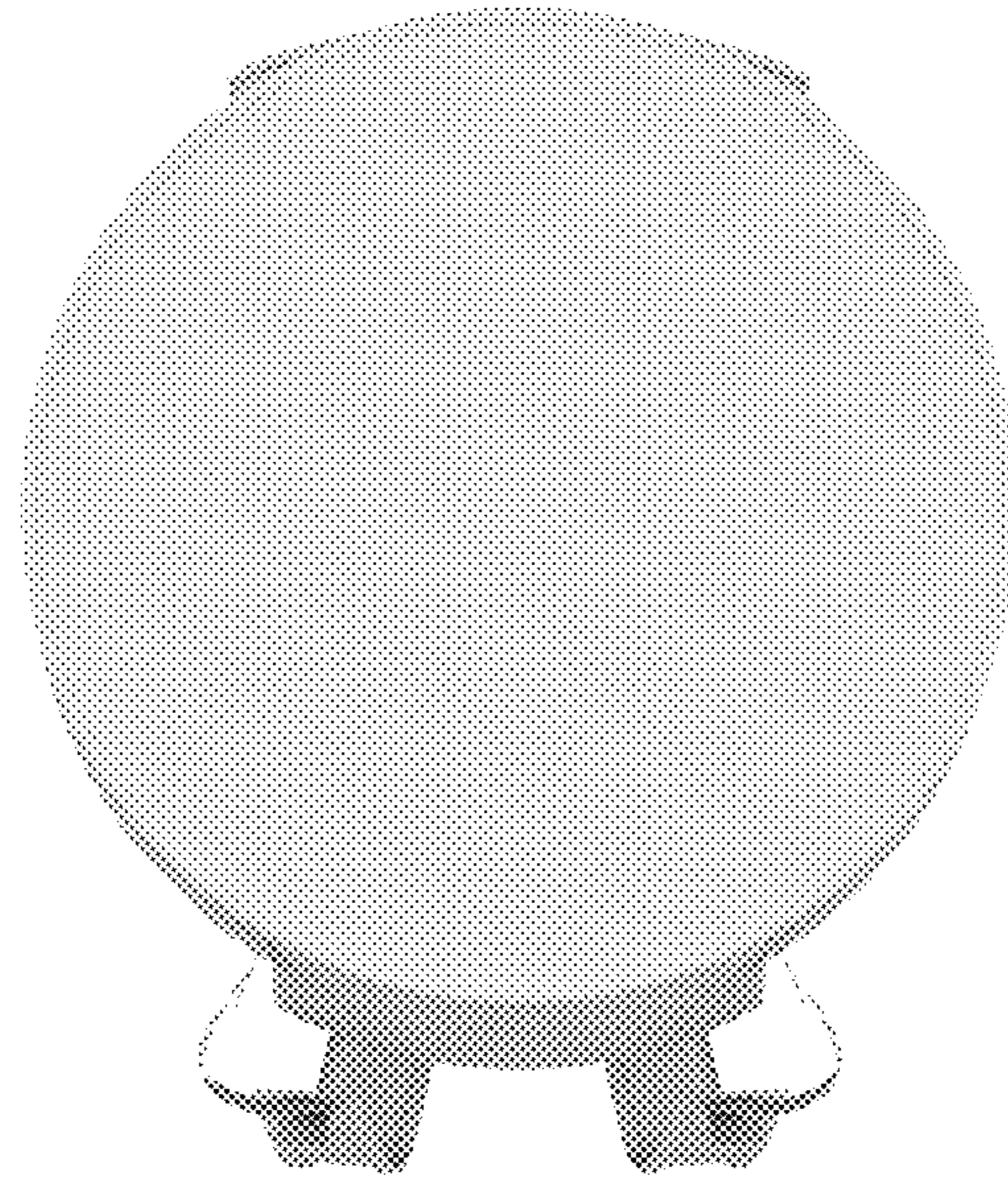

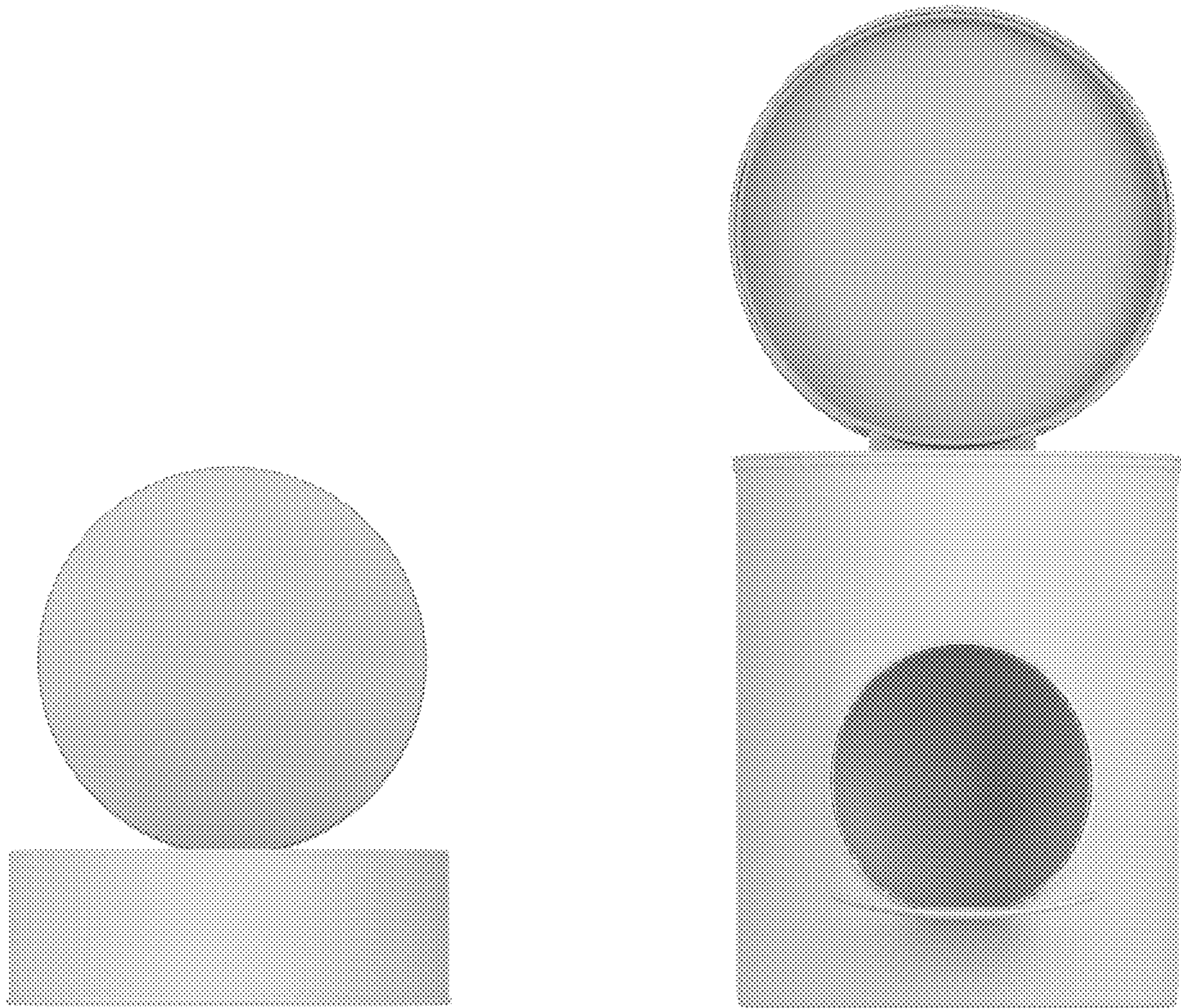

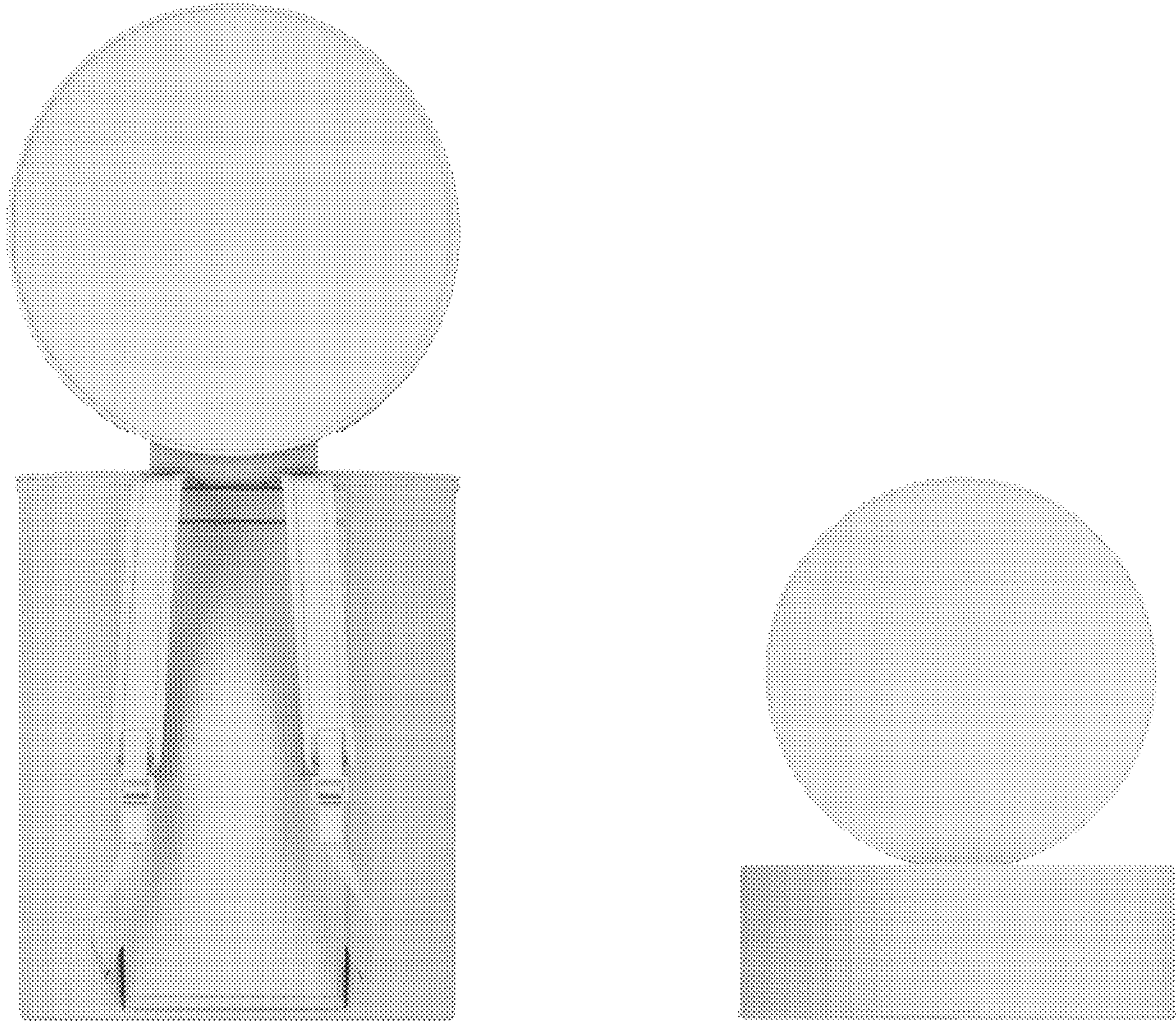

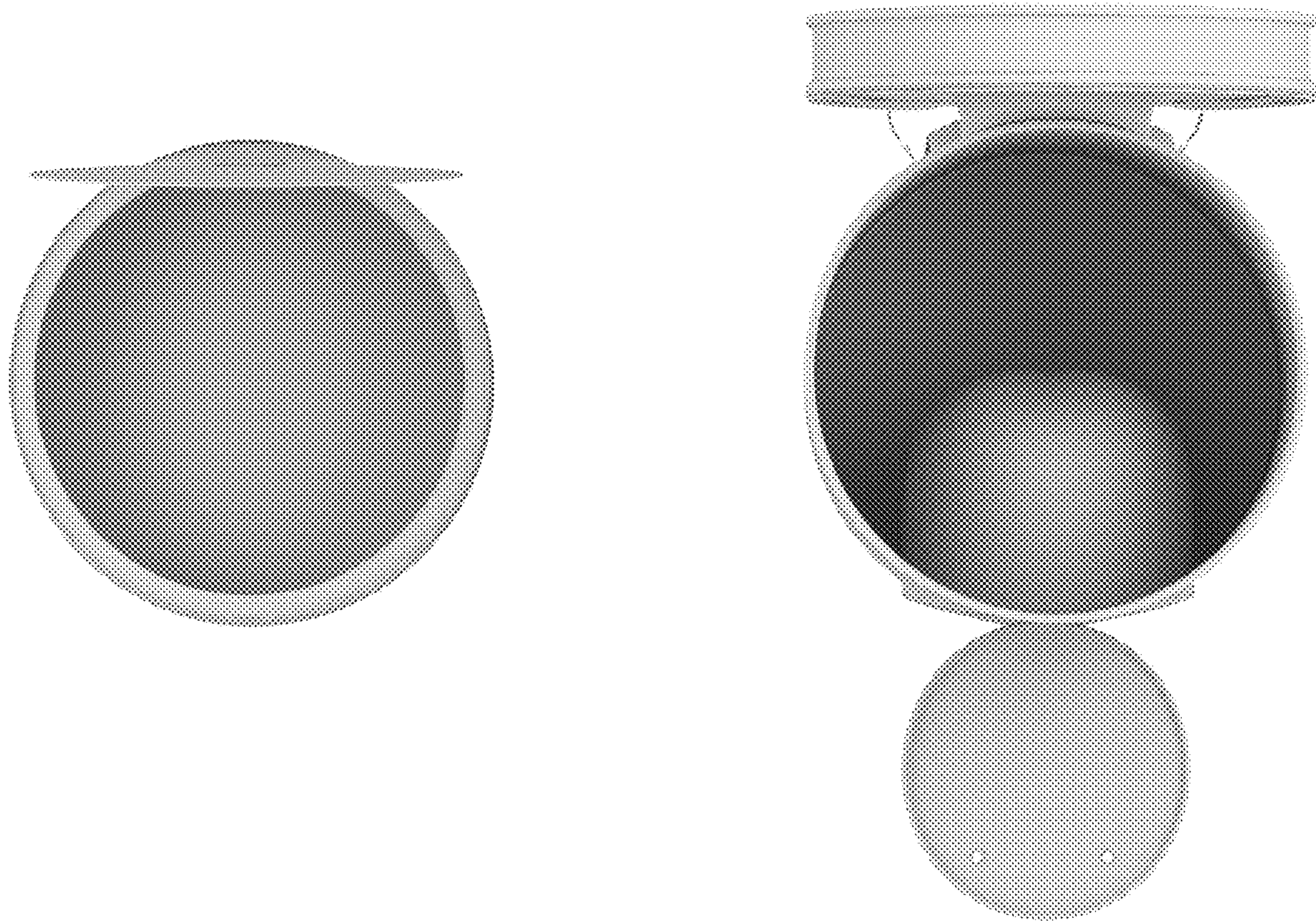

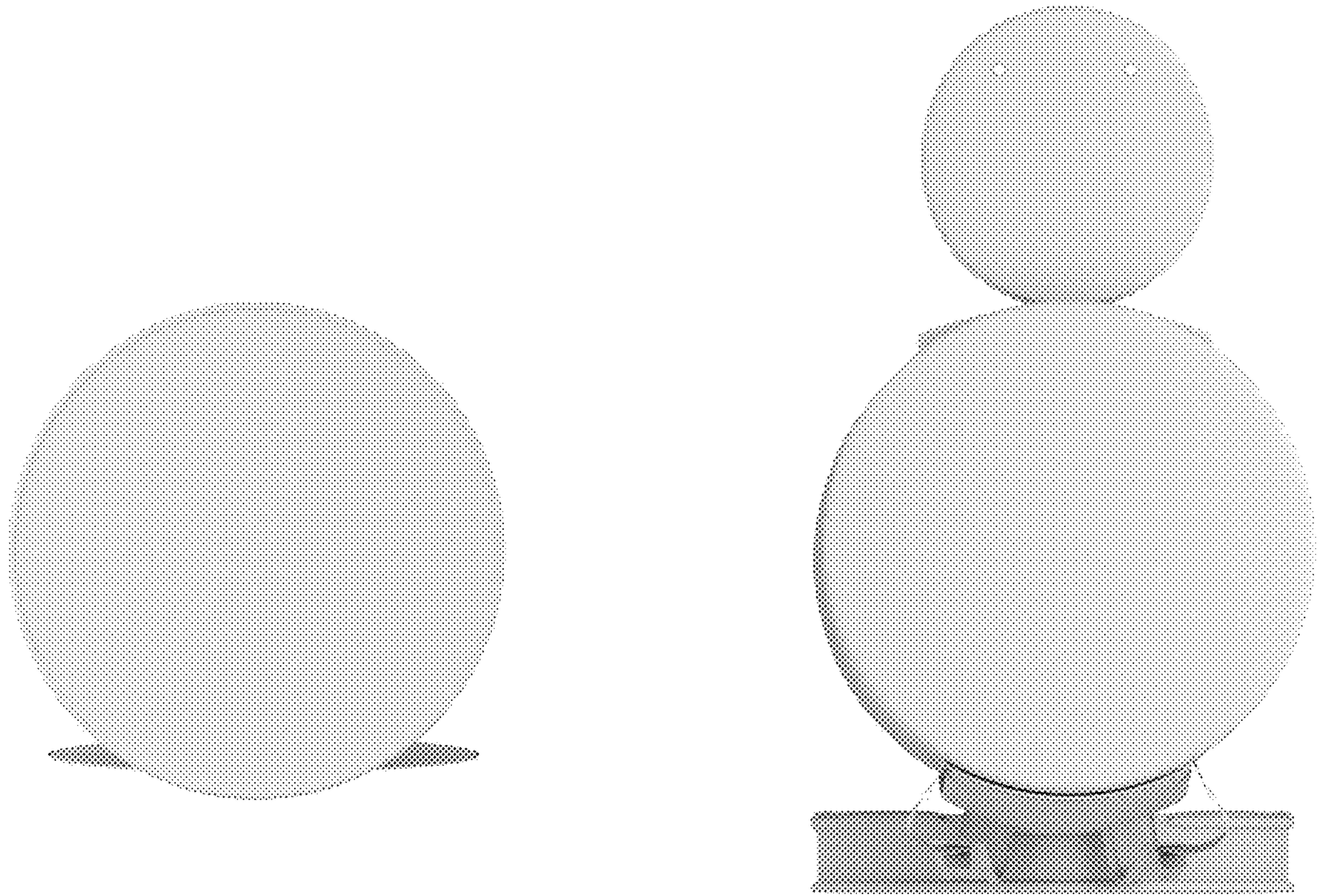
