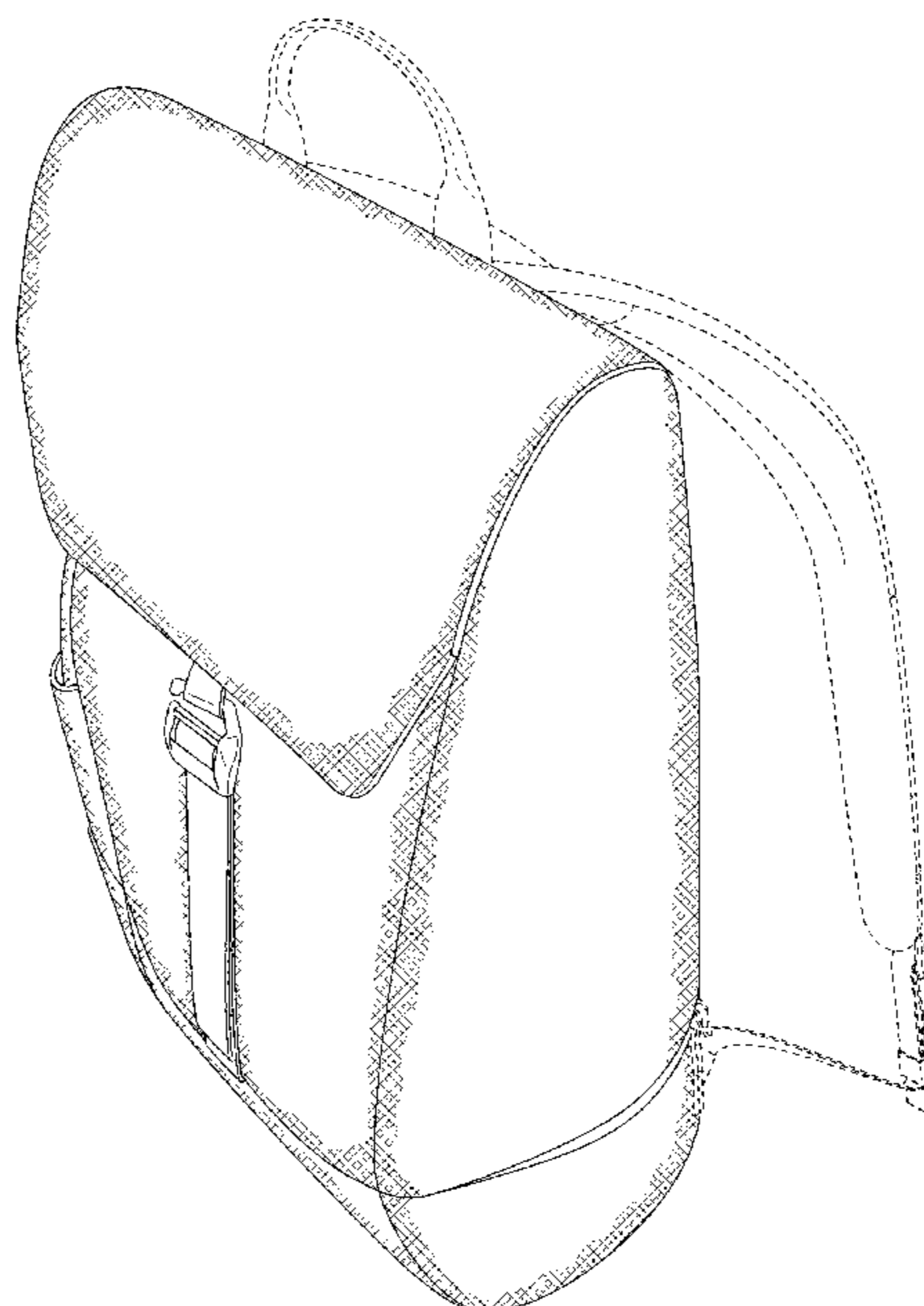
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top front perspective view of a backpack showing the claimed design;

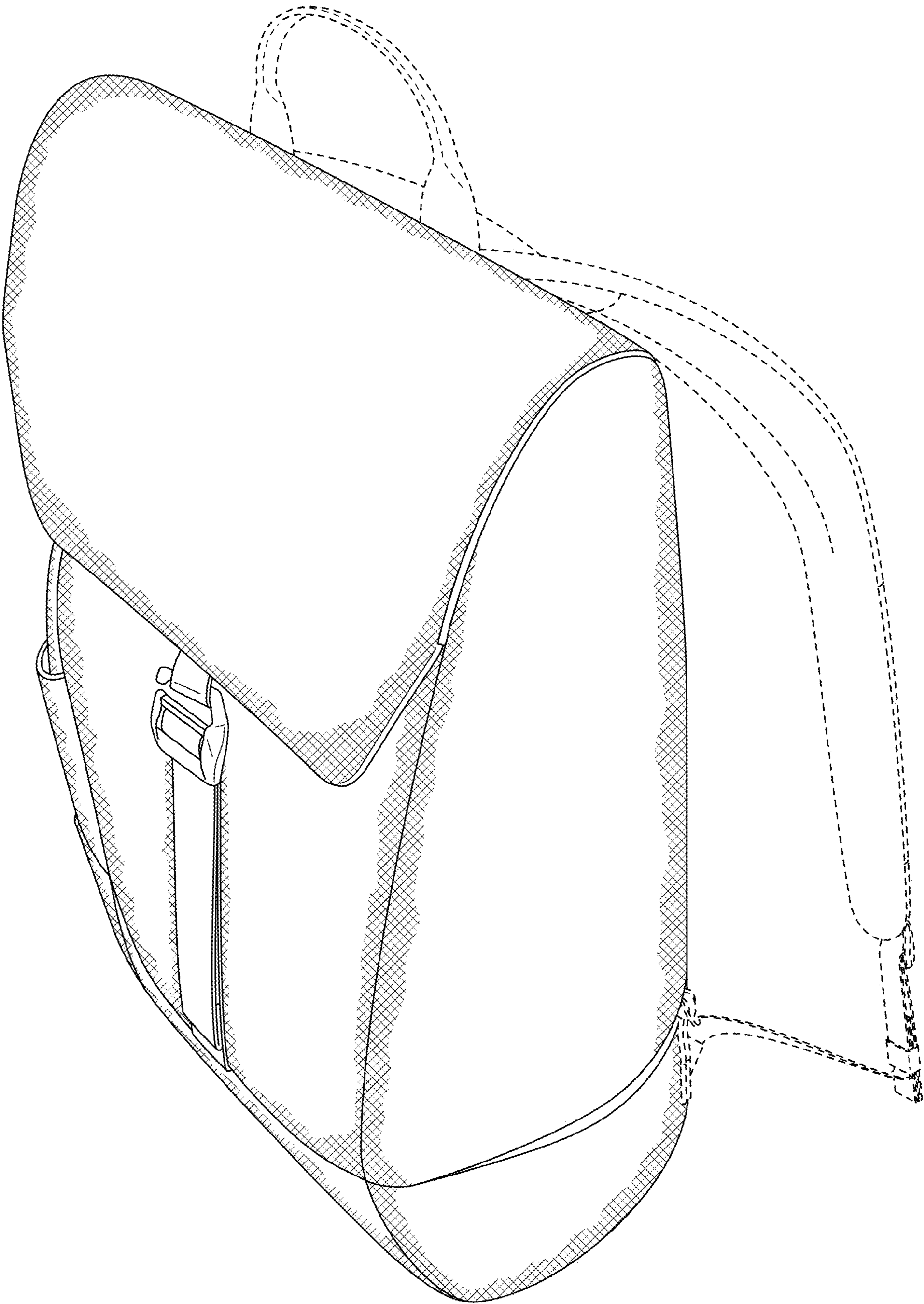

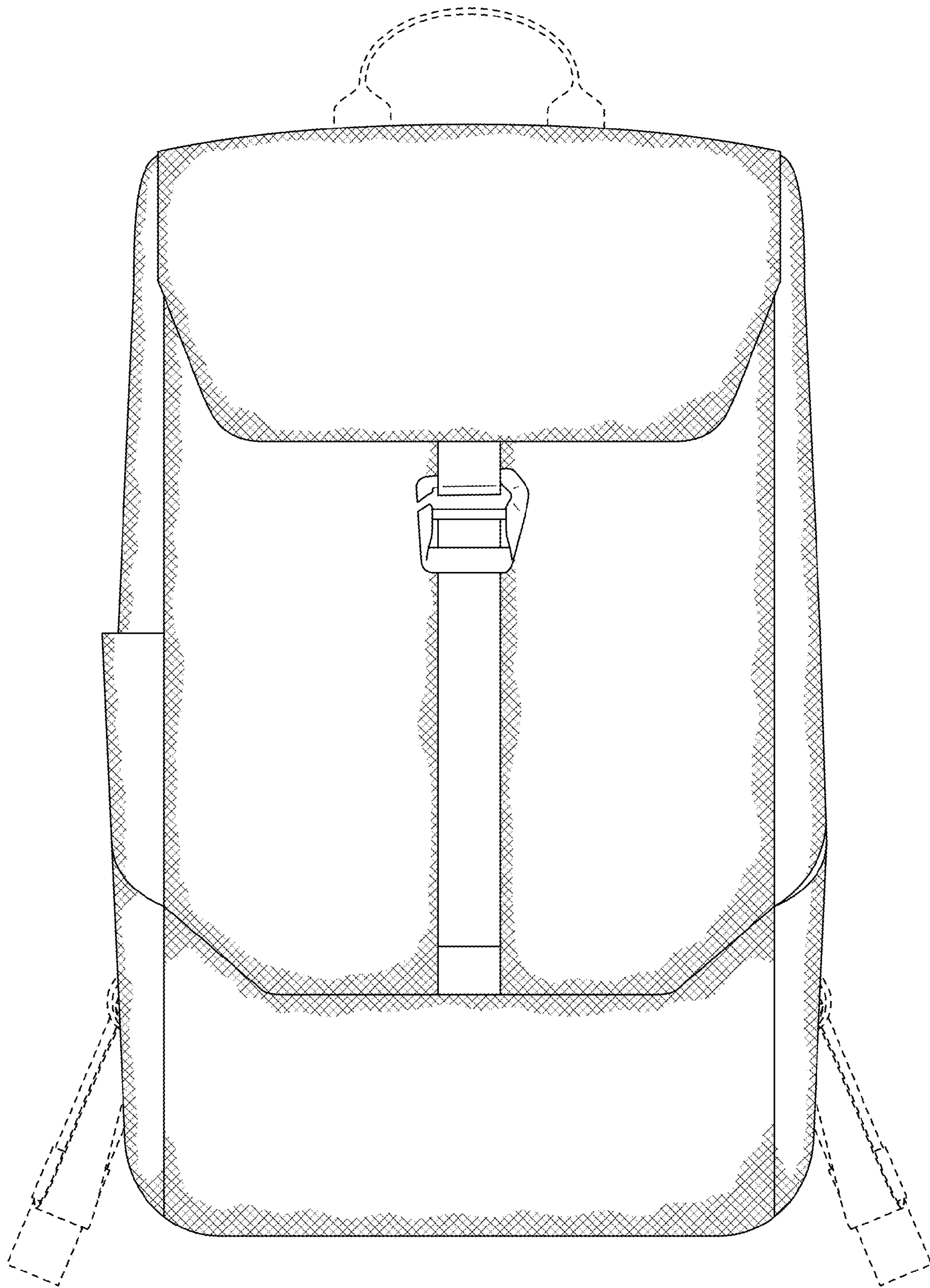

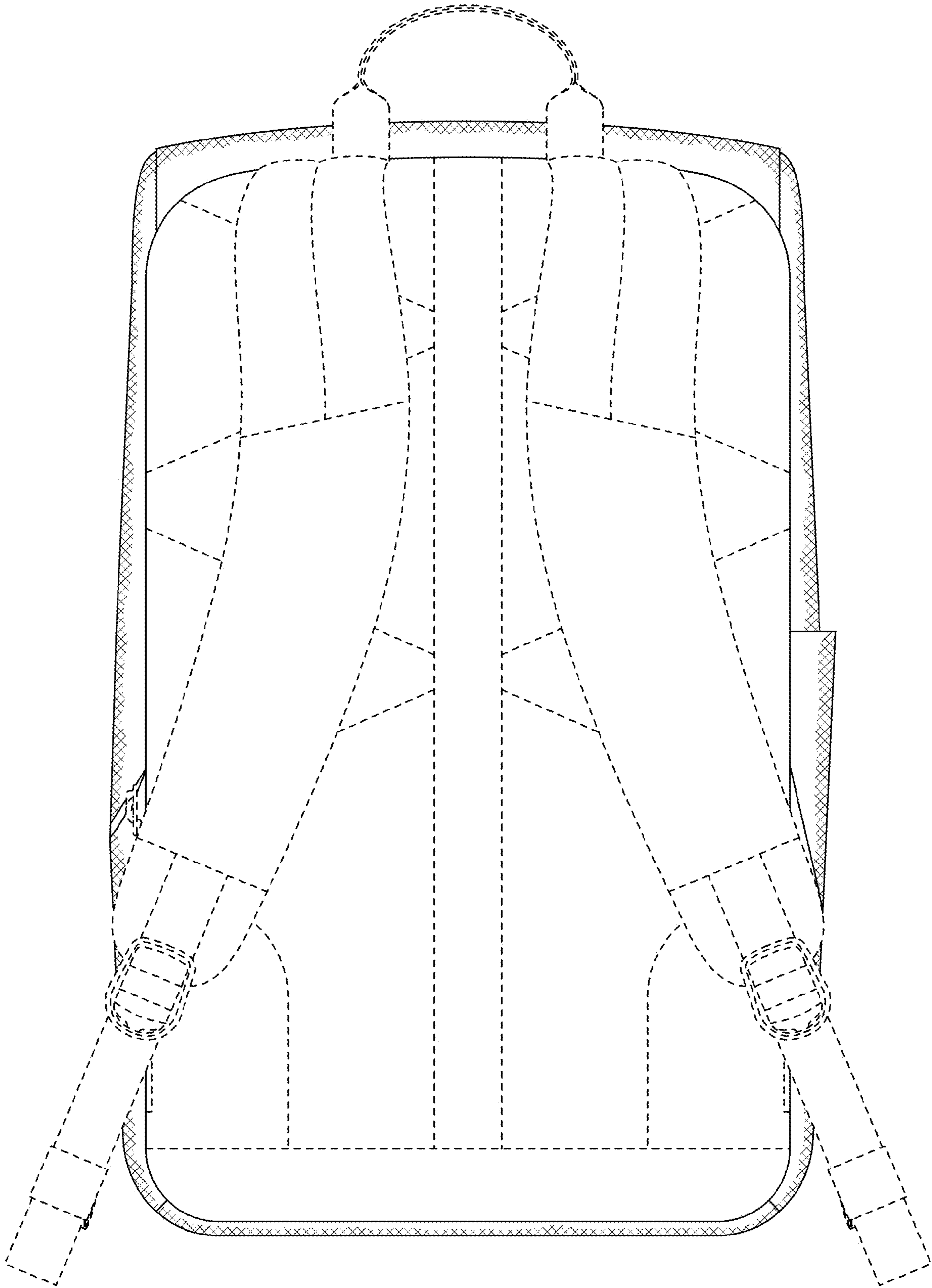

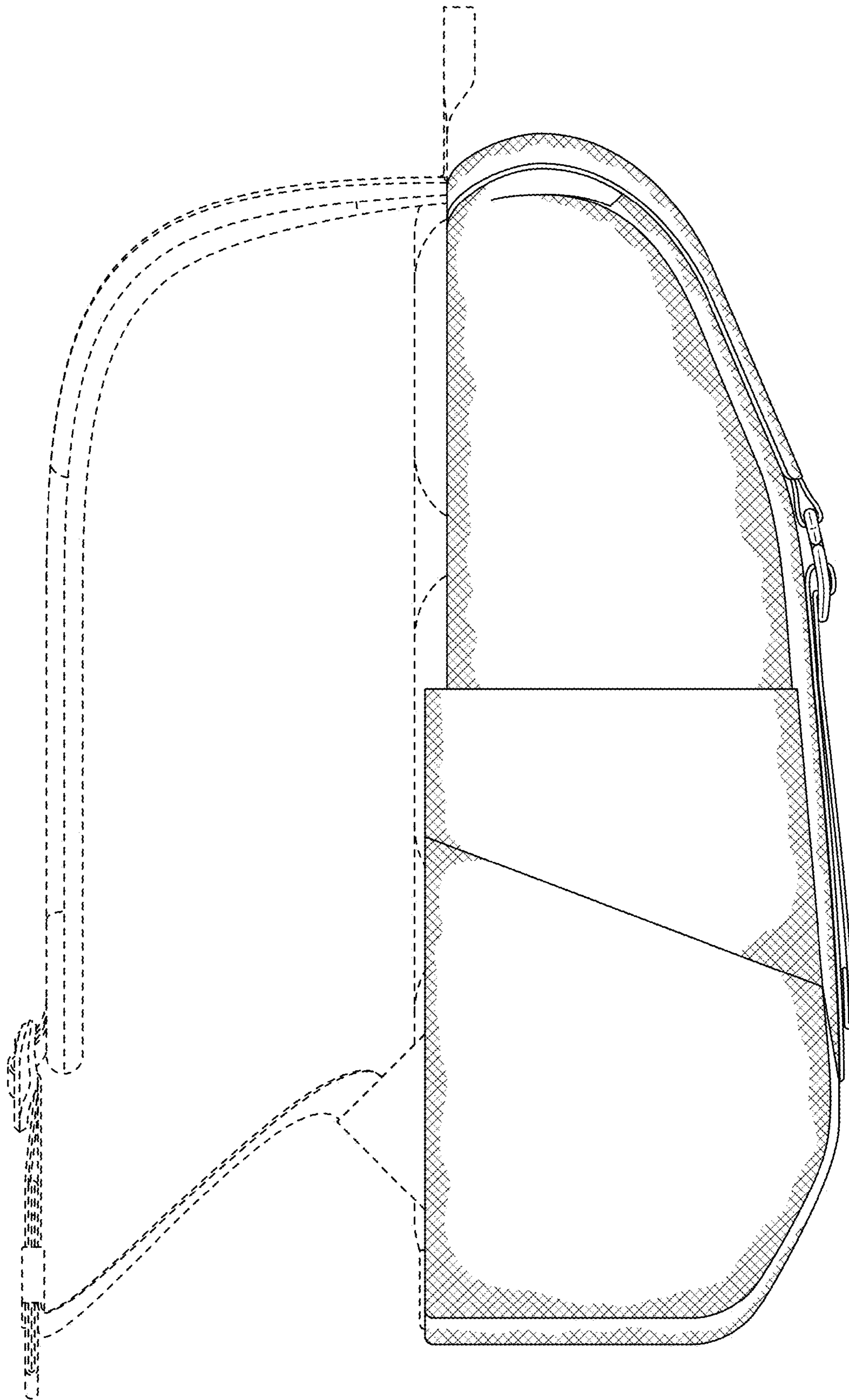

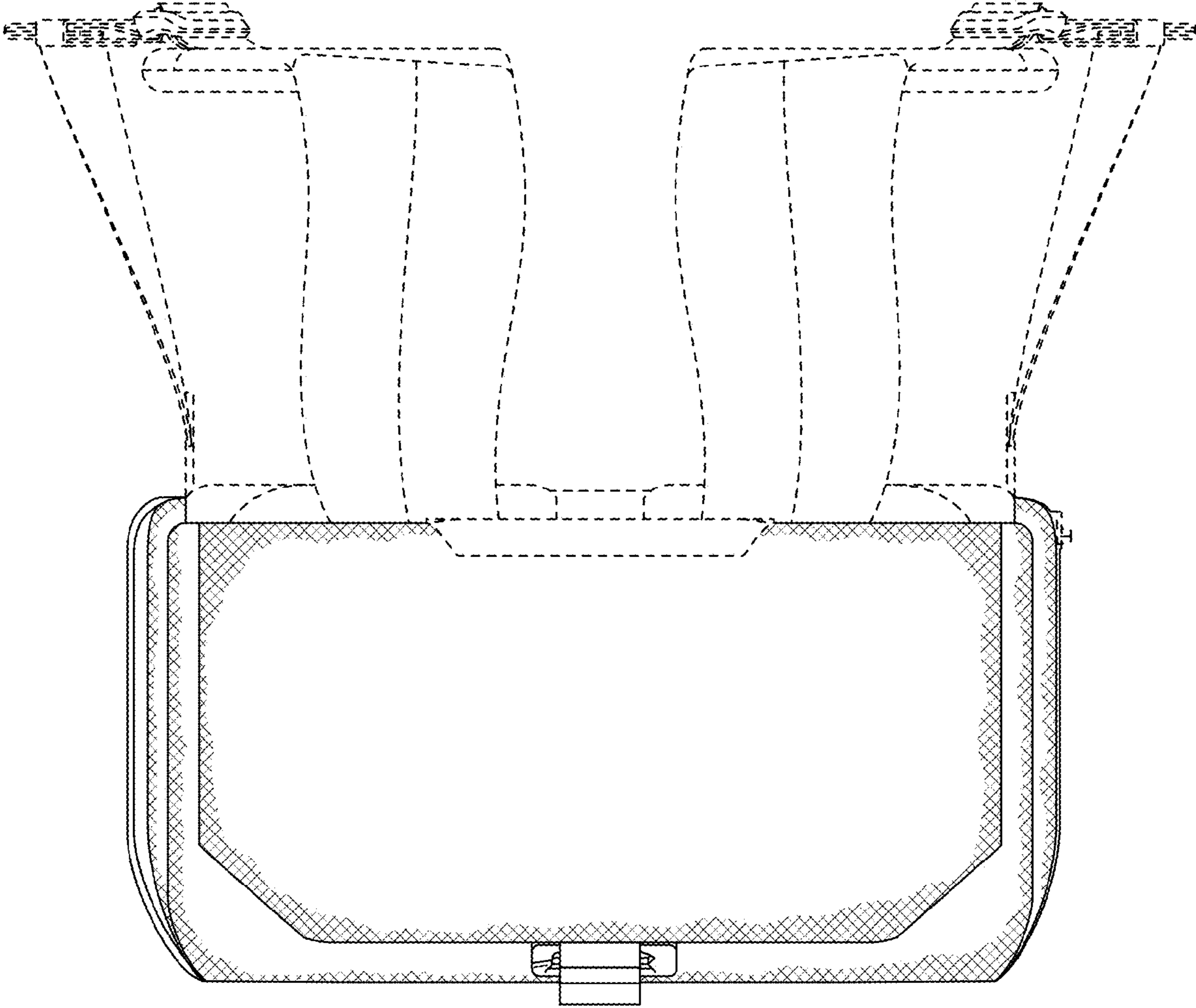

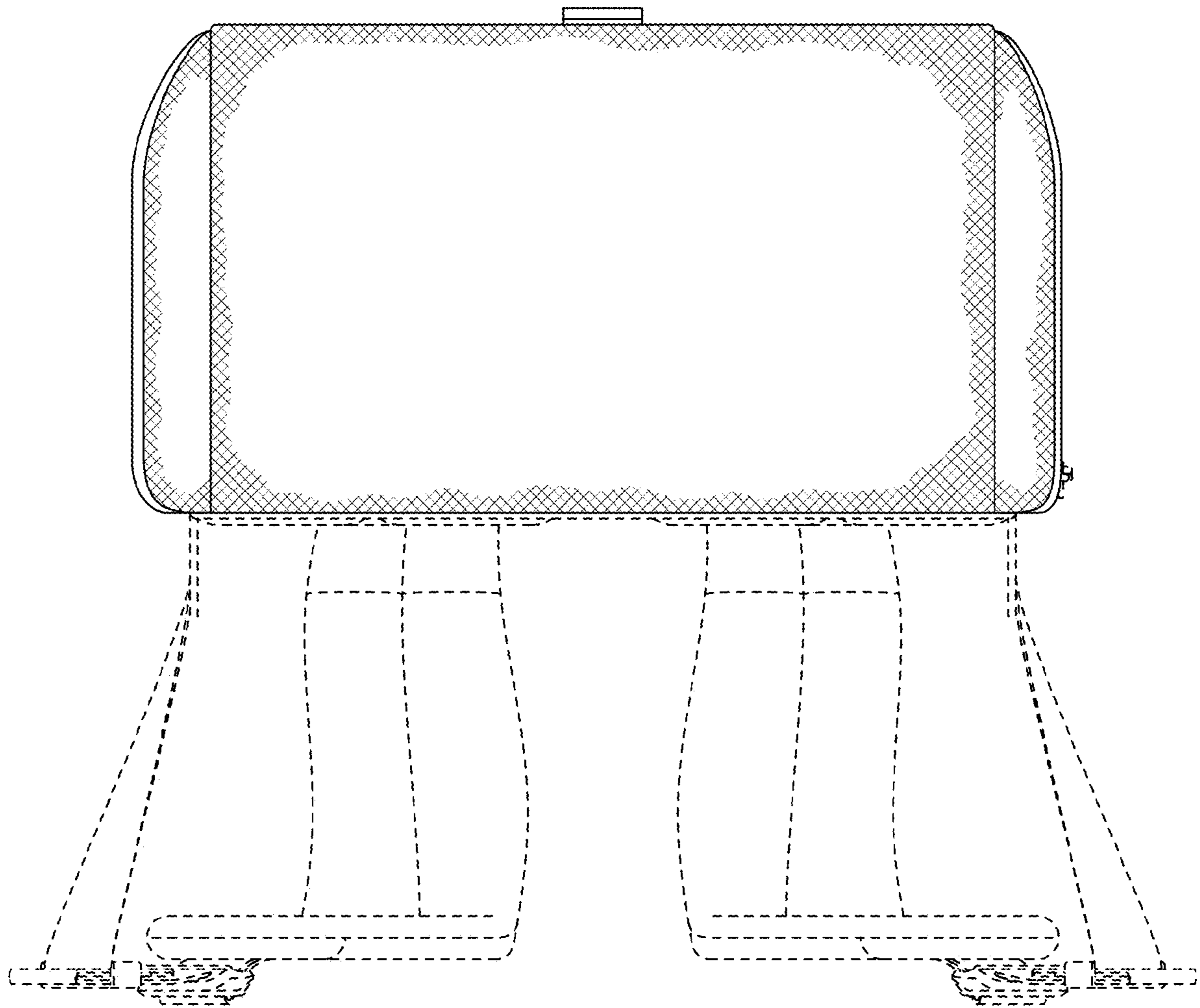
