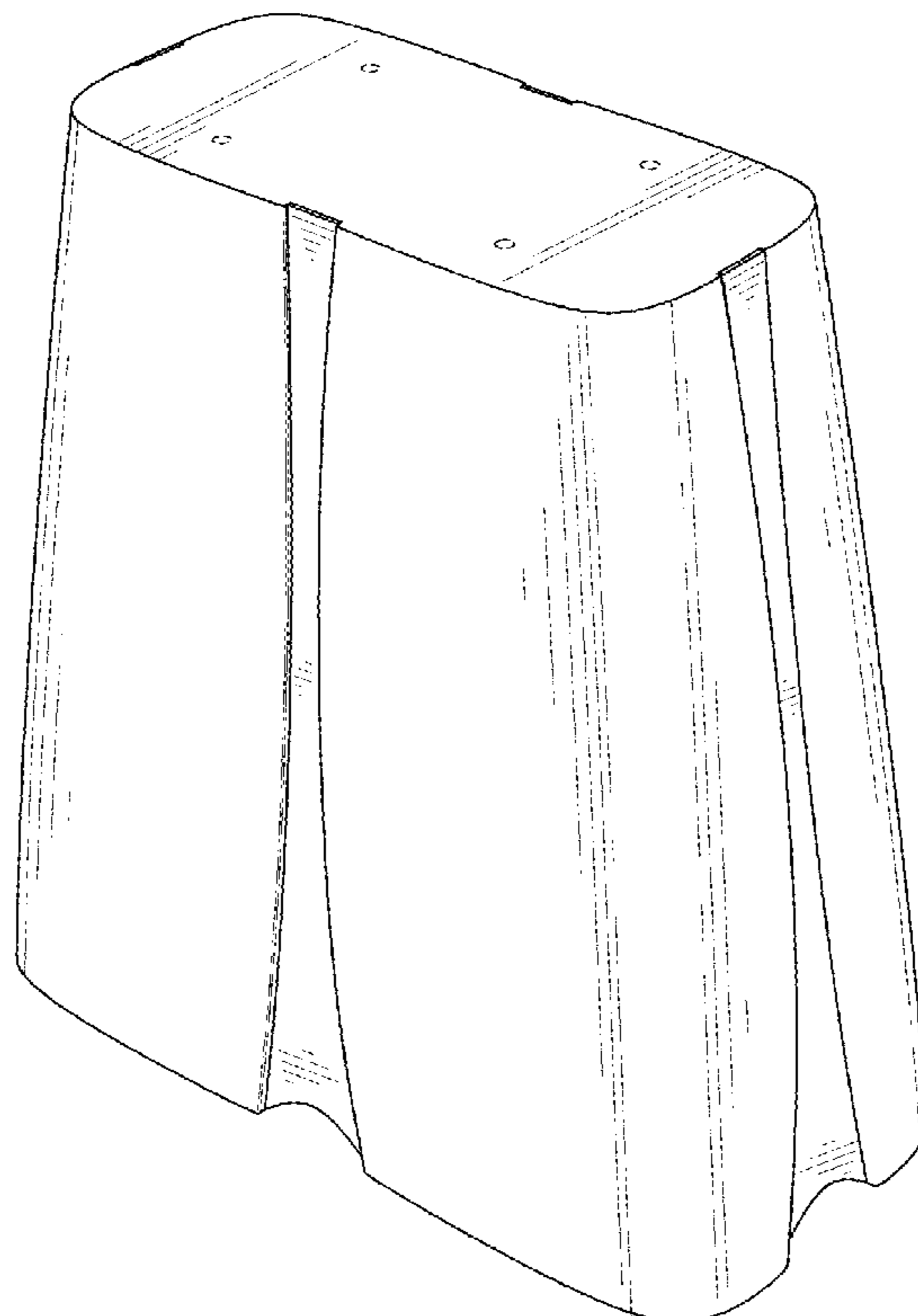
(57) **CLAIM**

The ornamental design for a pedestal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a supporting assembly showing my new design;
FIG. 2 is a front elevational view thereof, the back elevation is identical thereto, and thus omitted;
FIG. 3 is a side elevational view thereof, the opposite elevation is identical thereto, and thus omitted;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a perspective view of the supporting assembly installed with a table and a substrate in use.

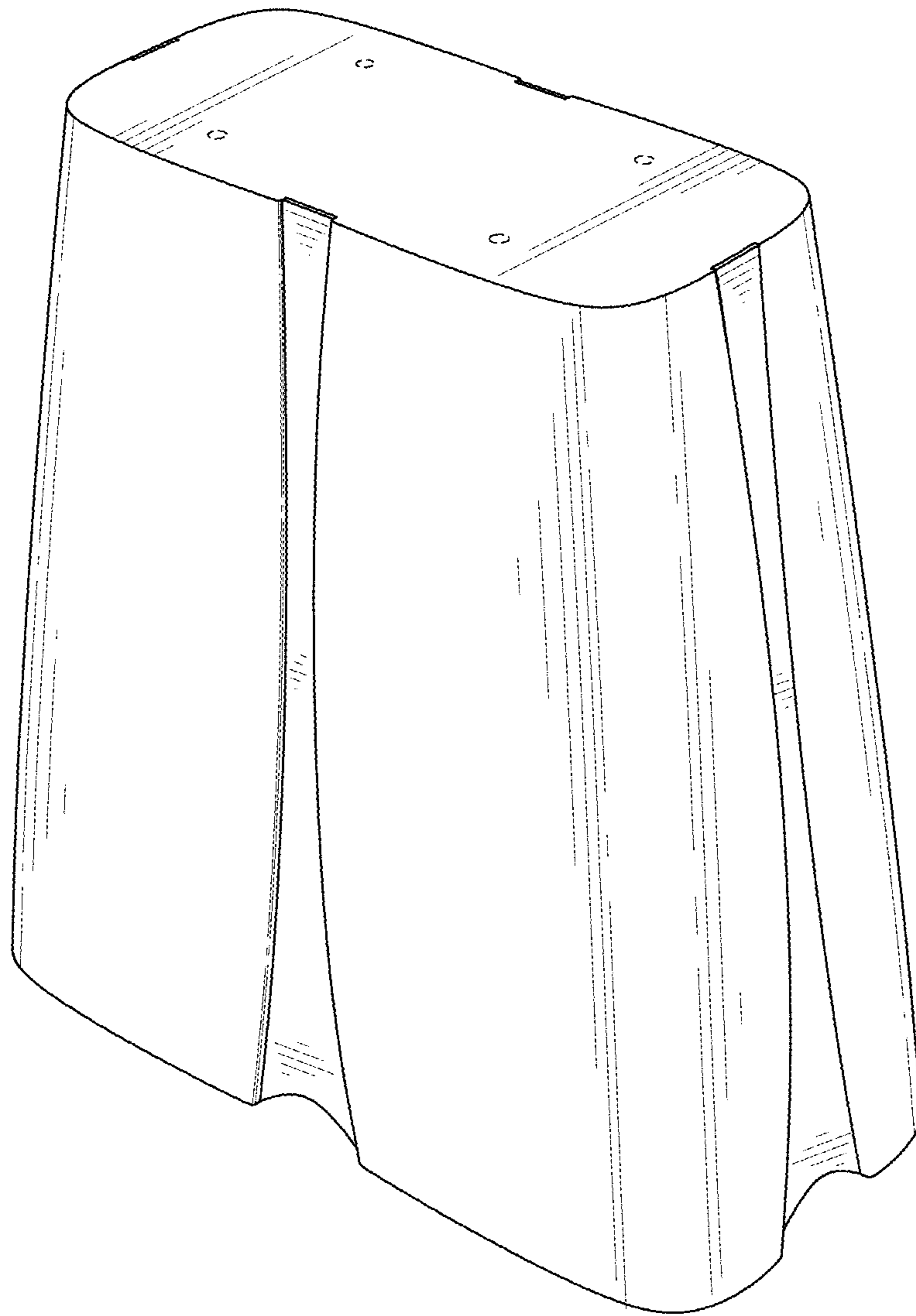

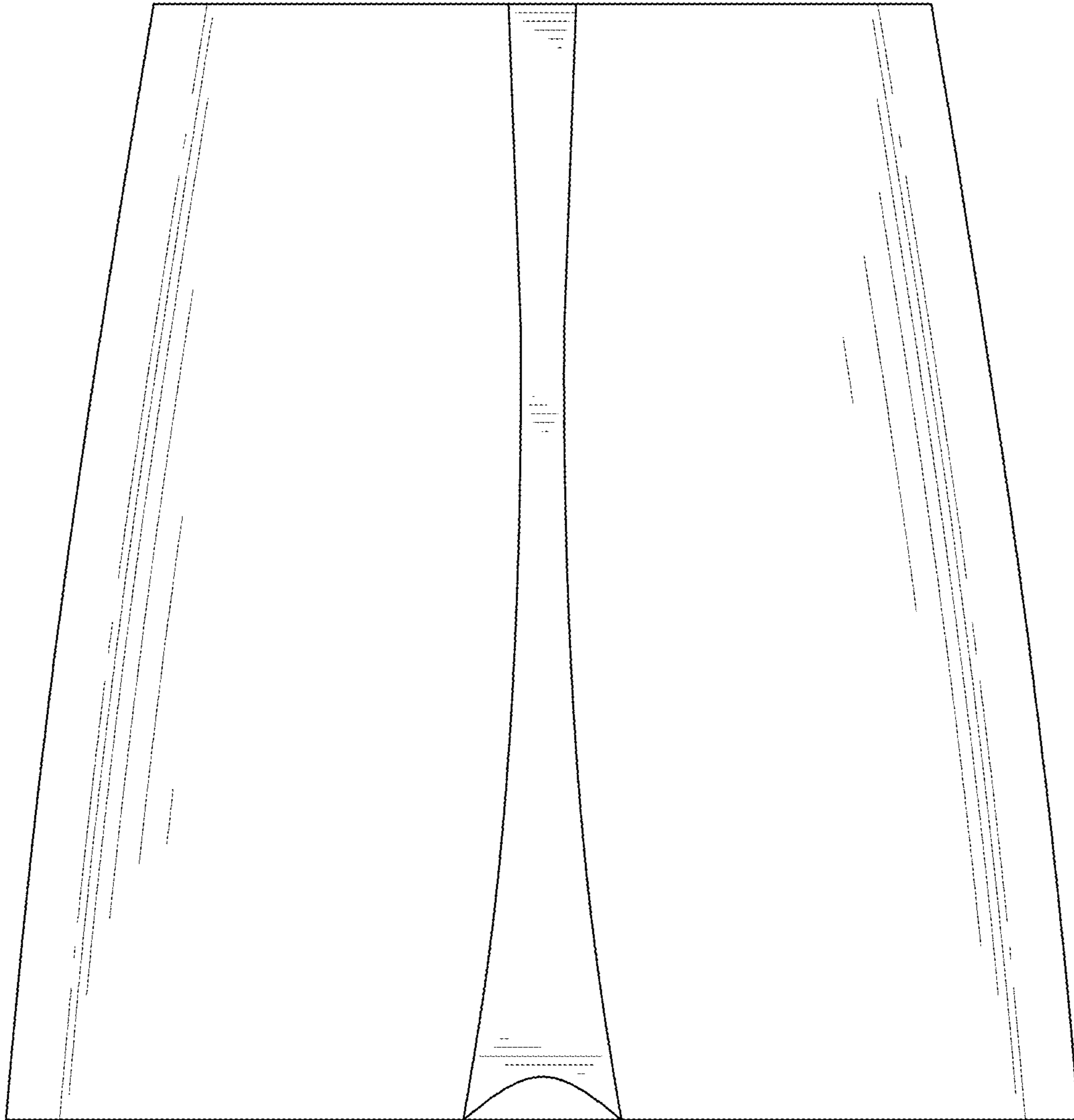

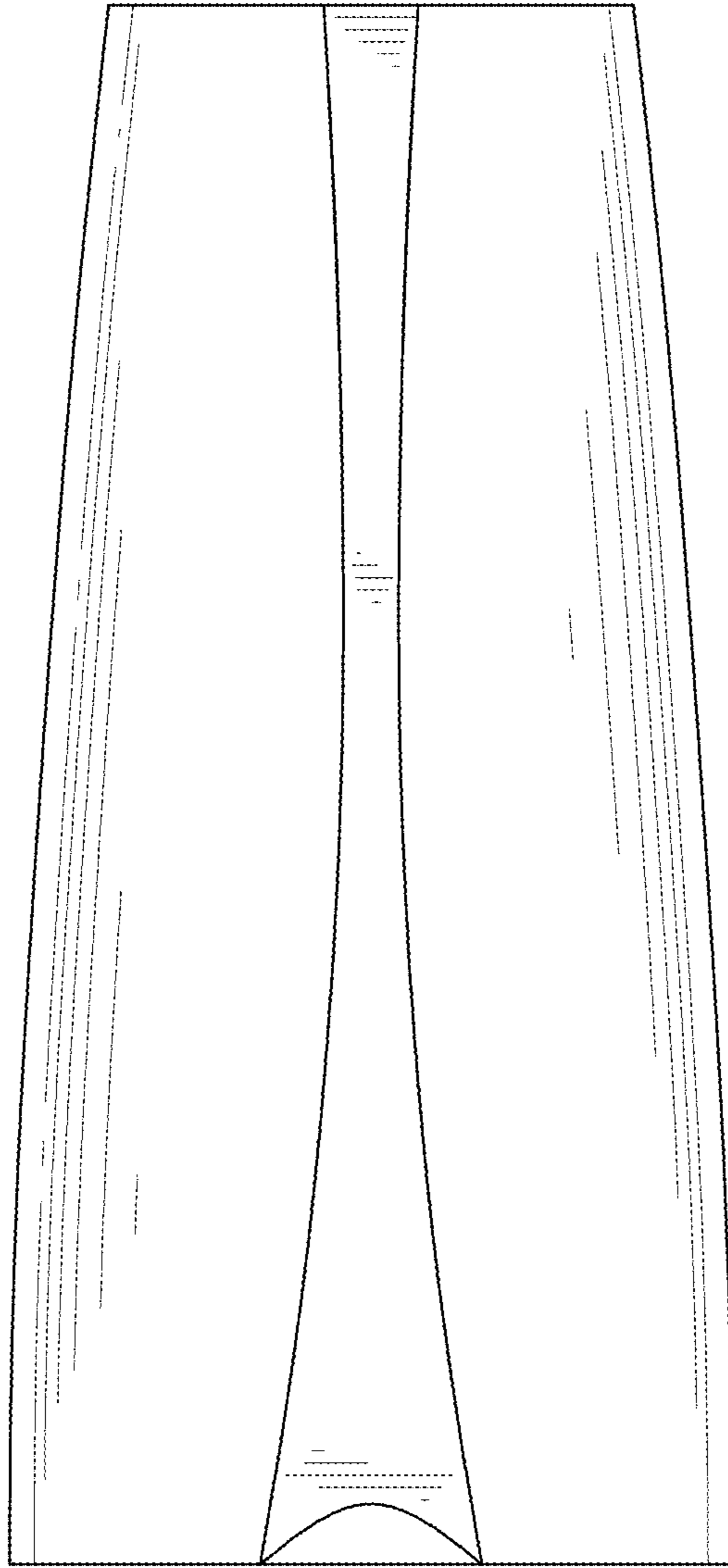

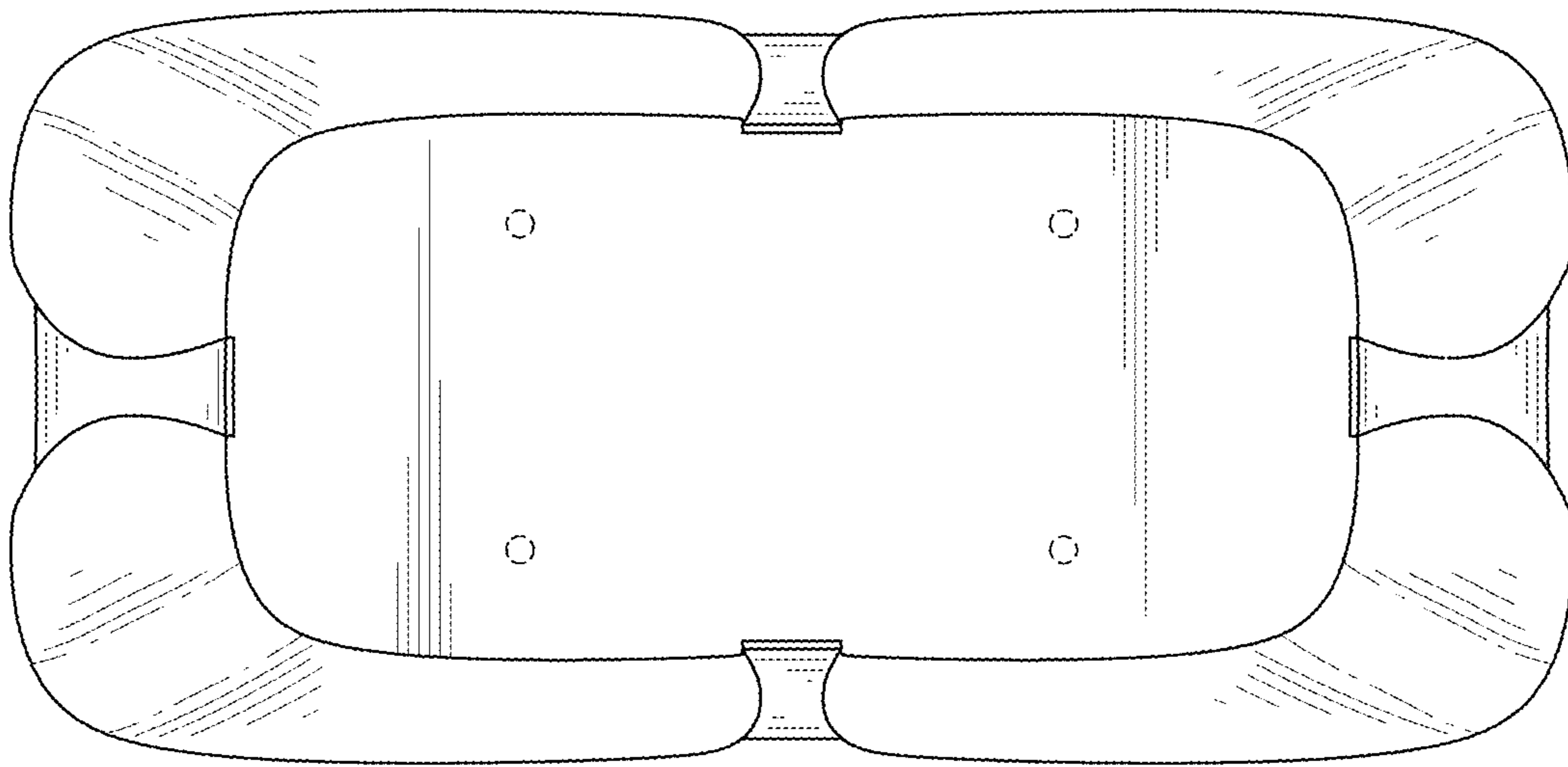

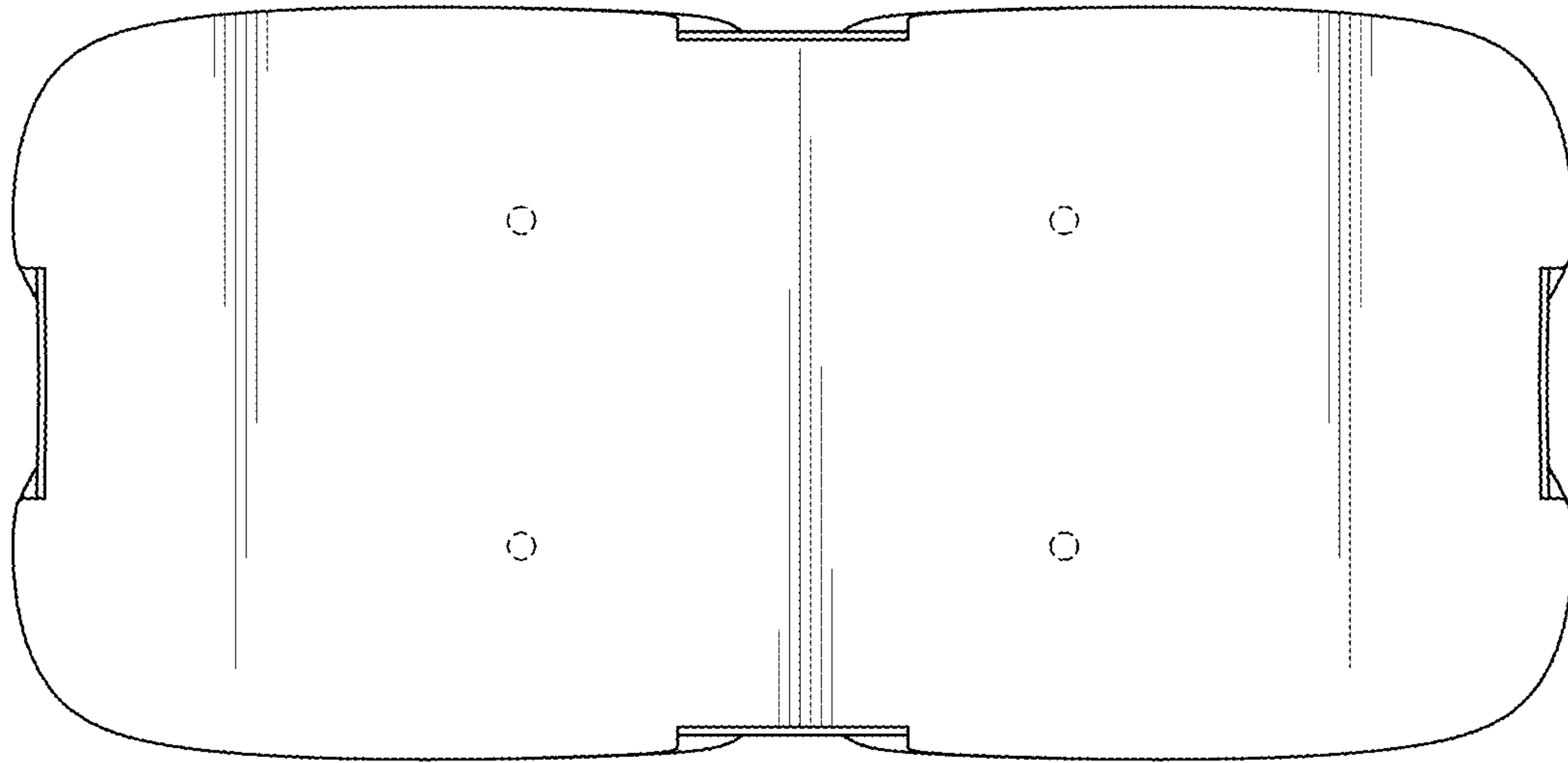

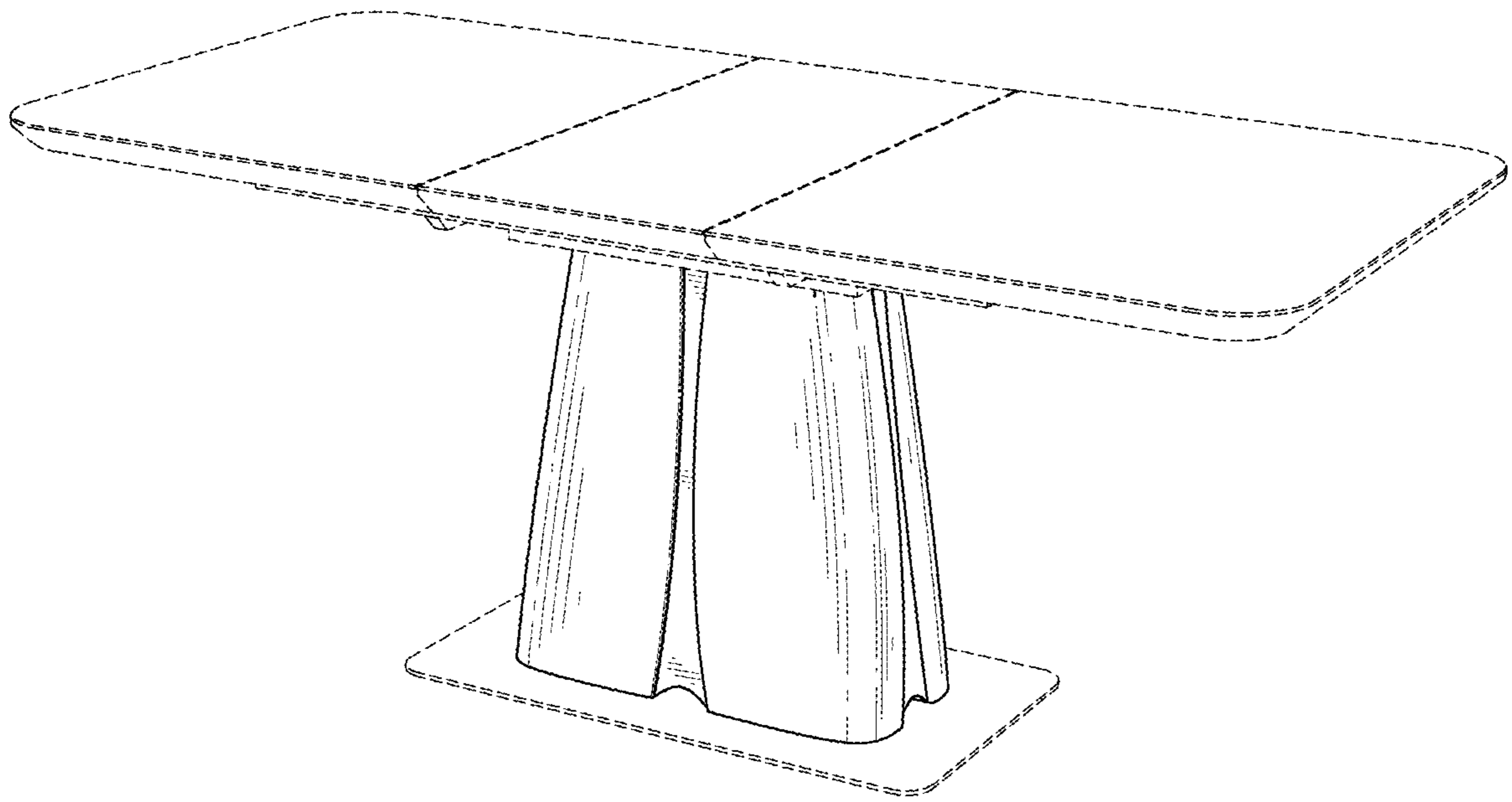
