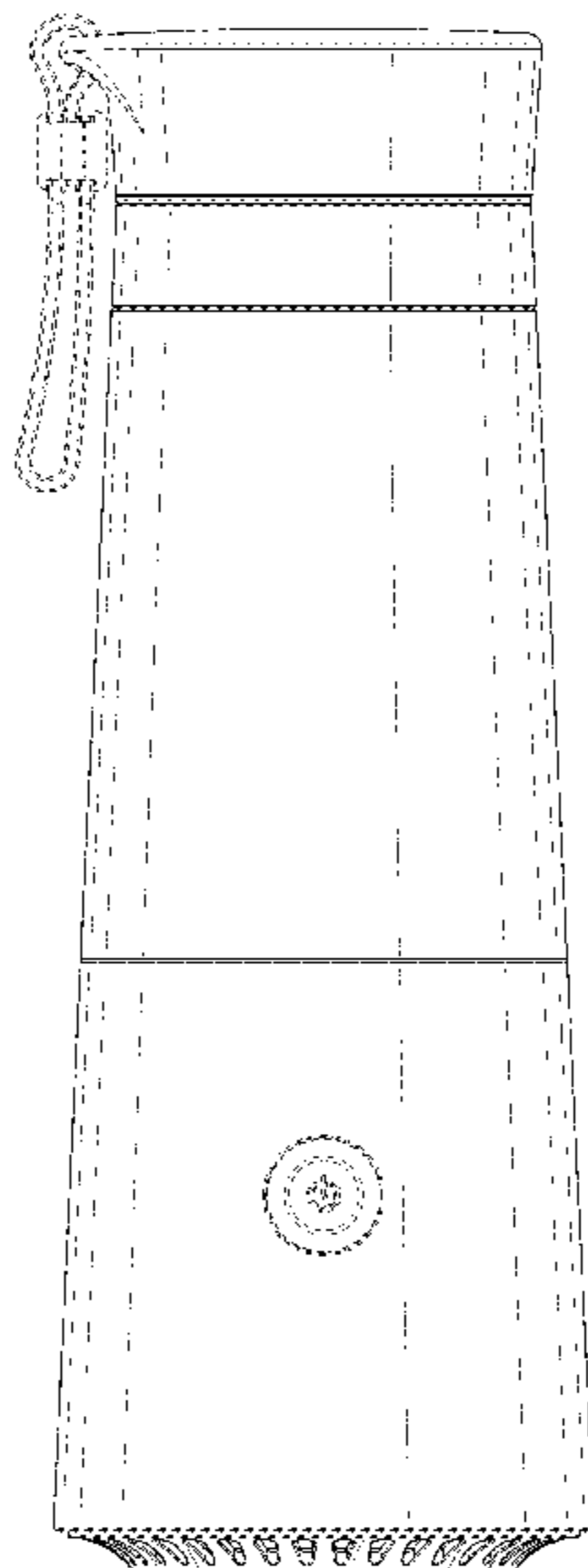
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a right side view of a portable blending apparatus with integrated speaker, showing my new design;

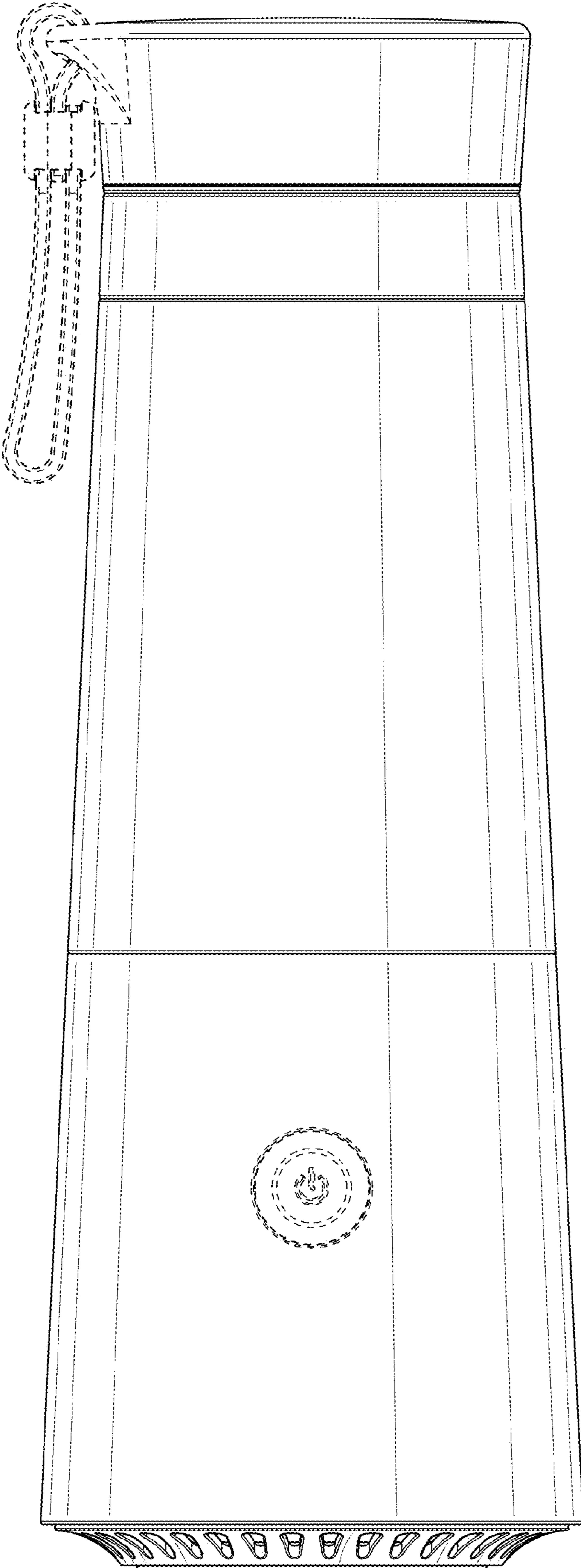

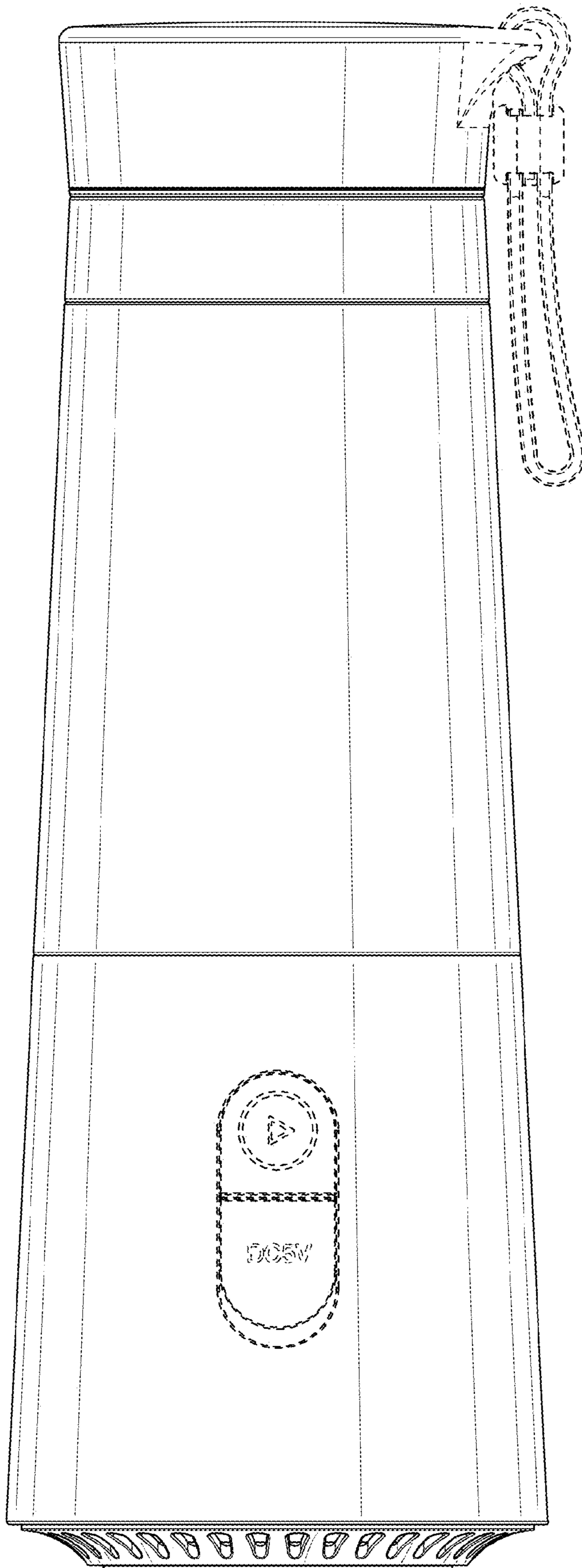

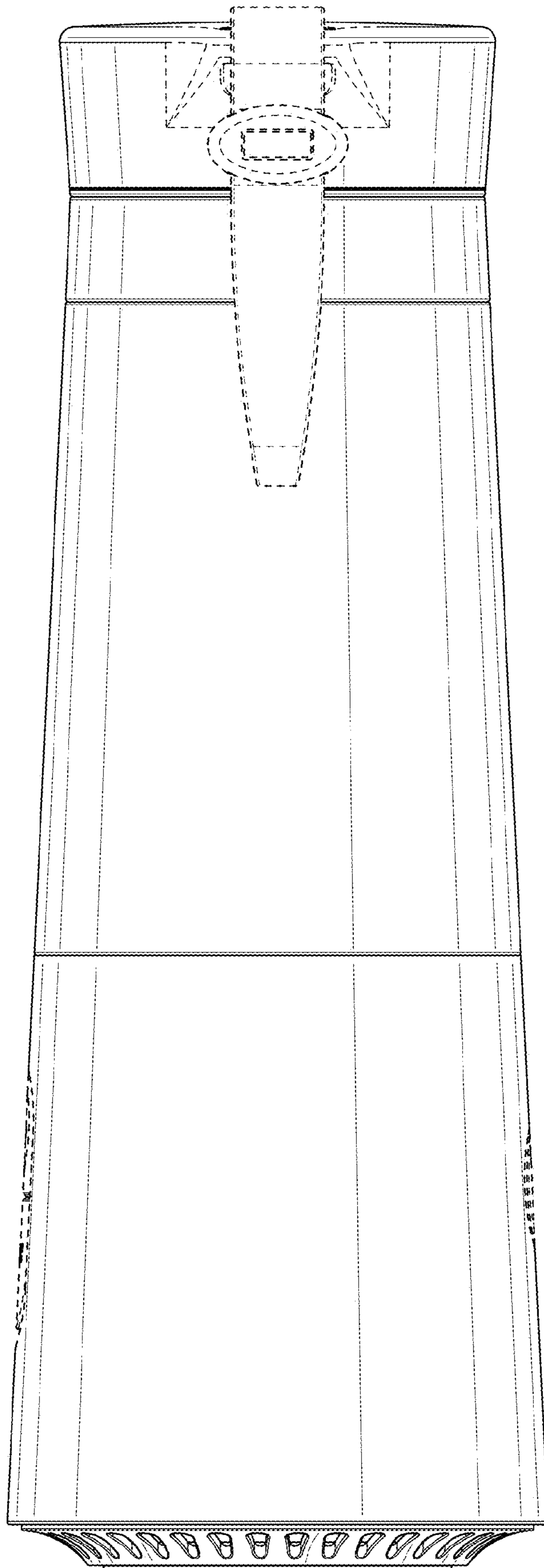

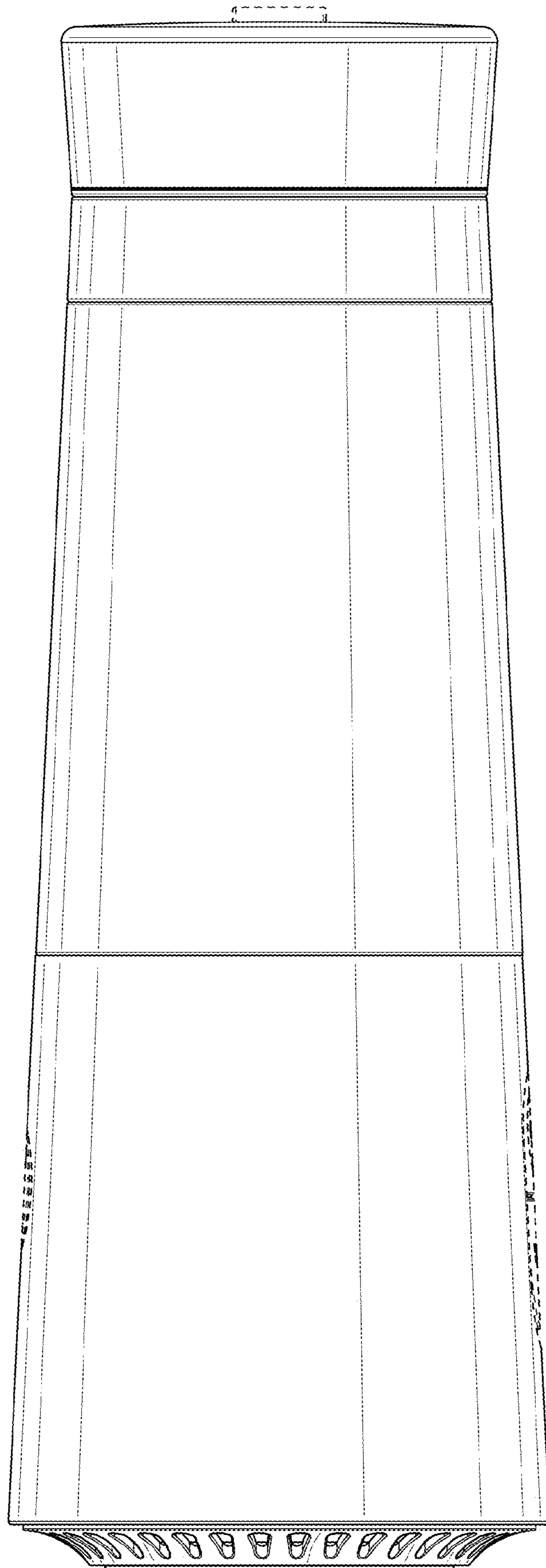

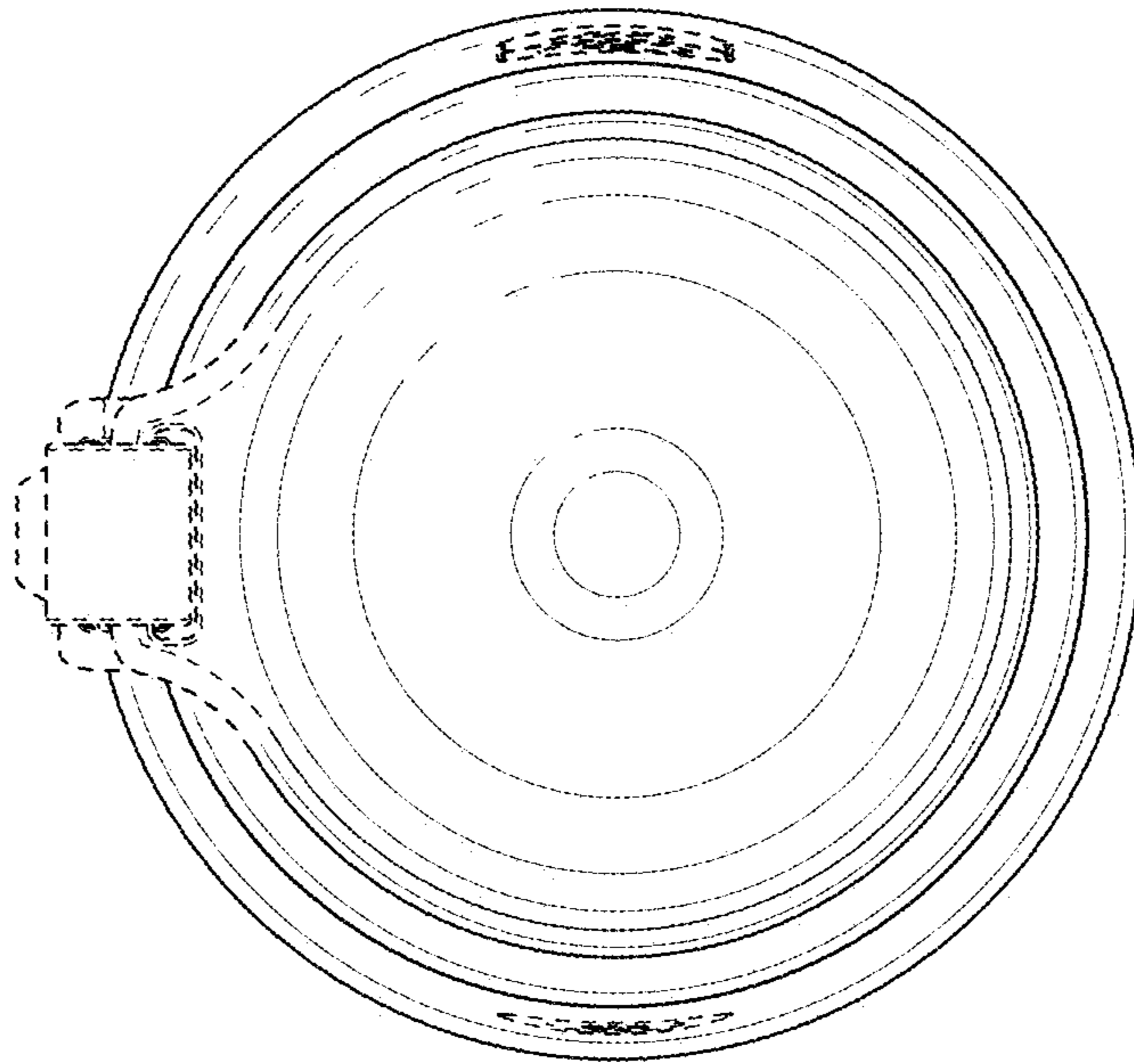

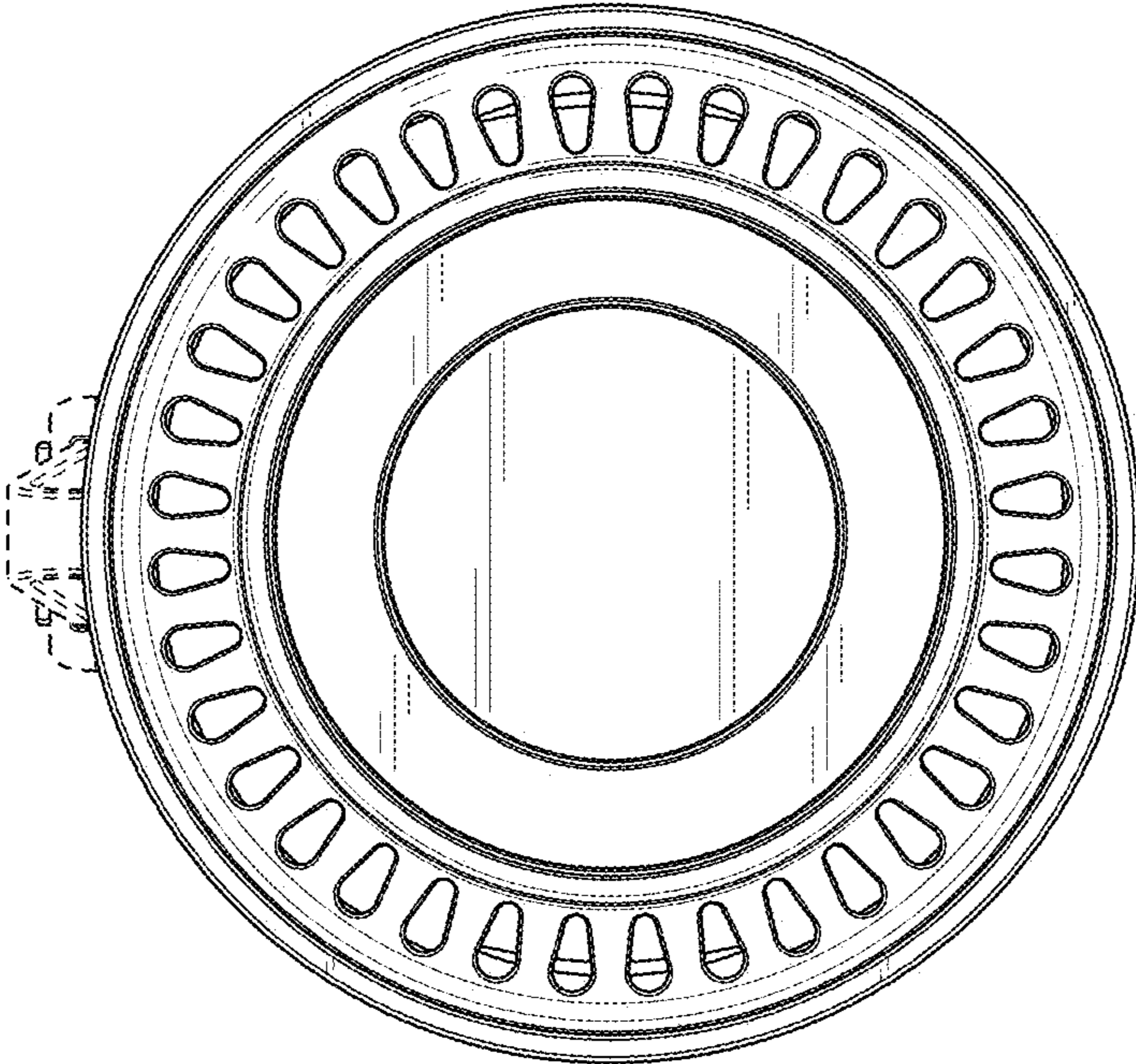
