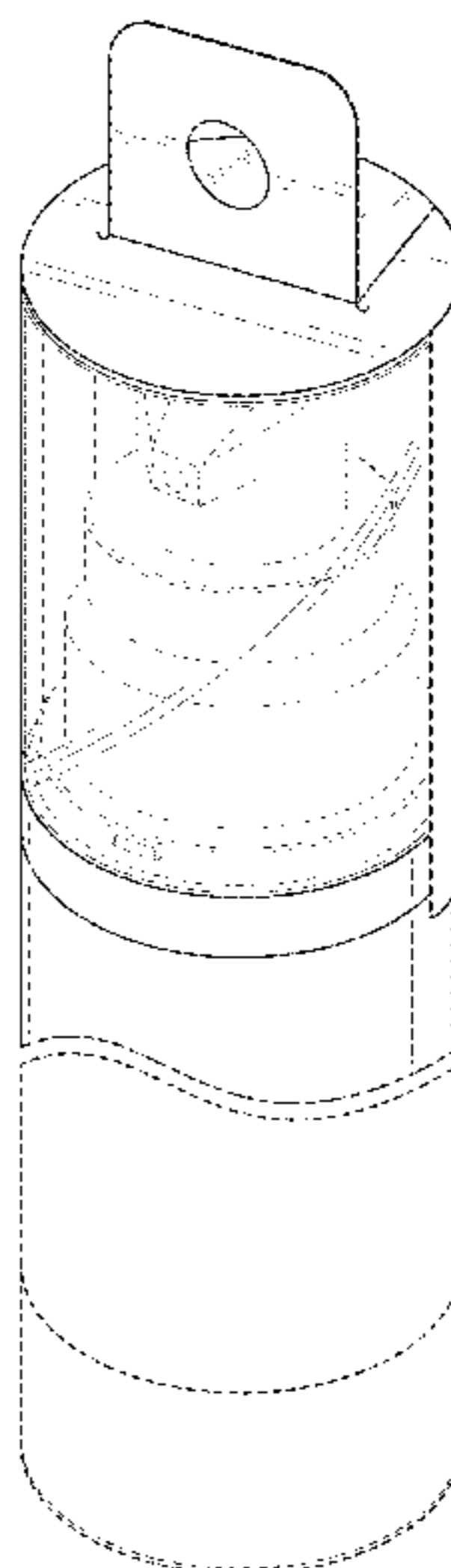
(57) **CLAIM**

The ornamental design for a cosmetic product package having a hang tab, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new design for a cosmetic product package having a hang tab;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view thereof with the cosmetic product package having a hang tab shown in a condition of display on a hanging rod, which forms no part of the claim. The evenly-spaced broken lines depicting the bottom portion and applicator of the claim form no part of the claimed design. The long dash-short dash broken lines shown in the drawings form no part of the claimed design.

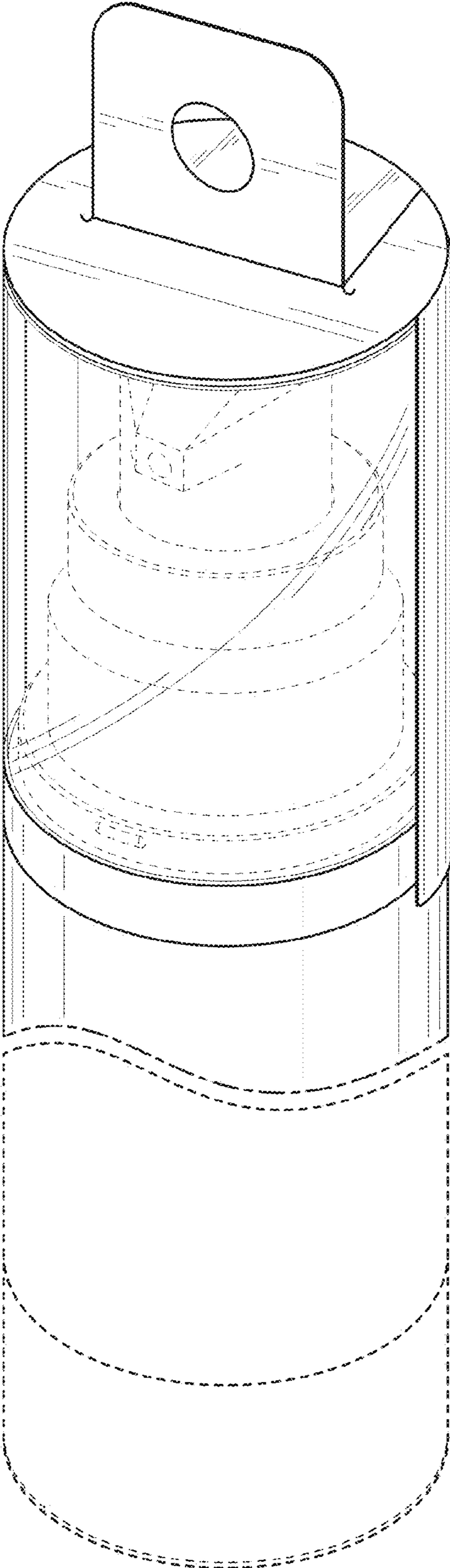

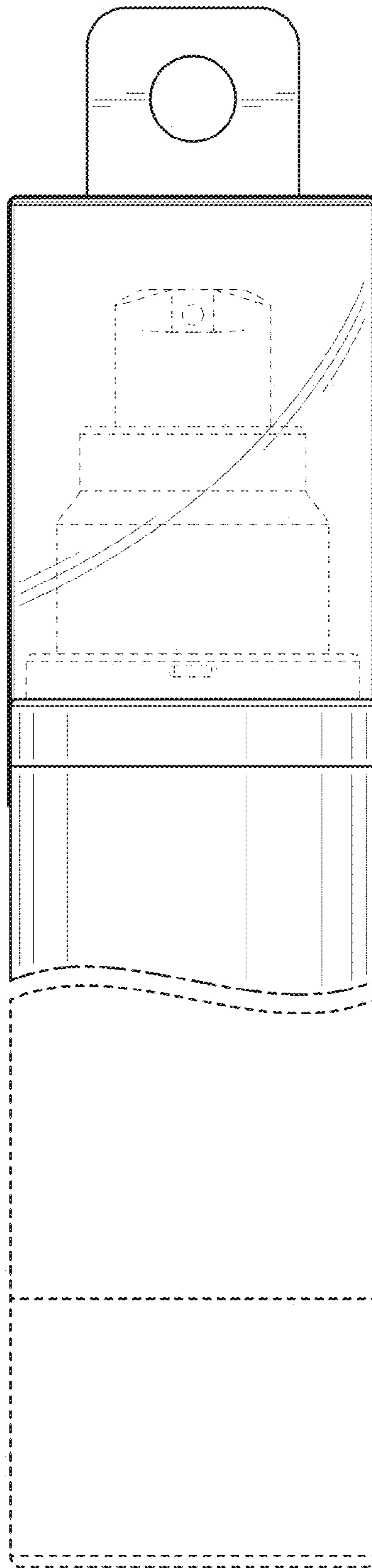

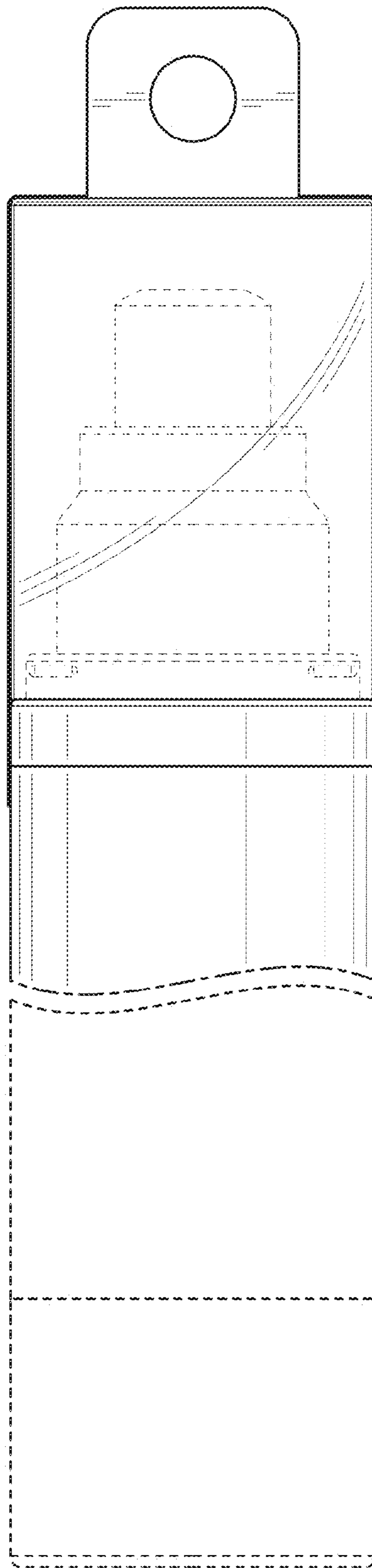

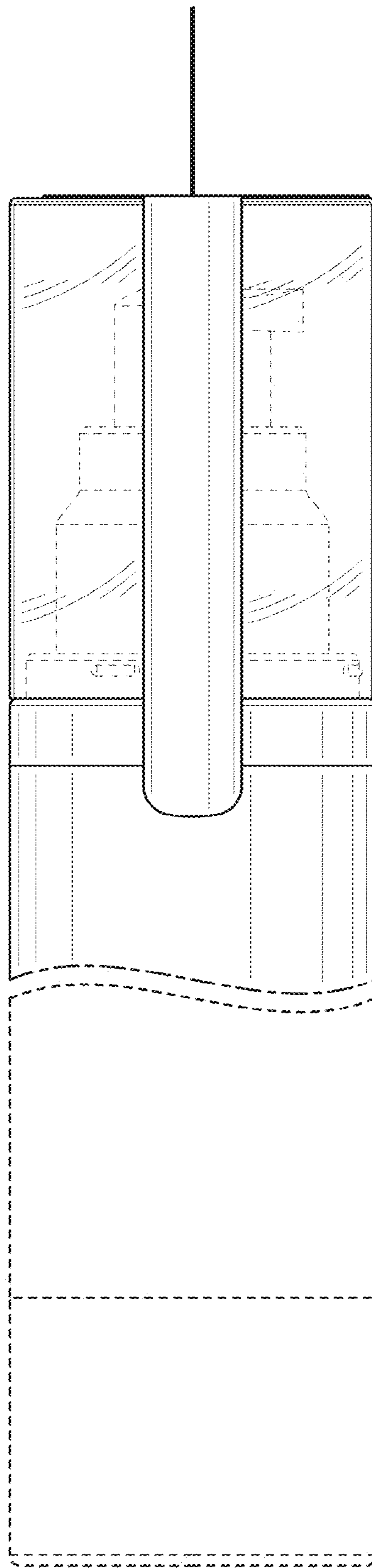

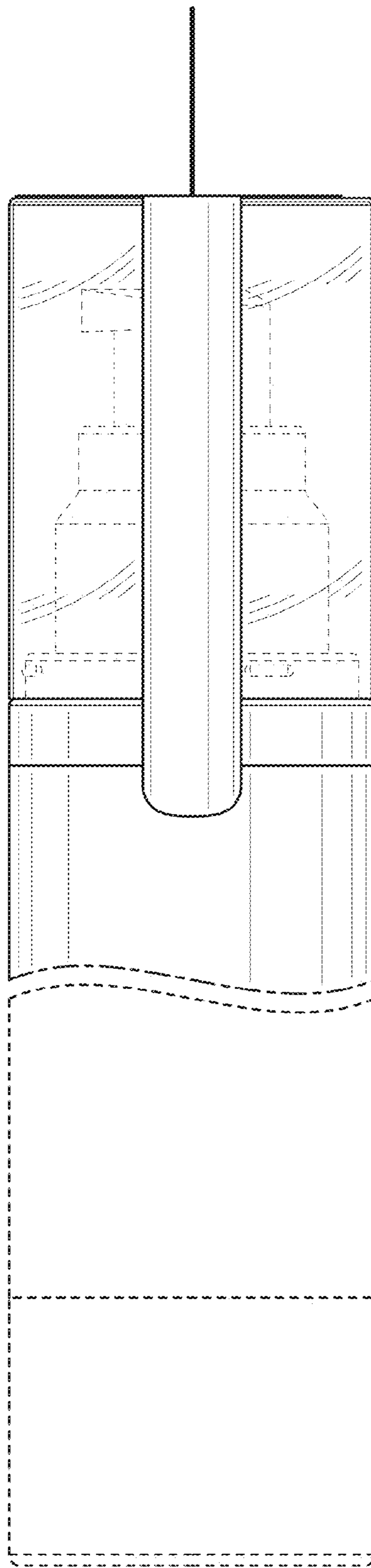

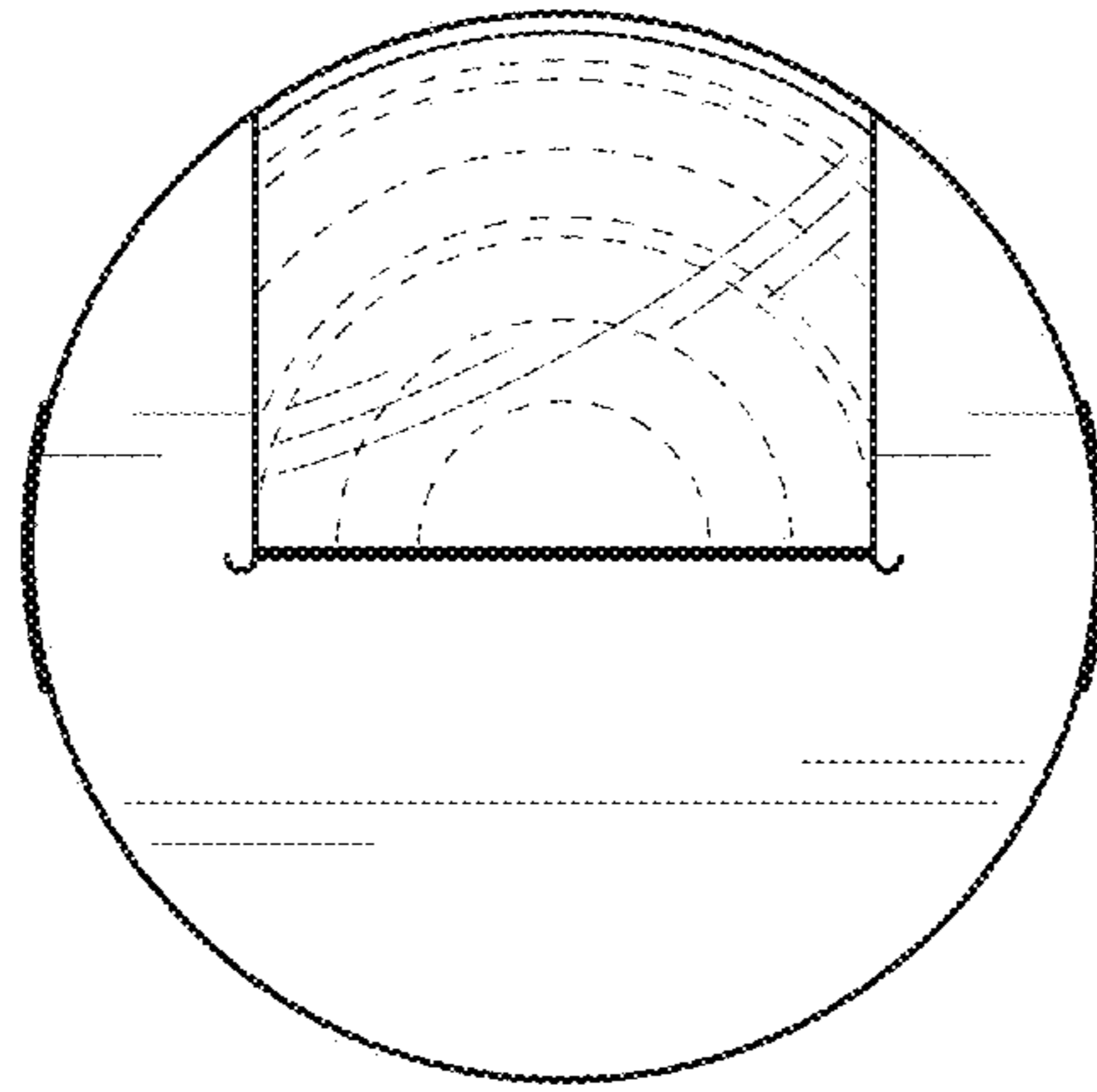

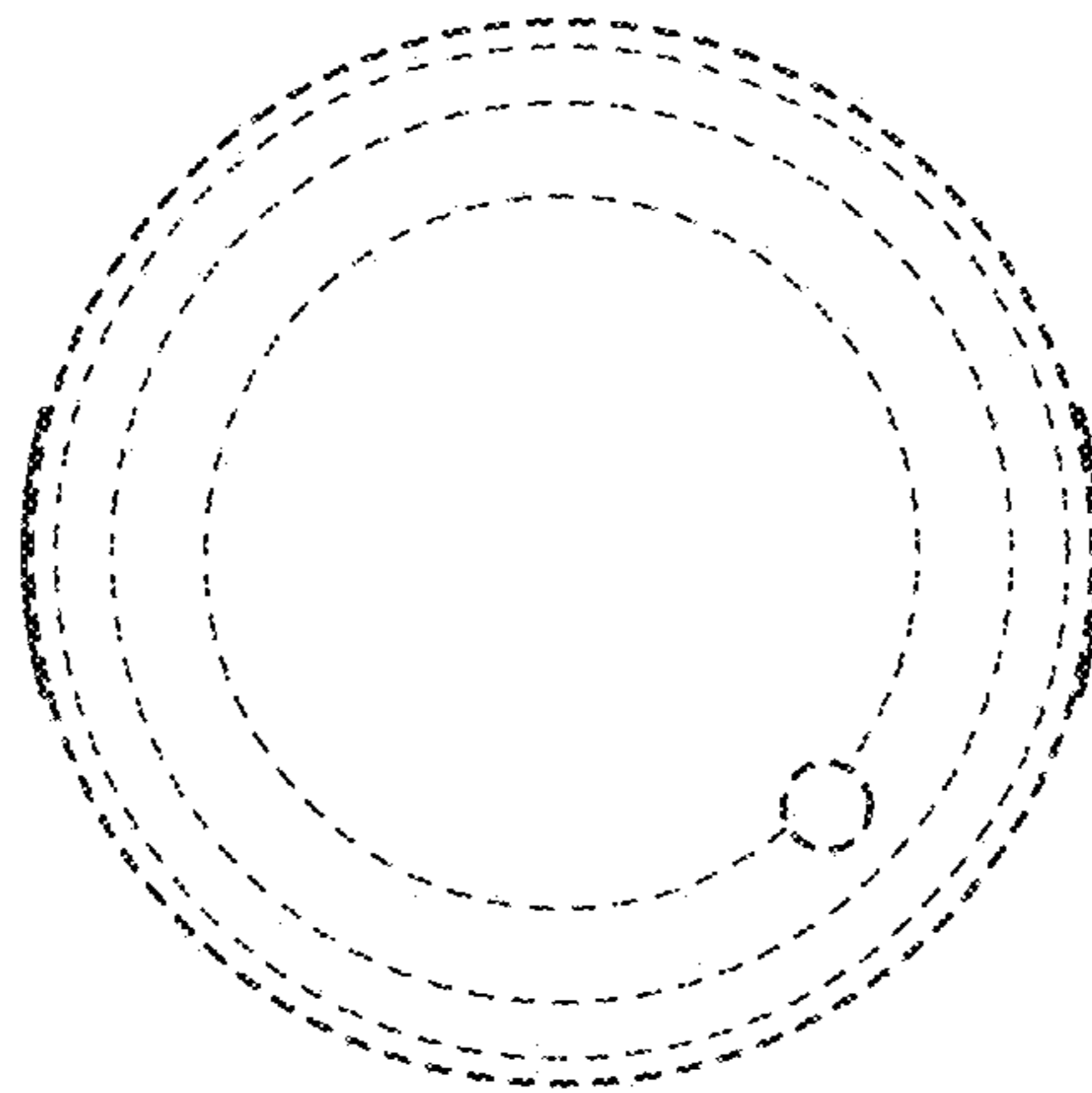

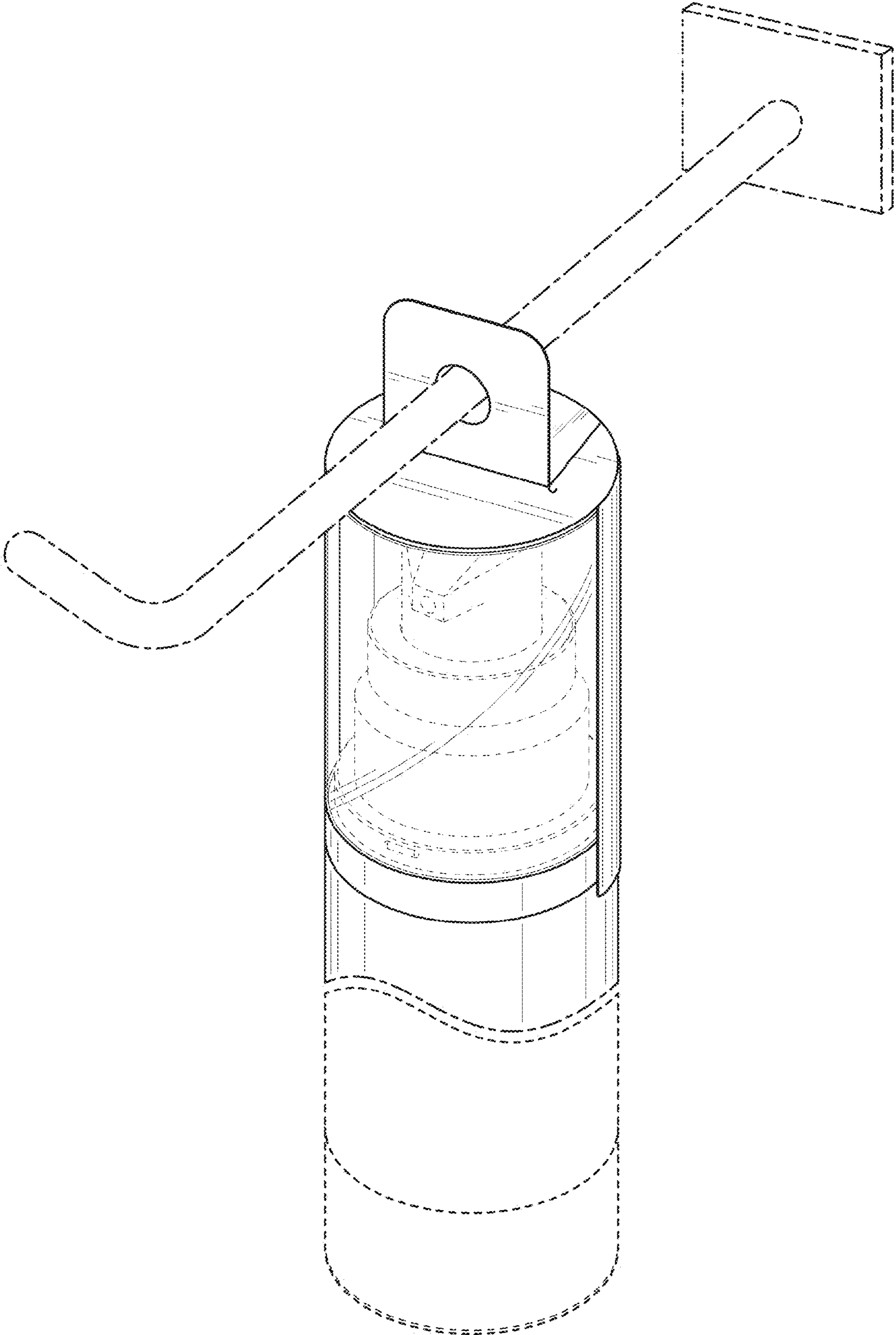
