(57) **CLAIM**

The ornamental design for an insert for a container for cupcakes, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the insert for a container for cupcakes;

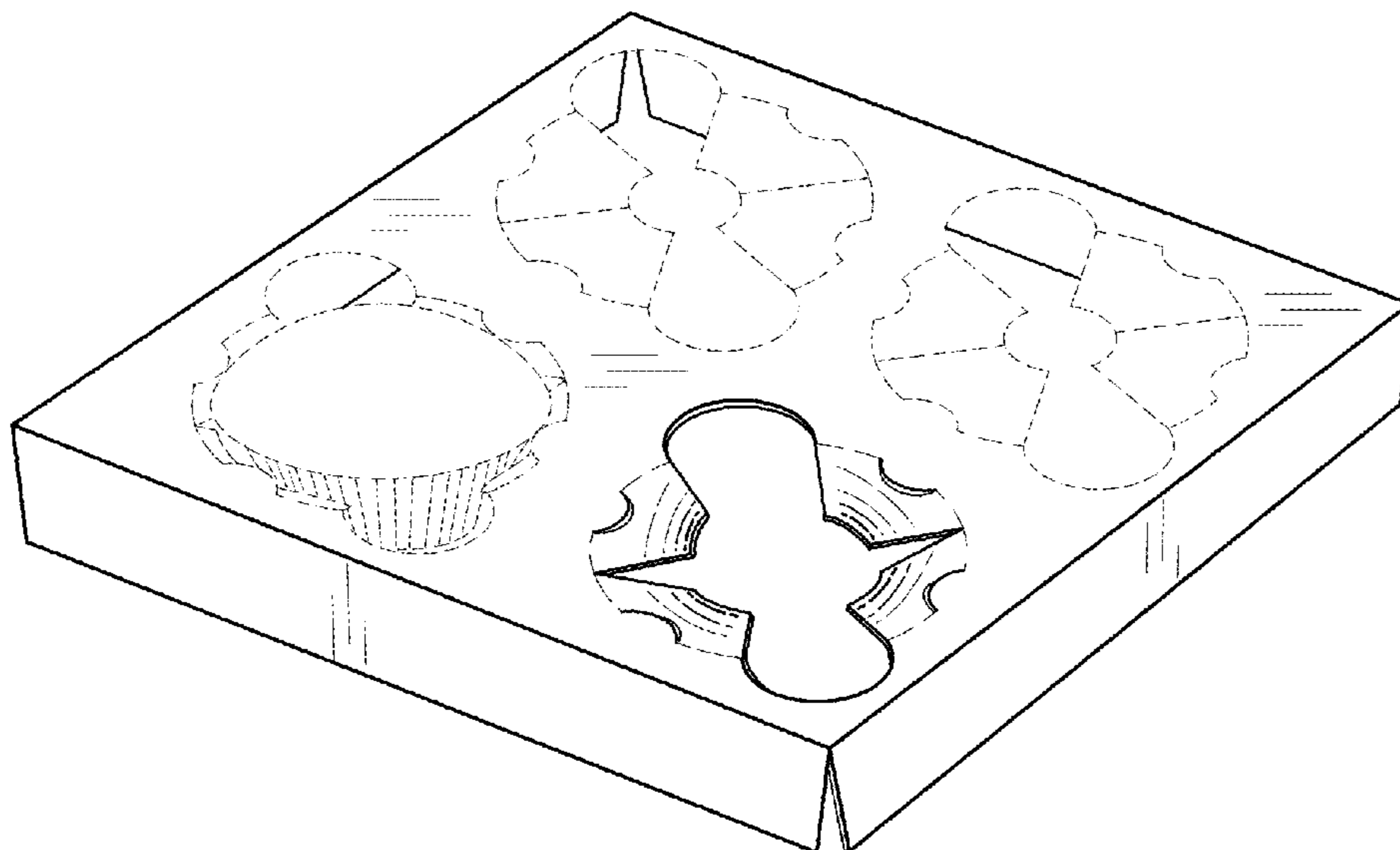
FIG. 2 is a top view thereof, shown with the flaps of the cupcake receiving aperture in an unfolded configuration;

FIG. 3 is another top view of the insert shown in FIG. 1;

FIG. 4 is a bottom view of the insert shown in FIG. 2; and, FIG. 5 is a right side view thereof, the left side, front side, and rear side being a mirror image thereof.

The broken lines showing a cupcake illustrate environmental structure. The broken lines immediately adjacent to the aperture flap illustrate fold lines. All other broken lines illustrate portions of the insert for a container for cupcakes. The broken lines form no part of the claimed design.

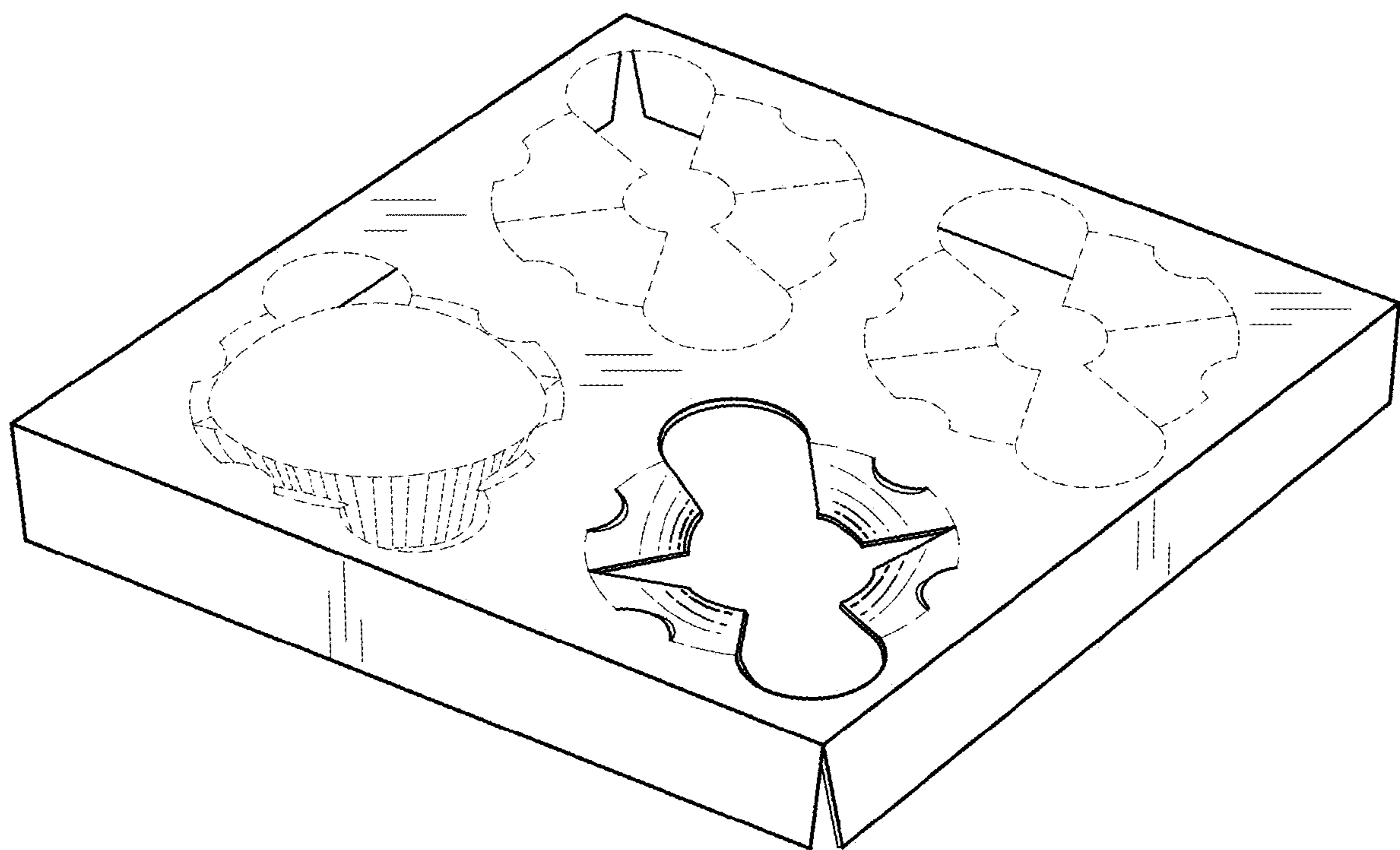

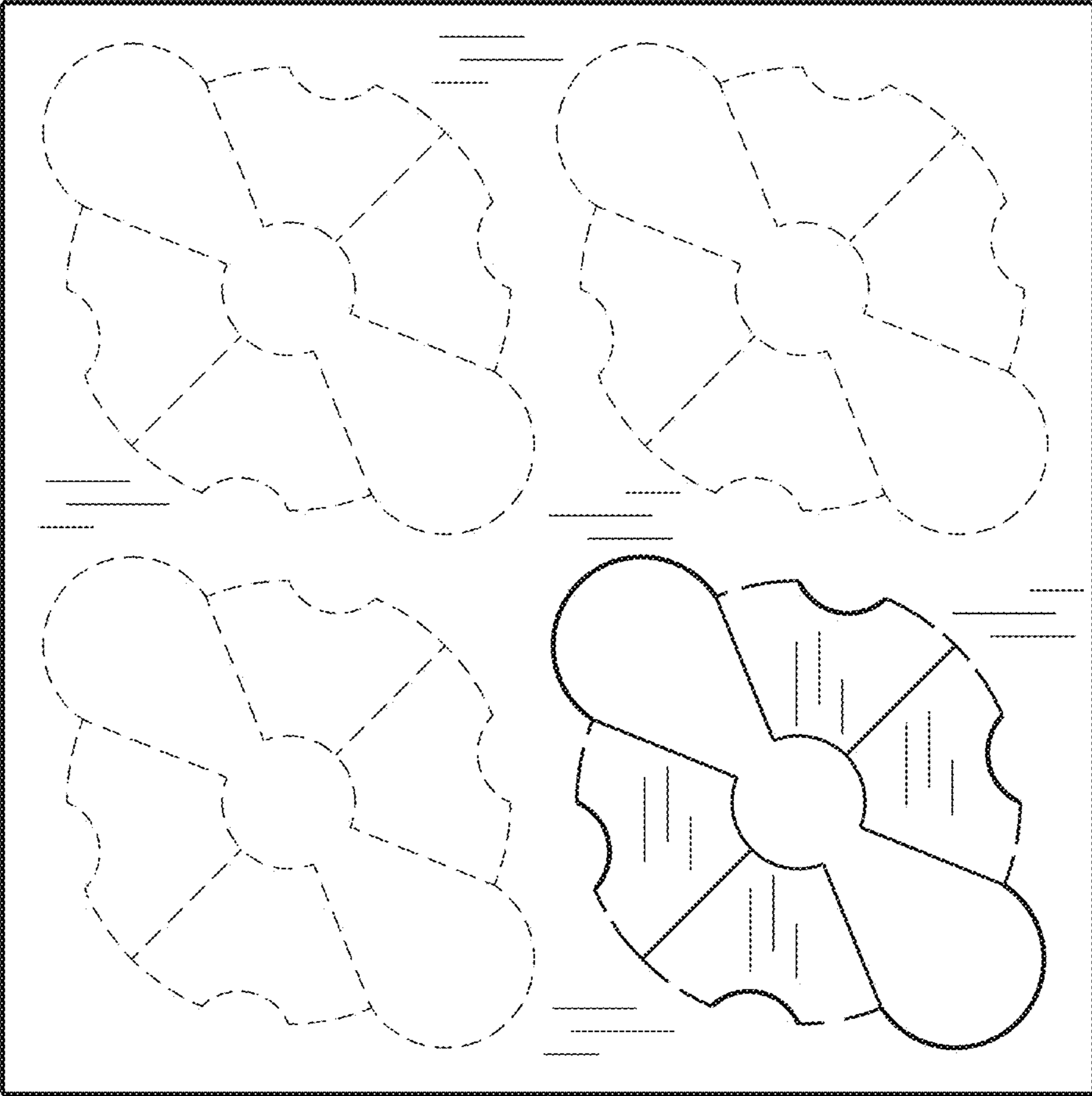

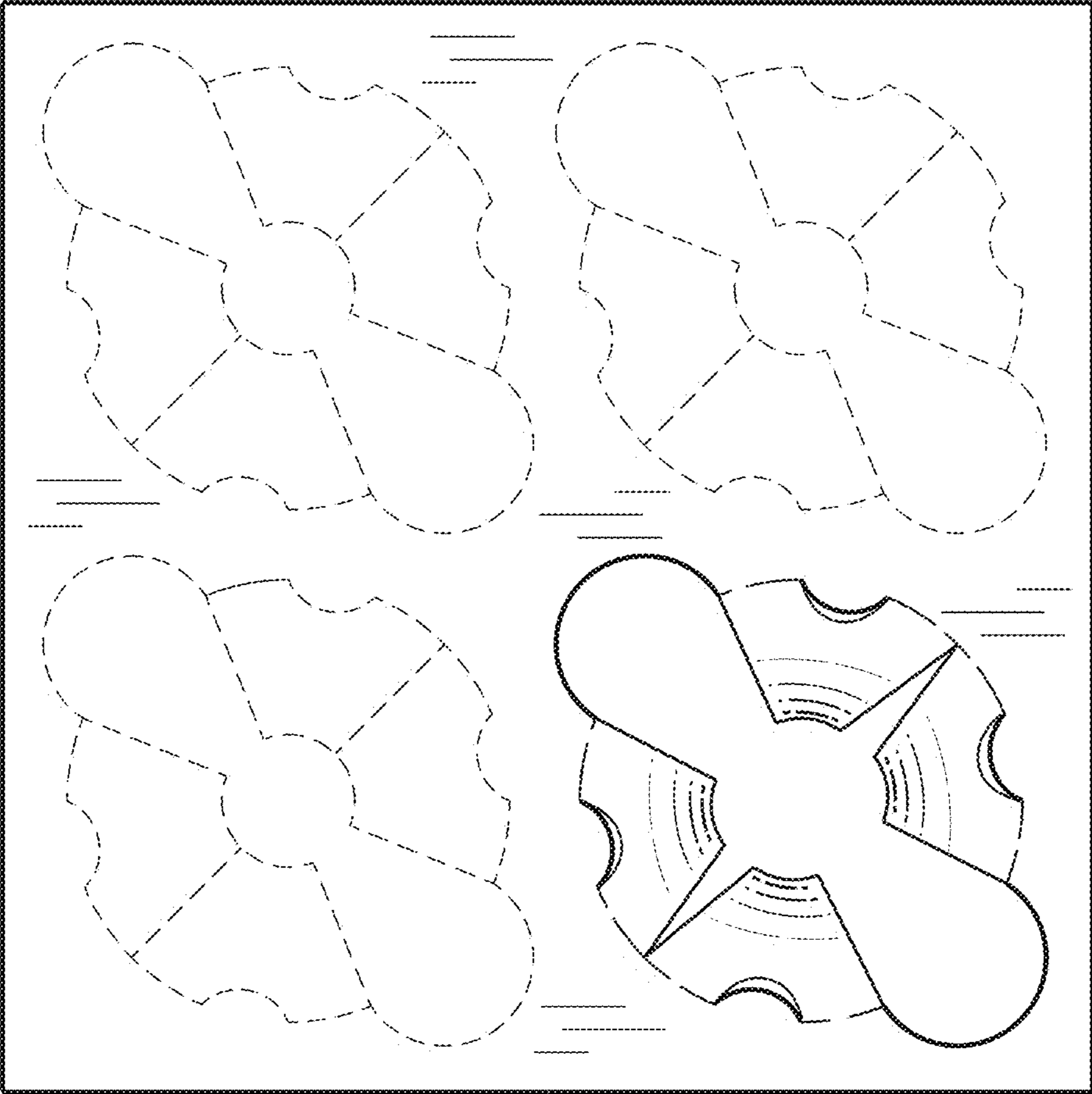

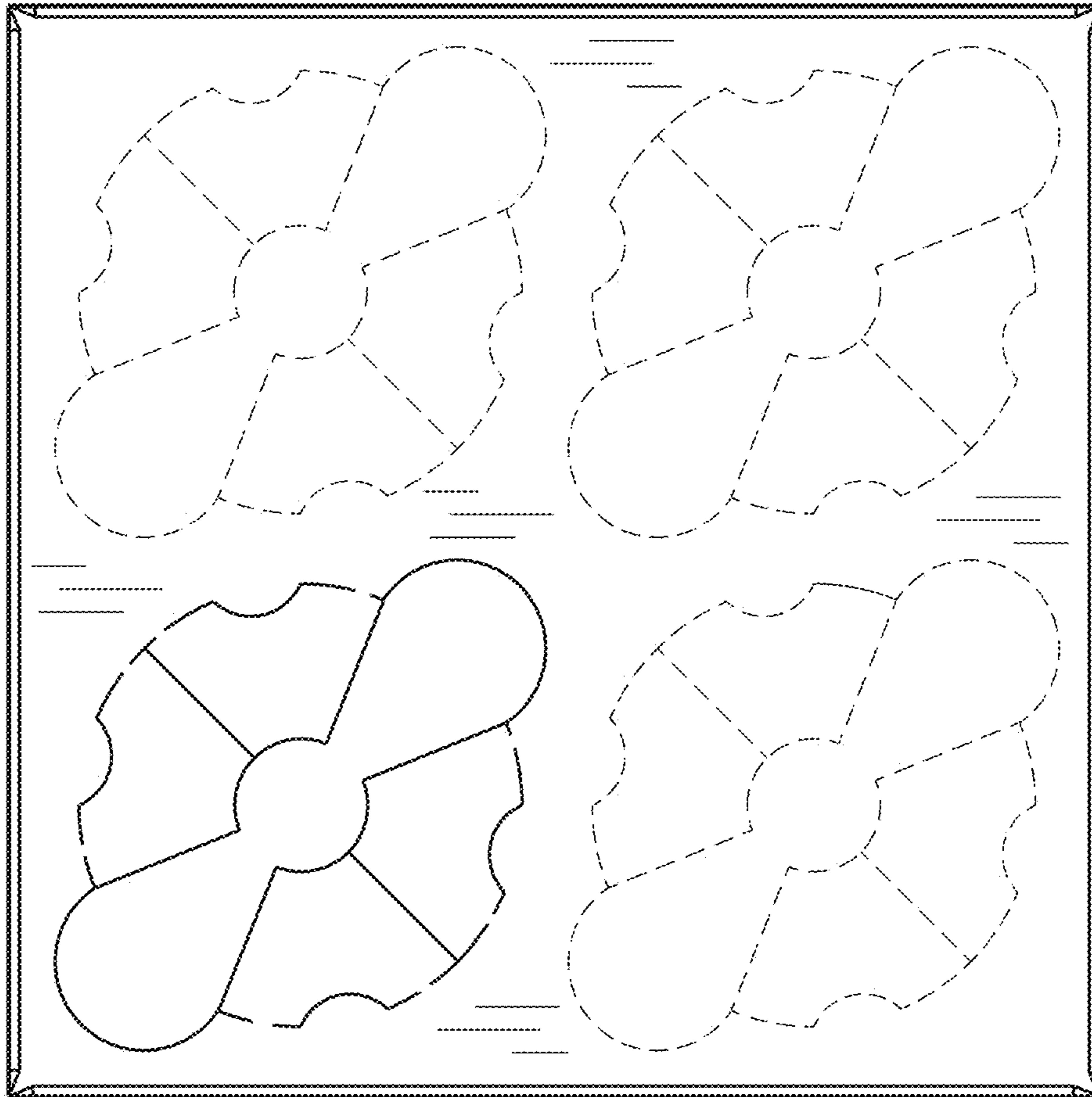
