(57) **CLAIM**

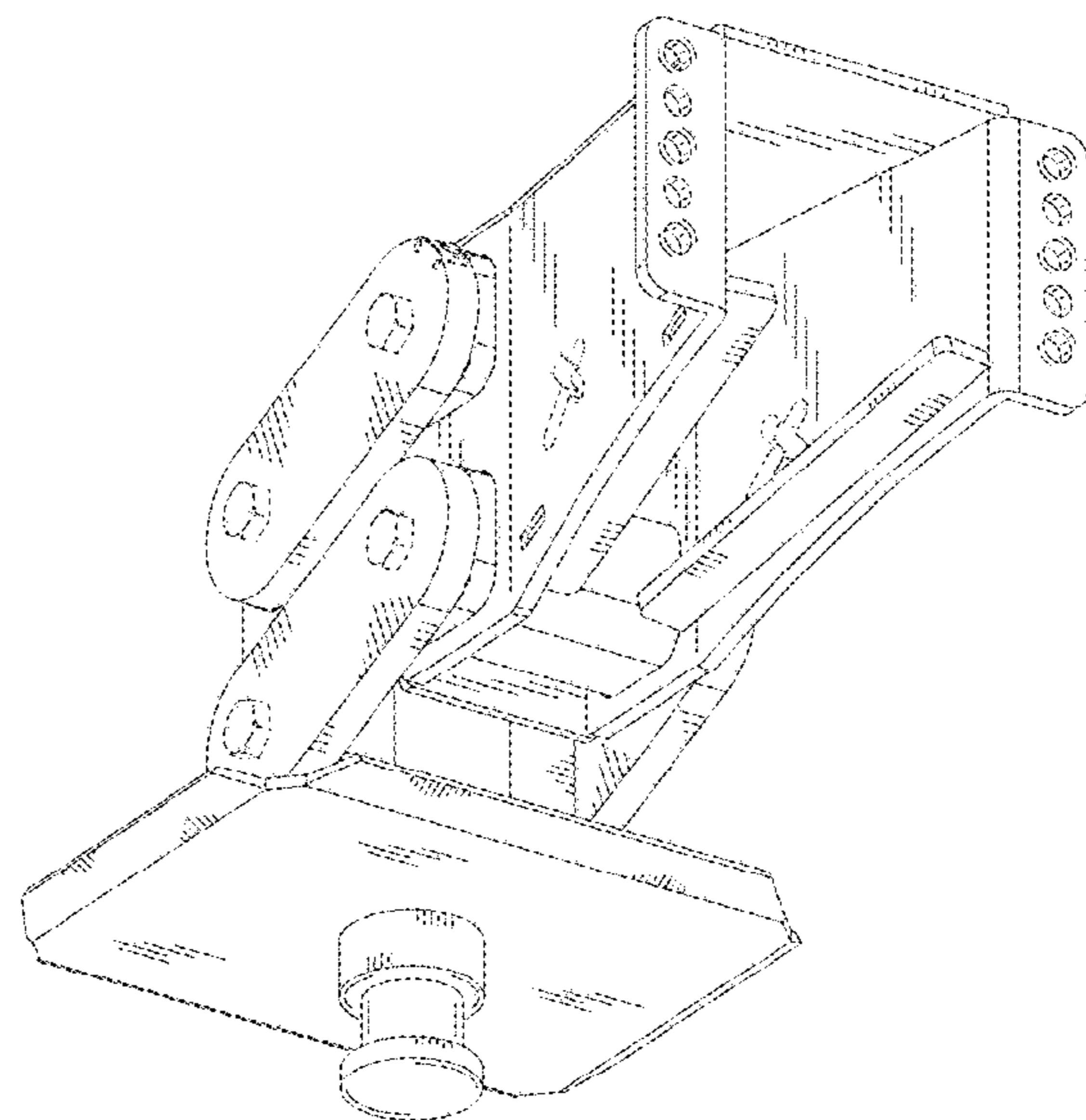
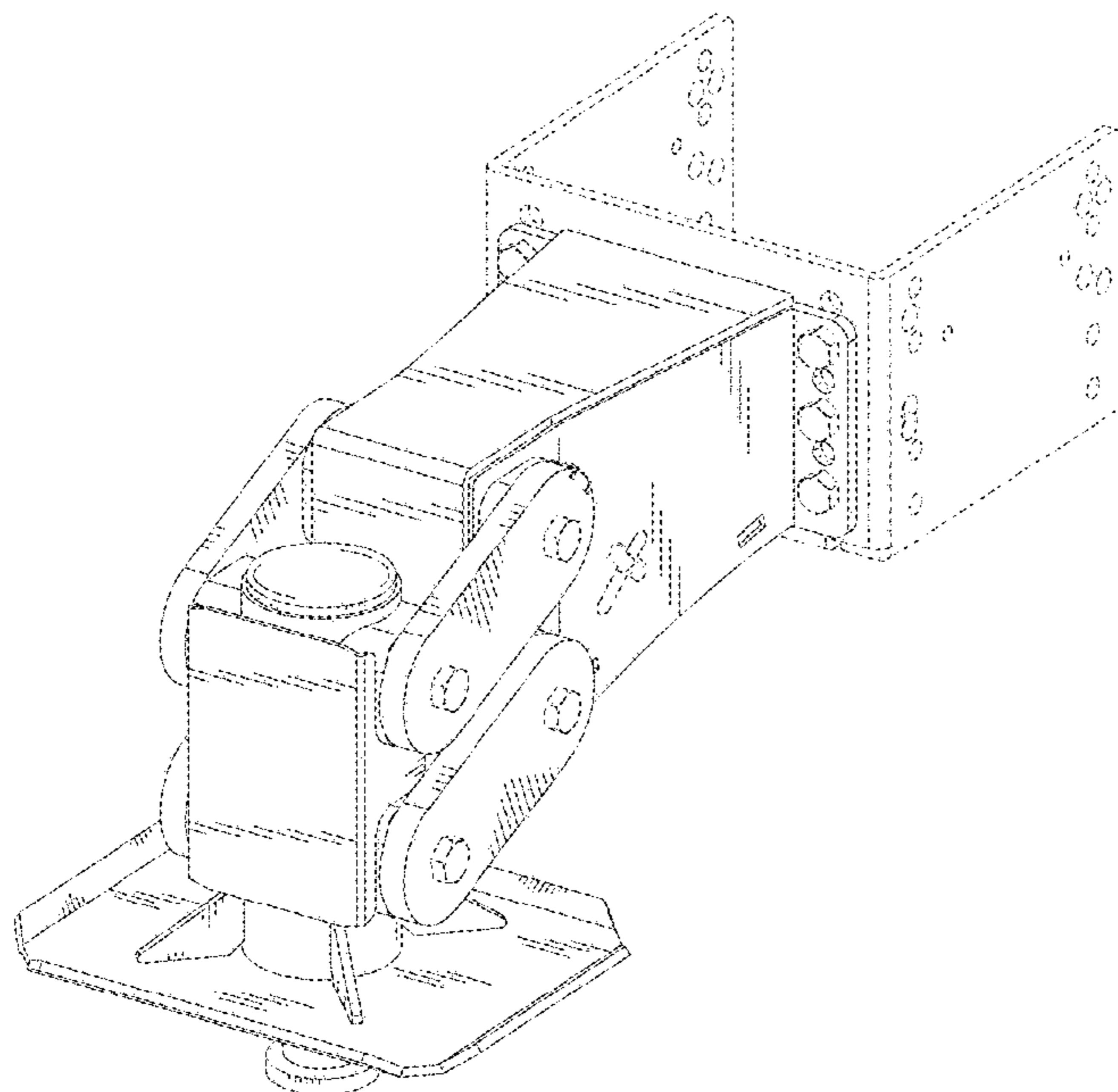
The ornamental design for a fifth wheel torsion kingpin, as shown and described.

**DESCRIPTION**

FIG. 1 is a top isometric view of the fifth wheel torsion kingpin;  
FIG. 2 is a bottom isometric view of the fifth wheel torsion kingpin of FIG. 1;  
FIG. 3 is a left side view of the fifth wheel torsion kingpin of FIG. 1;  
FIG. 4 is a right side view of the fifth wheel torsion kingpin of FIG. 1;  
FIG. 5 is a front view of the fifth wheel torsion kingpin of FIG. 1;  
FIG. 6 is a back view of the fifth wheel torsion kingpin of FIG. 1;  
FIG. 7 is a top view of the fifth wheel torsion kingpin of FIG. 1; and,

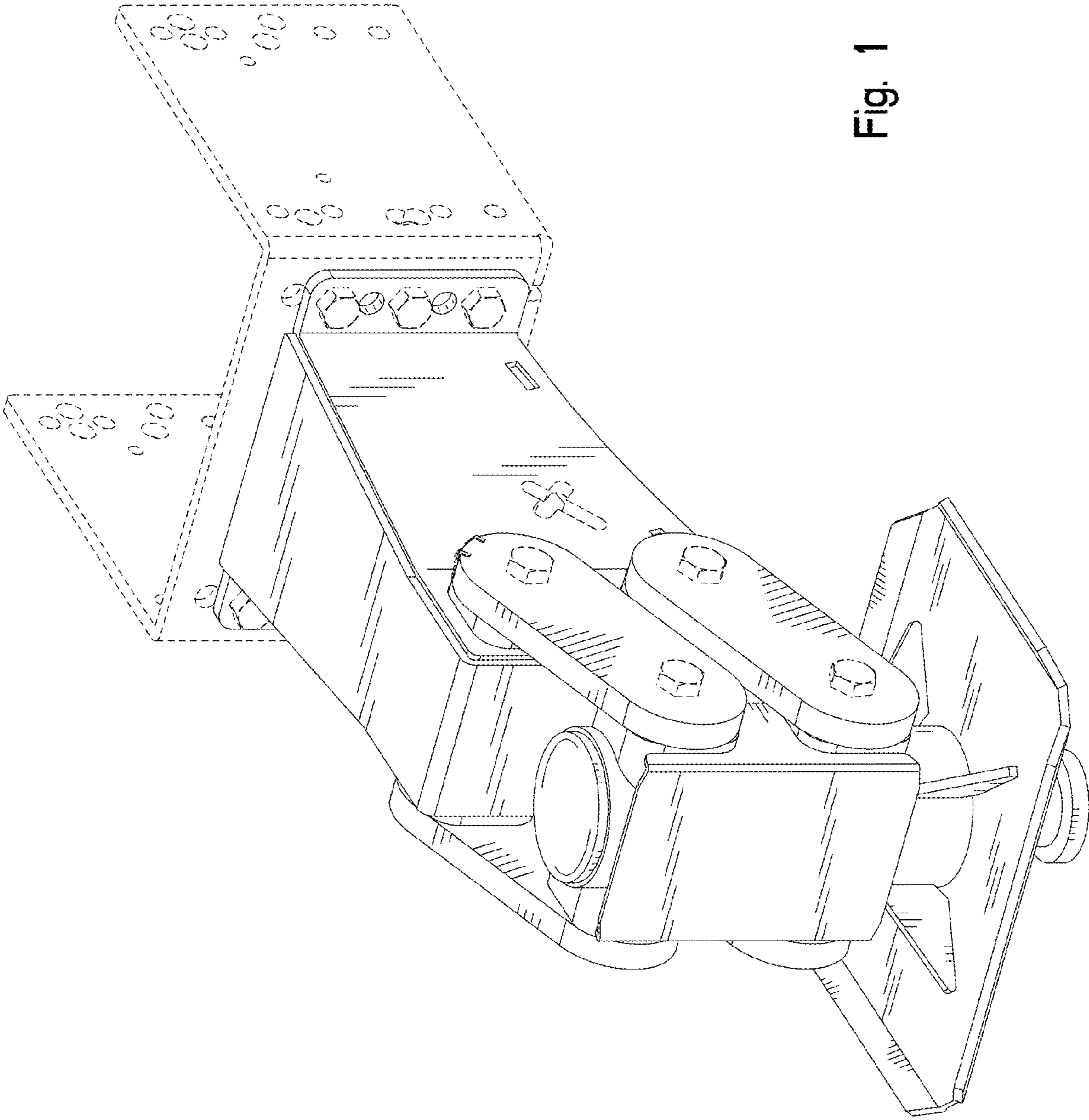
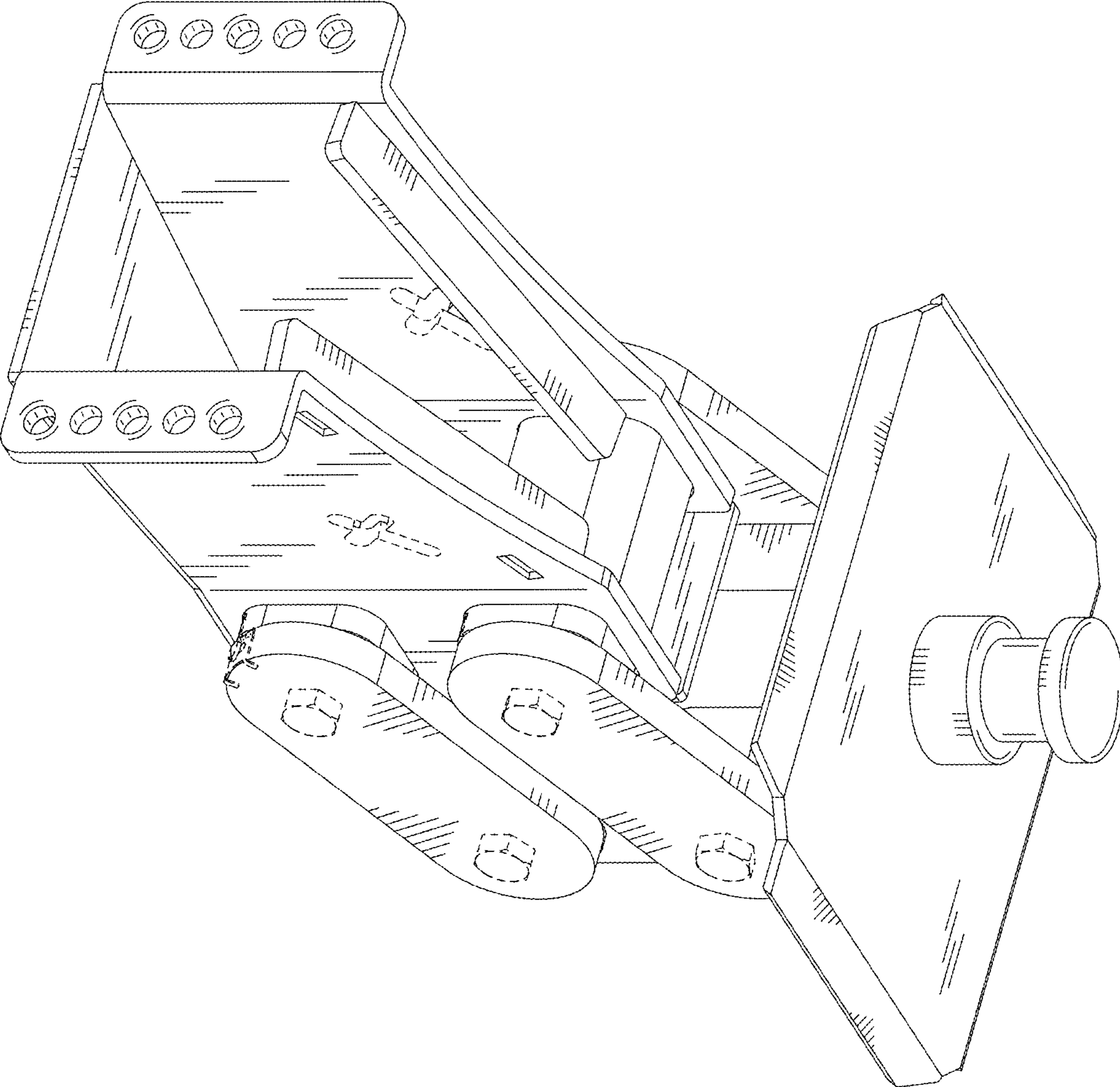

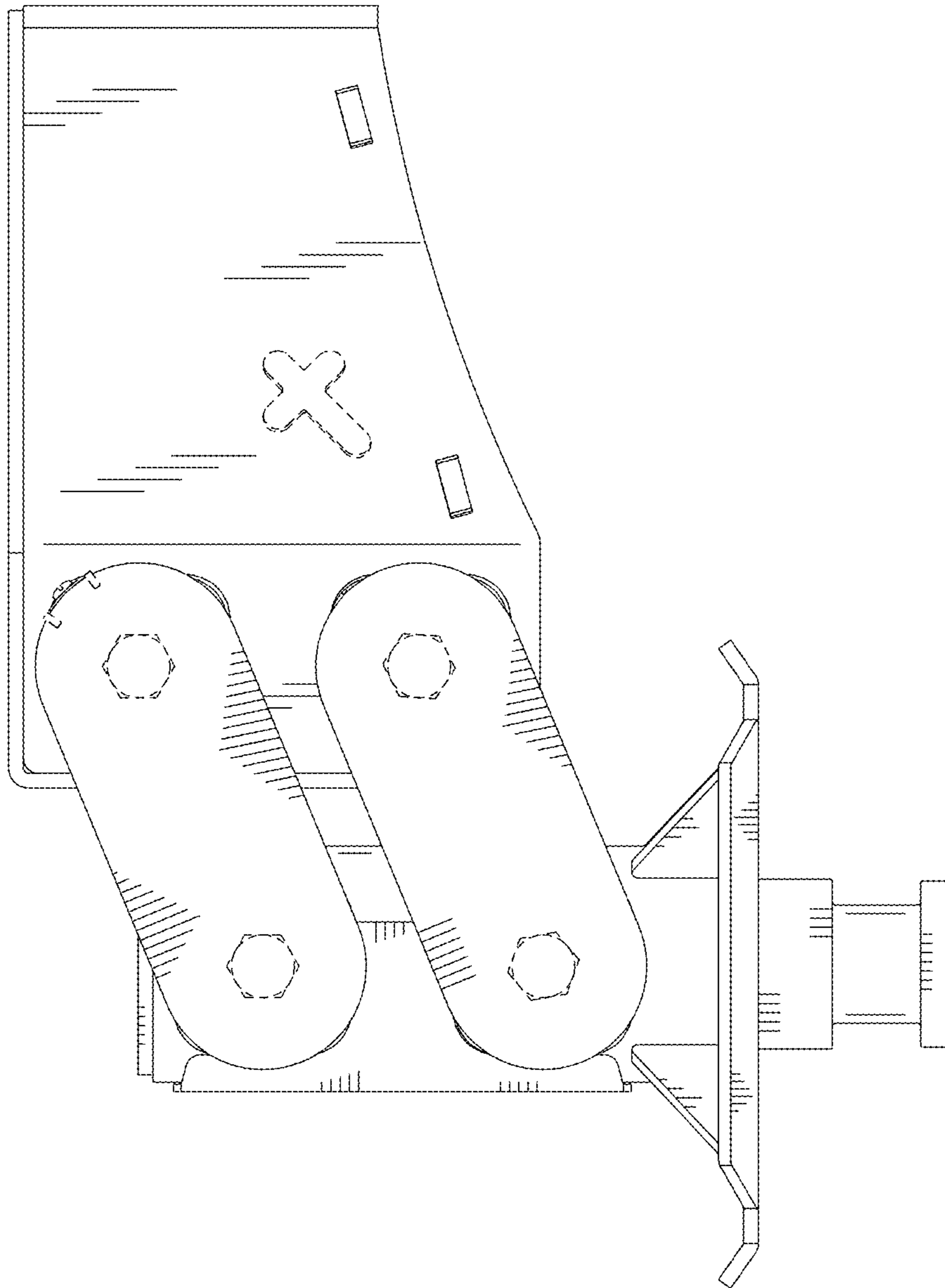

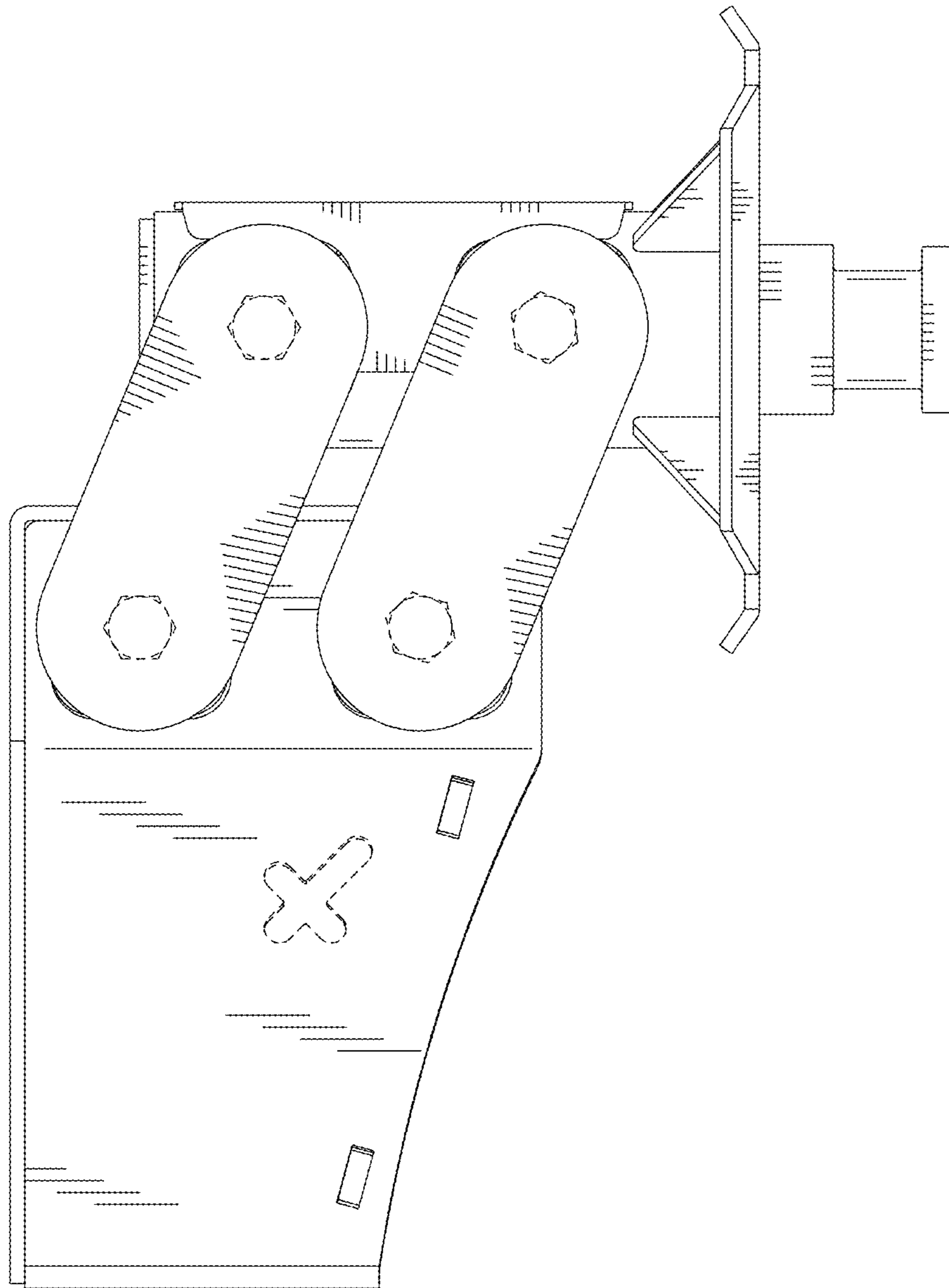

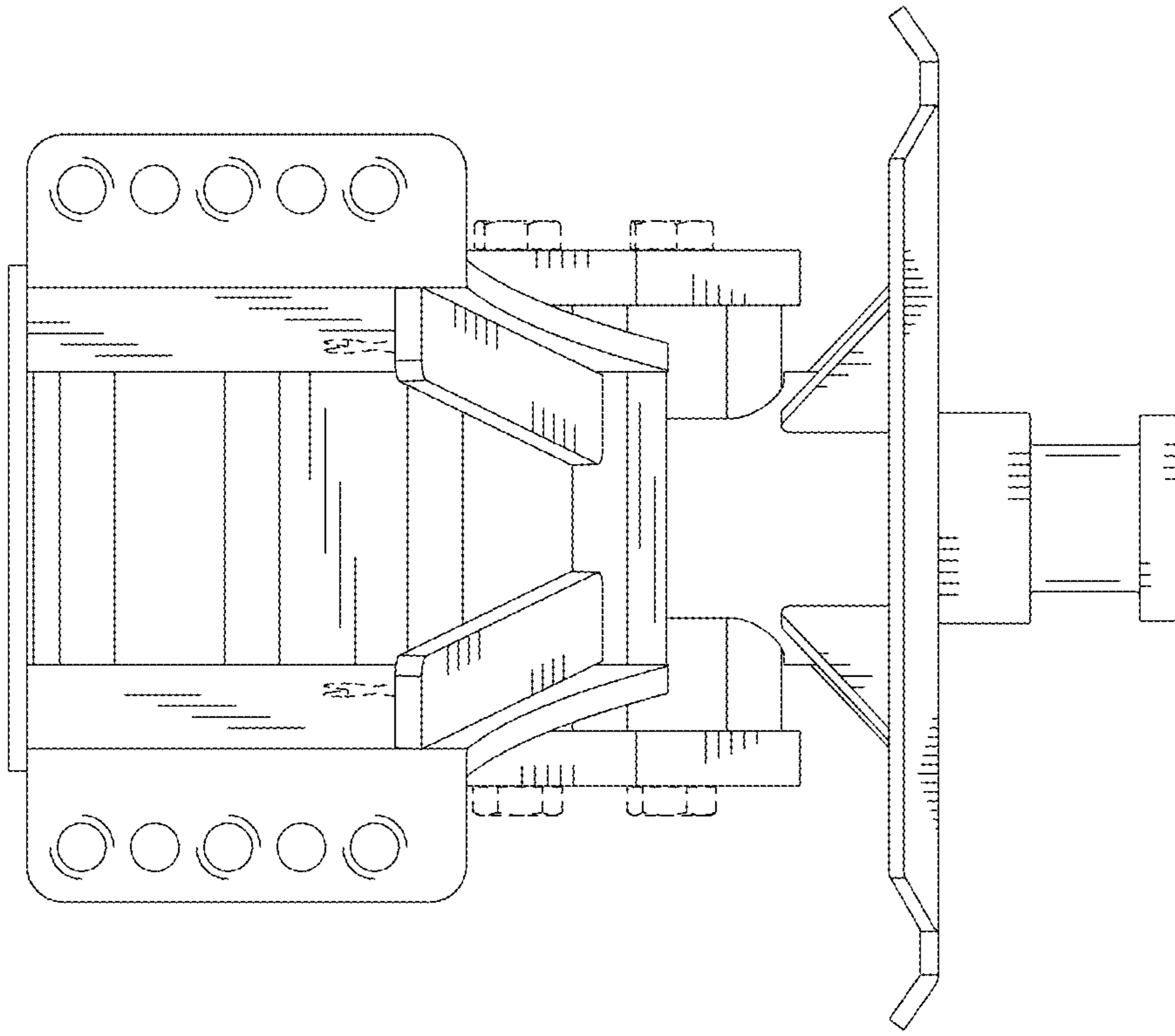

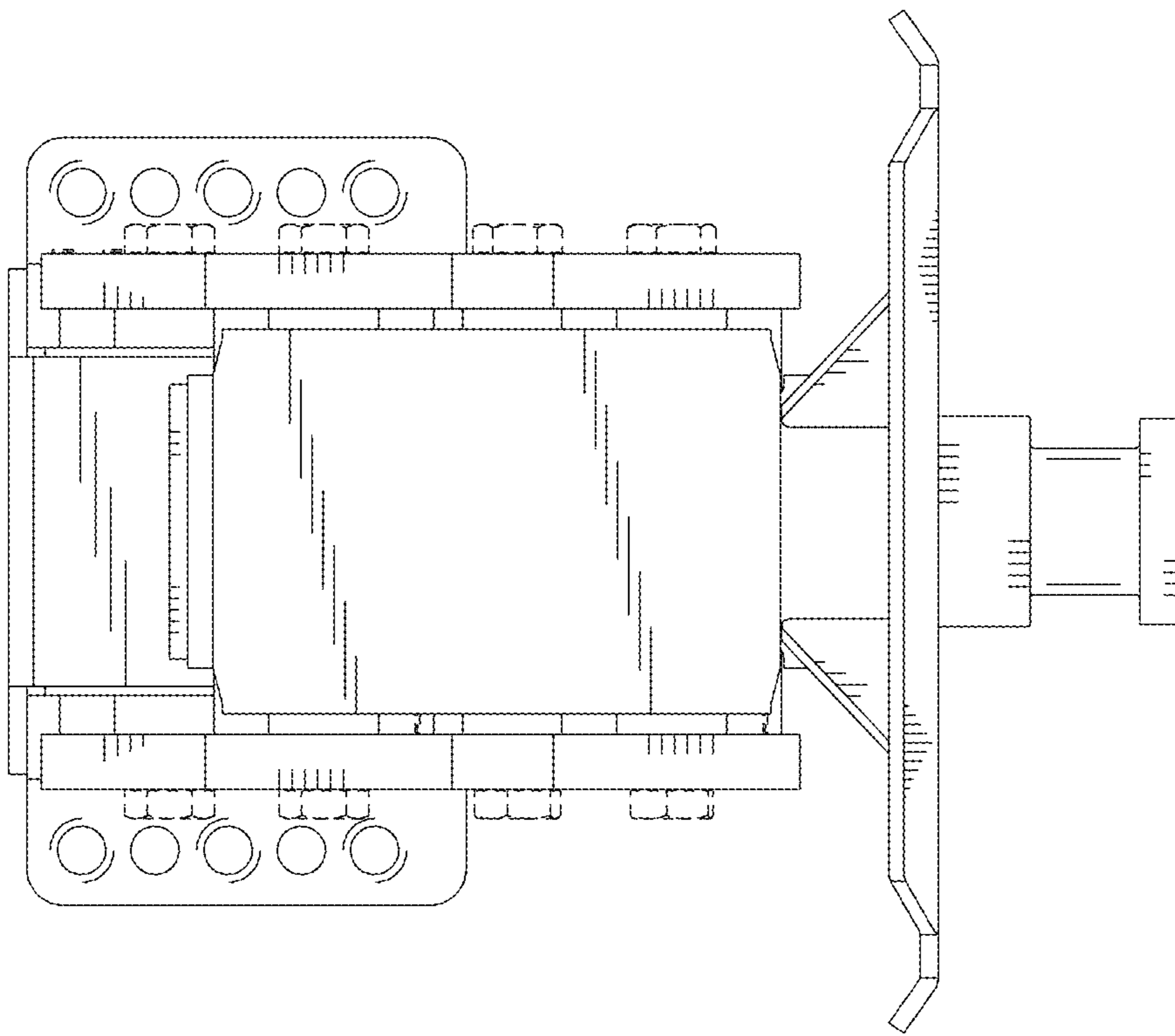

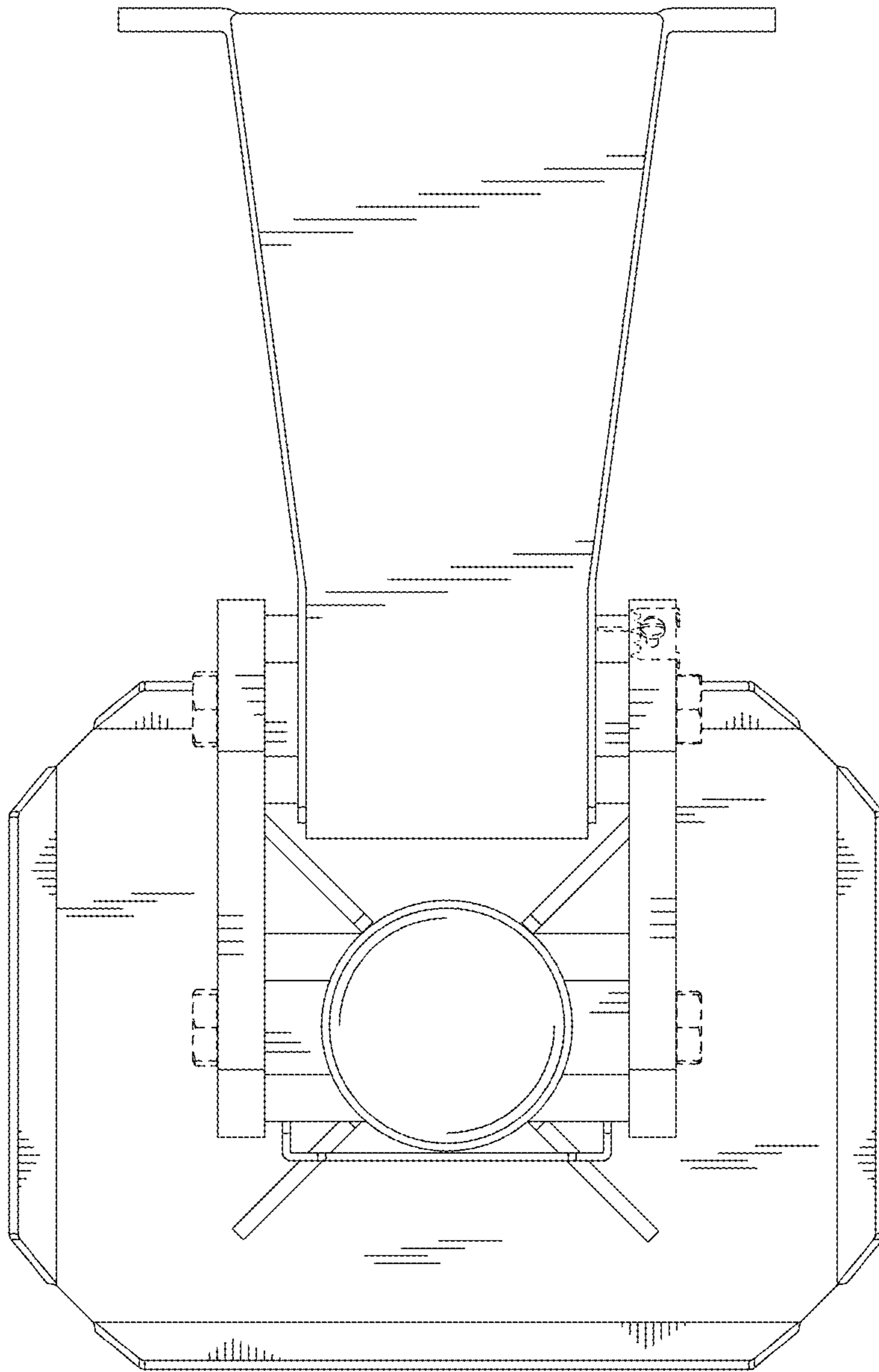

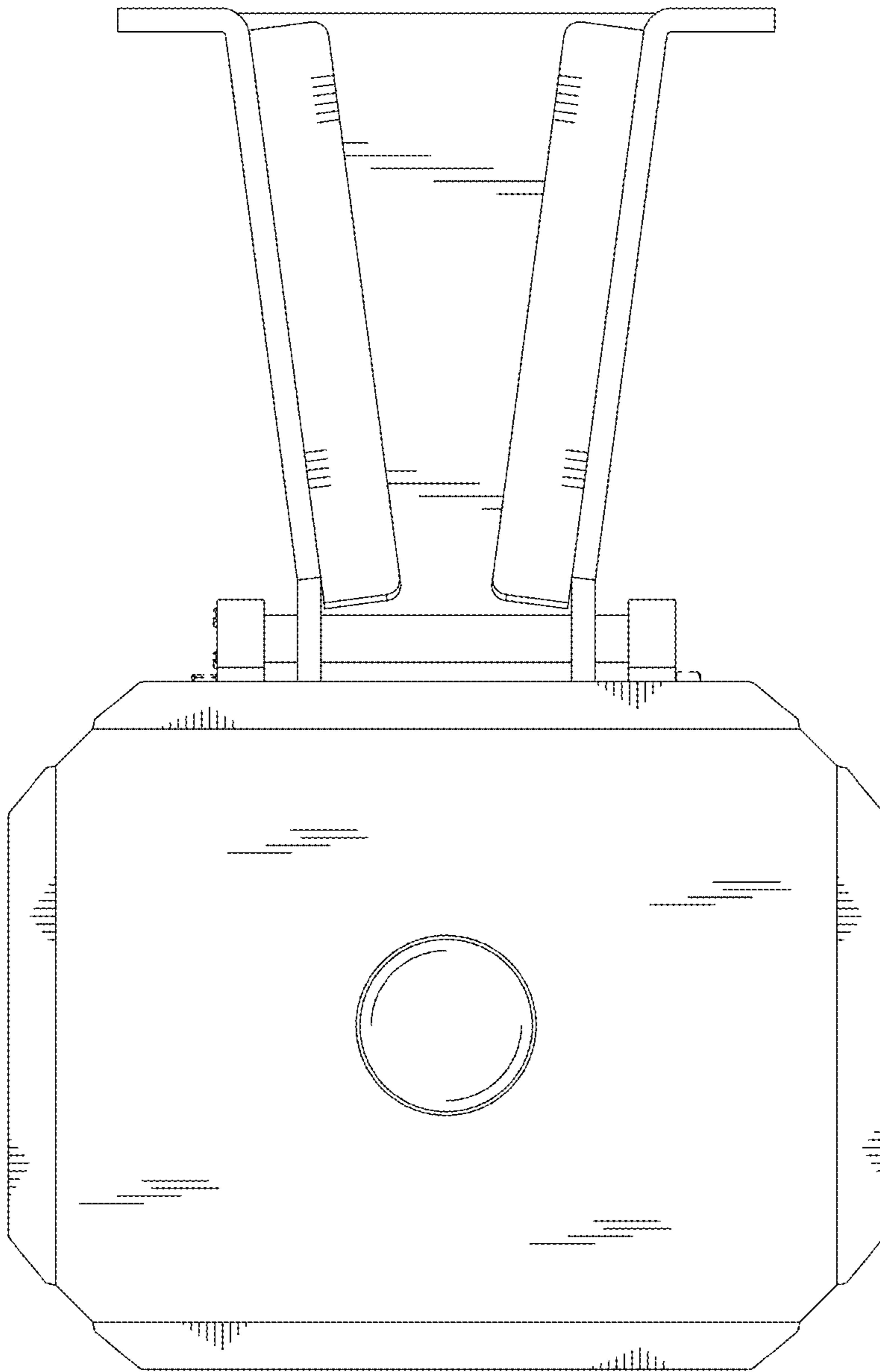
