DESCRIPTION

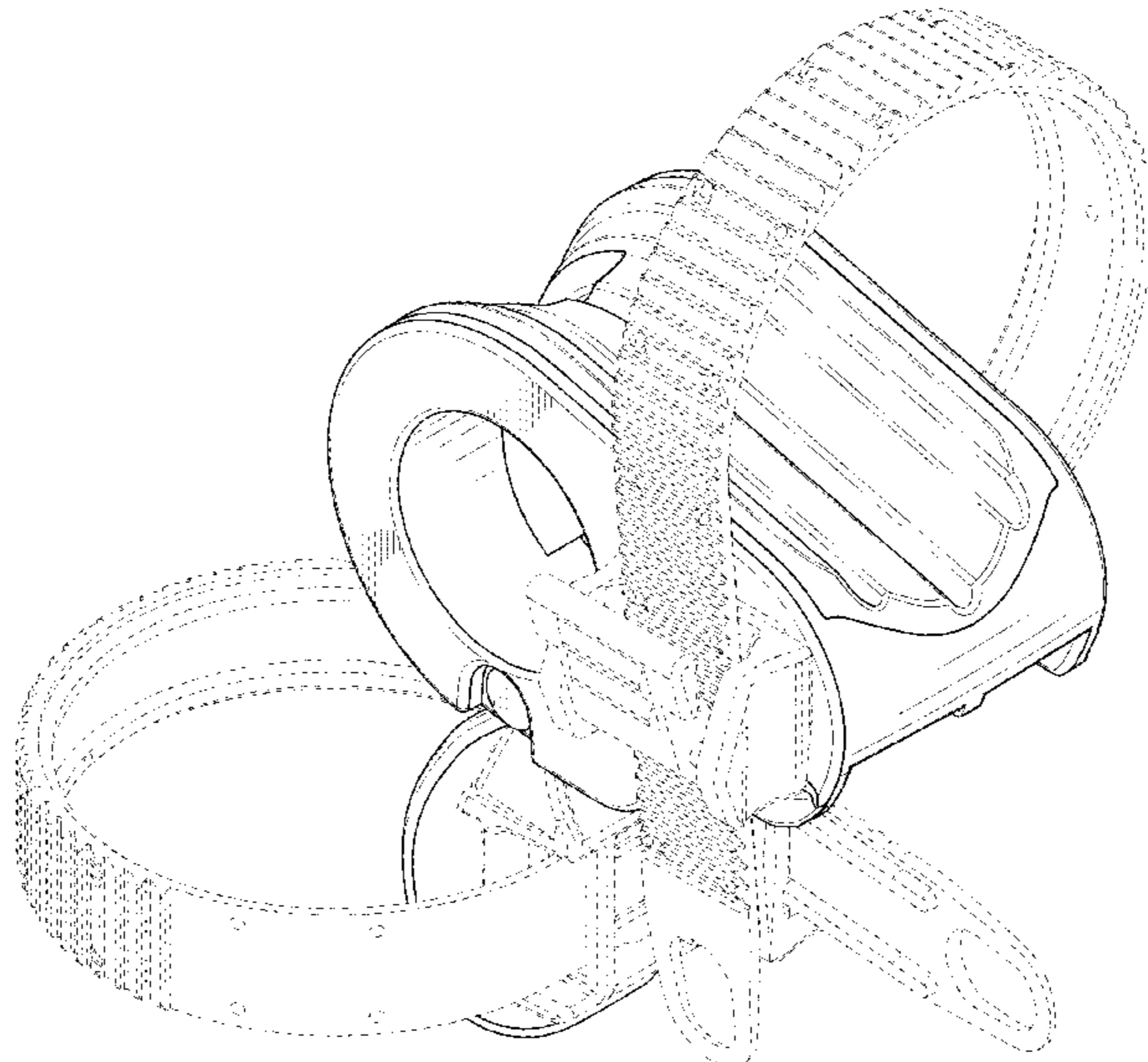
FIG. 1 is a top front perspective view of a bike cradle showing the claimed design;

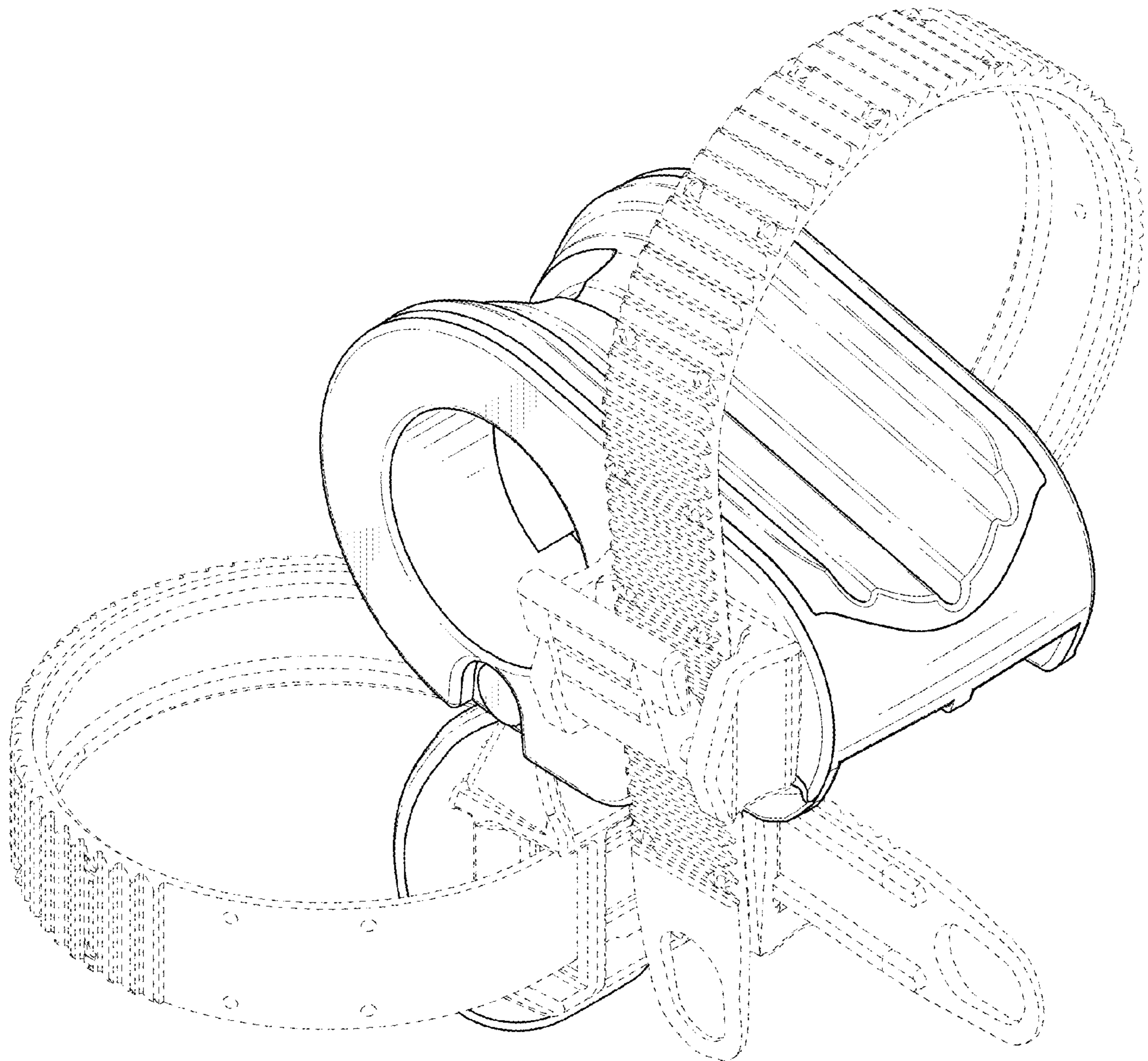

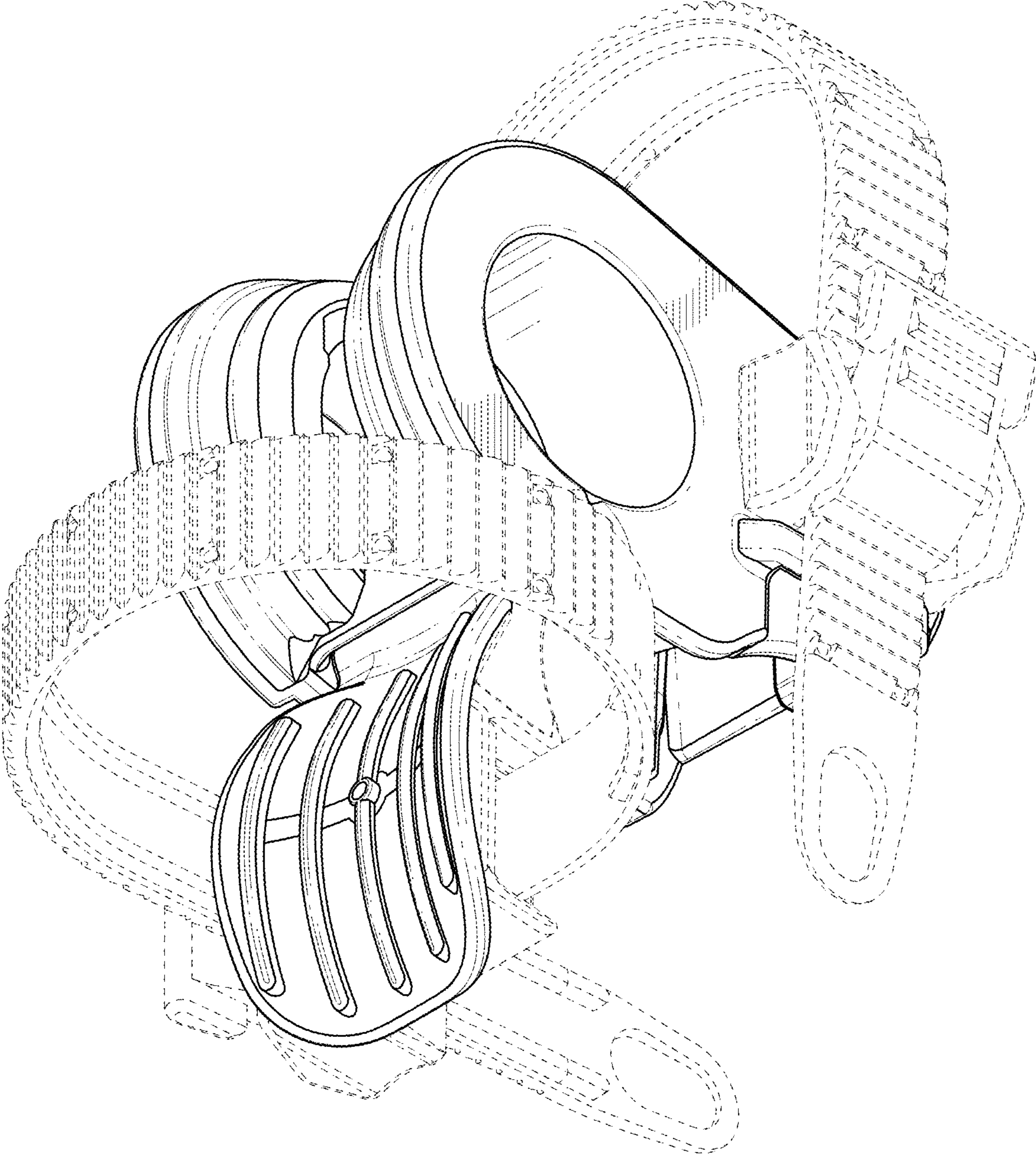

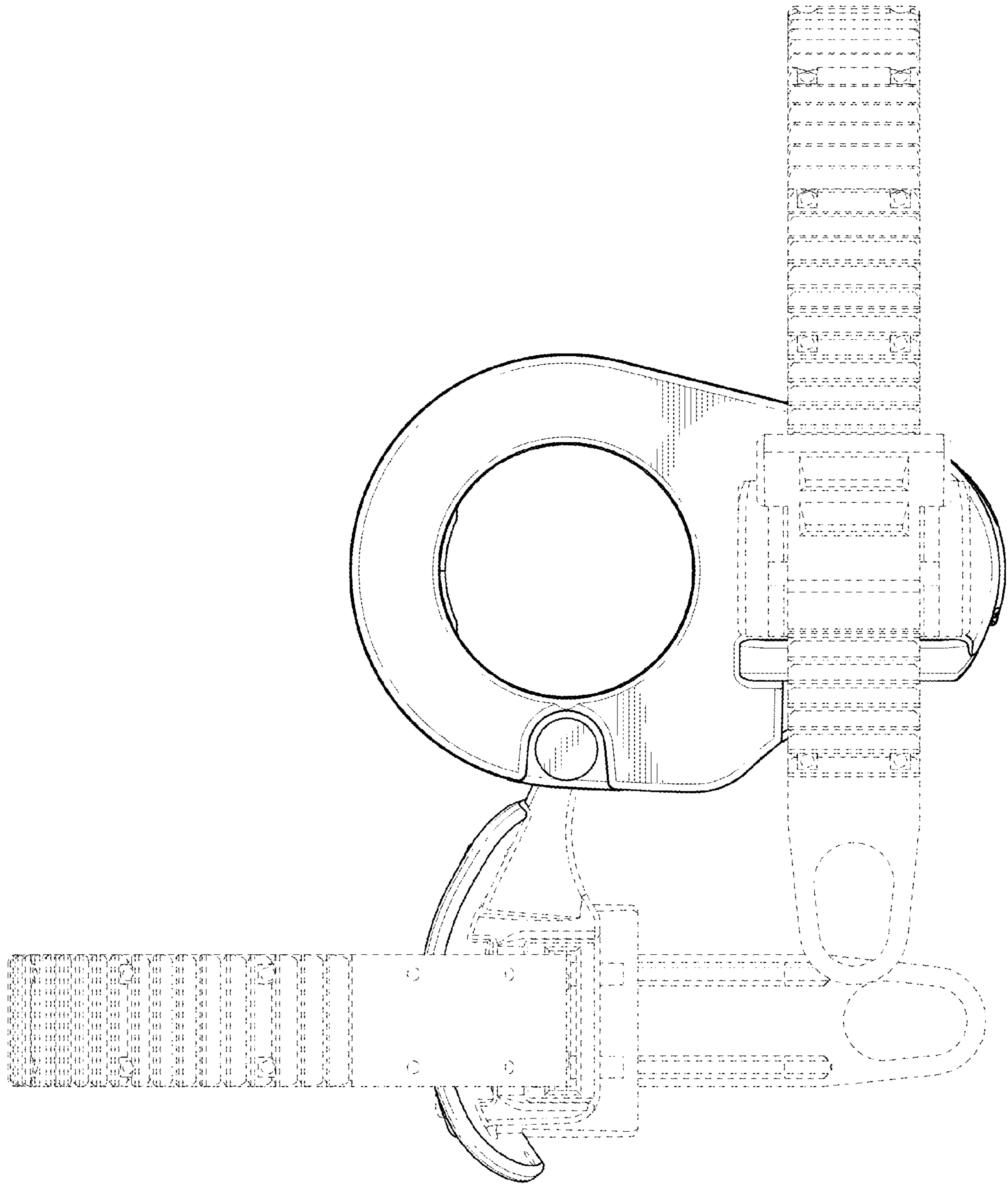

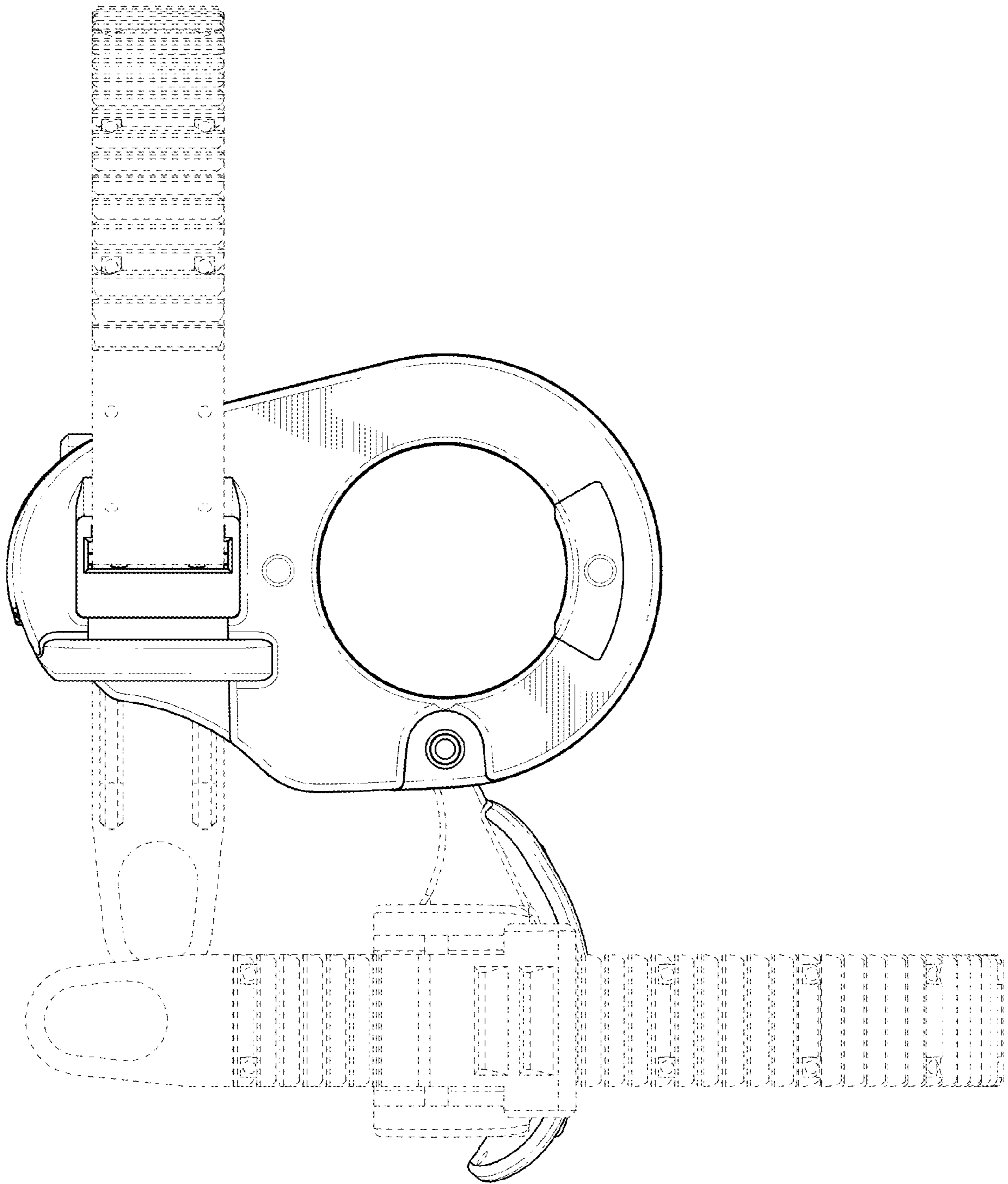

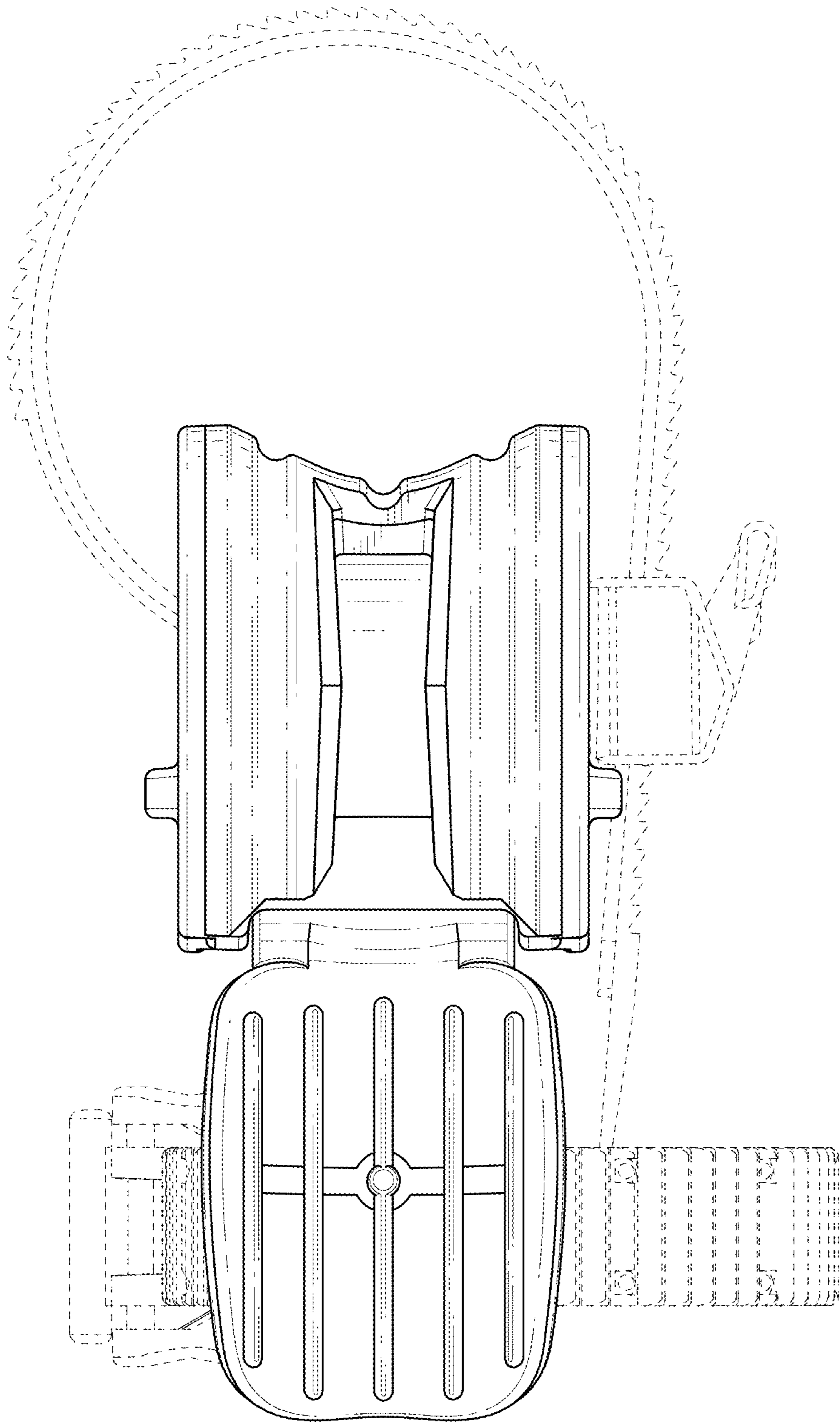

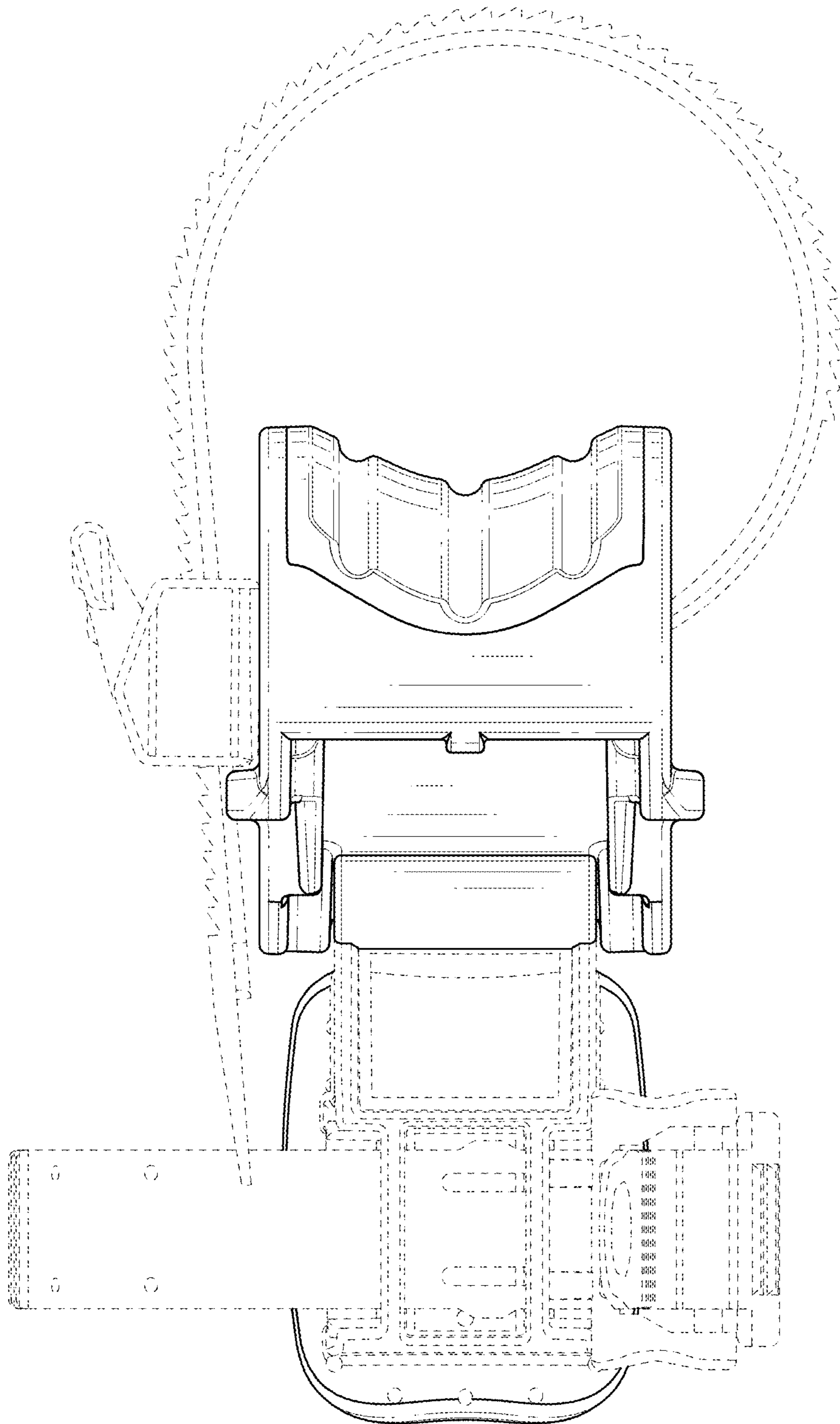

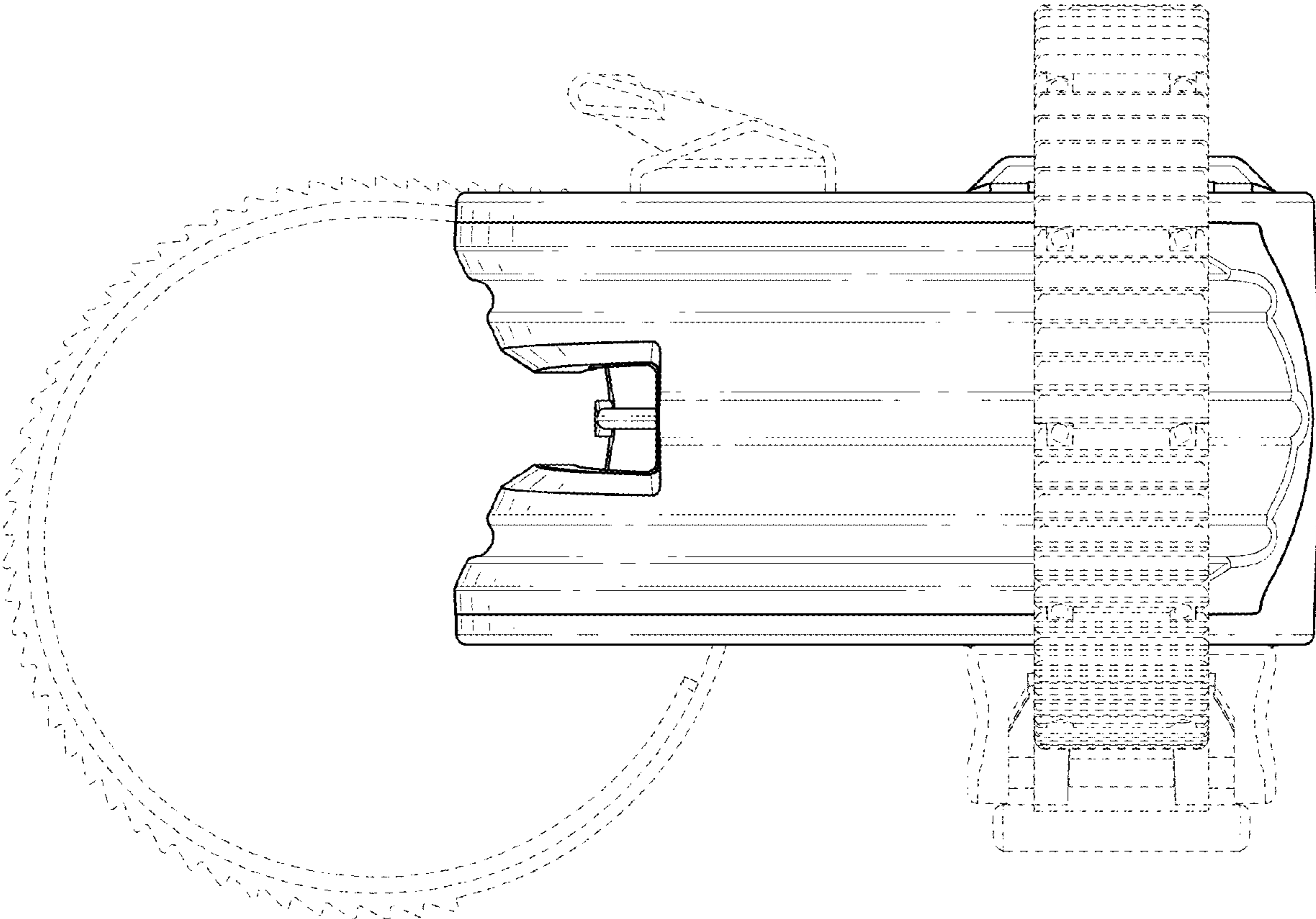

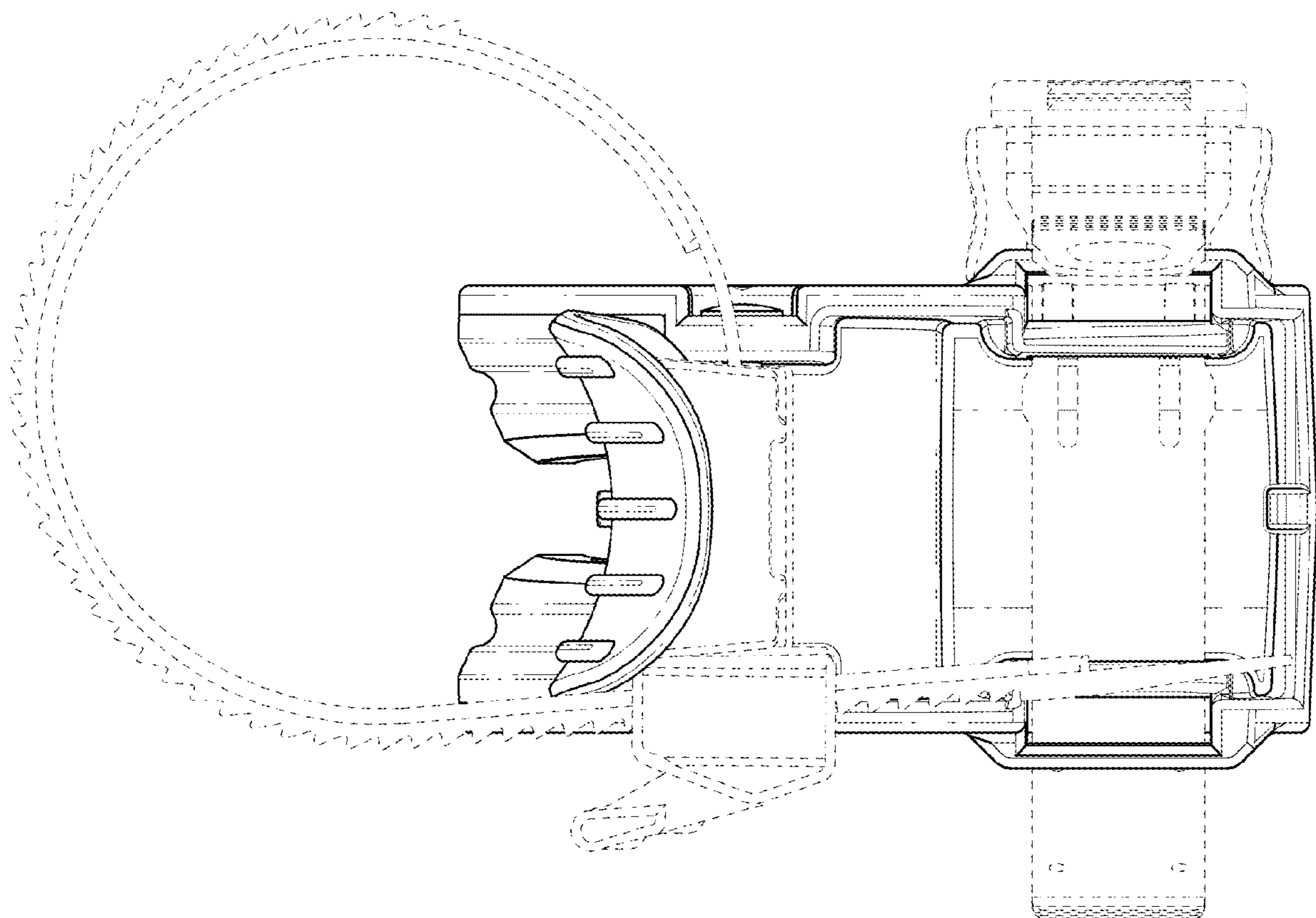

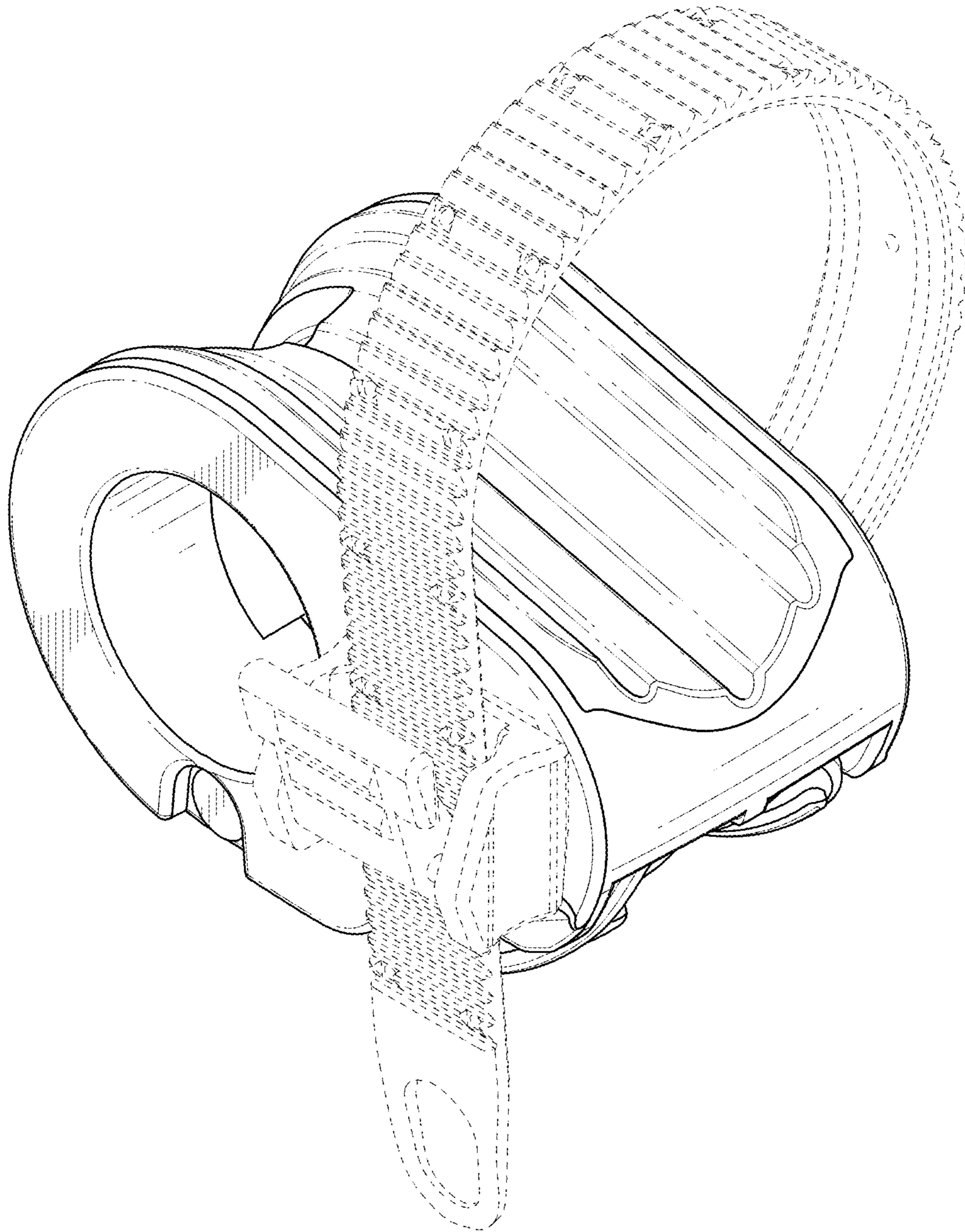

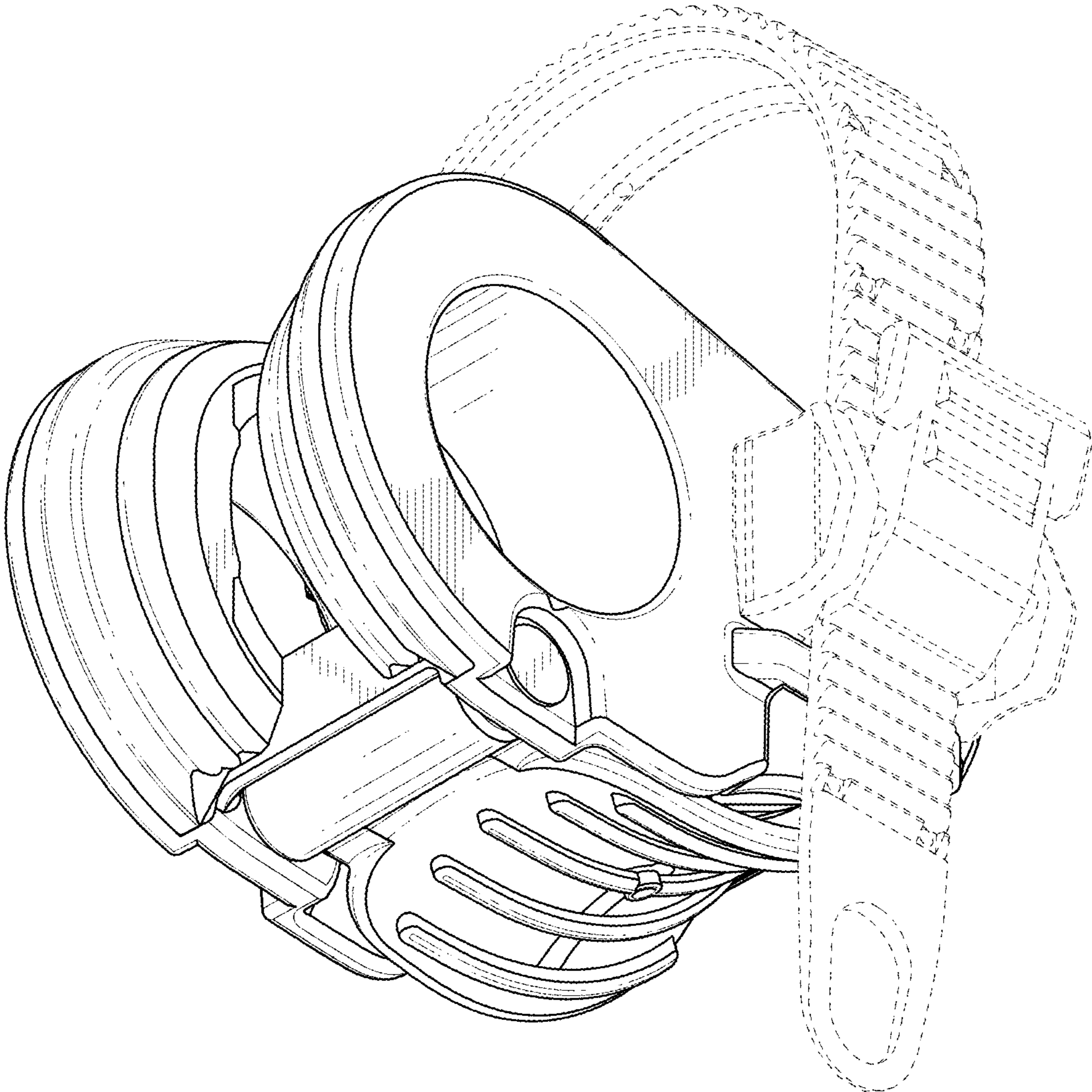

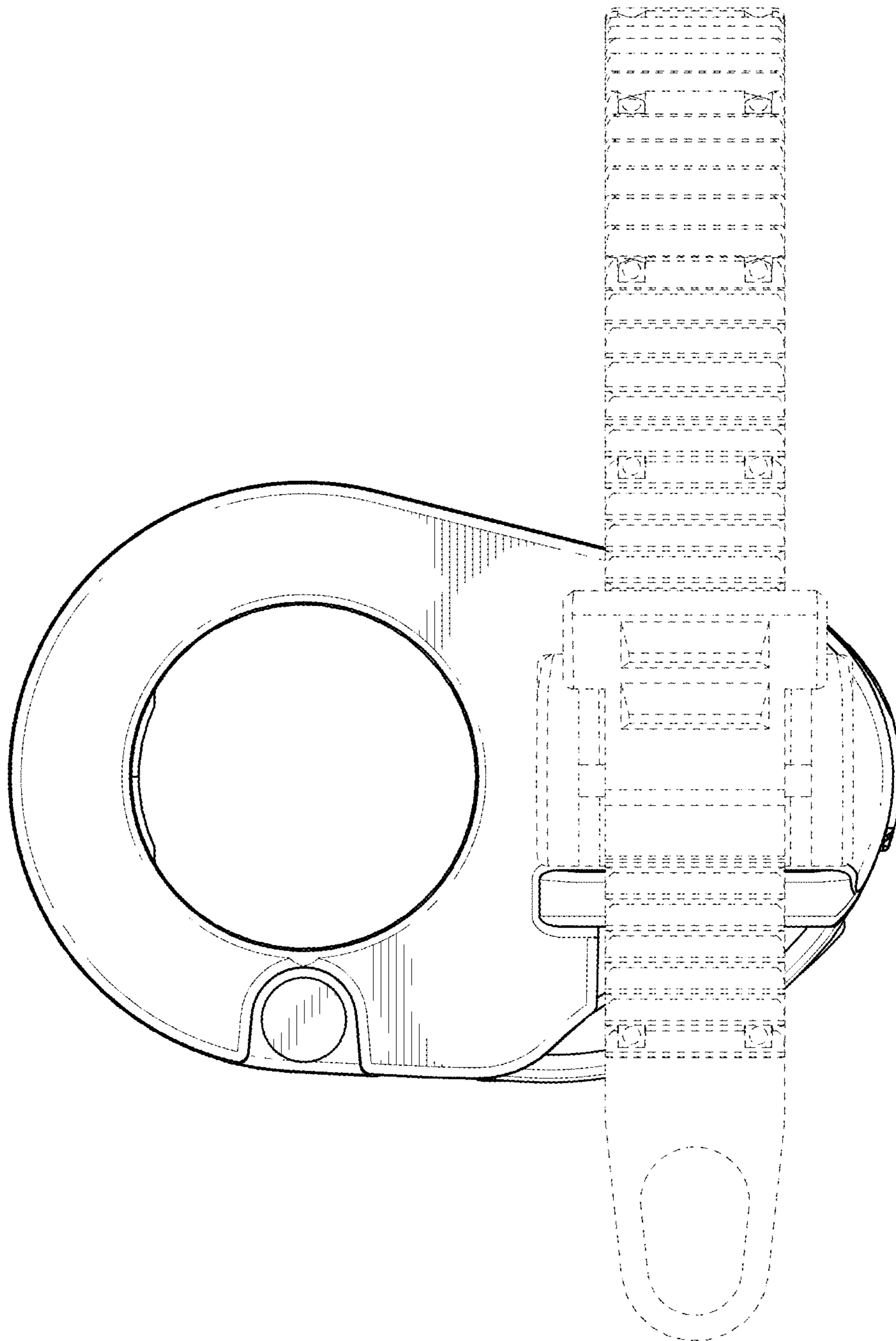

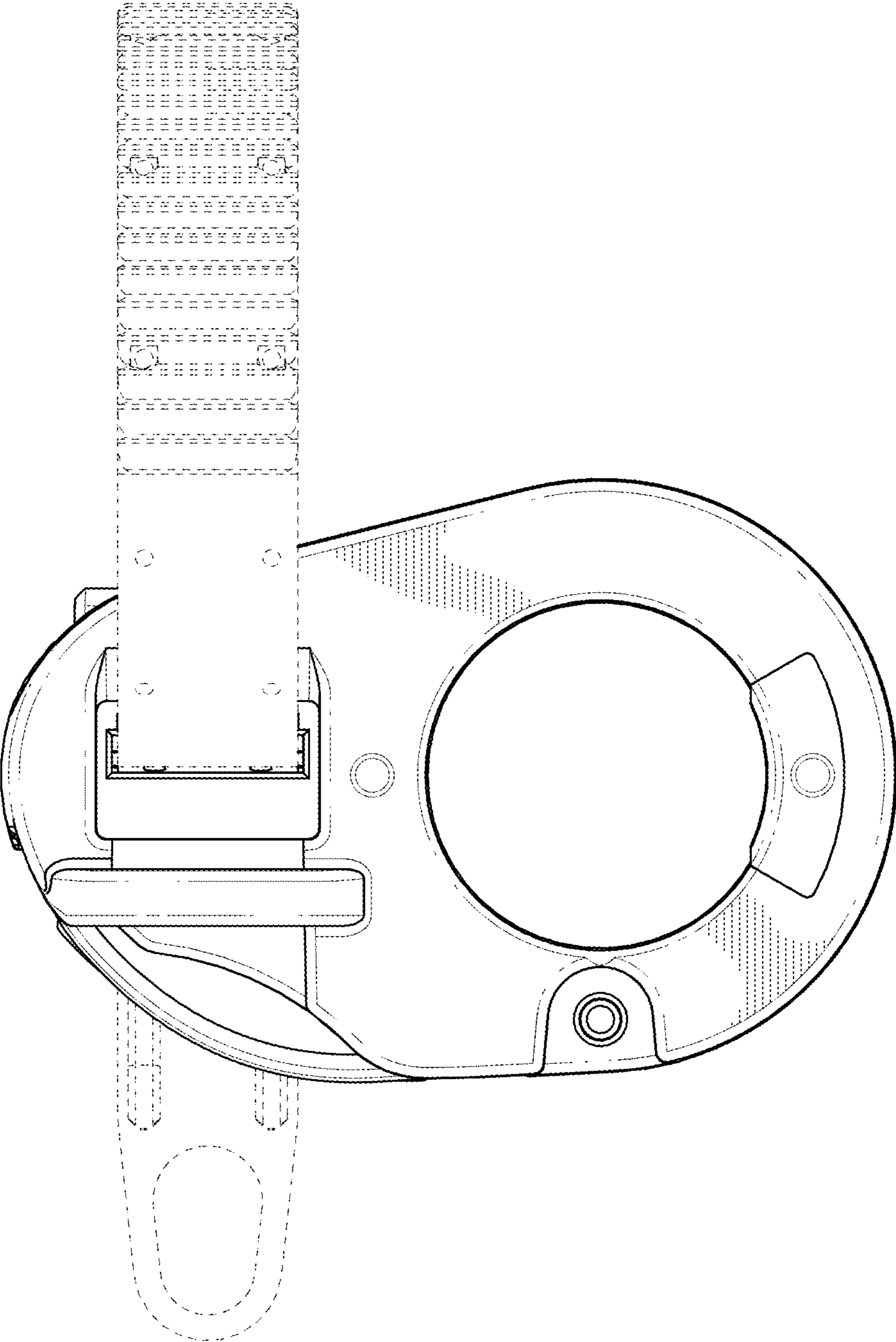

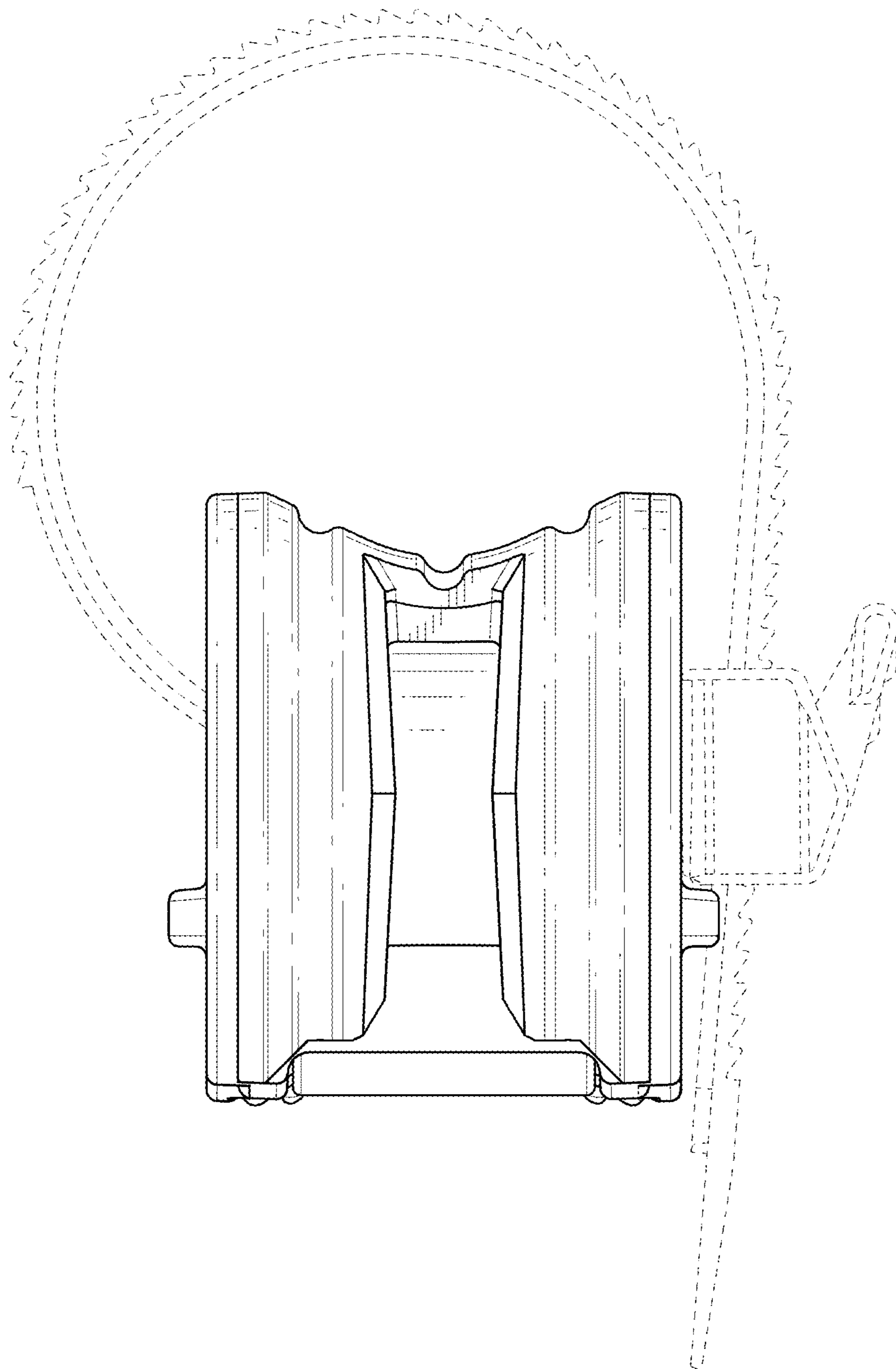

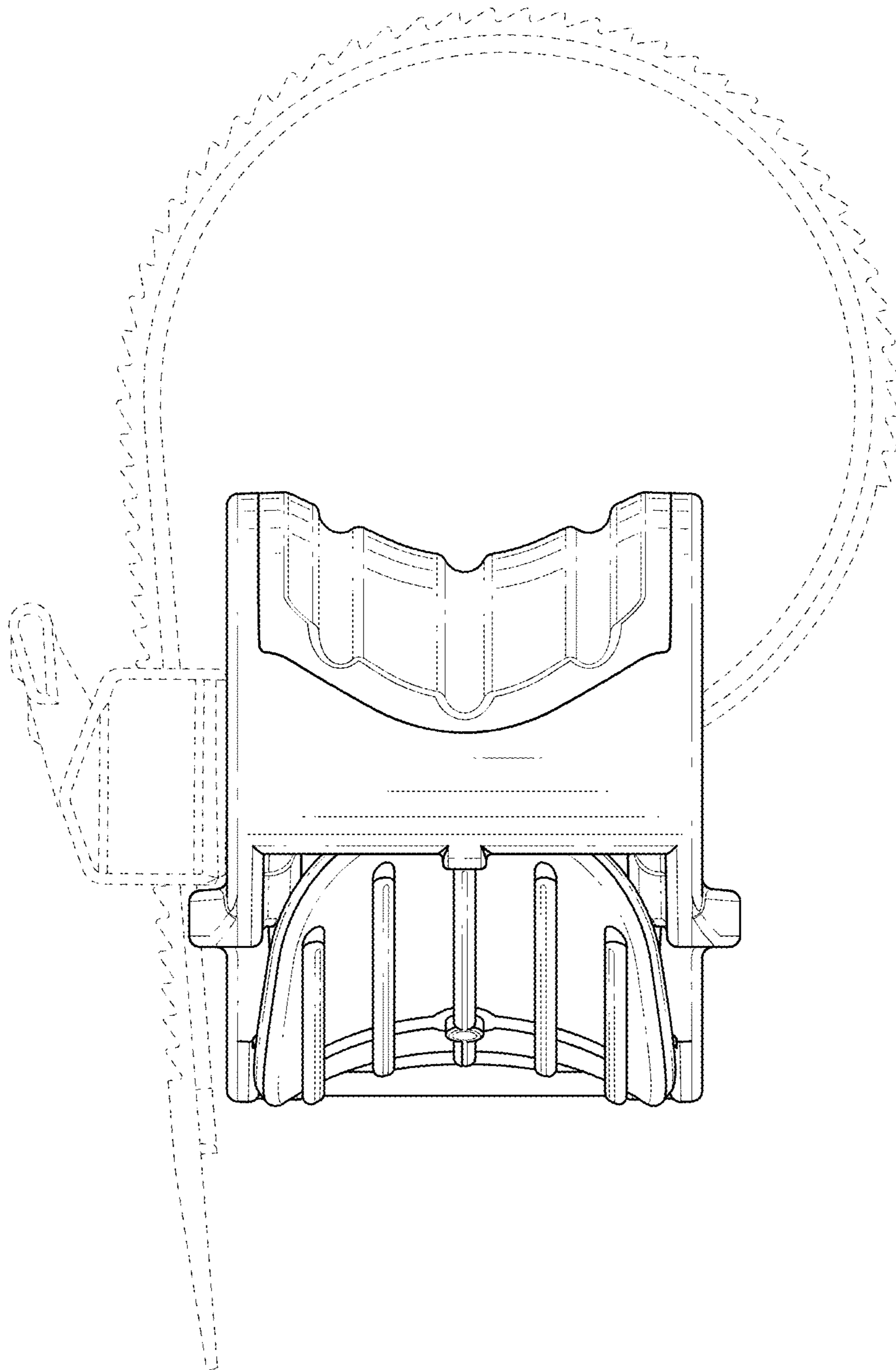

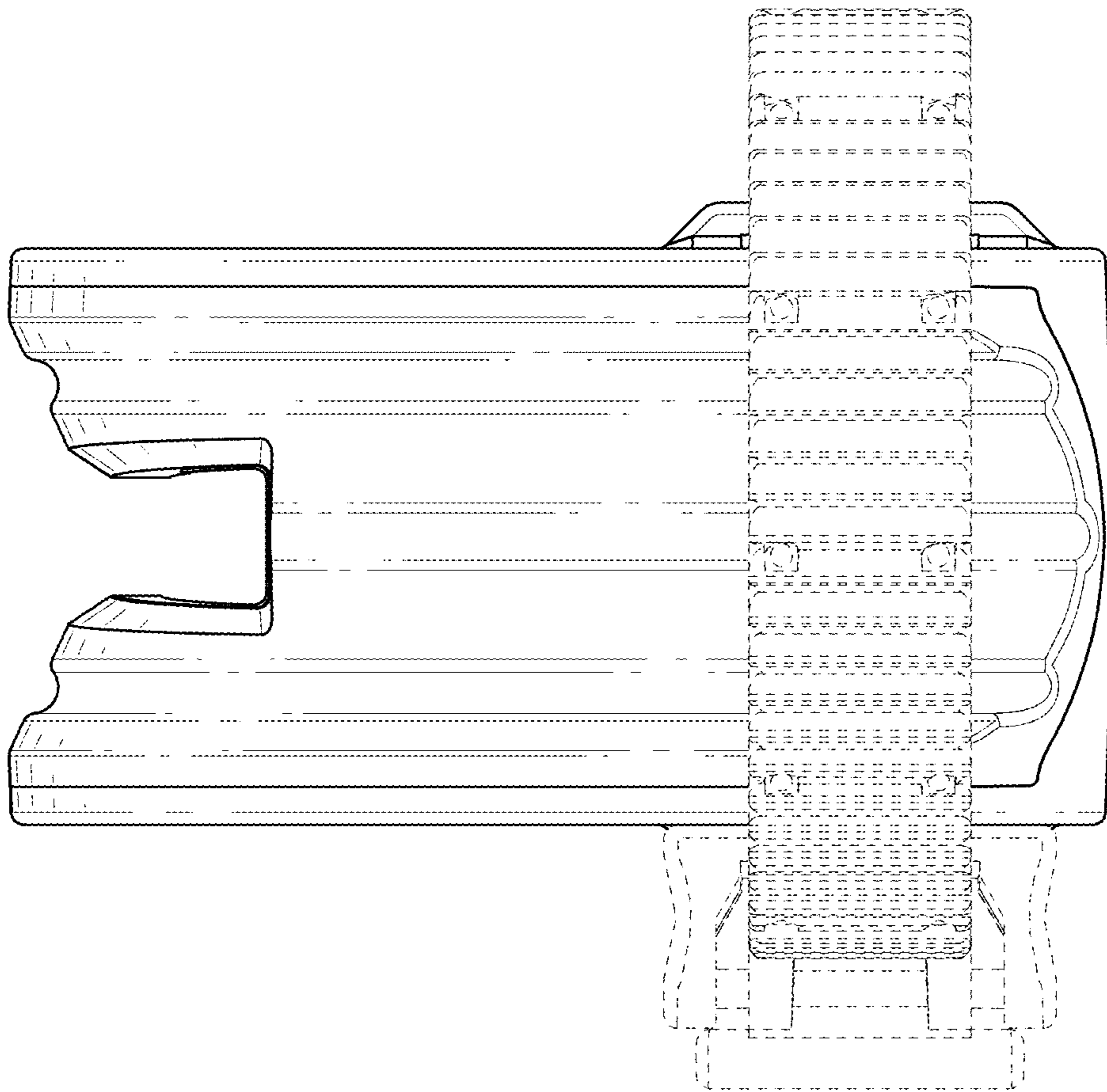

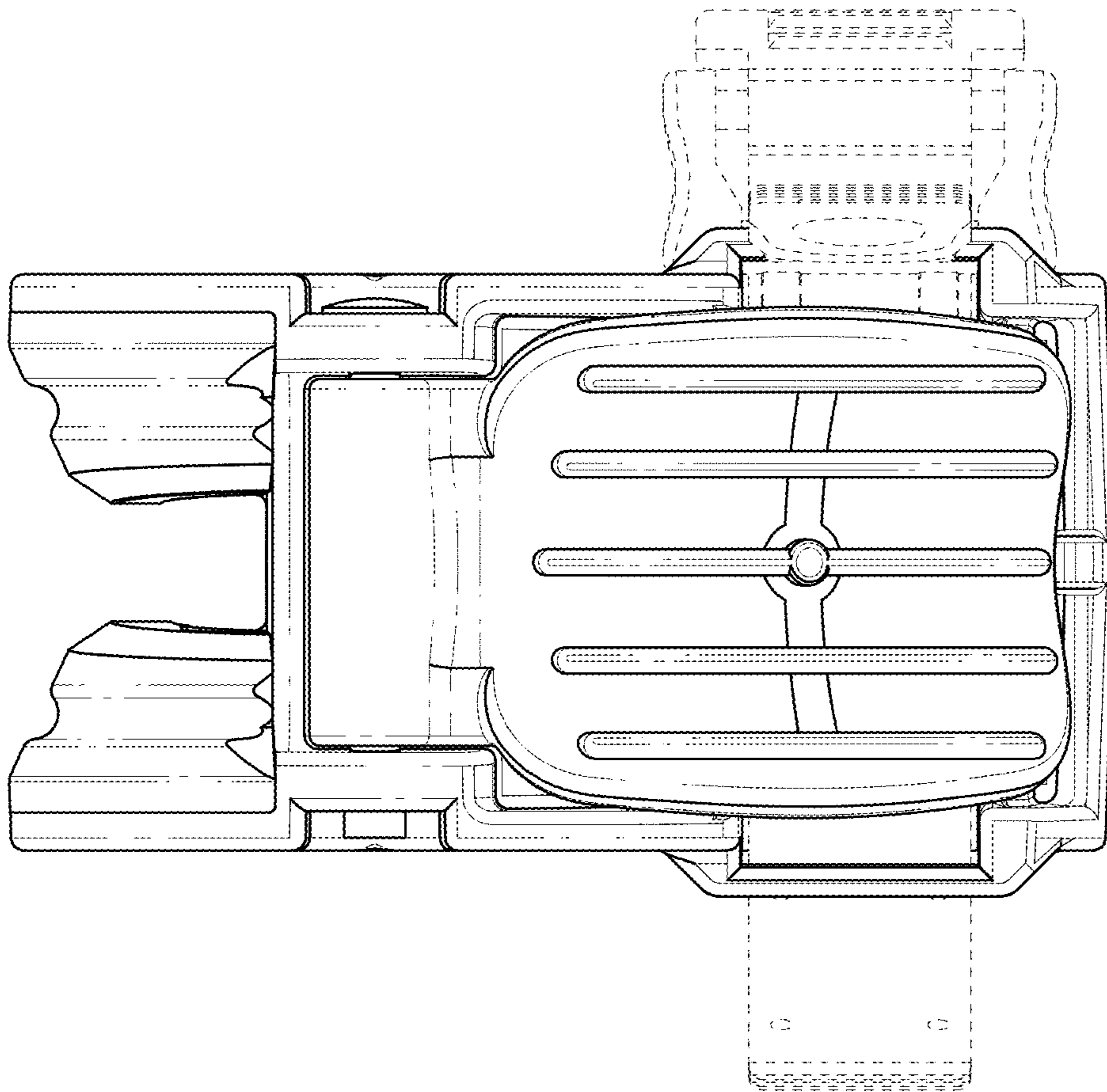
