(57) **CLAIM**

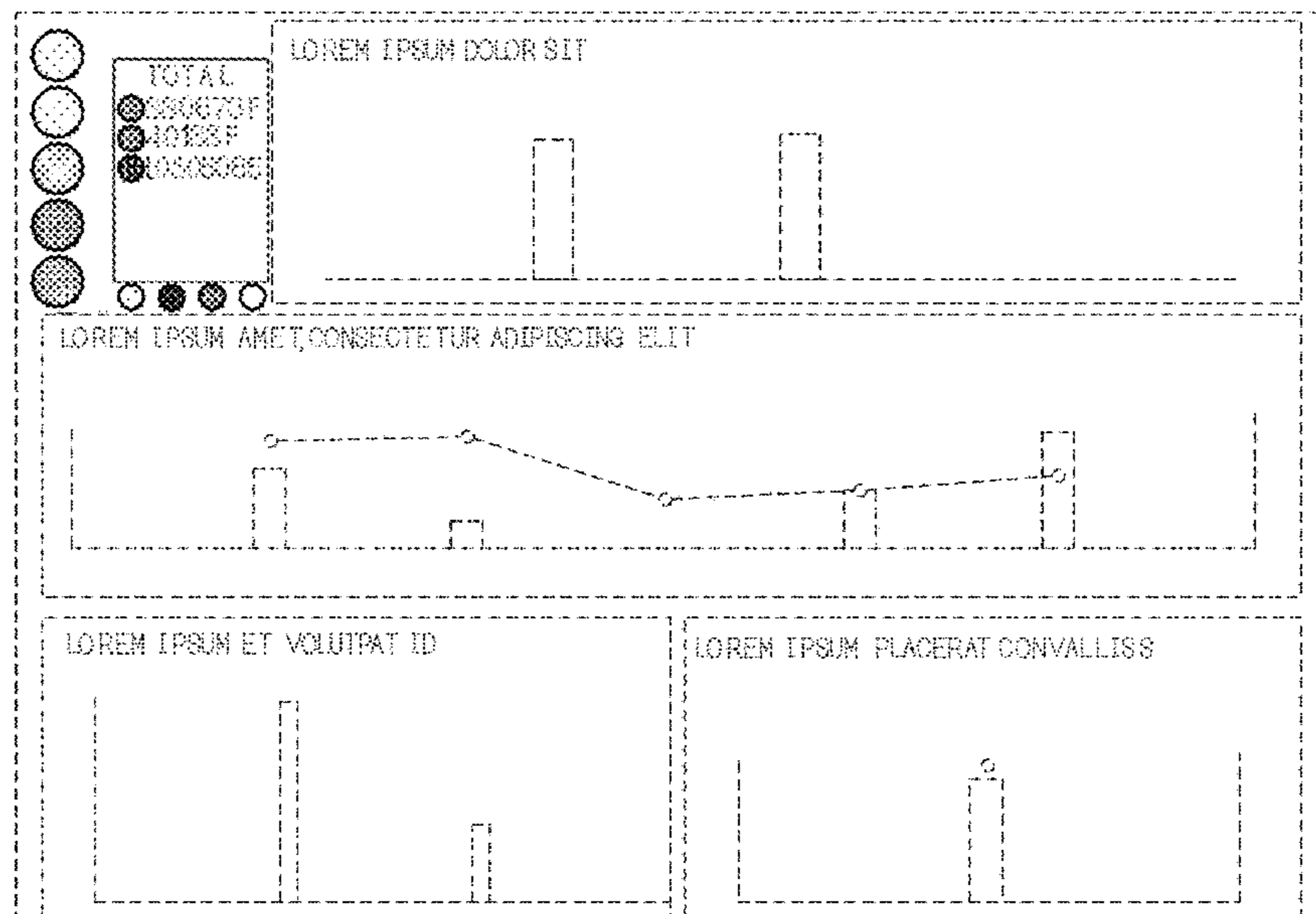
What is claimed is the ornamental design for a display with a graphical user interface, as shown and described.

**DESCRIPTION**

The single FIGURE is a front view of a display with graphical user interface.

The broken line at the periphery of the FIGURE illustrates a display and the remainder of the broken lines within the FIGURE illustrates portions of the graphical user interface. None of the broken lines form part of the claimed design. The variation in stippling within the circles demonstrates contrasting colors.
