DESCRIPTION

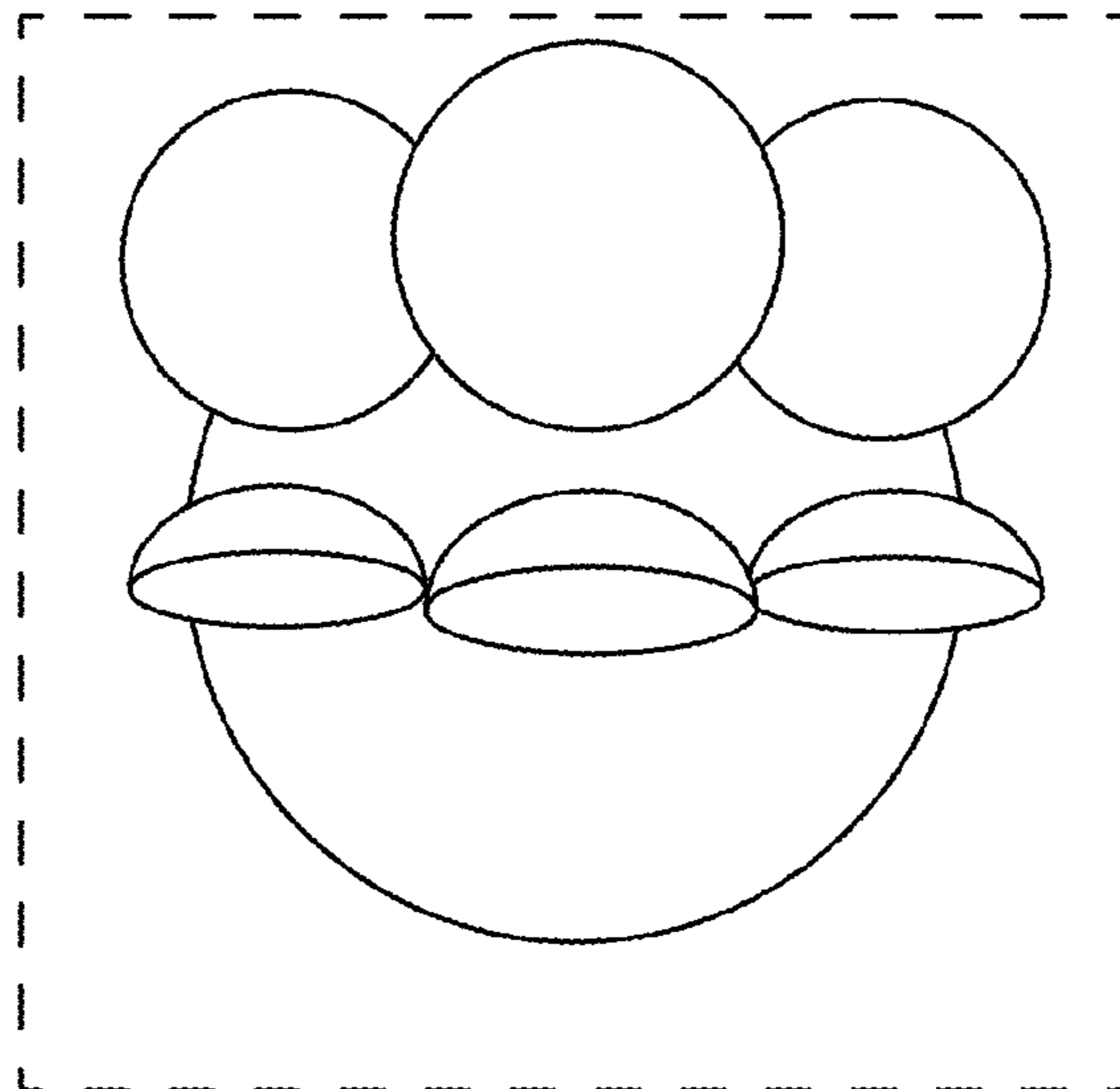
FIG. 1 is a front view of a display panel or portion thereof with a graphical user interface showing the first image in a sequence; and,

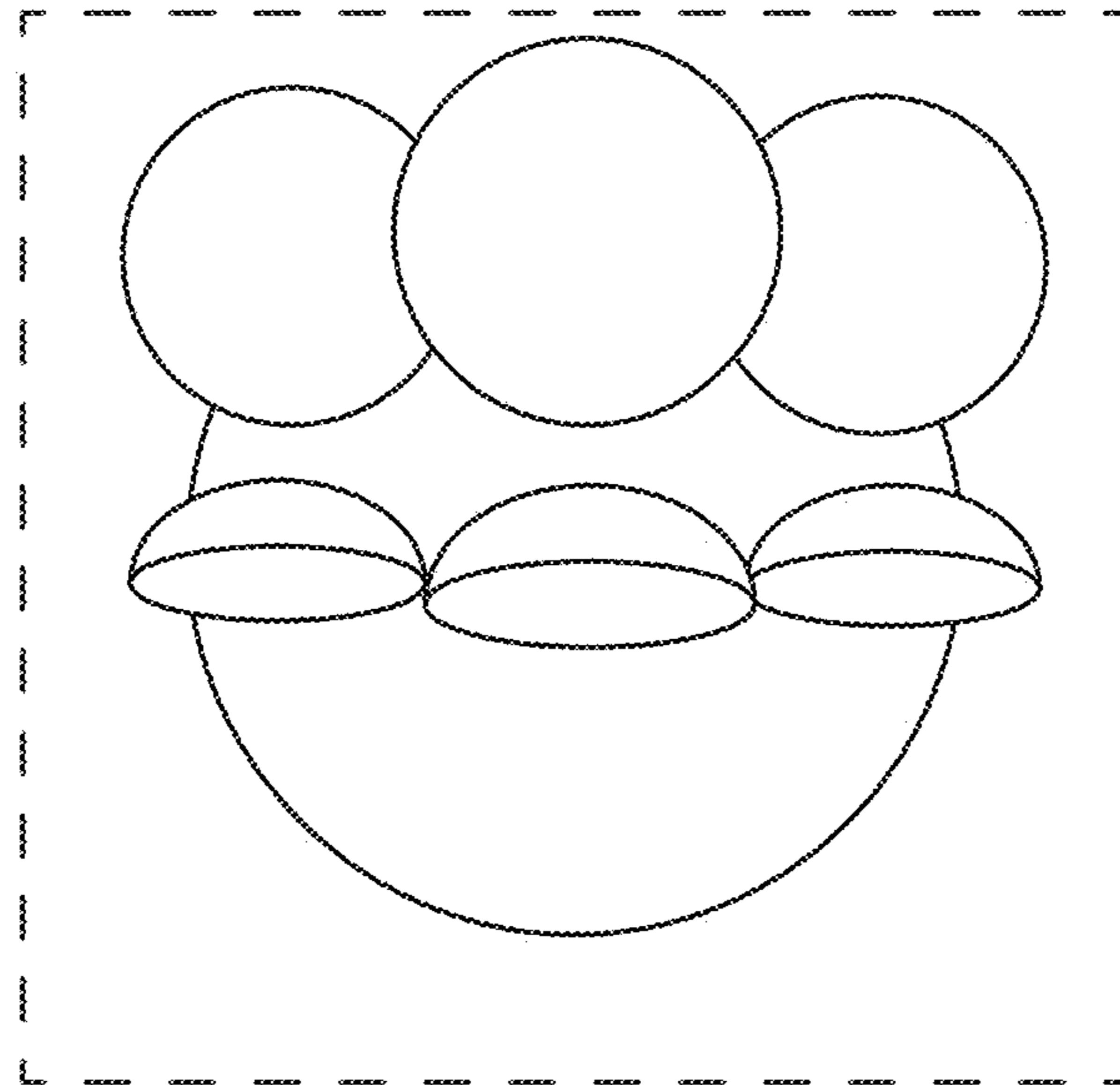

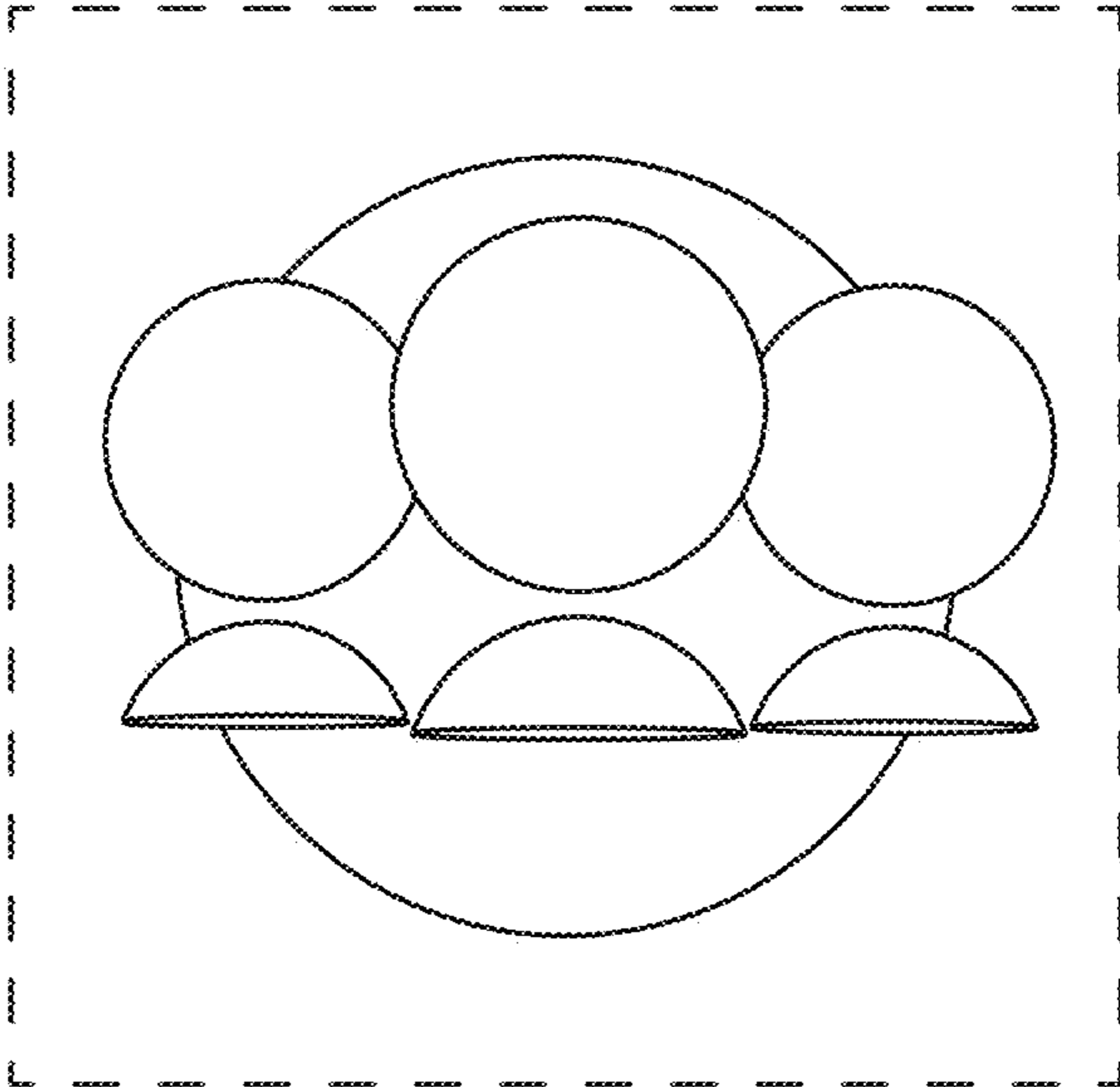
