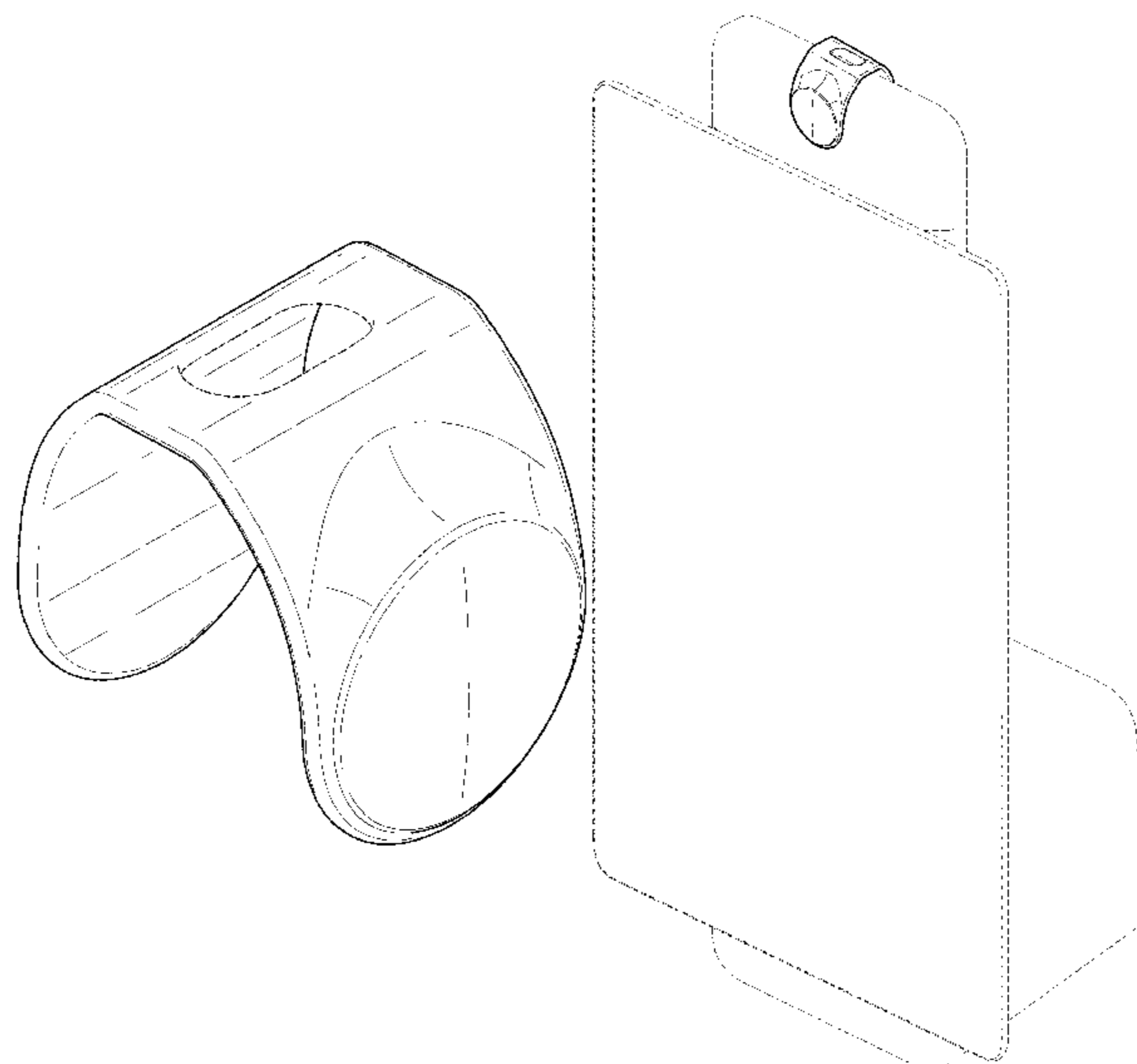
(57) **CLAIM**

The ornamental design for a camera cover for electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a camera cover for electronic device showing the new design;

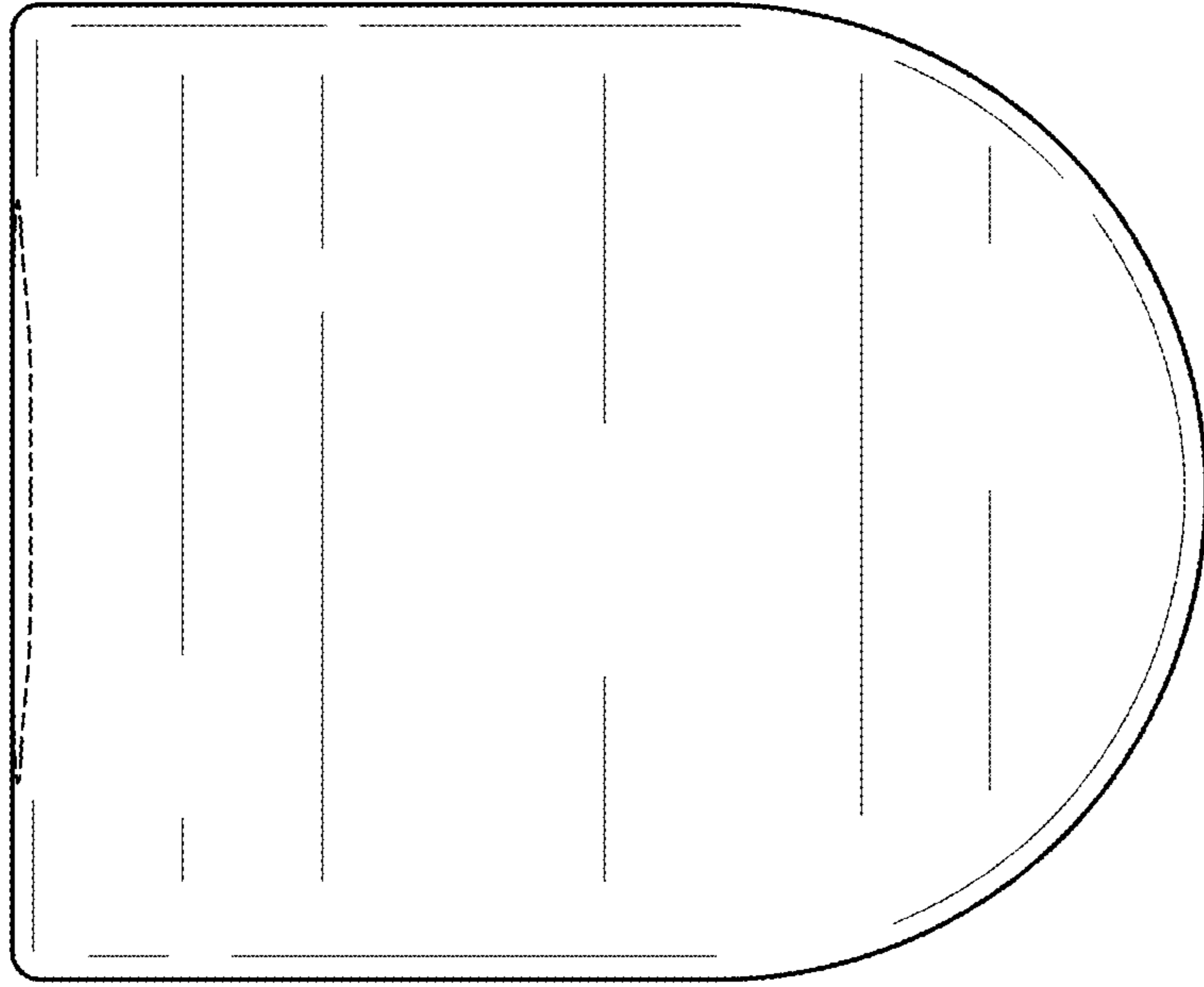

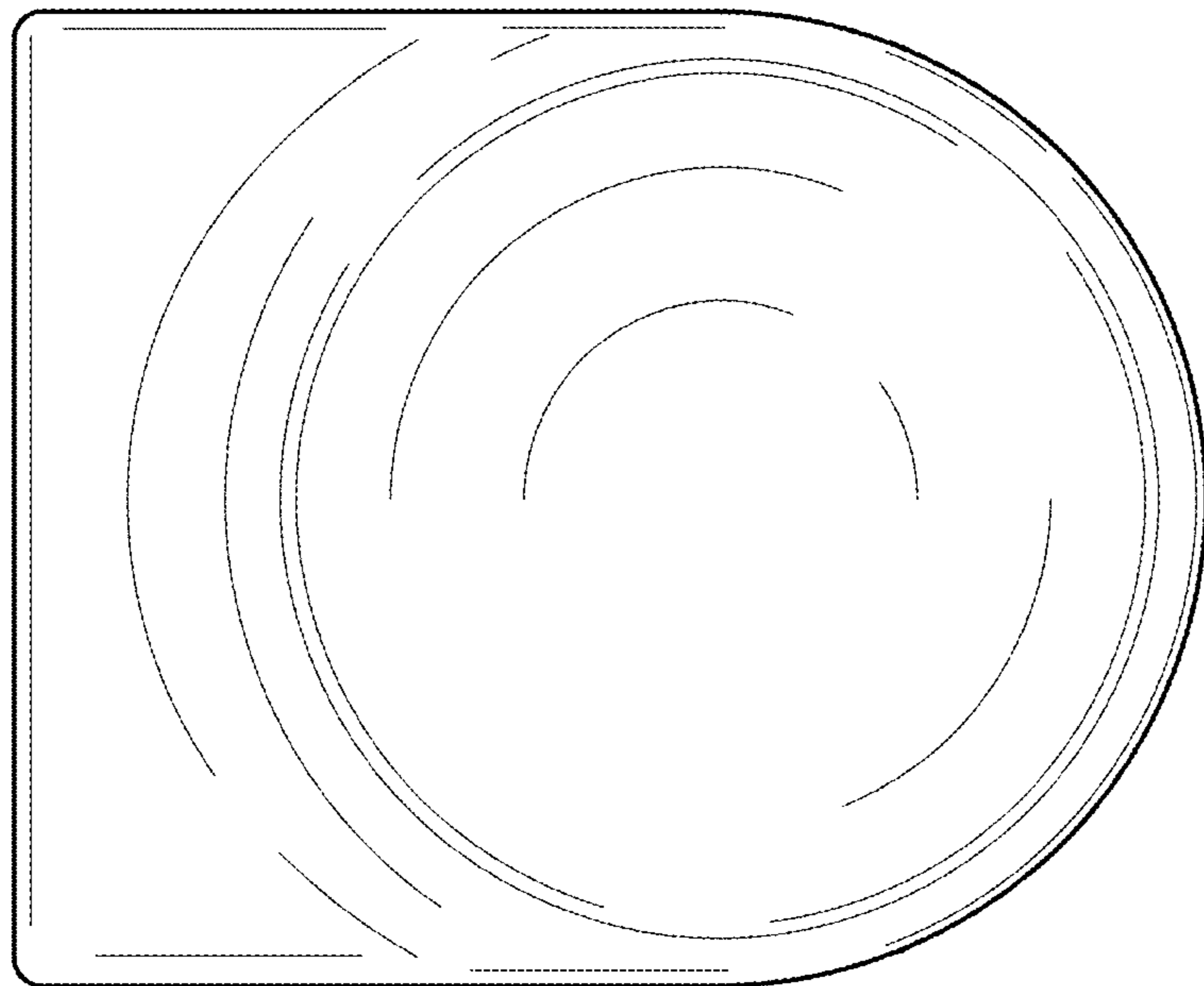

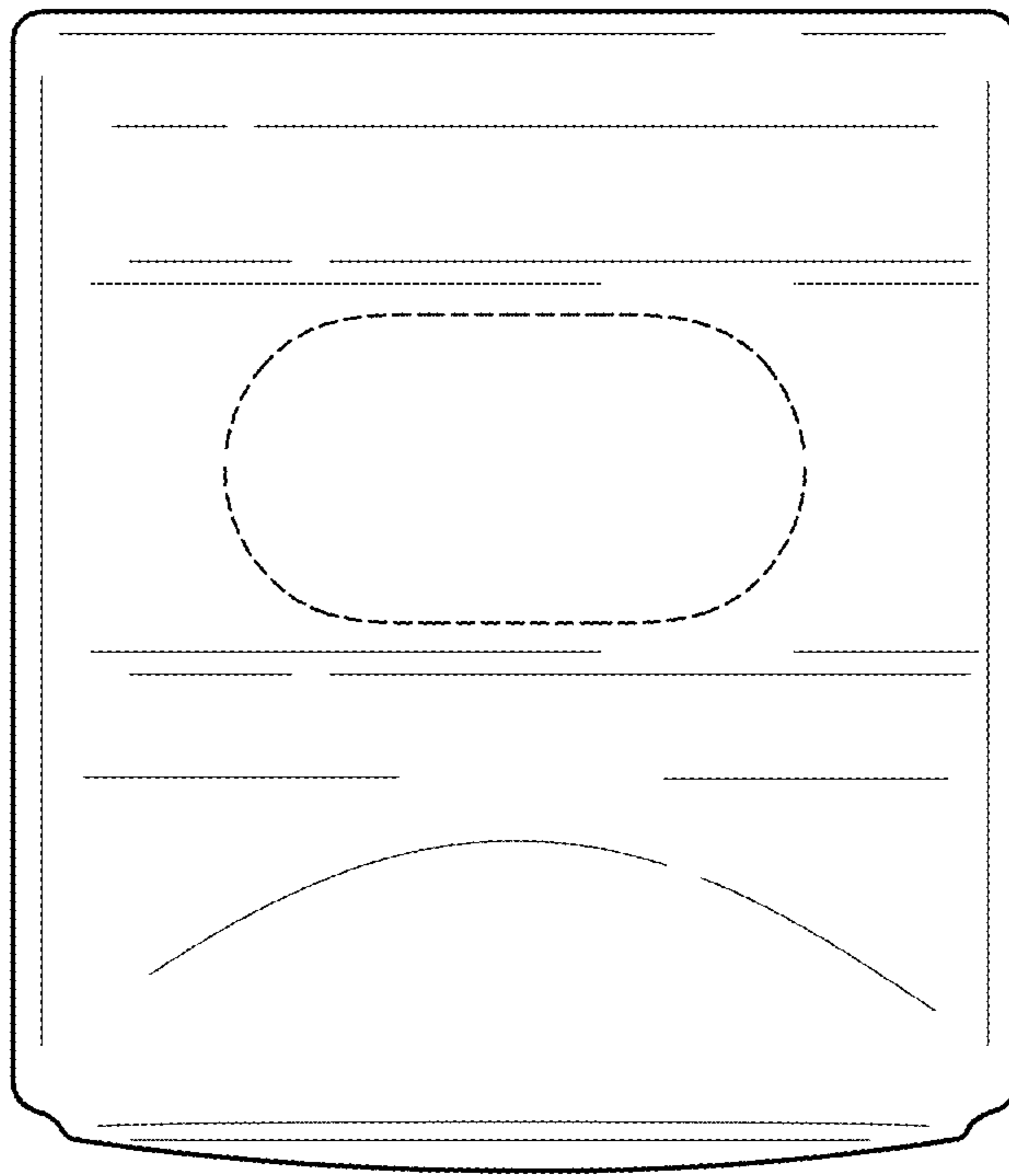

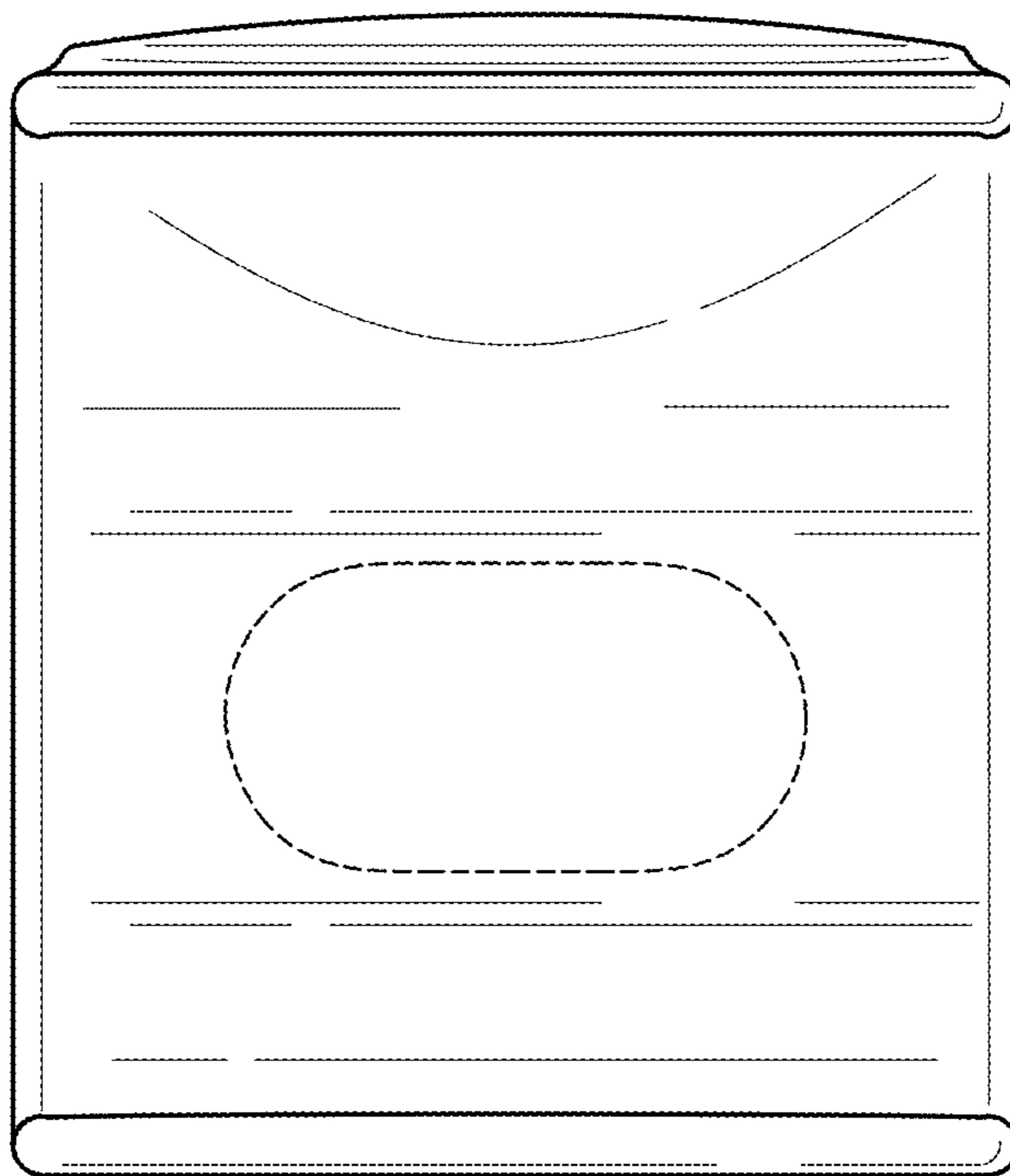

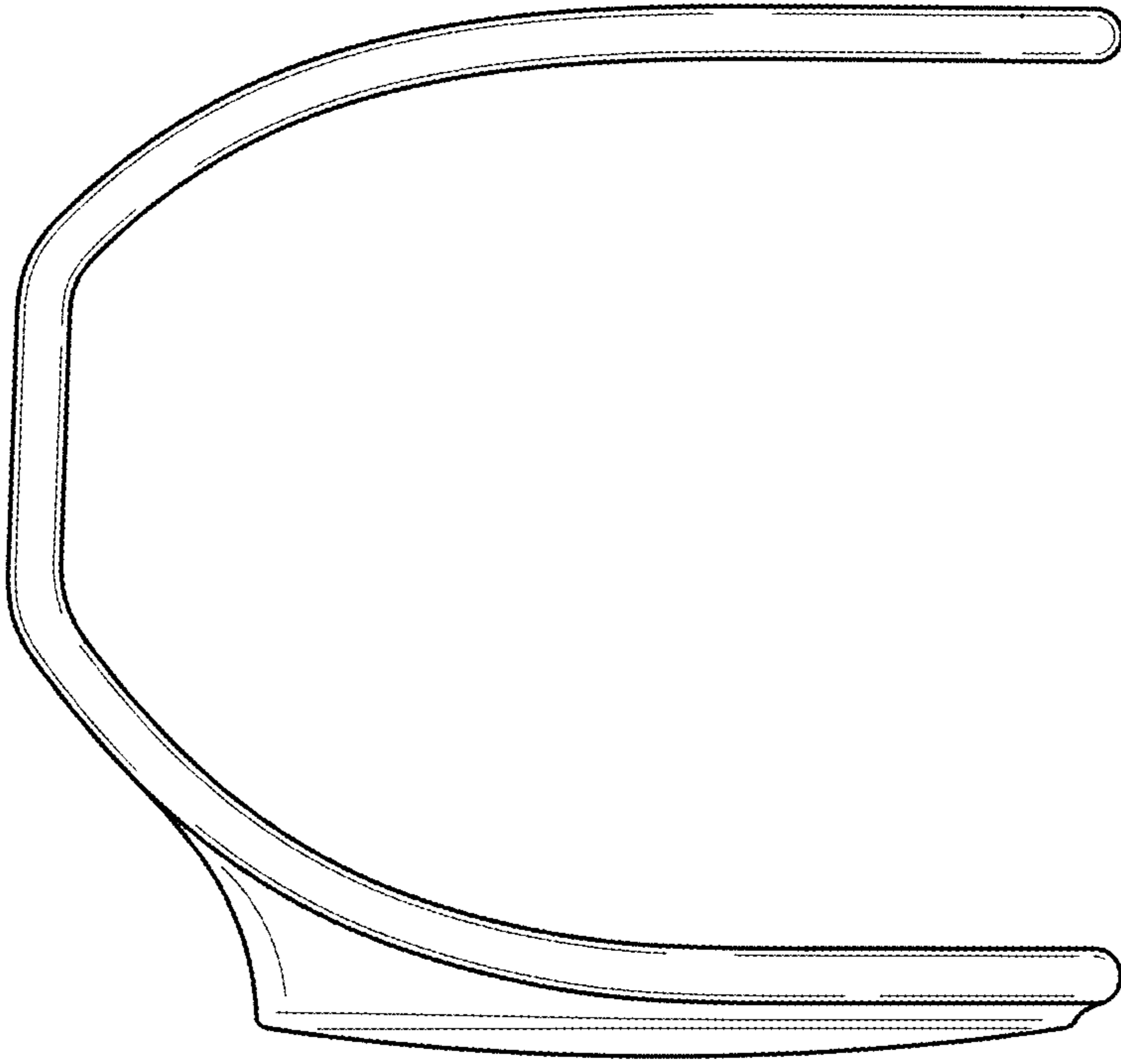

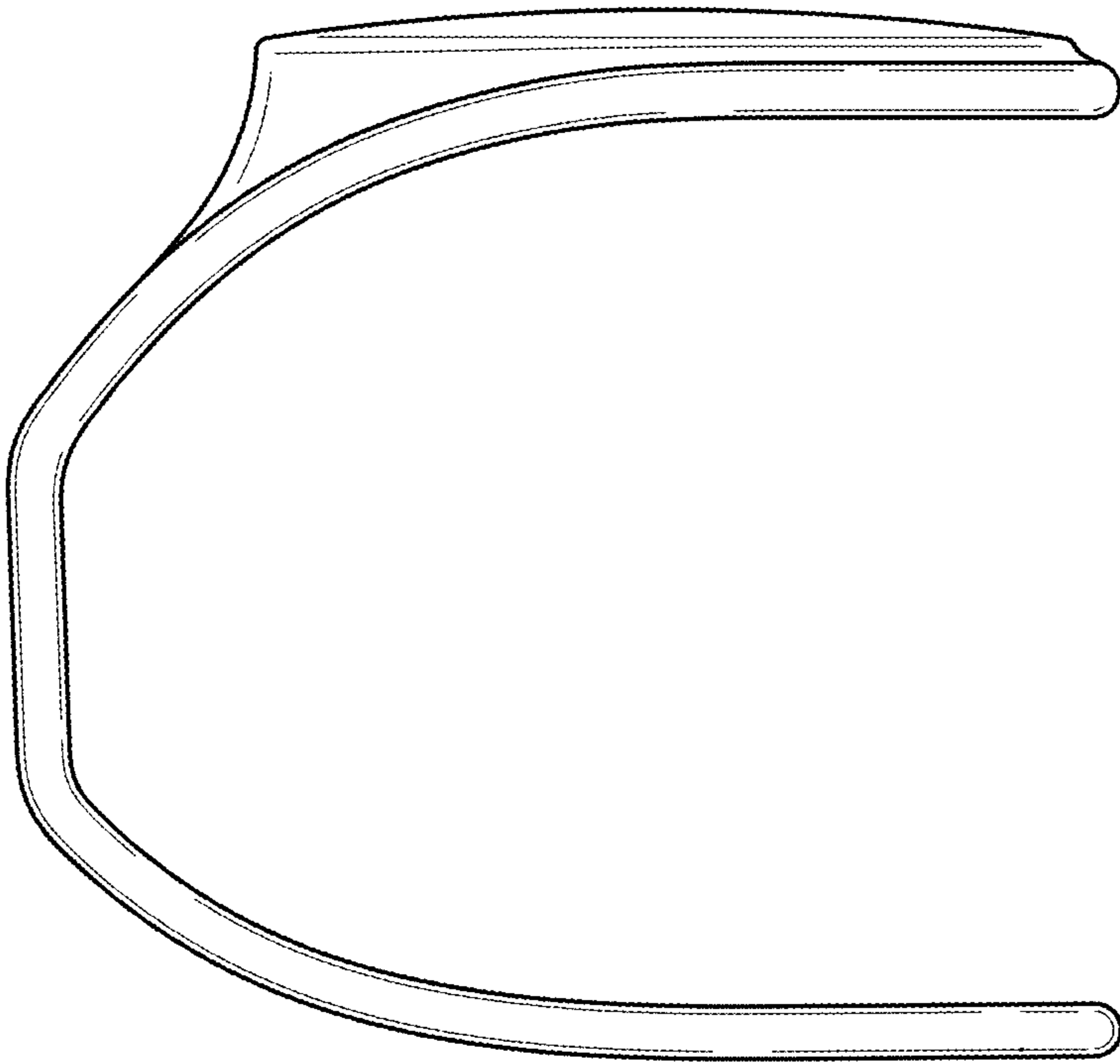

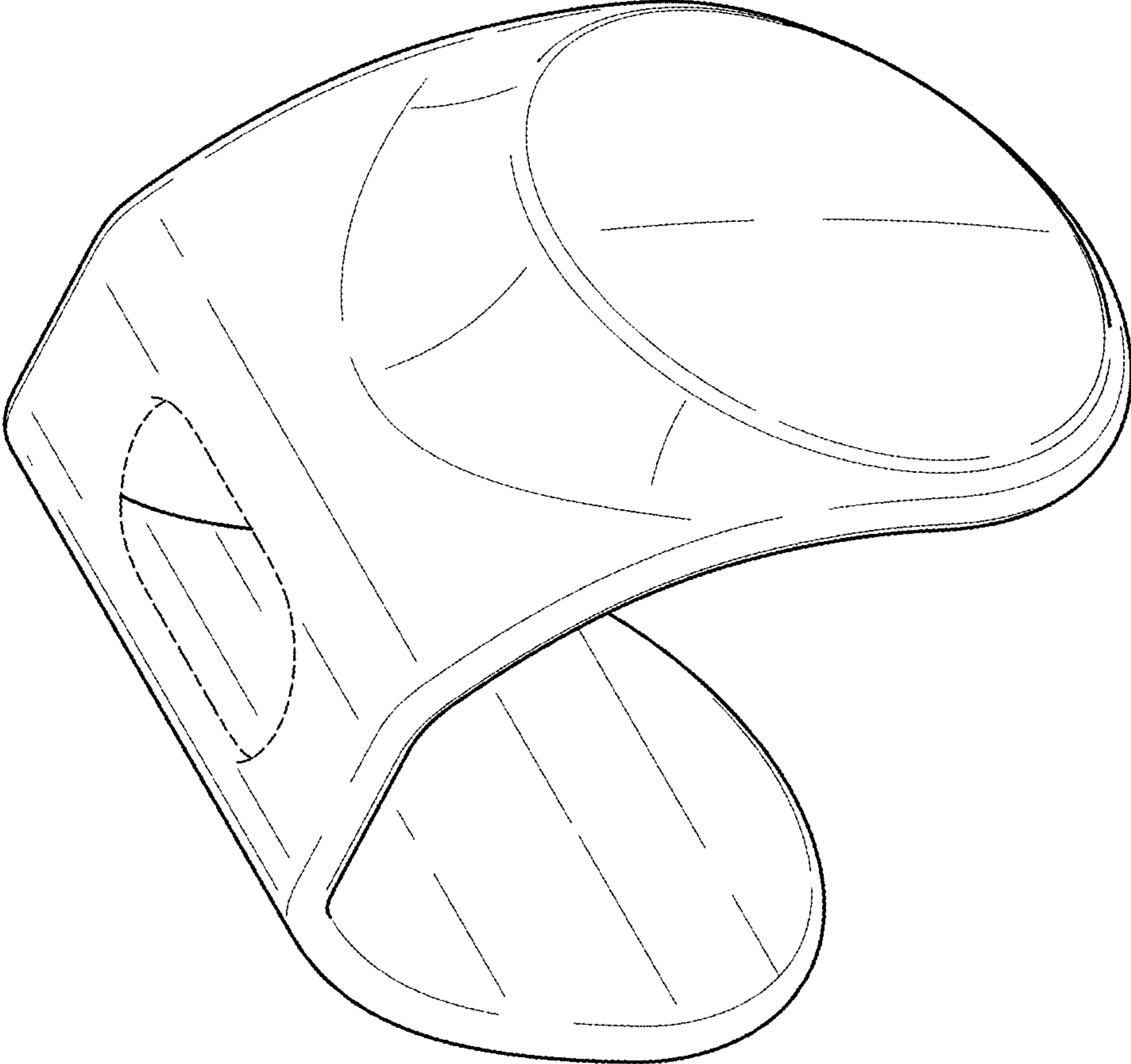

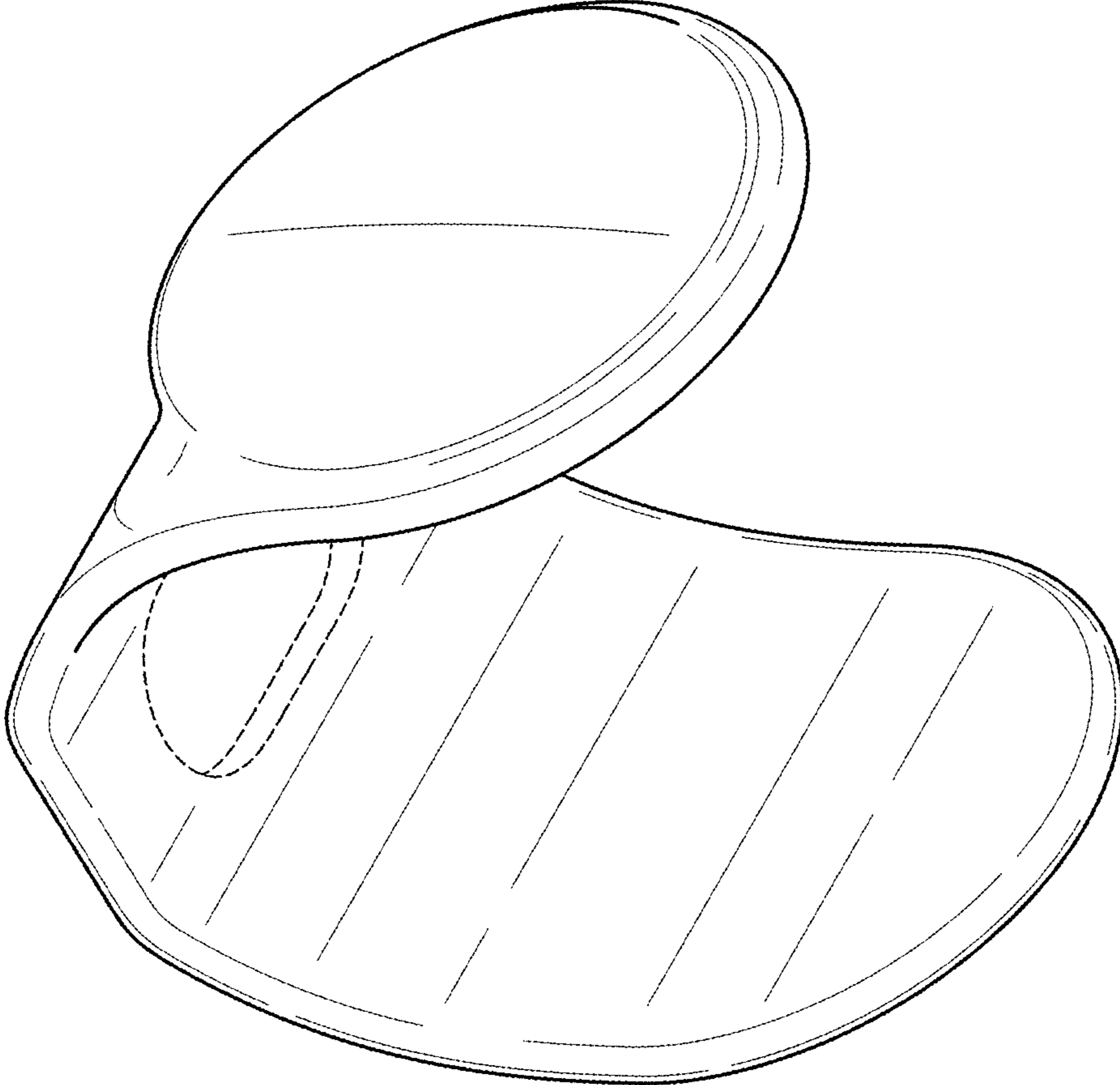
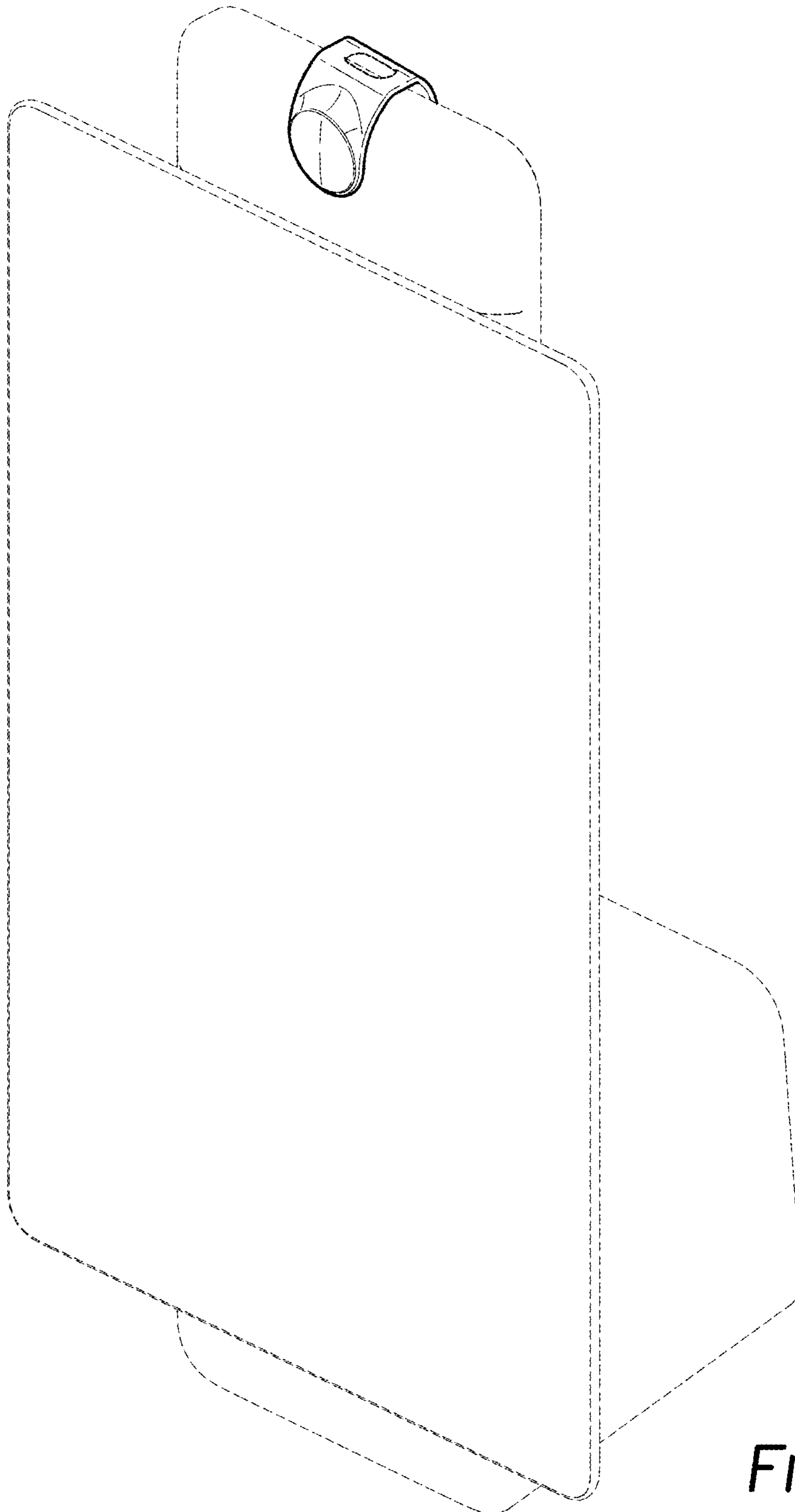
