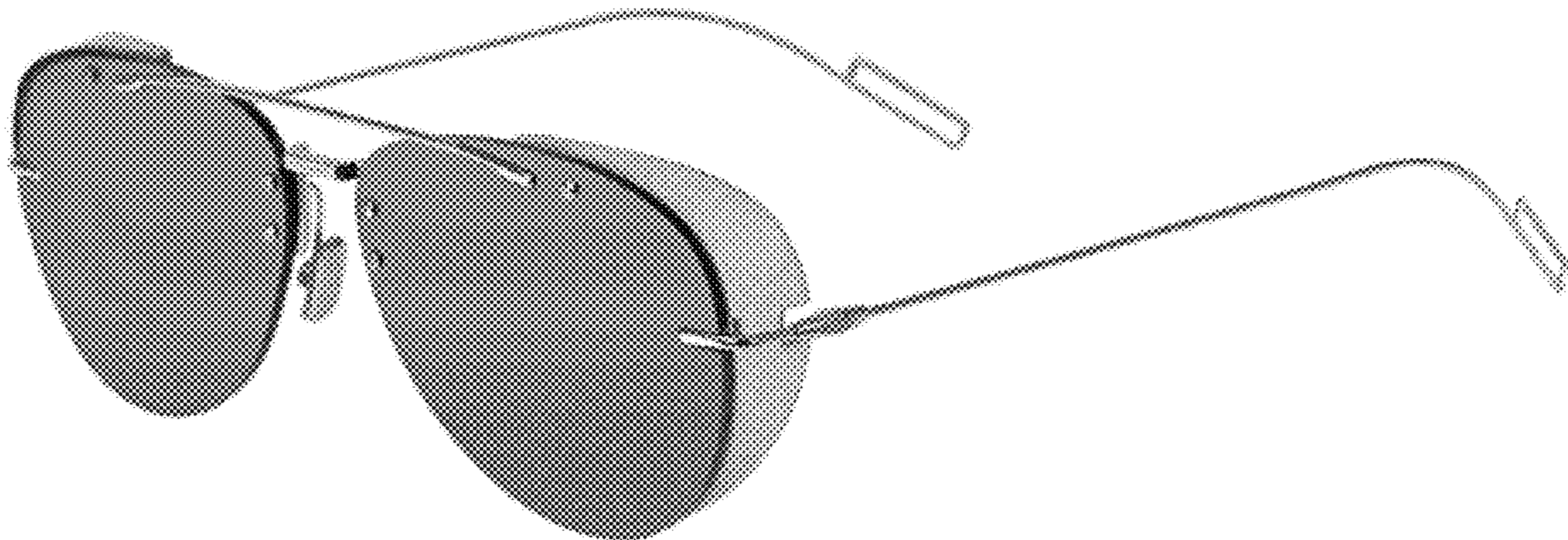

The ornamental design for spectacles, as shown and described.

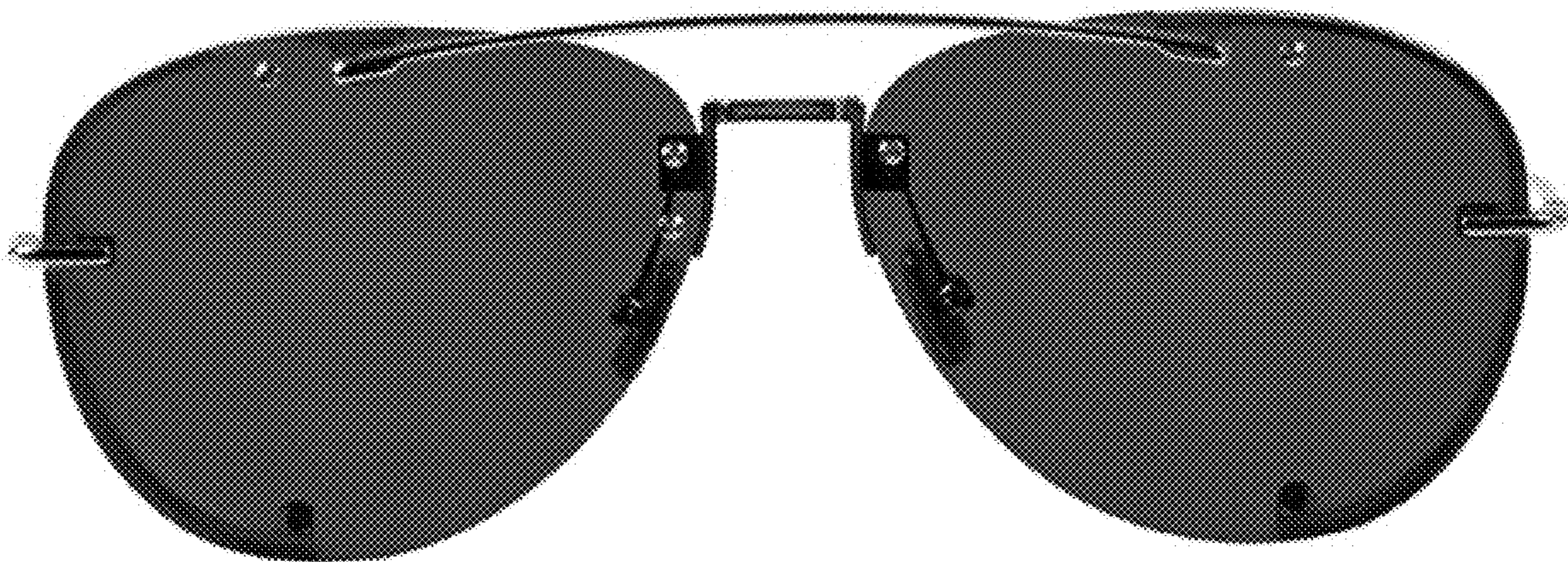
DESCRIPTION

- 1.7** is a perspective view thereof.

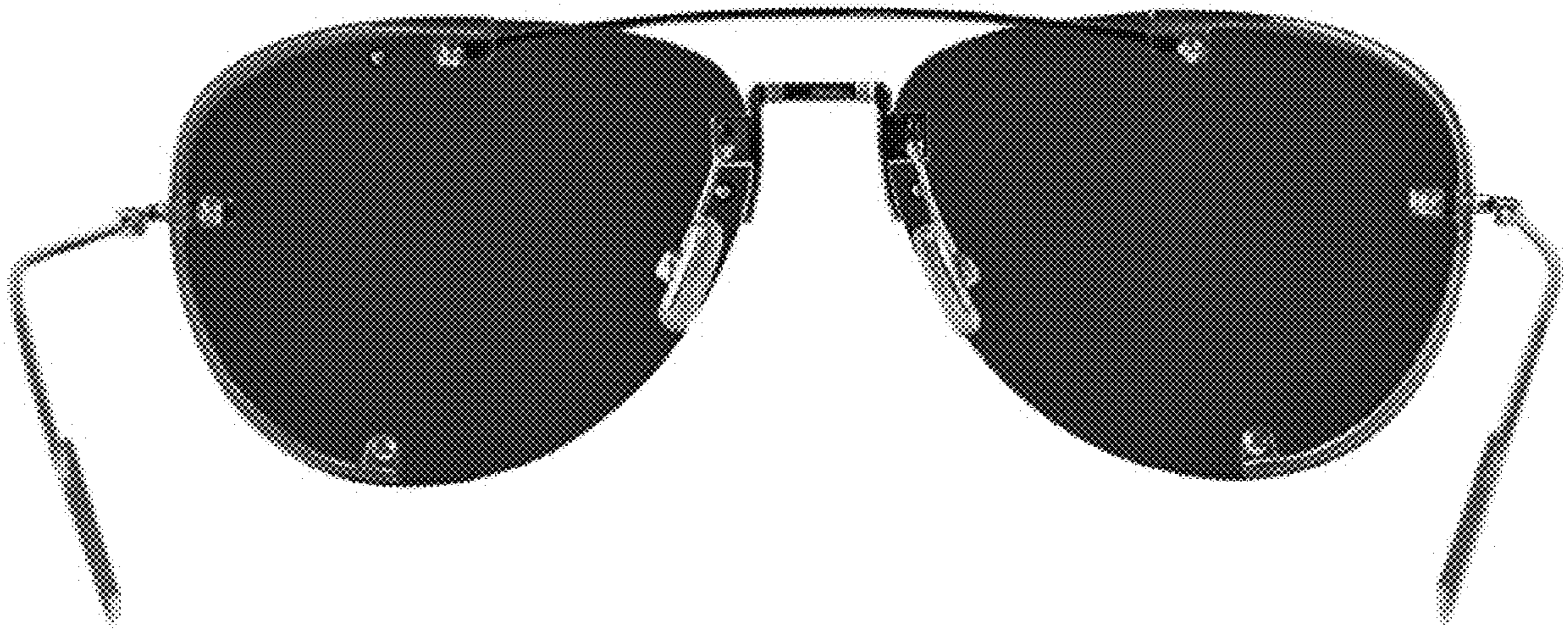

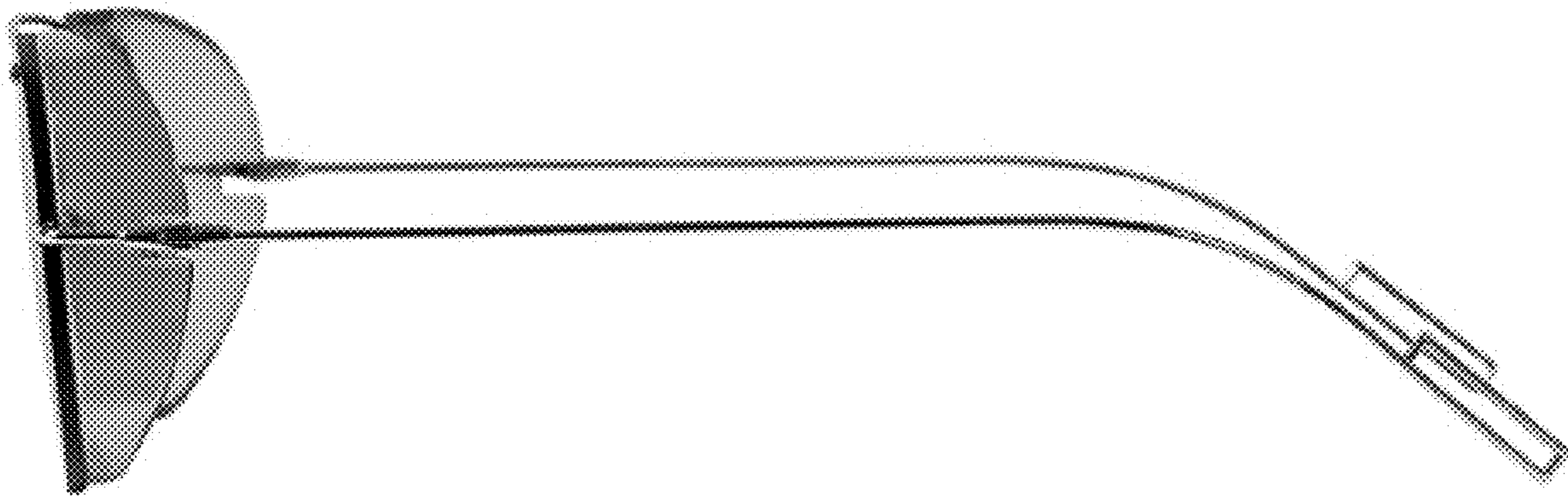

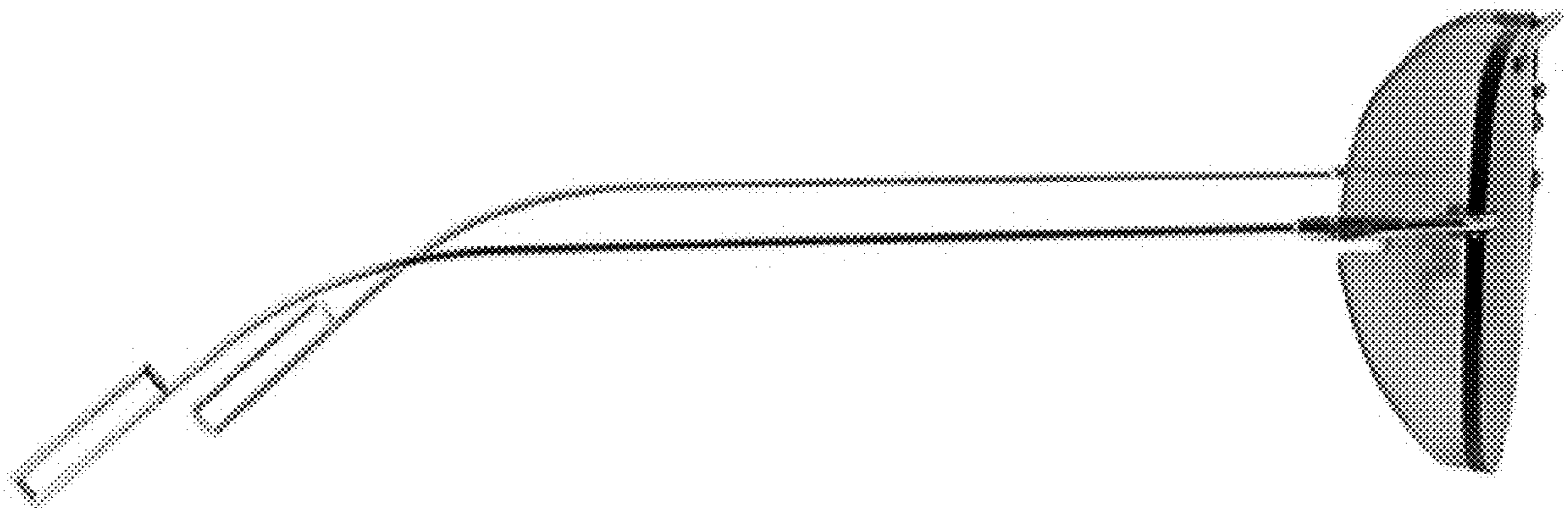
