The ornamental design for a shooting bag, as shown and described.

FIG. 4 is elevational view of the right side thereof;

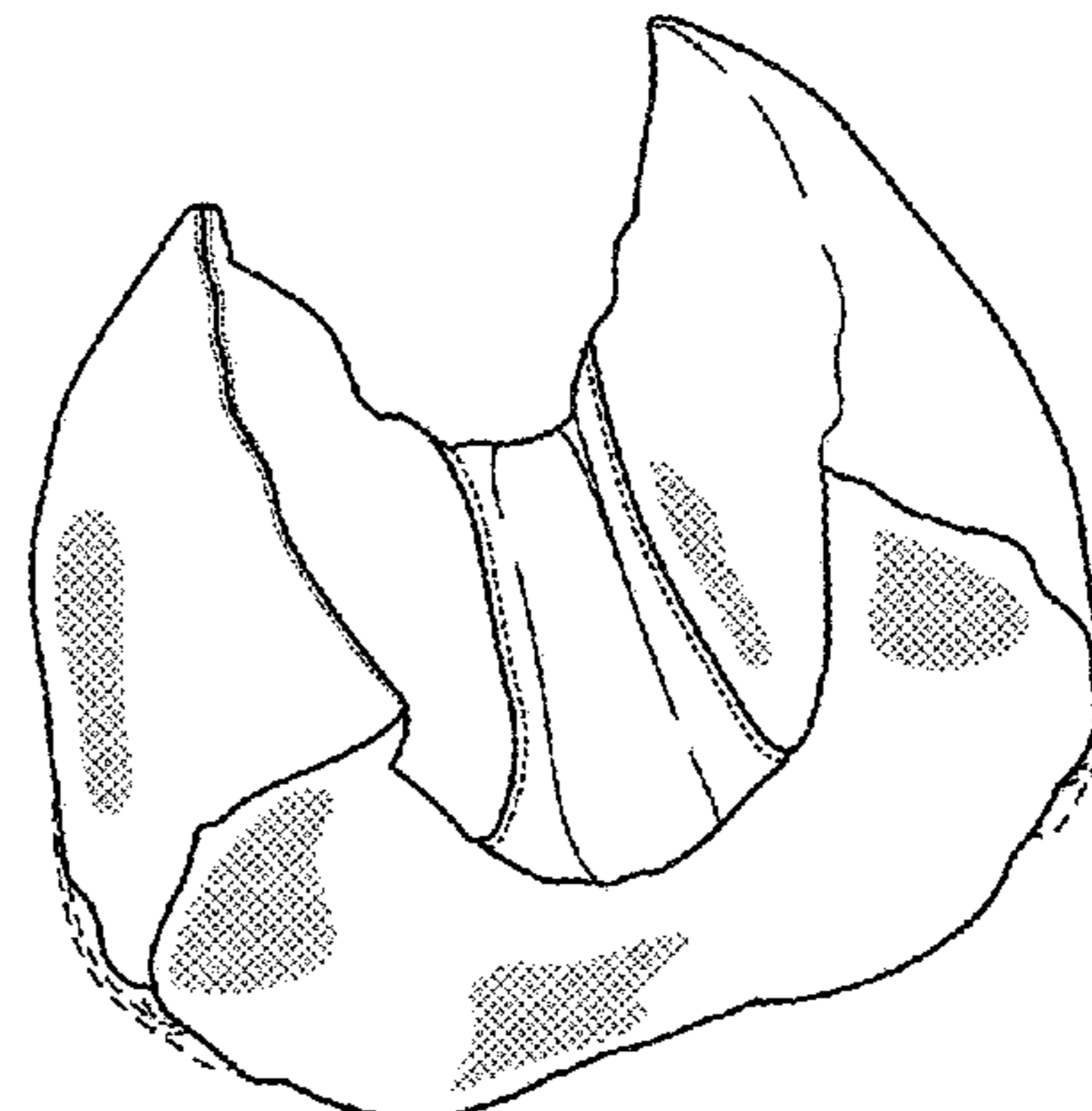
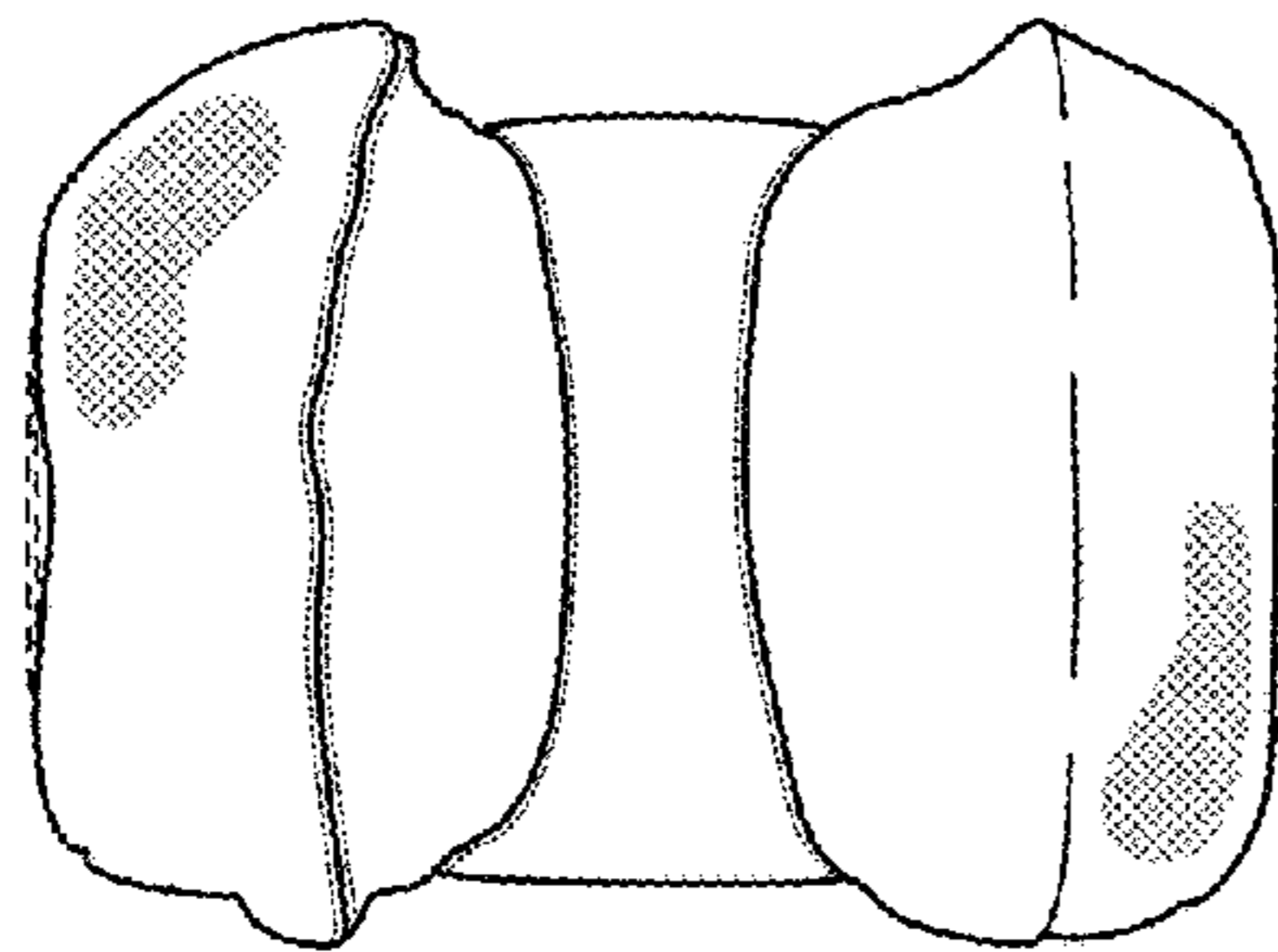
FIG. 5 is an elevational view of the front thereof; and,

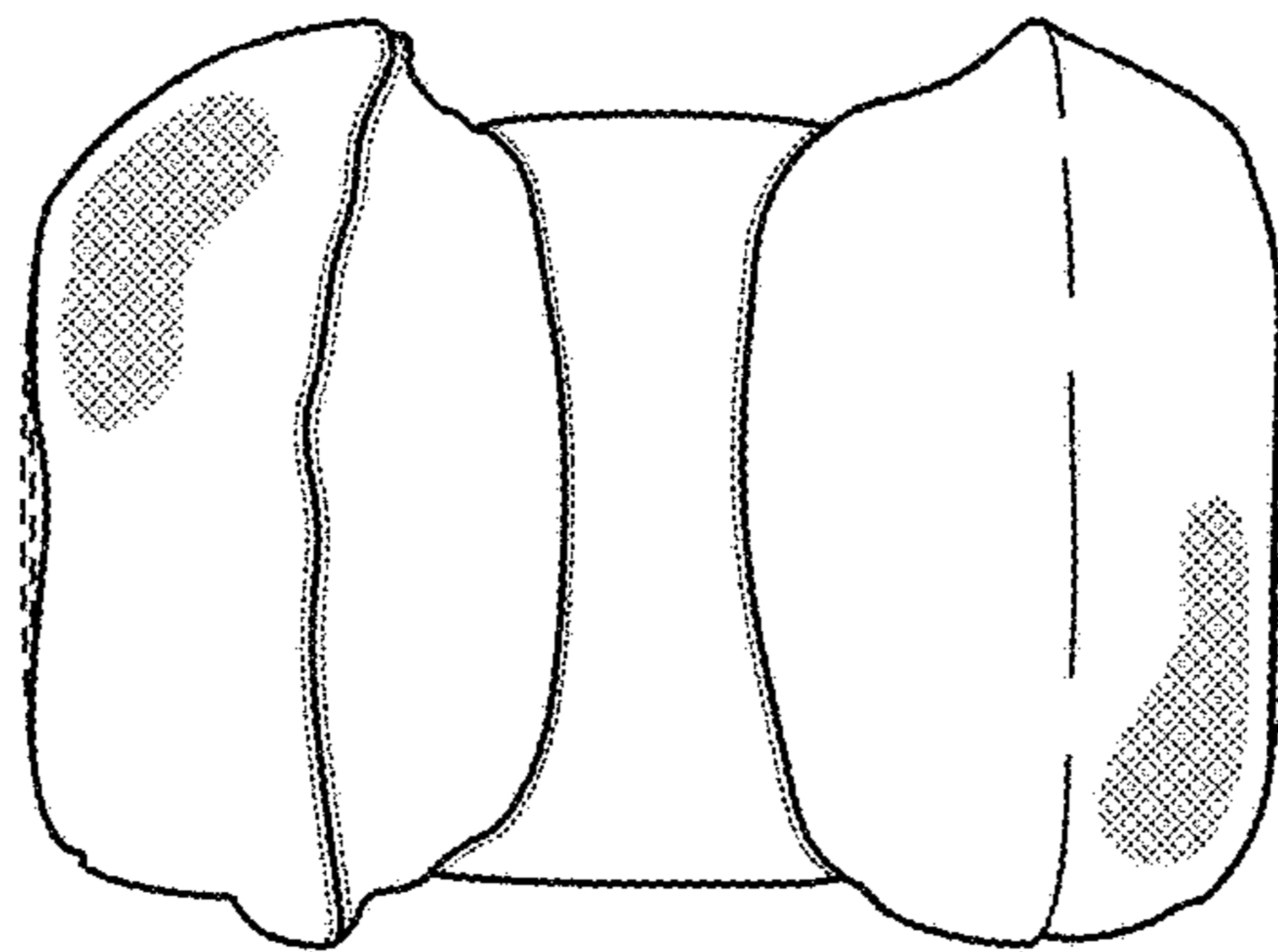

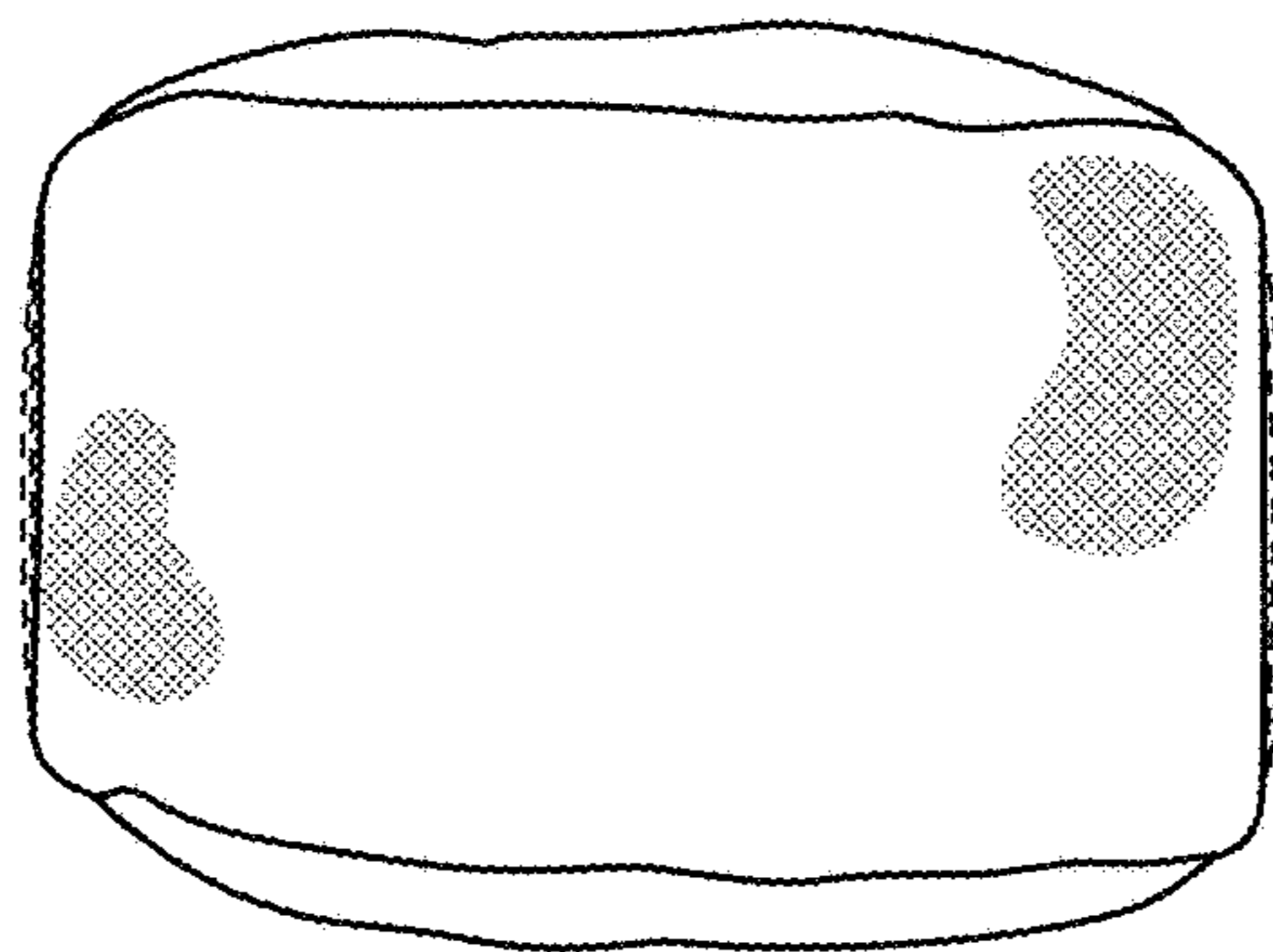

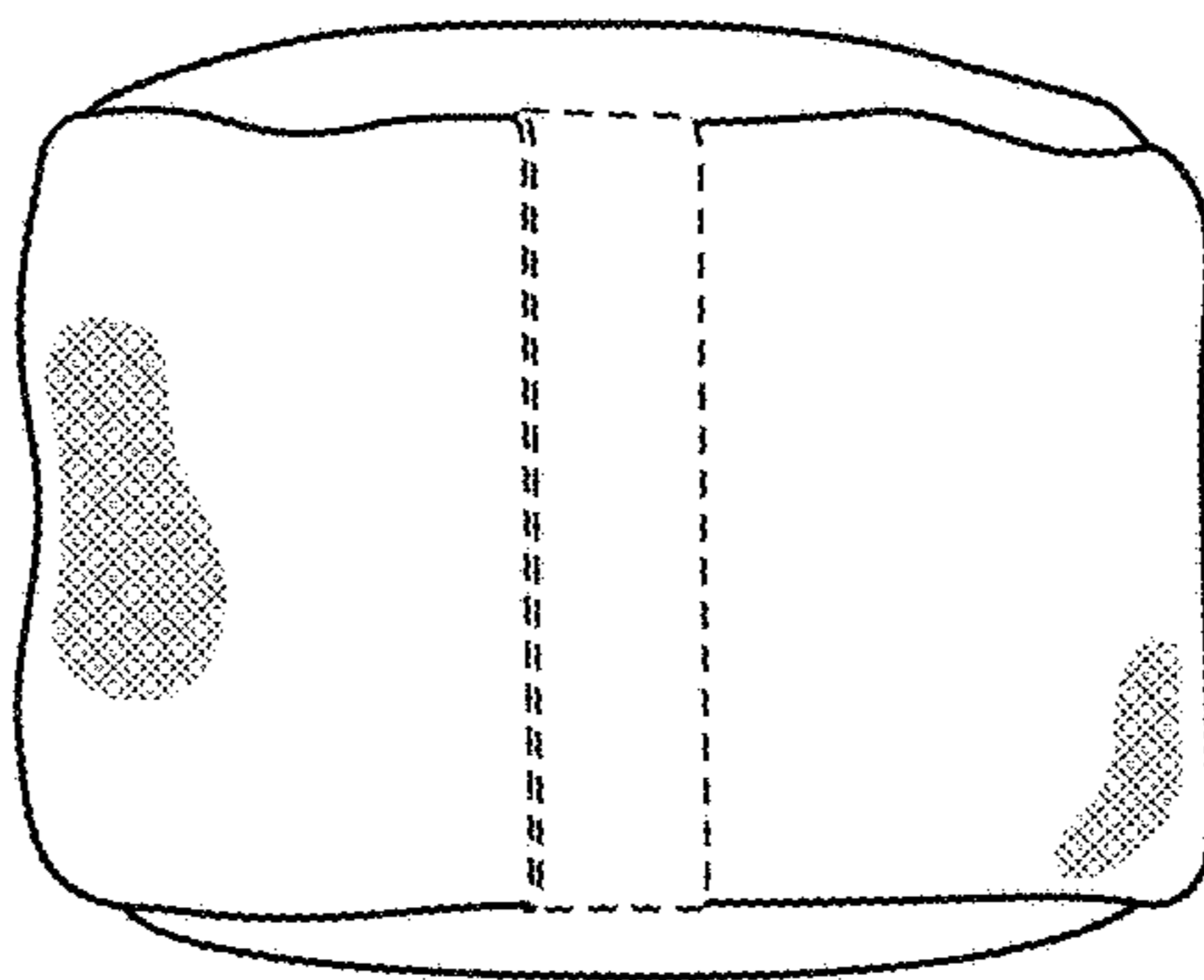

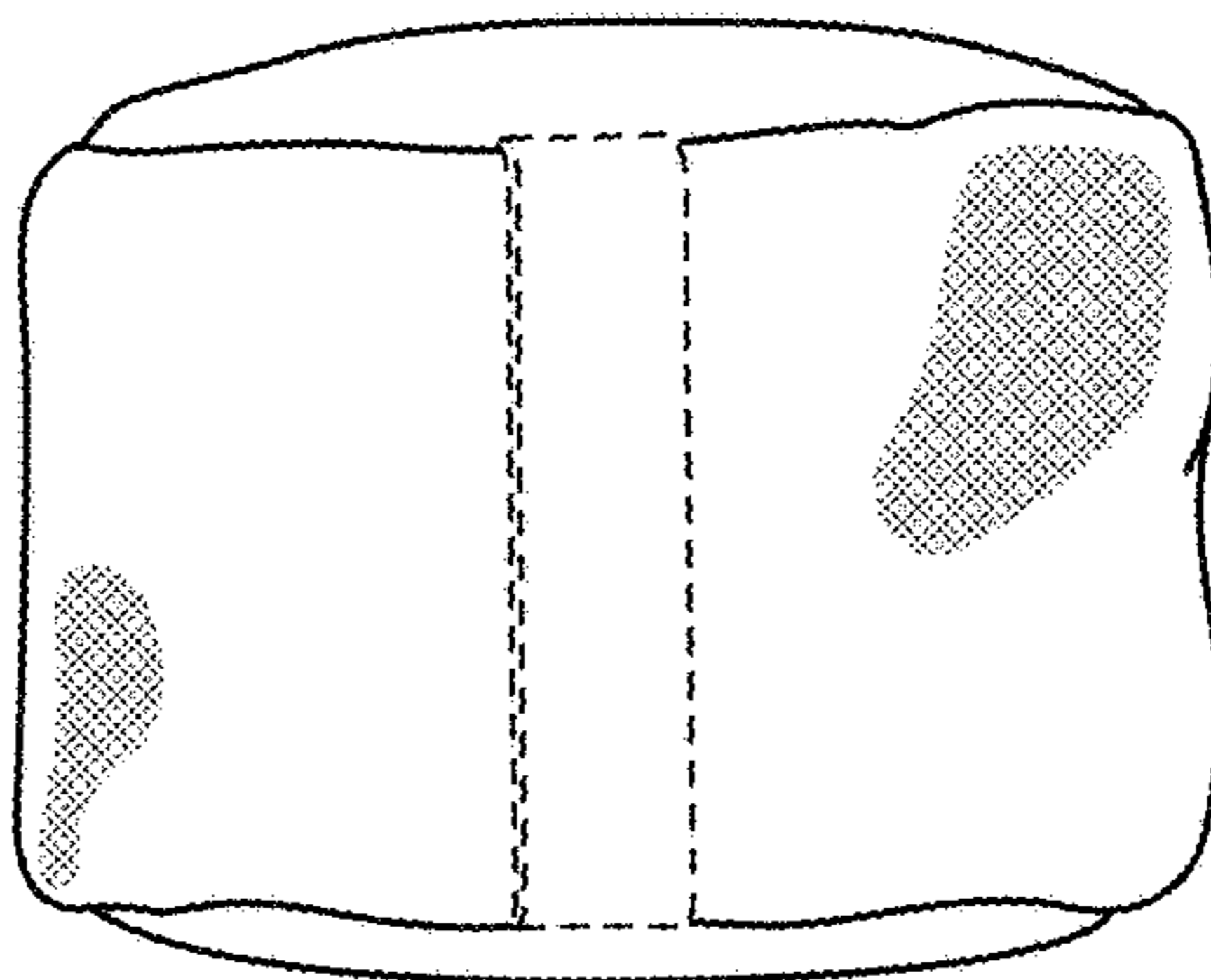

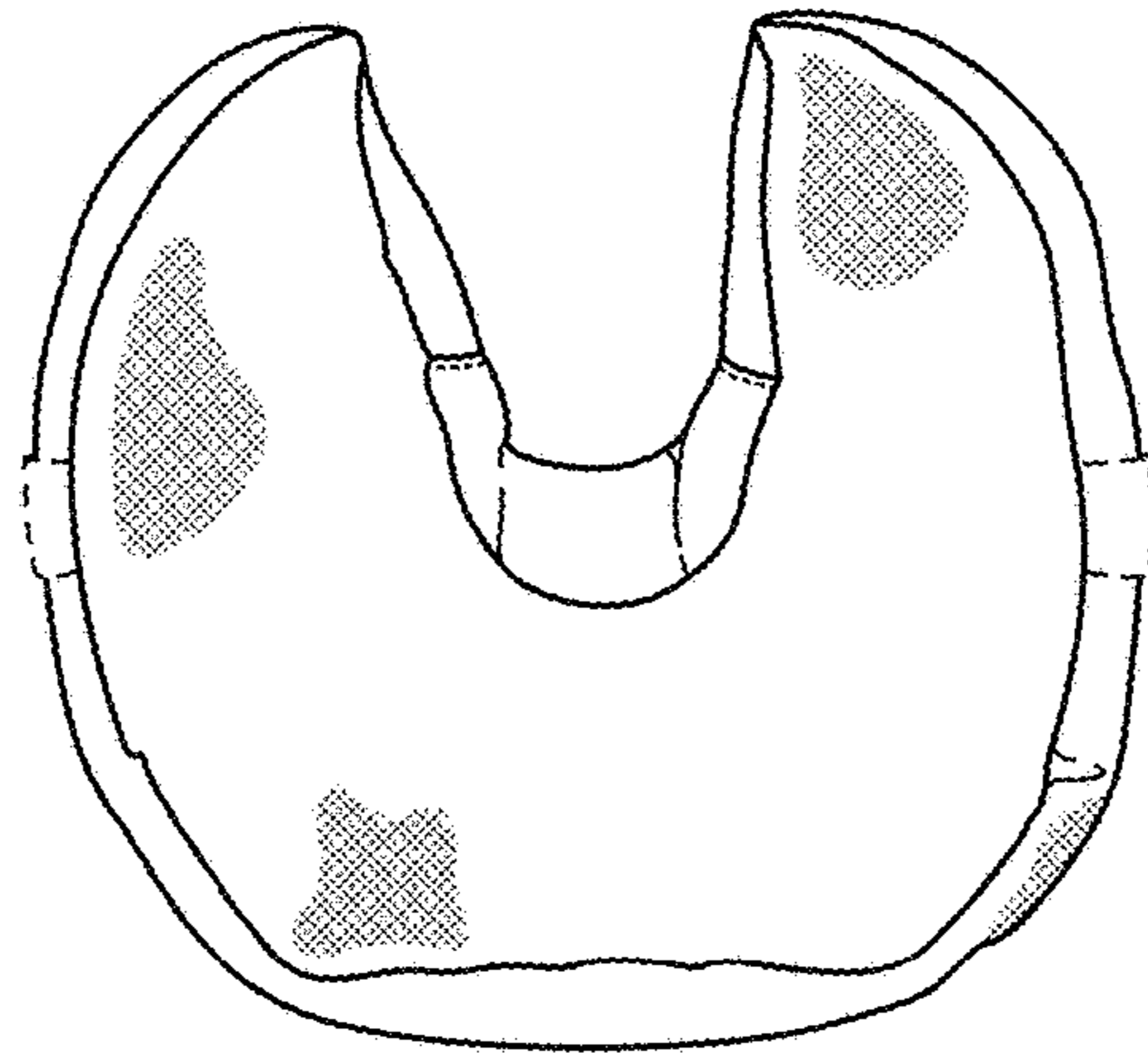

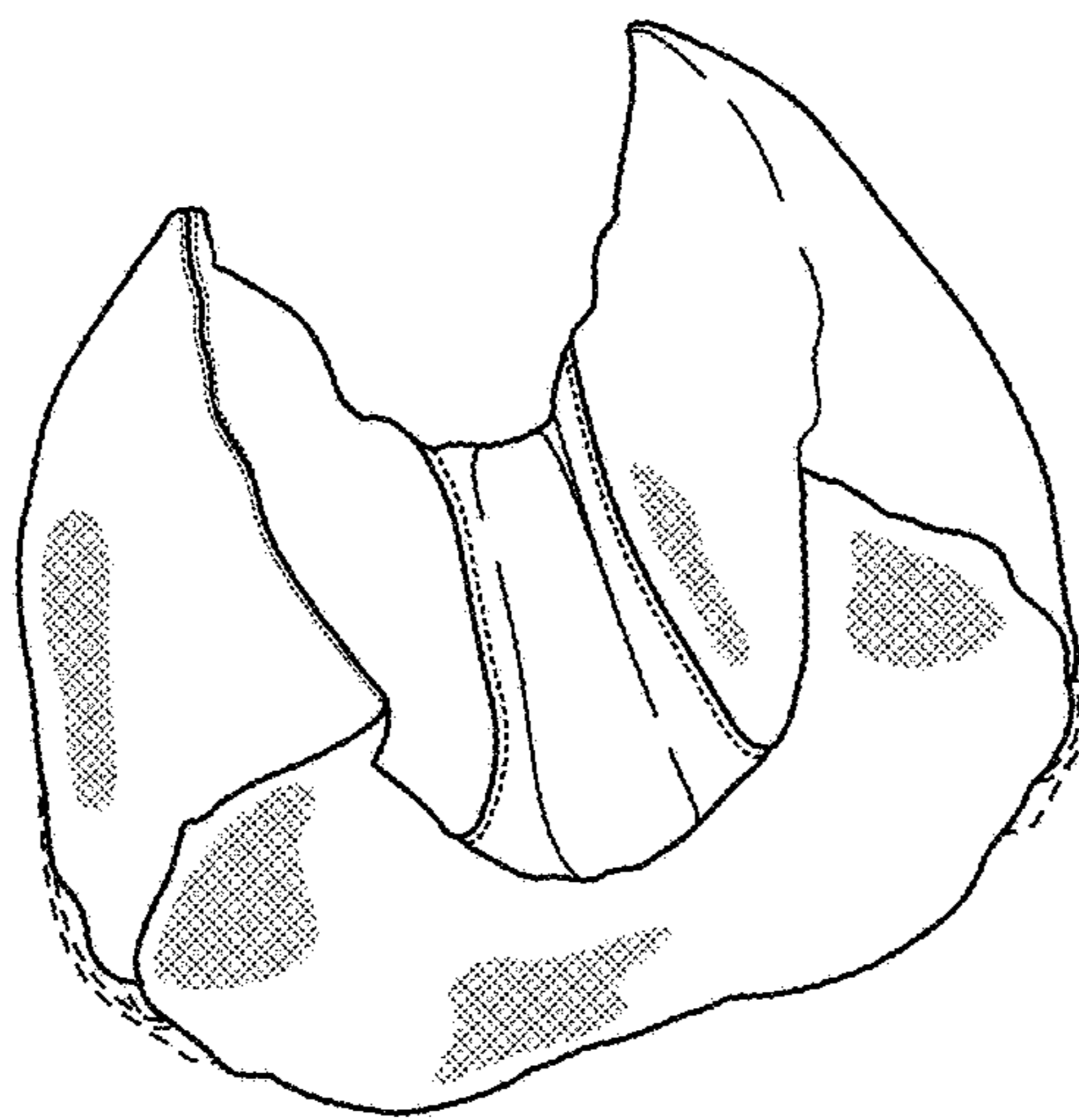
