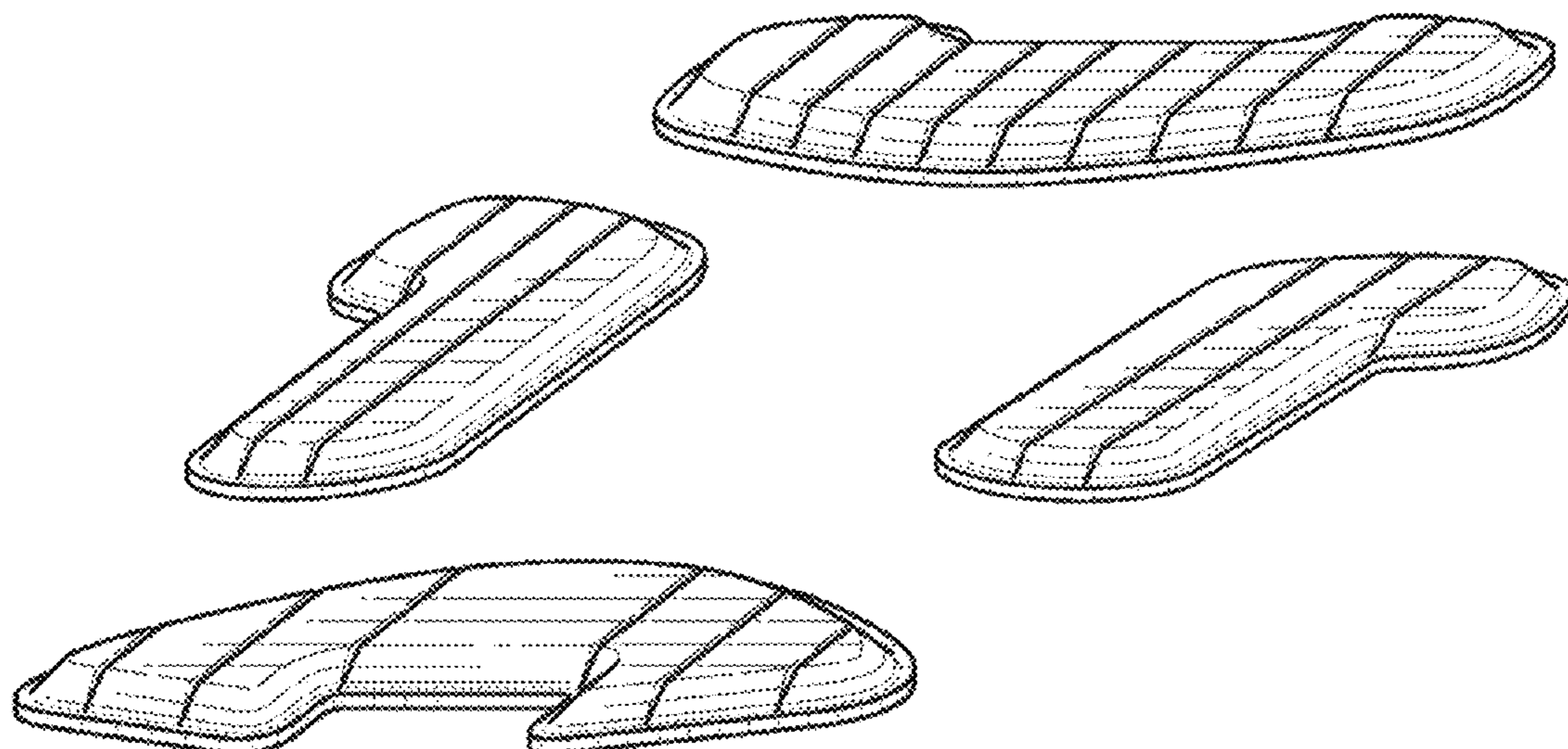
The ornamental design for a pad kit for a helmet, as shown and described.

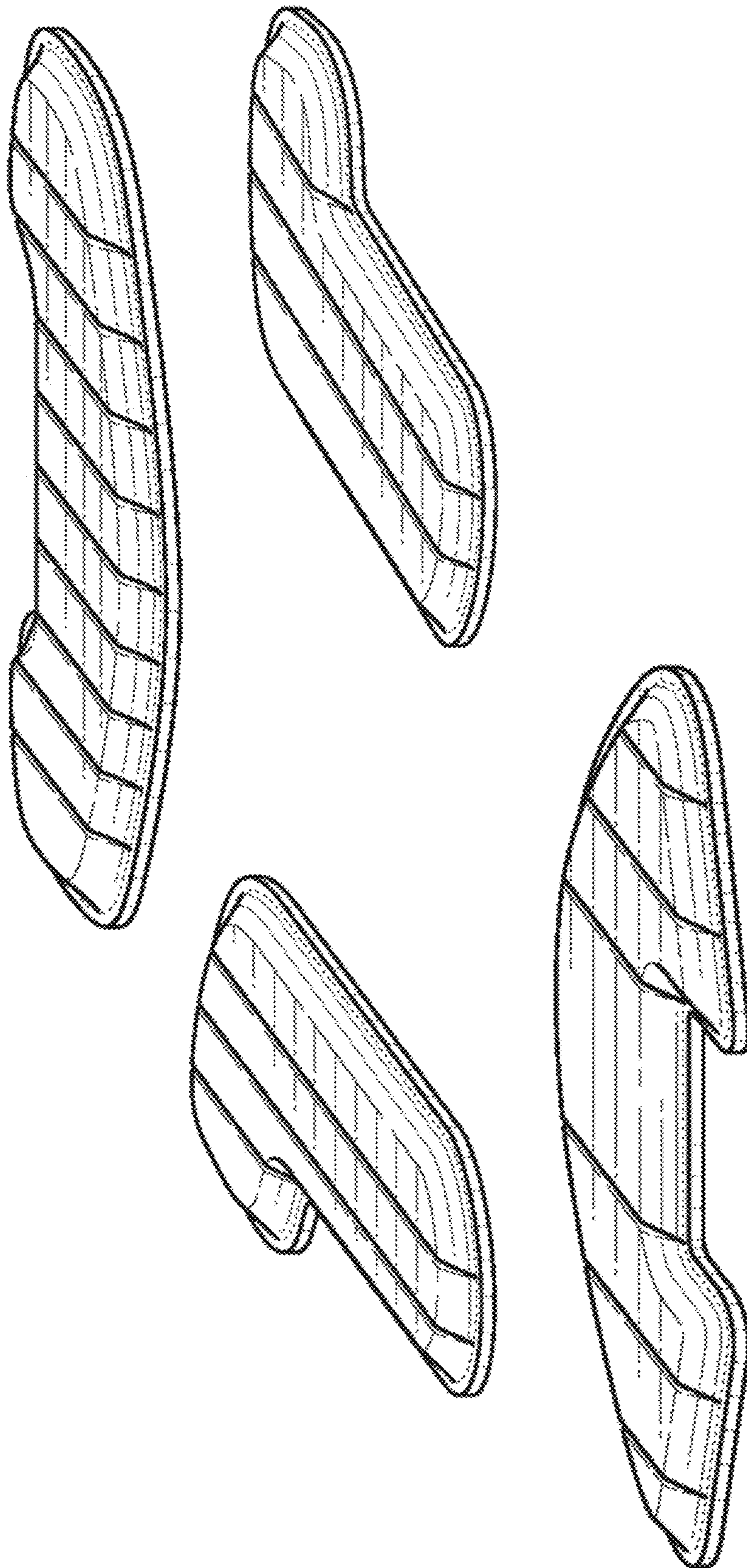

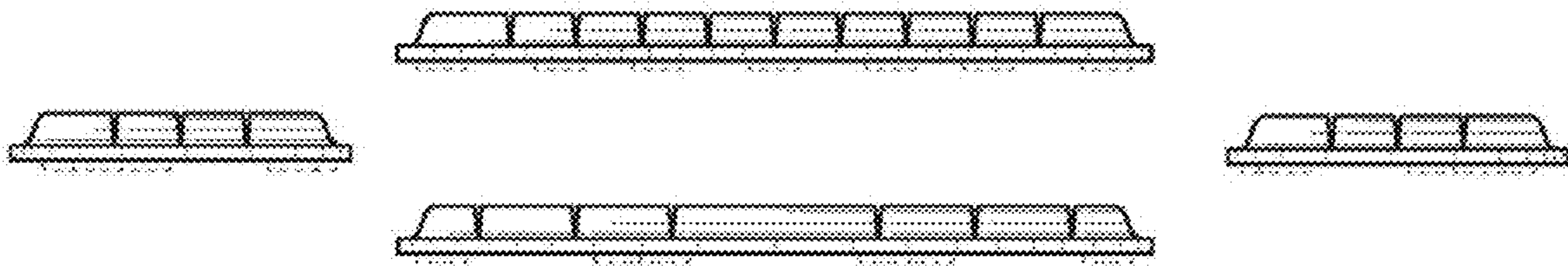

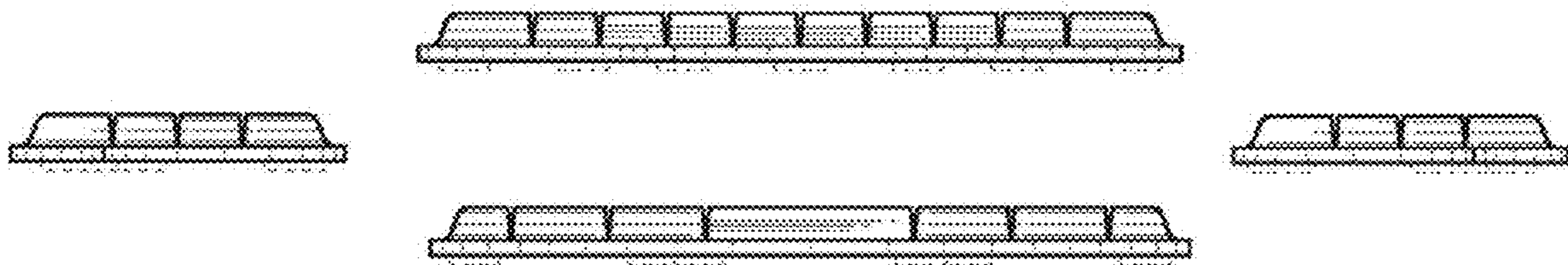

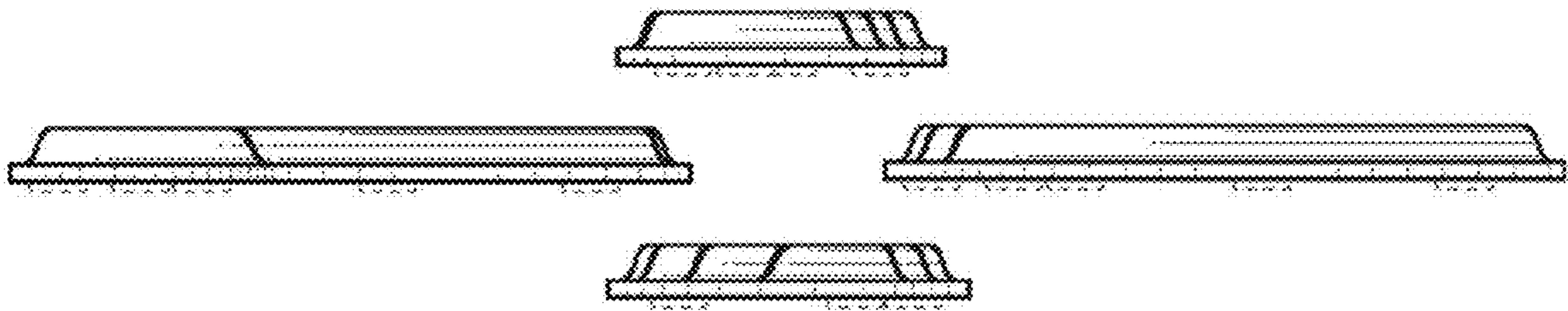

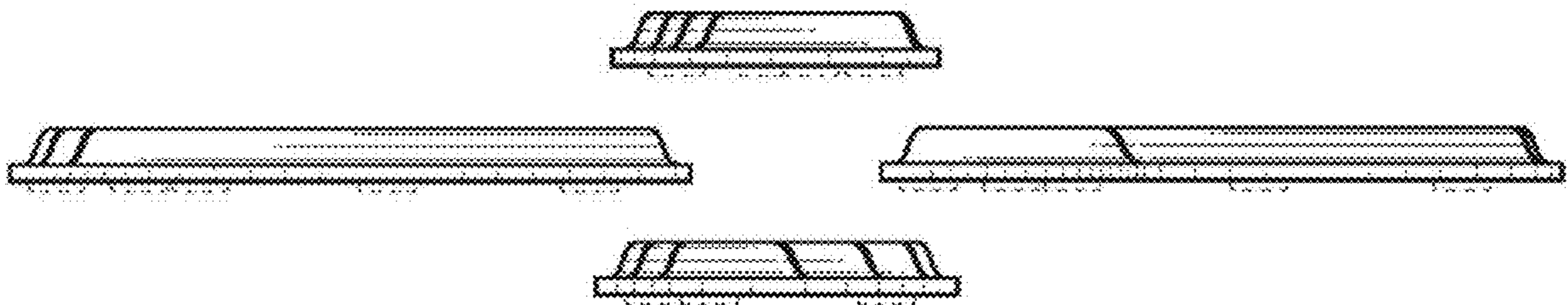

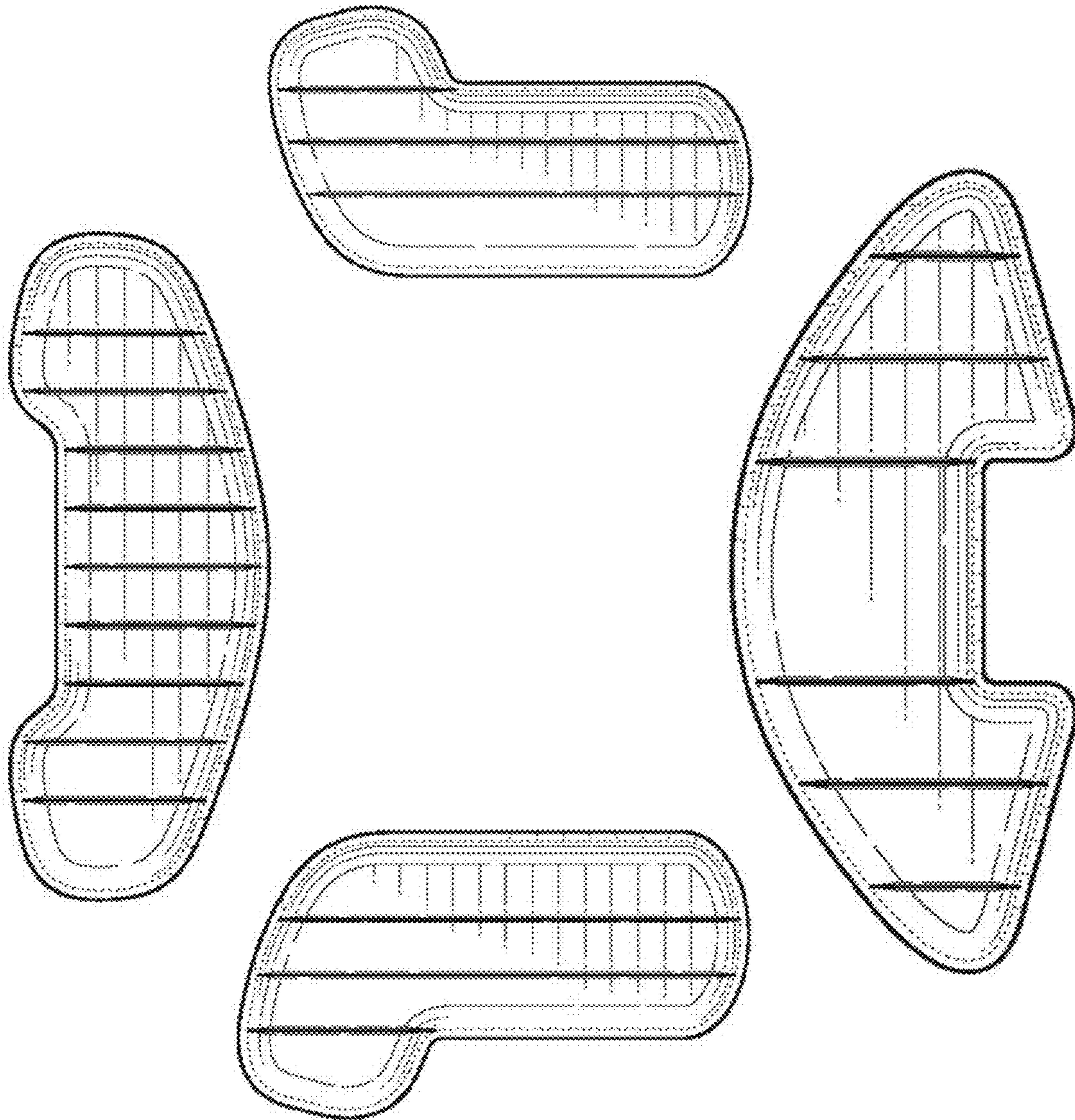

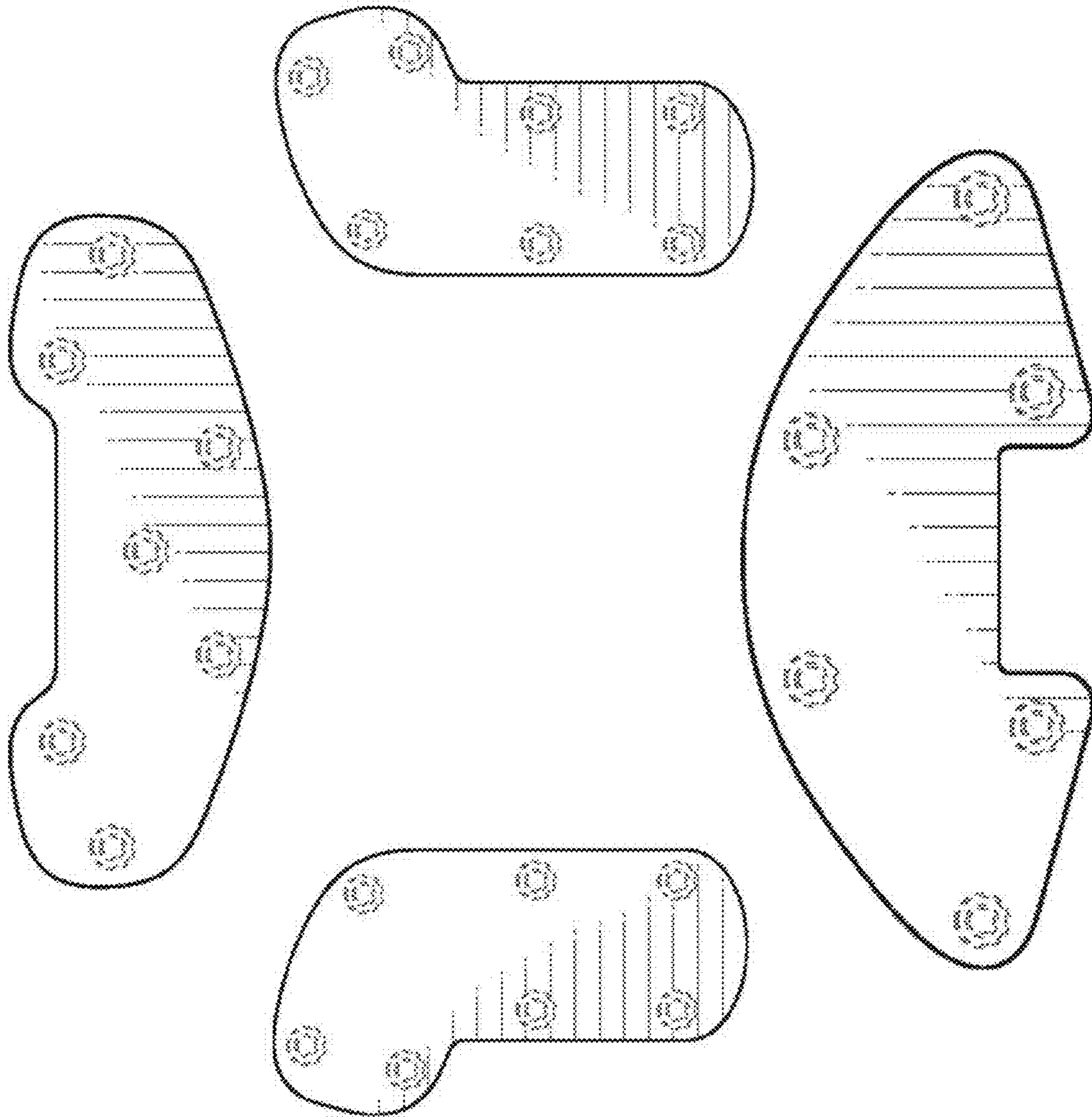

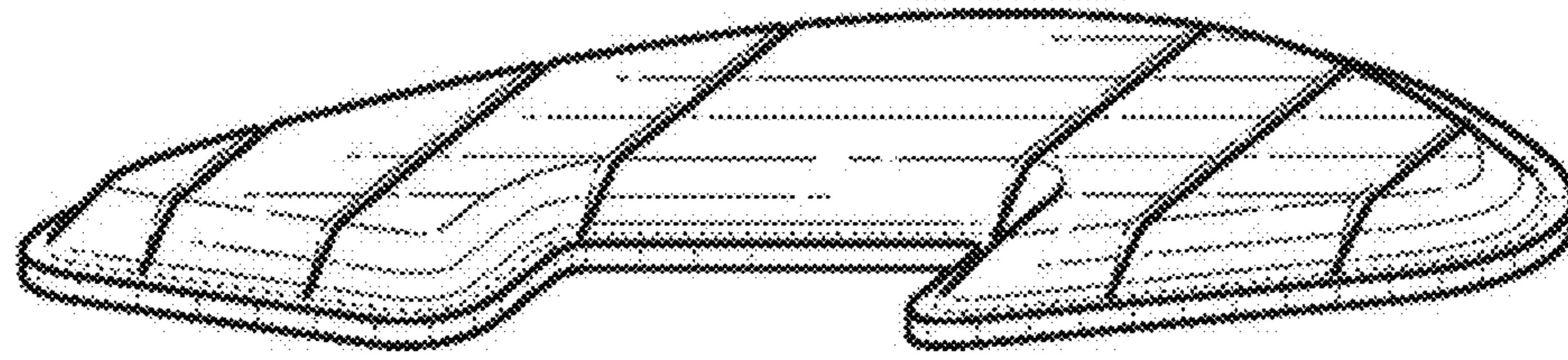

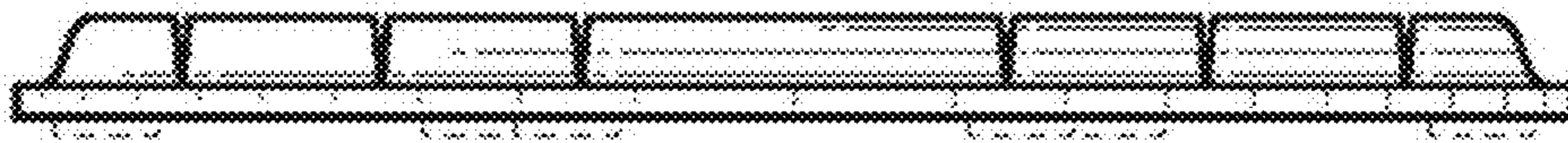

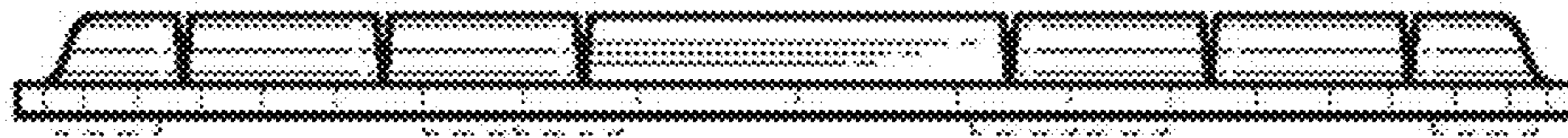

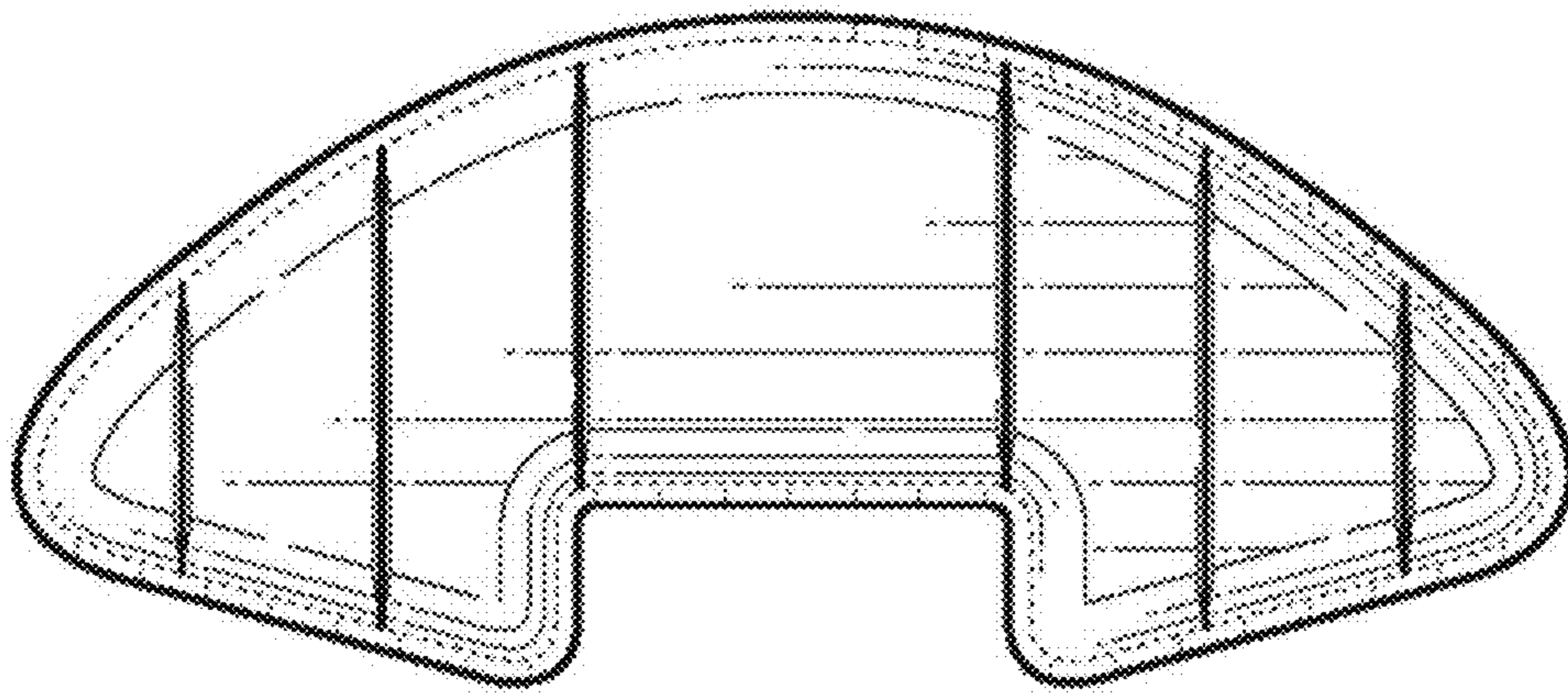

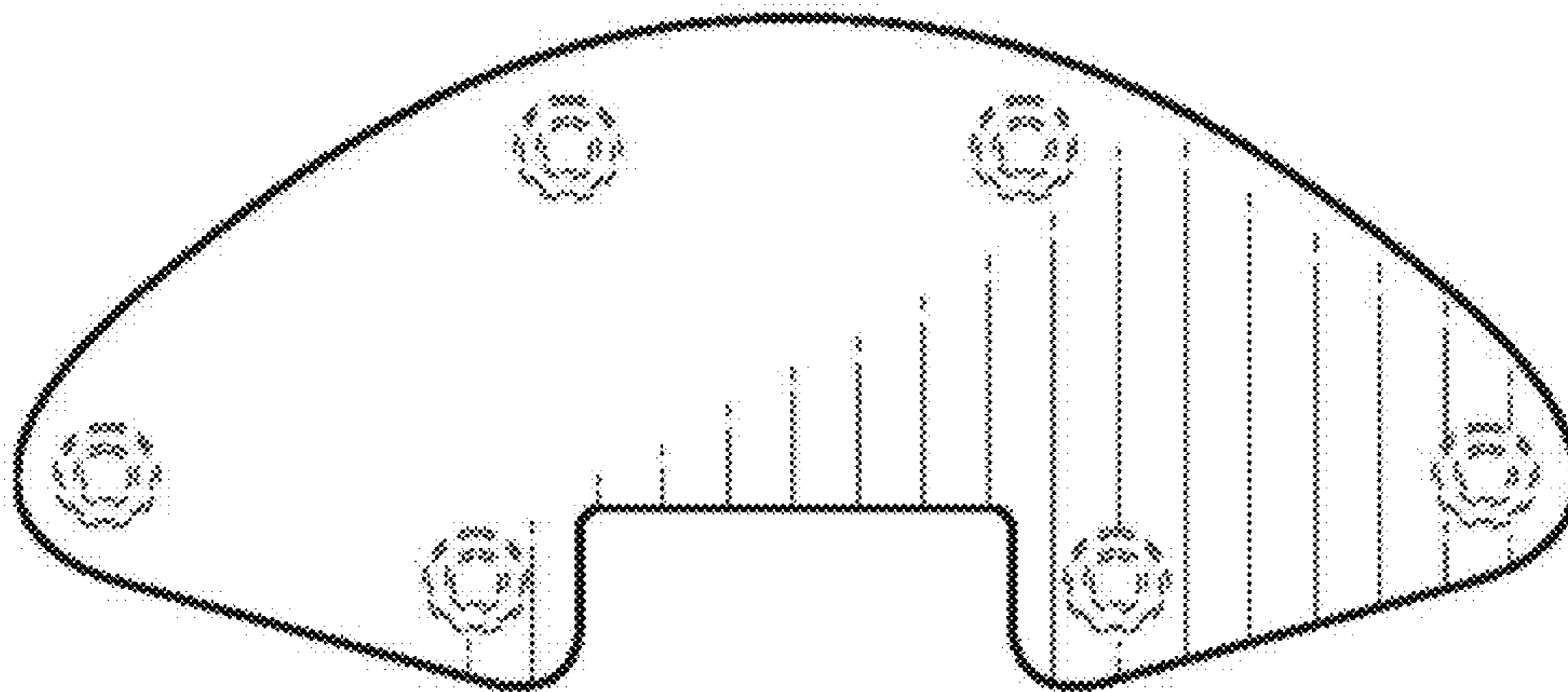

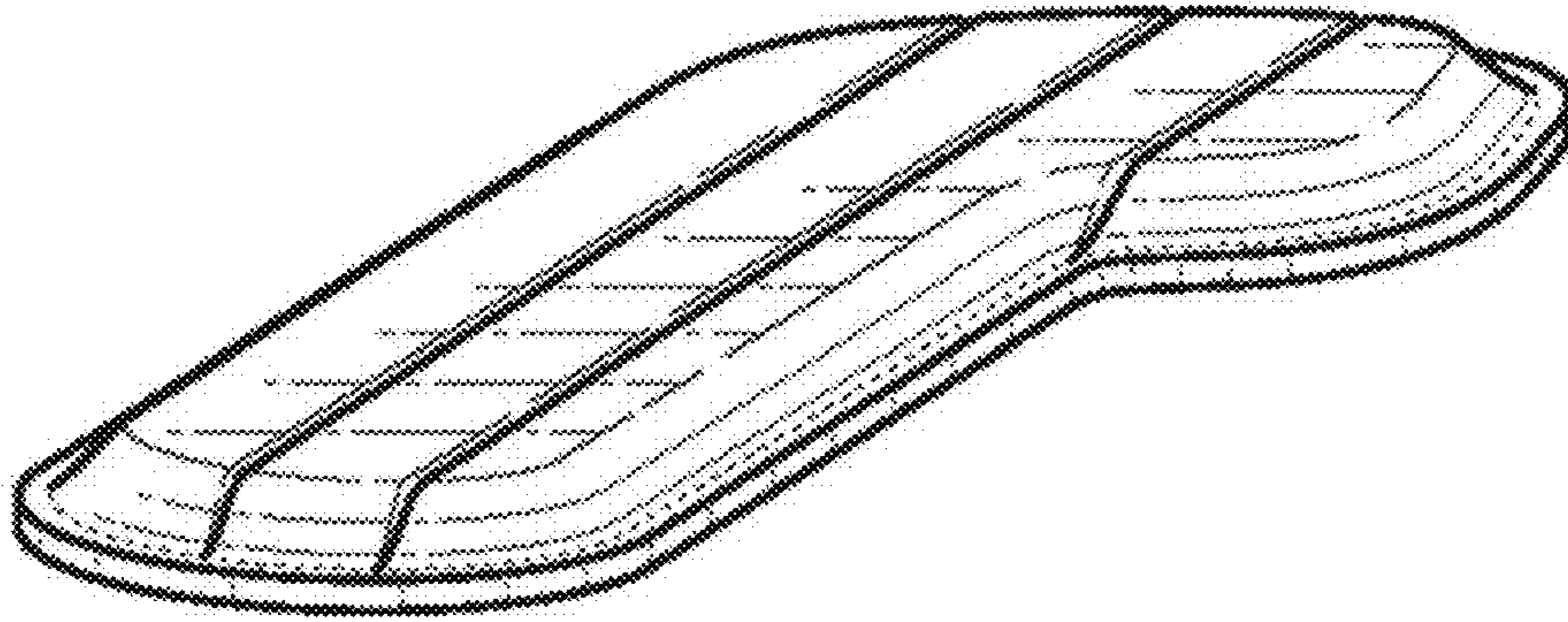

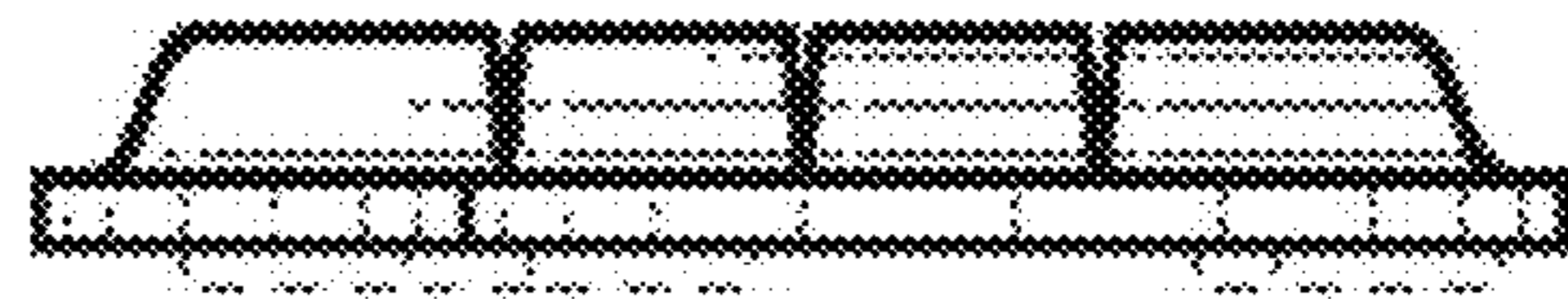

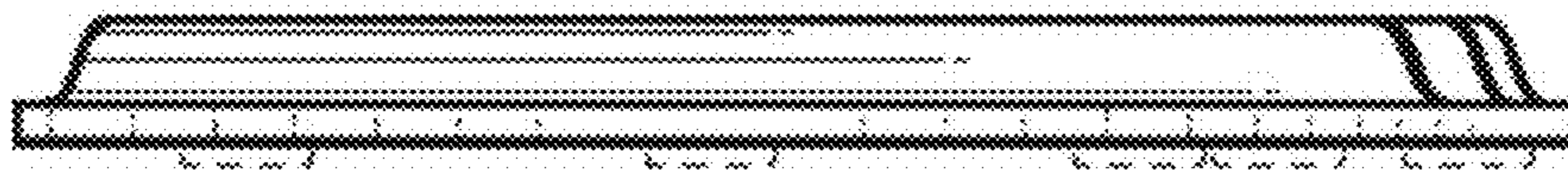

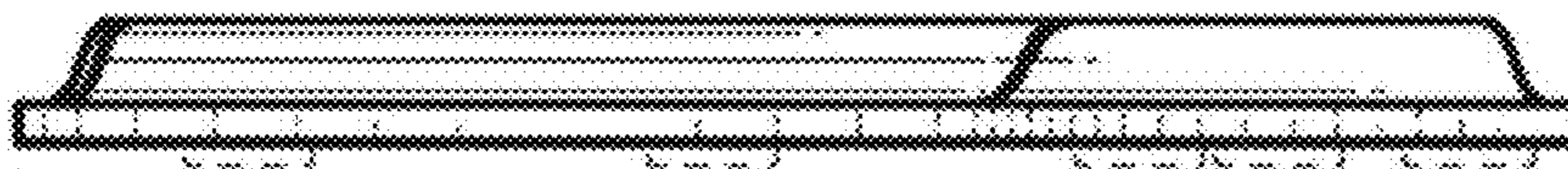

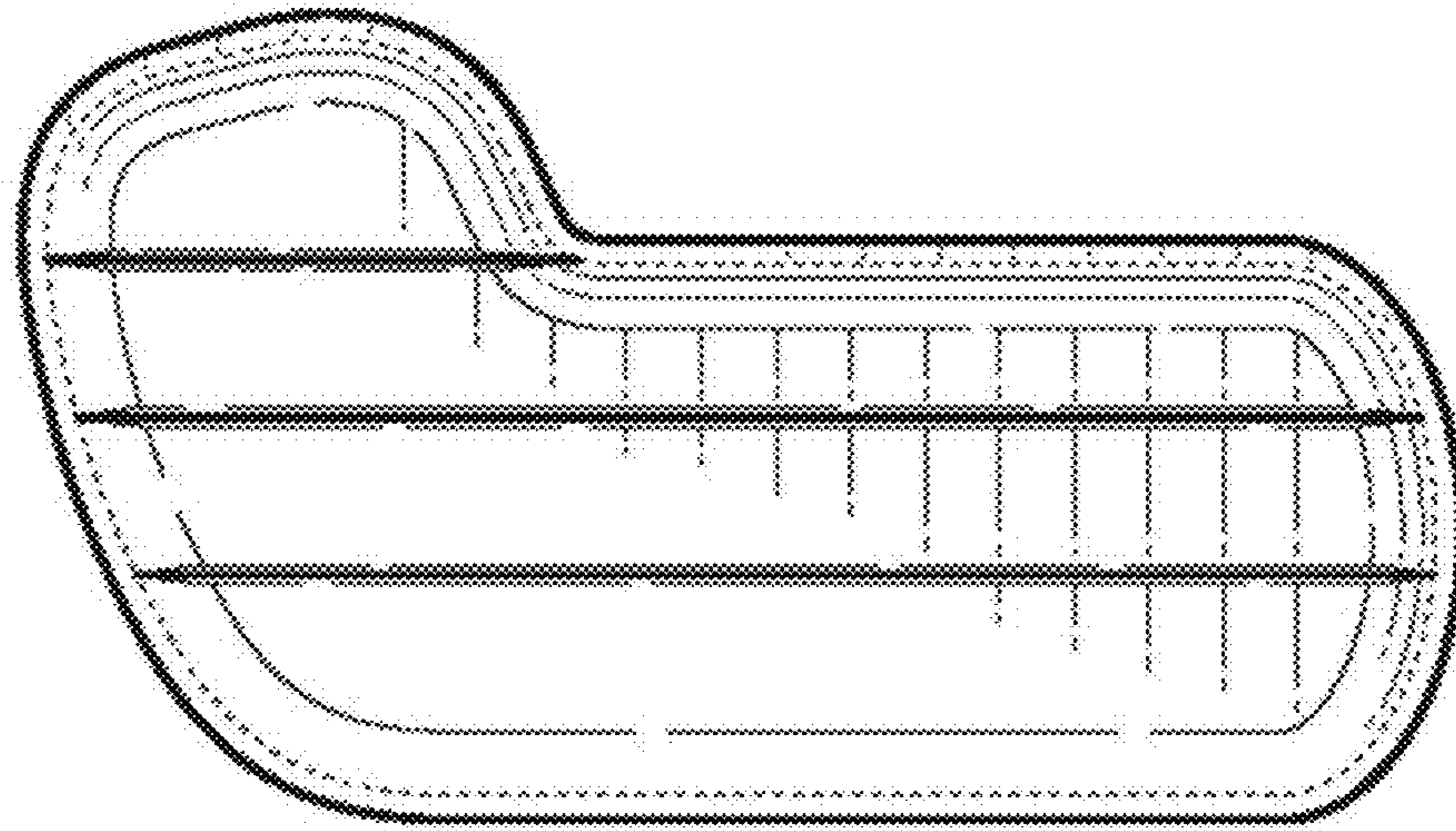

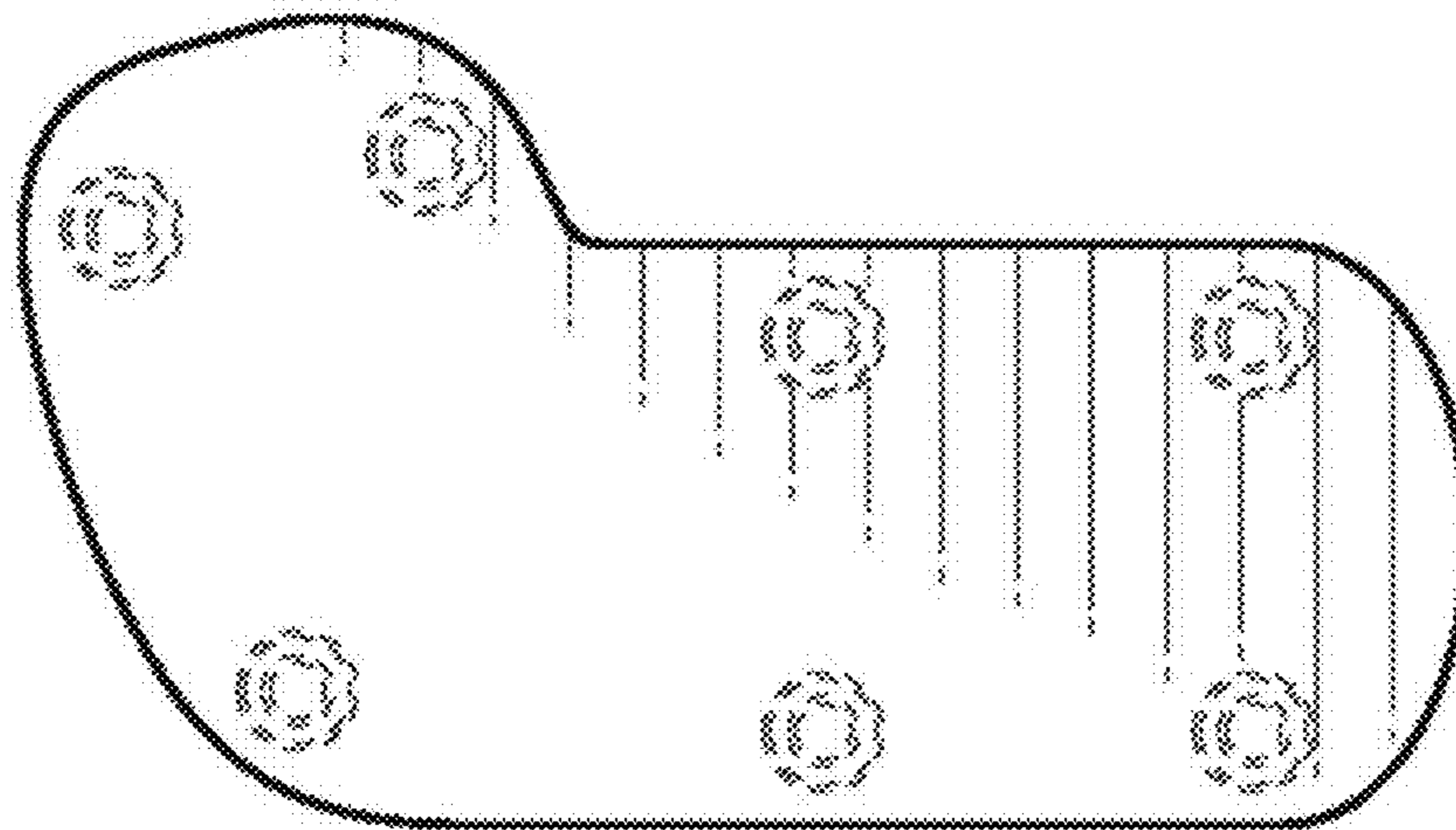

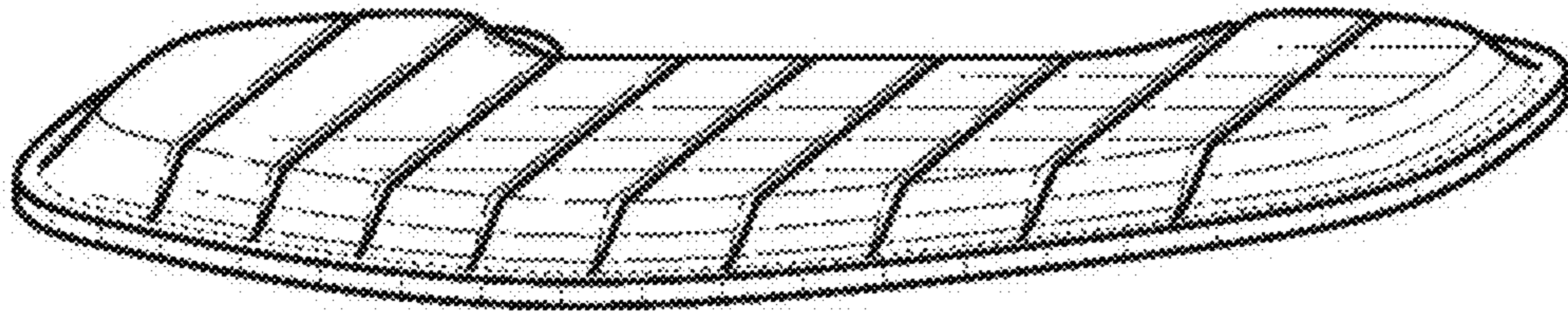

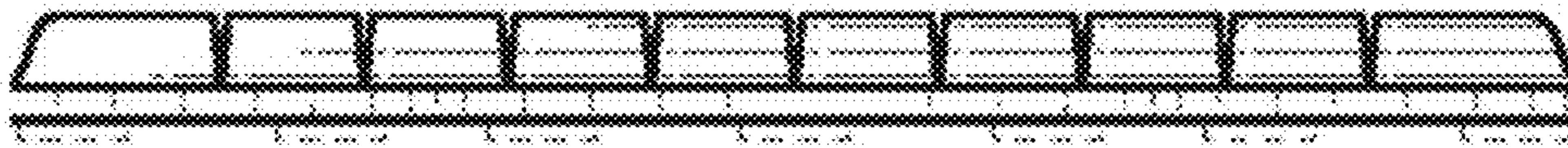

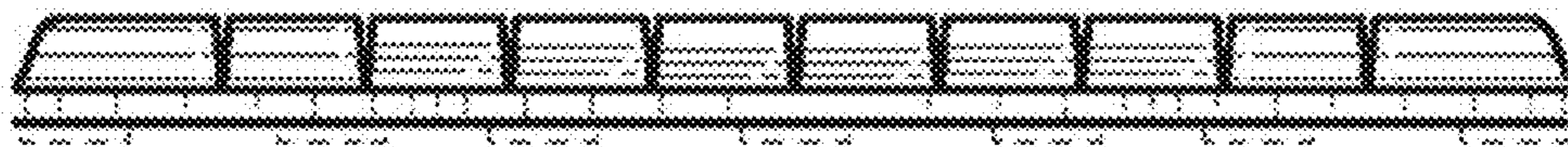

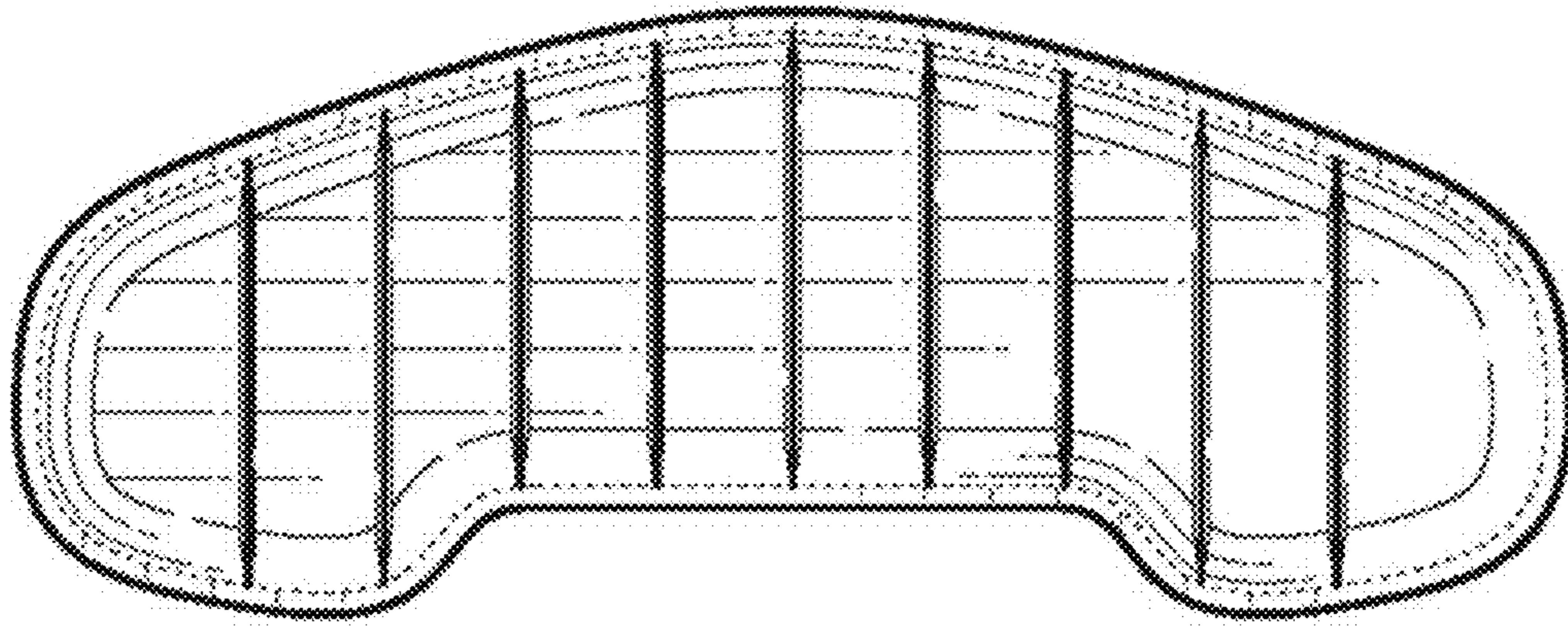

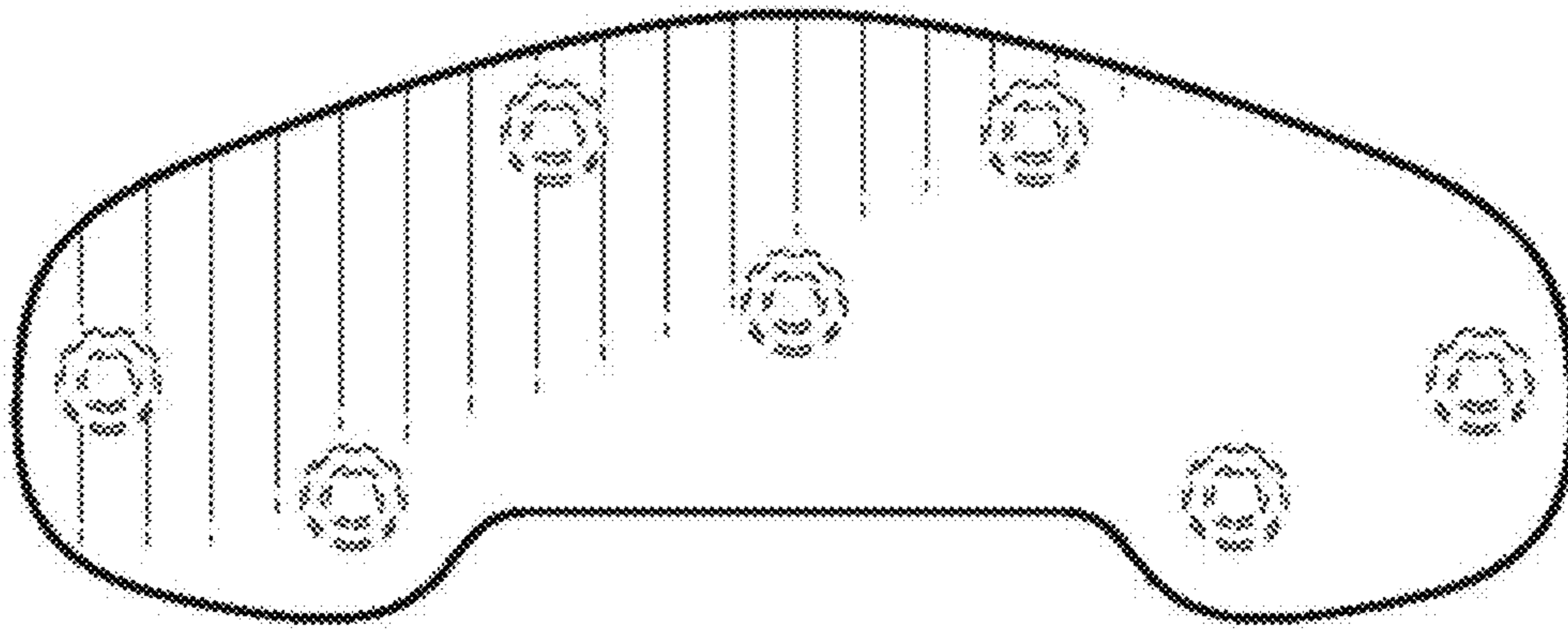
