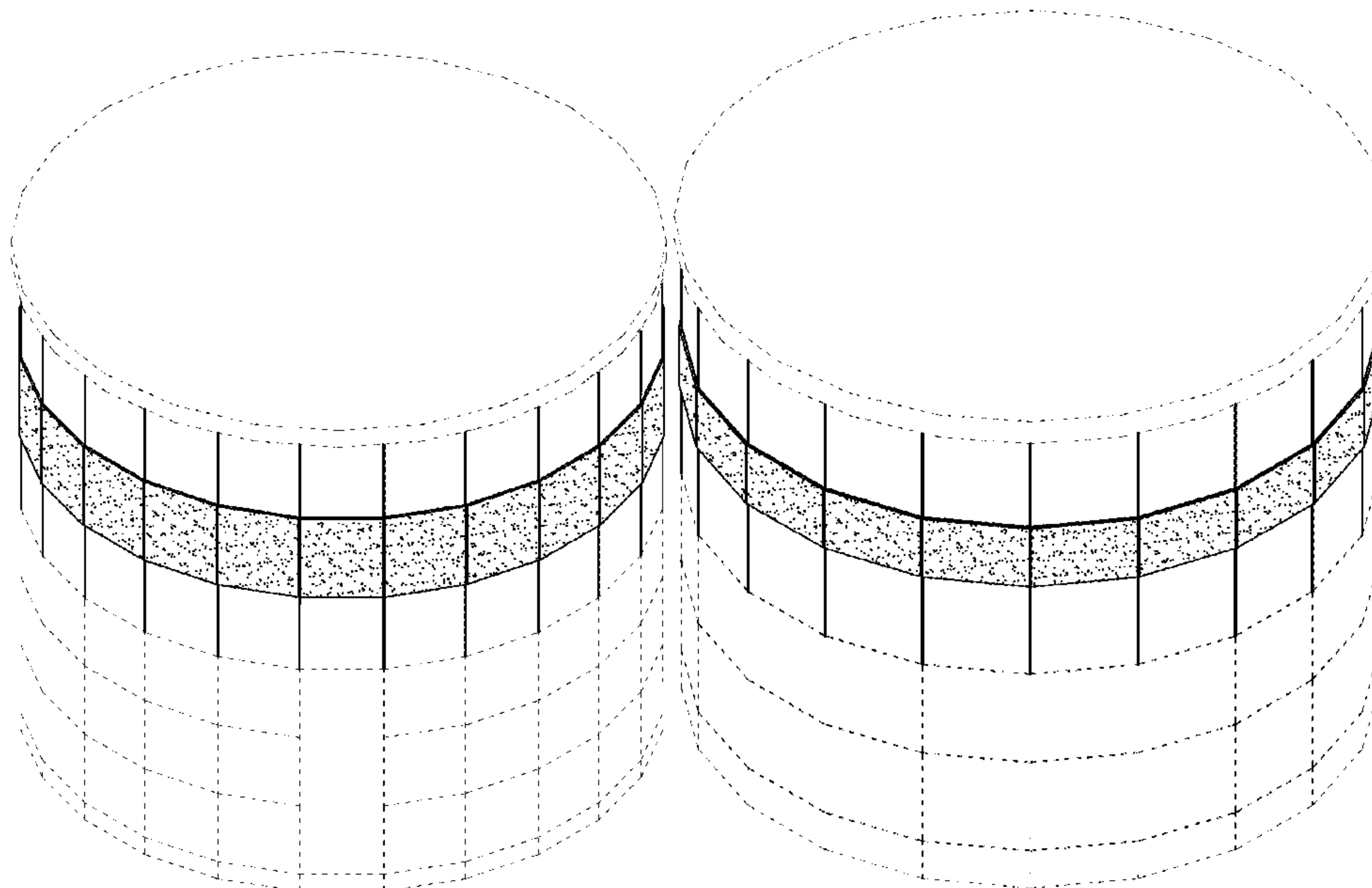
(57) **CLAIM**

The ornamental design for a columbarium with memorial band, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a columbarium with memorial band;
 FIG. 2 is a front elevational view thereof, a rear elevational view and side elevational views not being shown as they are mirror images of the front elevational view;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a perspective view of a second embodiment of a columbarium with memorial band;
 FIG. 6 is a front elevational view thereof, a rear elevational view and side elevational views not being shown as they are mirror images of the front elevational view;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a bottom plan view thereof;
 FIG. 9 is a perspective view of a third embodiment of a columbarium with memorial band;
 FIG. 10 is a front elevational view thereof, a rear elevational view and side elevational views not being shown as they are mirror images of the front elevational view;
 FIG. 11 is a top plan view thereof; and,
 FIG. 12 is a bottom plan view thereof.

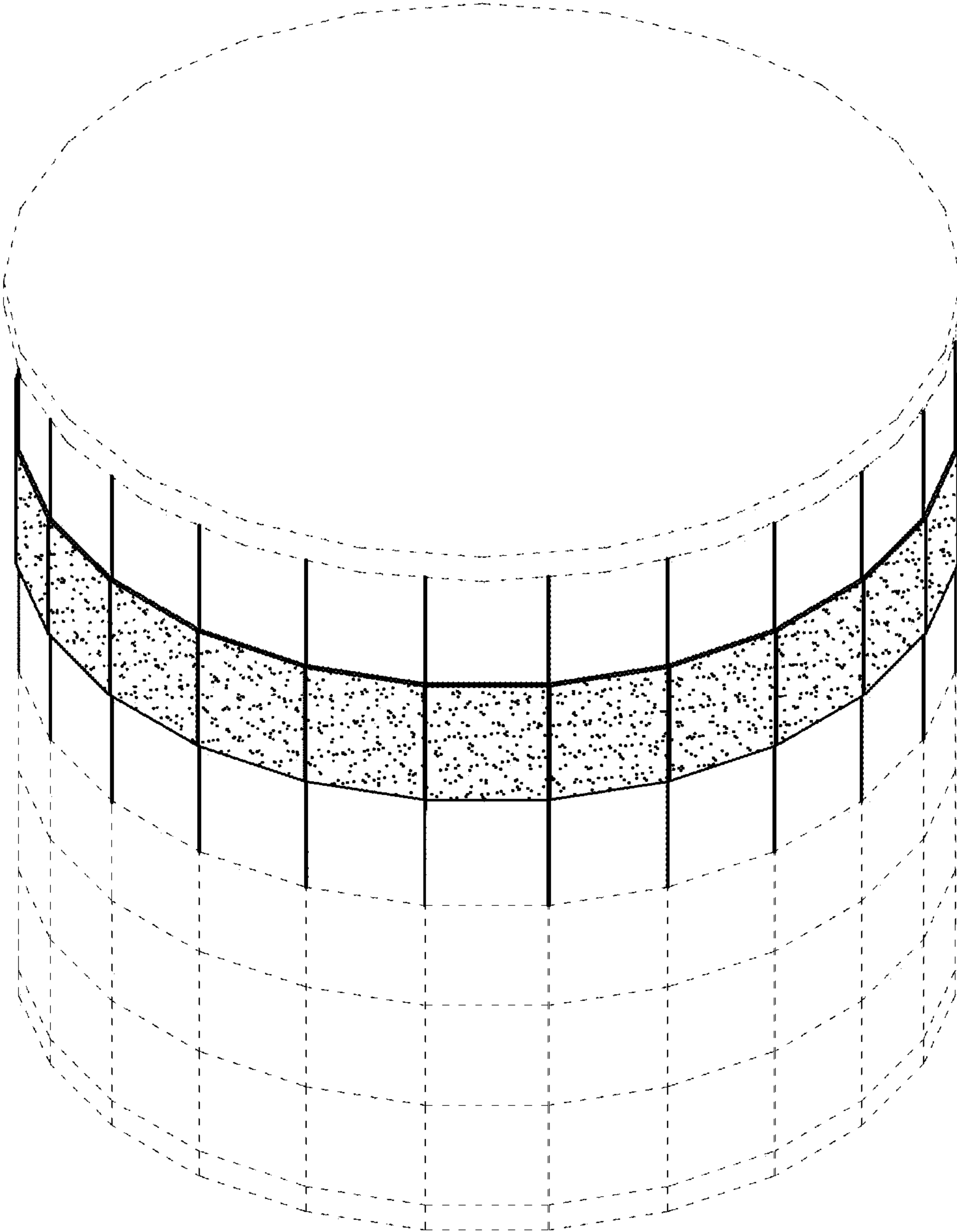

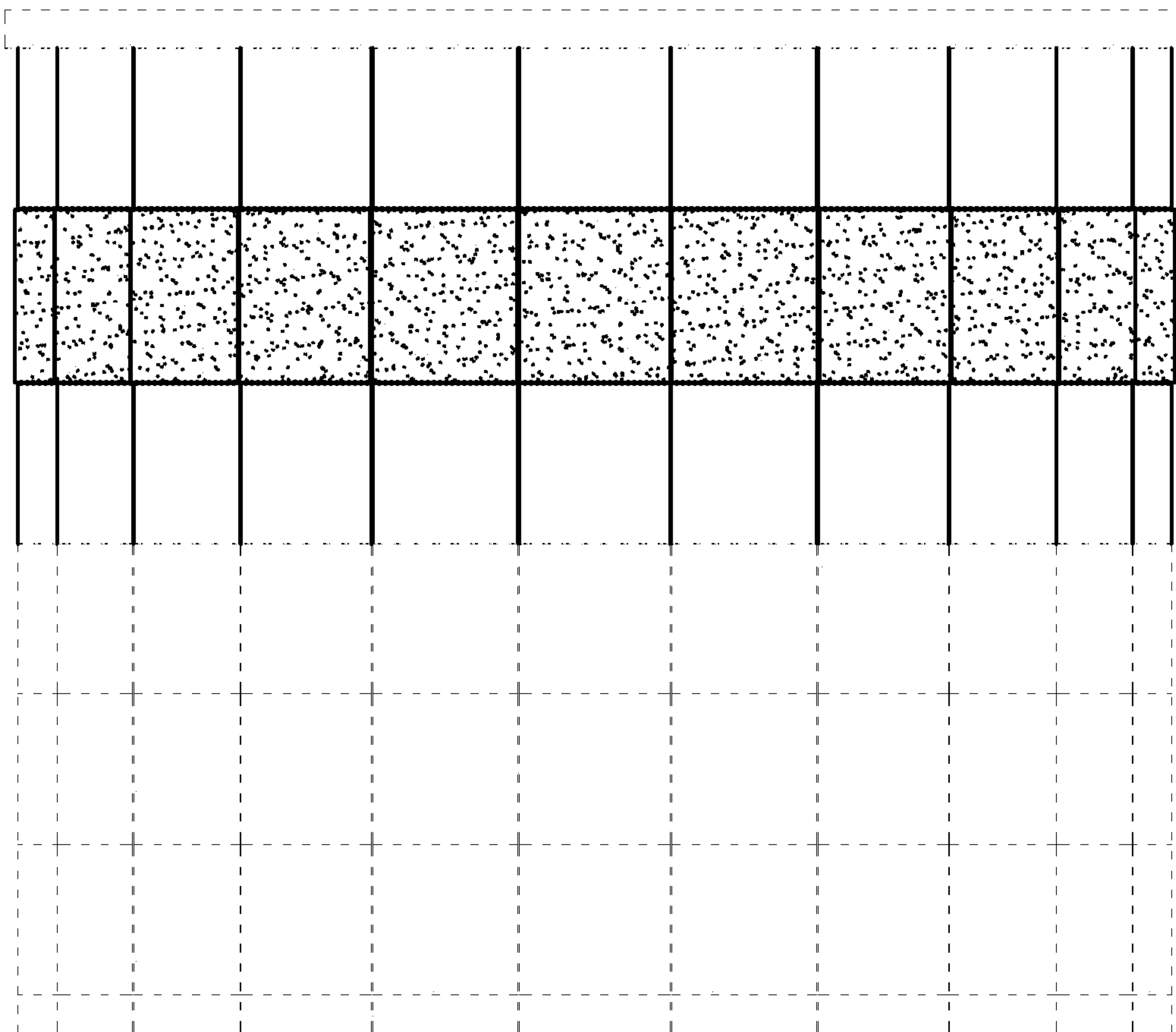

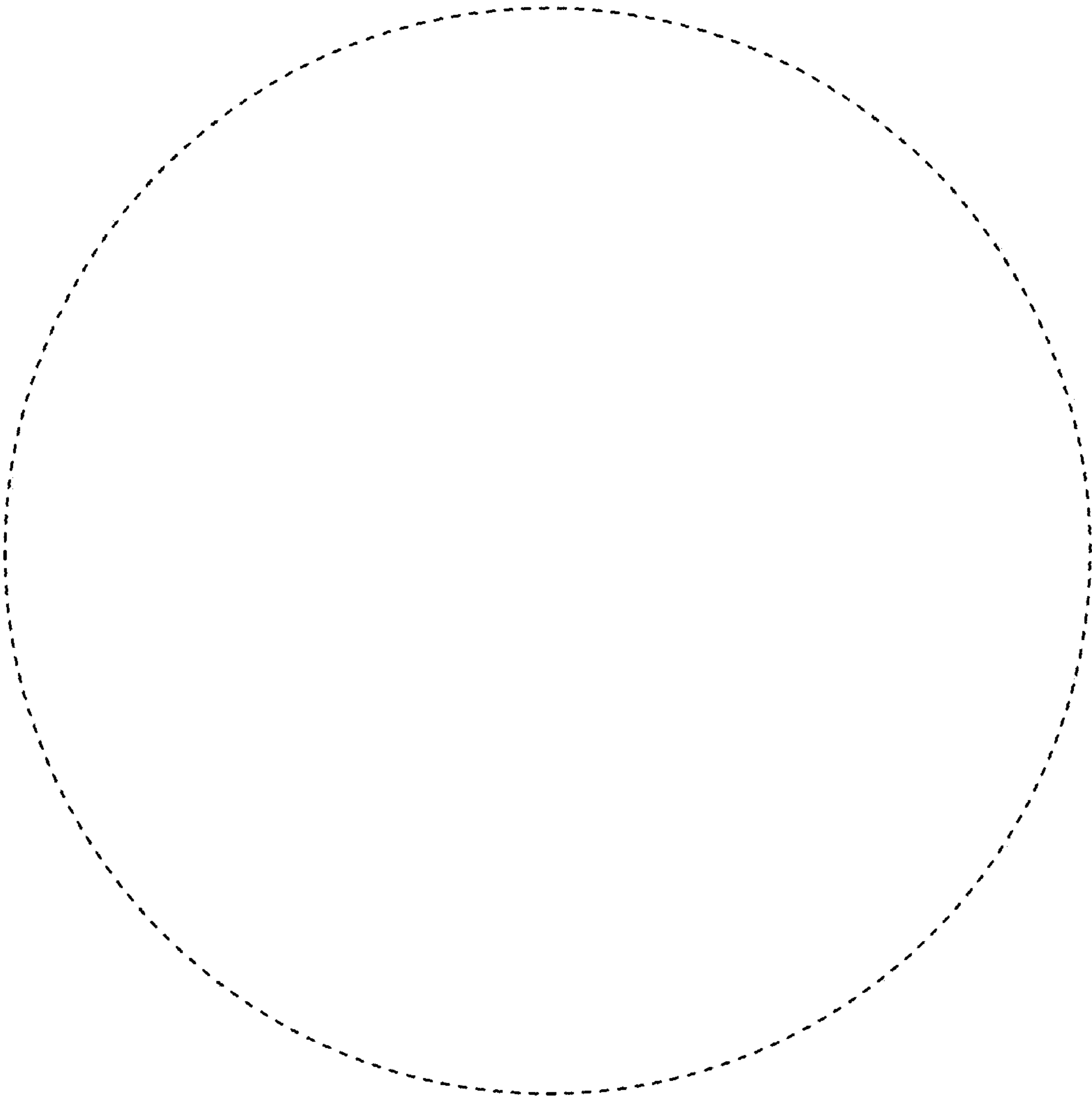

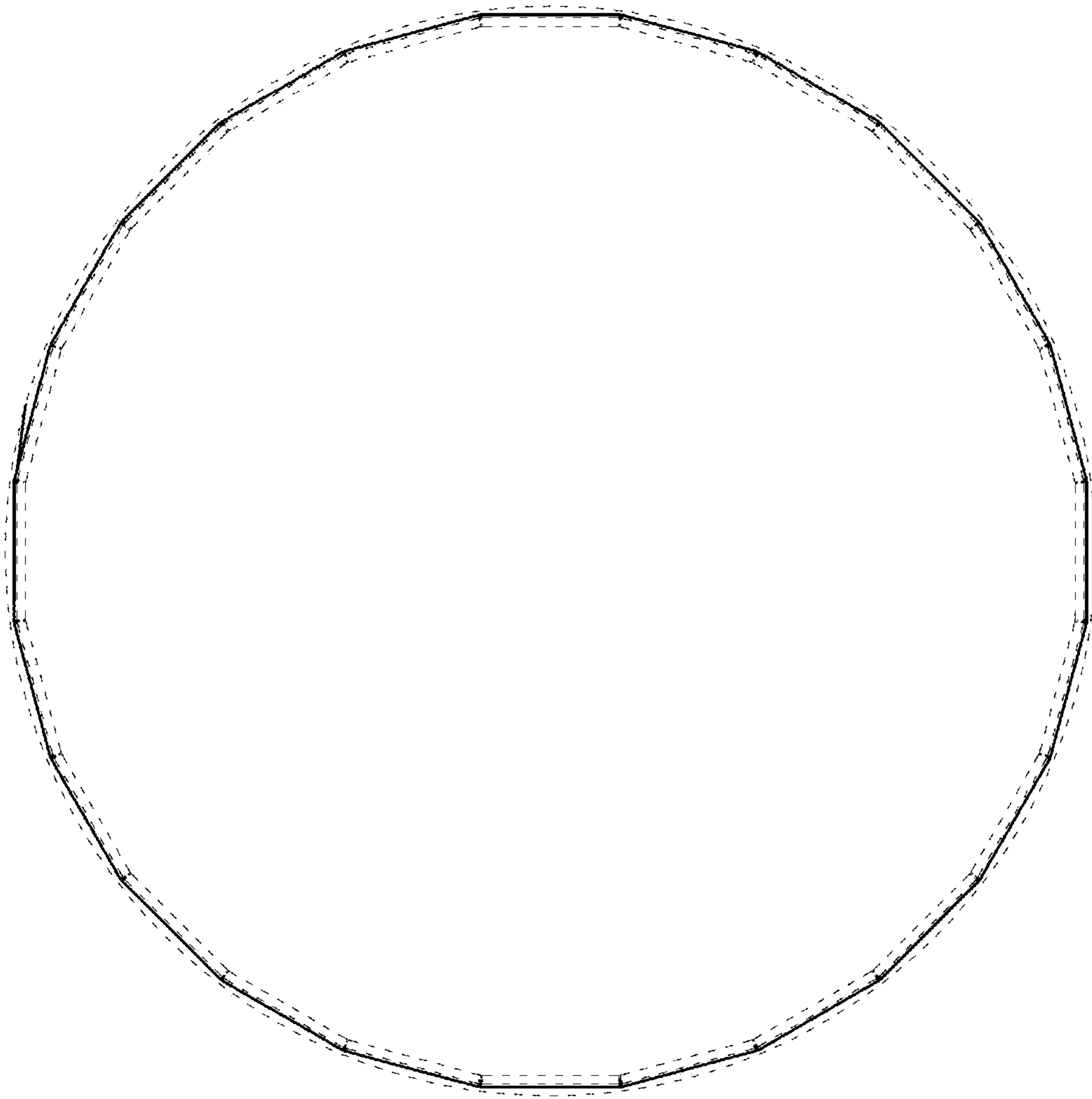

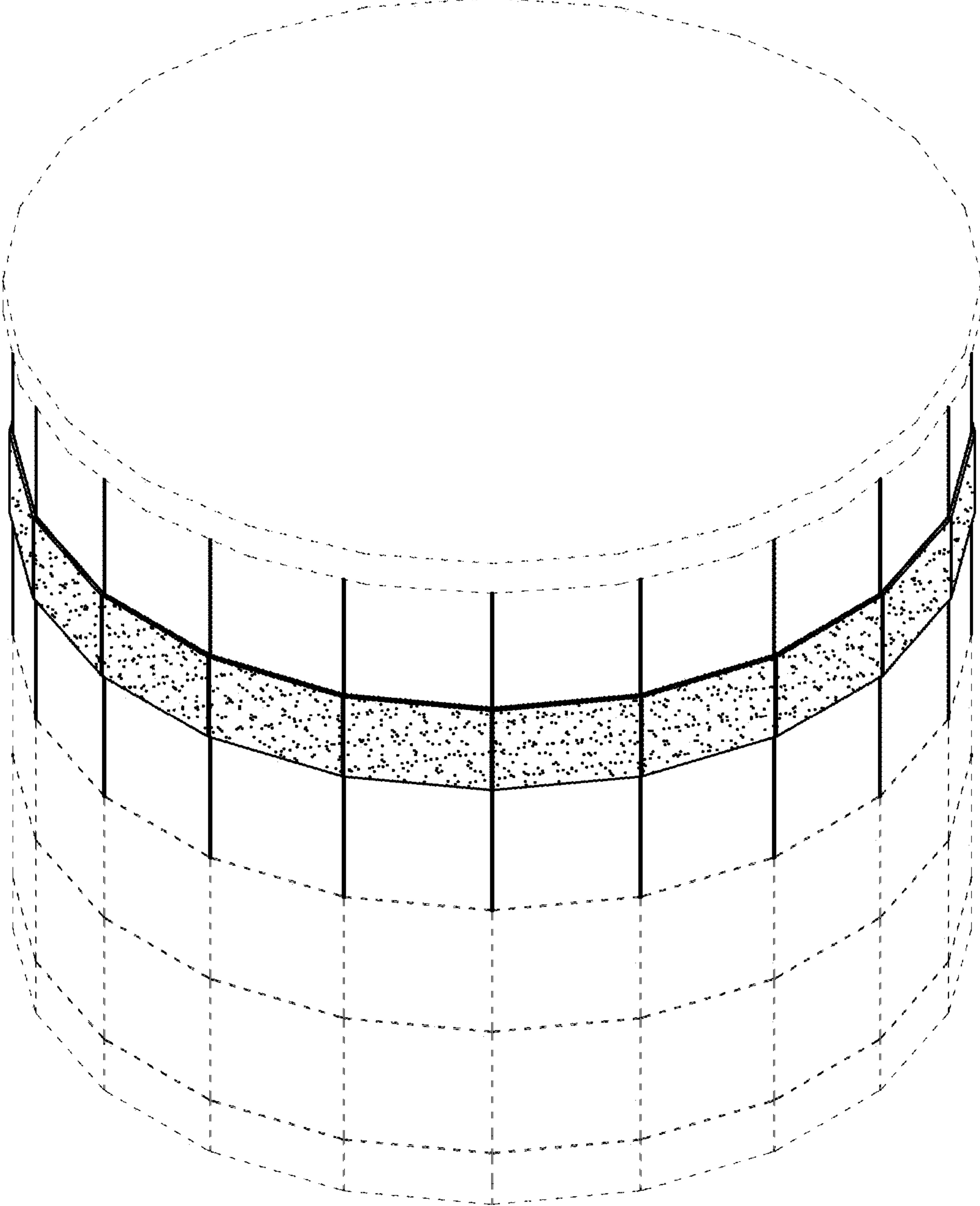

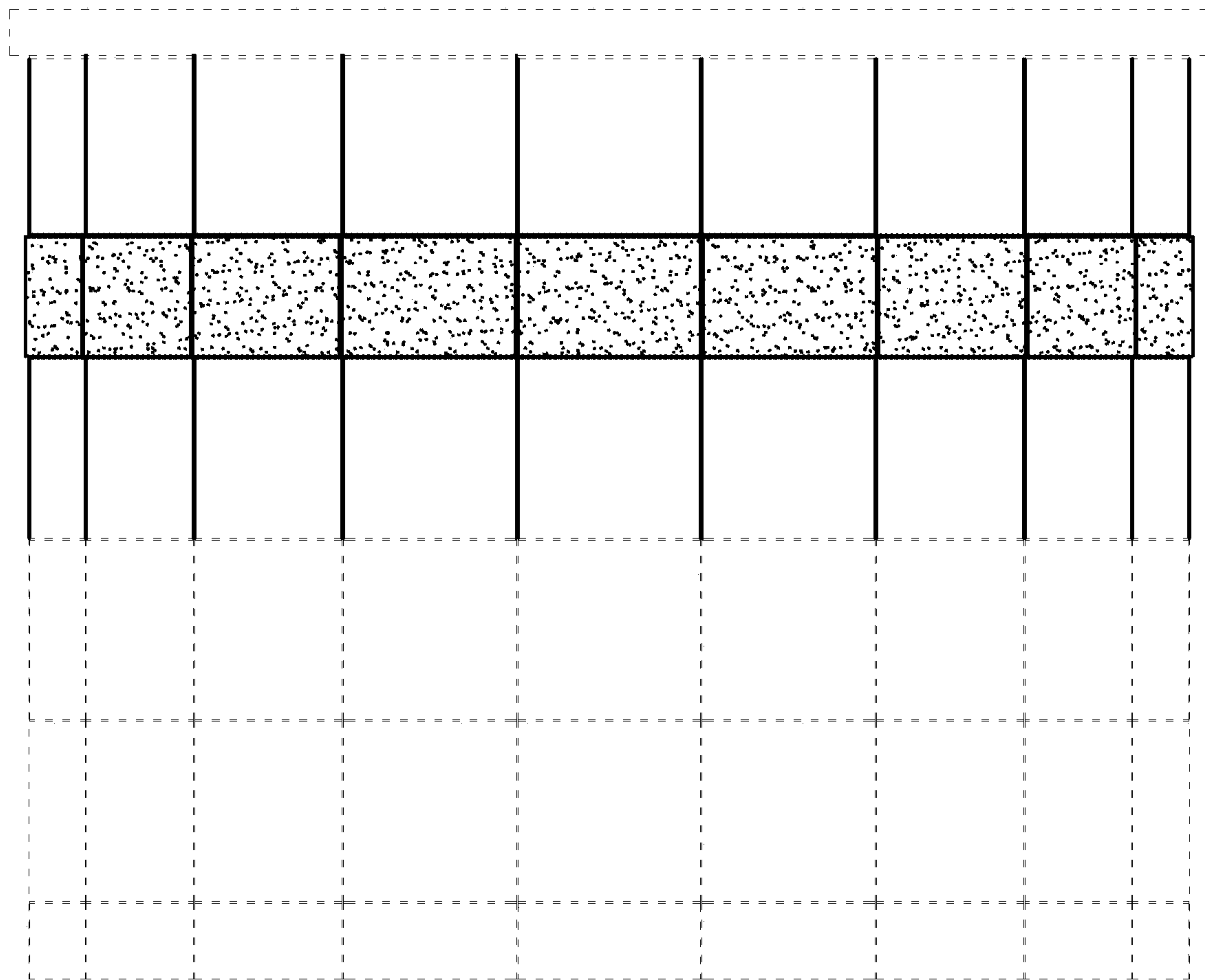

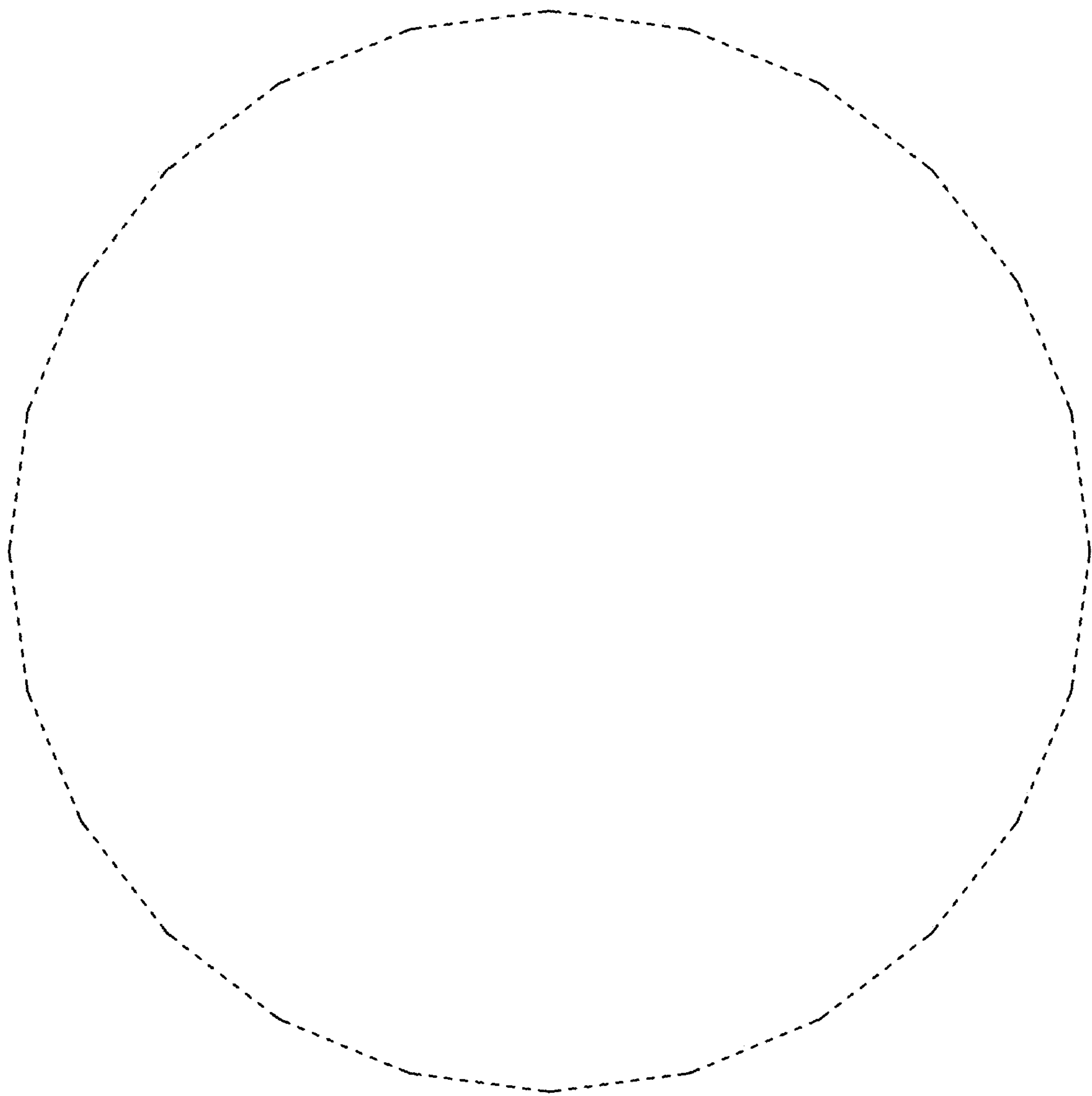

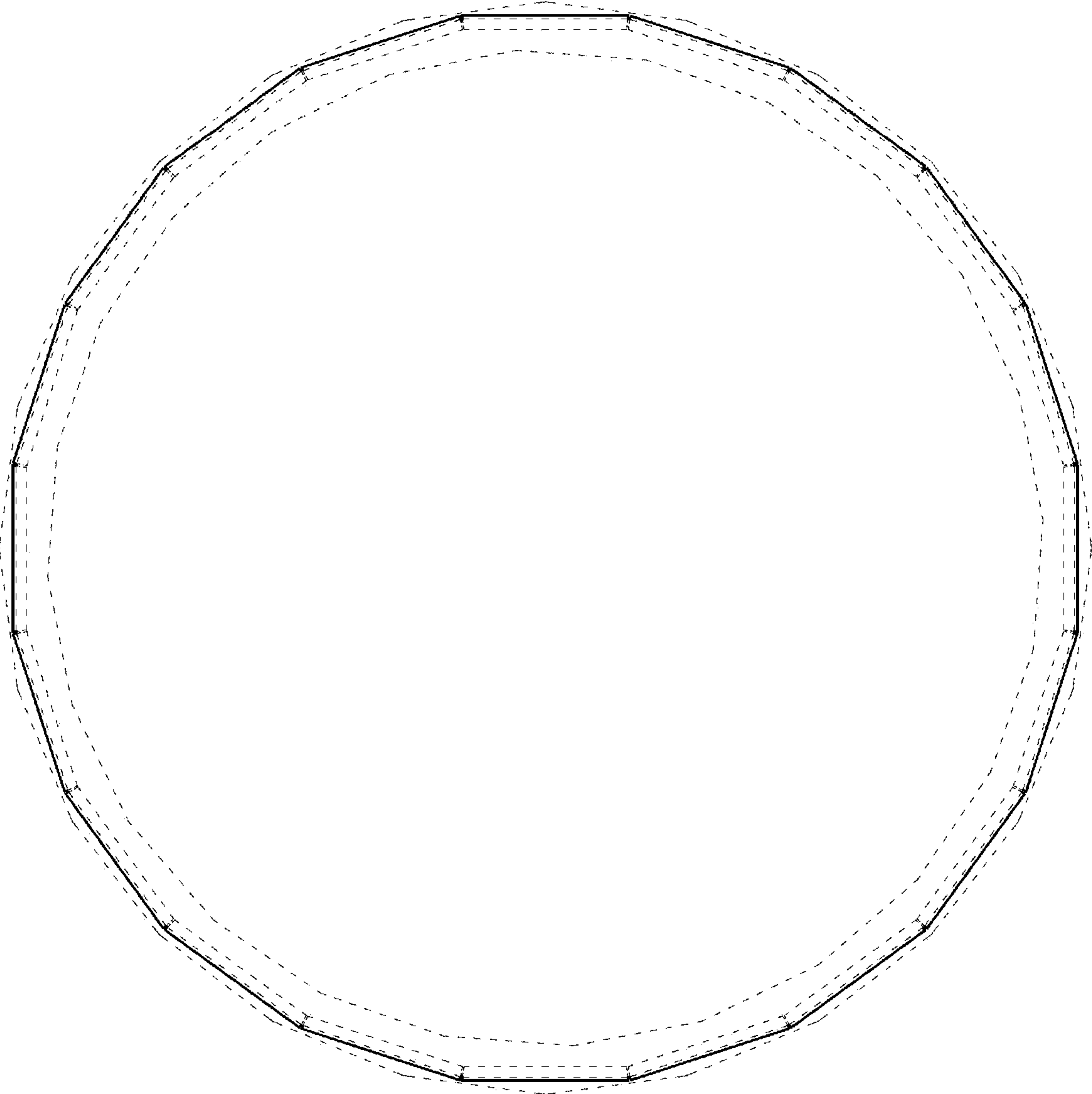

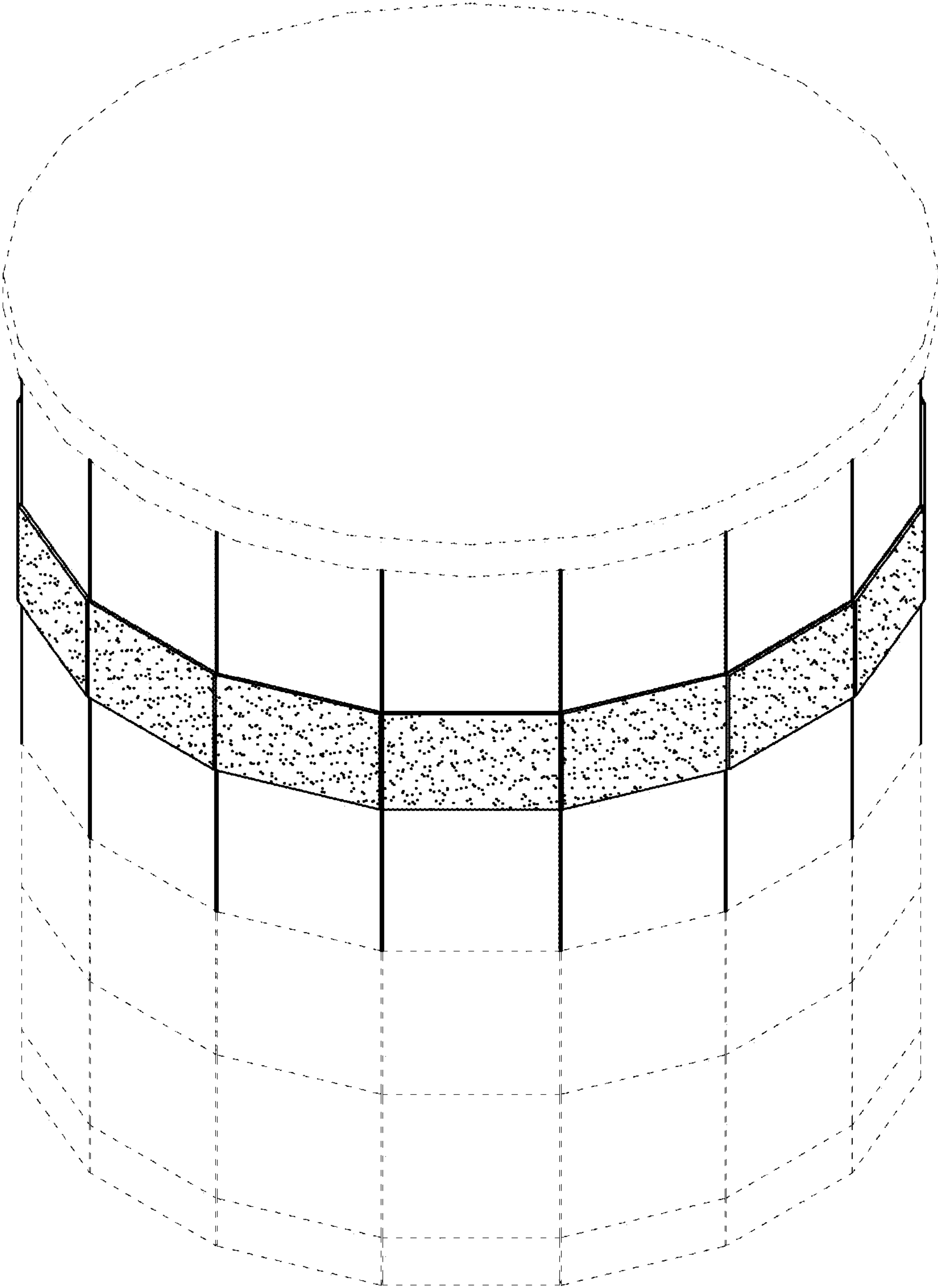

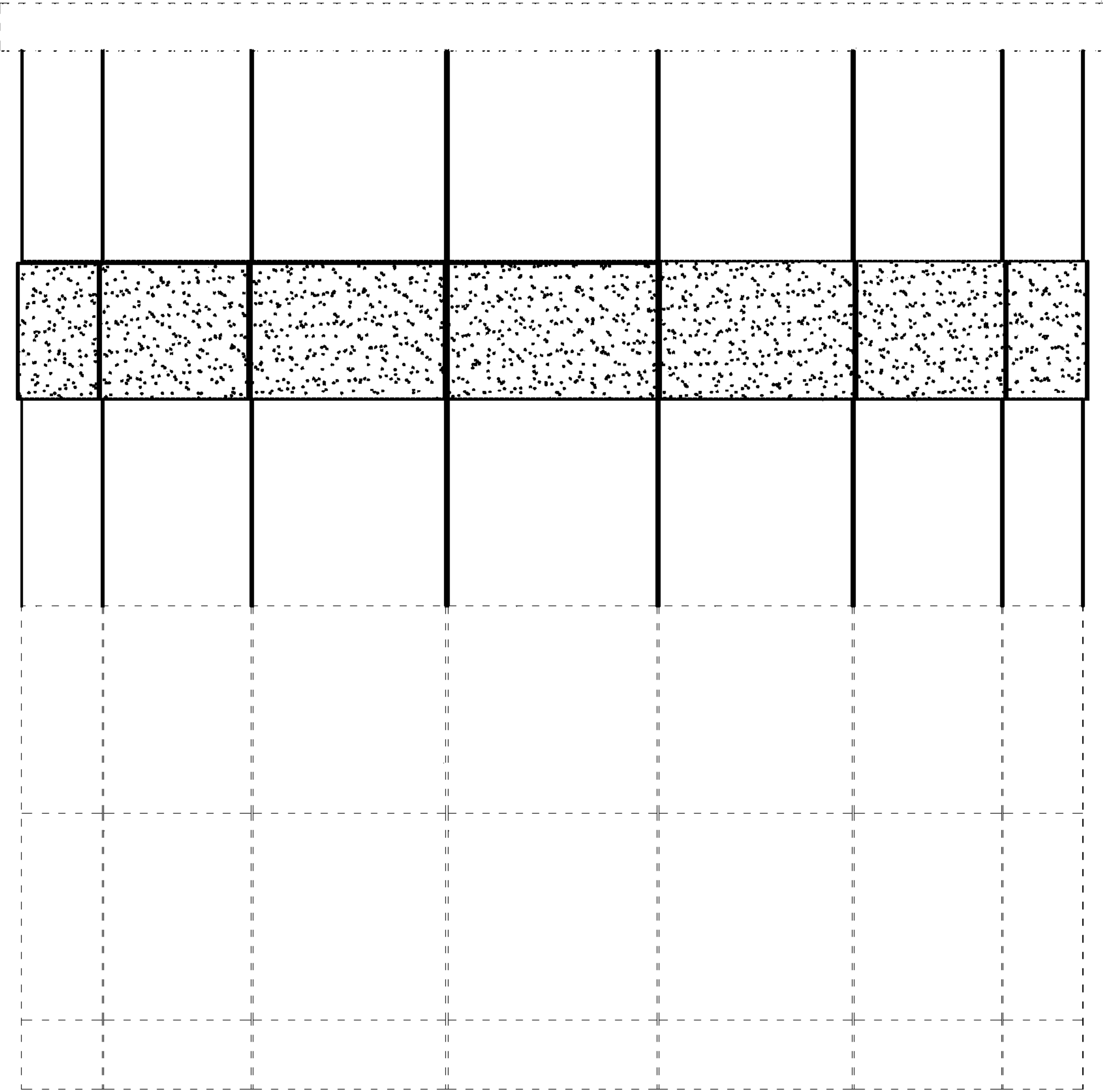

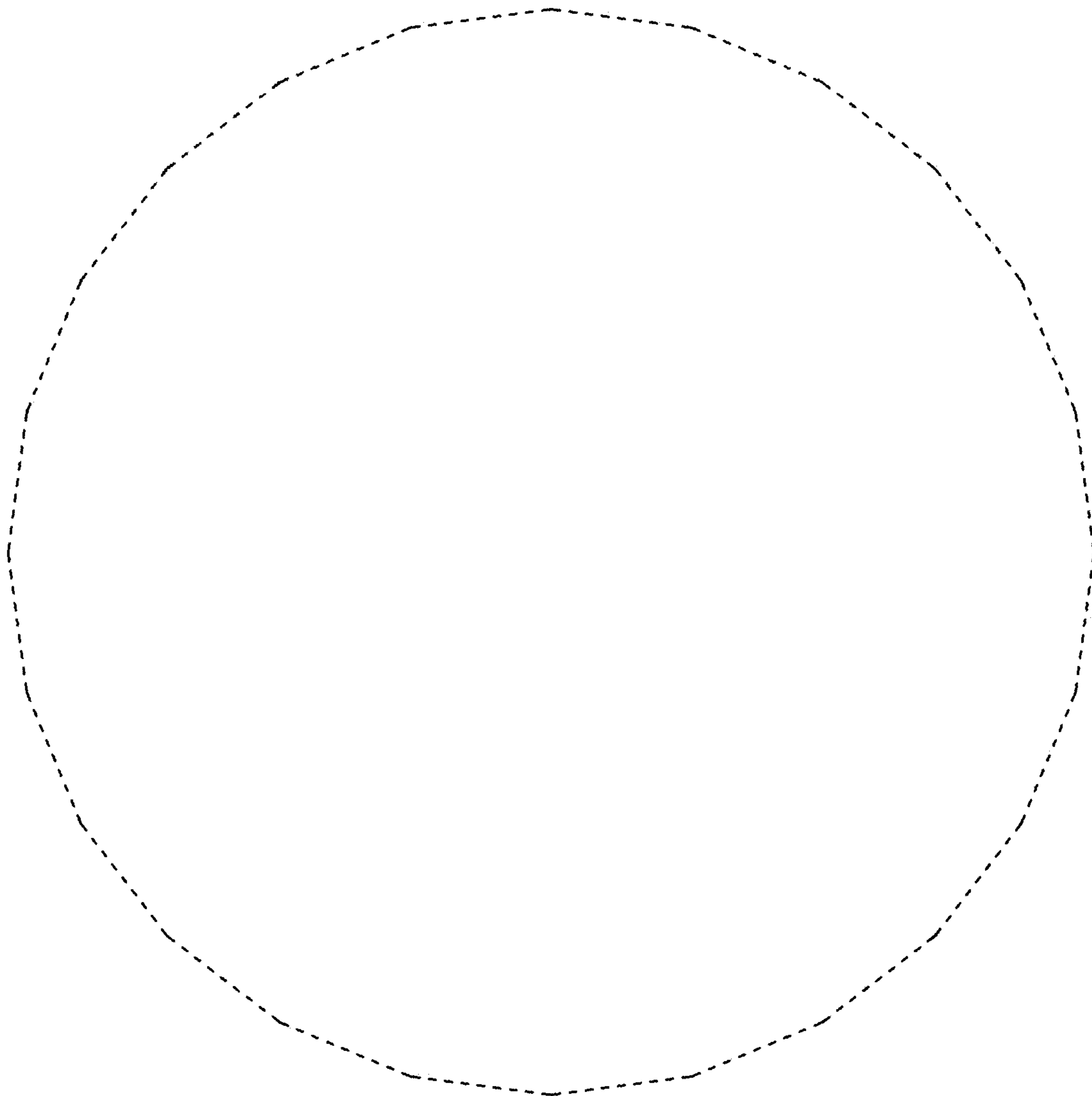
