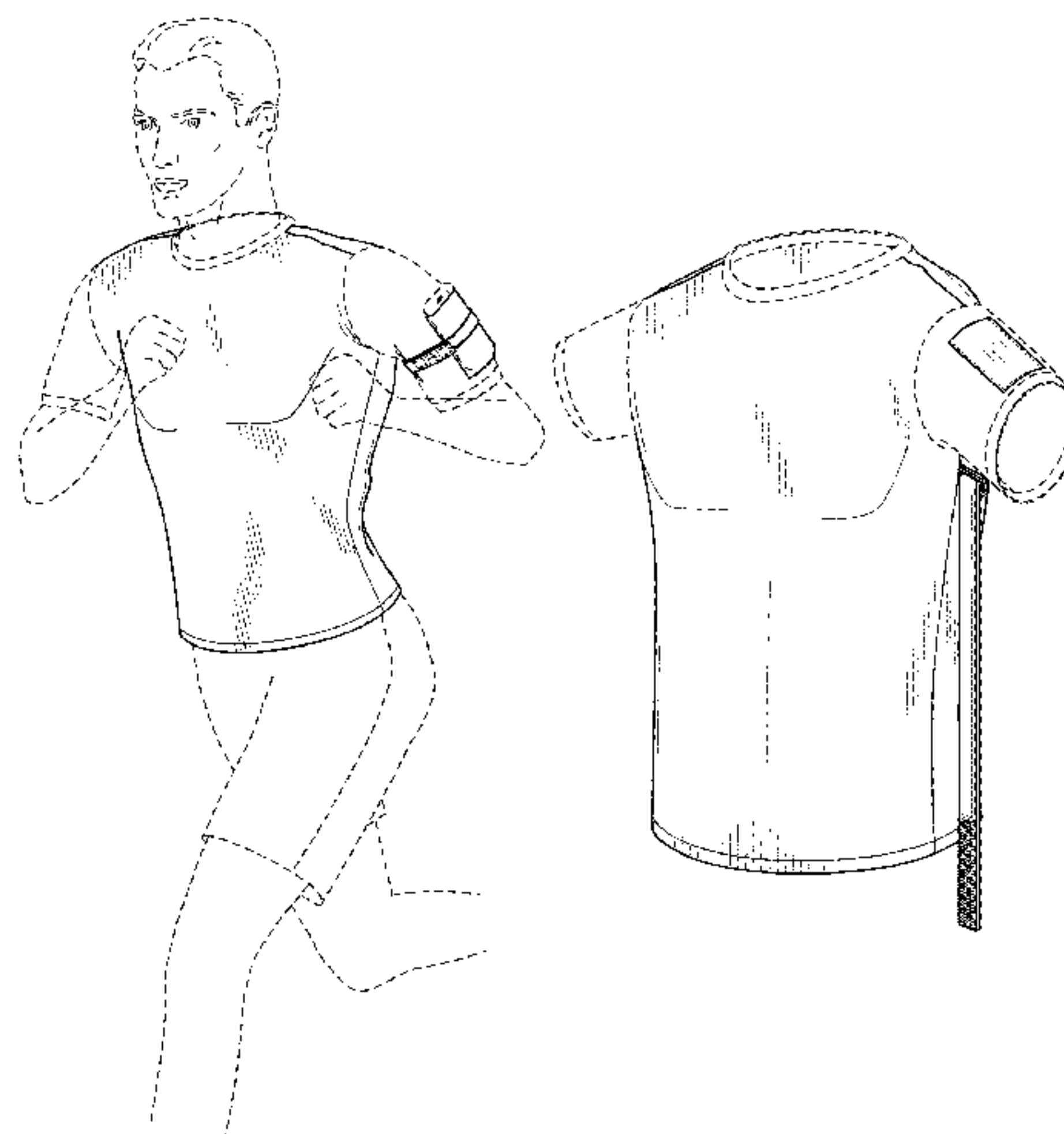
CLAIM

I claim the ornamental design for an “athletic top”, as shown.

DESCRIPTION

FIG. 1 is a perspective view of an athletic top, showing my new design as it would appear in use. The broken lines depicting a male figure and shorts represents environmental subject matter that forms no part of the claimed design; FIG. 2 is another perspective view of the athletic top of FIG. 1; FIG. 3 is a front view of the athletic top of FIG. 1; FIG. 4 is a back view of the athletic top of FIG. 1; FIG. 5 is an exploded front view of the athletic top of FIG. 3; FIG. 6 is an exploded back view of the athletic top of FIG. 4; FIG. 7 is a left side view of the athletic top of FIG. 1; FIG. 8 is a right side view of the athletic top of FIG. 1; FIG. 9 is a top view of the athletic top of FIG. 1; and, FIG. 10 is a bottom view of the athletic top of FIG. 1.

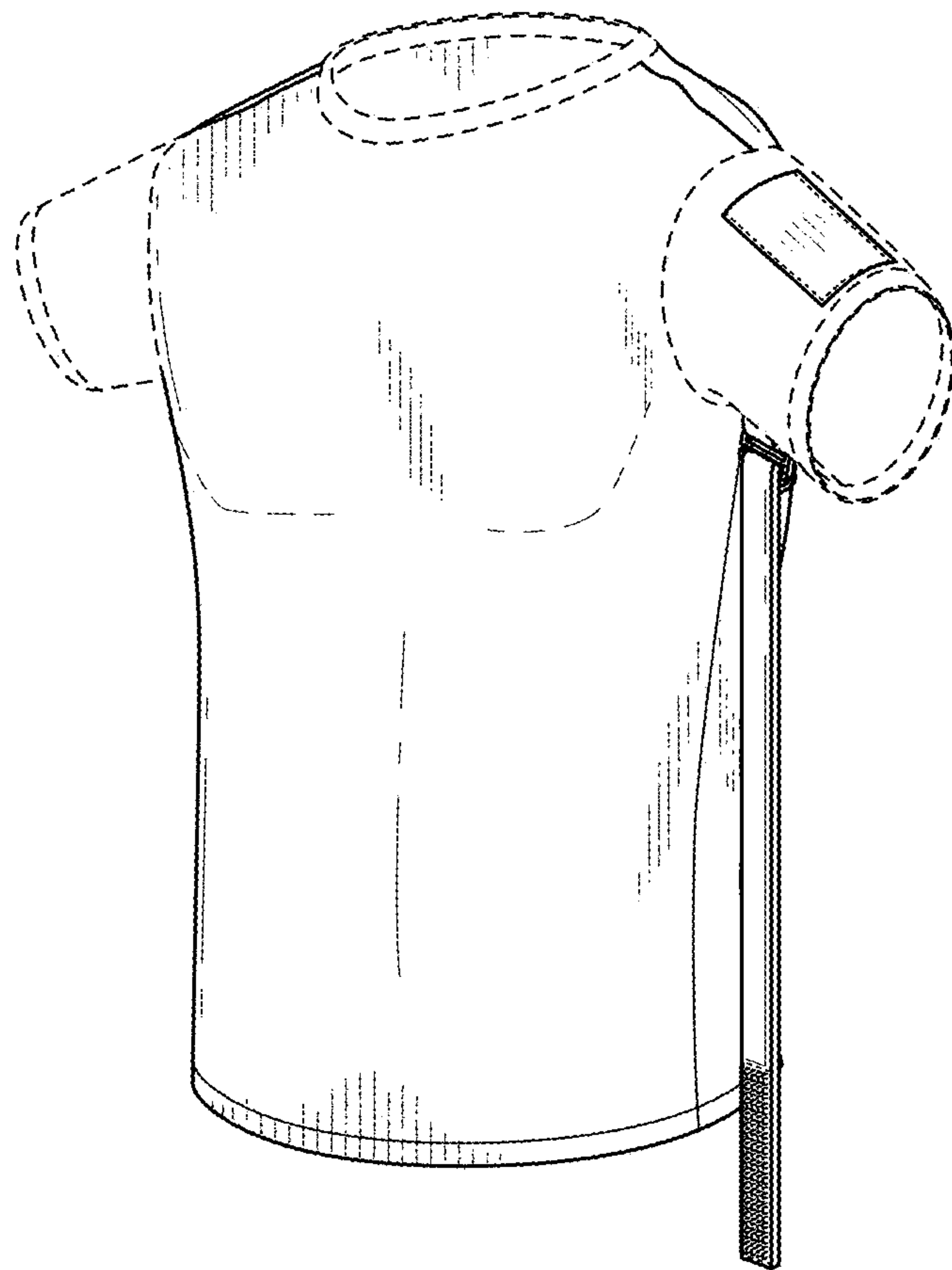

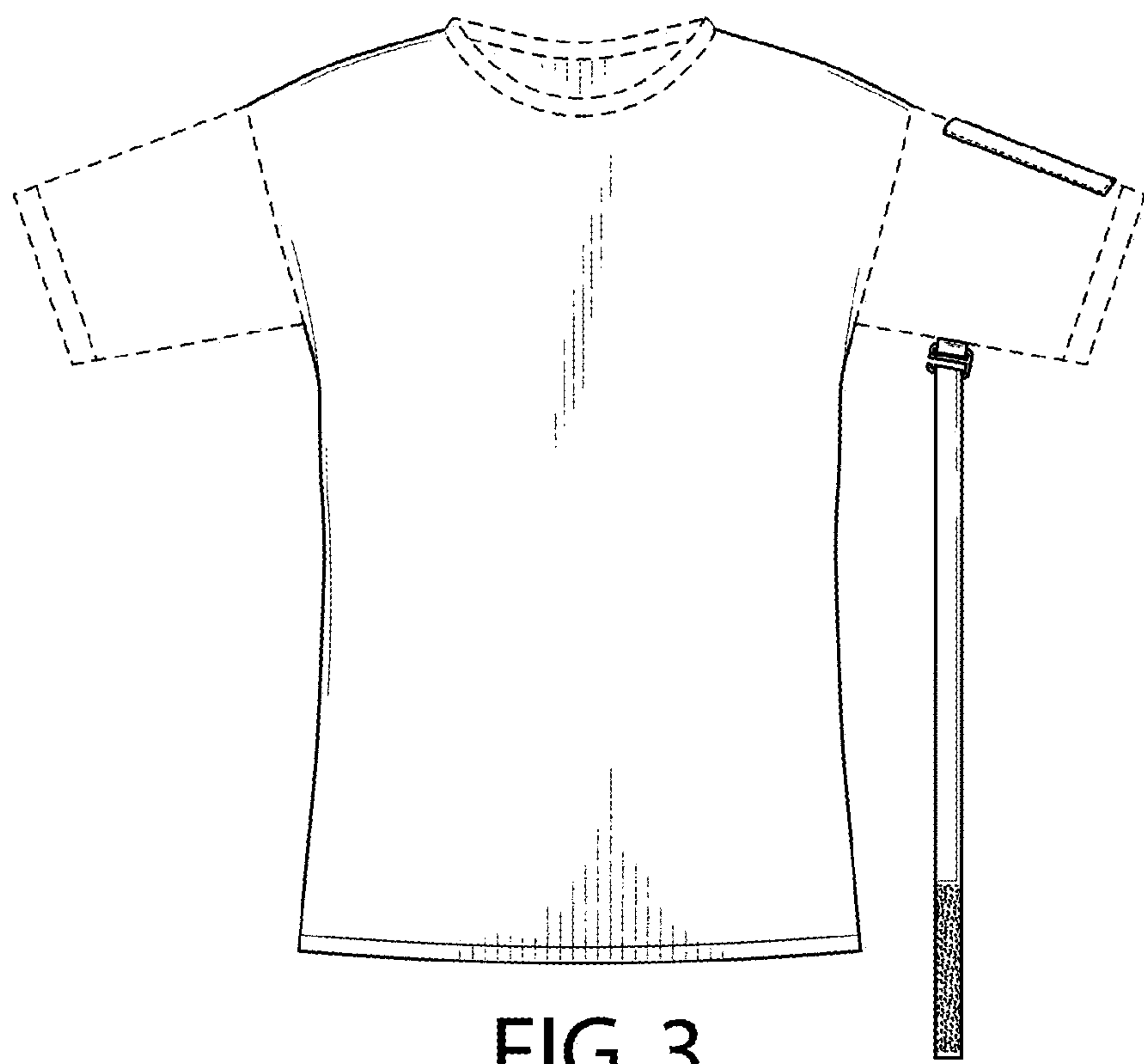

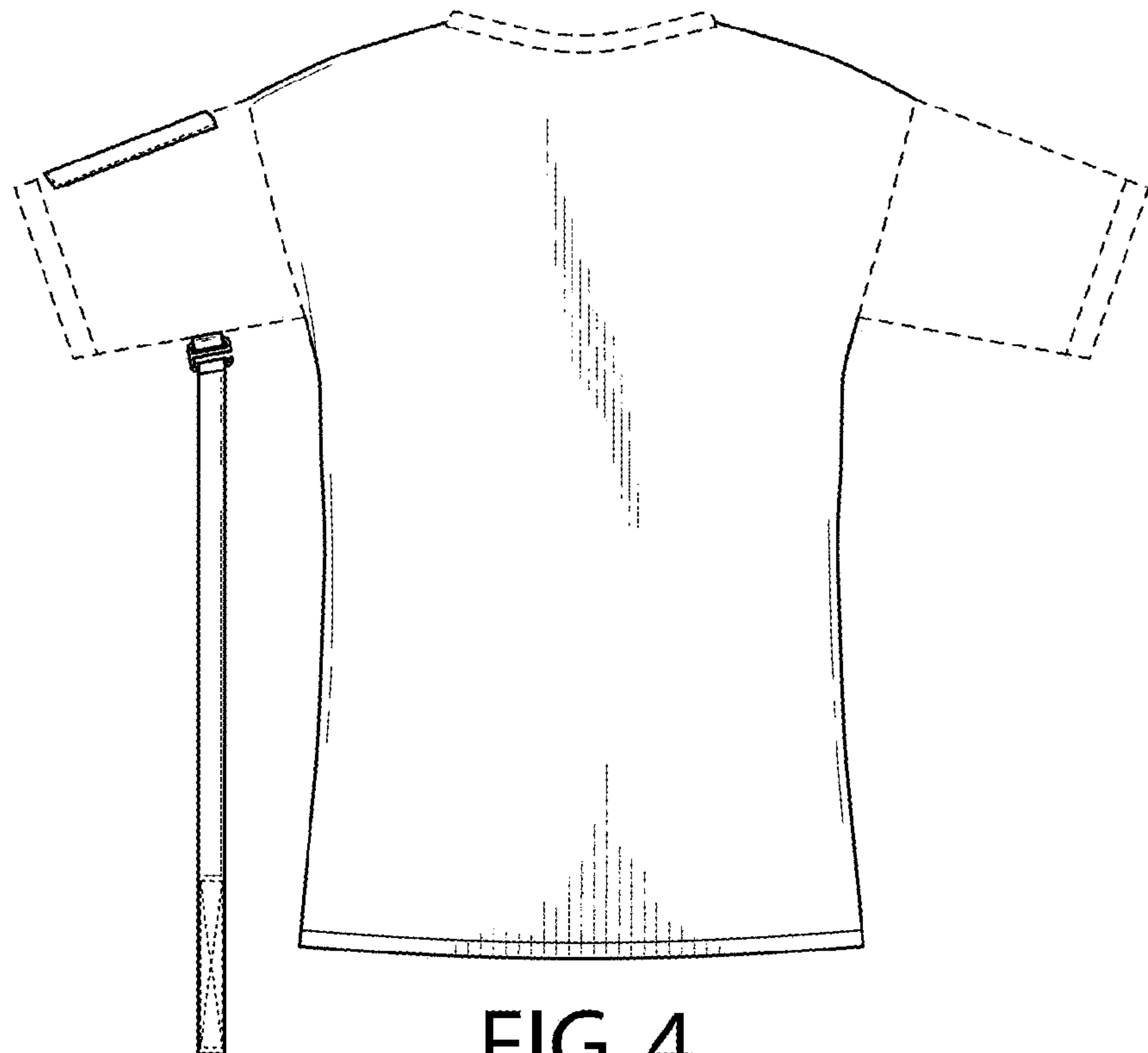
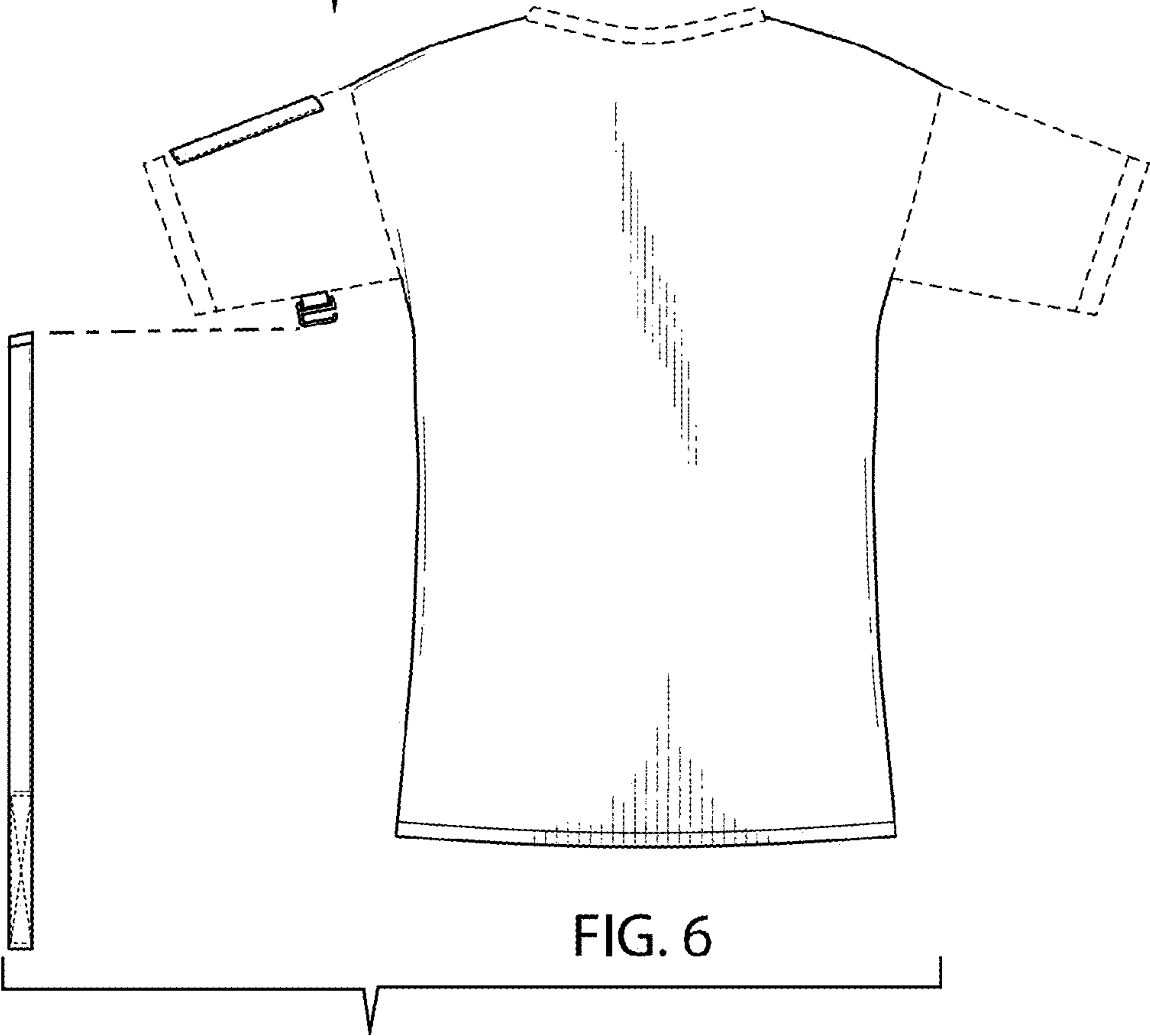
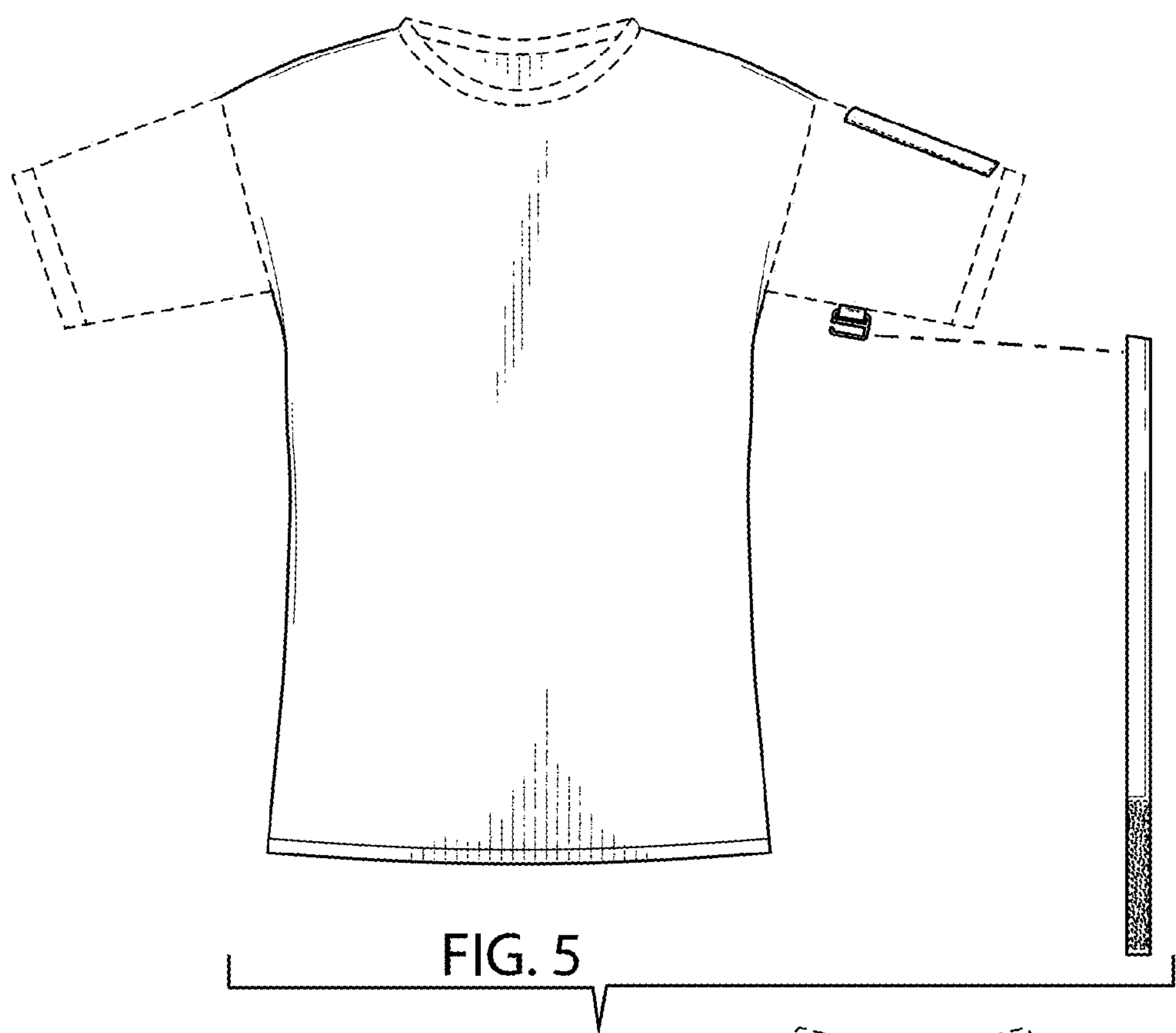

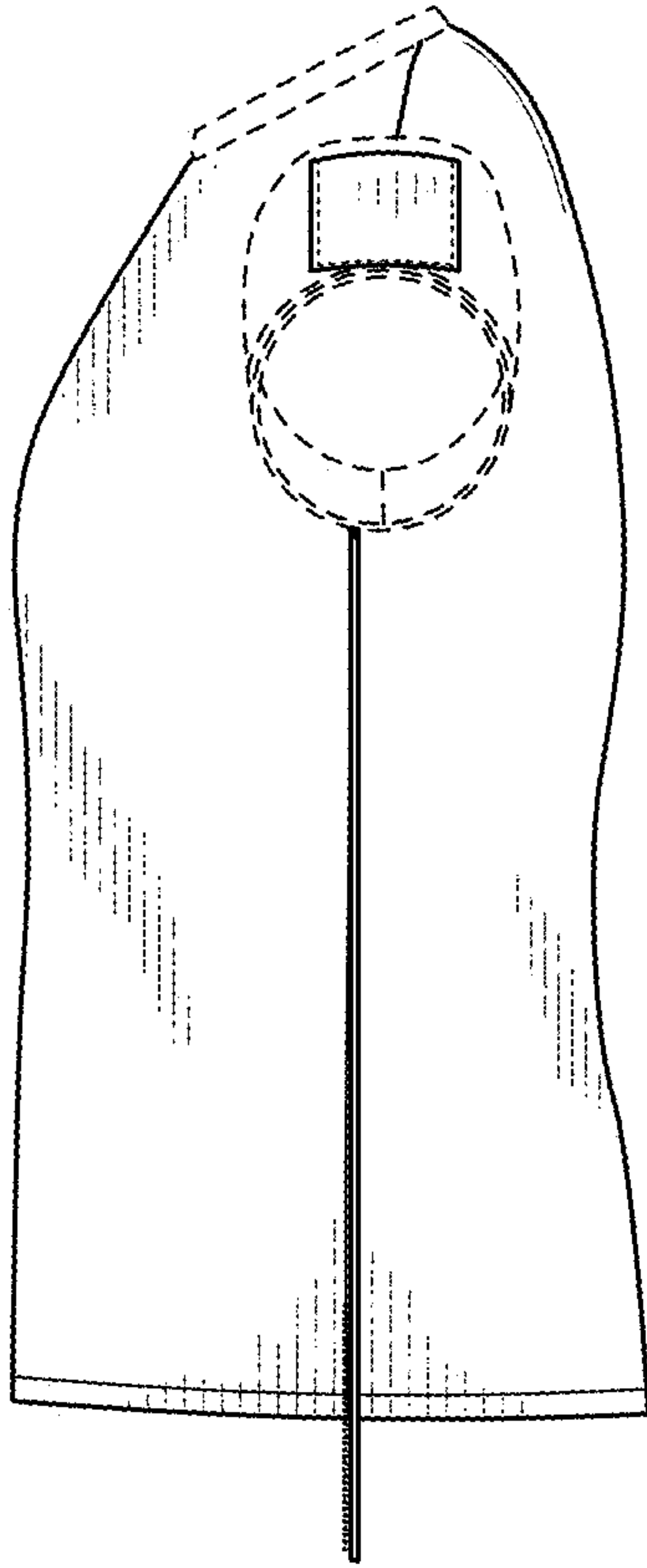

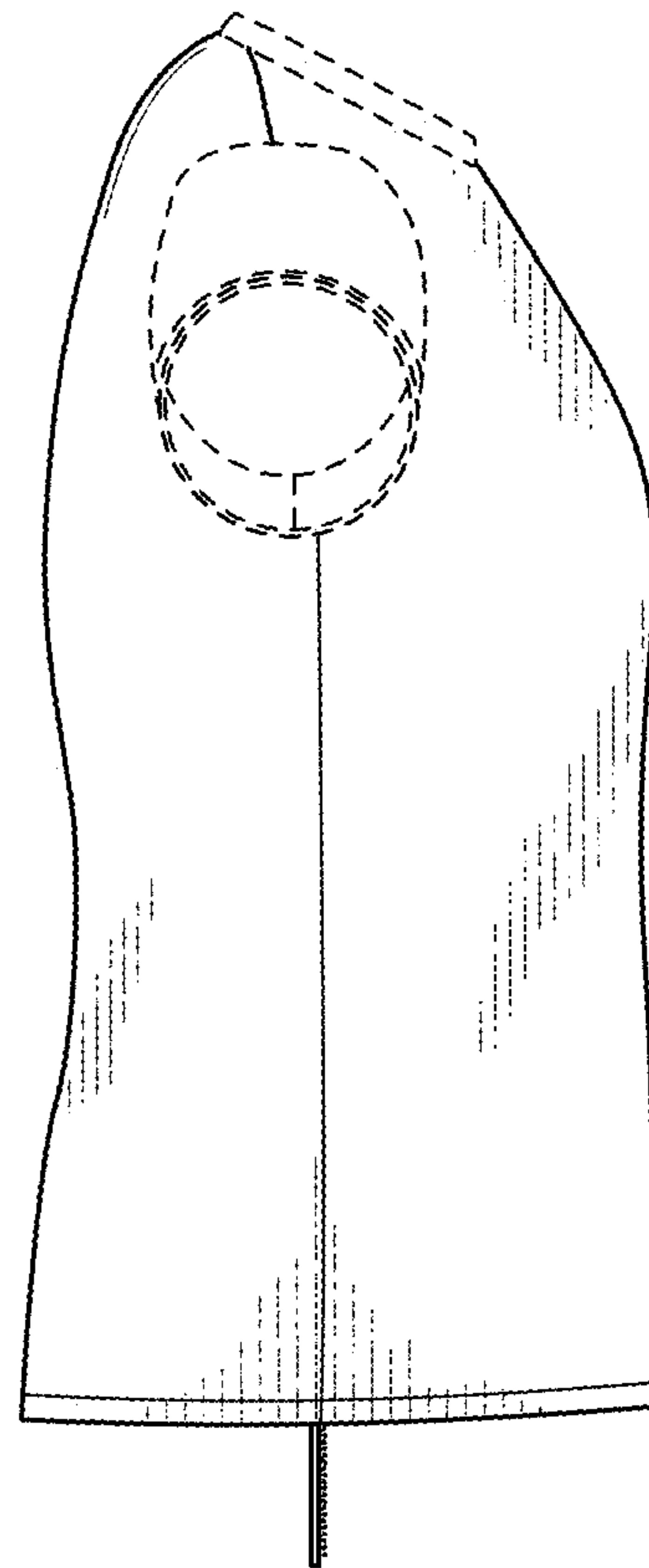

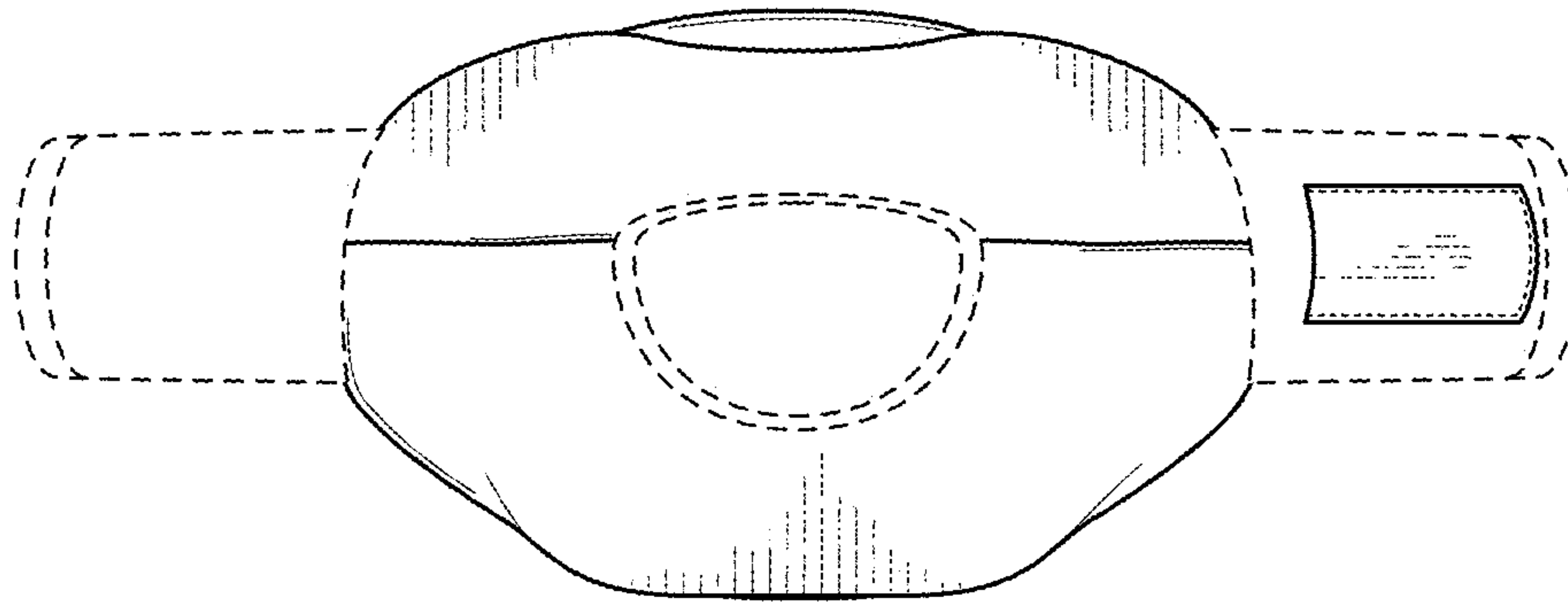

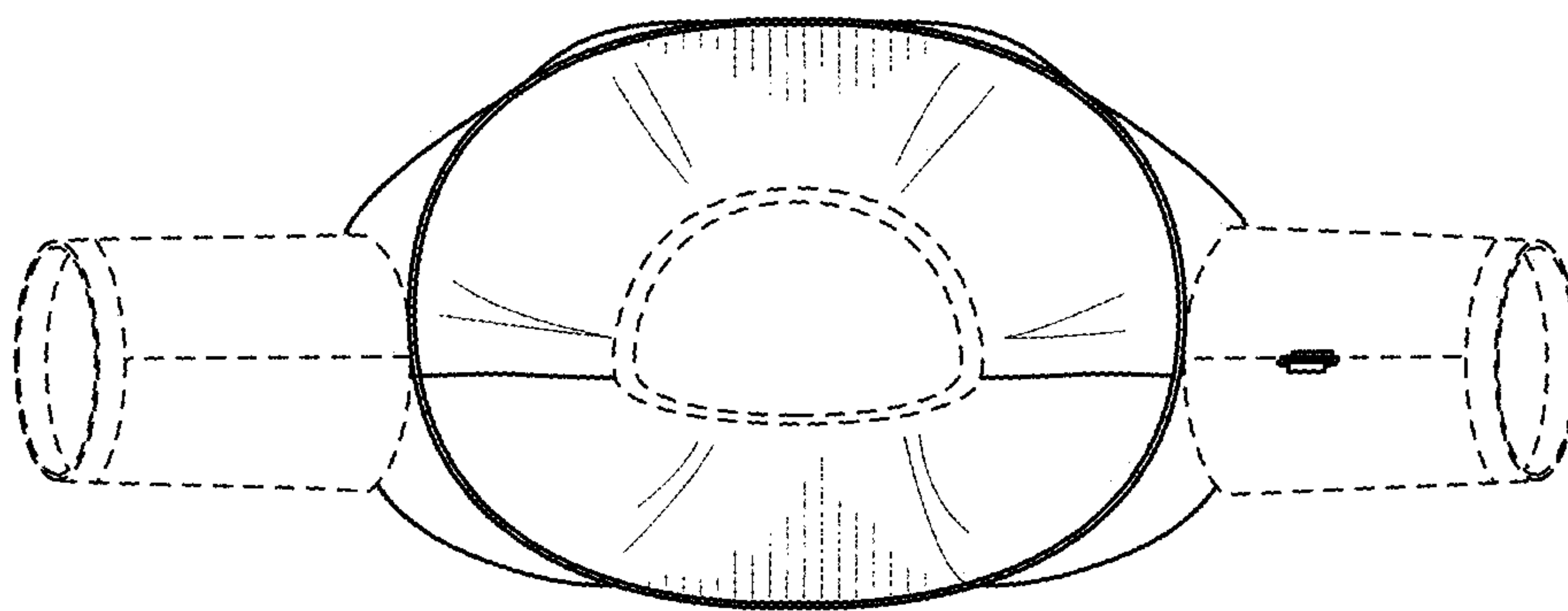
