(57) **CLAIM**

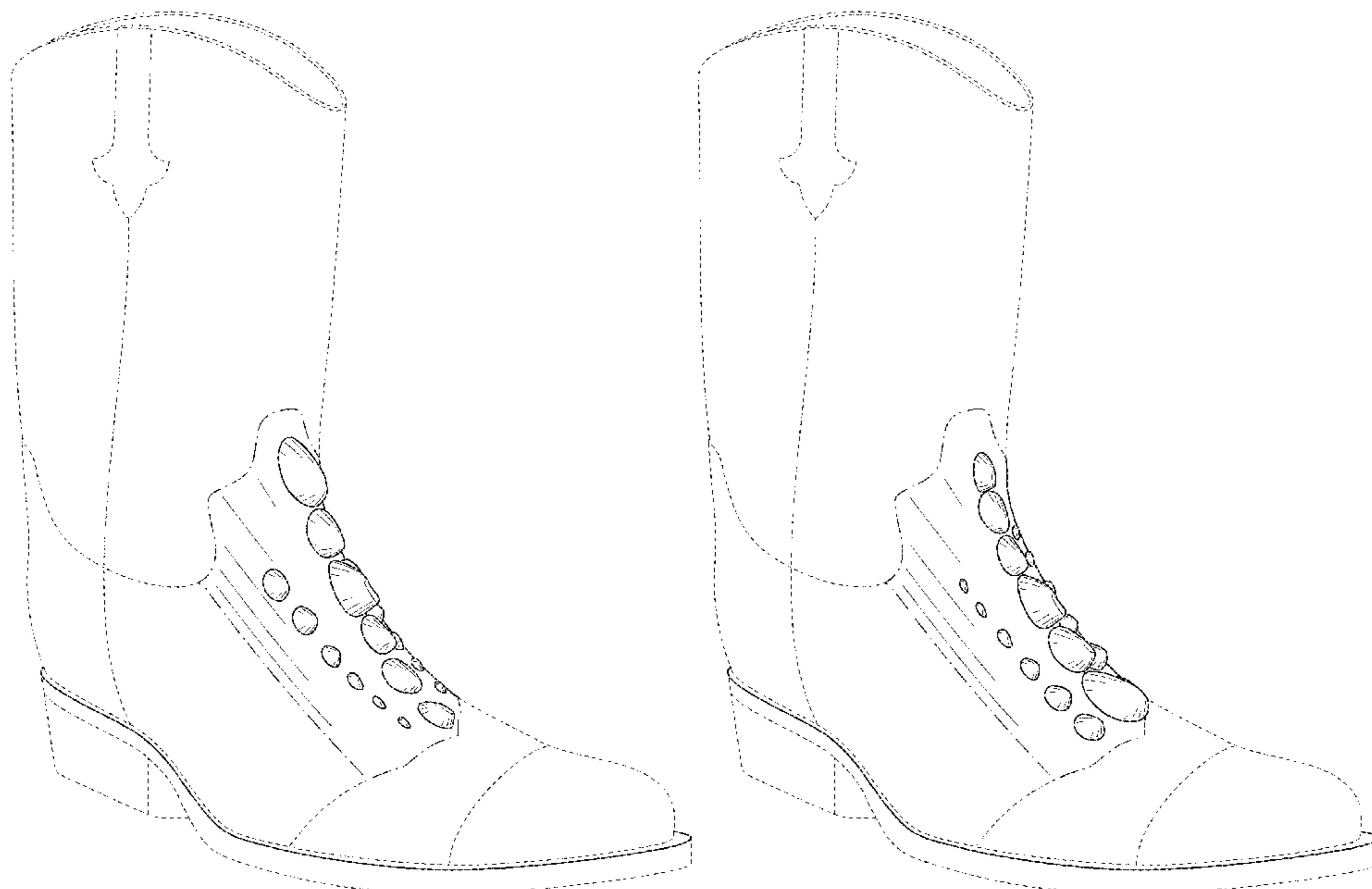
The ornamental design for a footwear, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of the footwear showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a front perspective view of a second embodiment of the footwear showing my new design; FIG. 8 is a front view thereof; FIG. 9 is a rear view thereof; FIG. 10 is a right side view thereof; FIG. 11 is a left side view thereof; and, FIG. 12 is a top view thereof.

The dashed broken lines in FIGS. 1-12 show unclaimed portions of the footwear. The dashed-dotted broken lines in FIGS. 1, 2, 4-8, and 10-12 show unclaimed boundaries between claimed and unclaimed subject matter on the footwear upper. The line shading in FIGS. 1, 2, 4-8, and 10-12 show surface contours, not surface ornamentation. The bottom views are omitted and form no part of the claimed design.

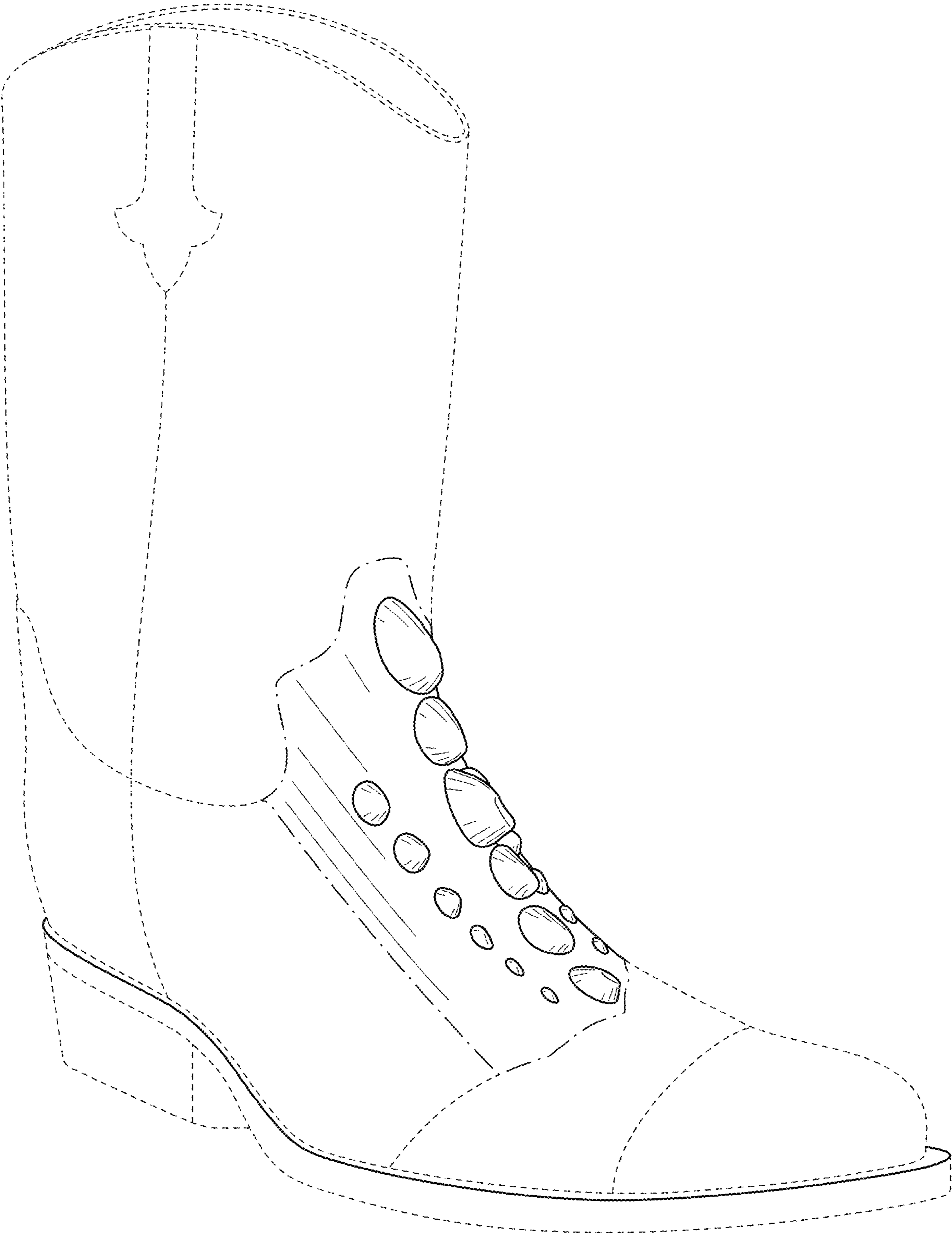

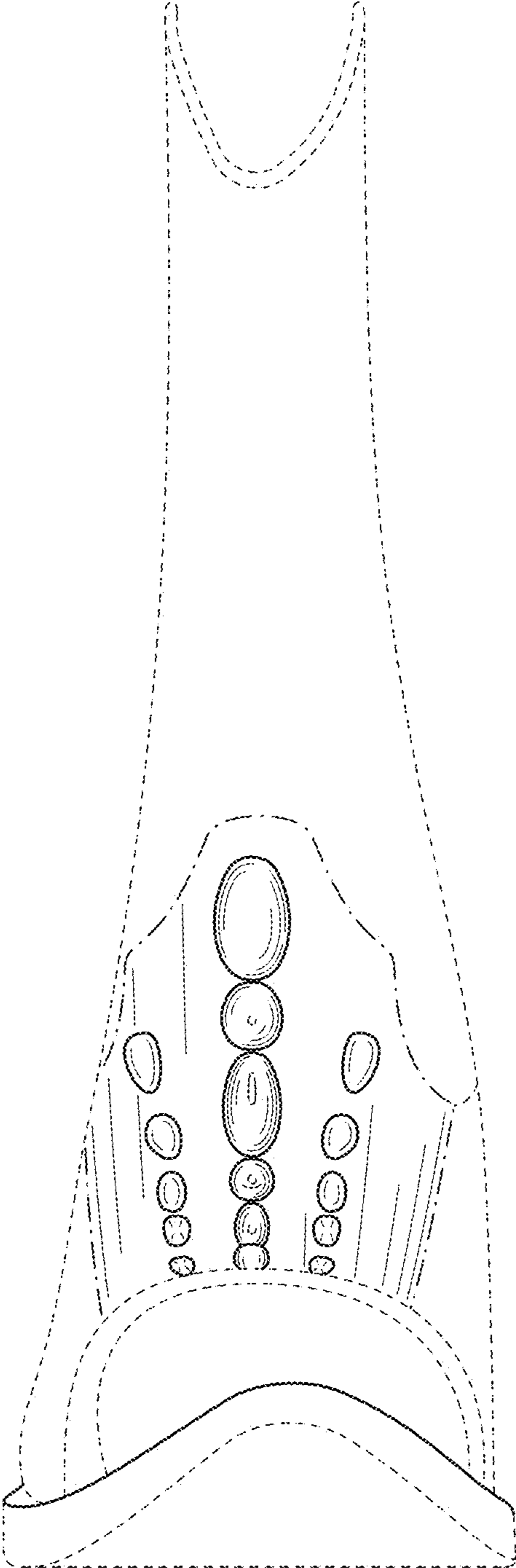

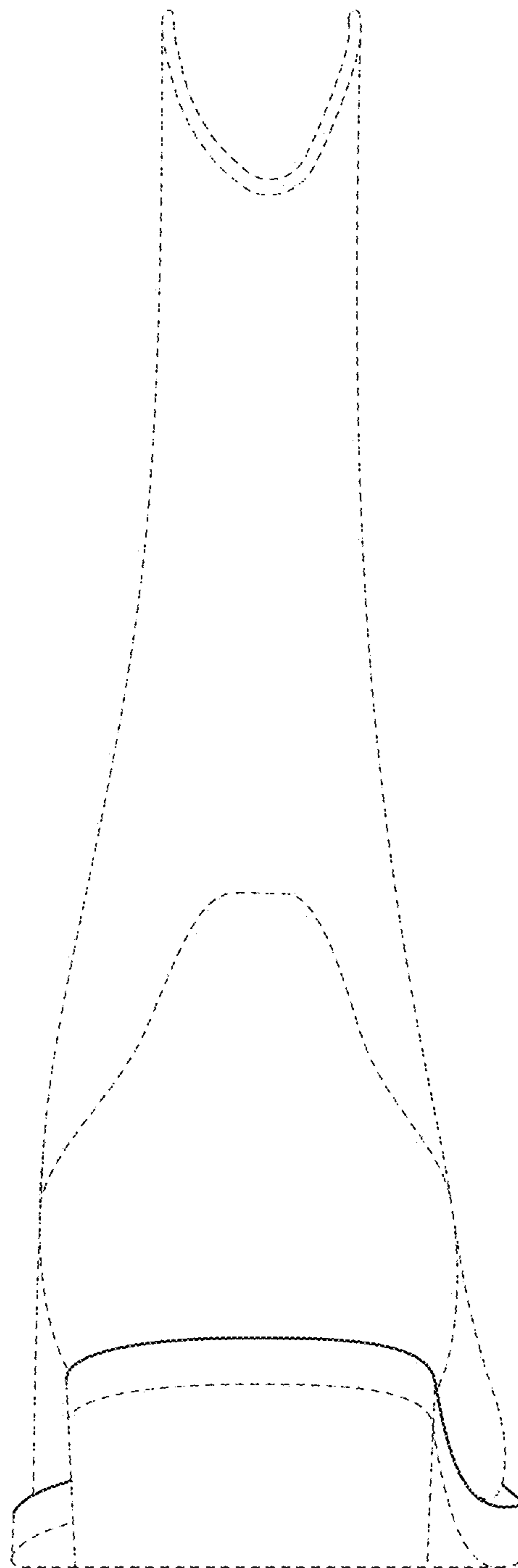

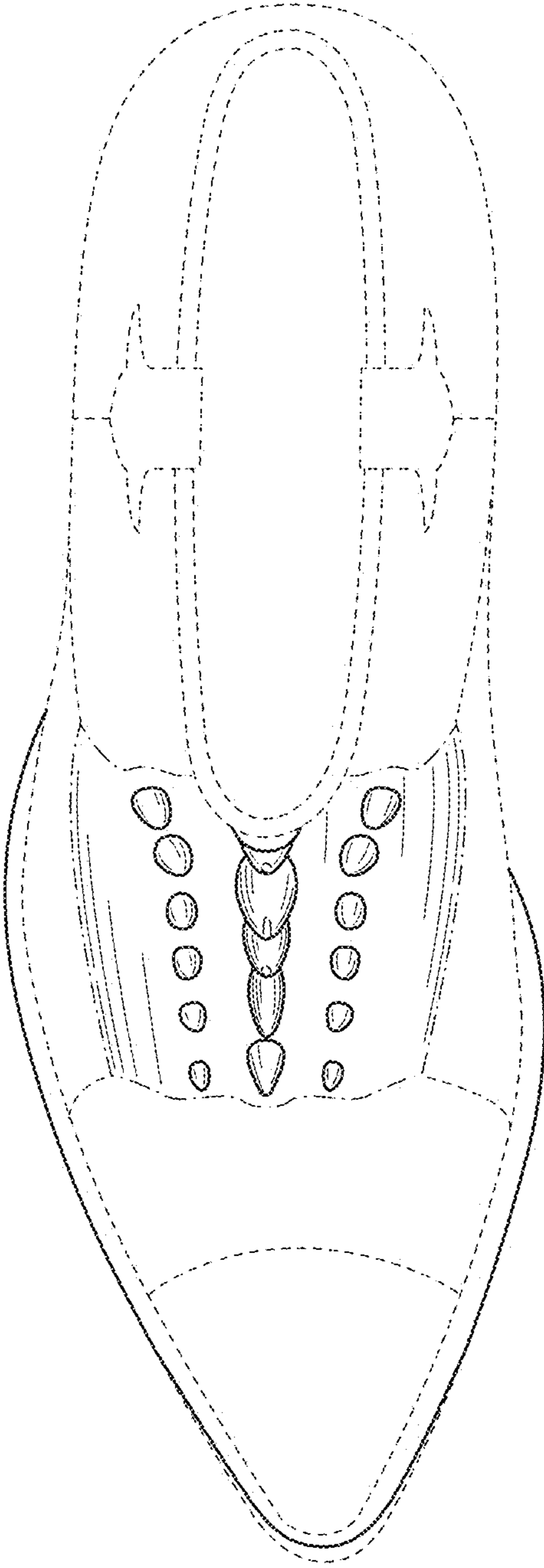

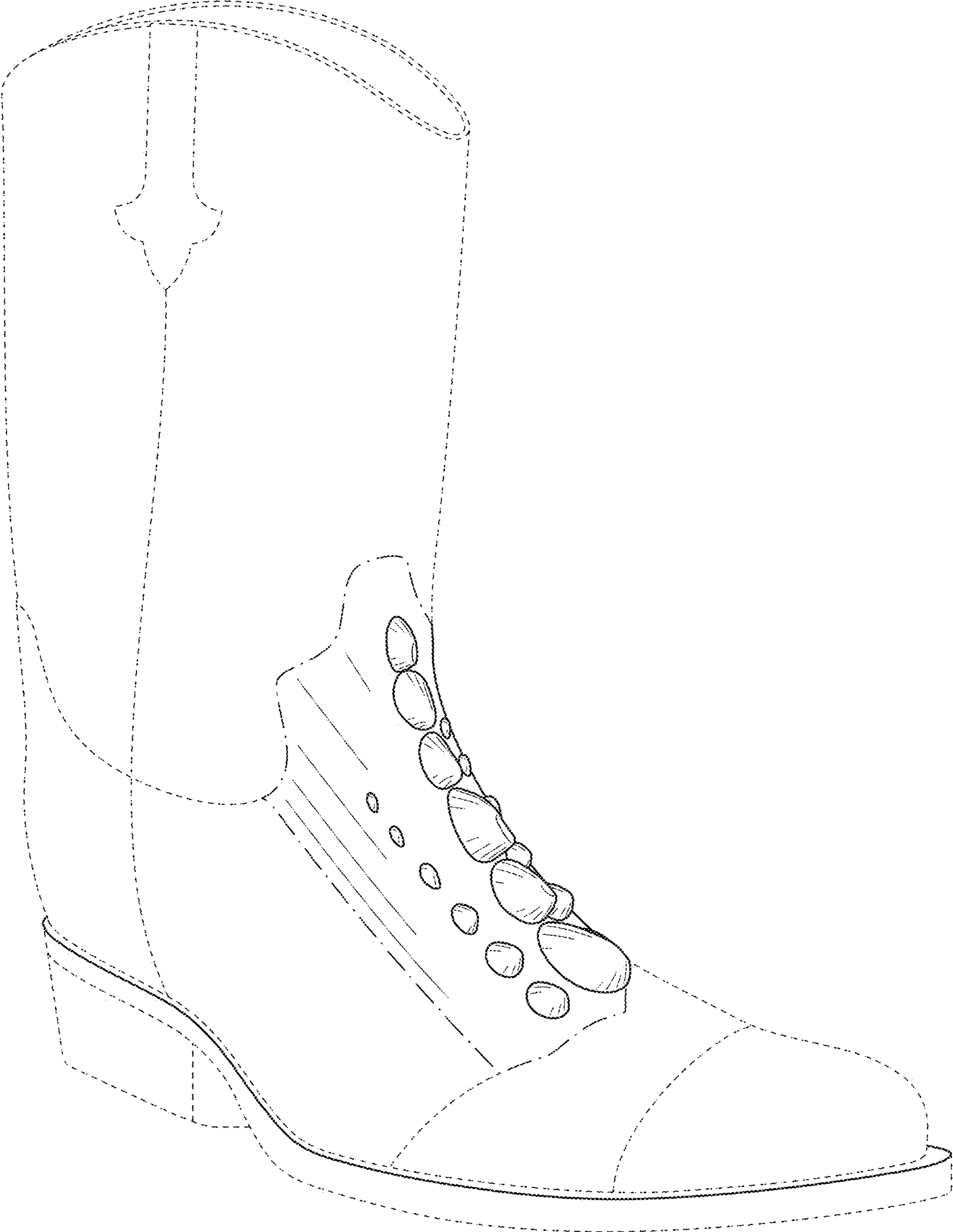

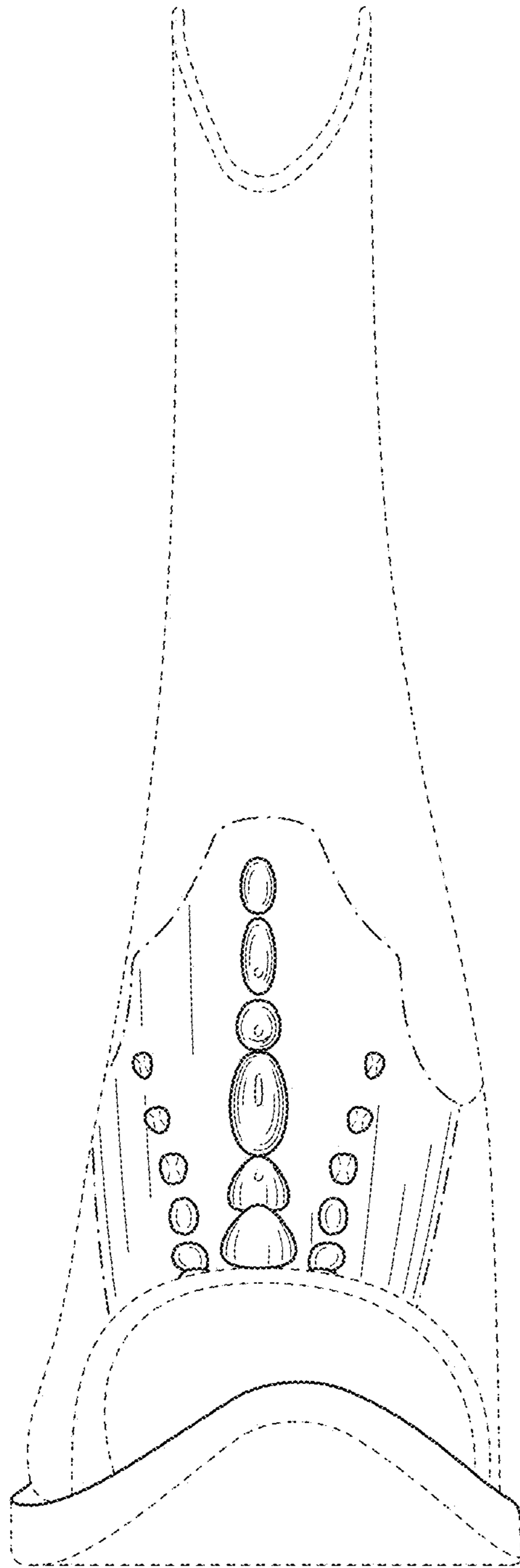

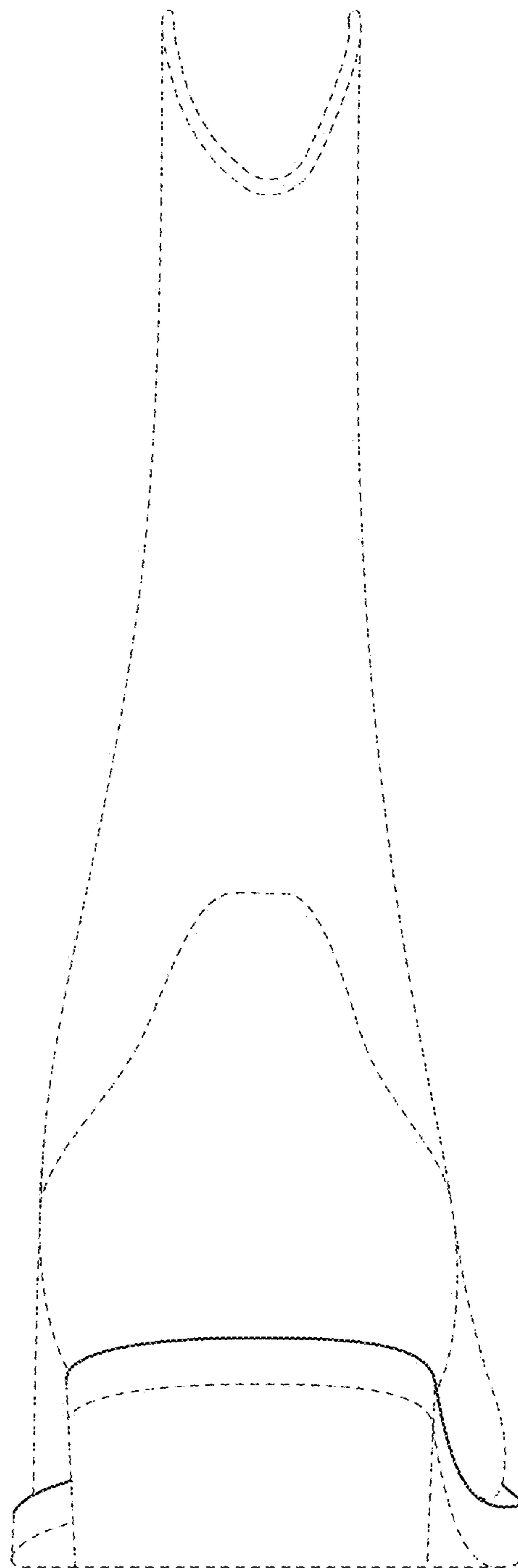

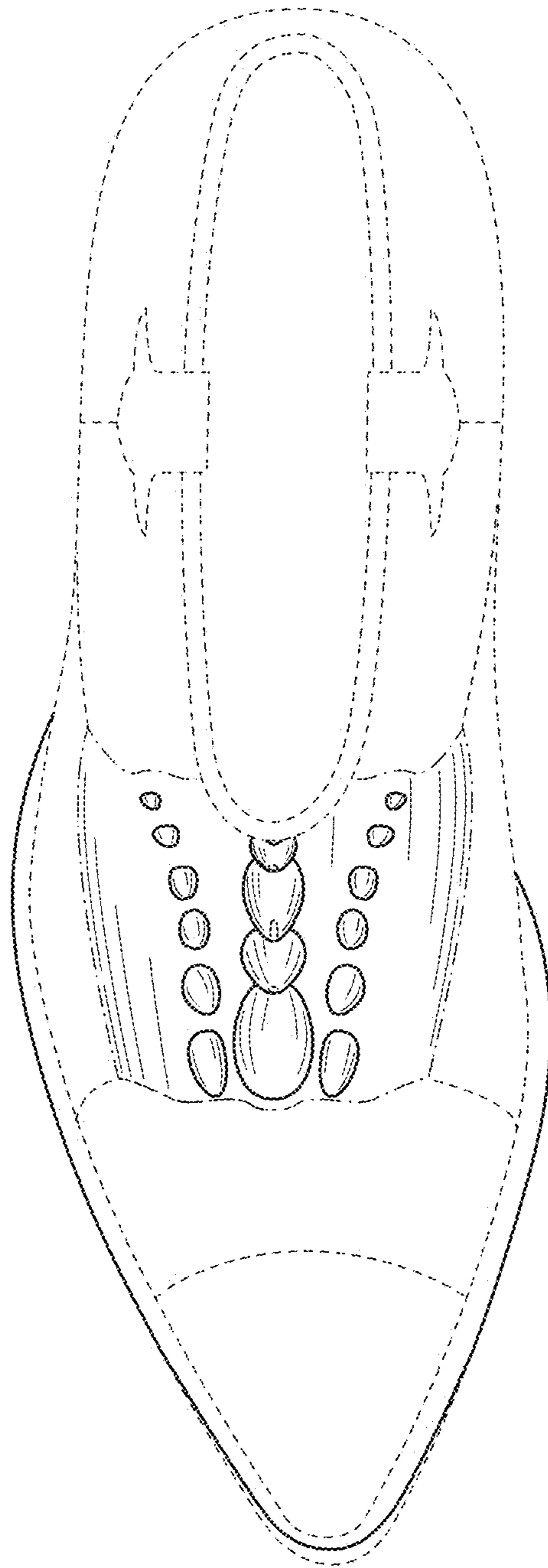
