FIG. 10 shows a front interior view of the design in an open configuration showing a compression pad exposed and the laundry bag of the design in a stored configuration.

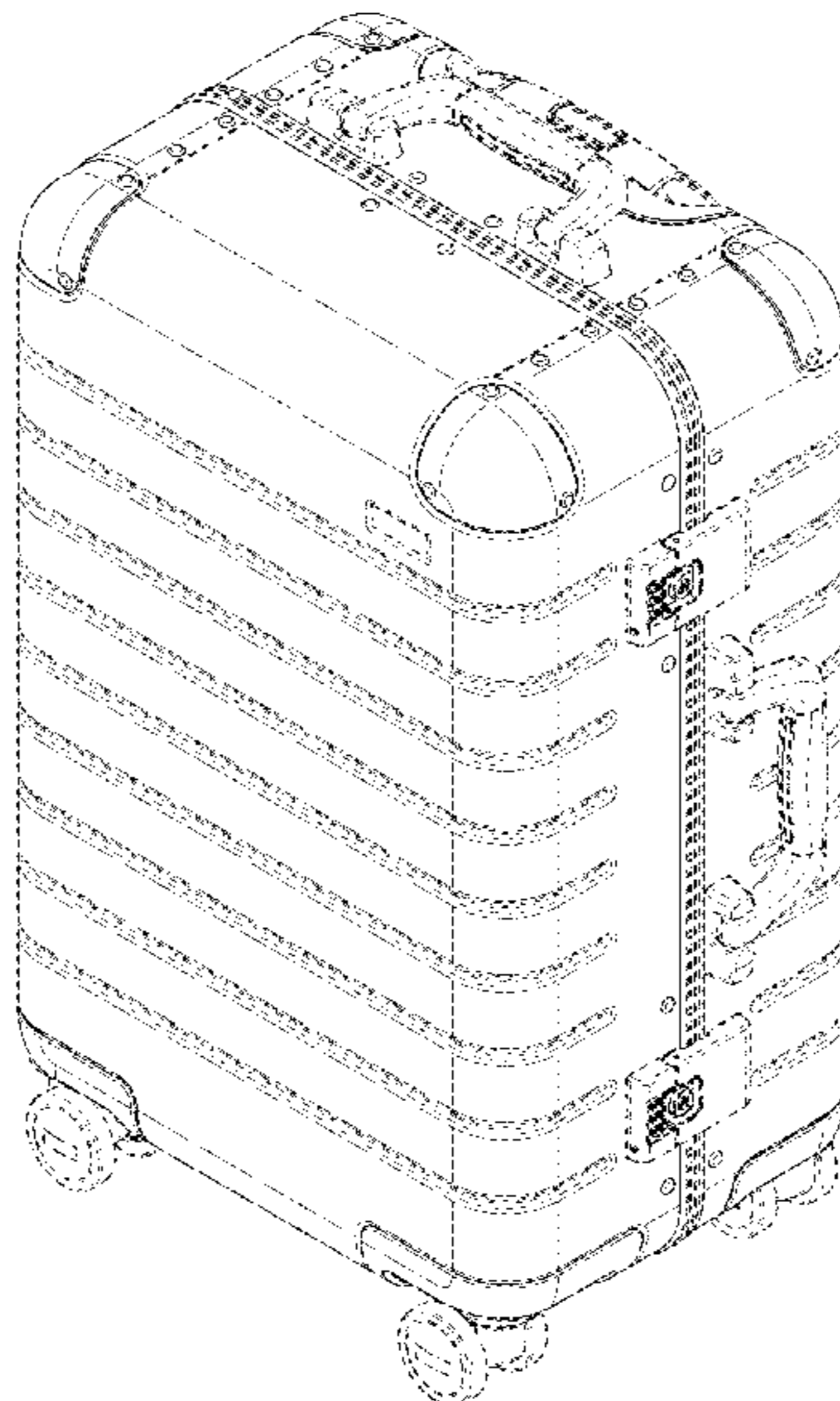

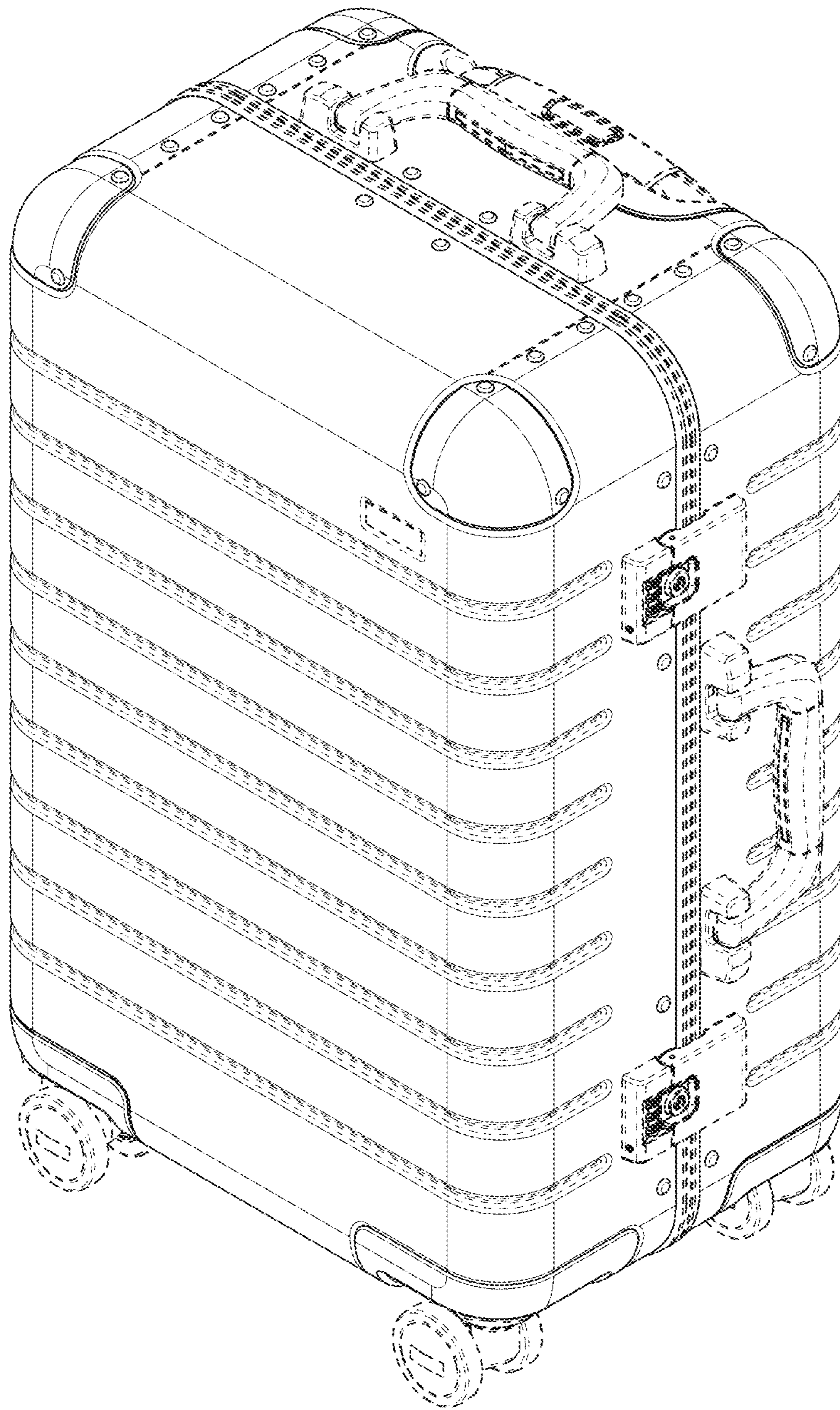

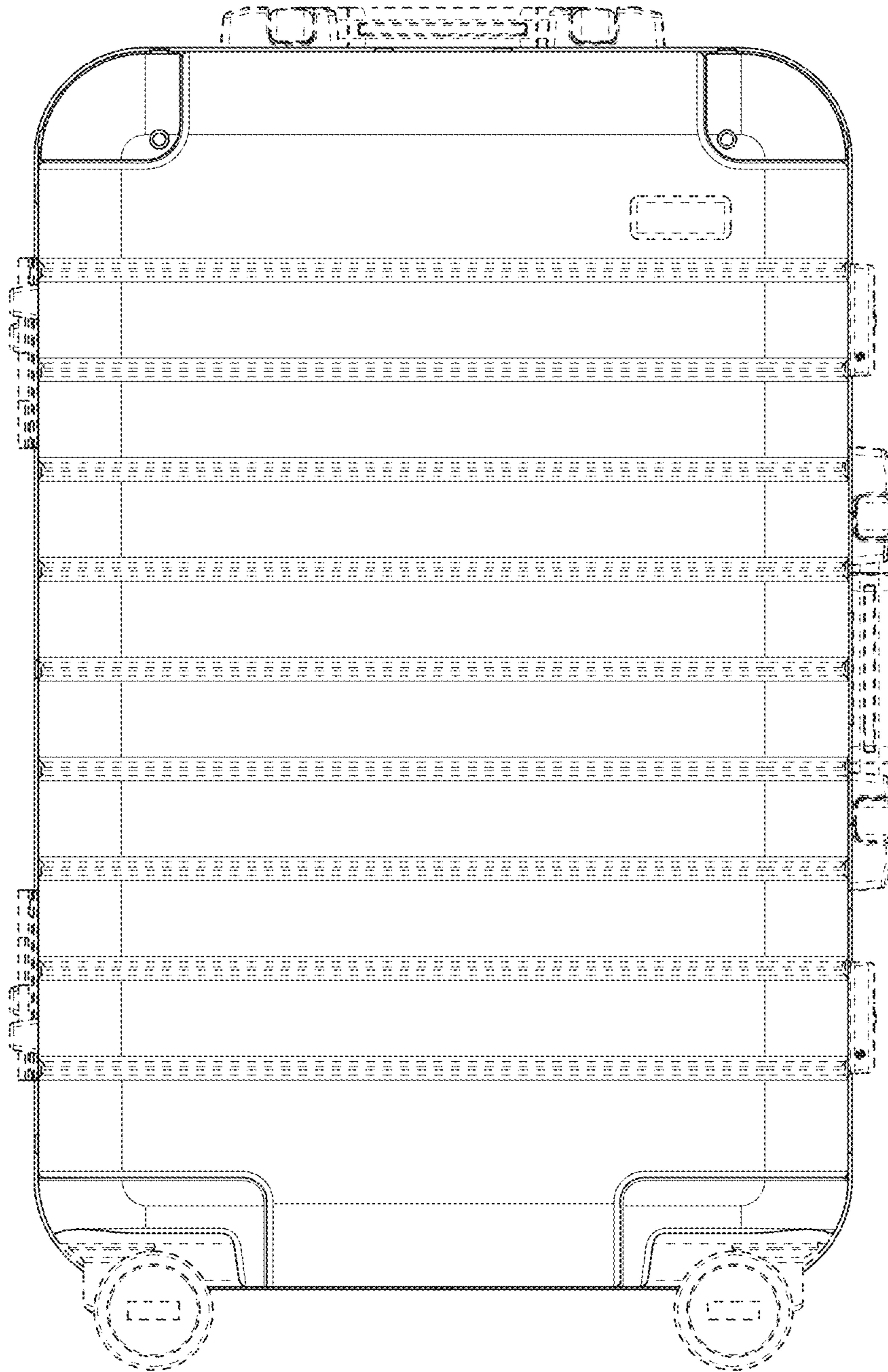

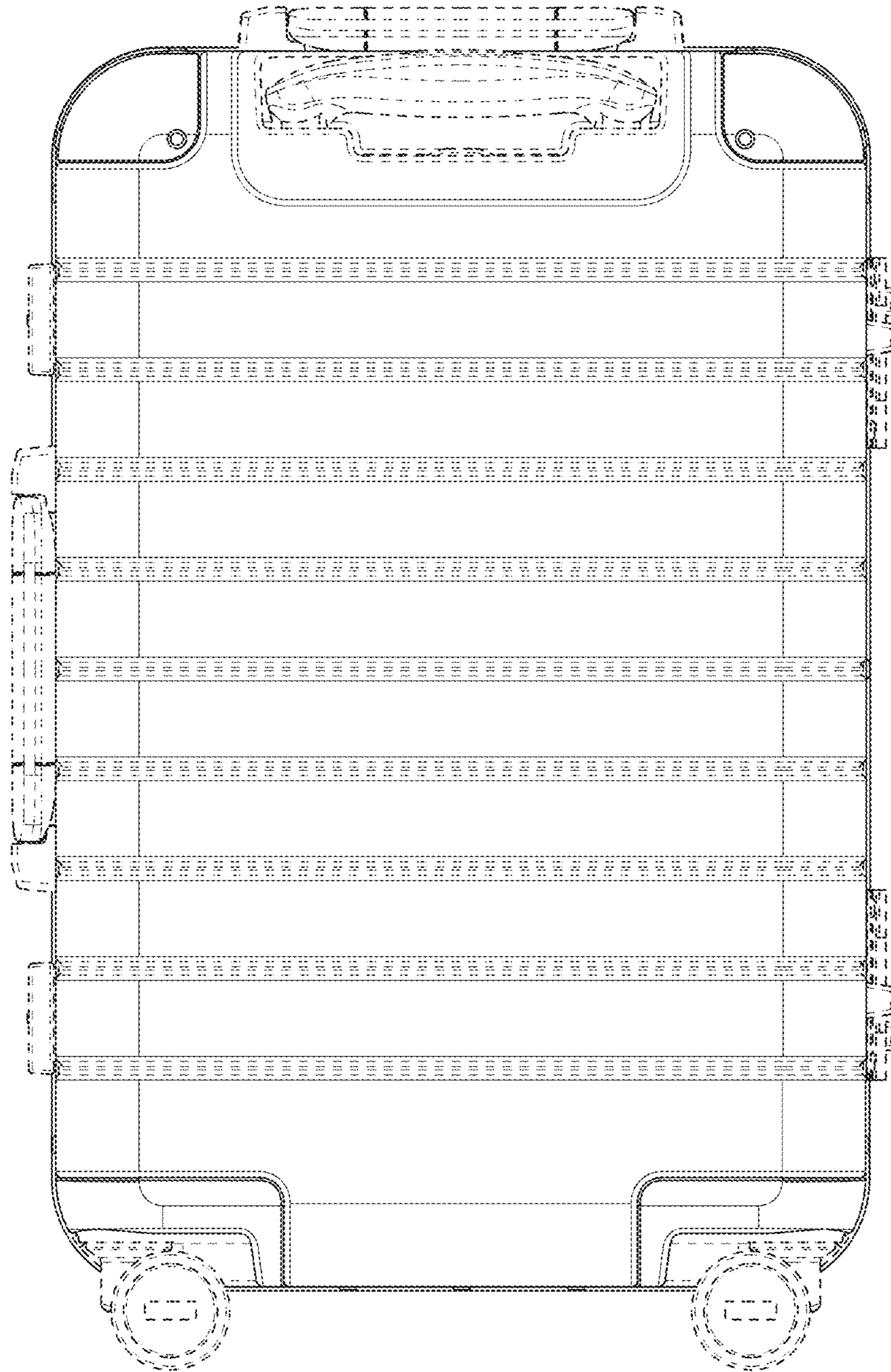

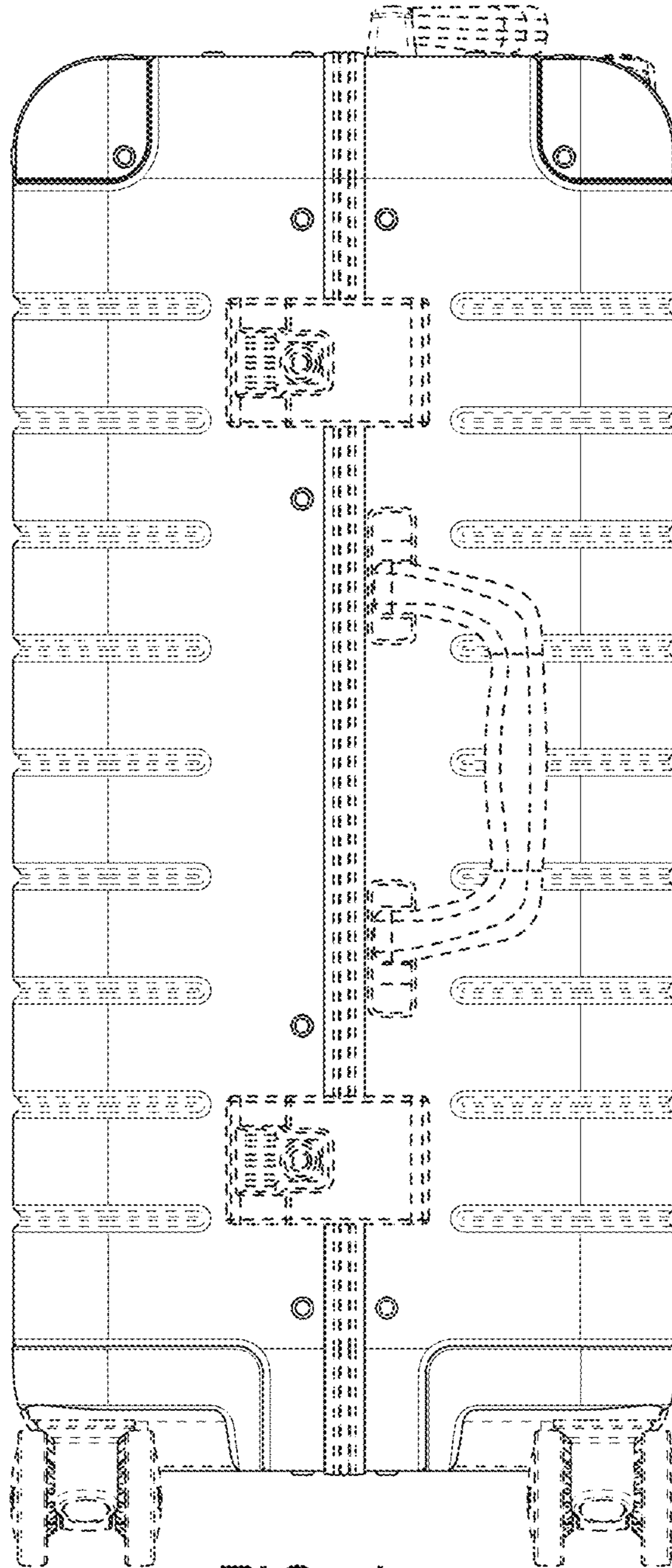

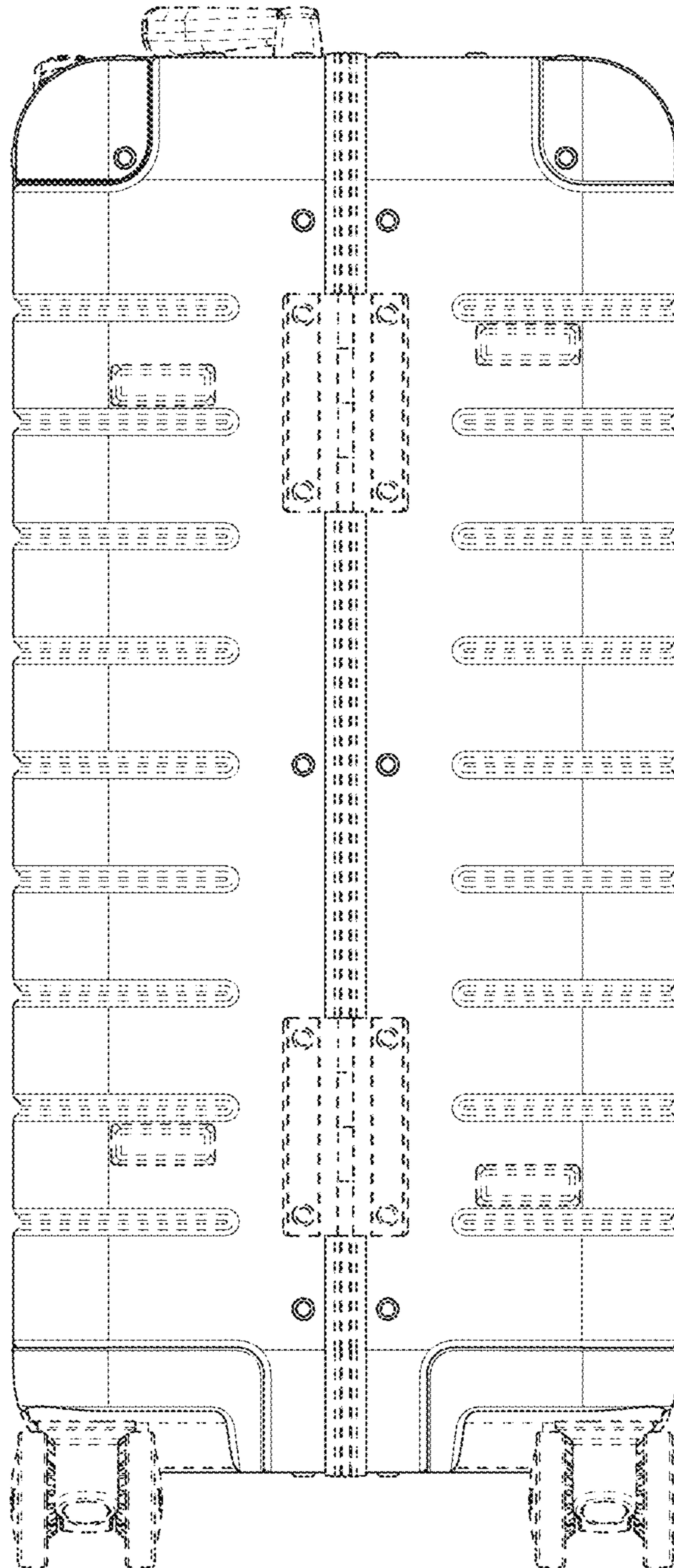

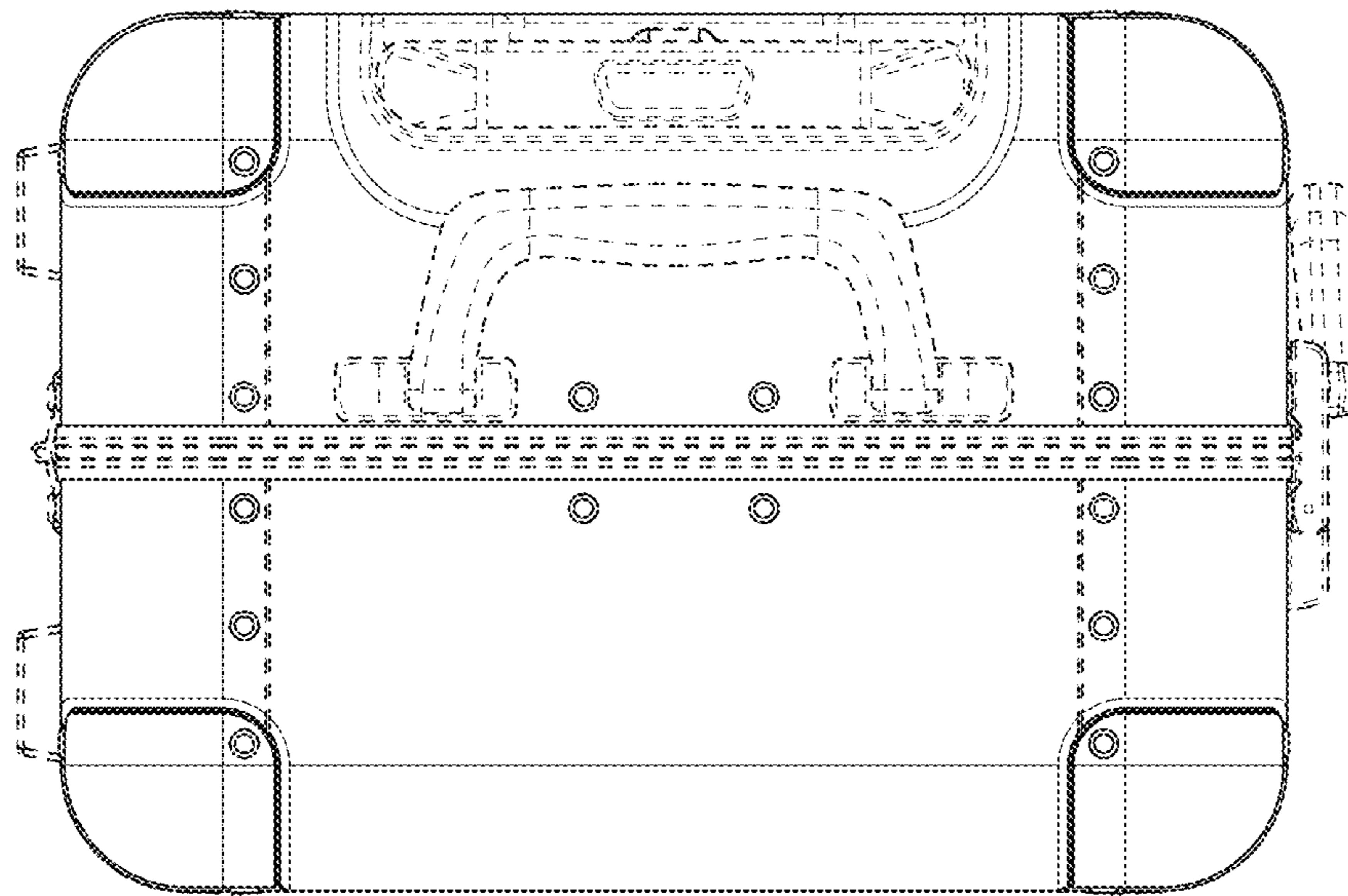

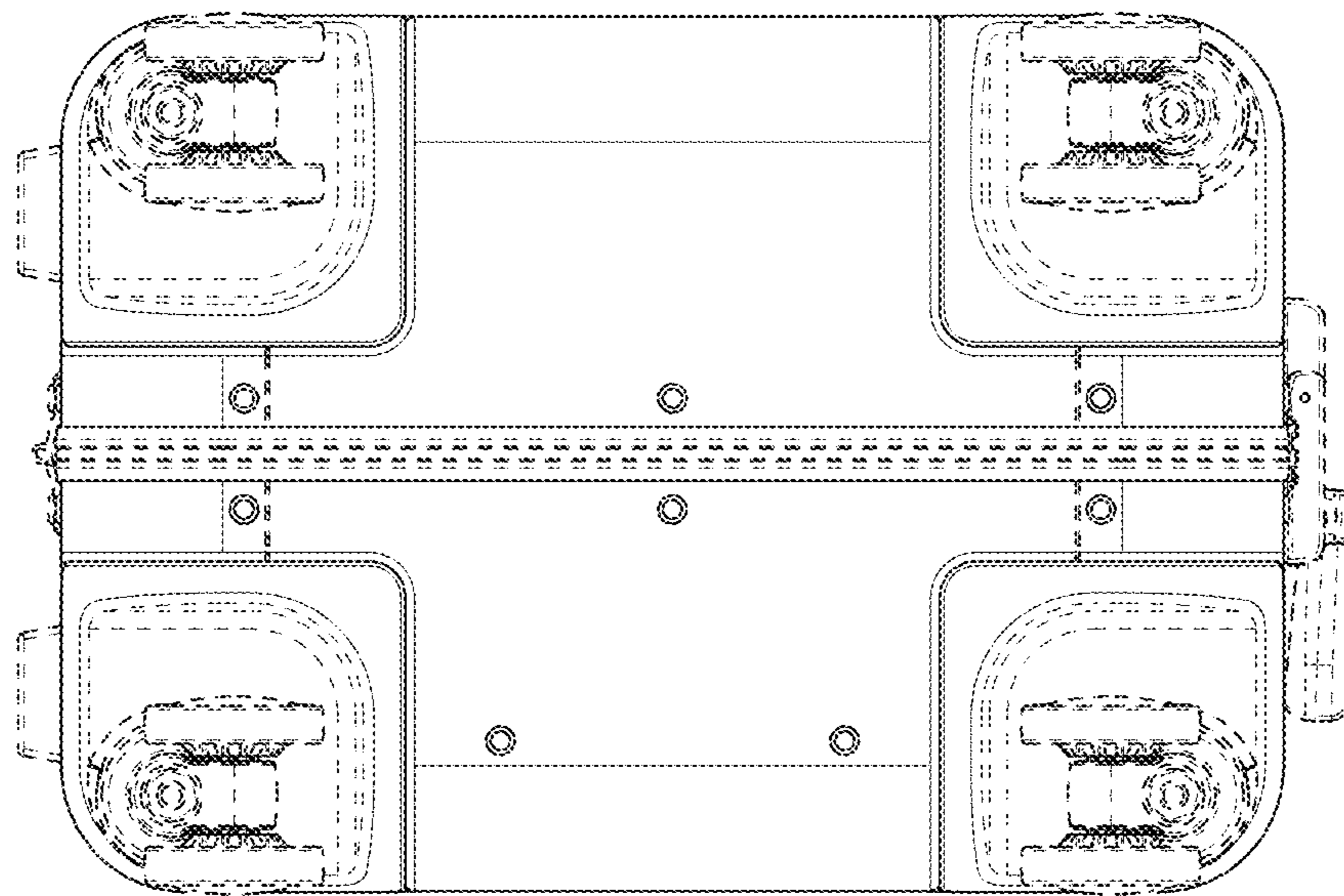

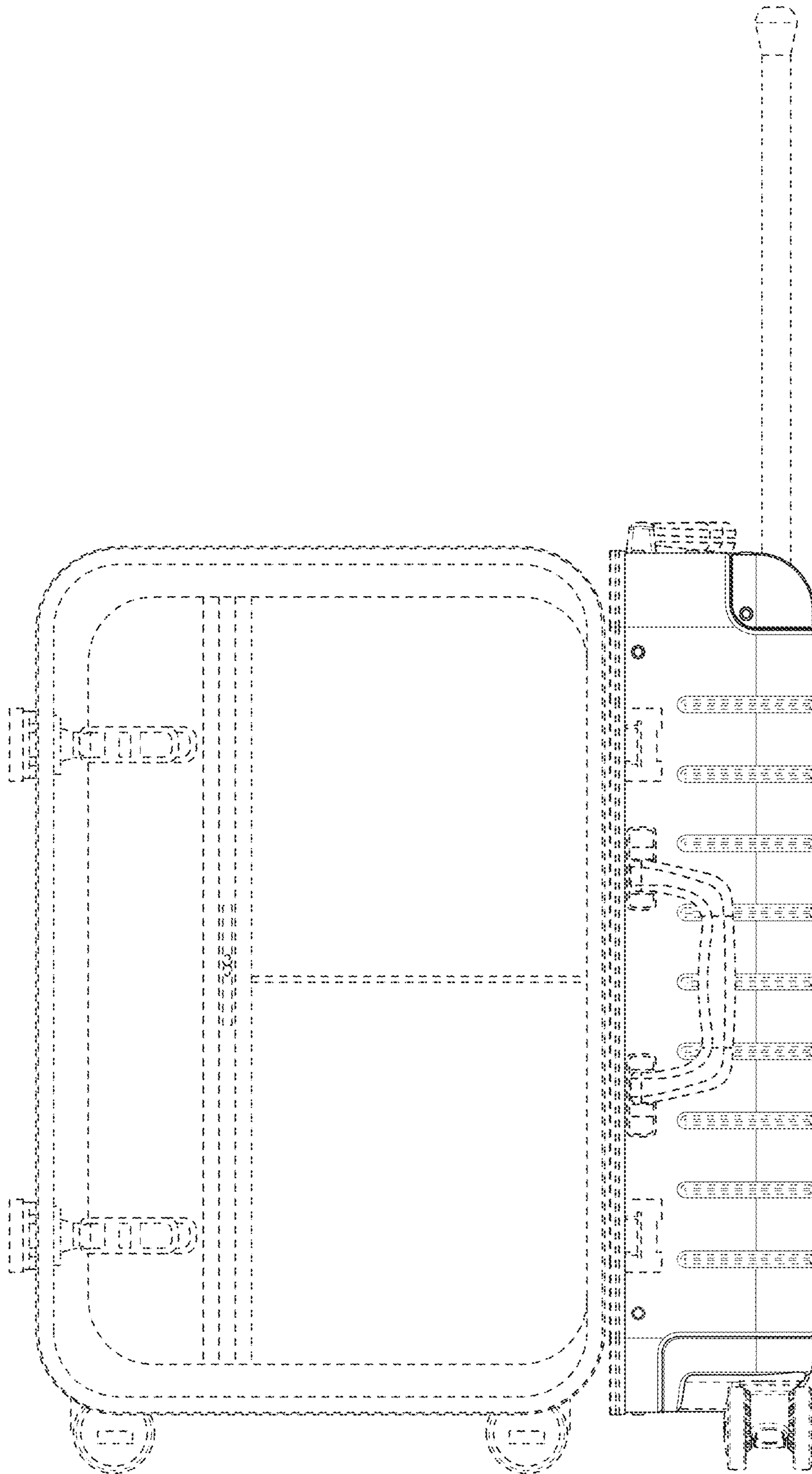

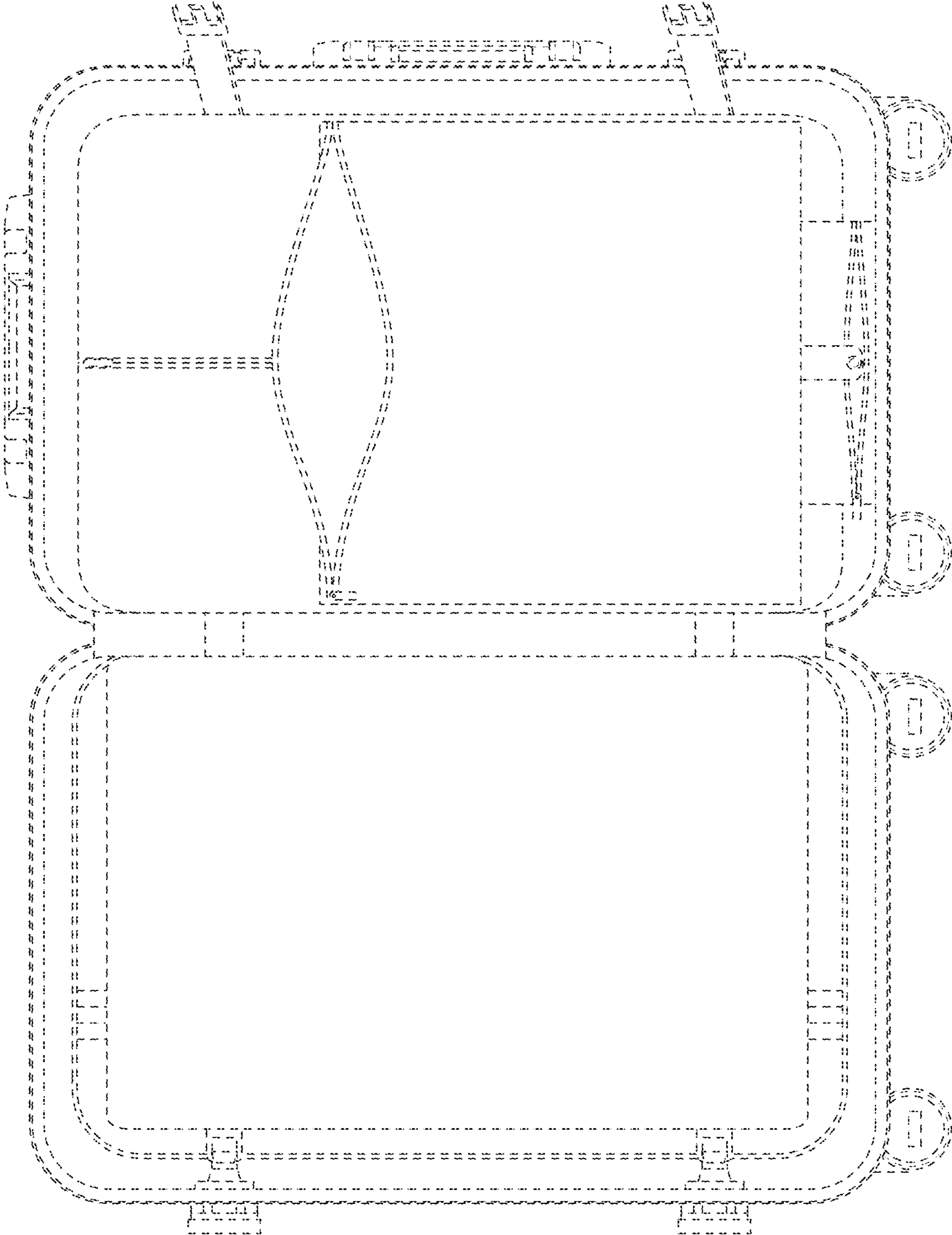

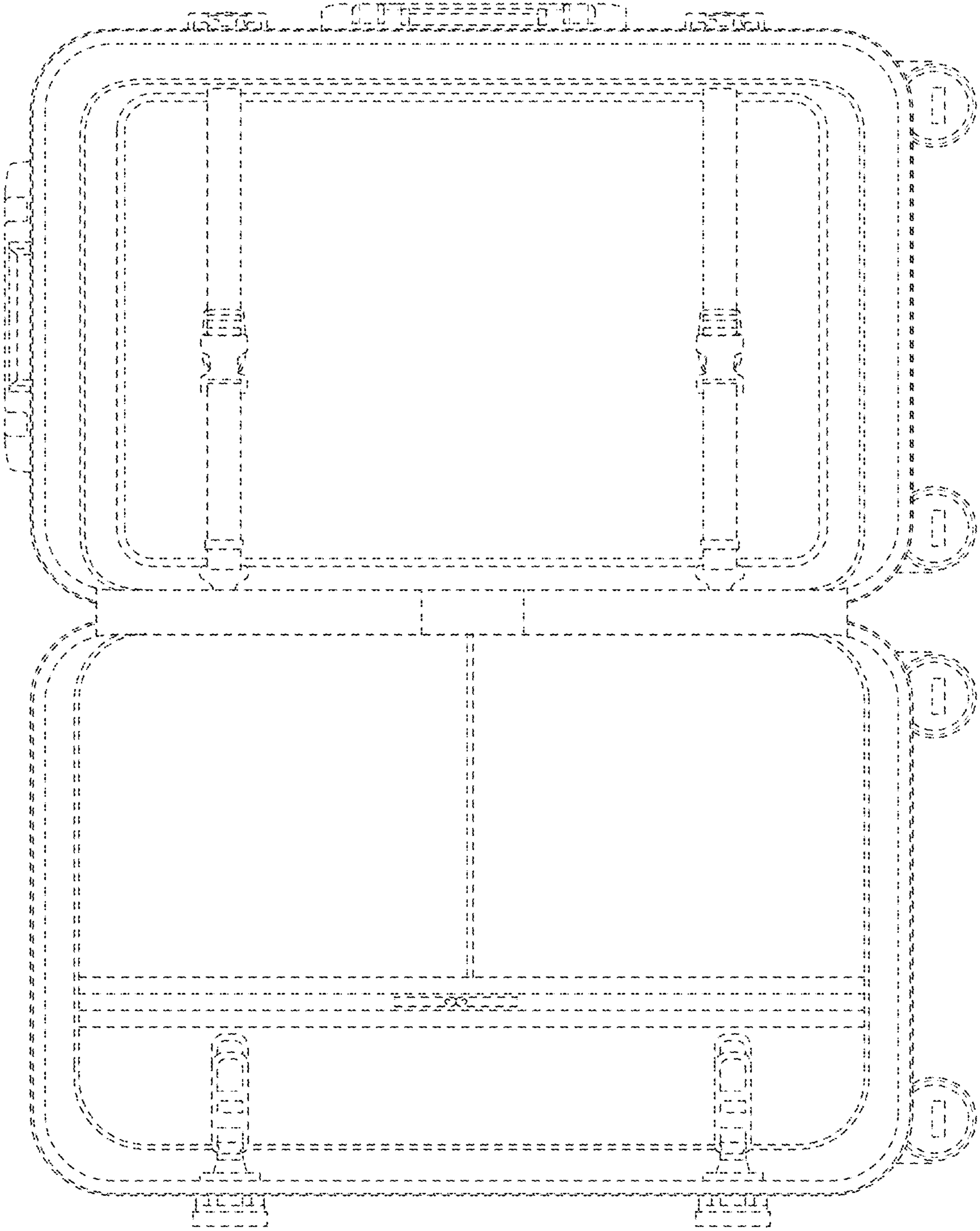
