(57) **CLAIM**

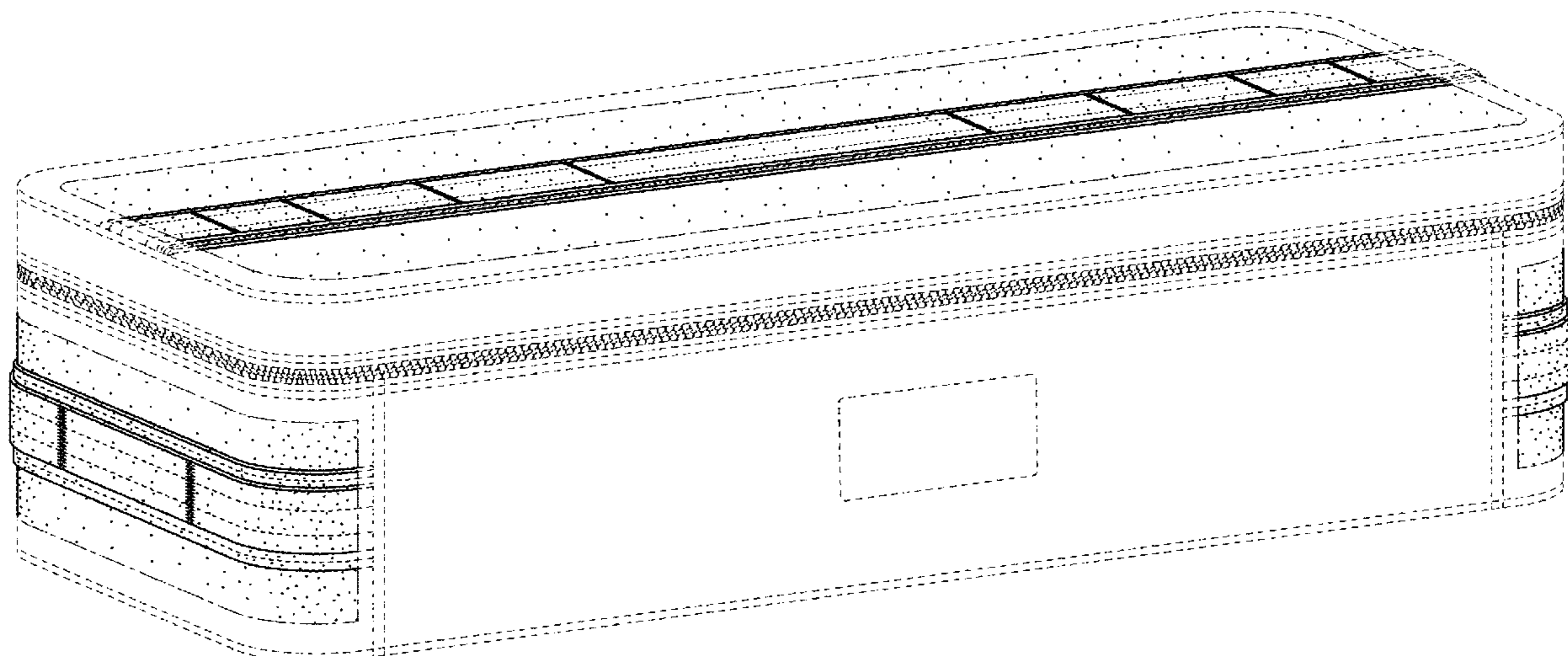
The ornamental design for a storage bag, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a storage bag showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The even-length broken lines within the shaded area represents a feature that forms no part of the claimed design. The uneven-length broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The even-length broken lines depicting the remainder of the storage bag show features that form no part of the claimed design.

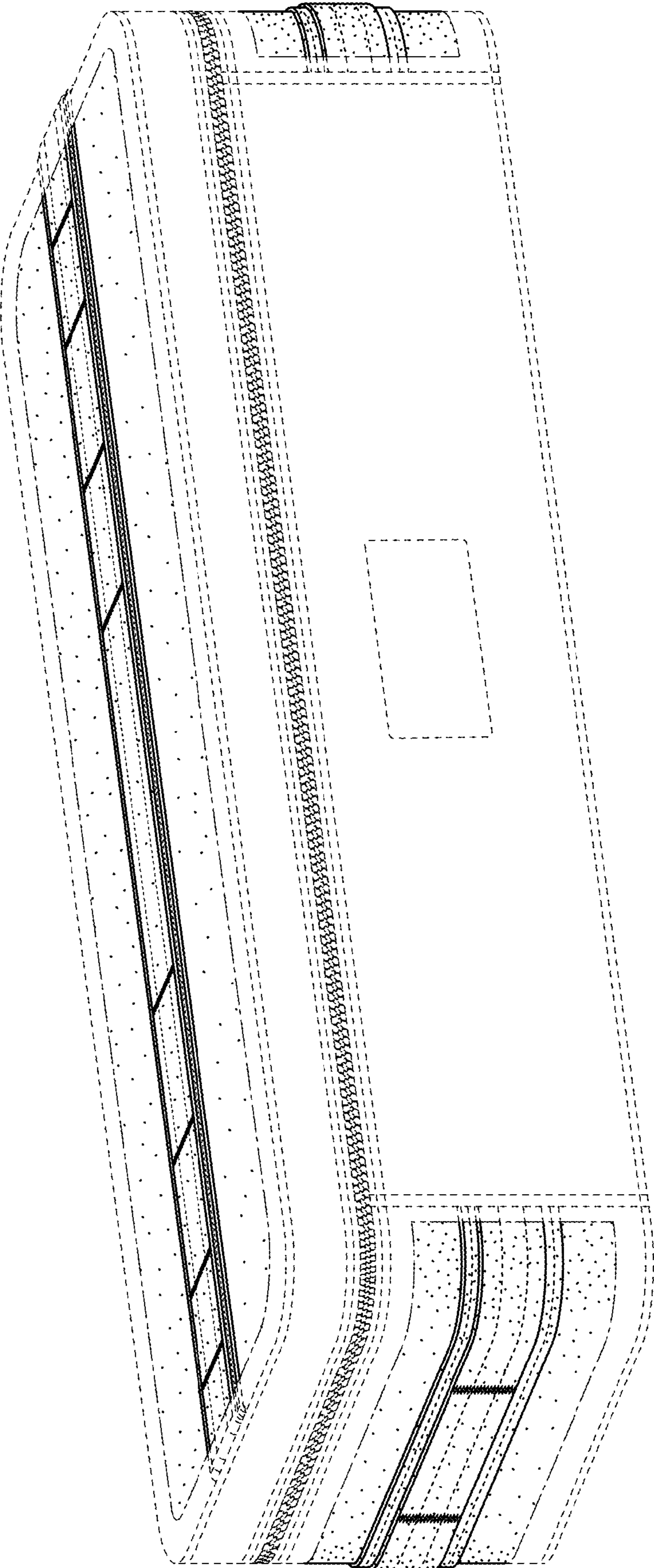

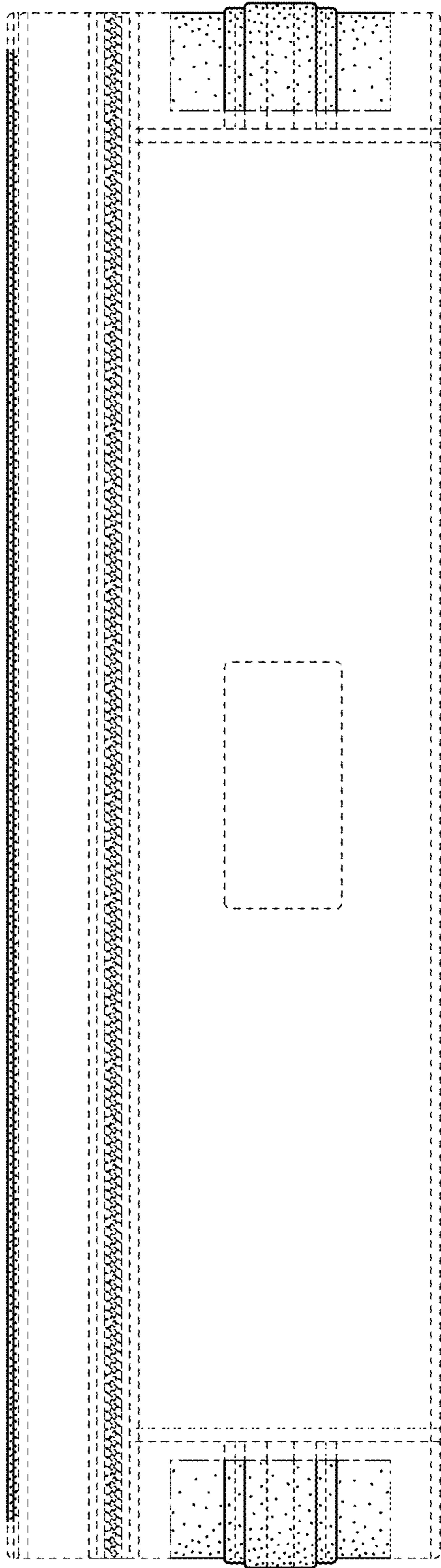

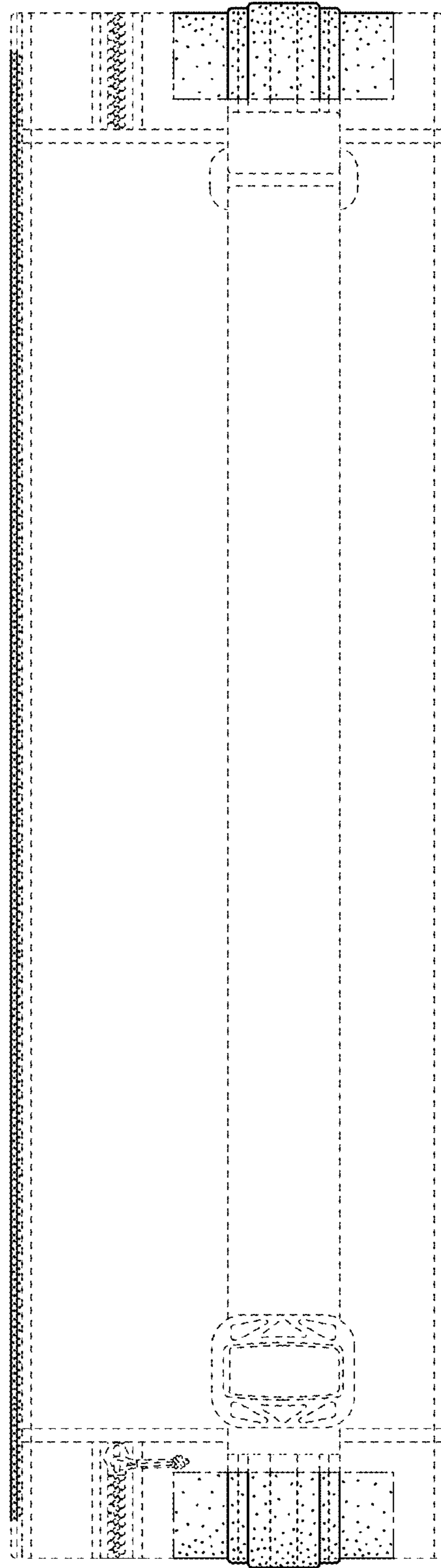

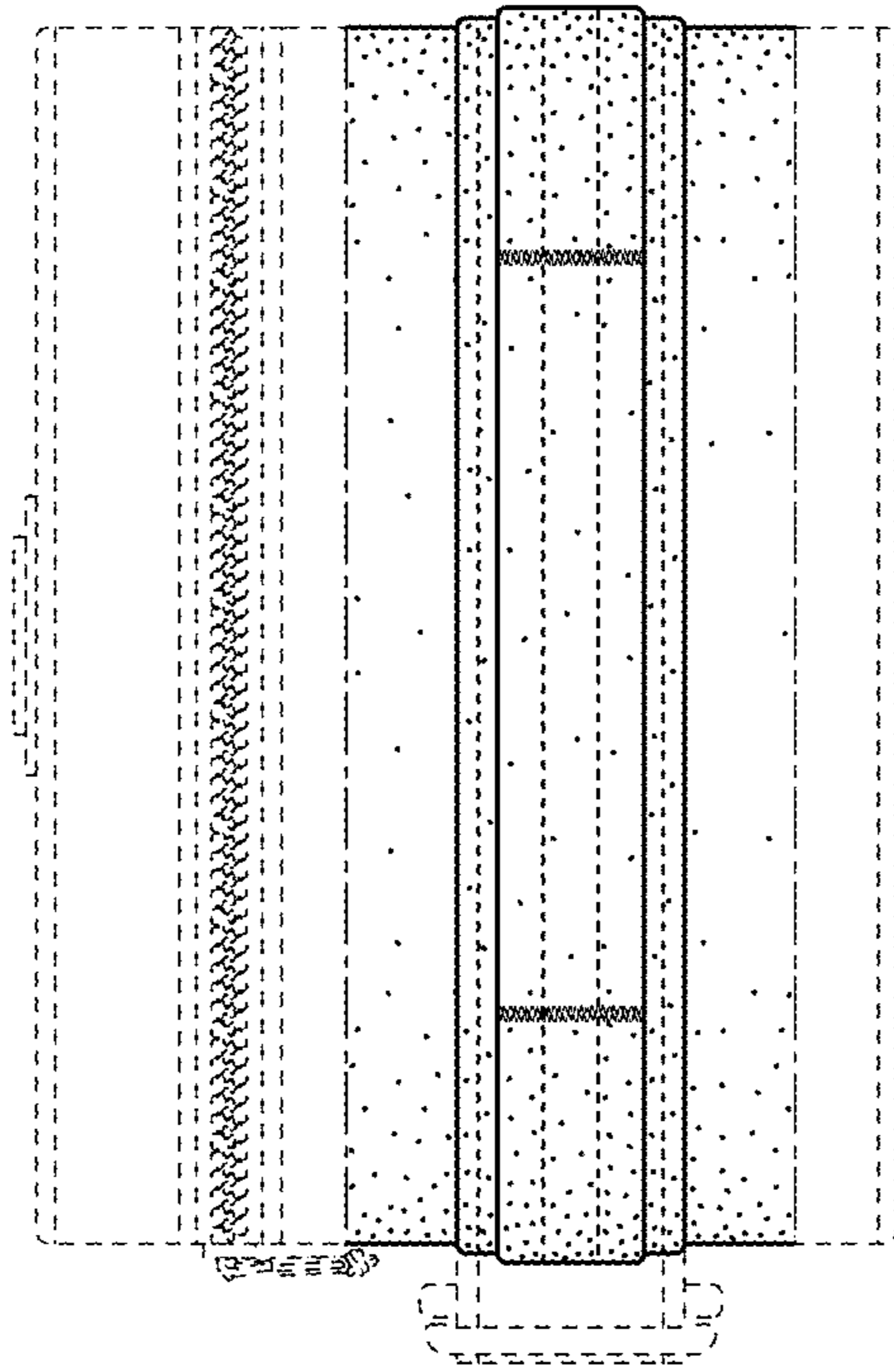

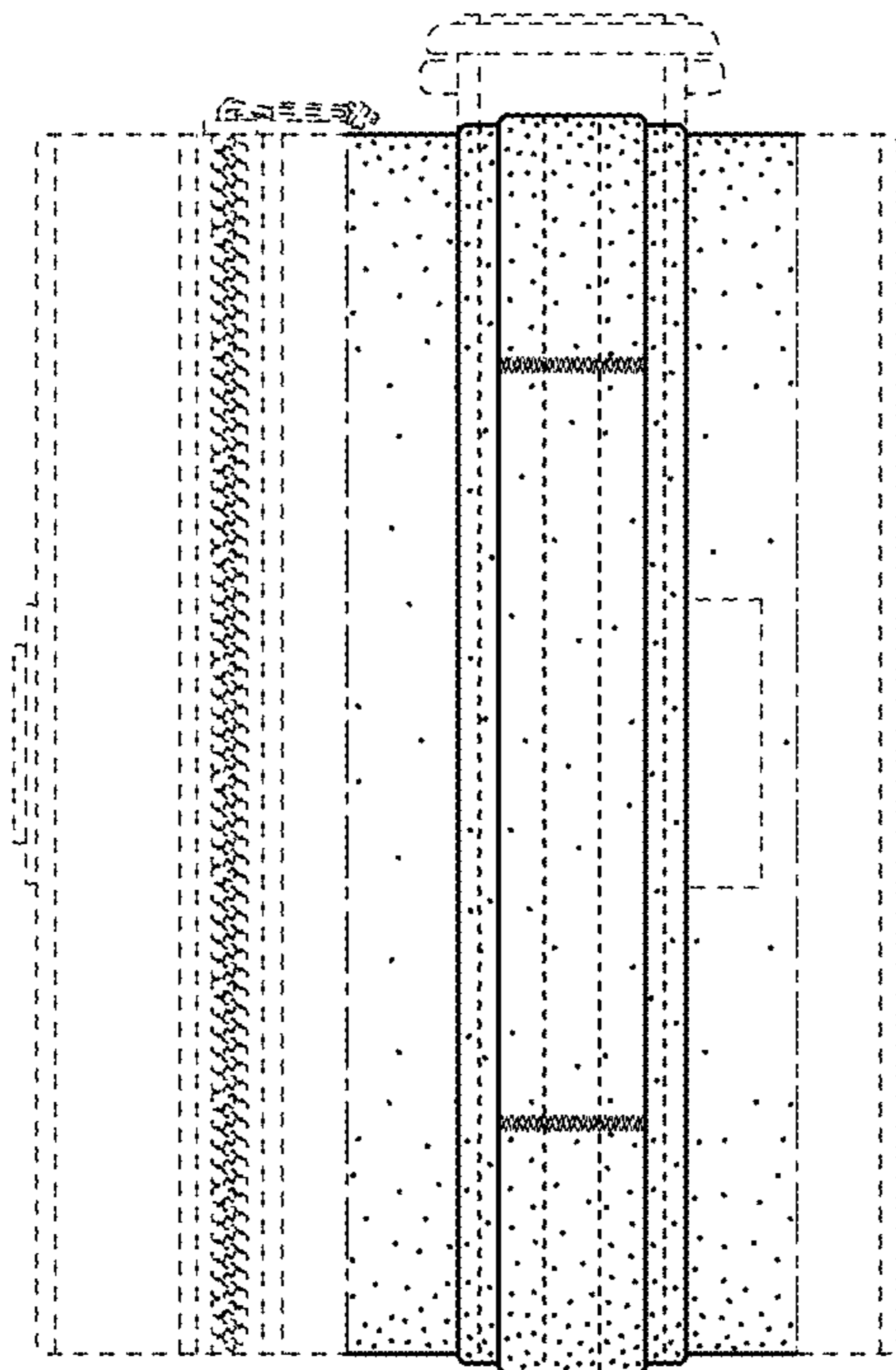

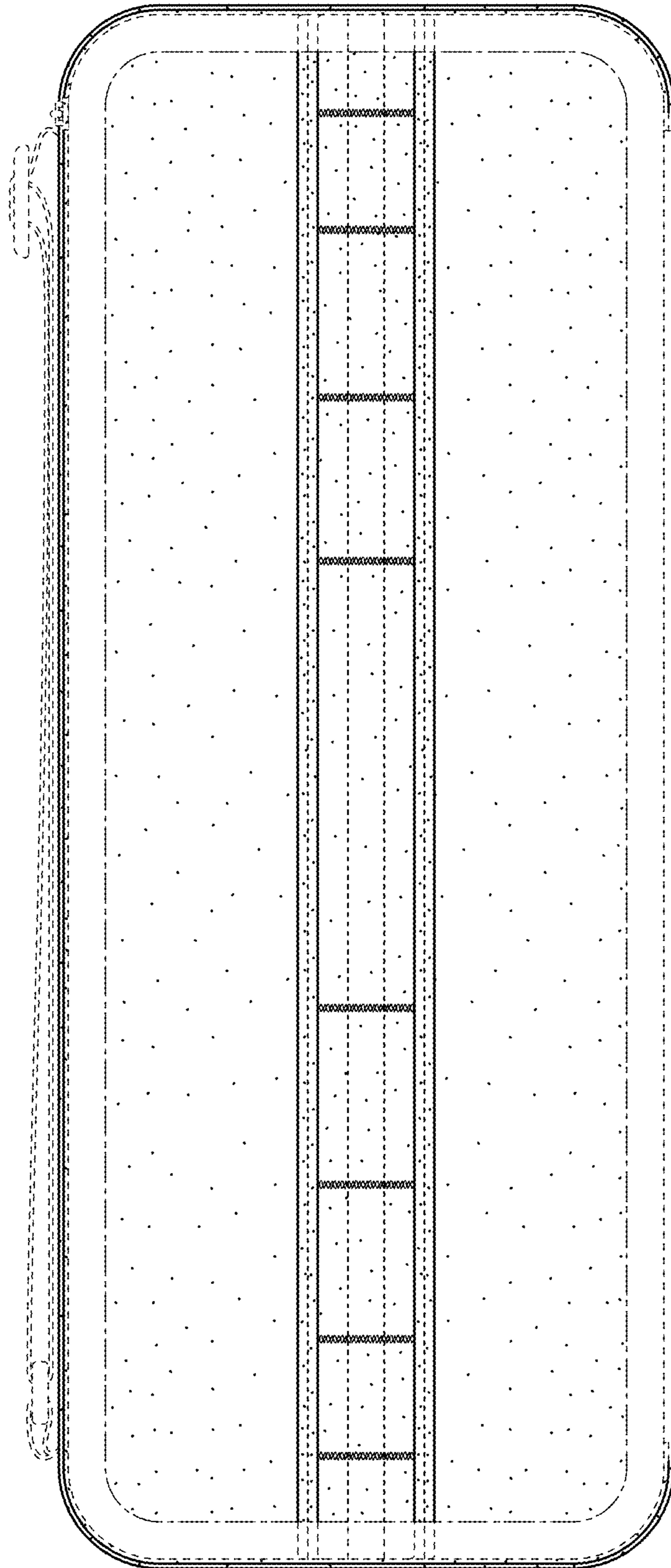

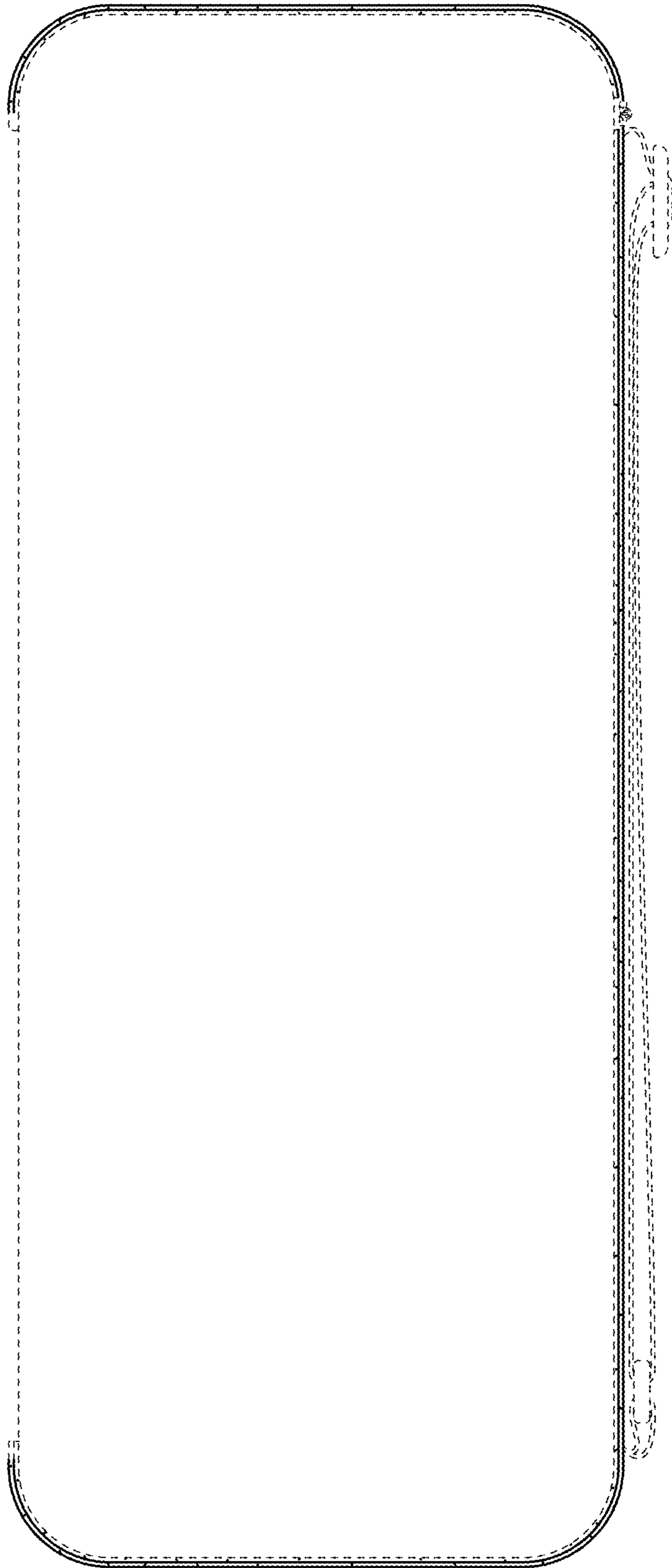
