**DESCRIPTION**

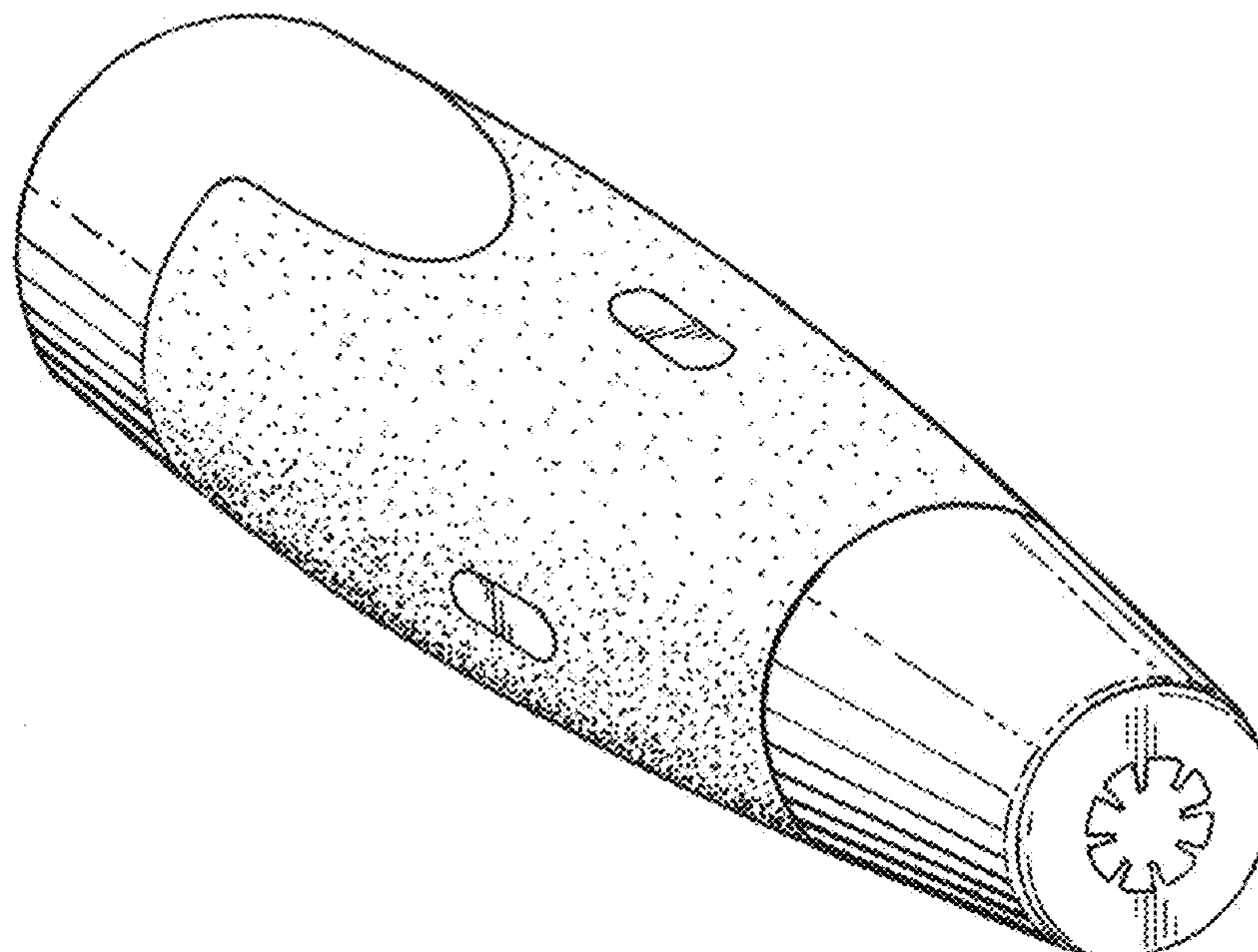
FIG. 1 is a perspective view of a handle in accordance with the invention;

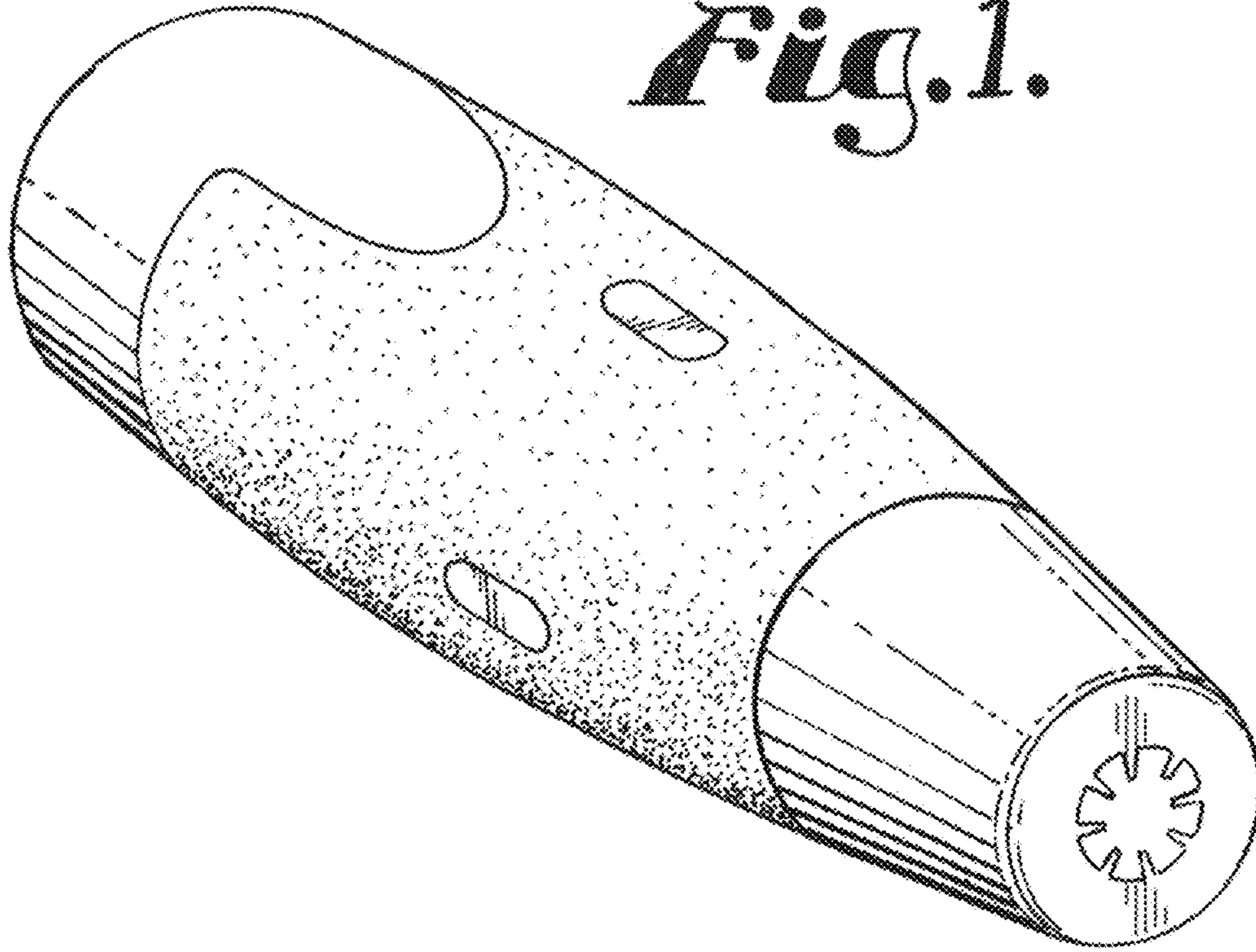

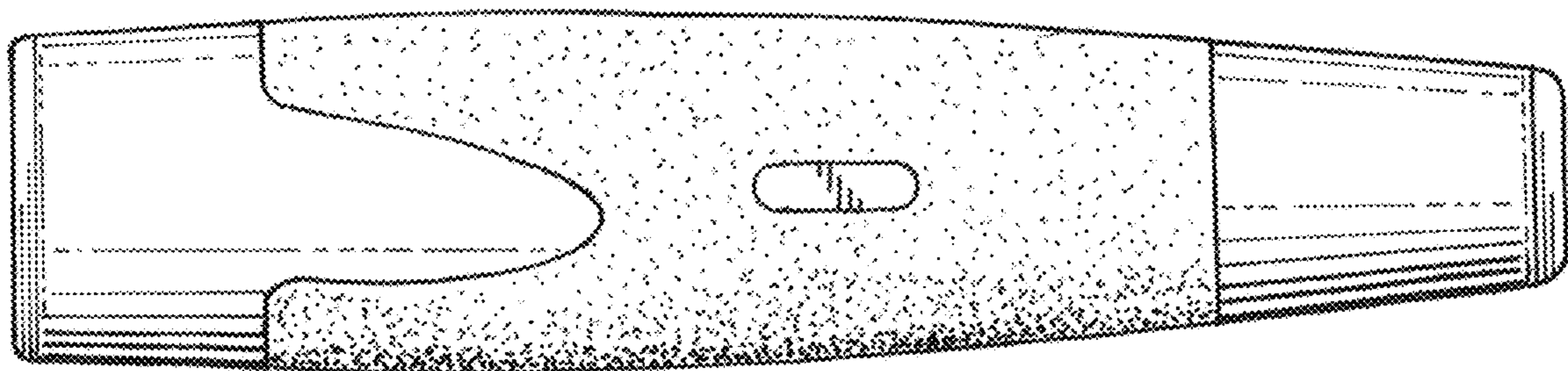

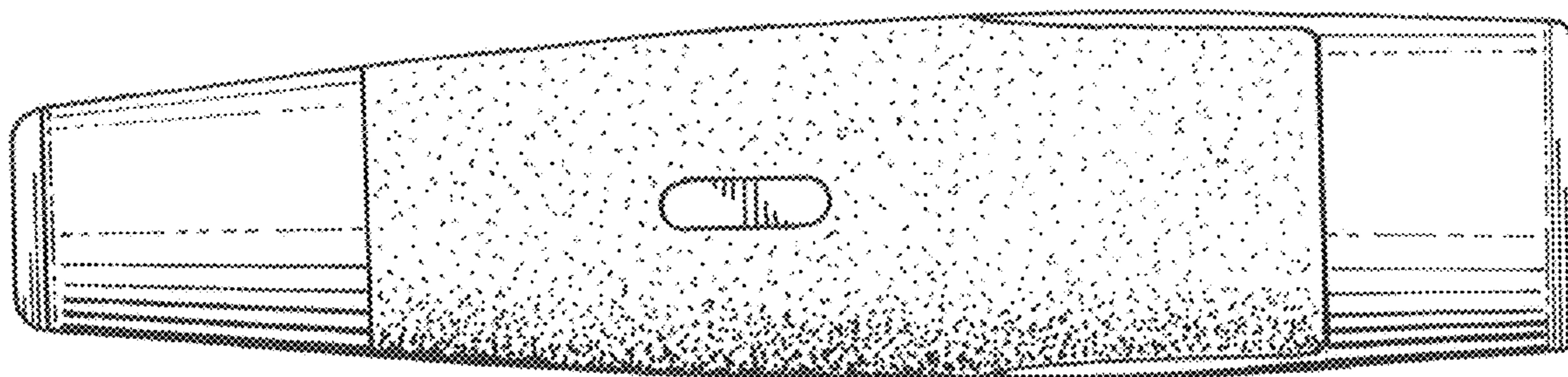

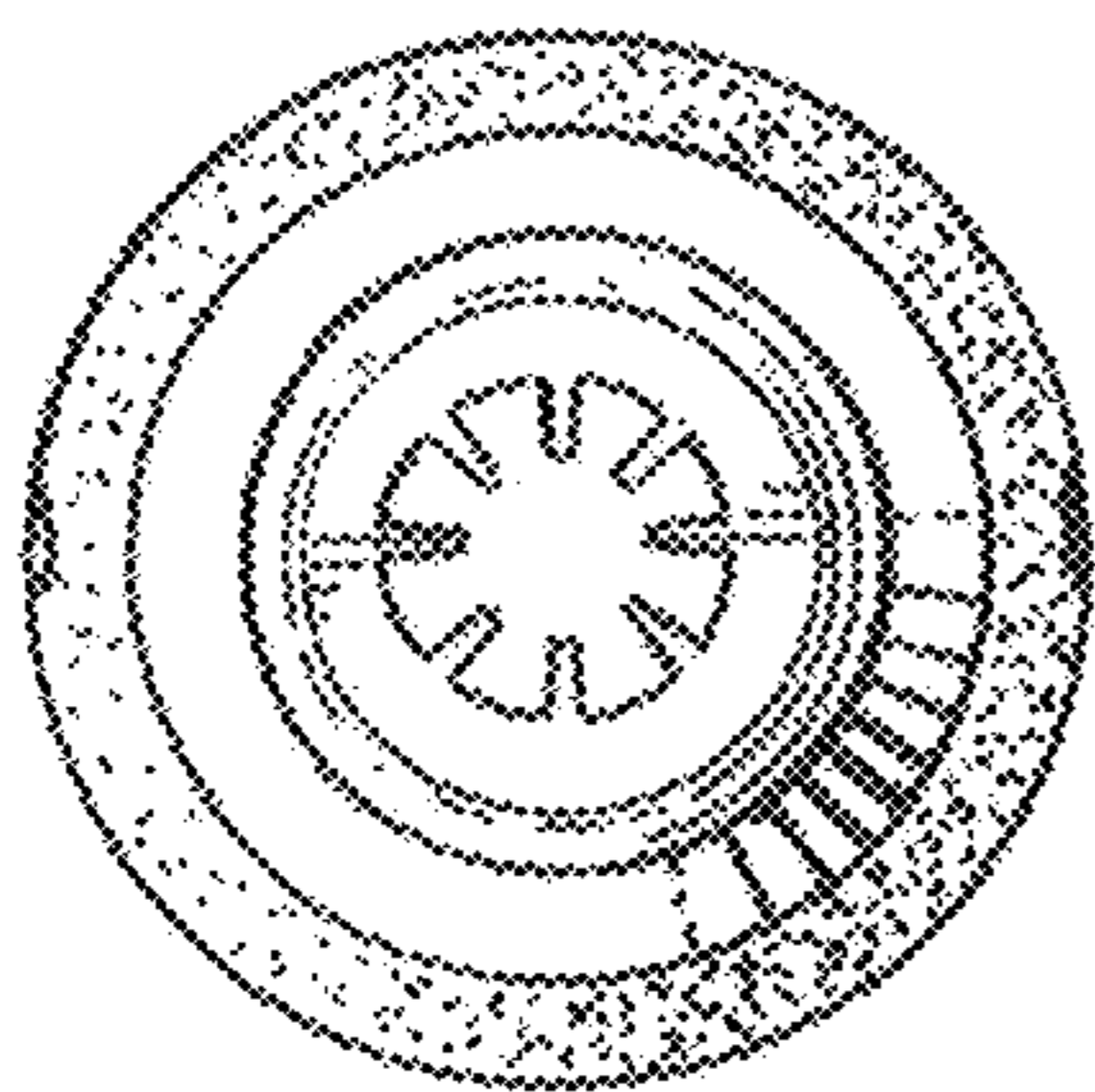
