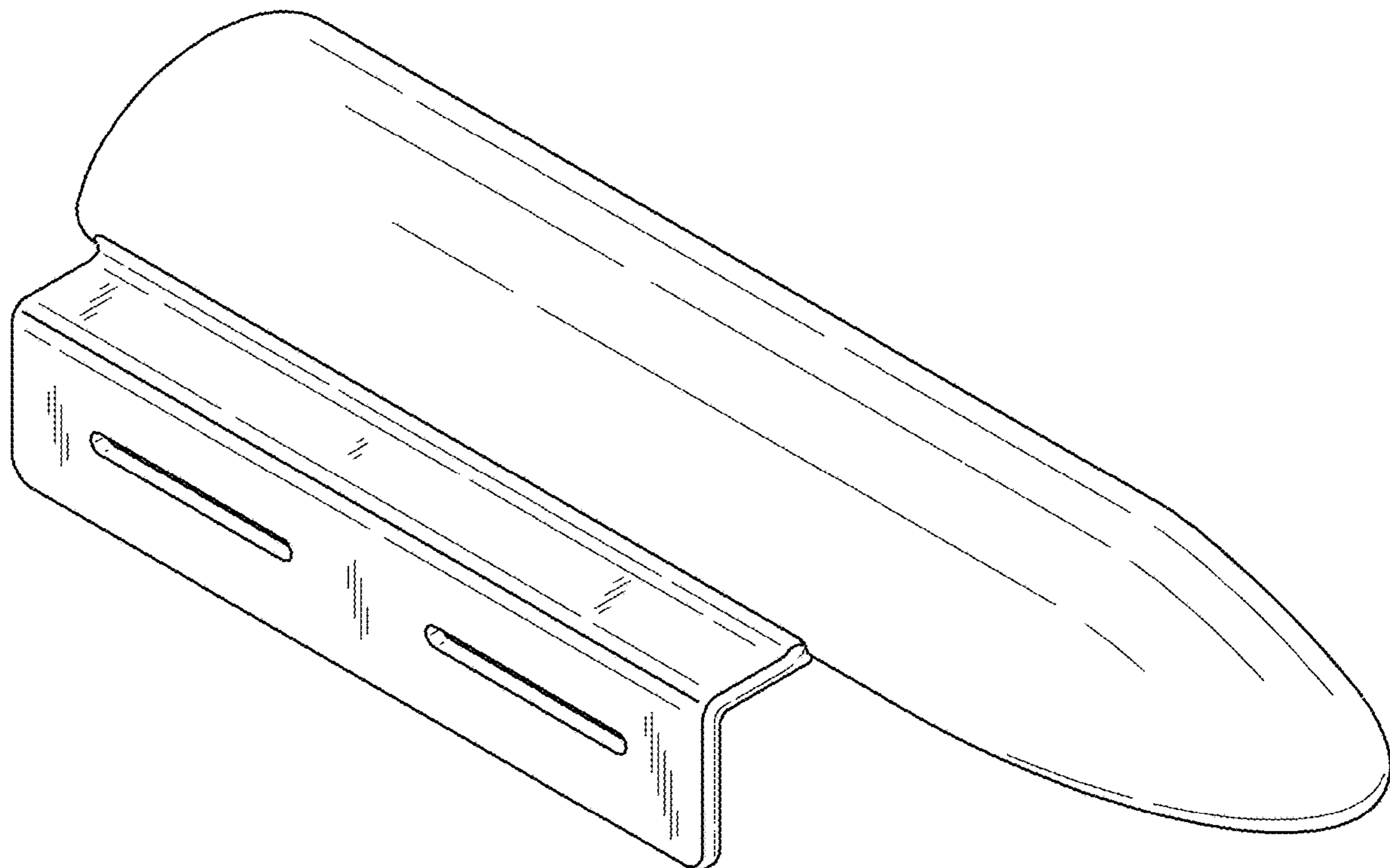
(57) **CLAIM**

I claim the ornamental design for a protective attachment for wheelchair, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a protective attachment for wheelchair showing my new design;

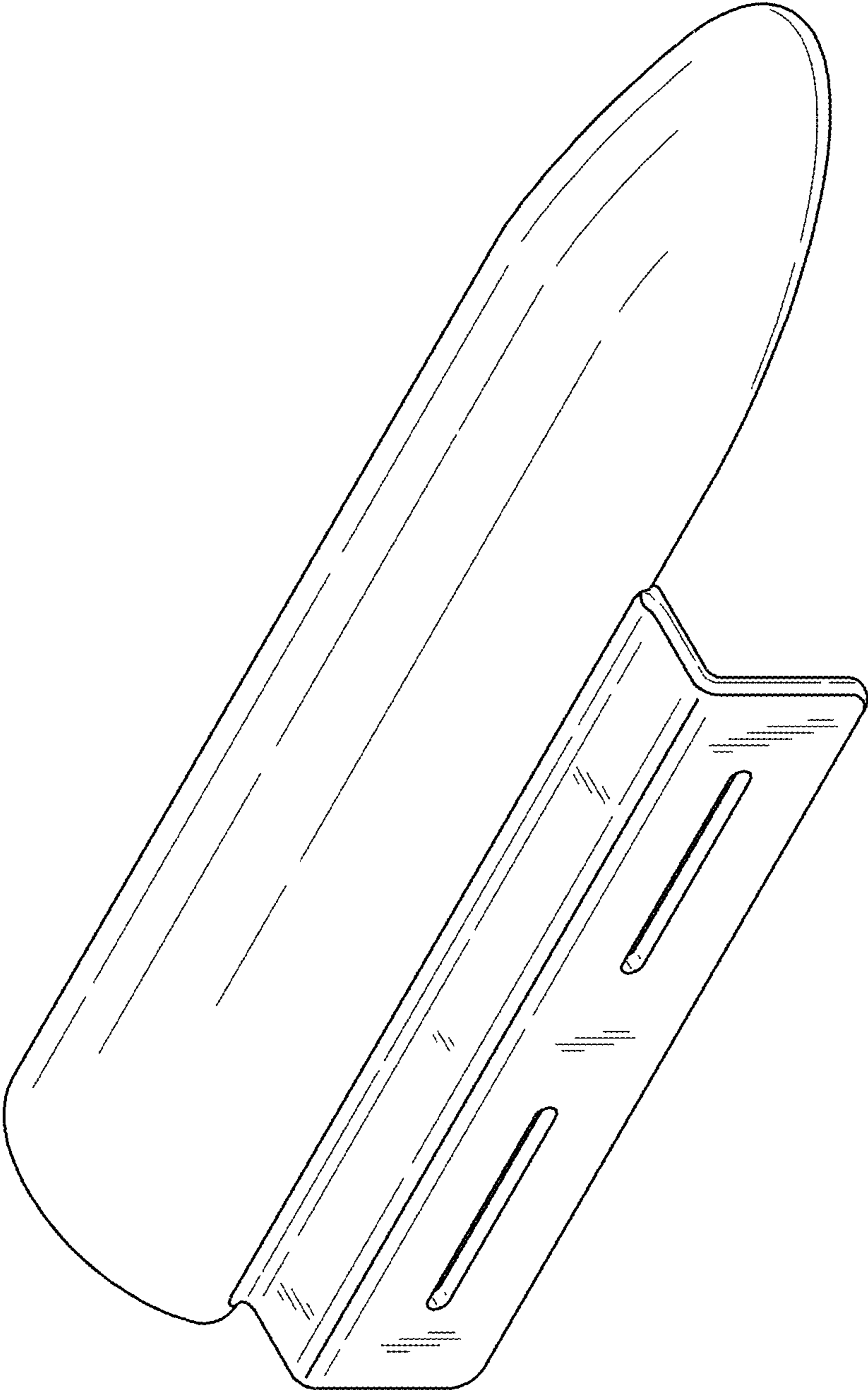

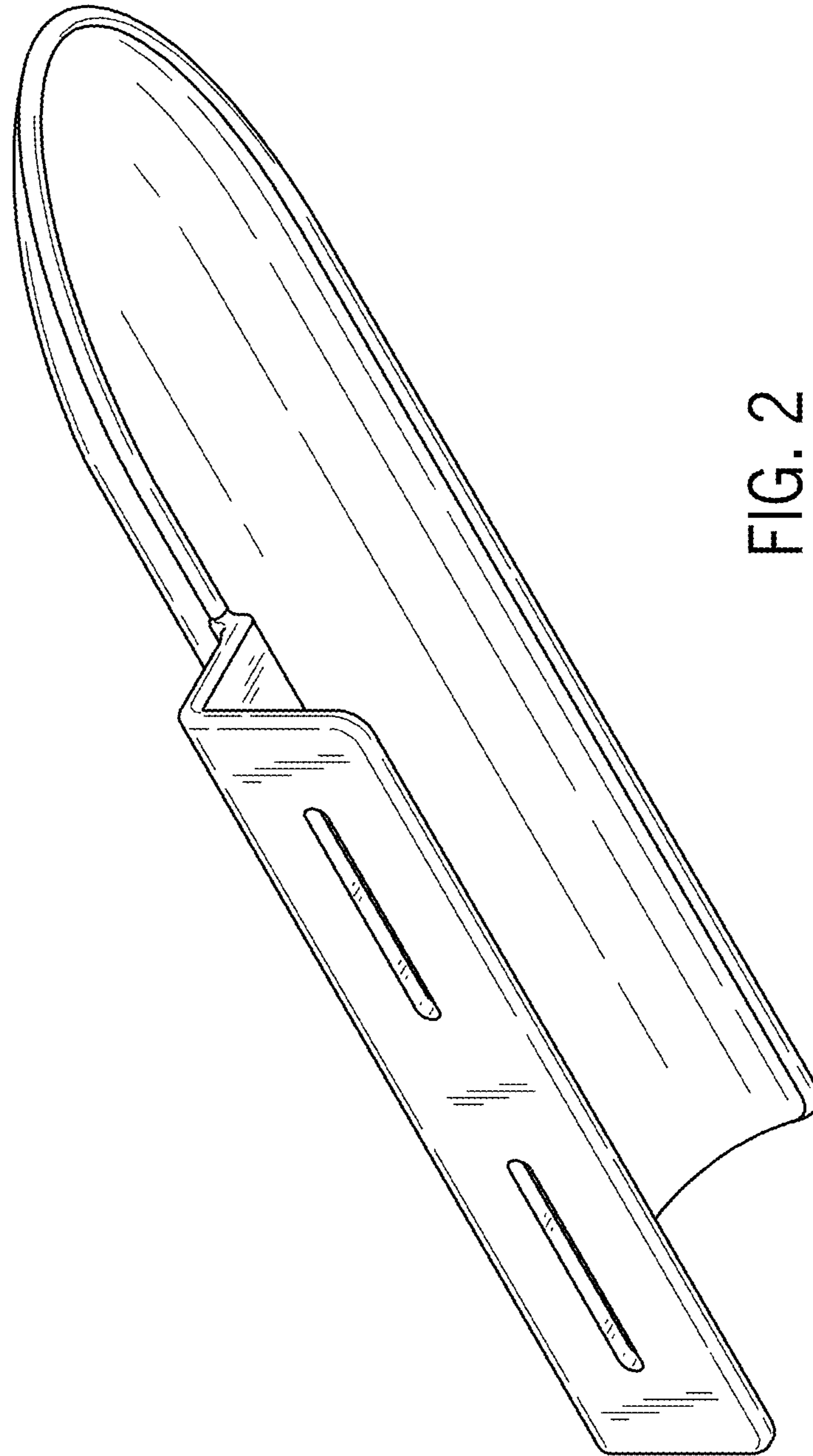

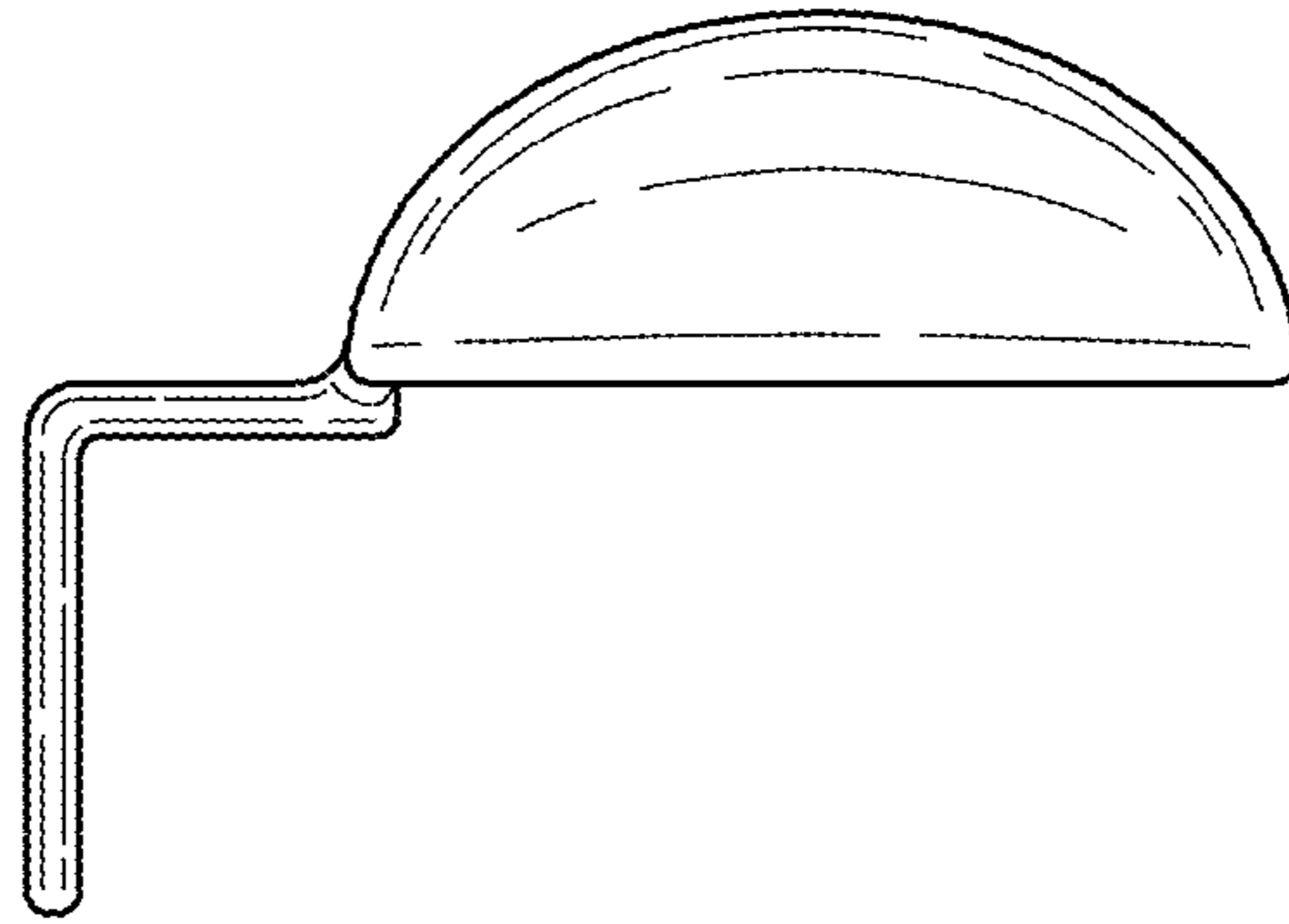

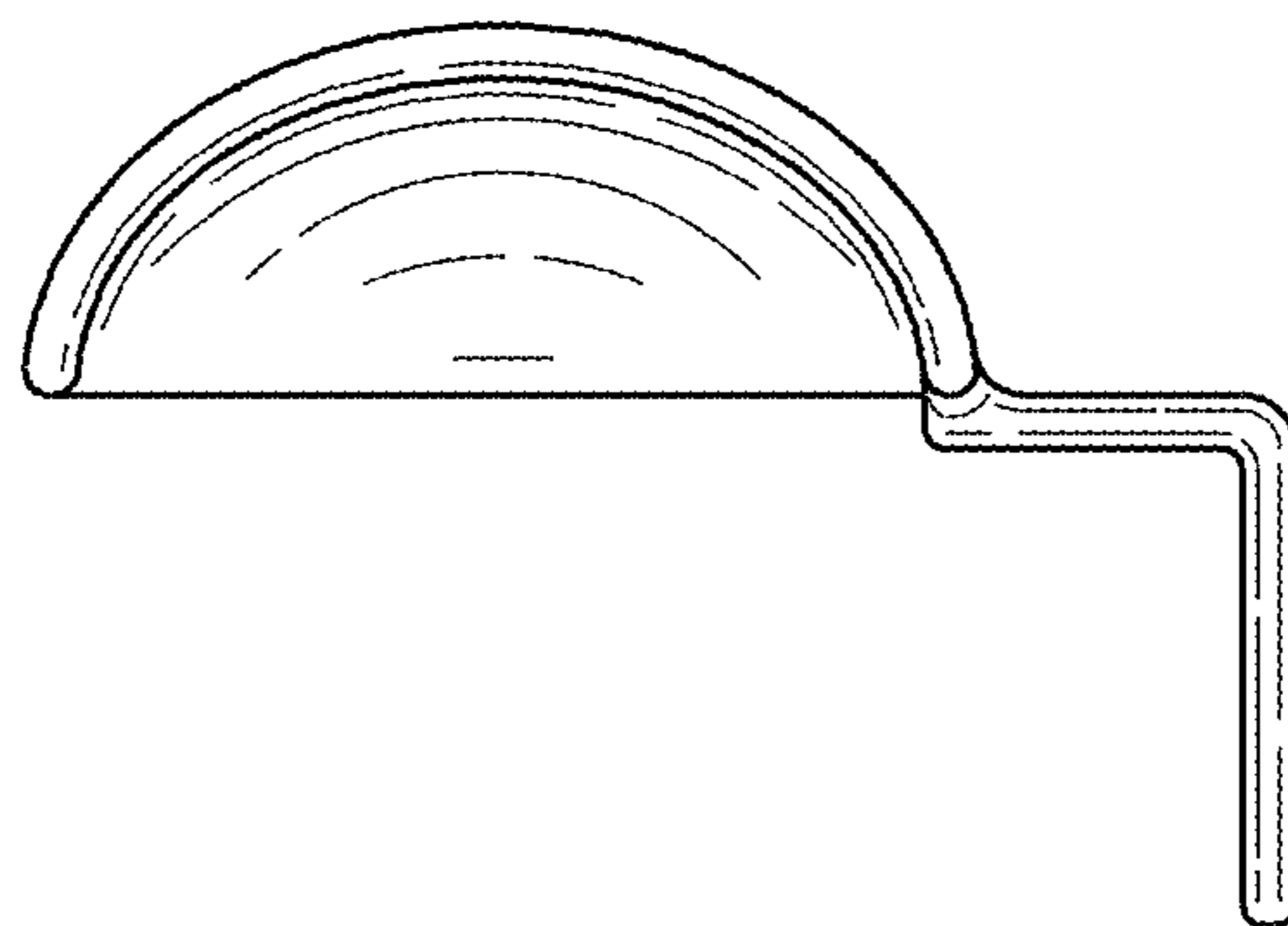

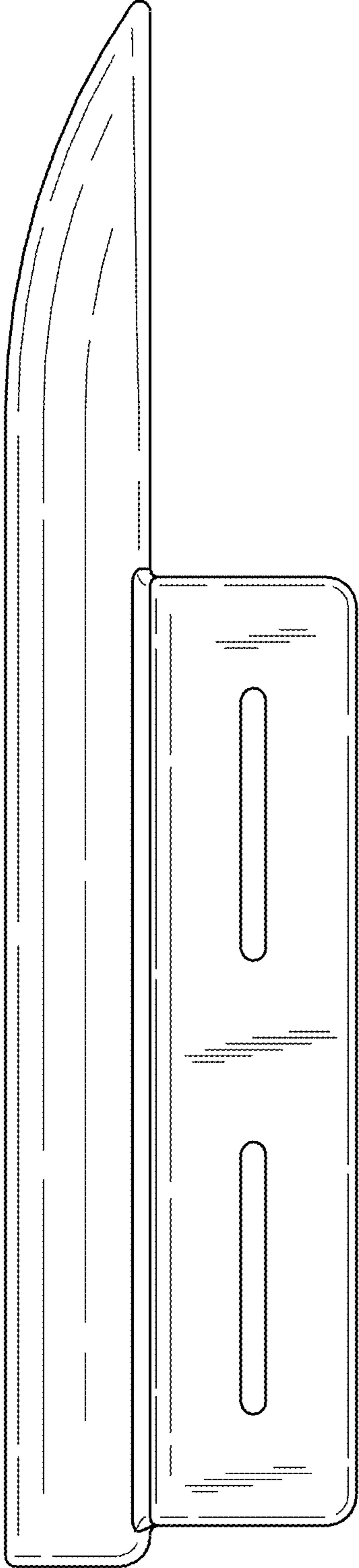

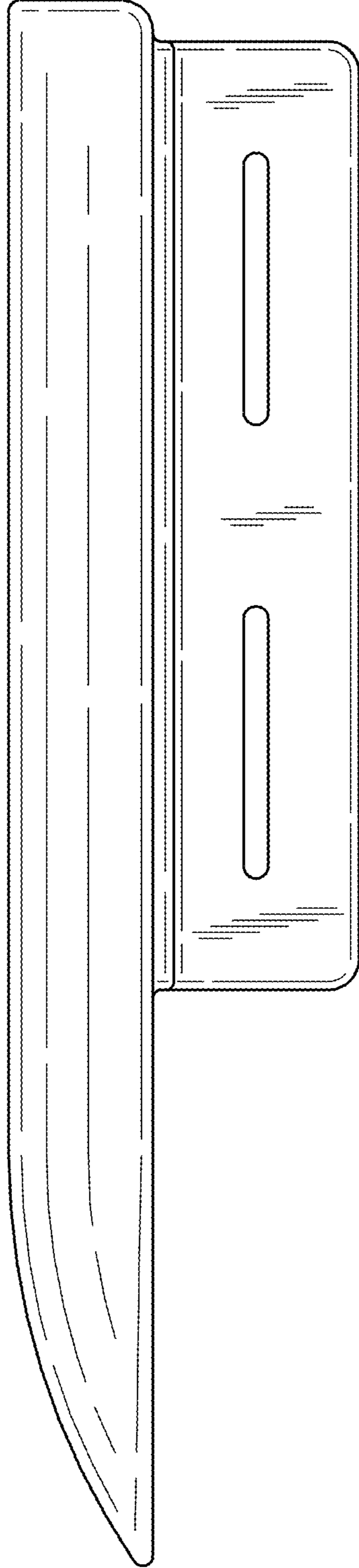

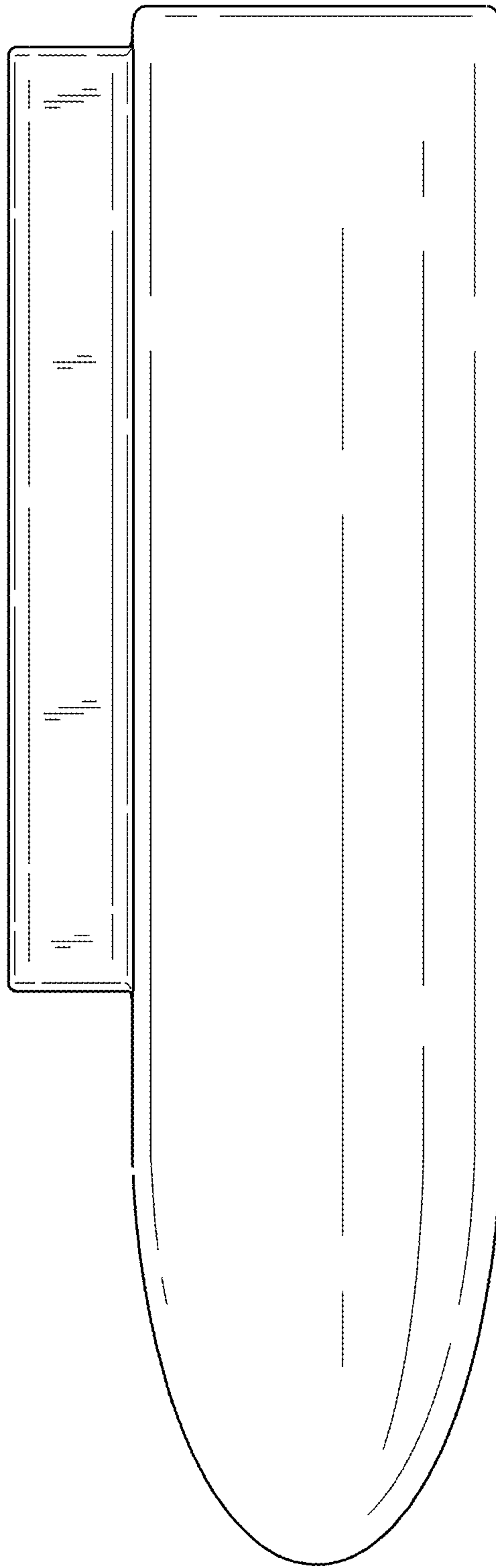

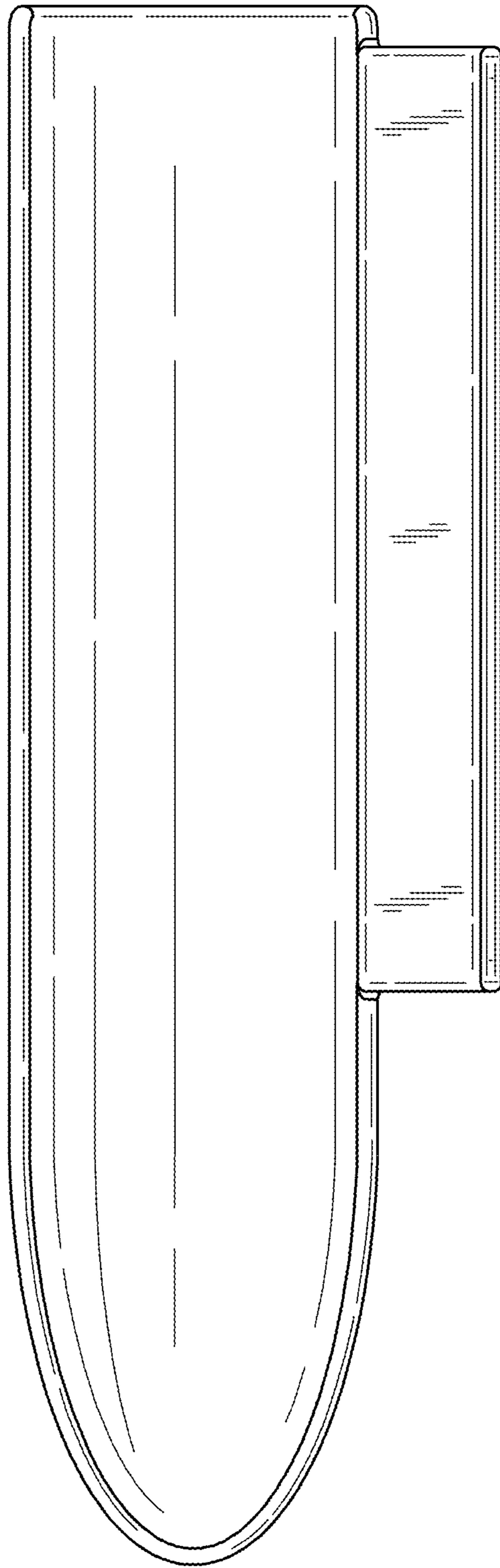
